[57] **CLAIM**

The ornamental design for a golf cleat, as shown and described.

DESCRIPTION

FIG. 1 is a front, left, bottom perspective view of a golf cleat showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a right side elevational view thereof, the left side being a mirror image;
FIG. 4 is a front elevational view thereof, the rear elevation being a mirror image; and,
FIG. 5 is a bottom plan view thereof.

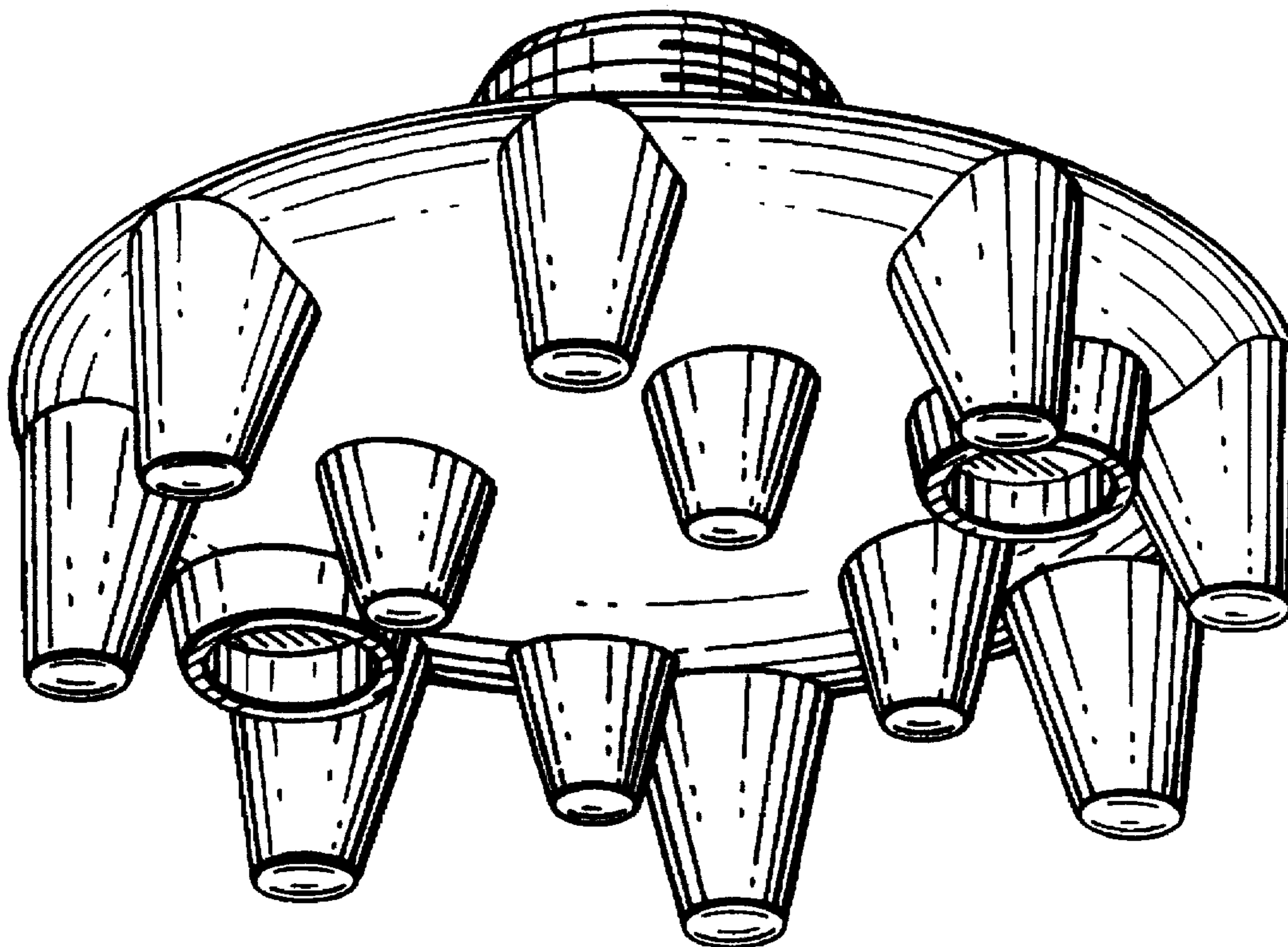

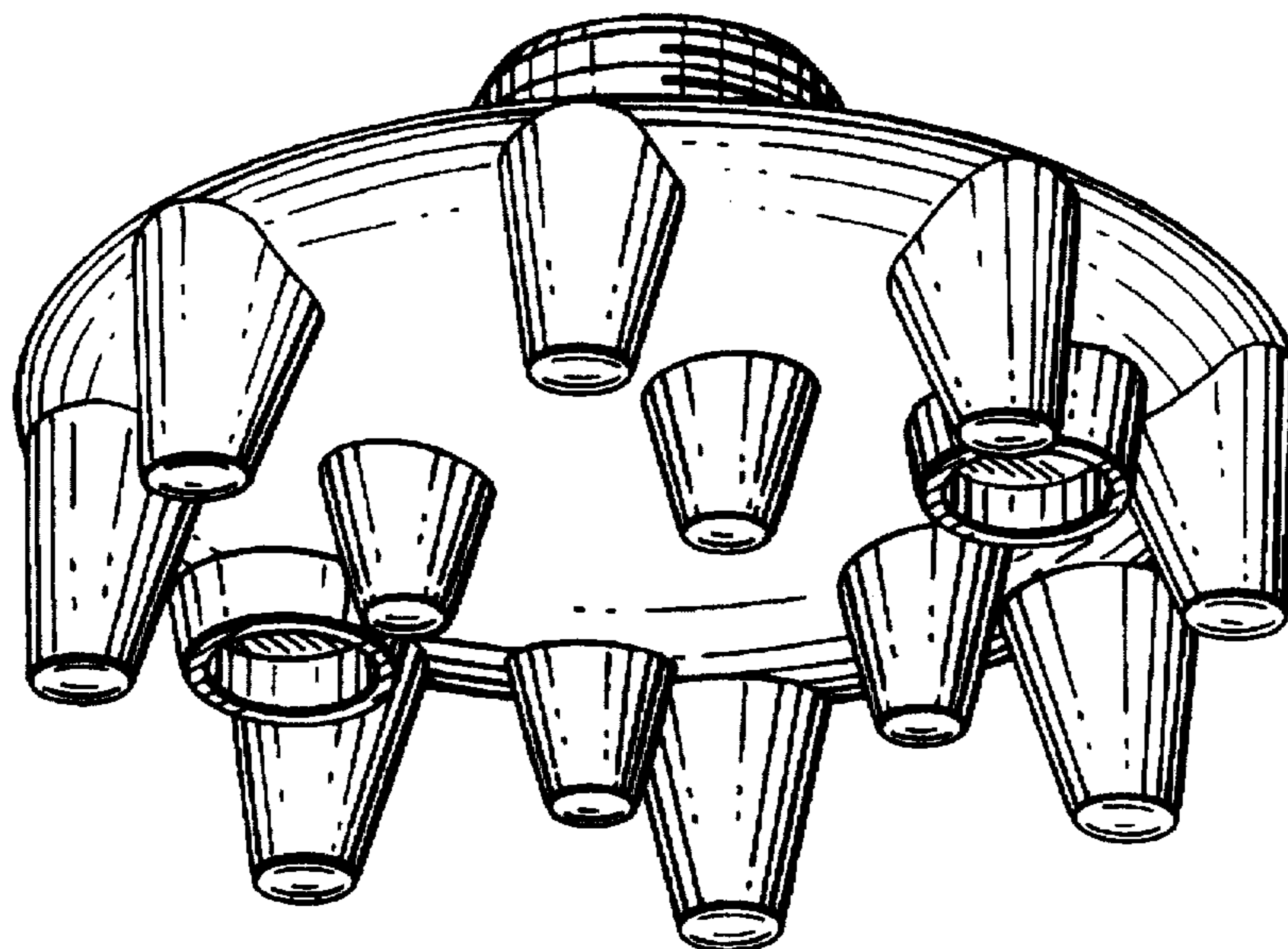

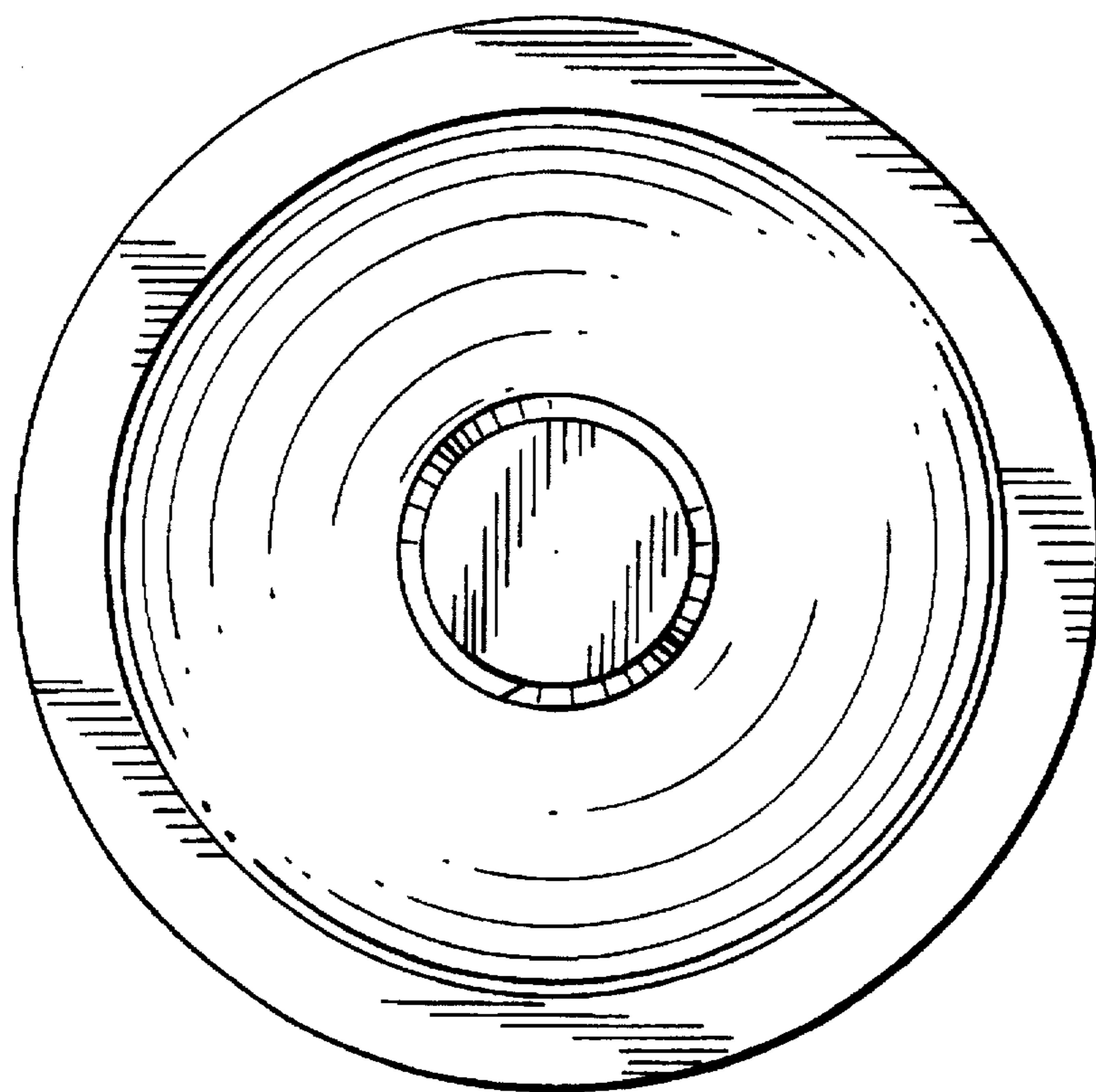

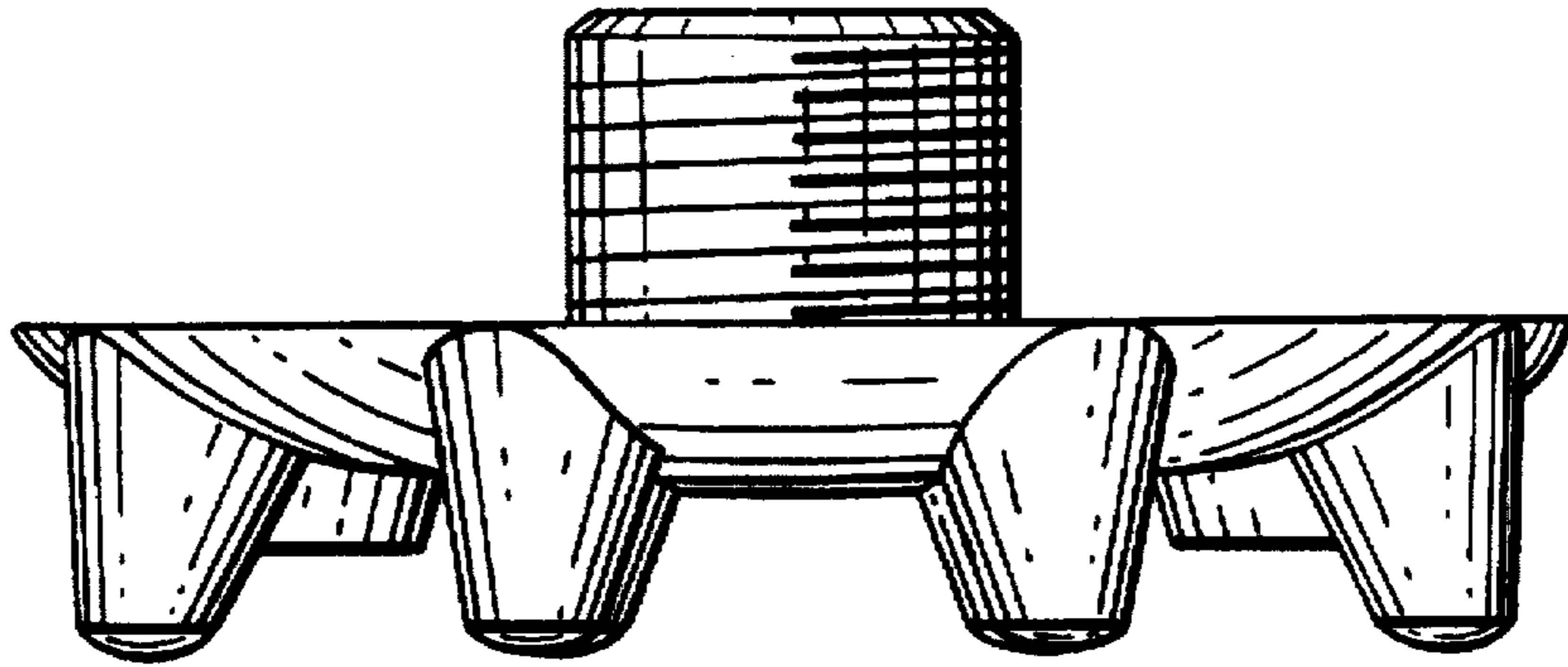

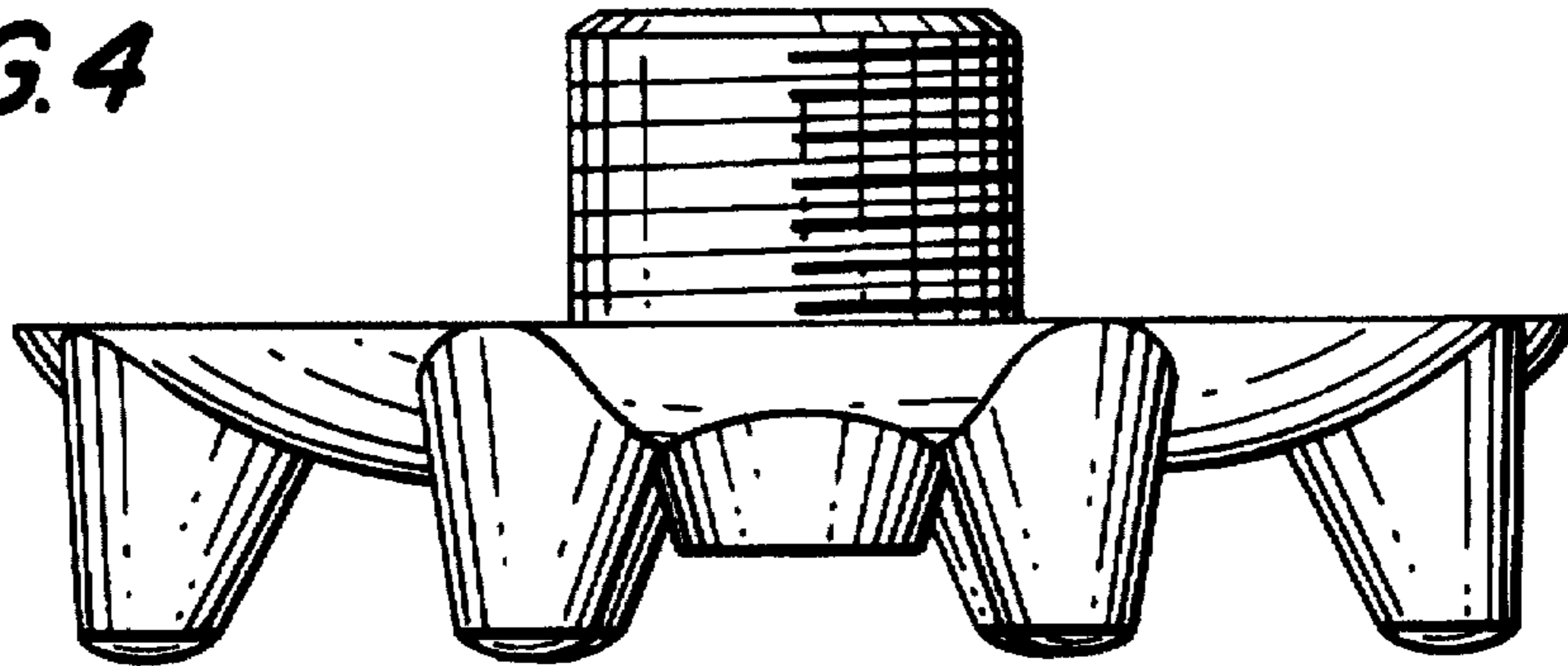
