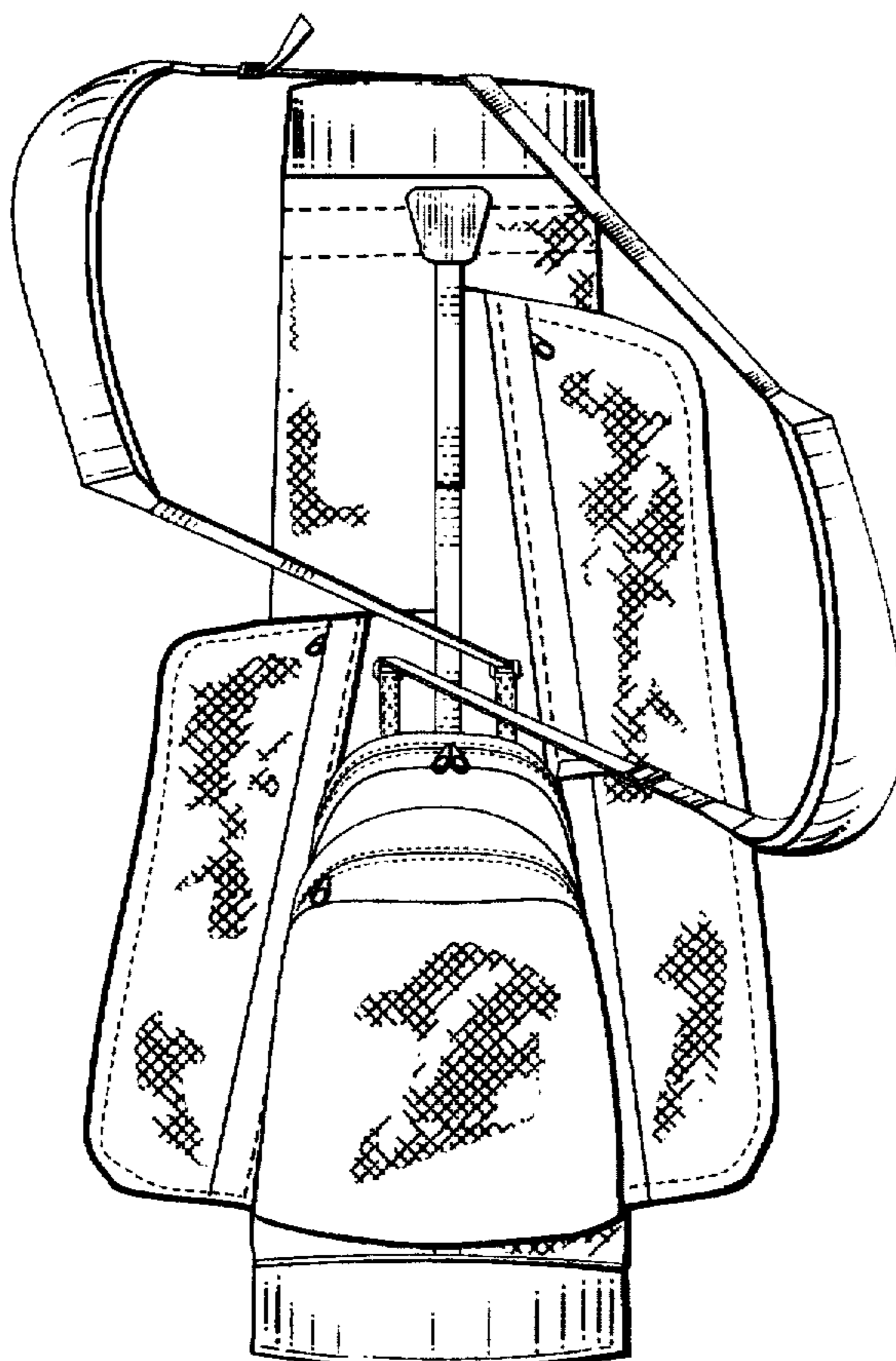
FIG. 1 is a front elevational view of a golf bag with dual shoulder straps showing our new design;

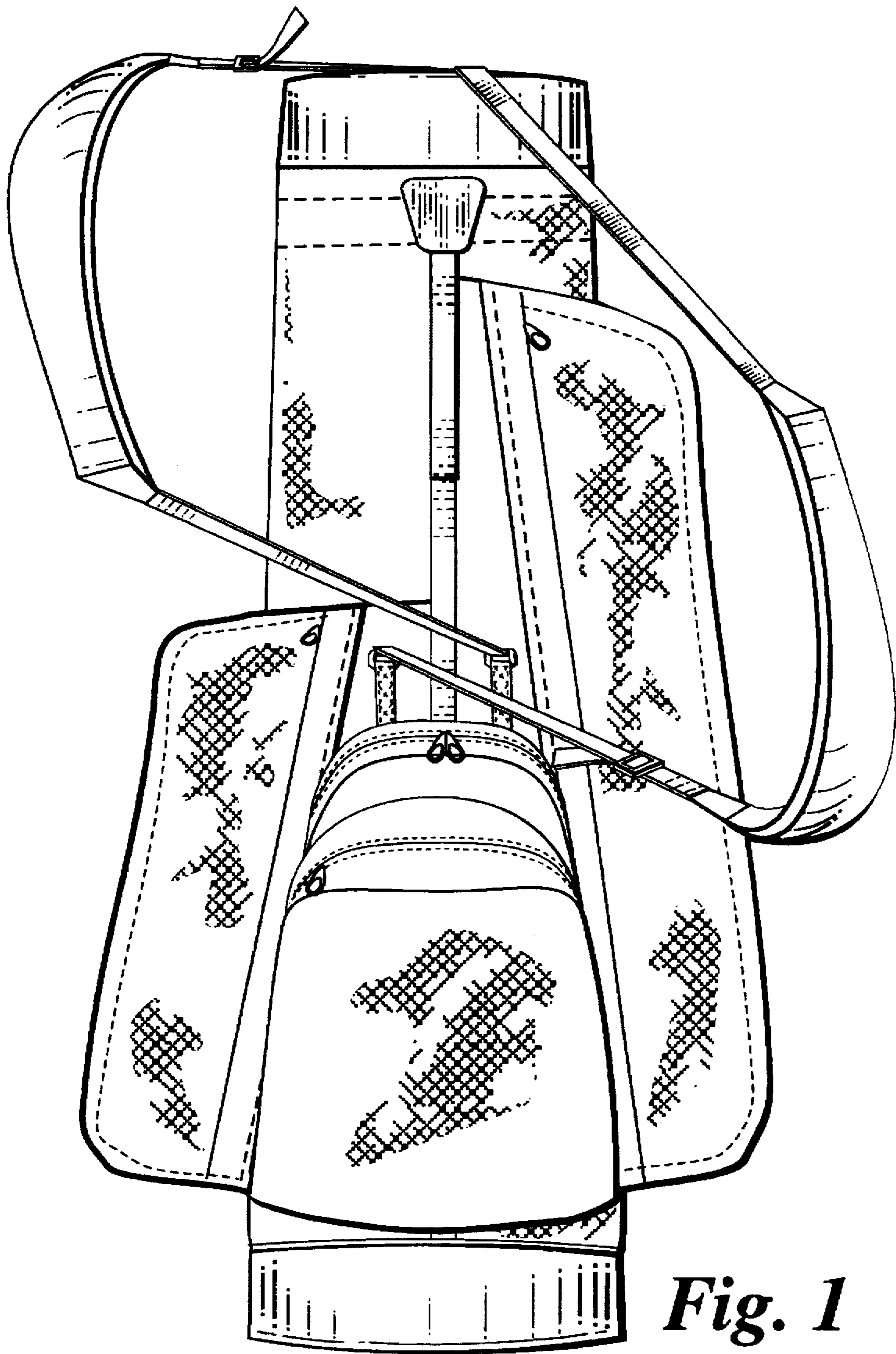

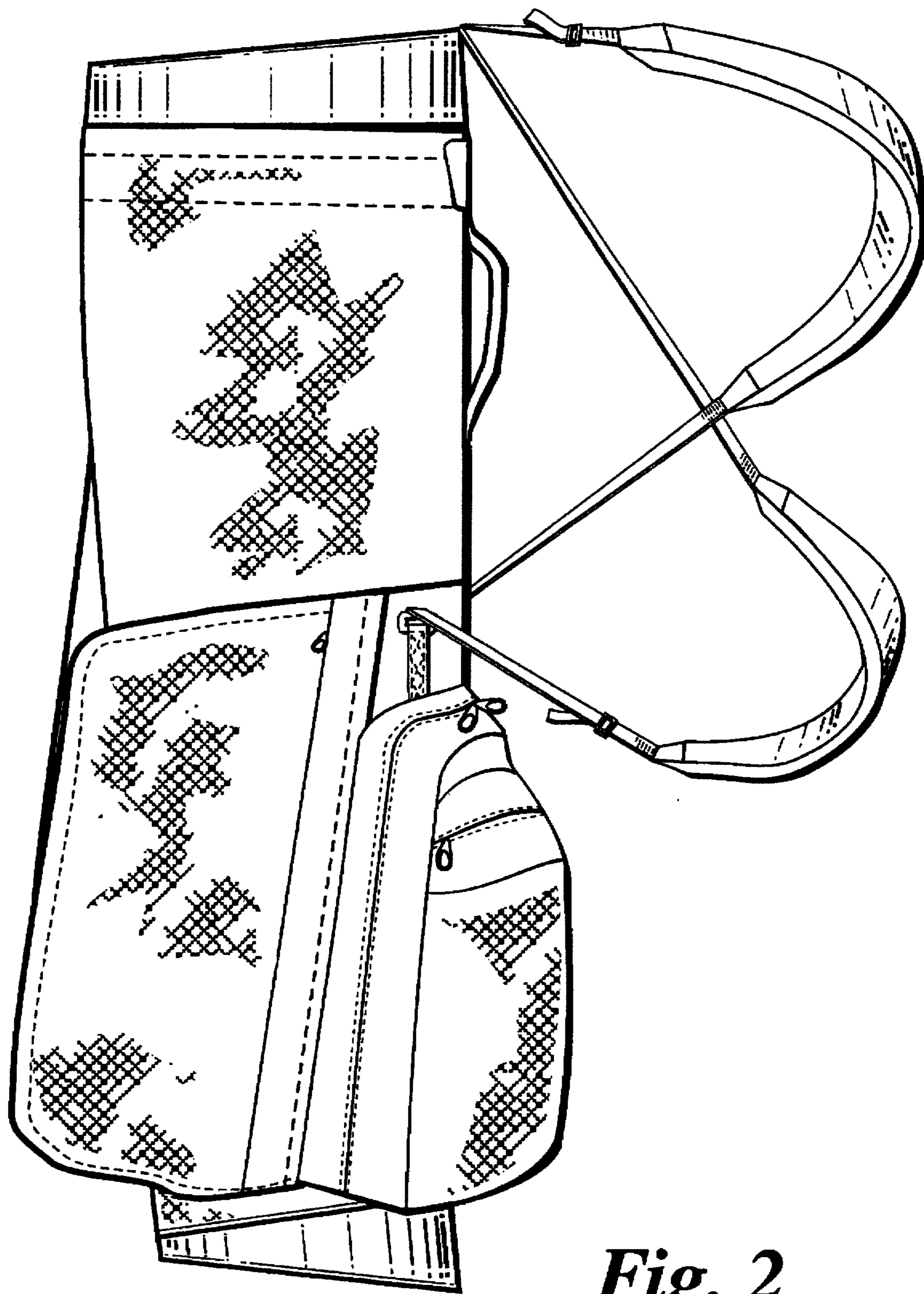

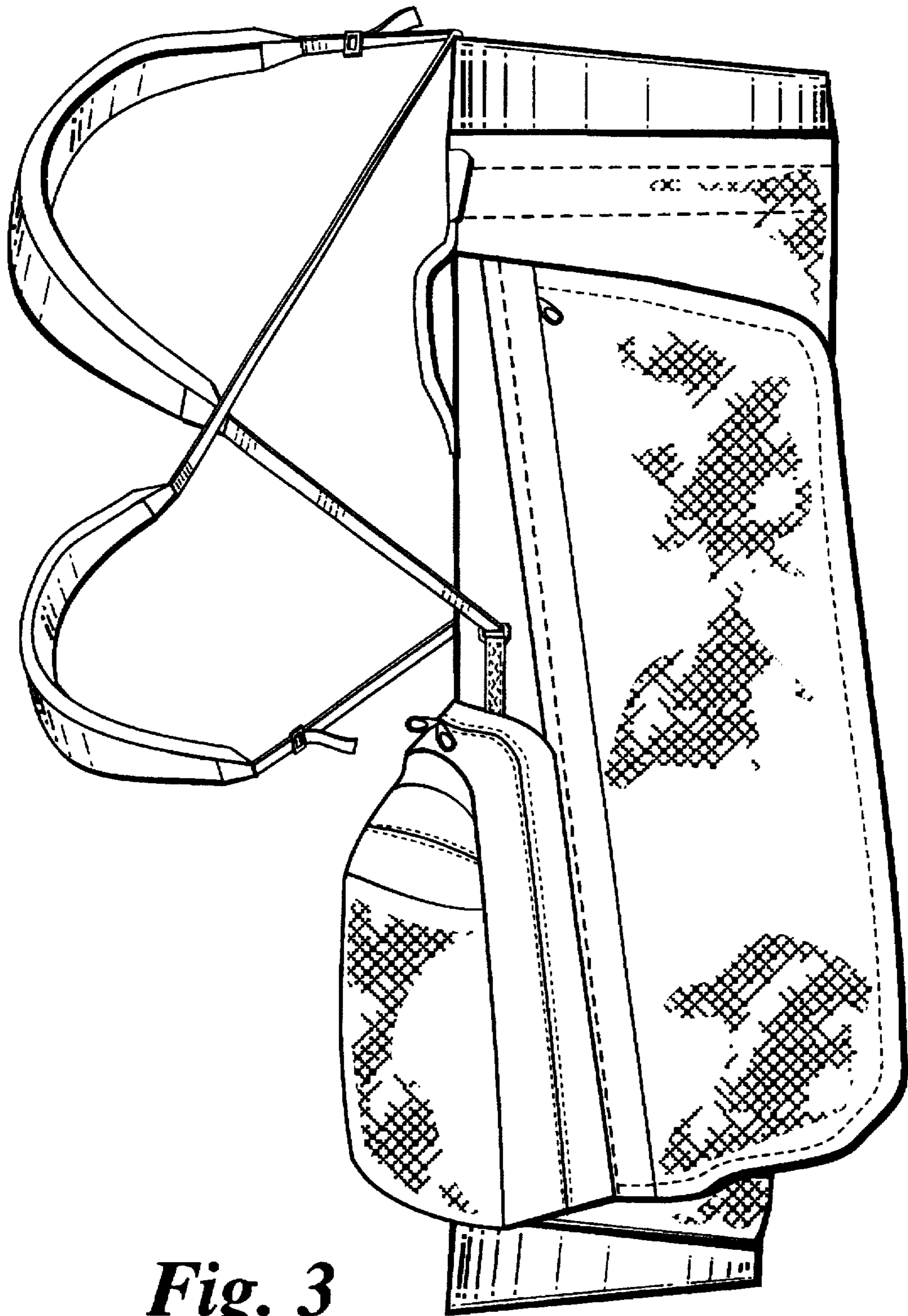

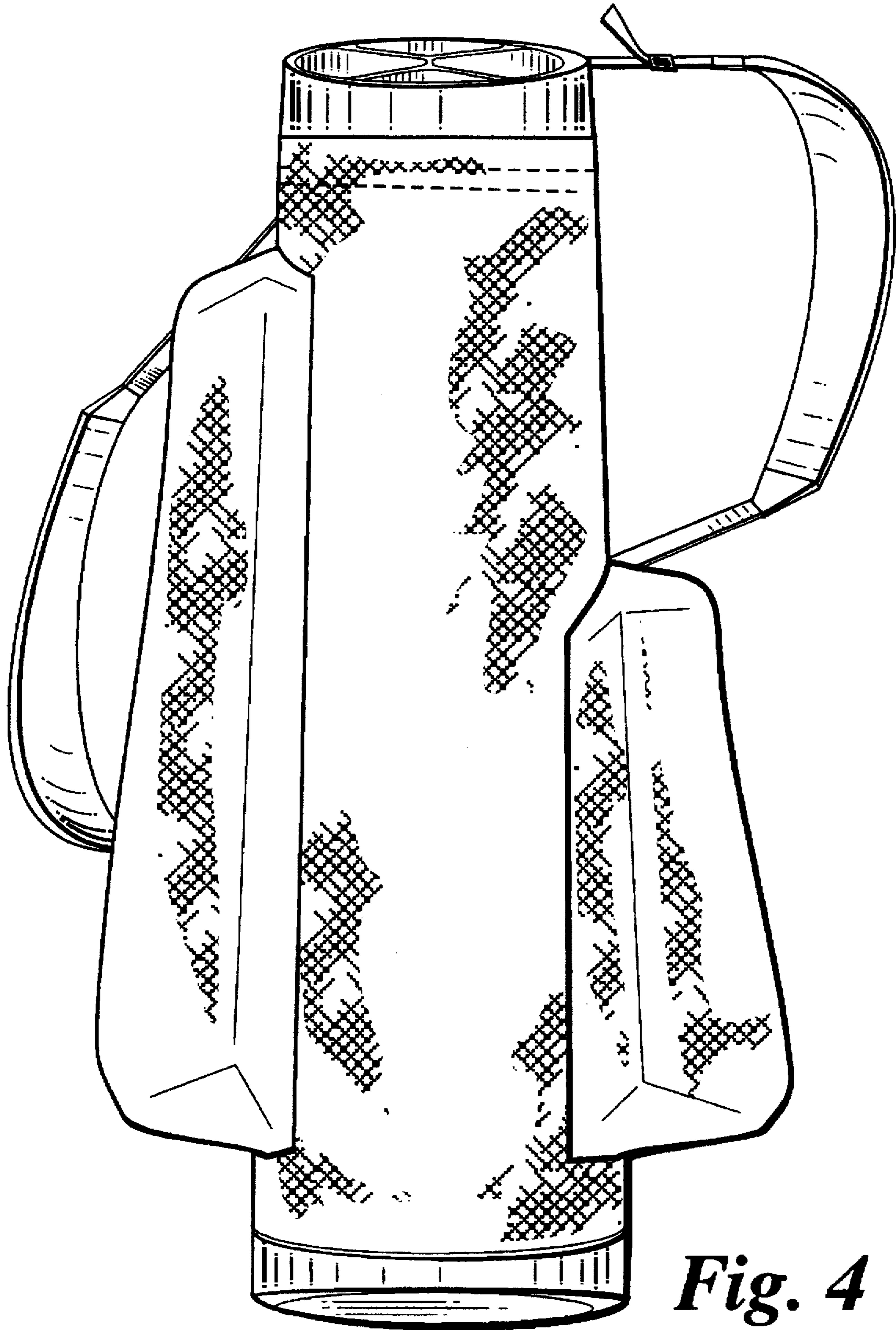

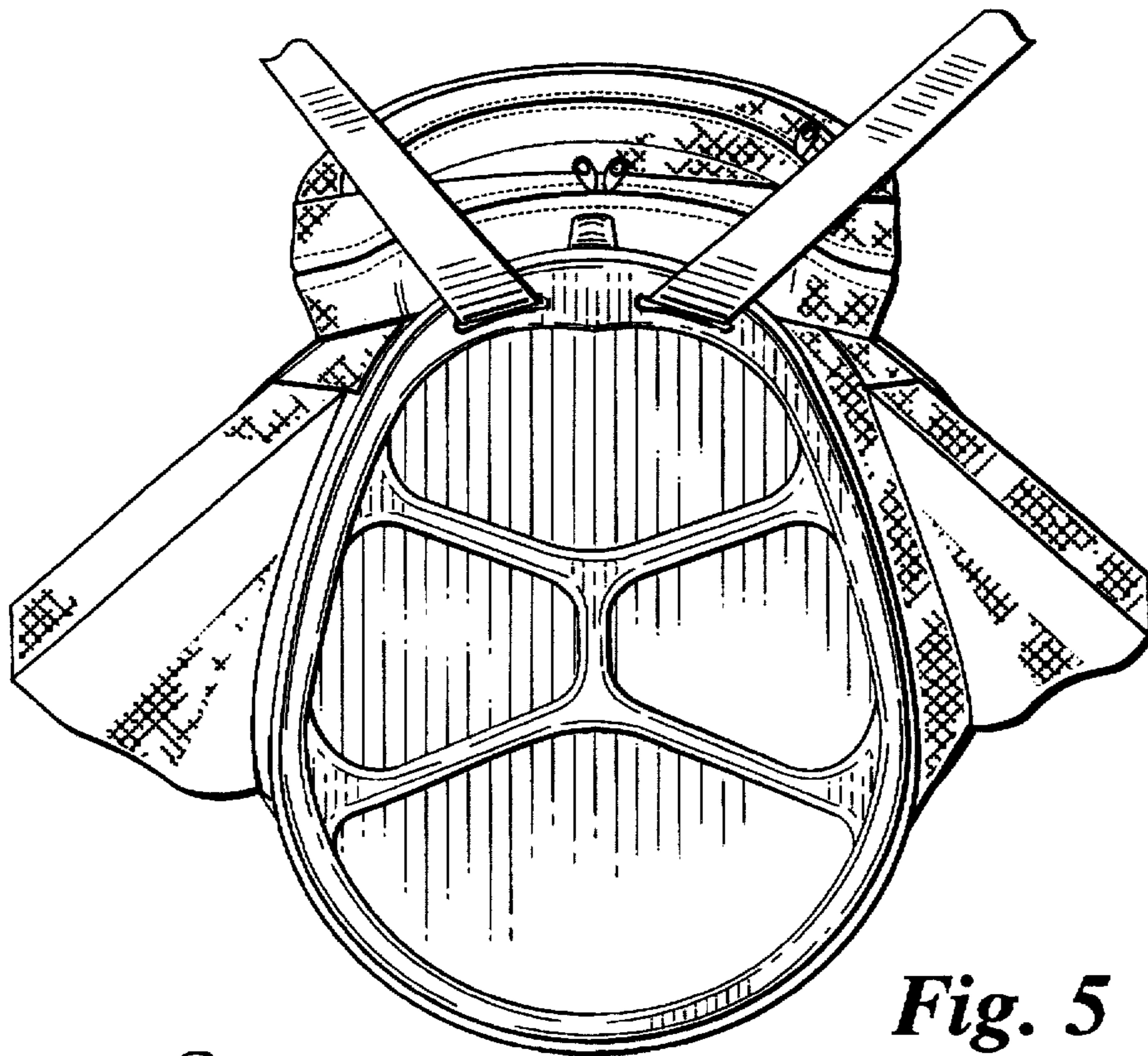

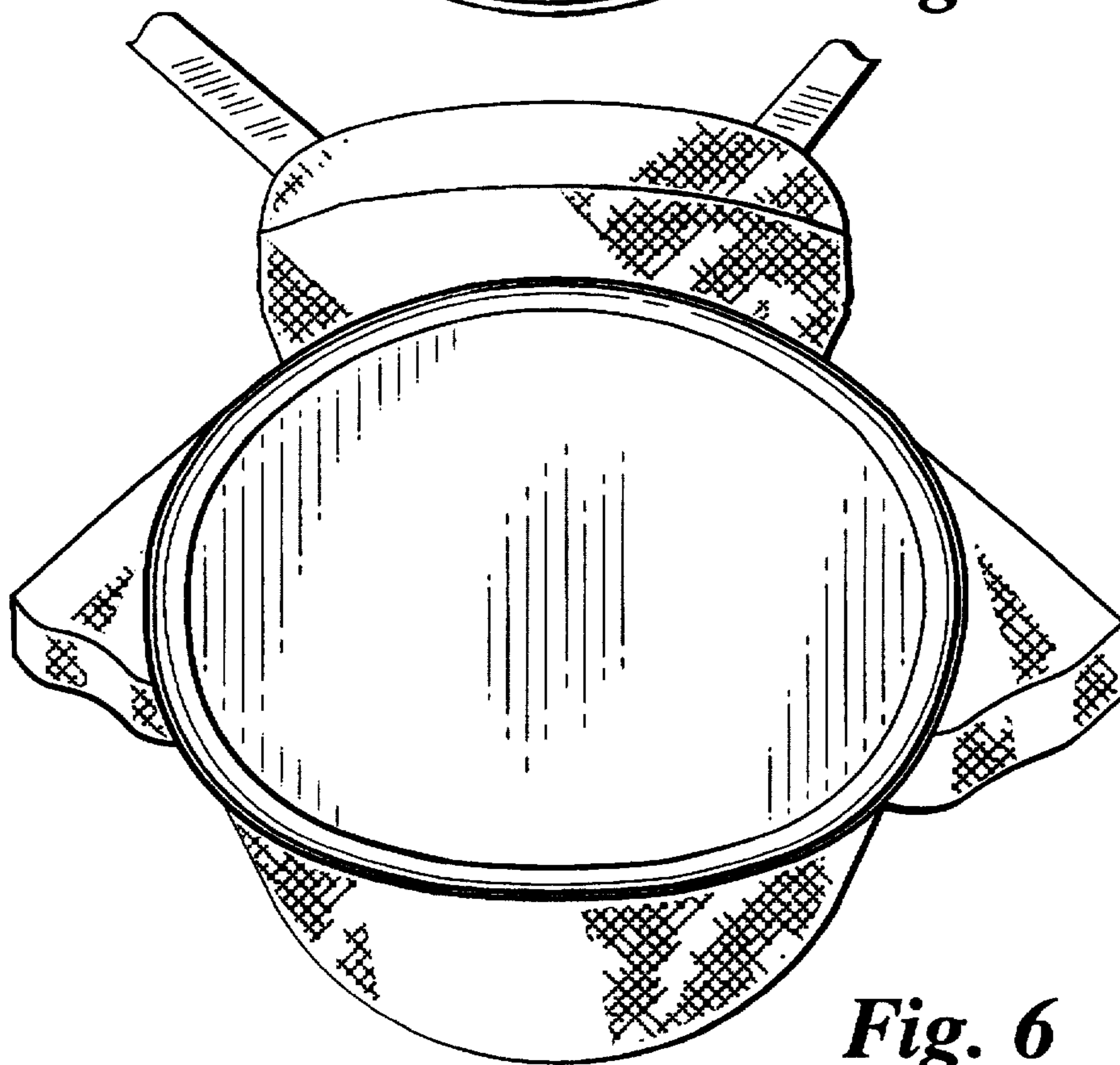
