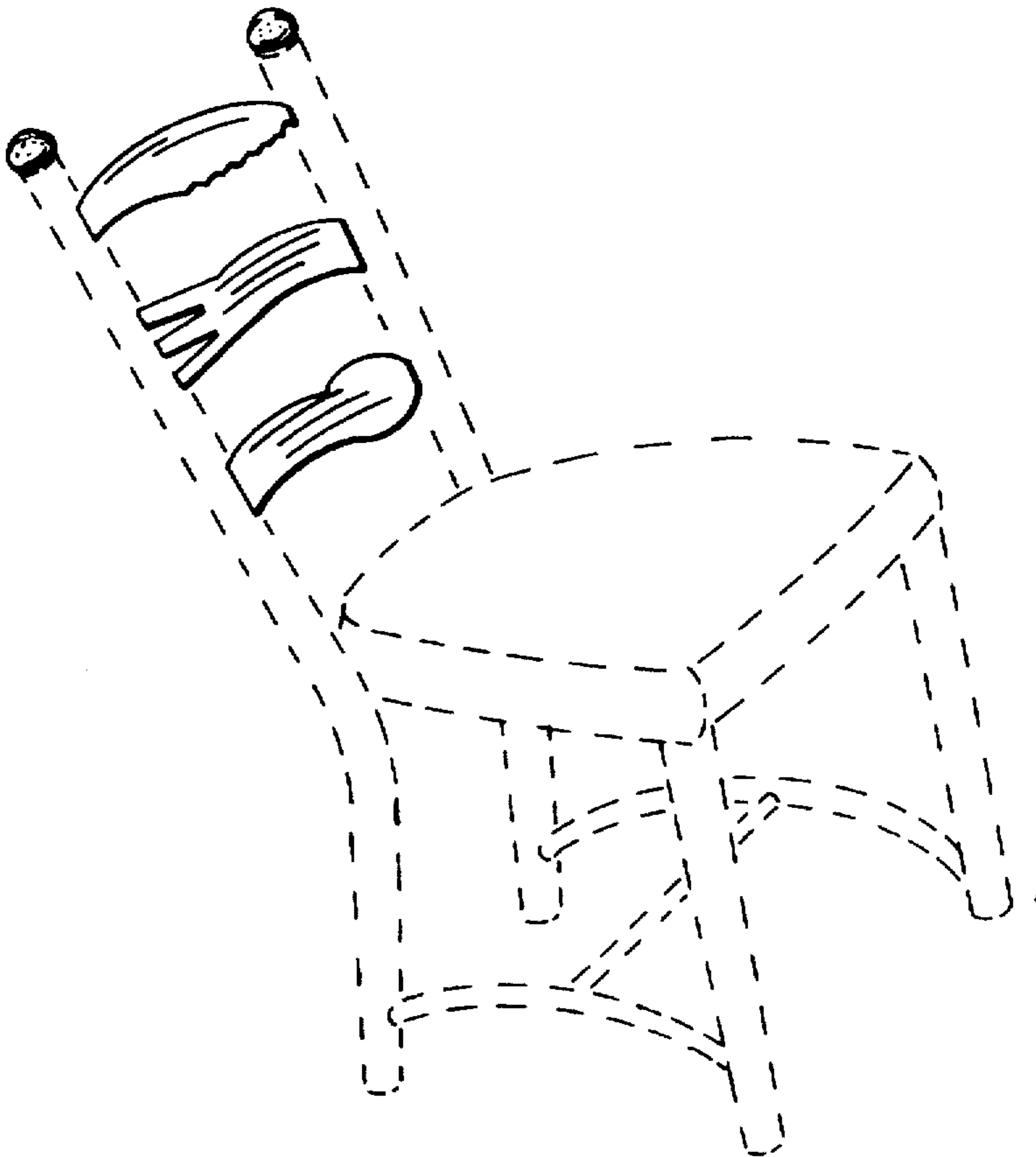
[57] **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a chair, showing my new design;
FIG. 2 is a rear perspective view thereof;
FIG. 3 is a front perspective view of a second embodiment of the design shown in FIG. 1;
FIG. 4 is a rear perspective view thereof;
FIG. 5 is a front perspective view of a third embodiment of the design shown in FIG. 1;
FIG. 6 is a rear perspective view thereof;
FIG. 7 is a front perspective view of a fourth embodiment of the design shown in FIG. 1;
FIG. 8 is a rear perspective view thereof;
FIG. 9 is a front perspective view of a fifth embodiment of the design shown in FIG. 1;

FIG. 11 is a front perspective view of a sixth embodiment of the design shown in FIG. 1; and
FIG. 12 is a rear perspective view thereof.

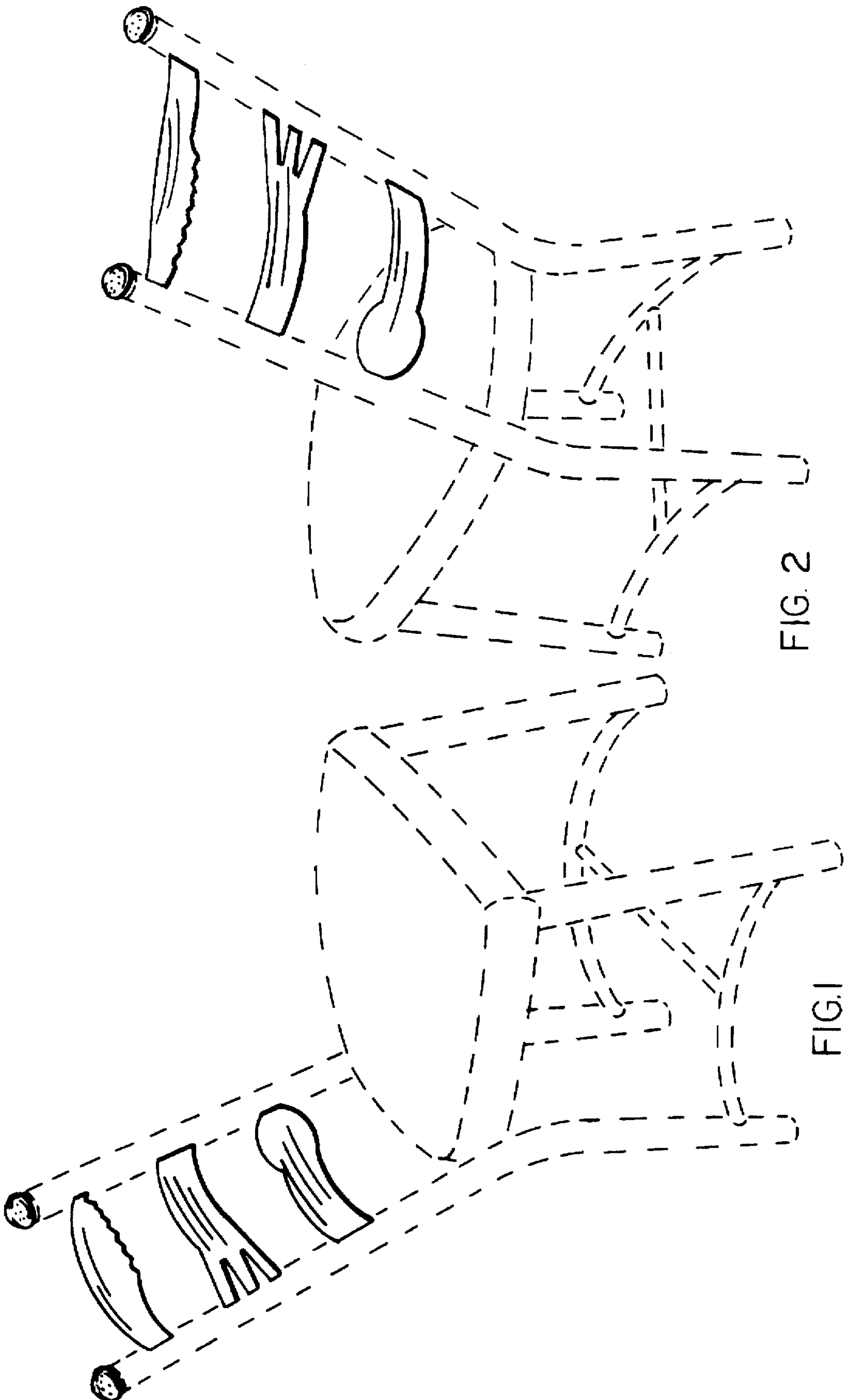

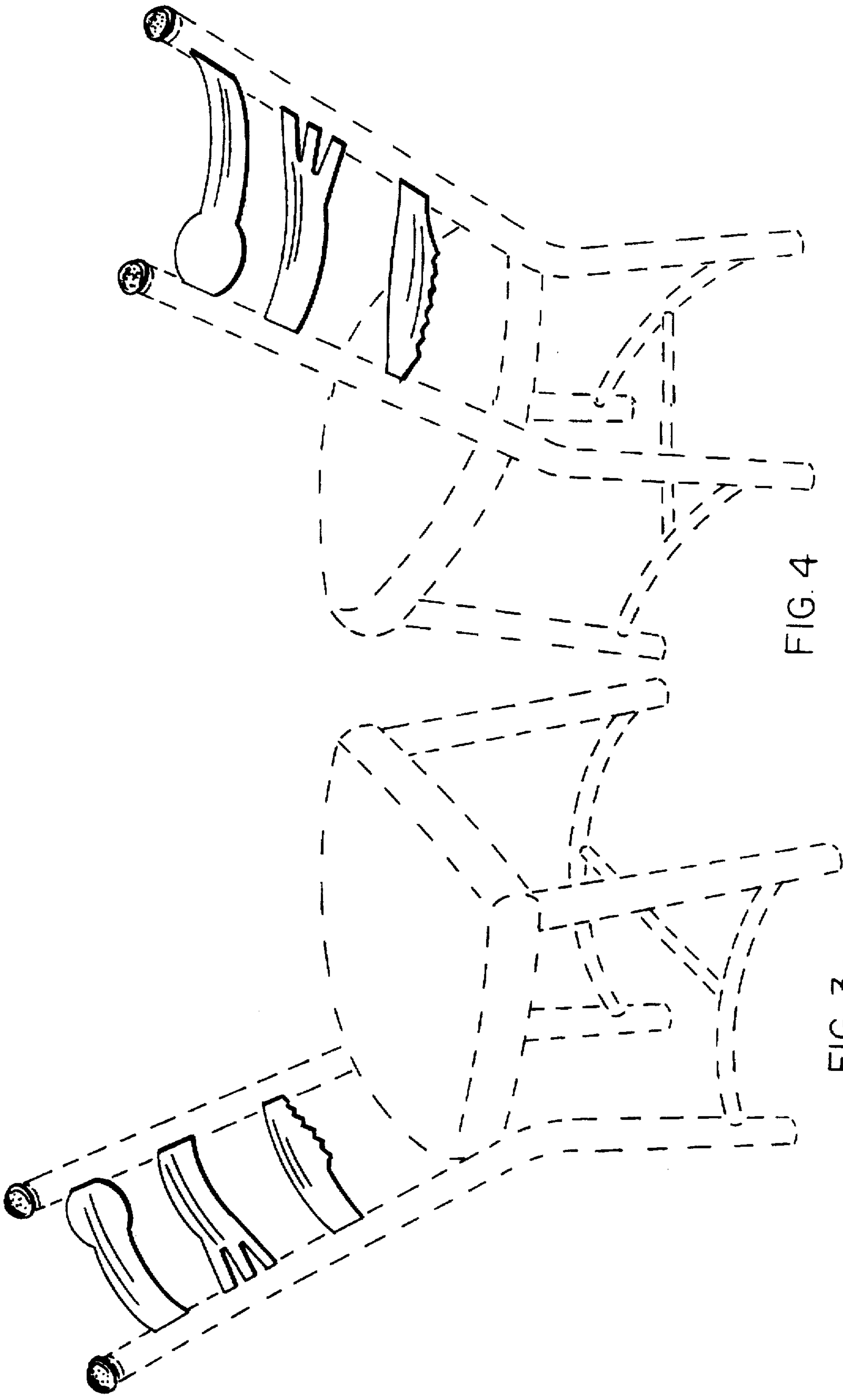
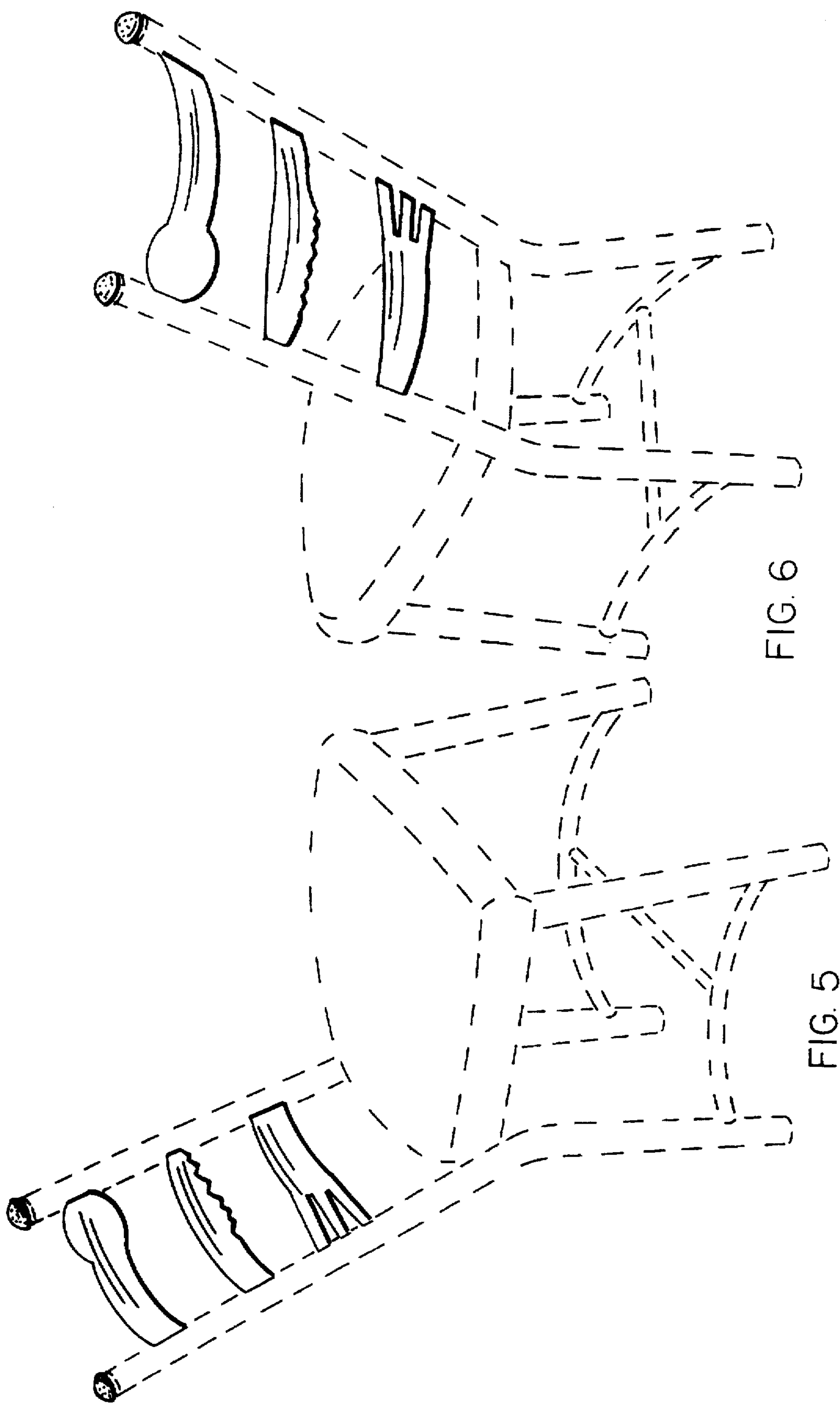
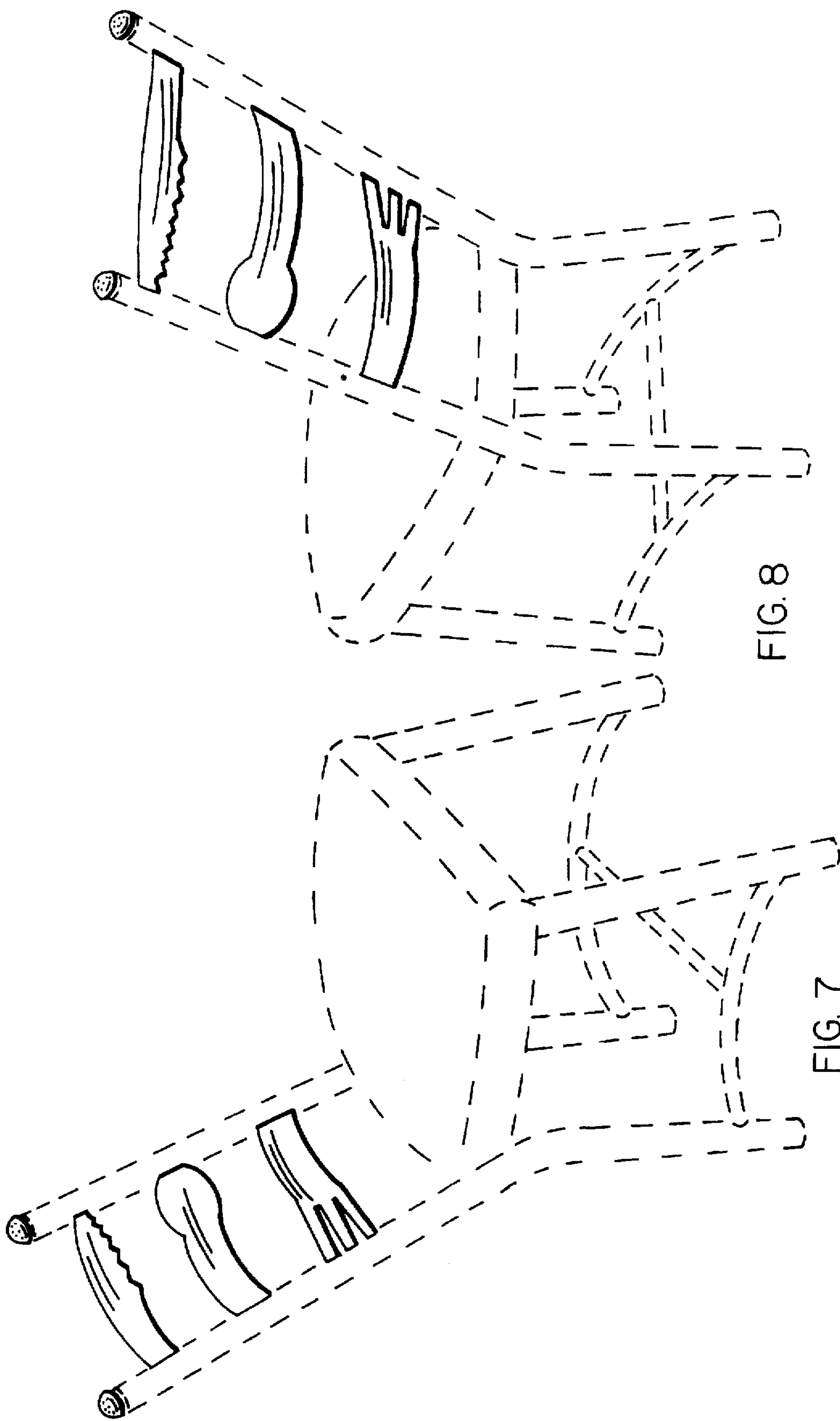
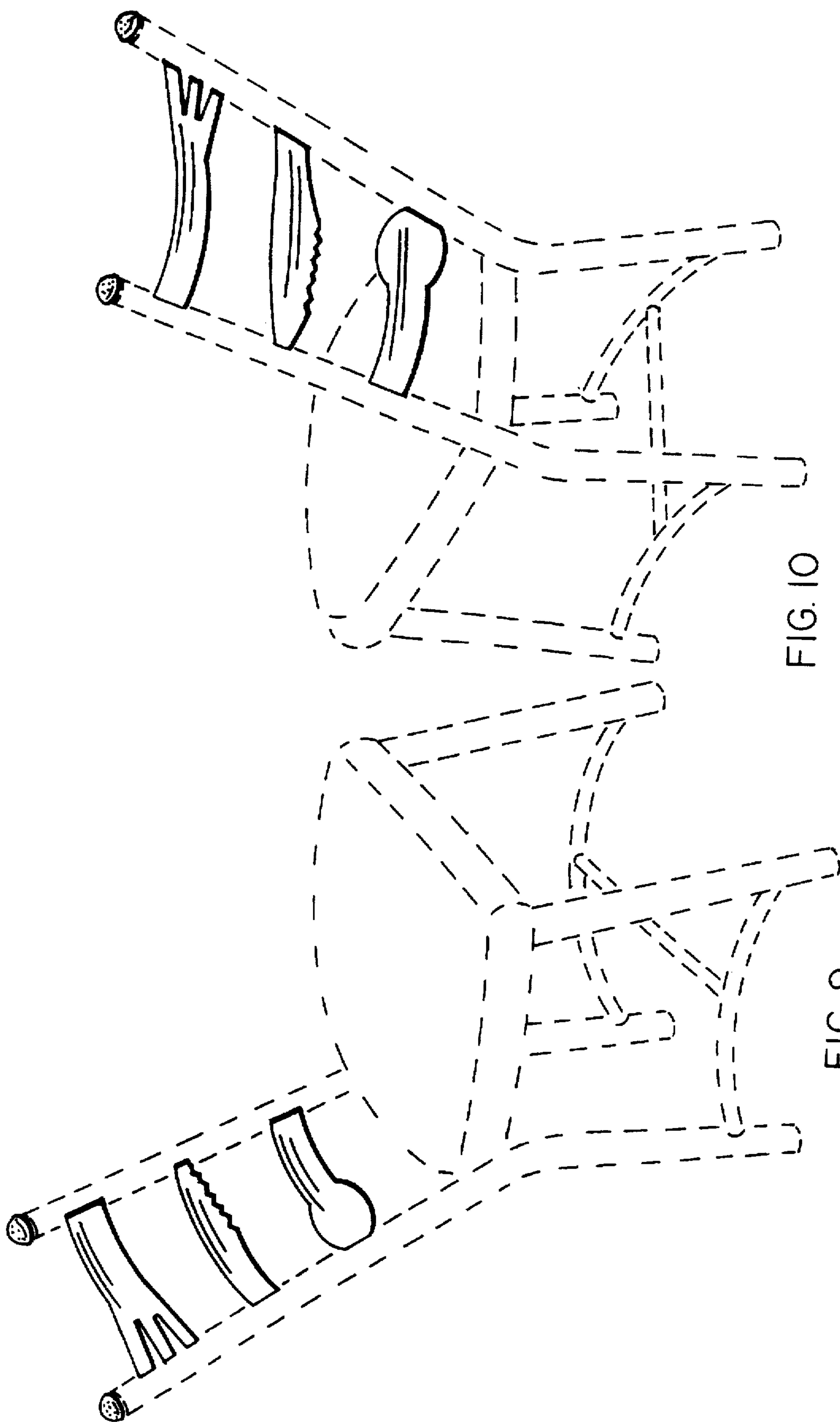

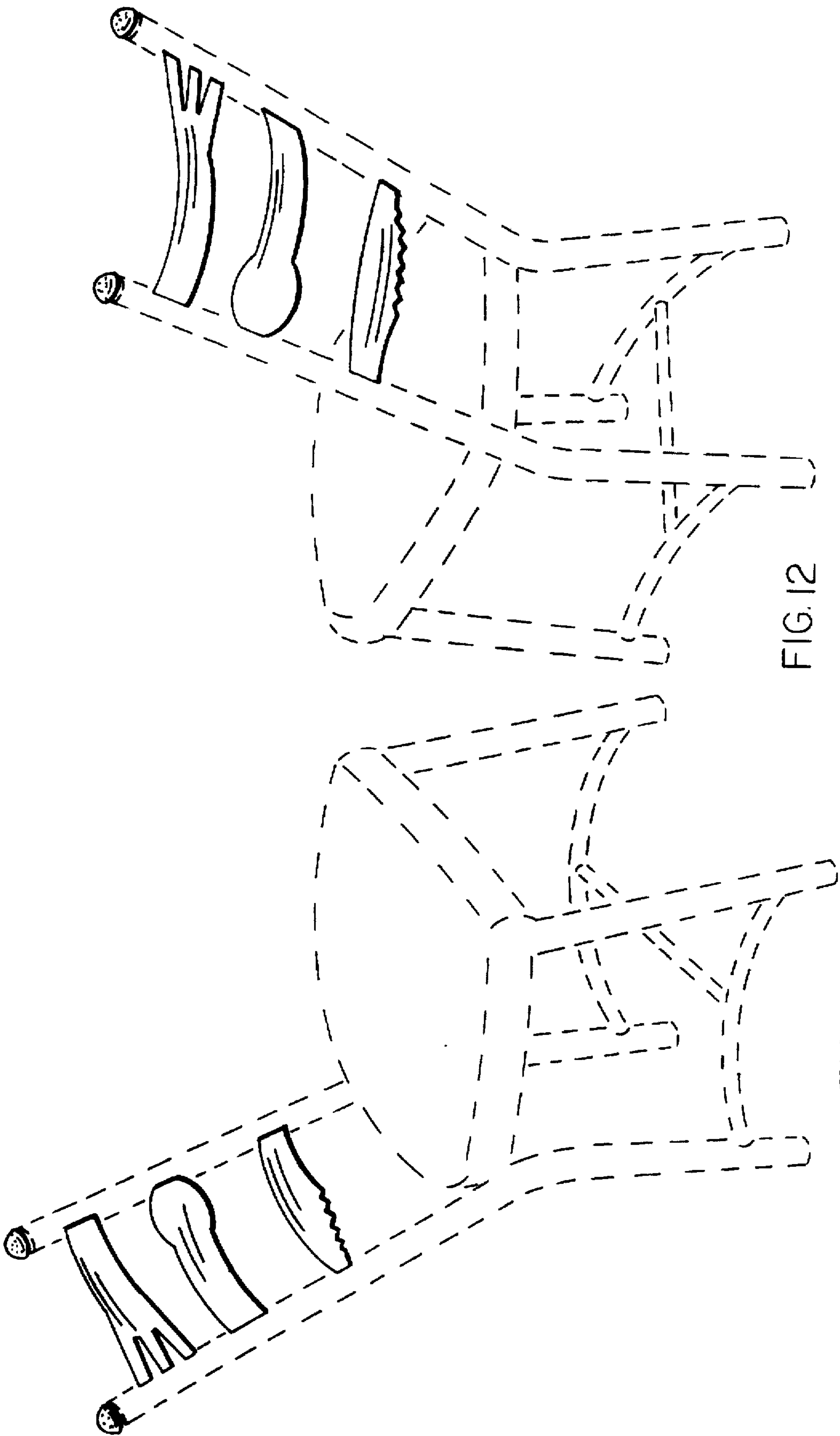
