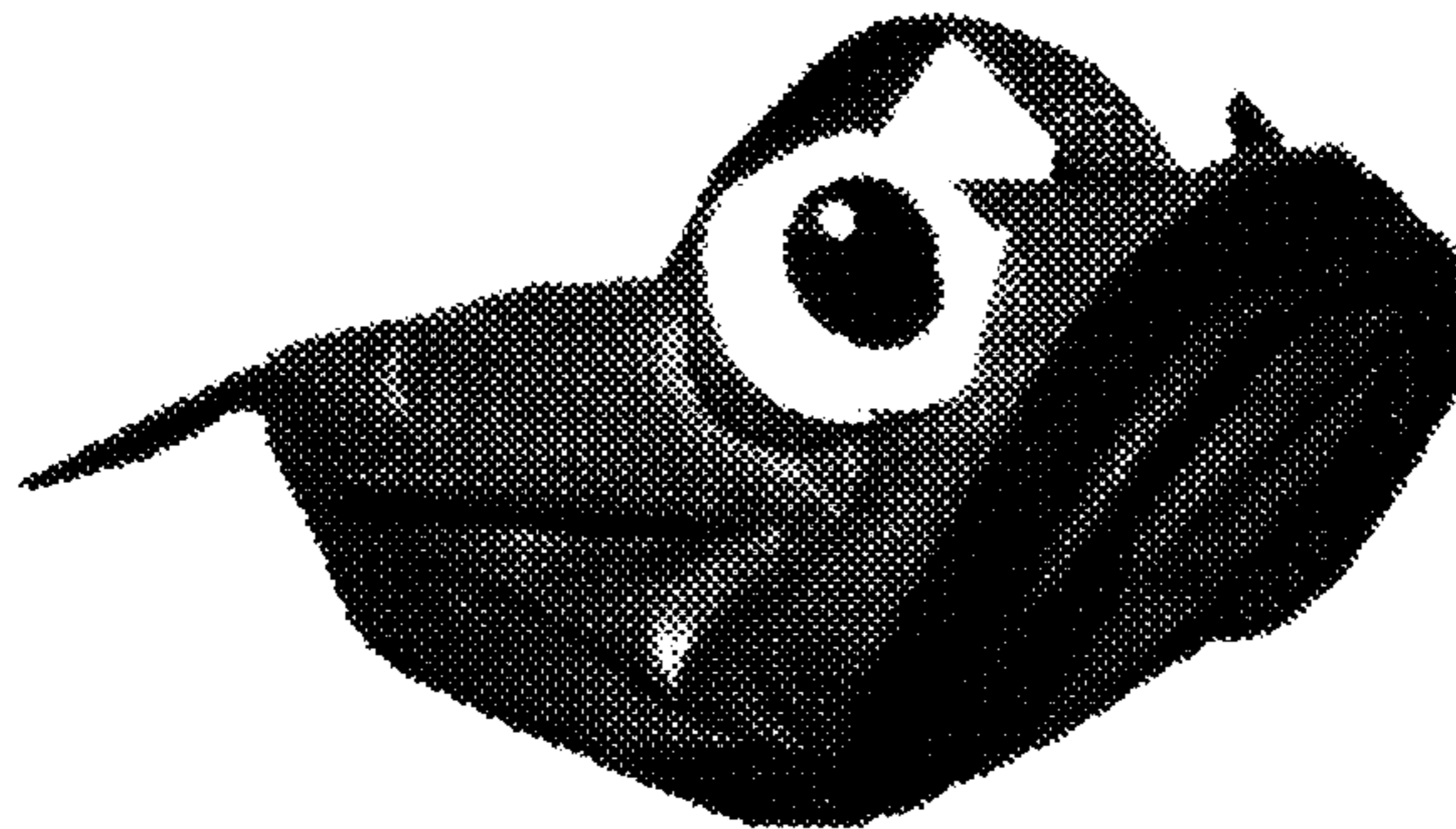
[57] **CLAIM**

DESCRIPTION

FIG. 1 is a top left front perspective view of a lunch container showing my new design;

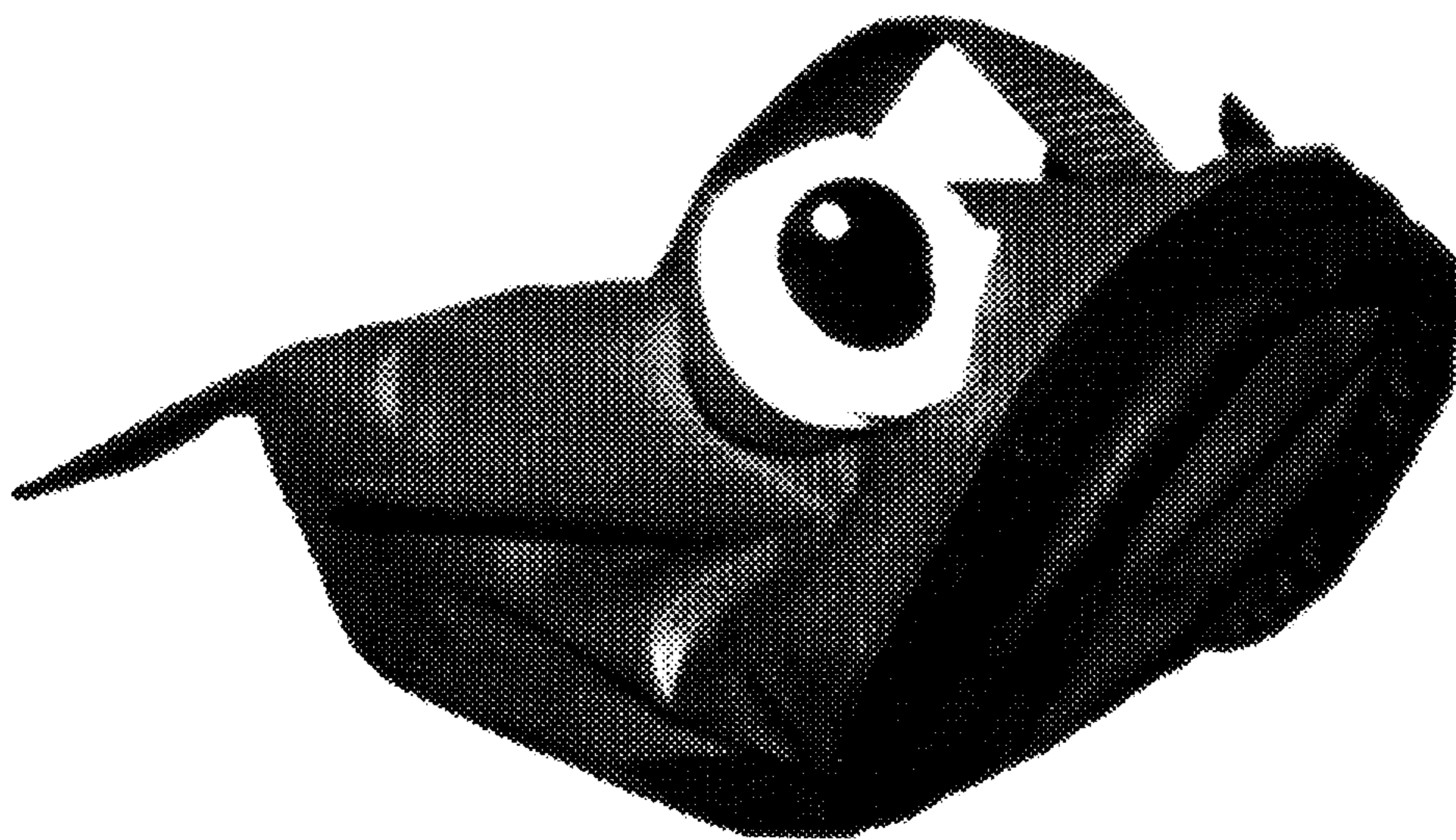

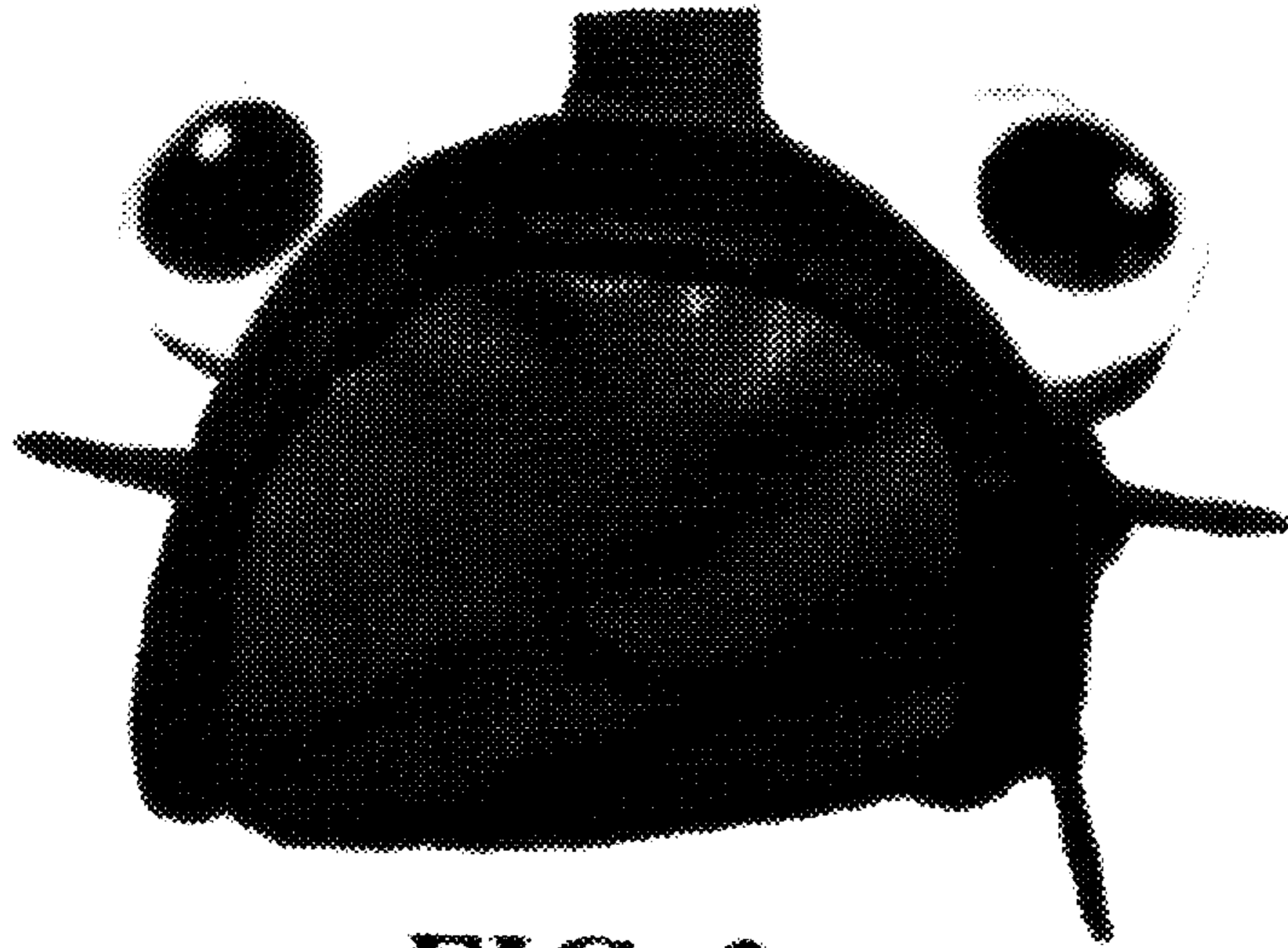

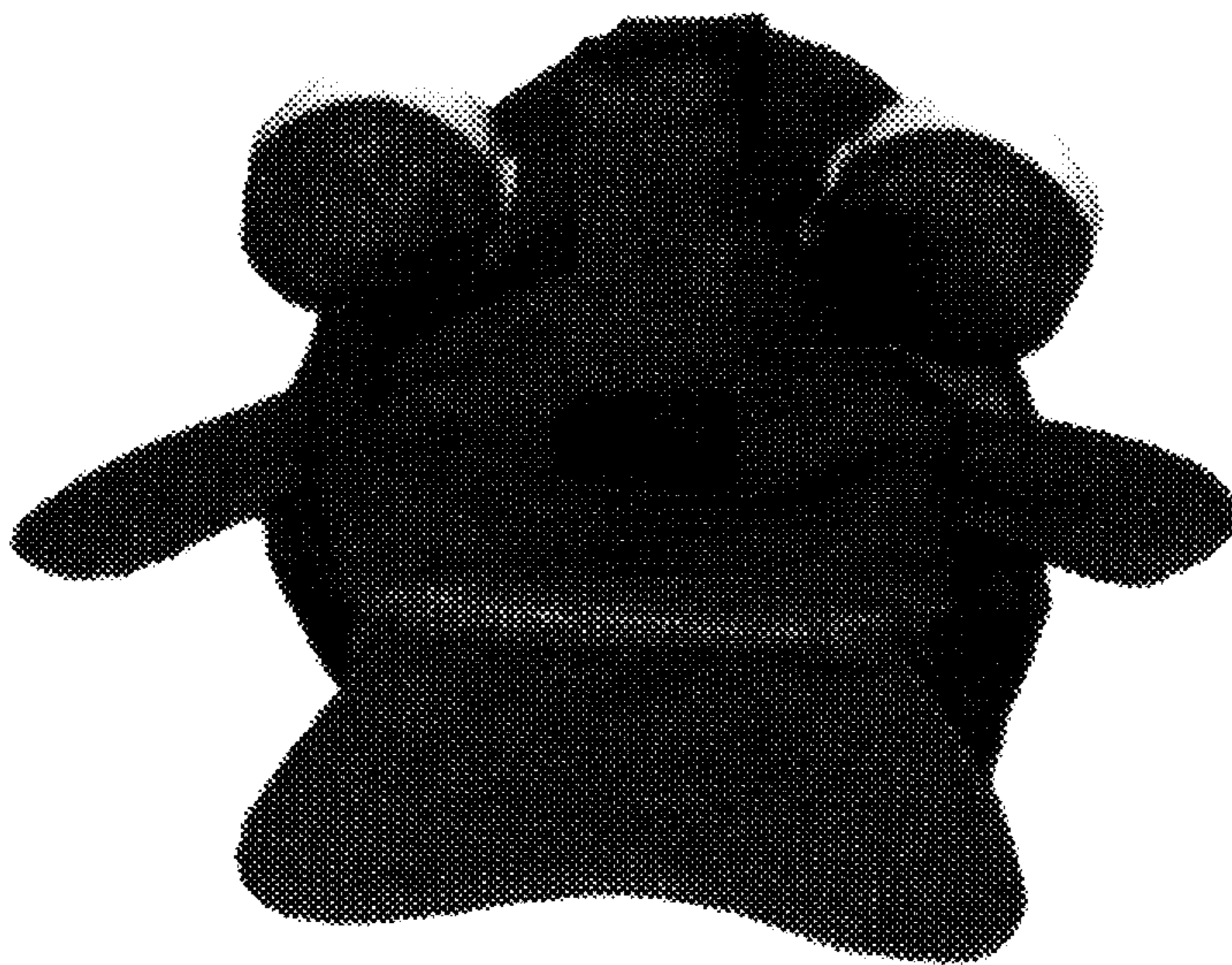

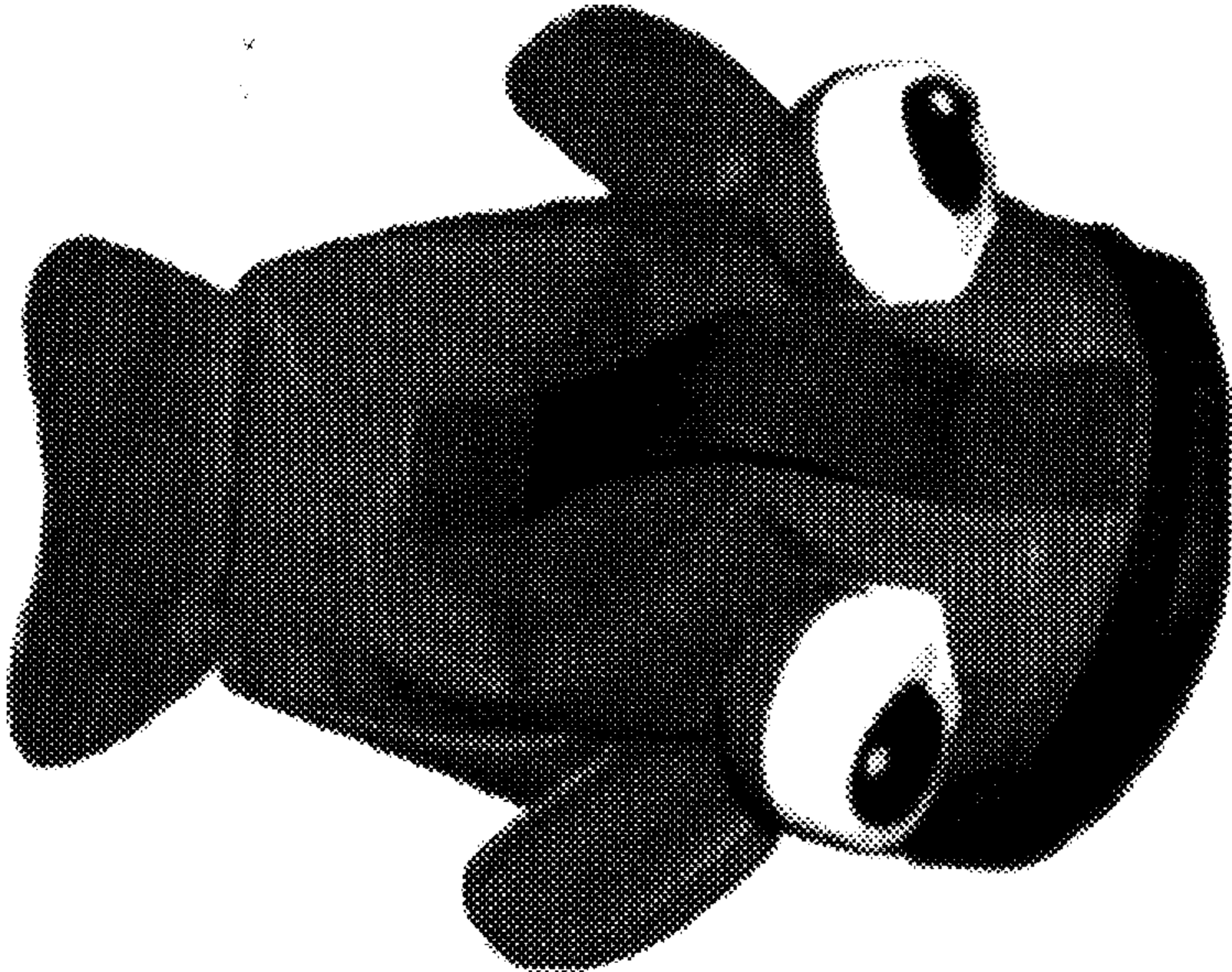
