### DESCRIPTION

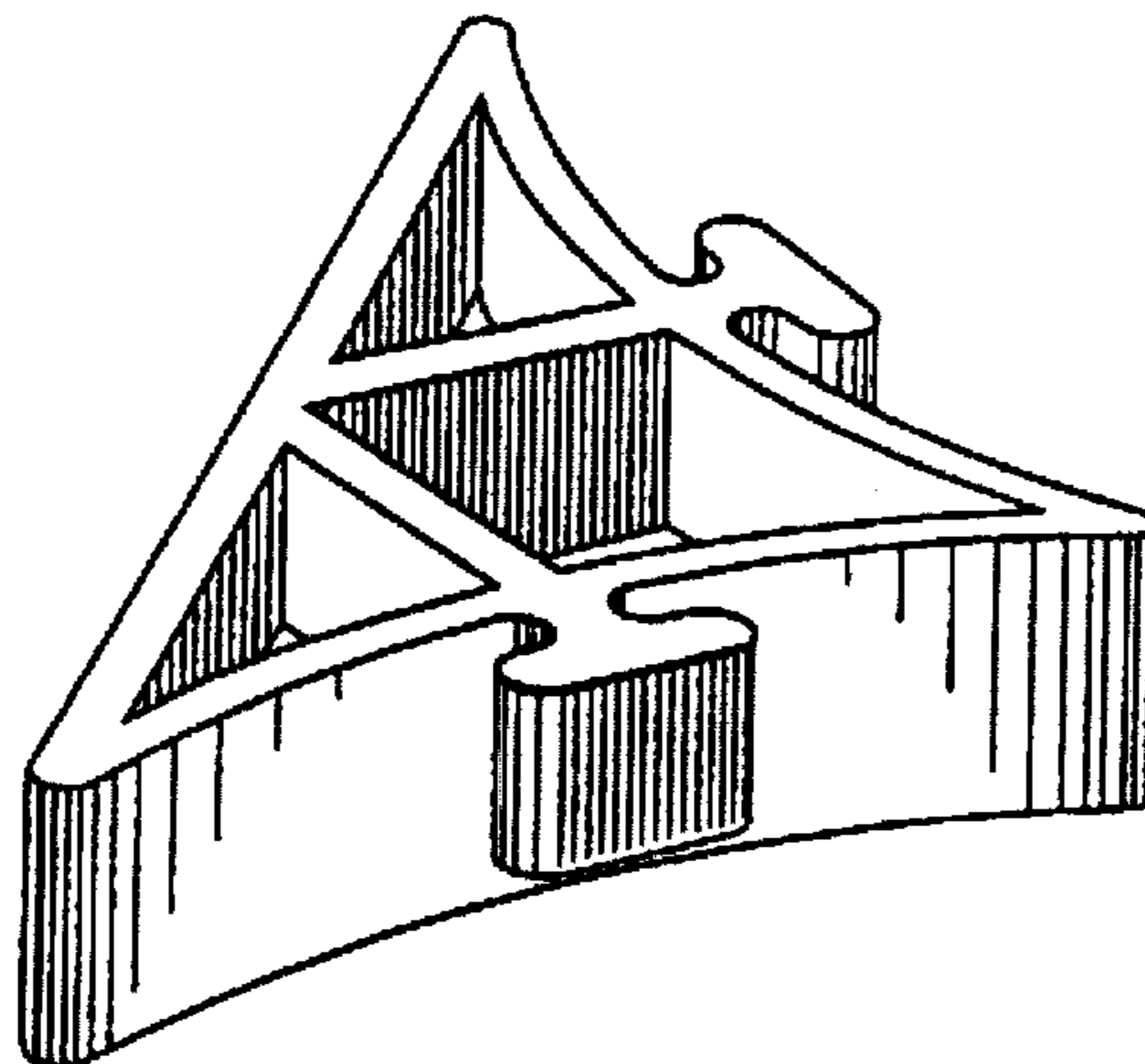
FIG. 1 is a top plan view of a filter connector clip showing my new design;

FIG. 6 is a top plan view thereof.

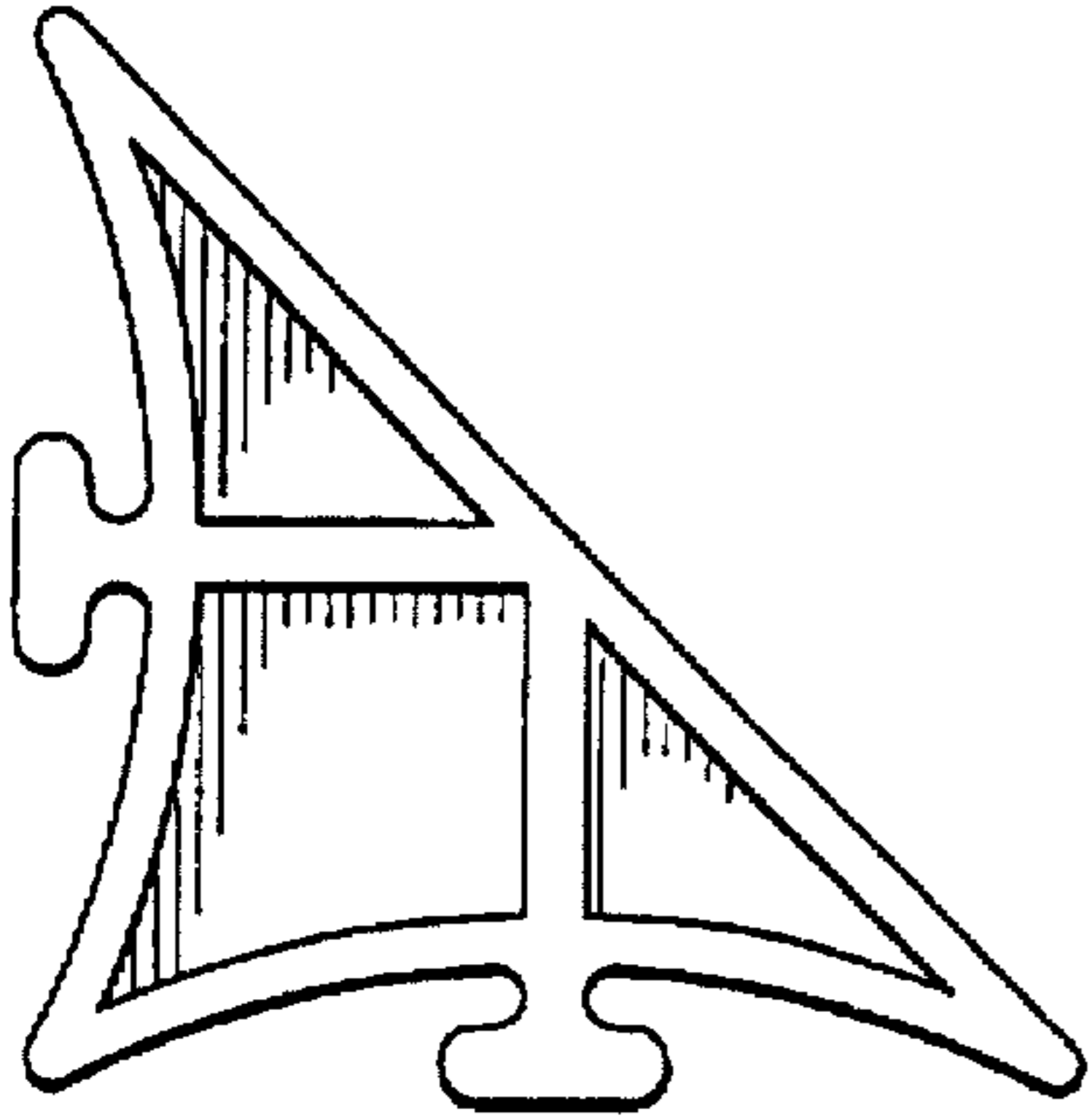

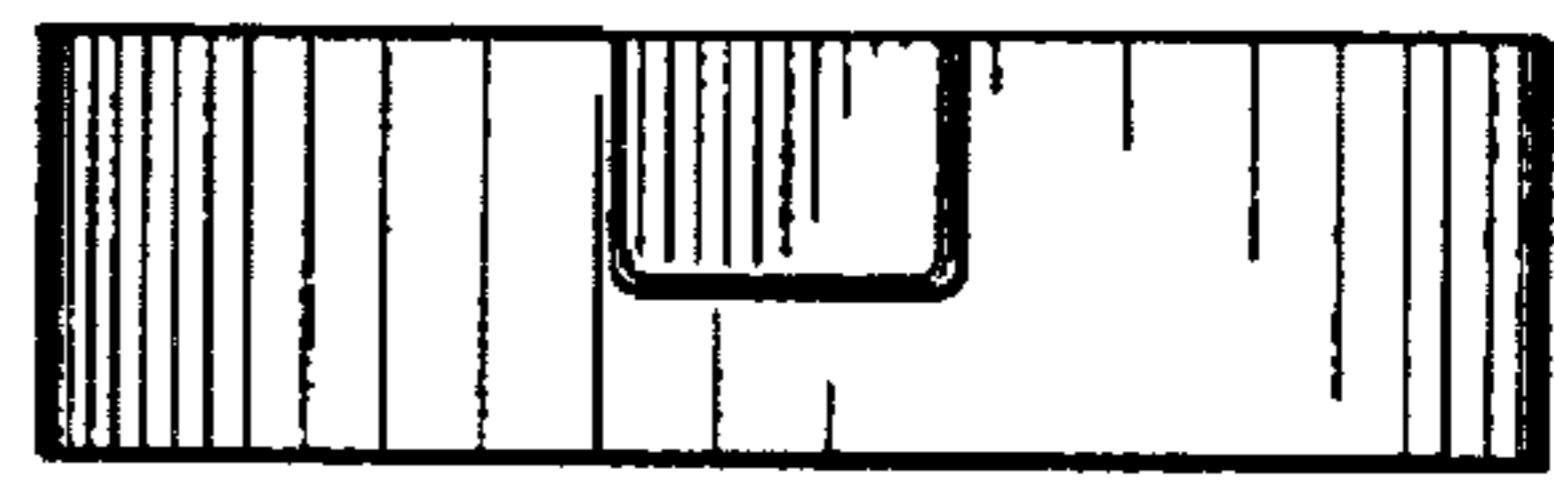

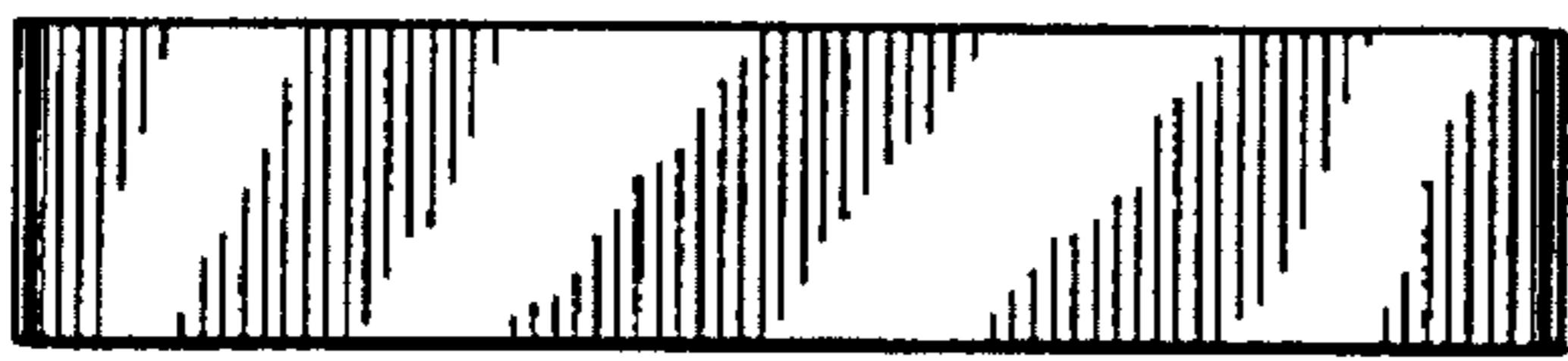

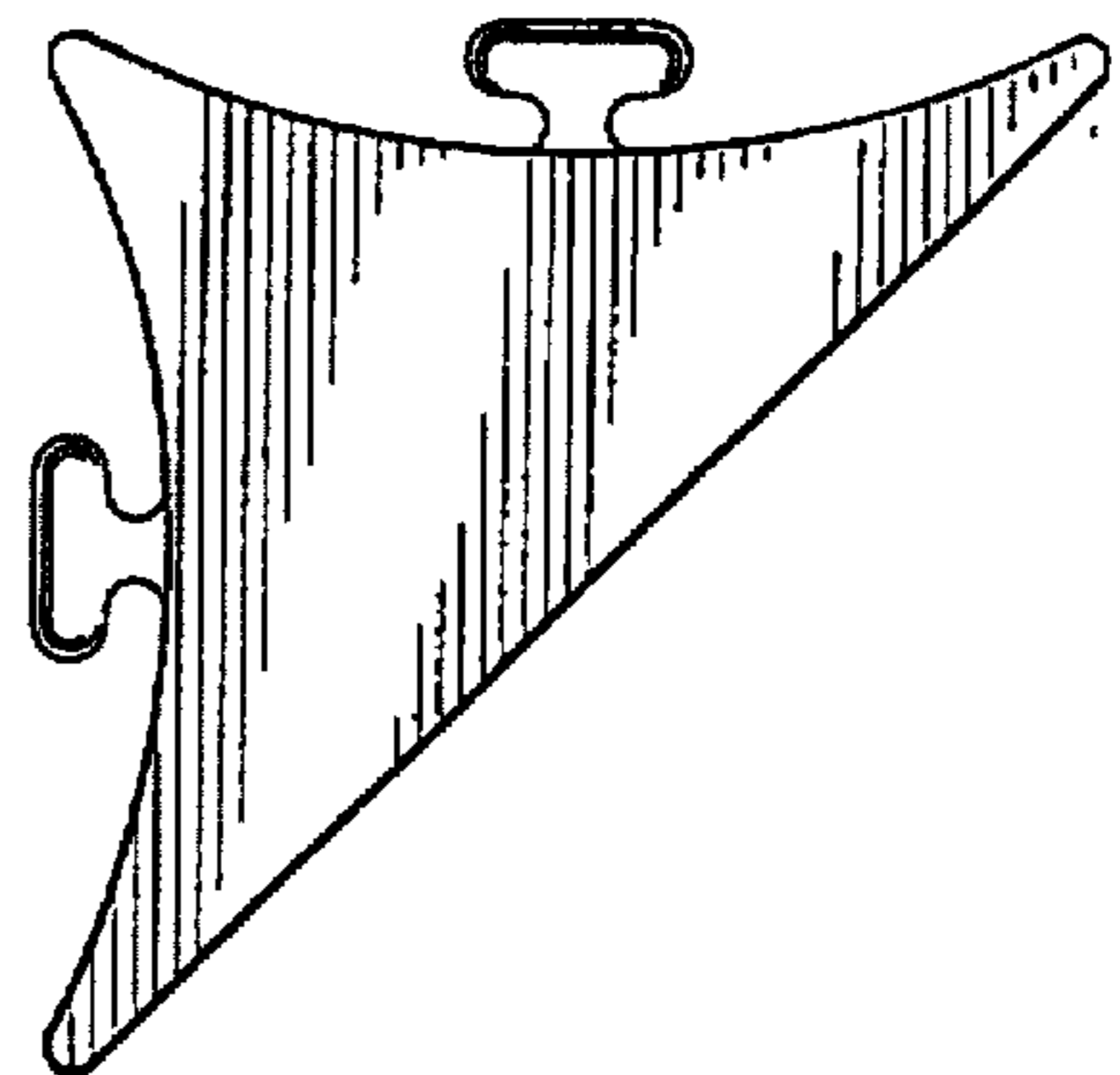

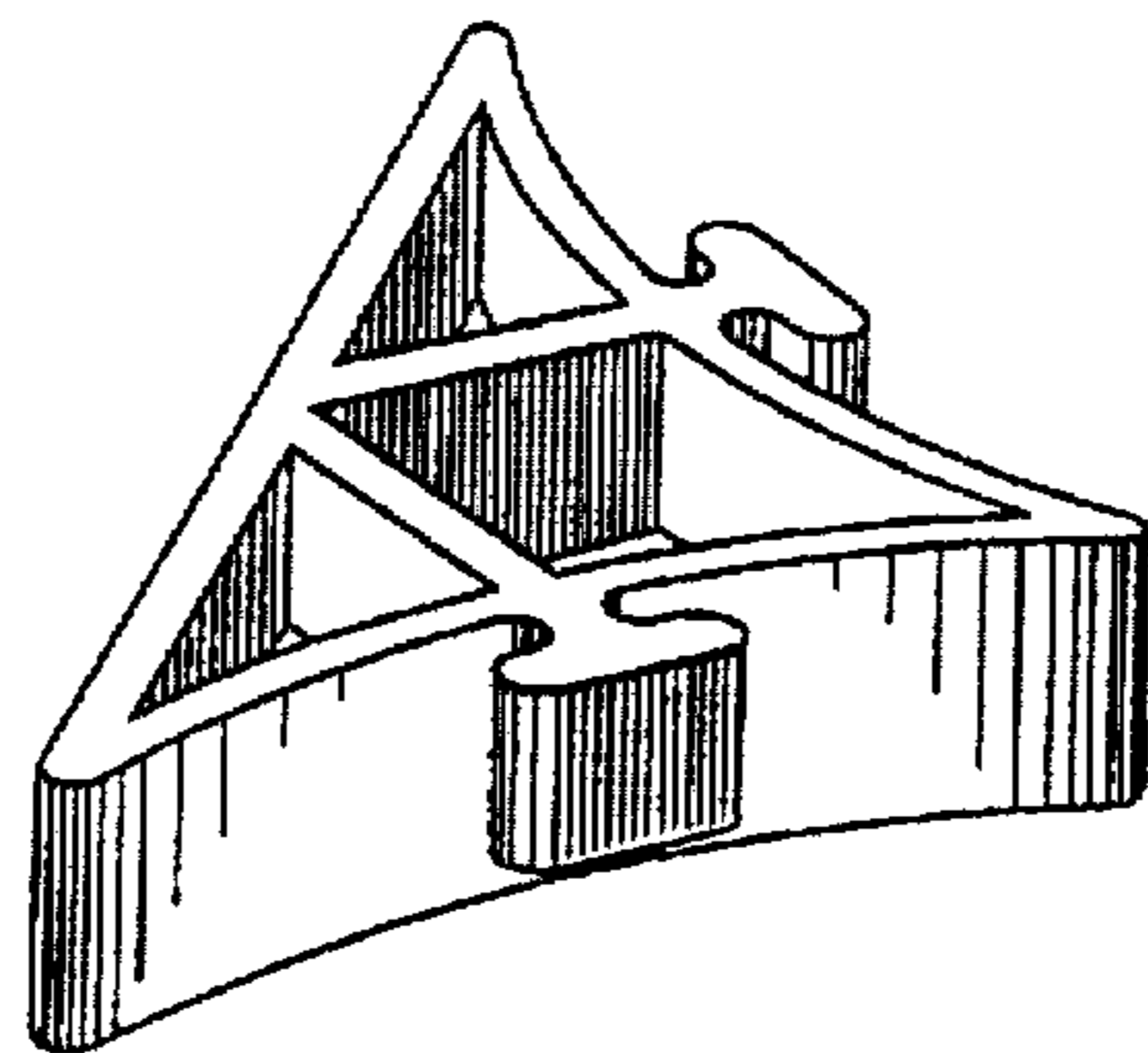

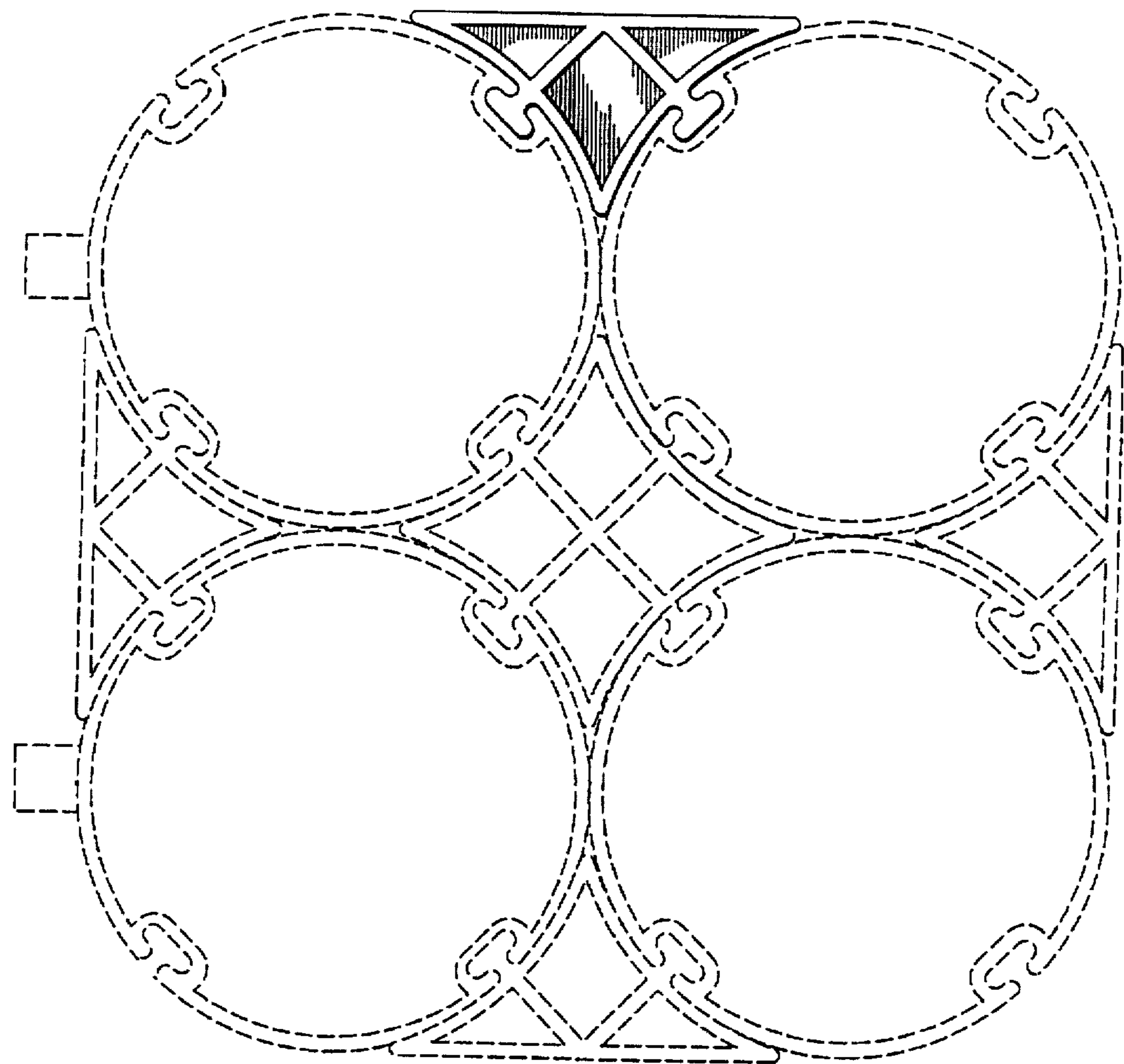
