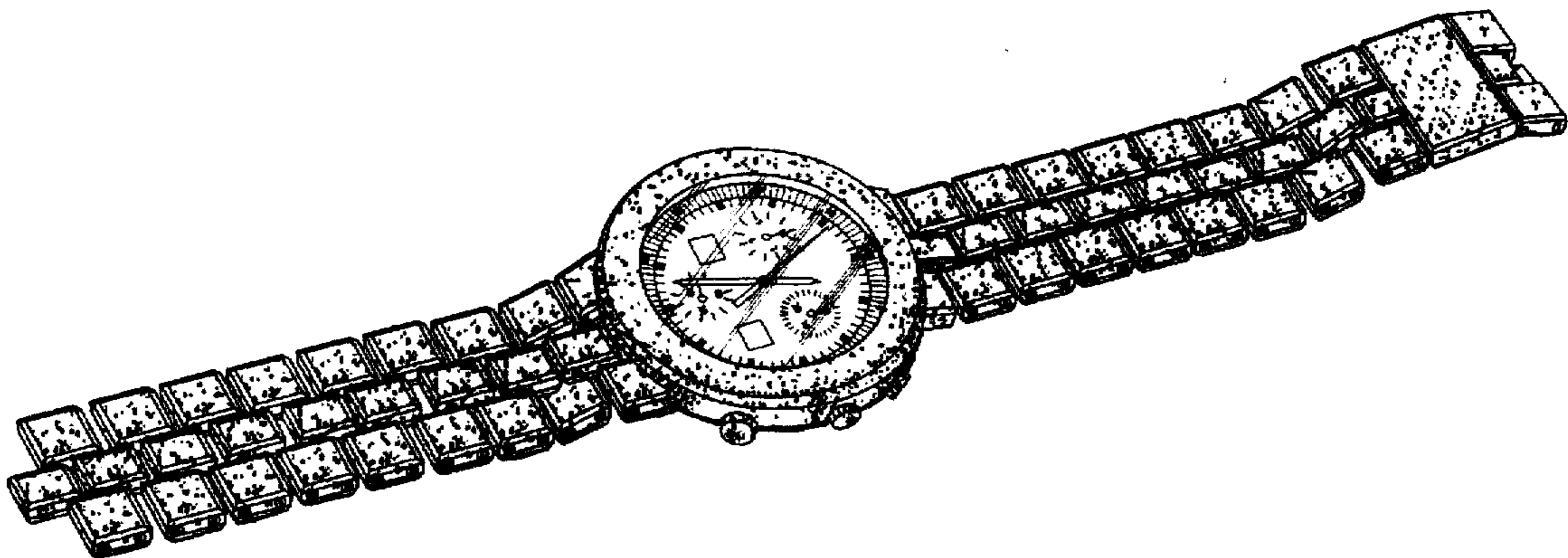
[57] **CLAIM**

The ornamental design for a wristwatch with band, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a wristwatch with band showing my new design;
 FIG. 2 is a bottom plan view thereof;
 FIG. 3 is a right side elevational view thereof;
 FIG. 4 is a left side elevational view thereof;
 FIG. 5 is a front elevational view thereof;
 FIG. 6 is a rear elevational view thereof;
 FIG. 7 is a top right perspective view thereof;
 FIG. 8 is a top plan view of another embodiment of my new design of FIGS. 1-7;
 FIG. 9 is a bottom plan view thereof;
 FIG. 10 is a right side elevational view thereof;
 FIG. 11 is a left side elevational view thereof;
 FIG. 12 is a front elevational view thereof;
 FIG. 13 is a rear elevational view thereof;
 FIG. 14 is a top right perspective view thereof;
 FIG. 15 is an enlarged top plan view of a link portion of the second embodiment of my new design, the watch portion having been omitted for ease of illustration;
 FIG. 16 is a bottom plan view of FIG. 15; and,
 FIG. 17 is a top right perspective view of FIG. 15.

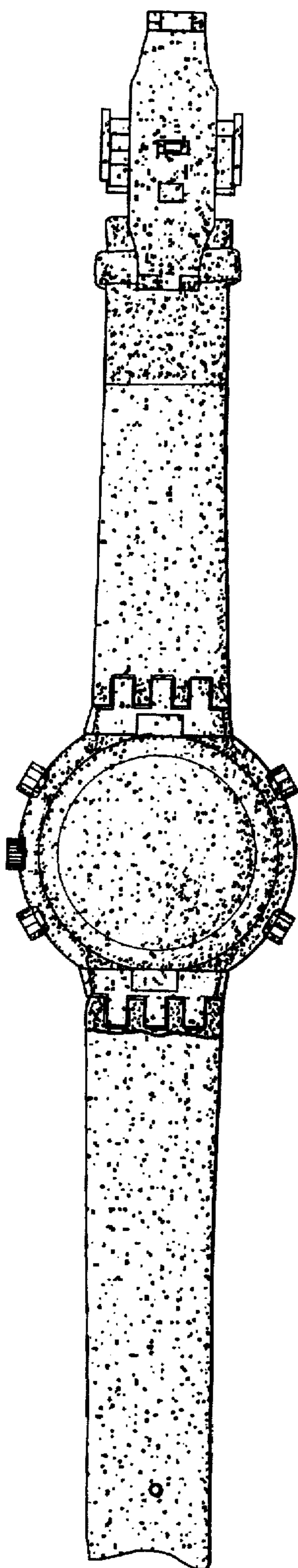

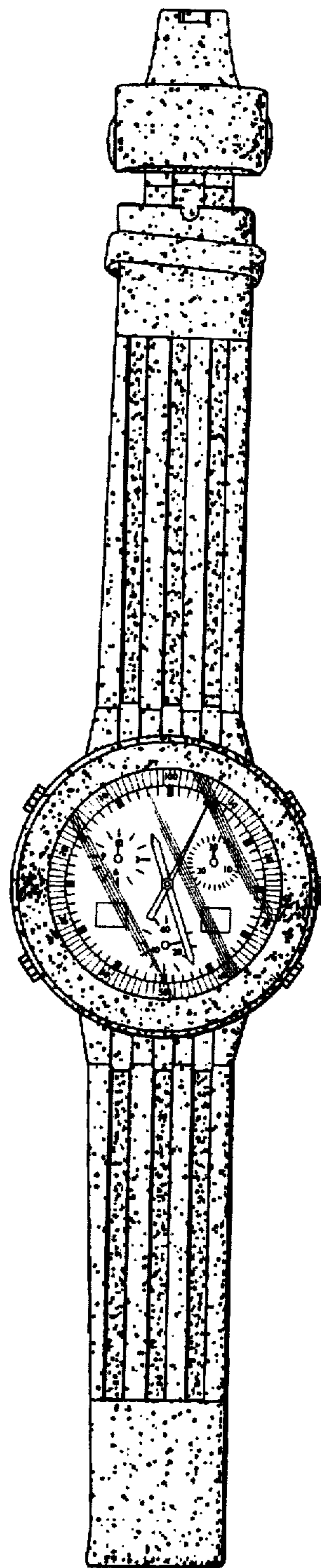

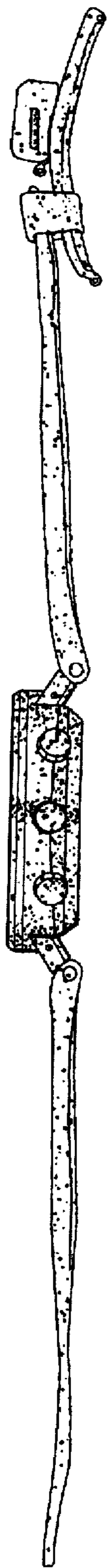

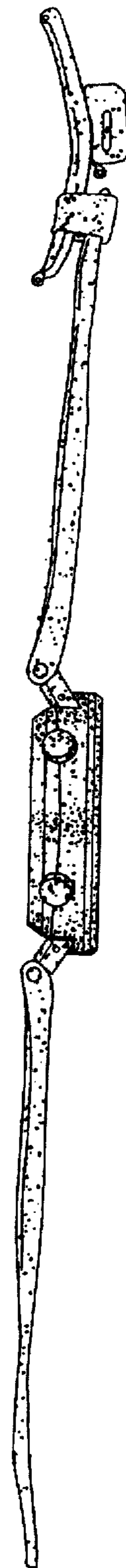

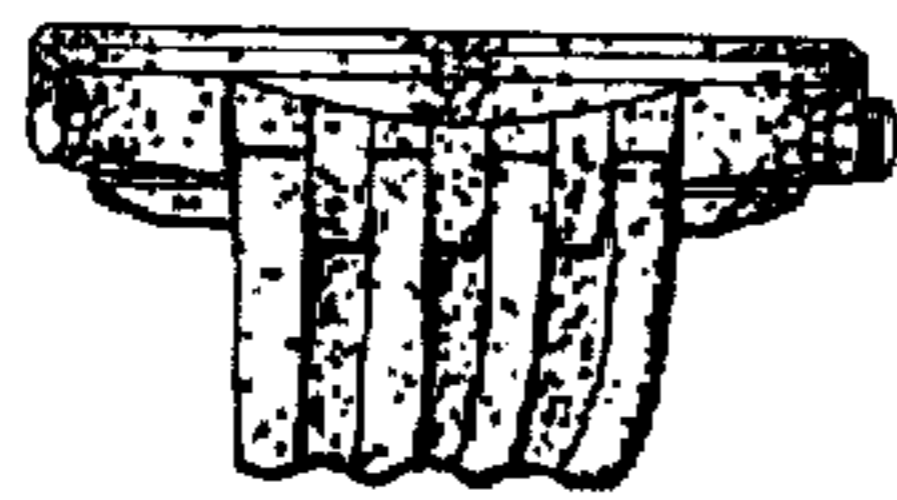

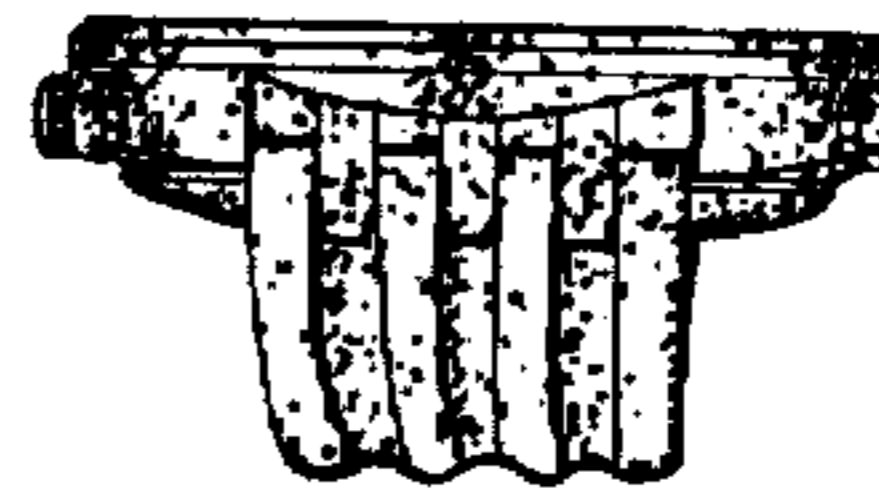

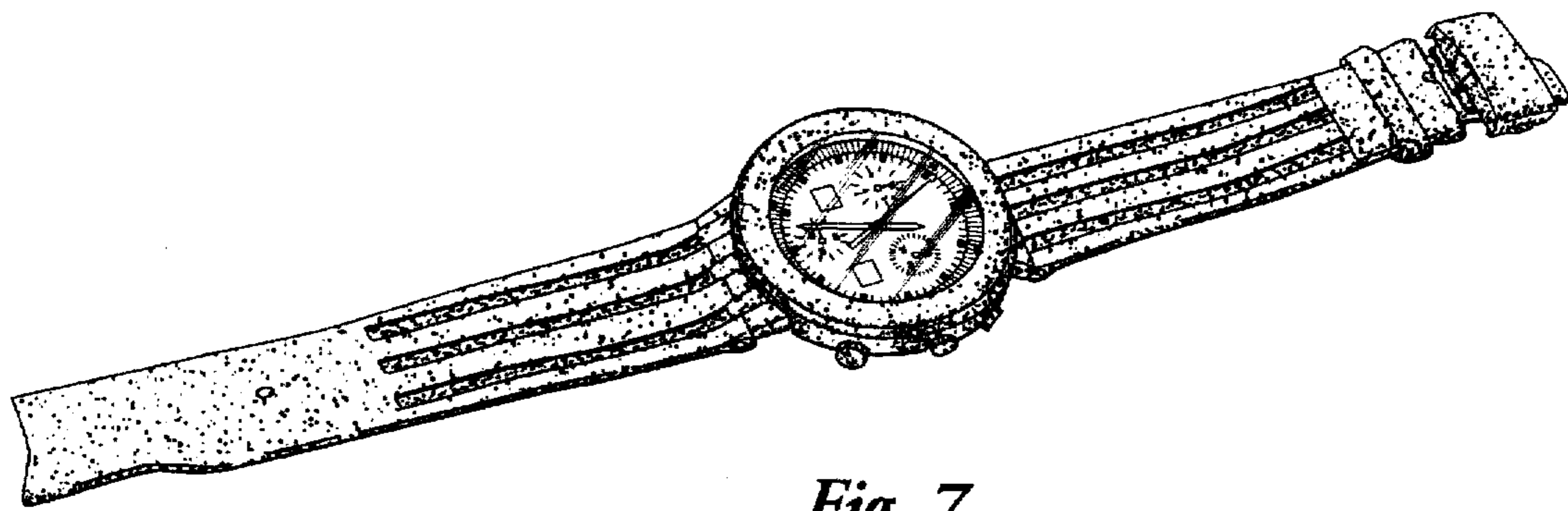

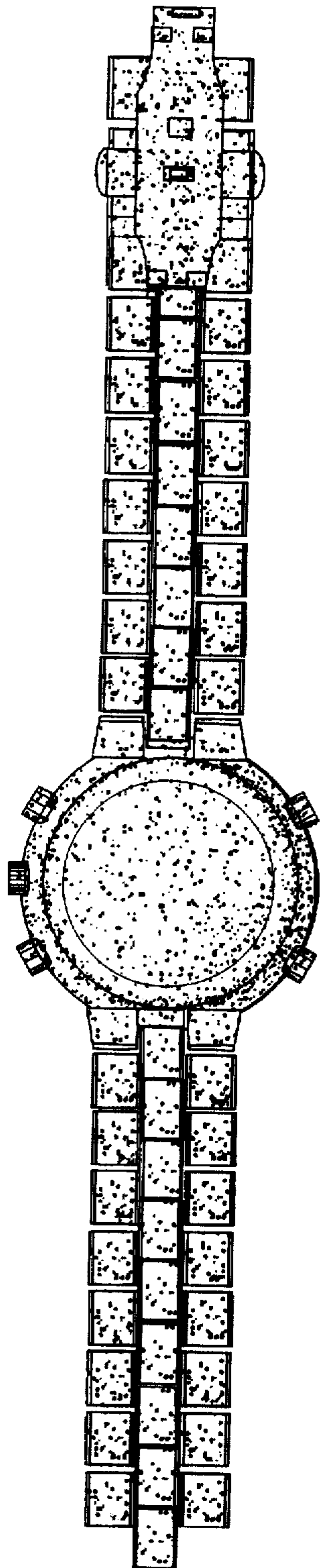

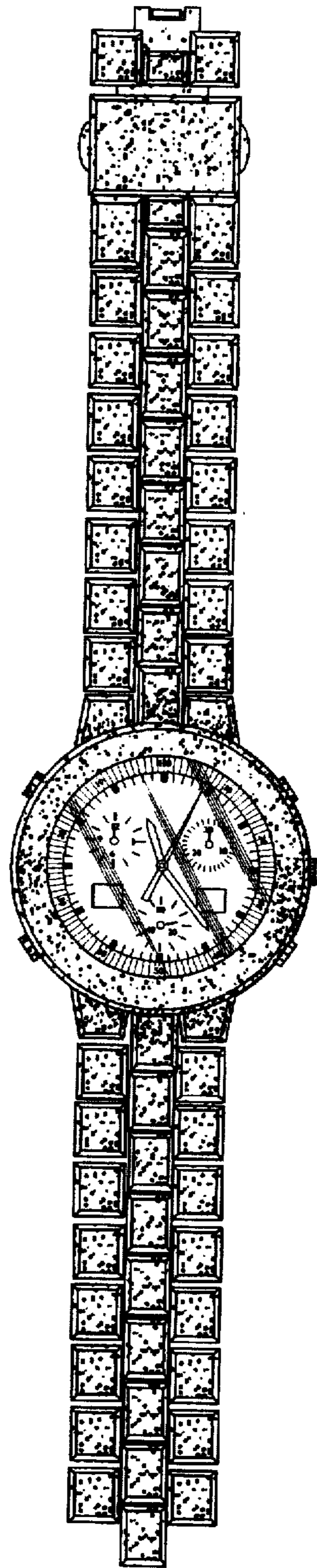

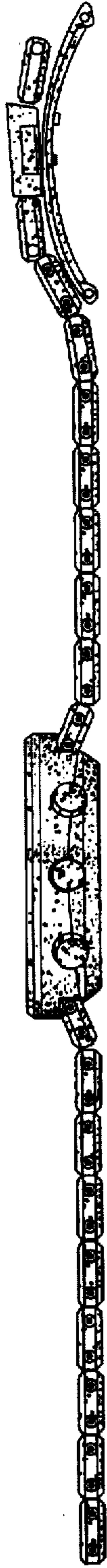

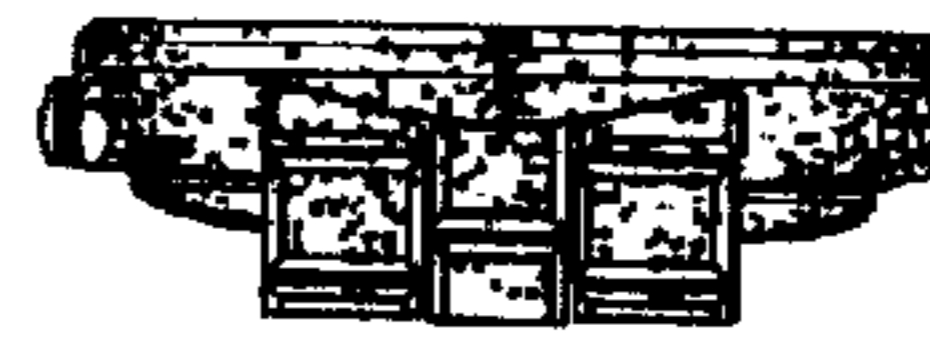

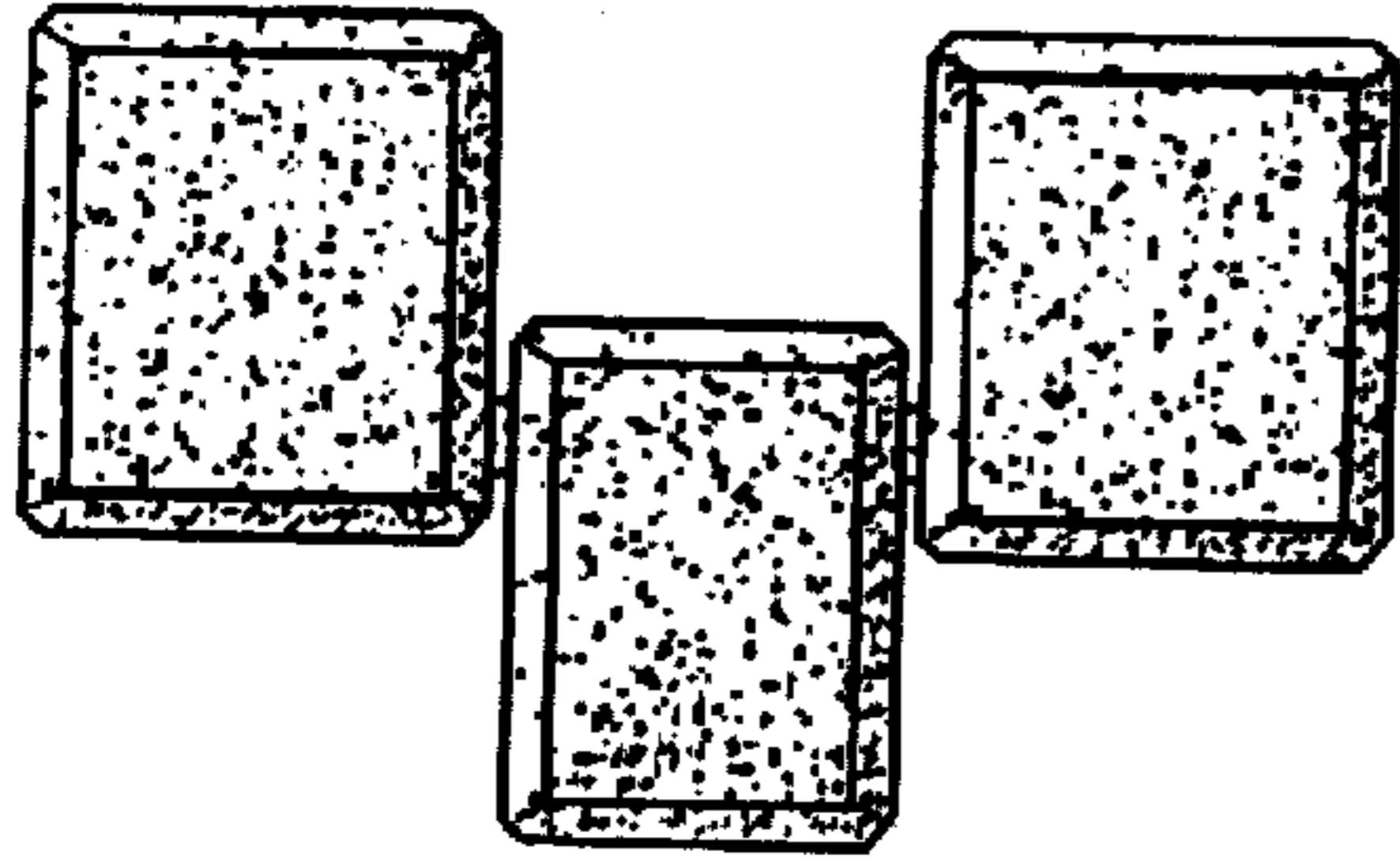

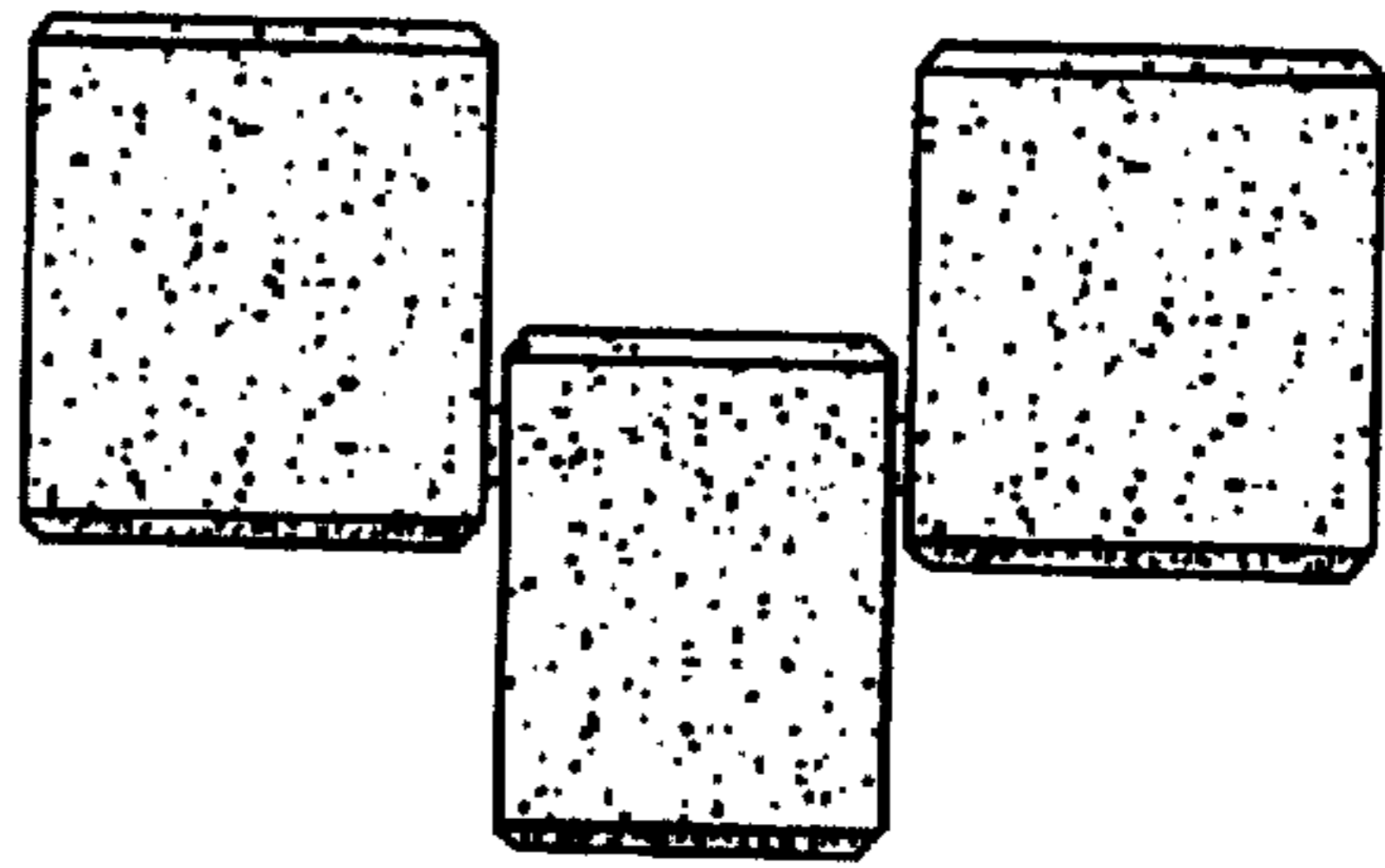

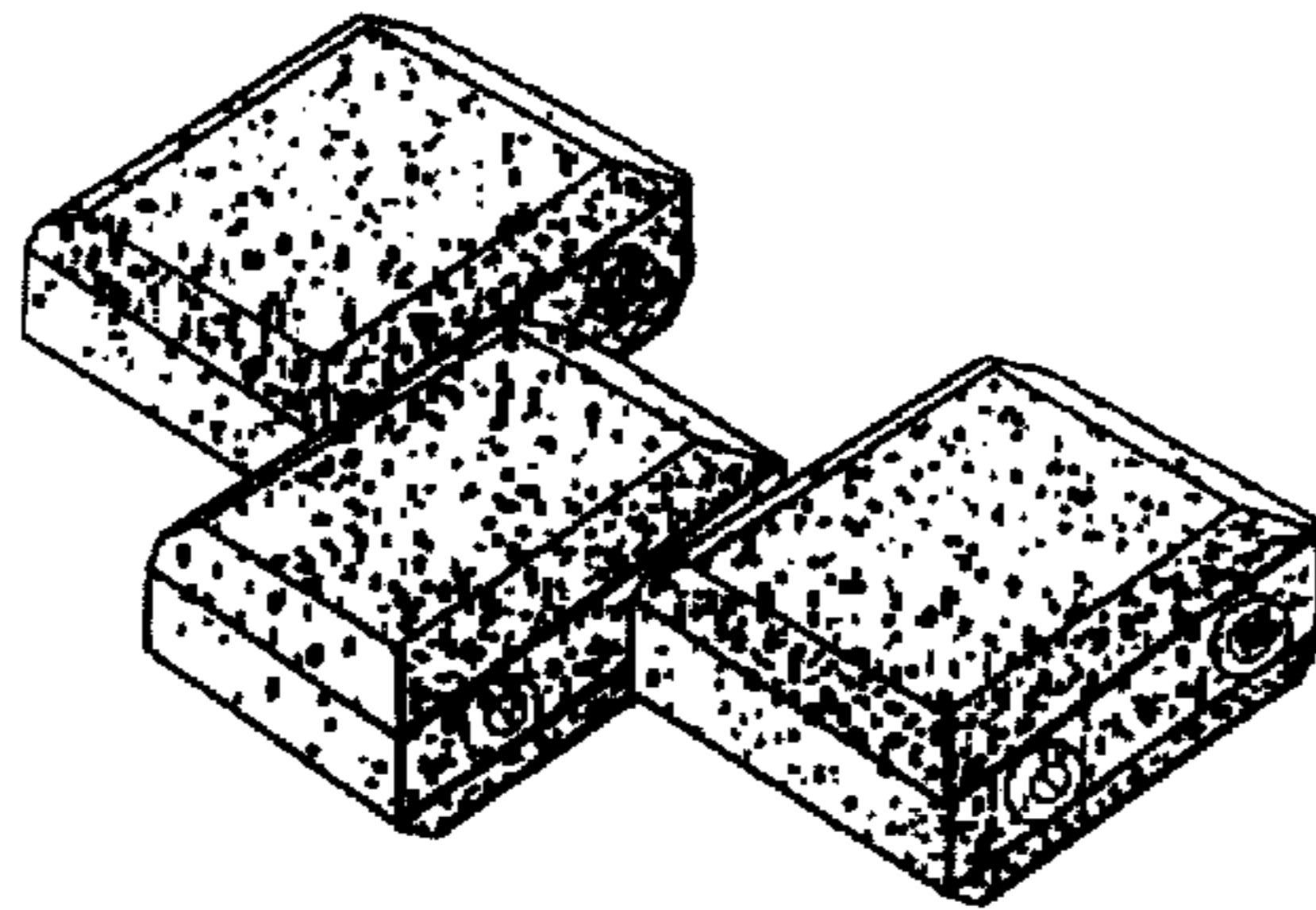
