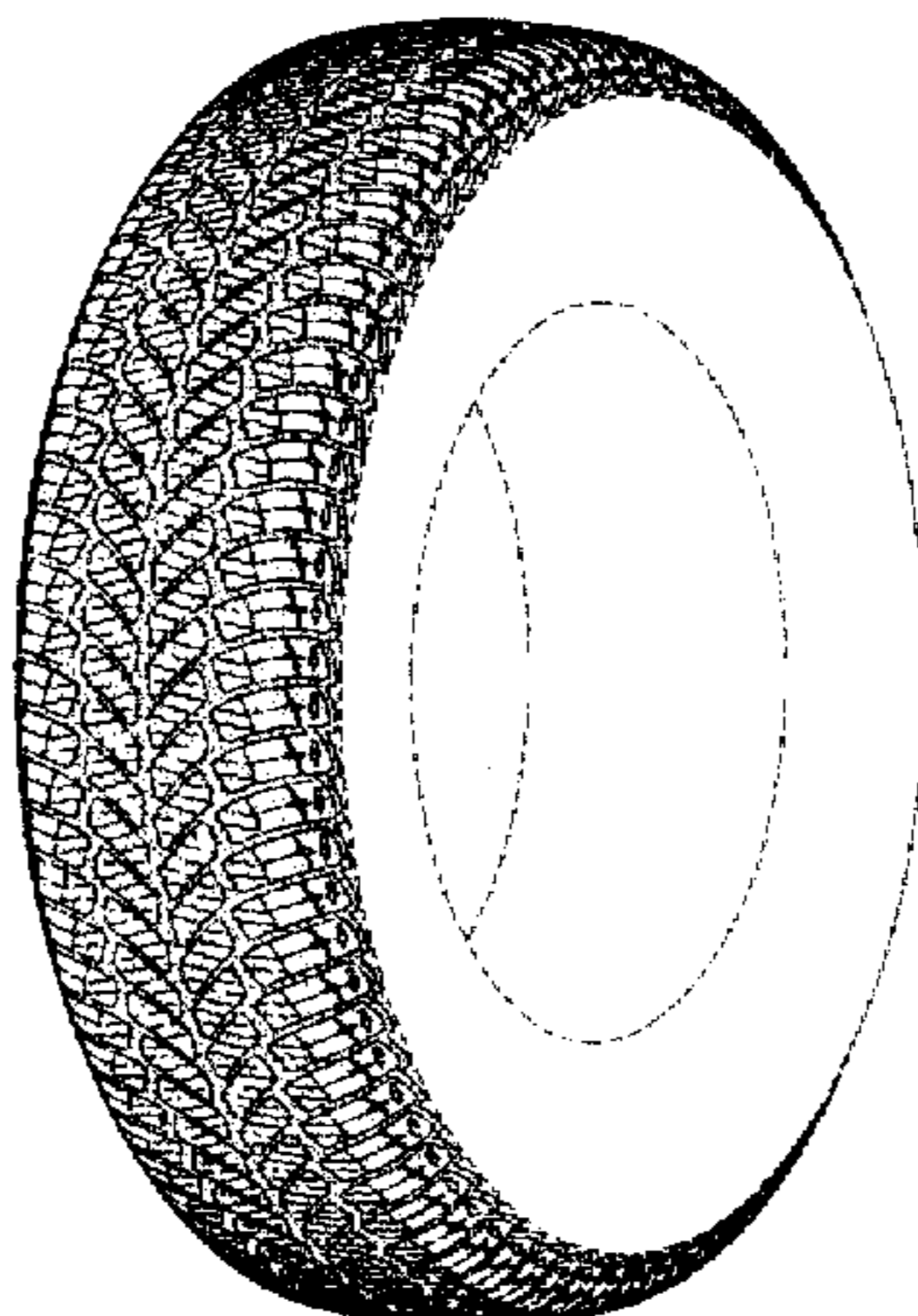
[57] **CLAIM**

The ornamental design for a tire tread, as shown and described.

### DESCRIPTION

FIG. 1 is a front left perspective view of a tire tread showing my new design, it being understood that the pattern is repeated uniformly throughout the circumference of the tread;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a left side elevational view thereof;  
 FIG. 4 is a right side elevational view thereof; and,  
 FIG. 5 is an enlarged fragmentary front view thereof.  
 The broken line showing of the tire sidewall in the drawings is for illustrative purposes only and forms no part of the claimed design.

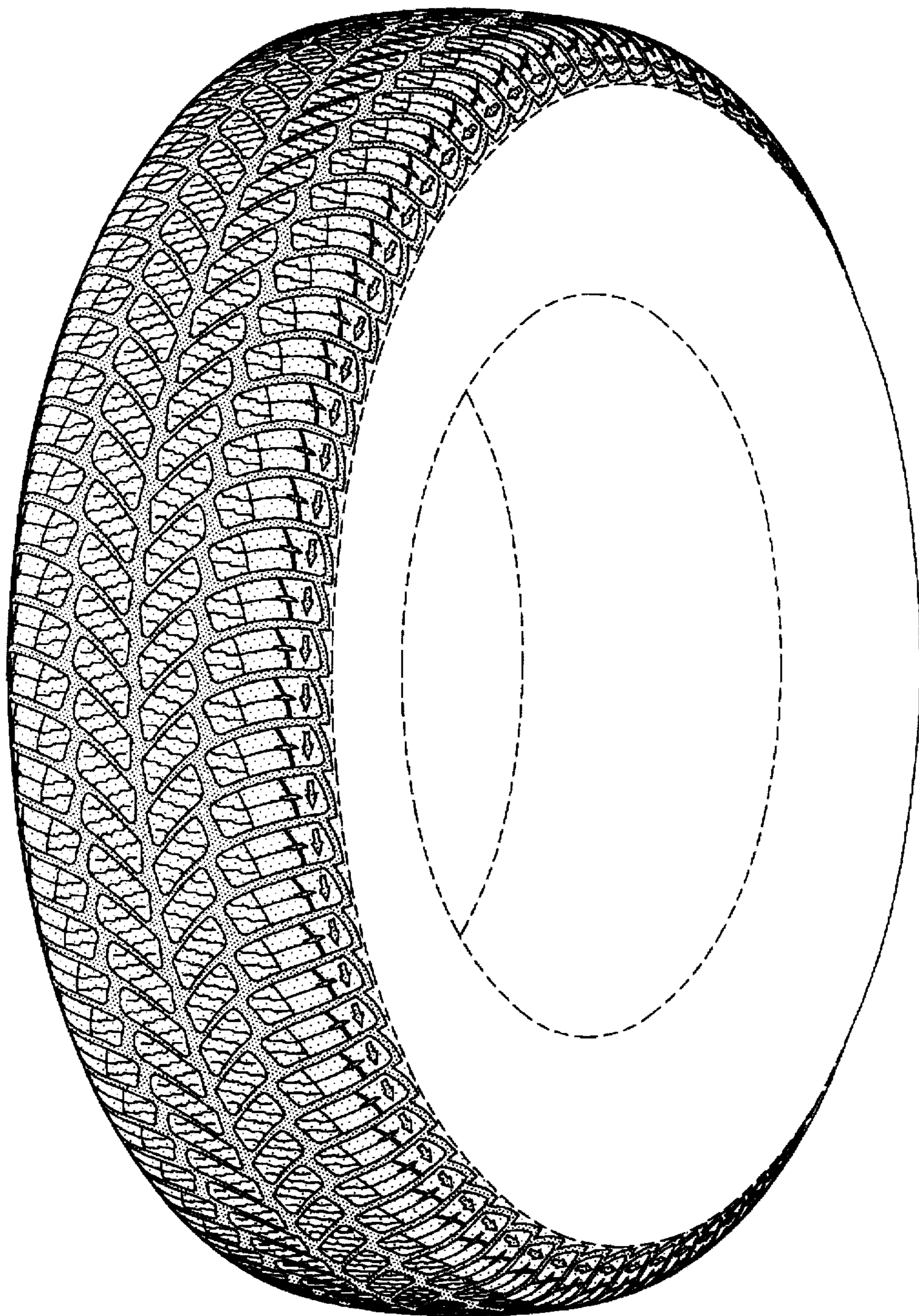

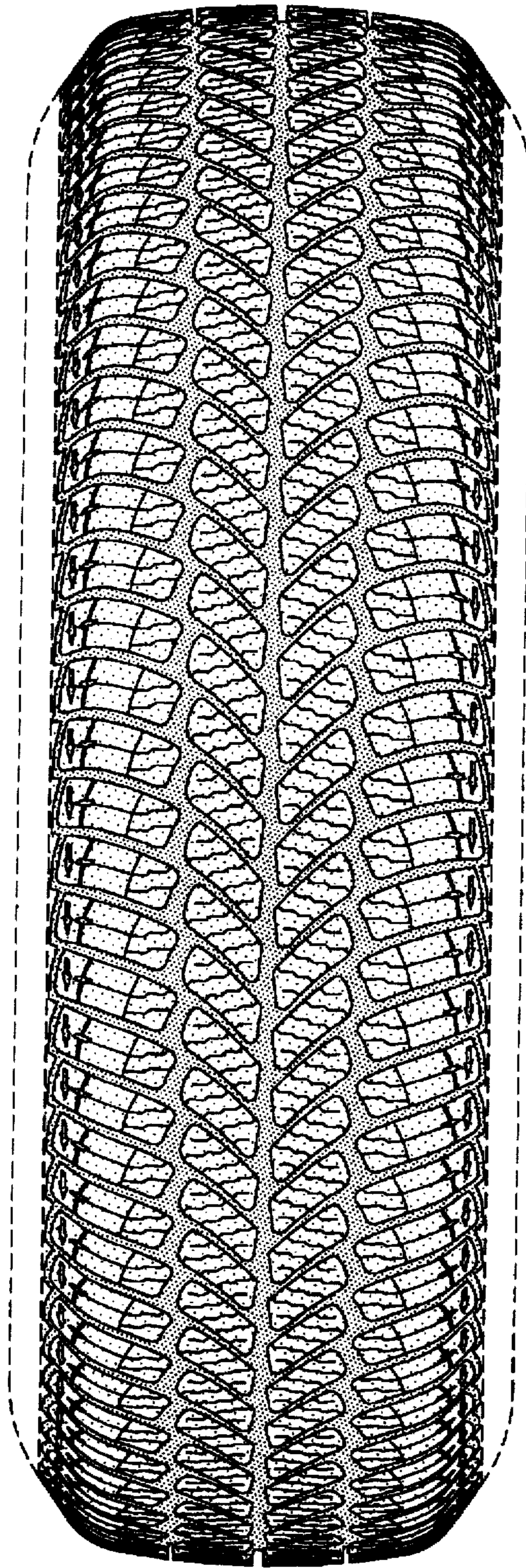

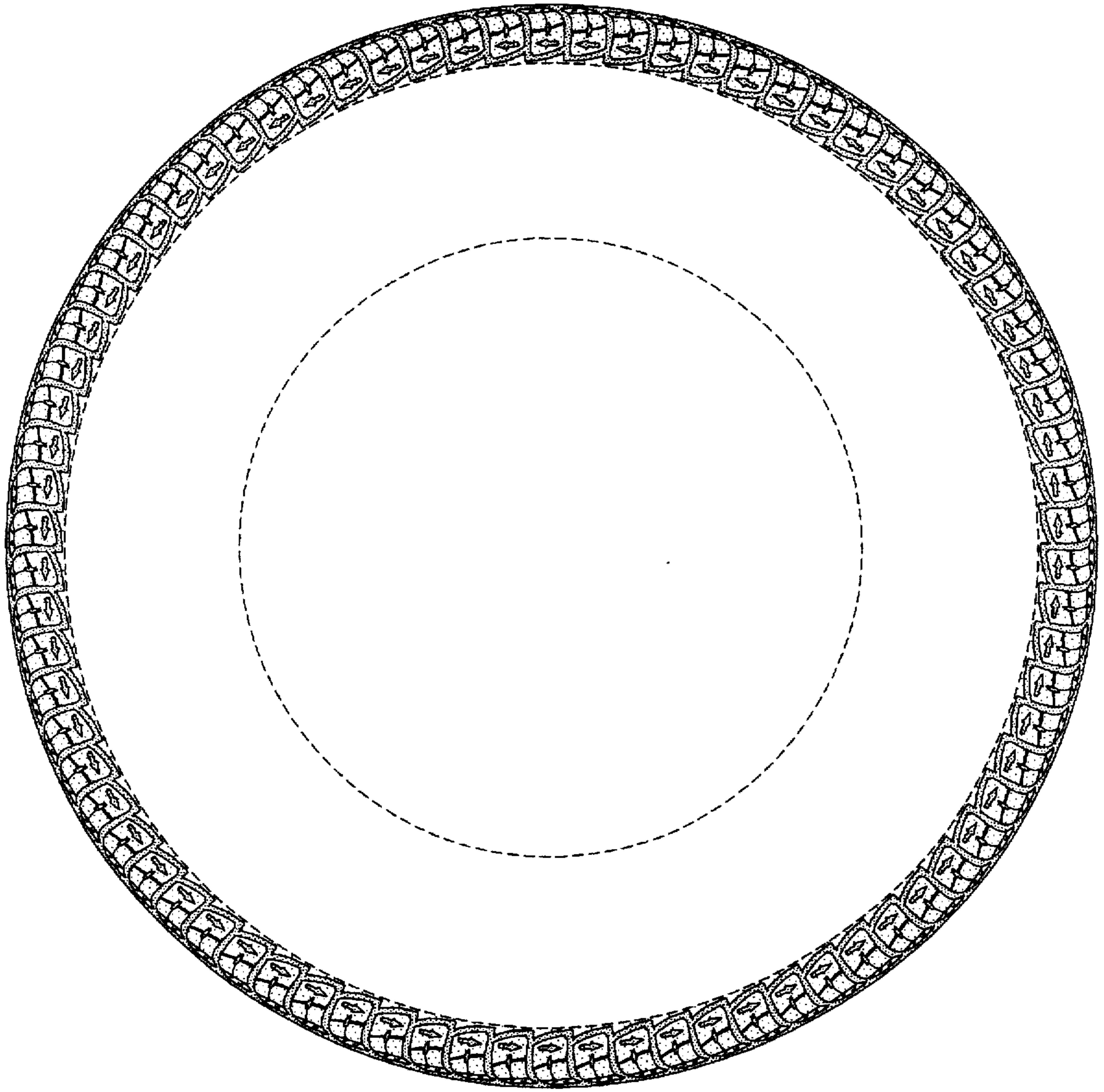

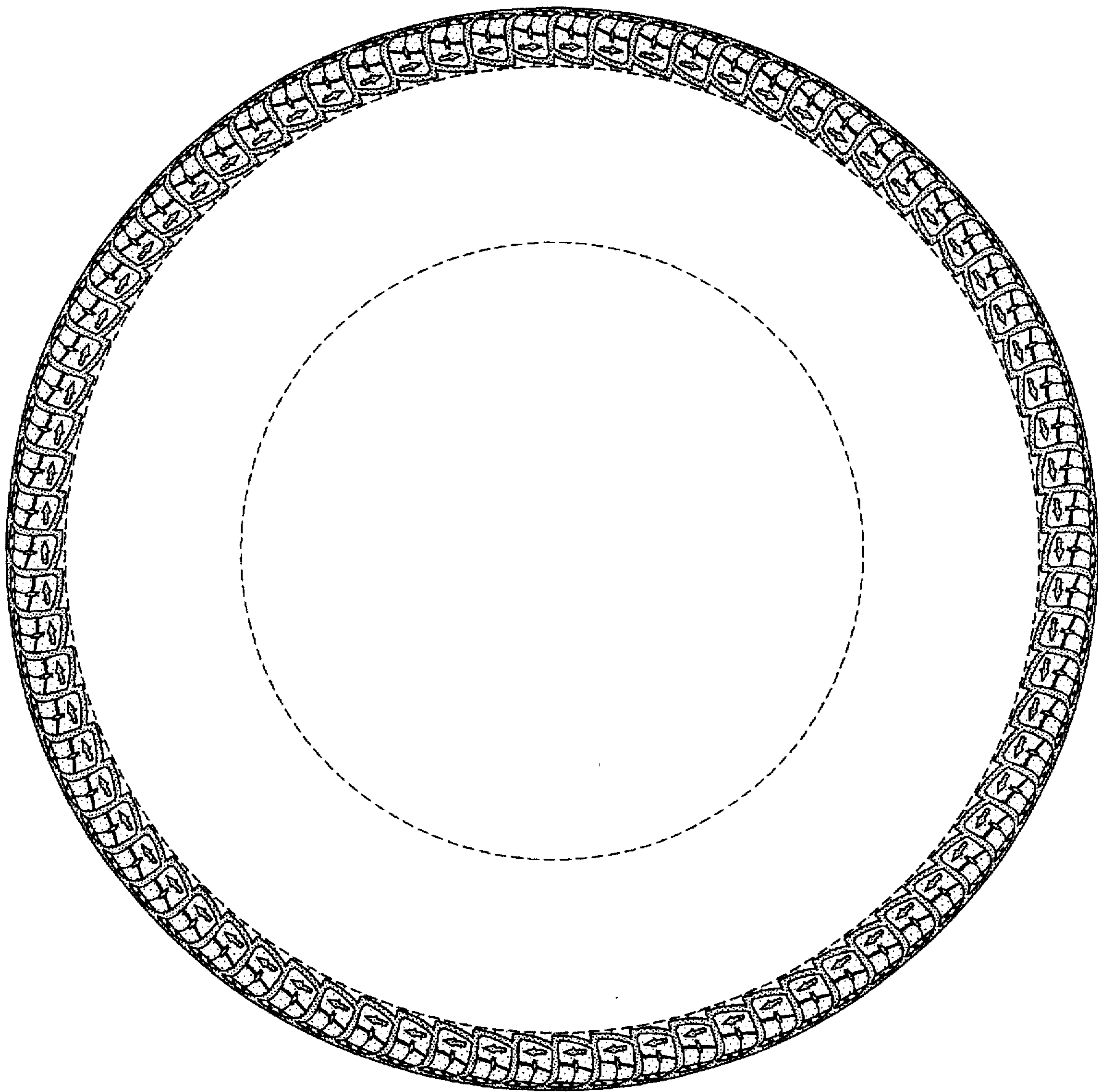

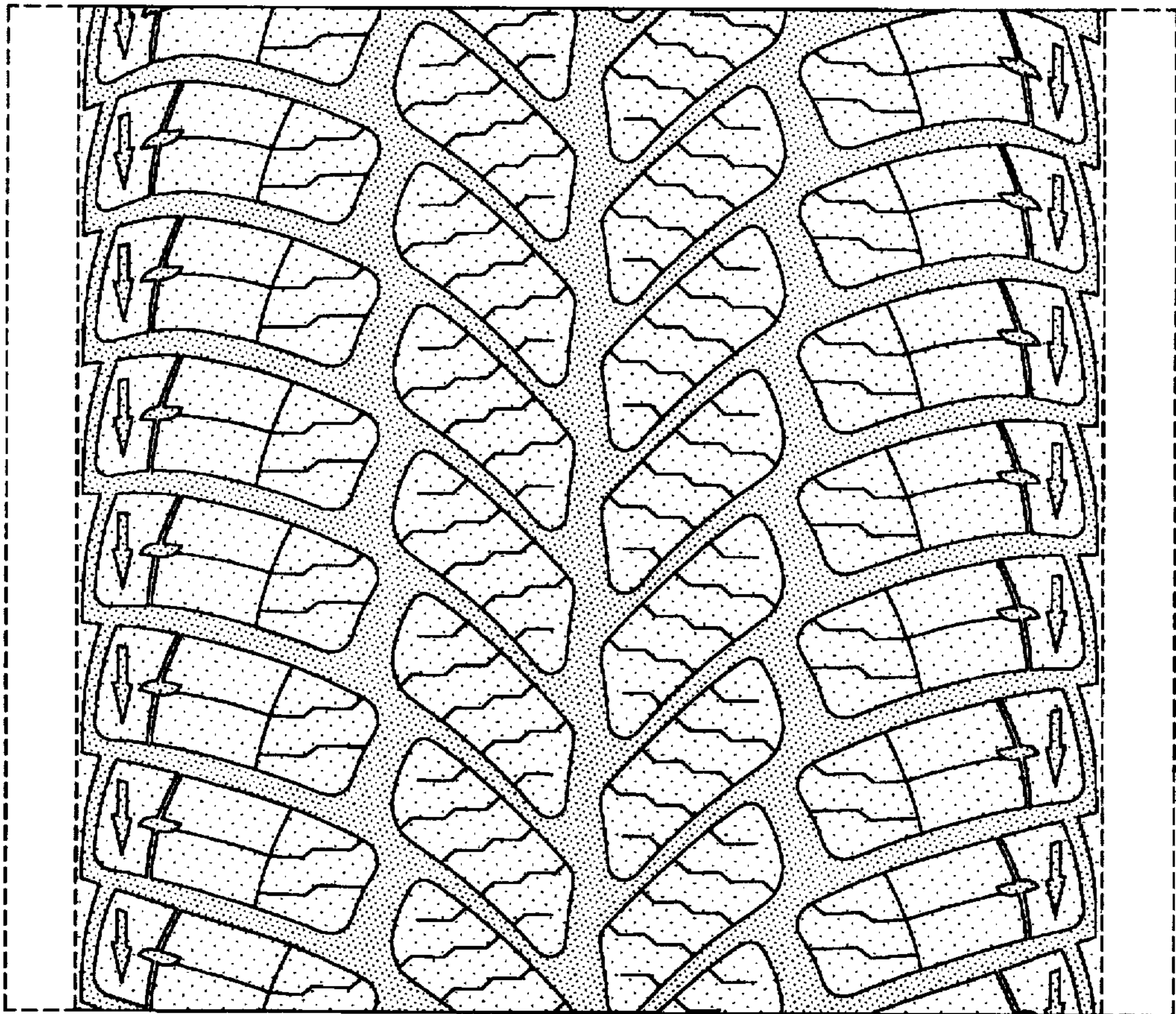
