The ornamental design for an outboard motor, as shown.

DESCRIPTION

FIG. 1 is a perspective view of an ornamental design for an outboard motor in accordance with a first embodiment of the present invention;

FIG. 10 is a bottom view of the ornamental design of FIG. 8;

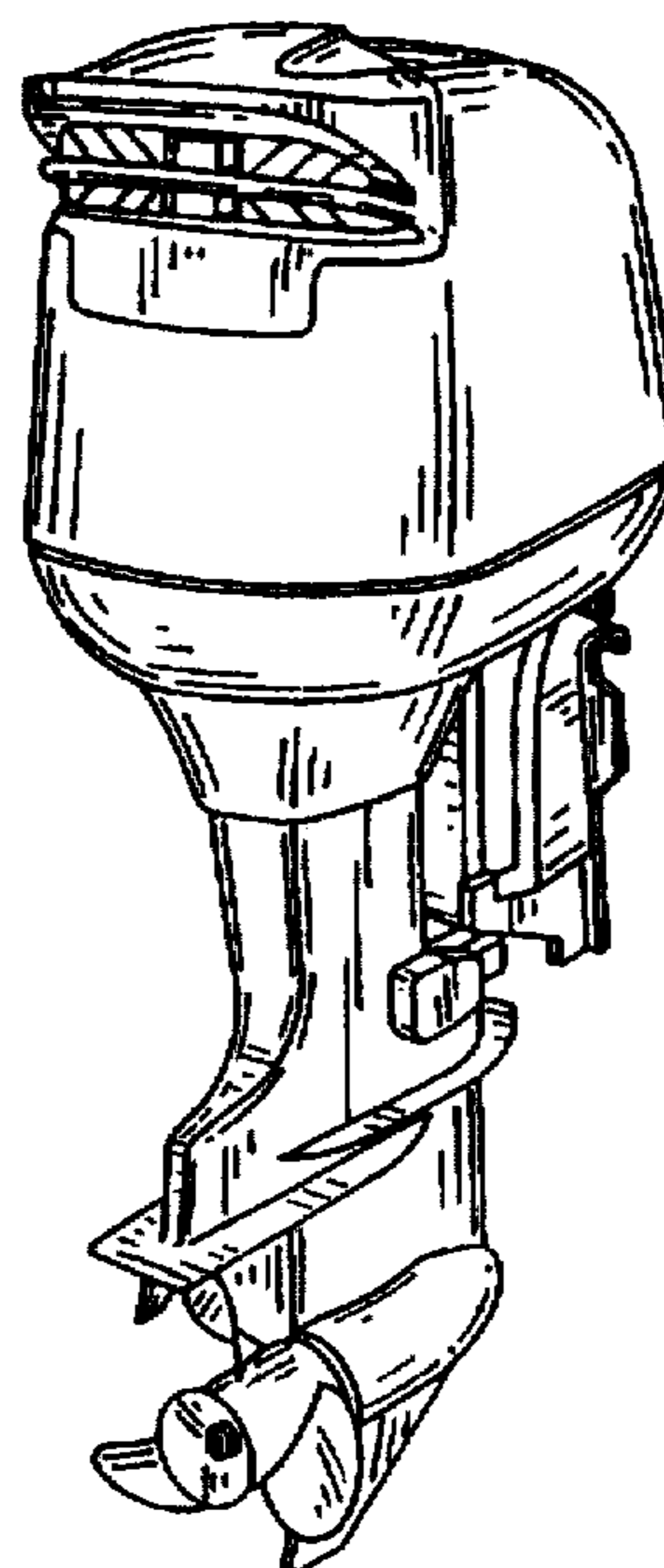
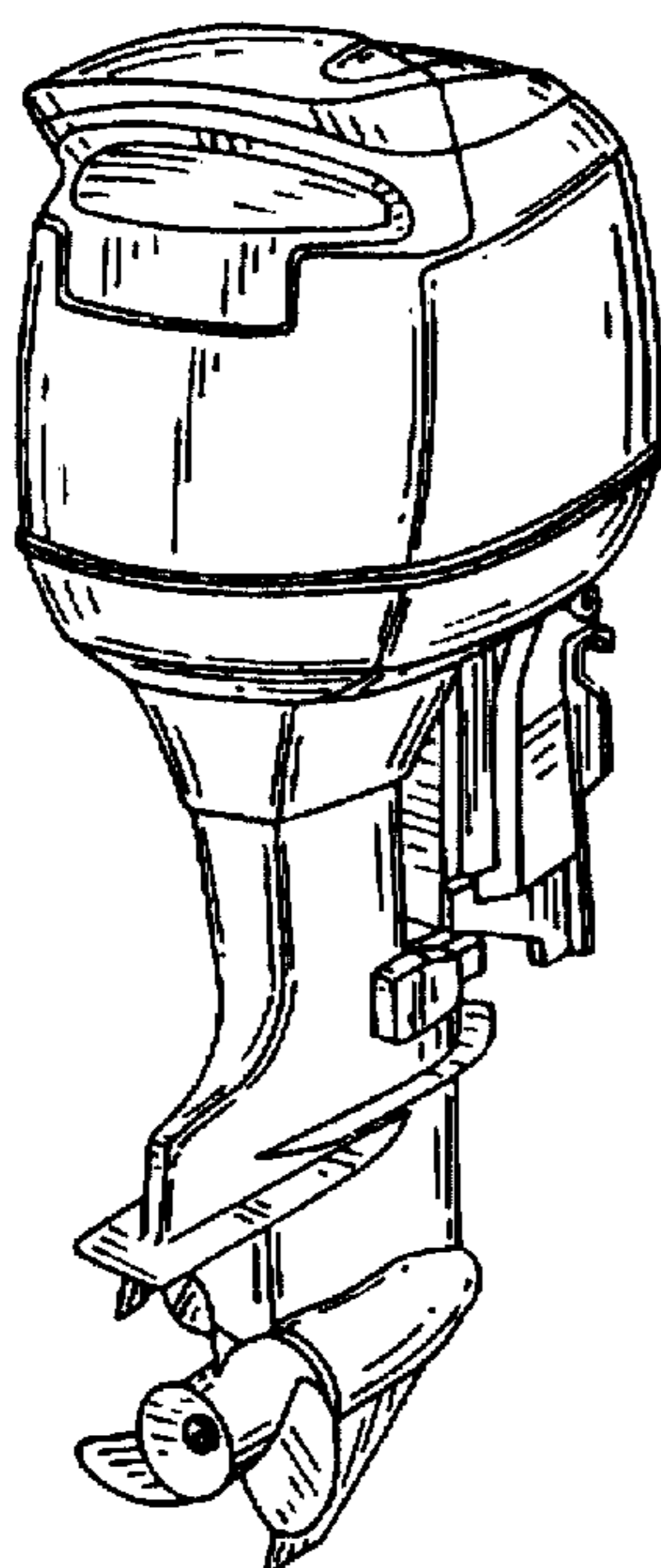
FIG. 11 is a left side view of the ornamental design of FIG. 8;

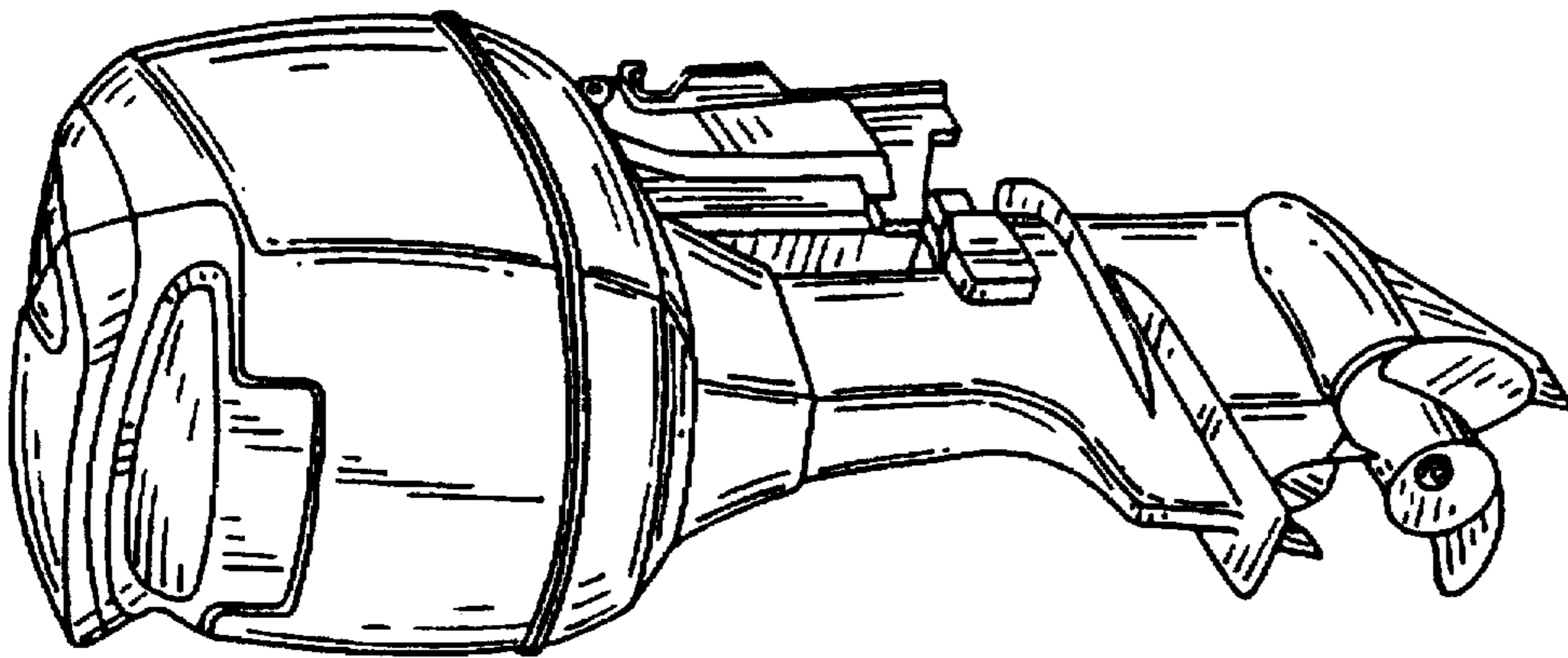

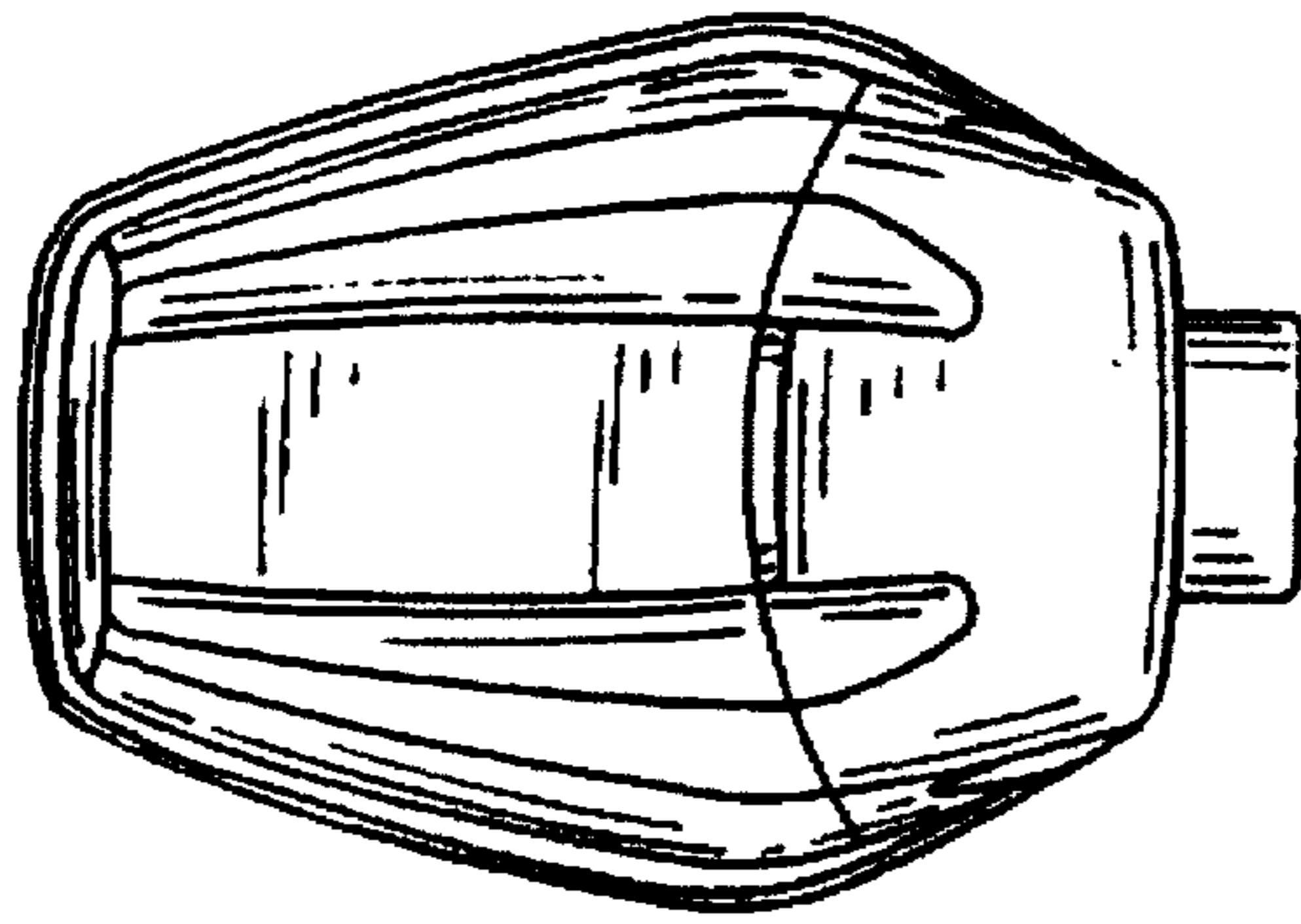

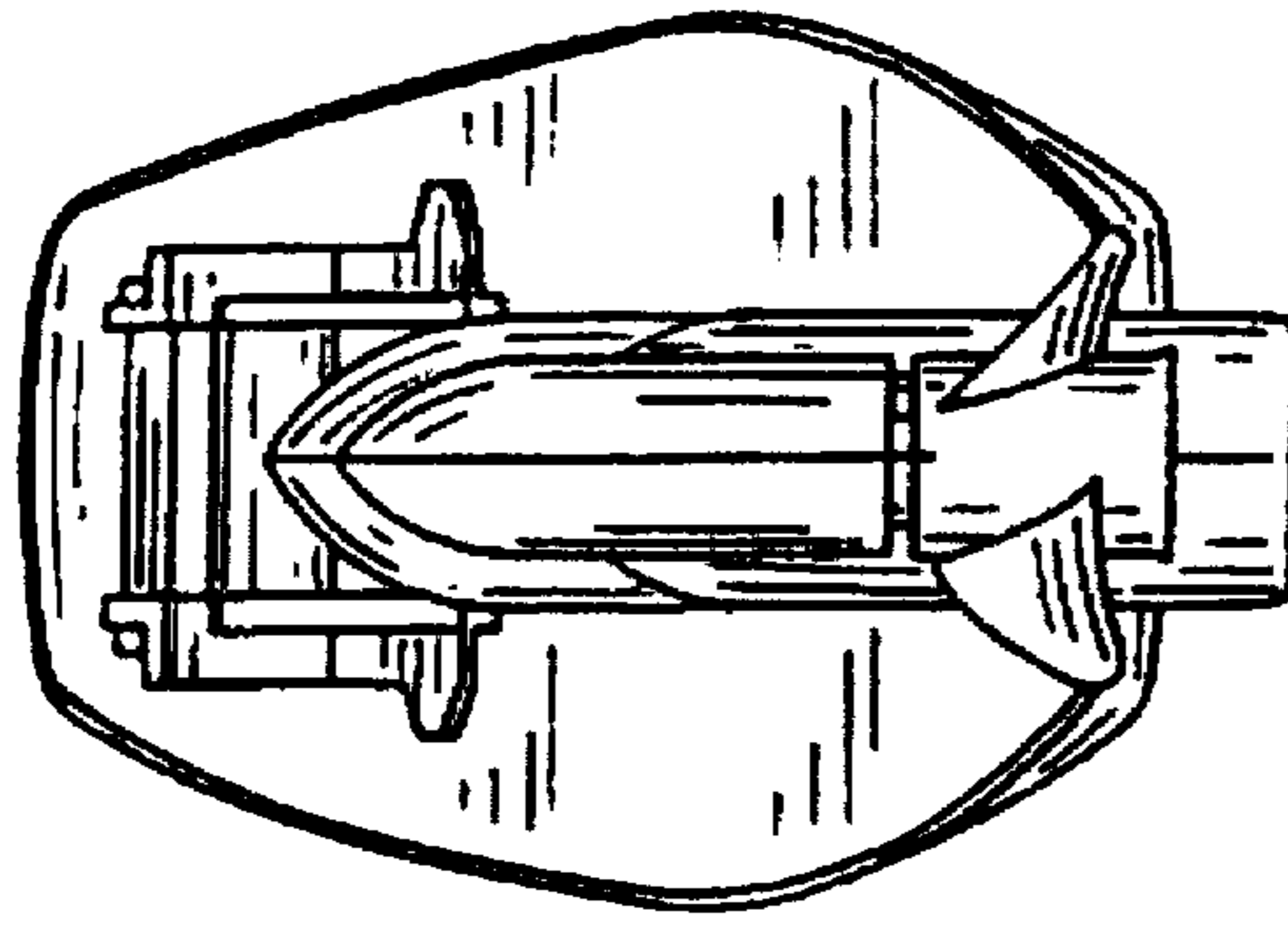

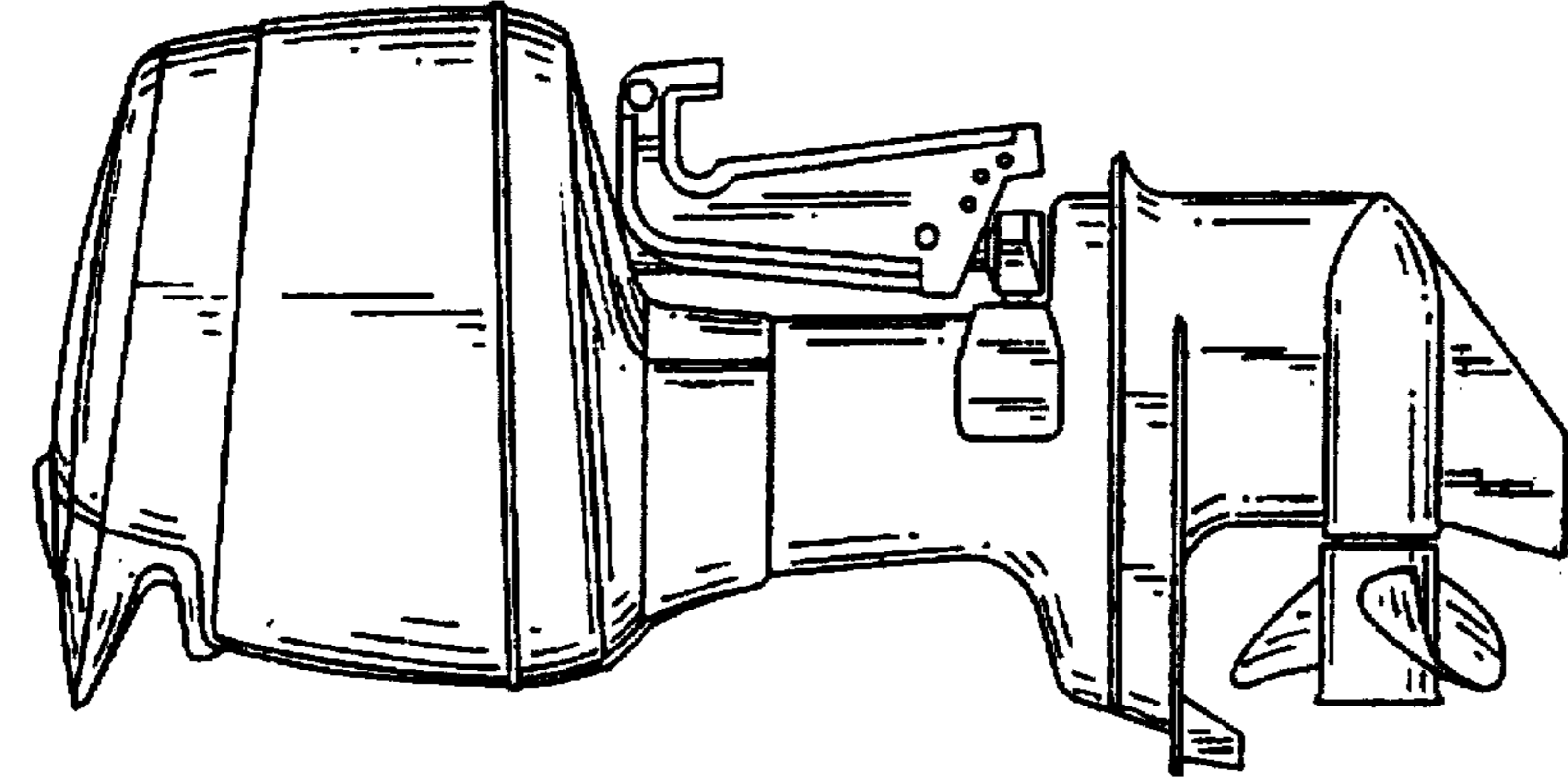

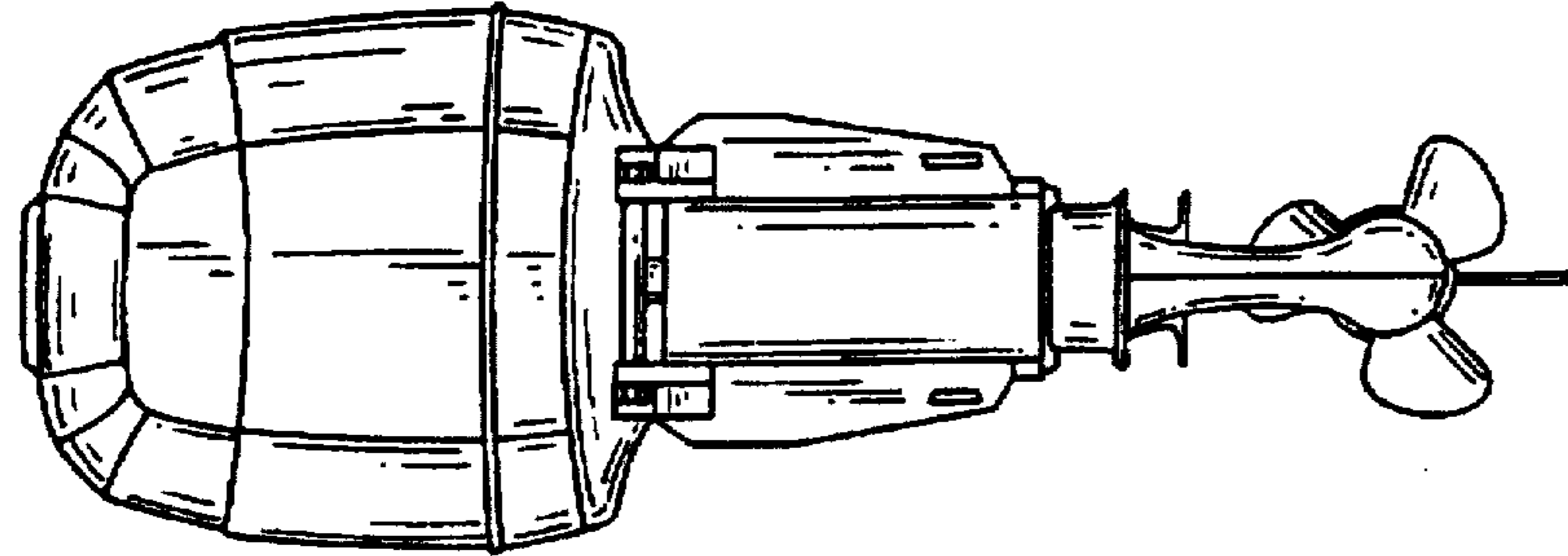

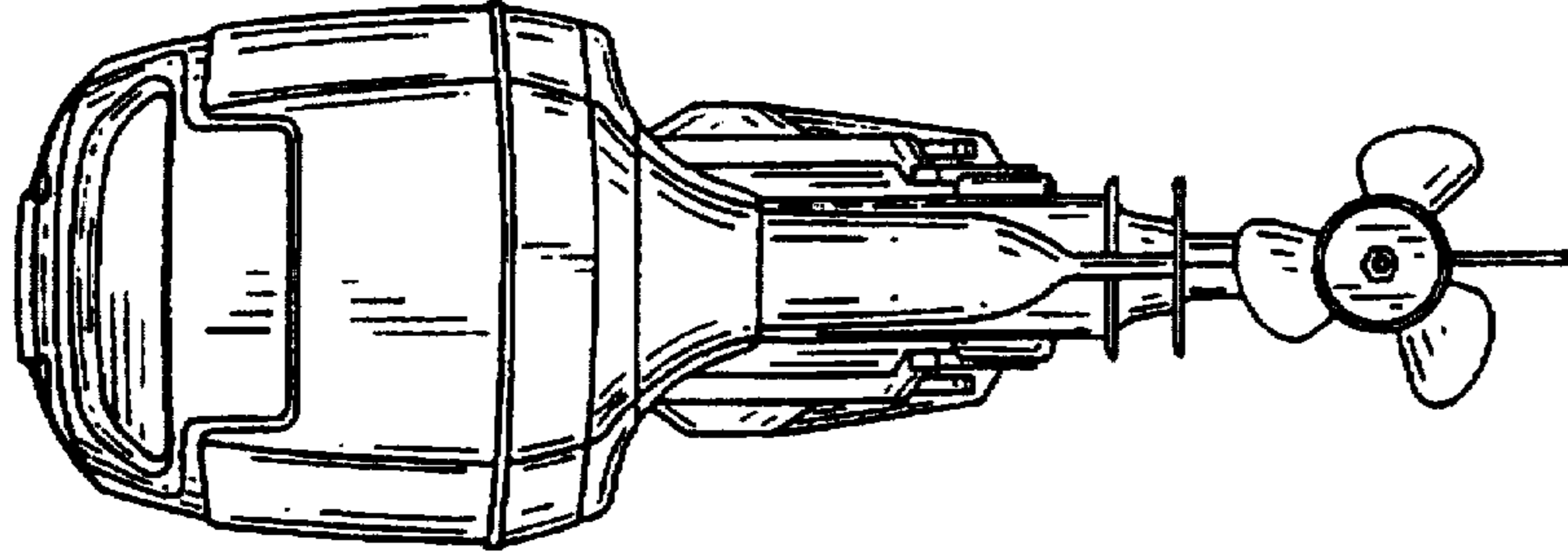

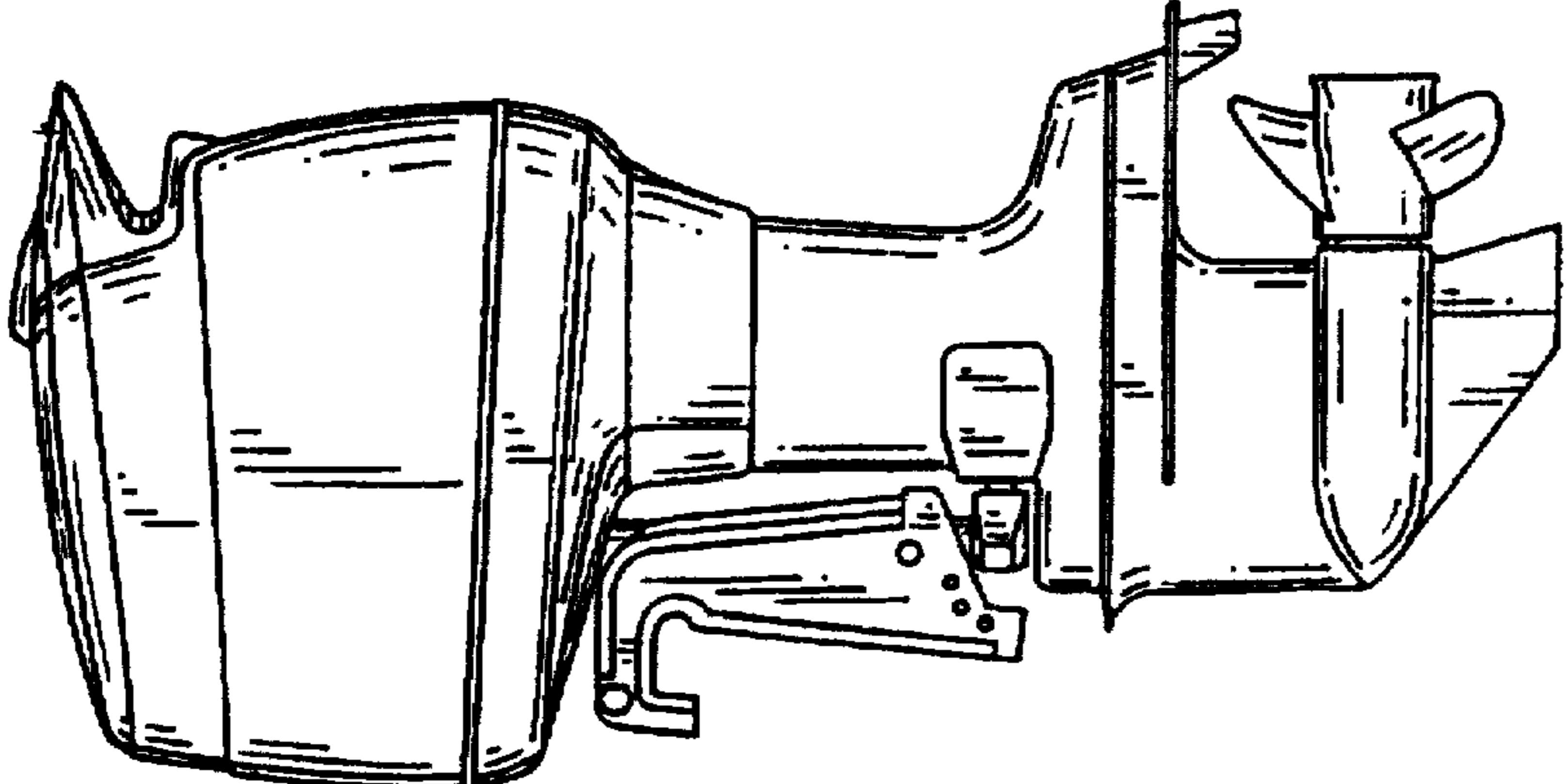

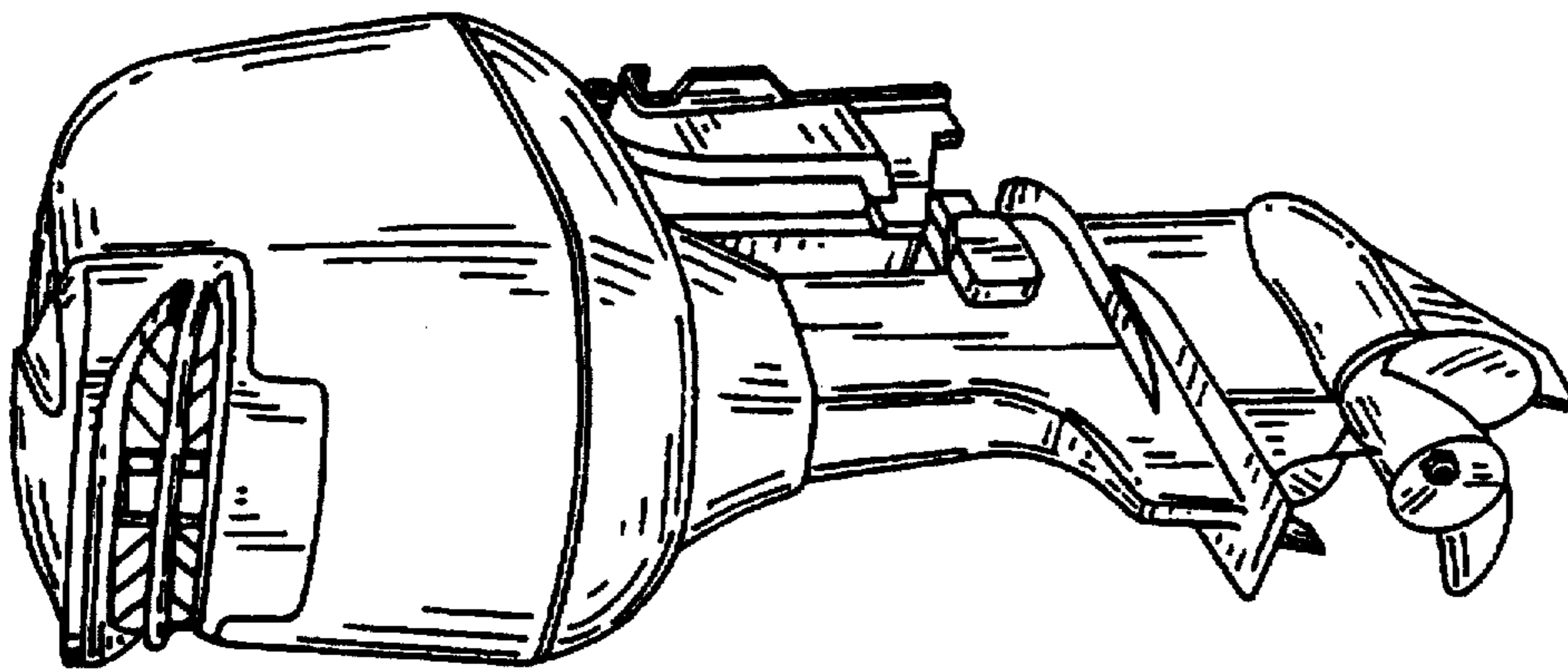

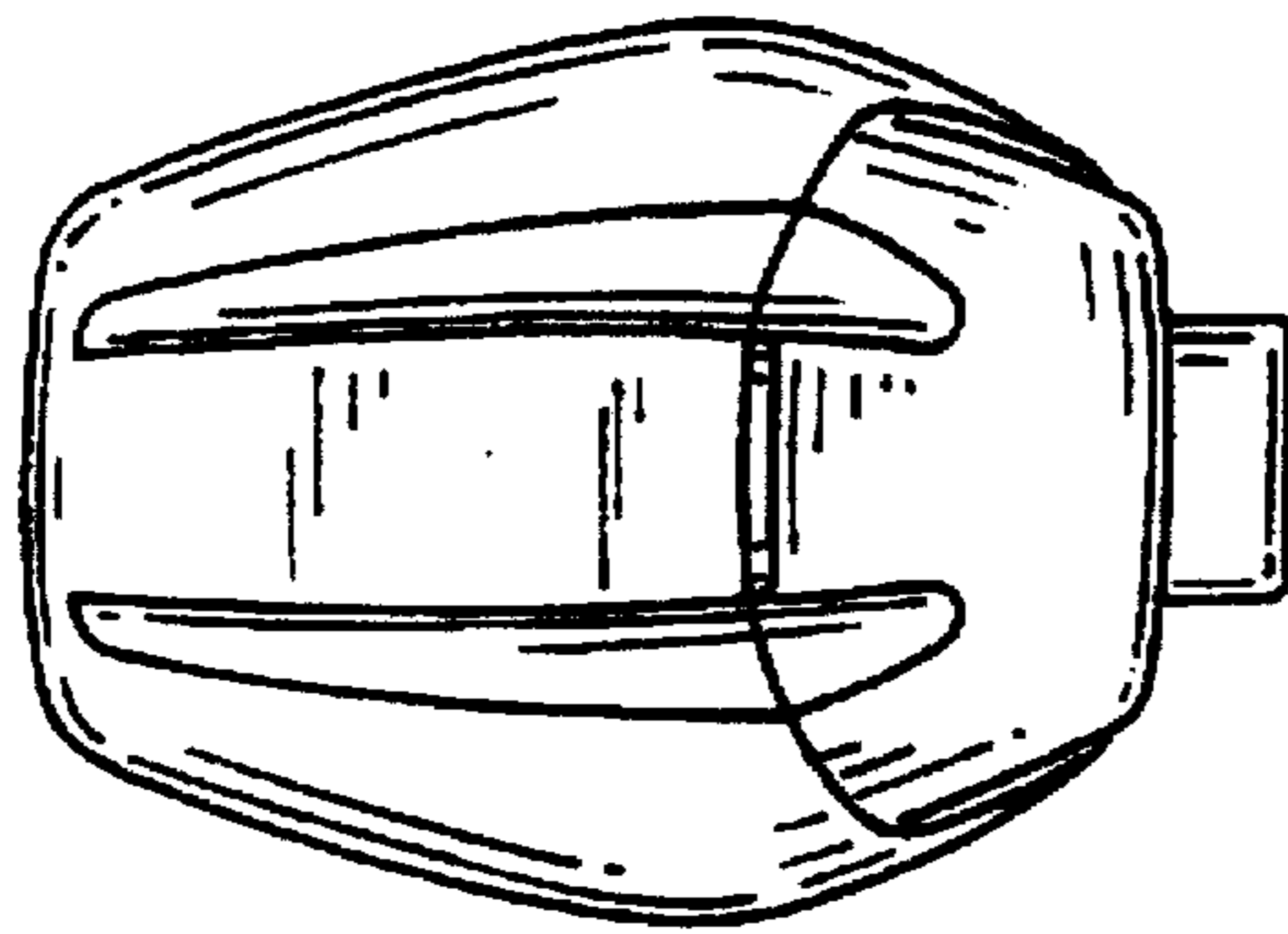

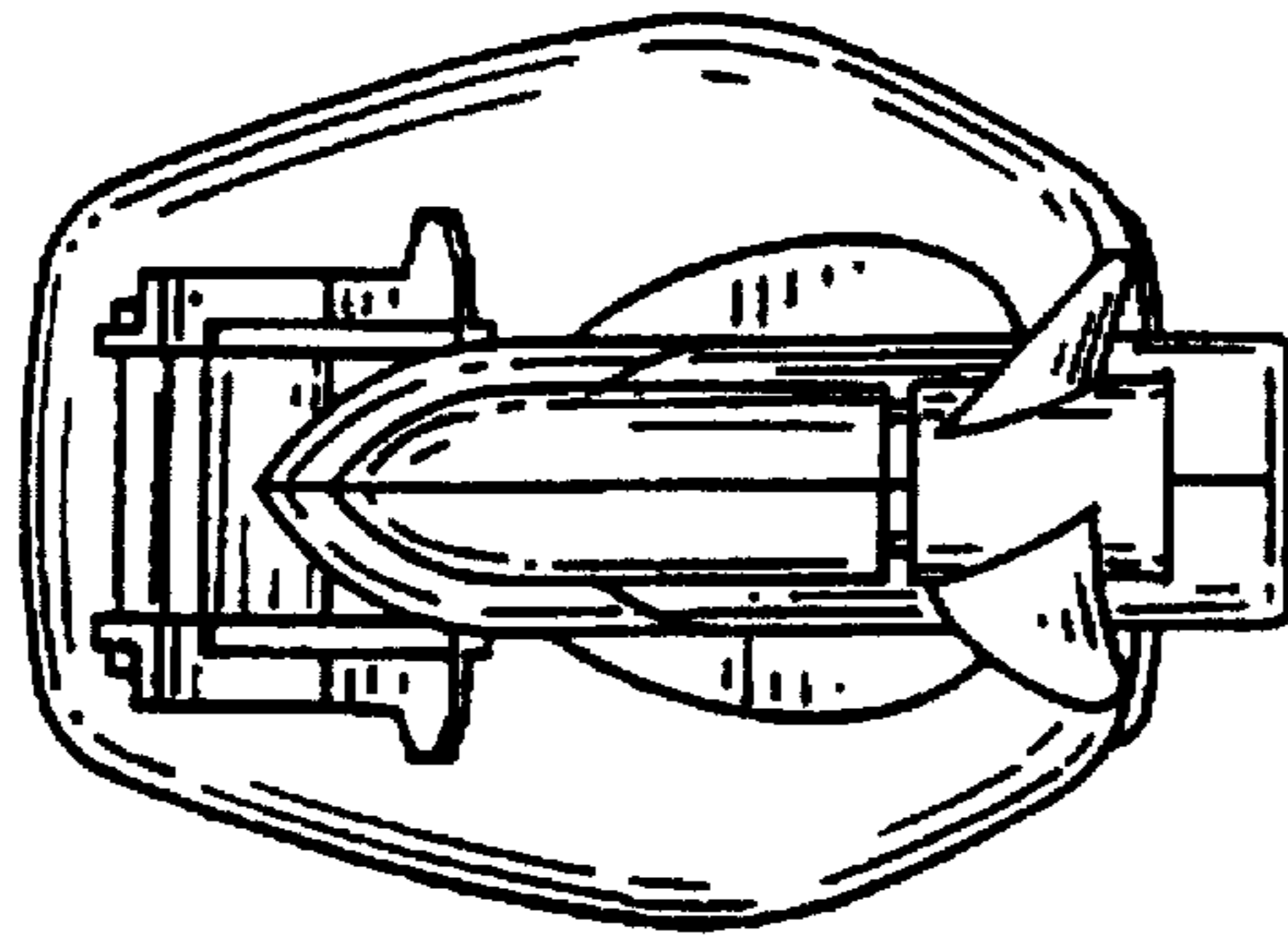

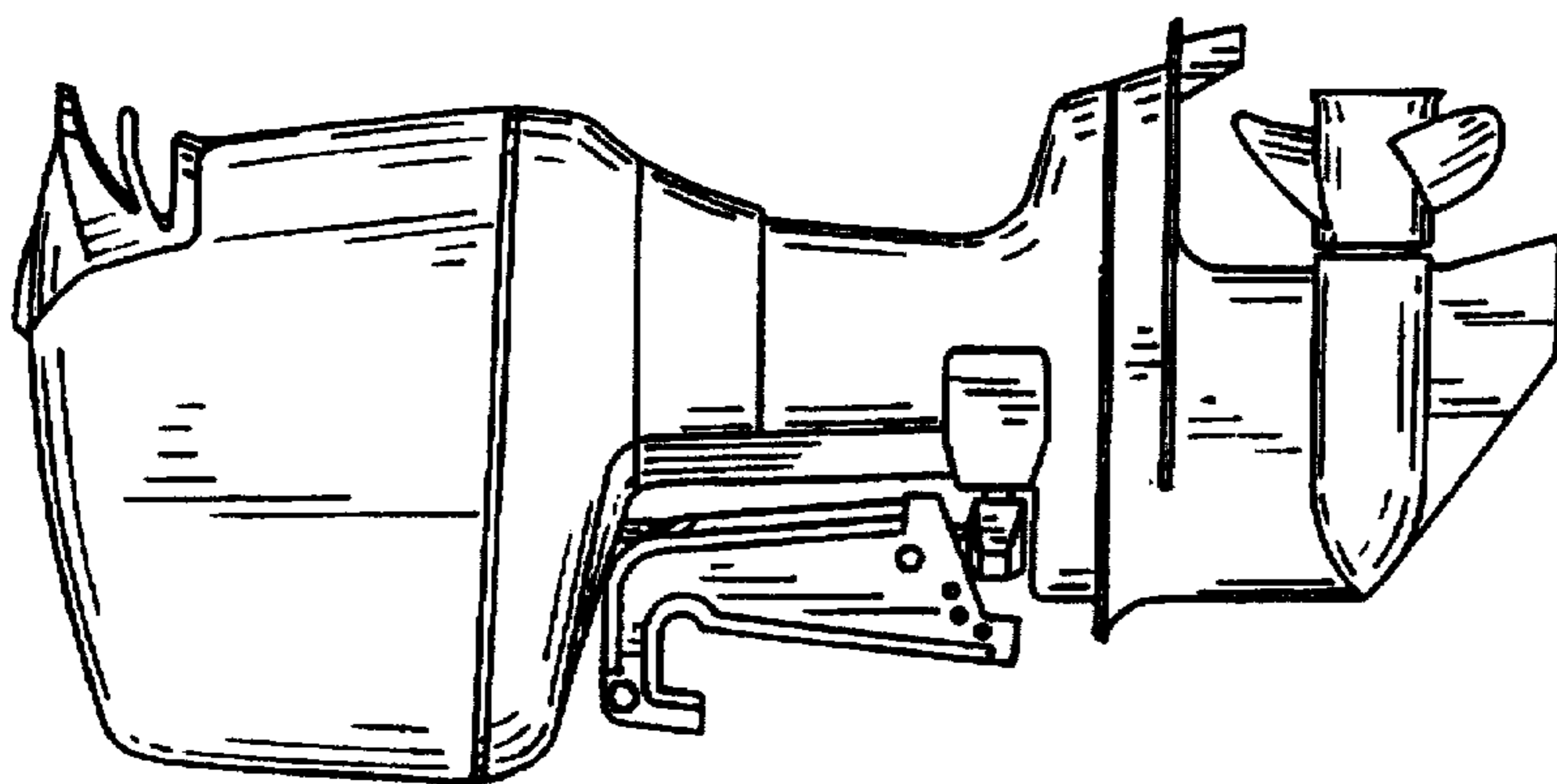

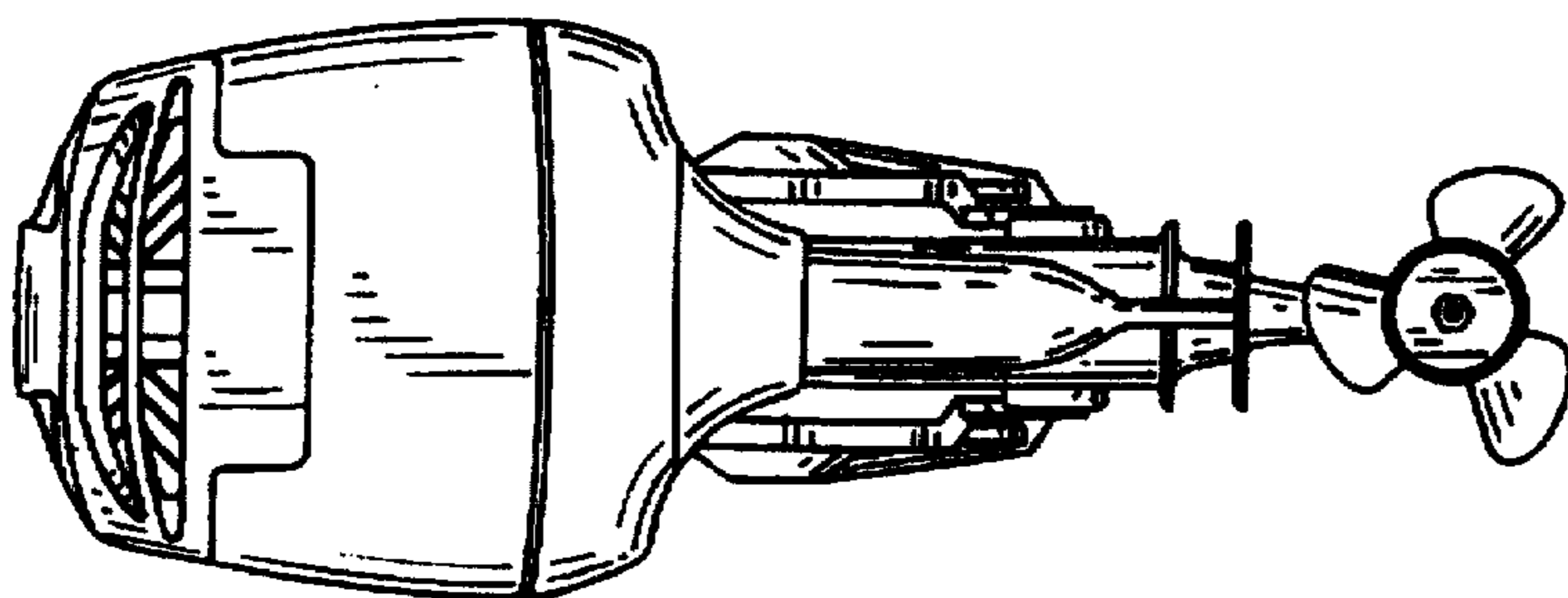

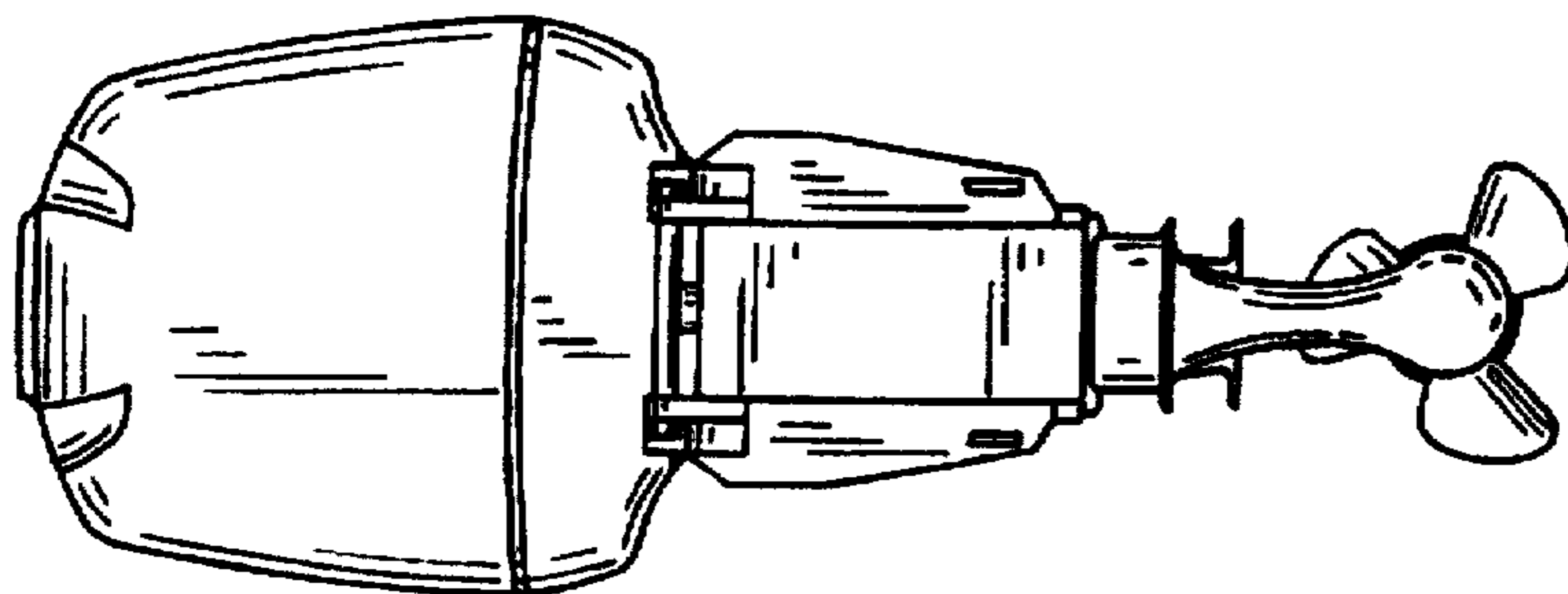

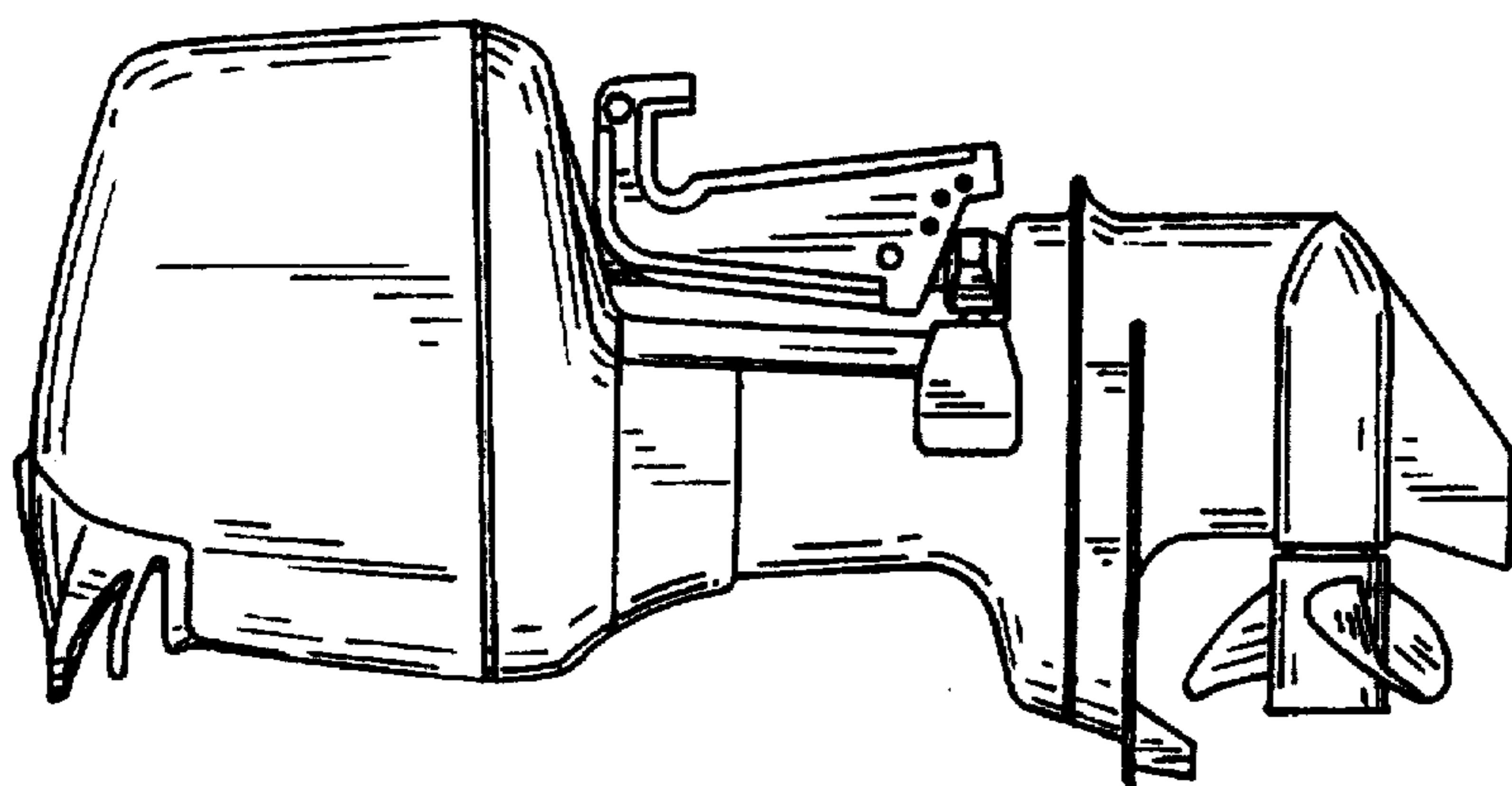
