DESCRIPTION

FIG. 1 is a perspective view of a food merchandiser vending machine front panel showing my new design;

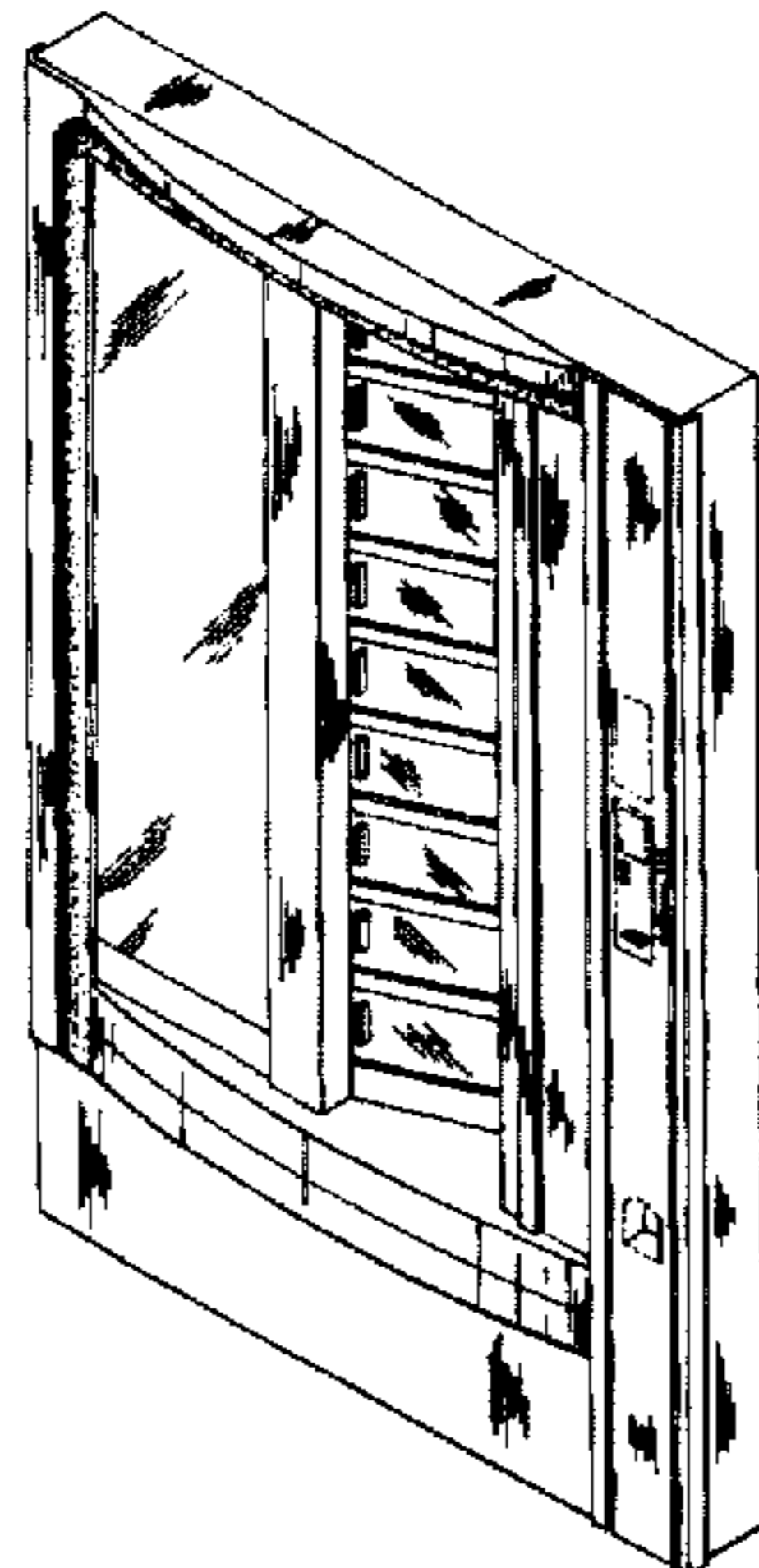
FIG. 2 is a front elevational view;

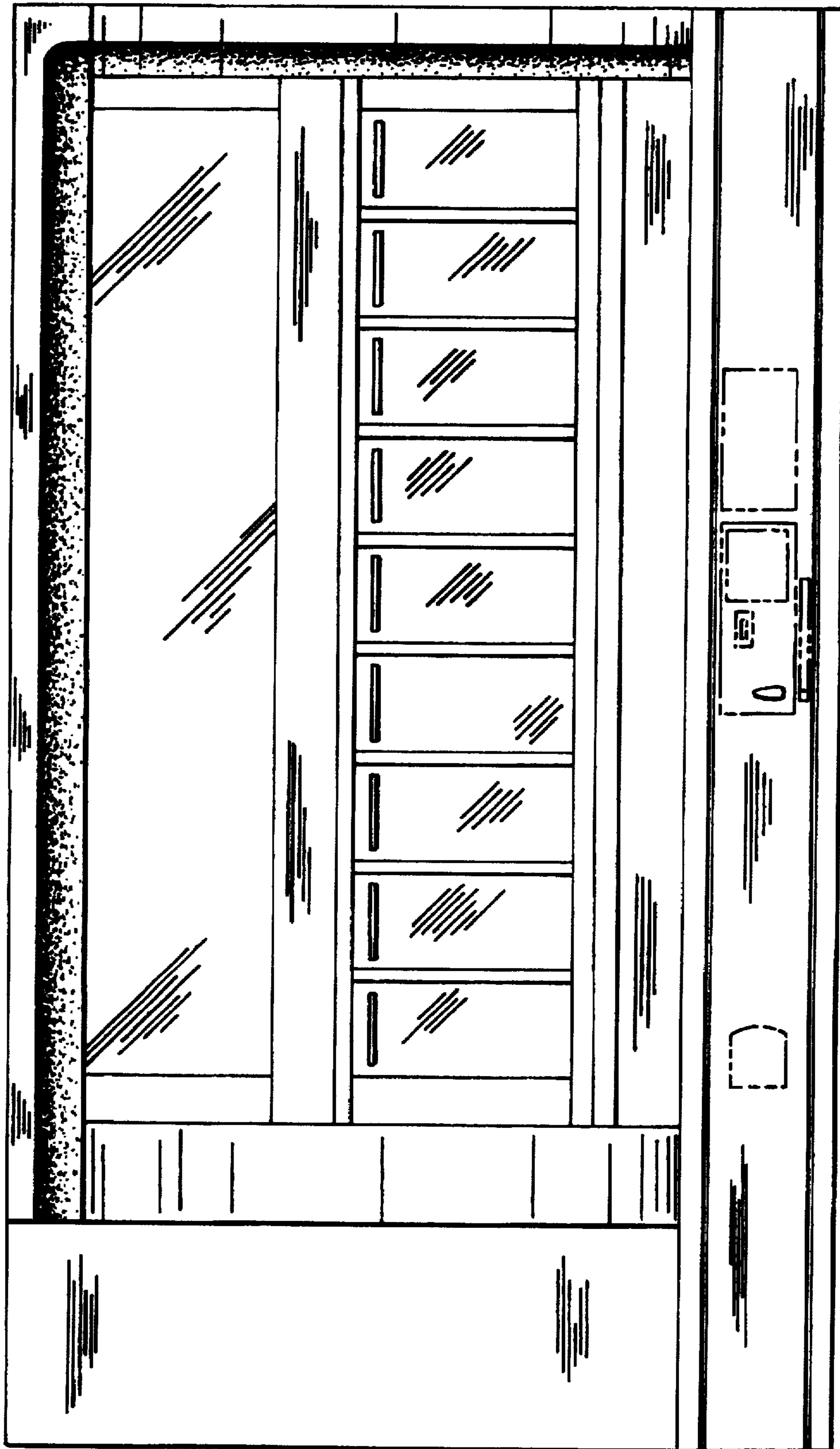

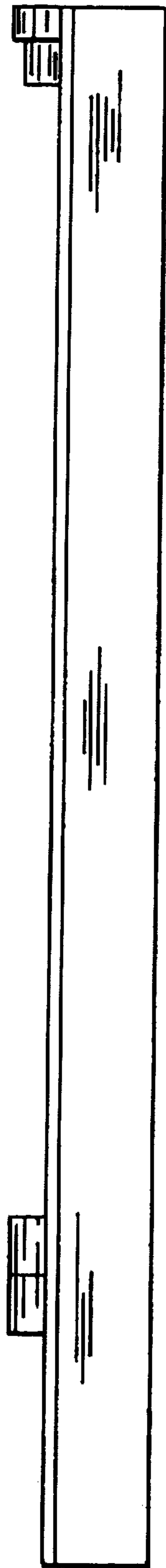

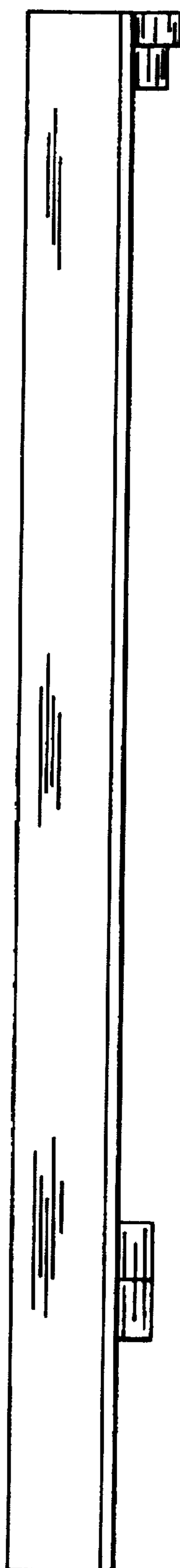

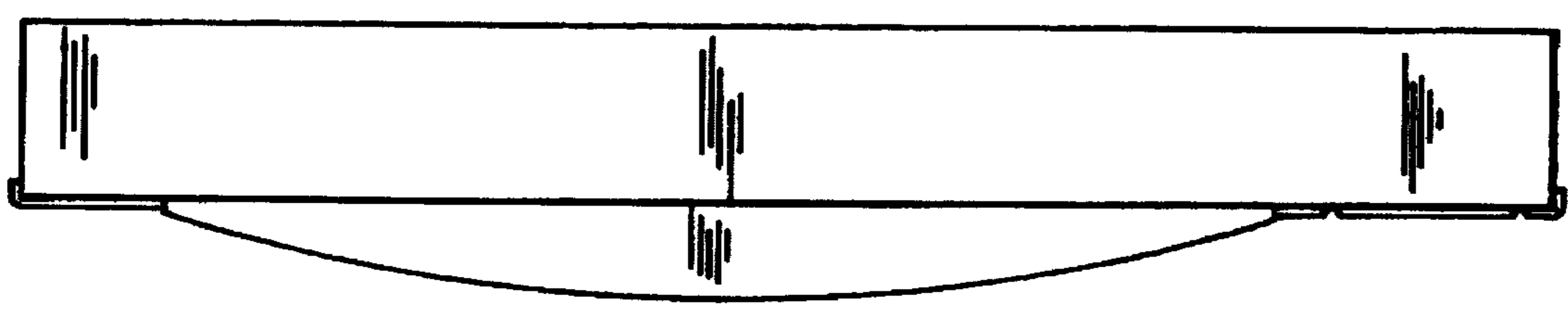
