DESCRIPTION

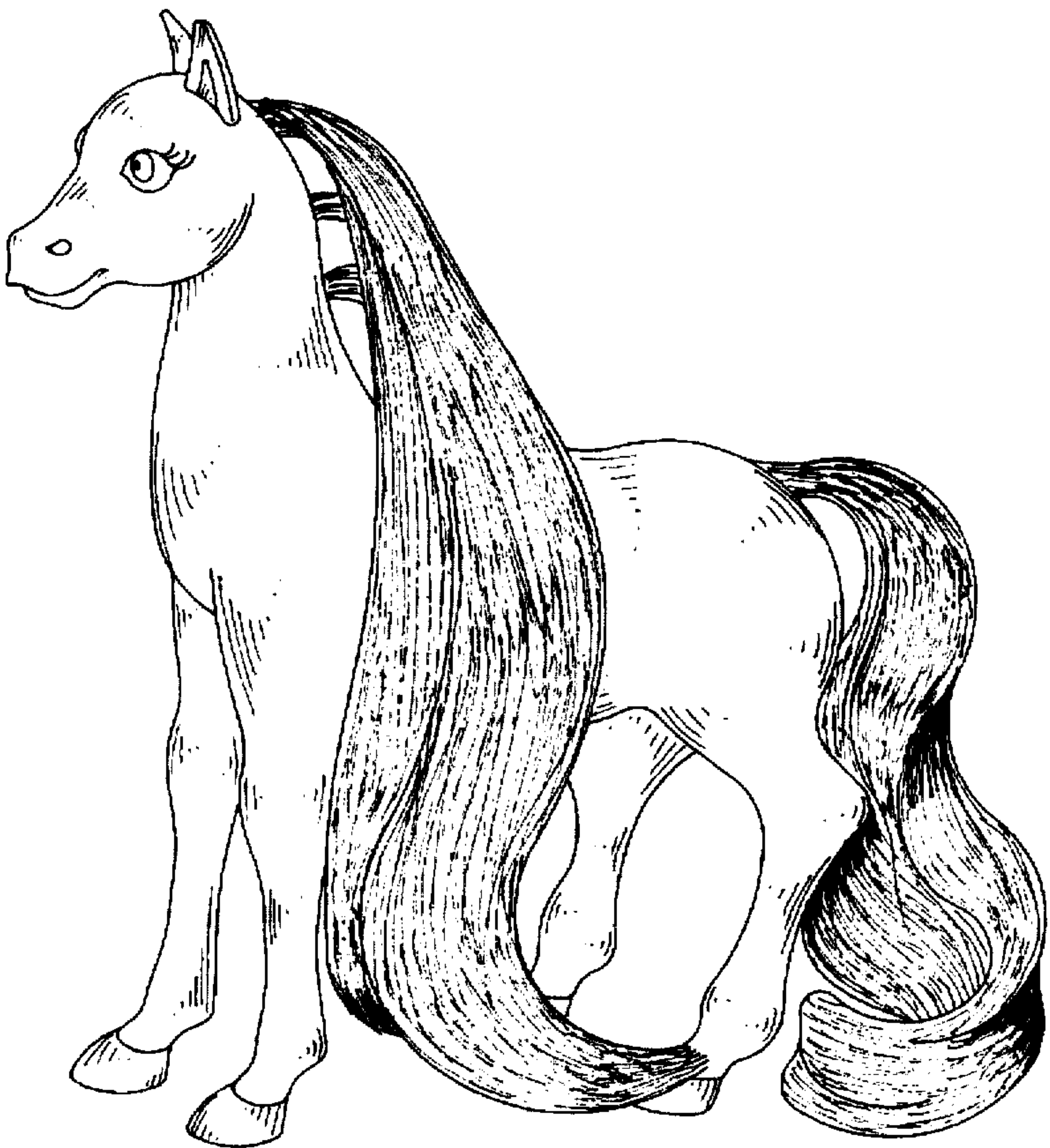

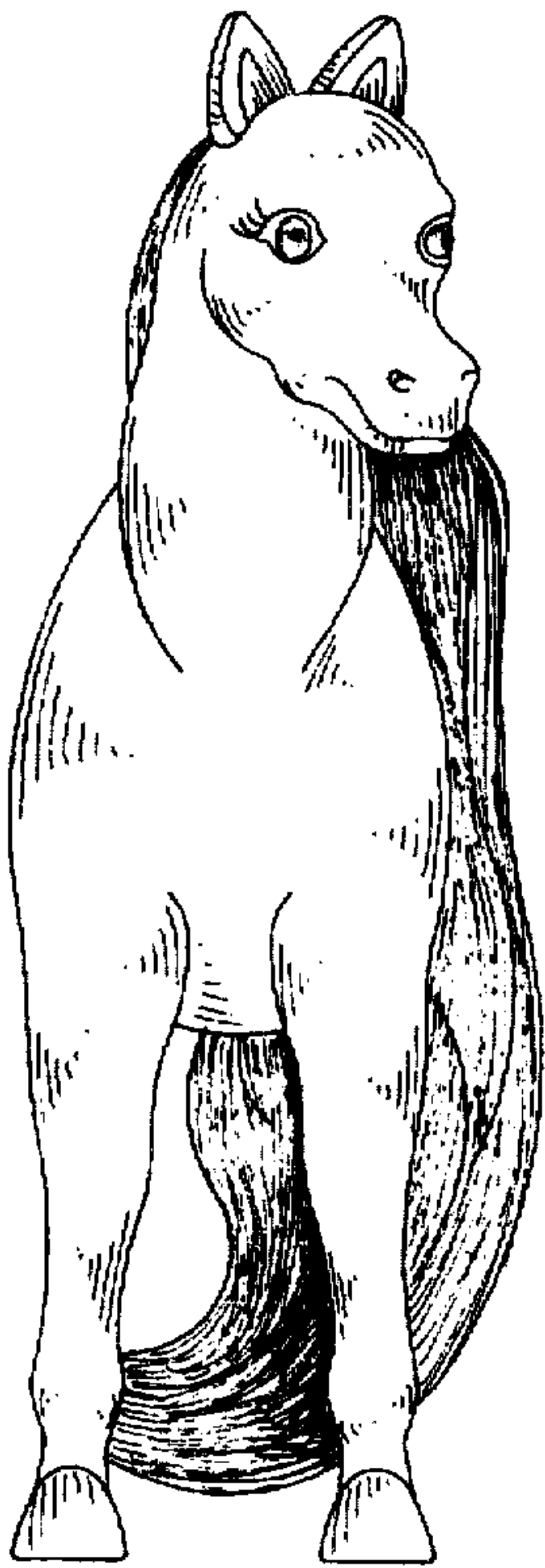

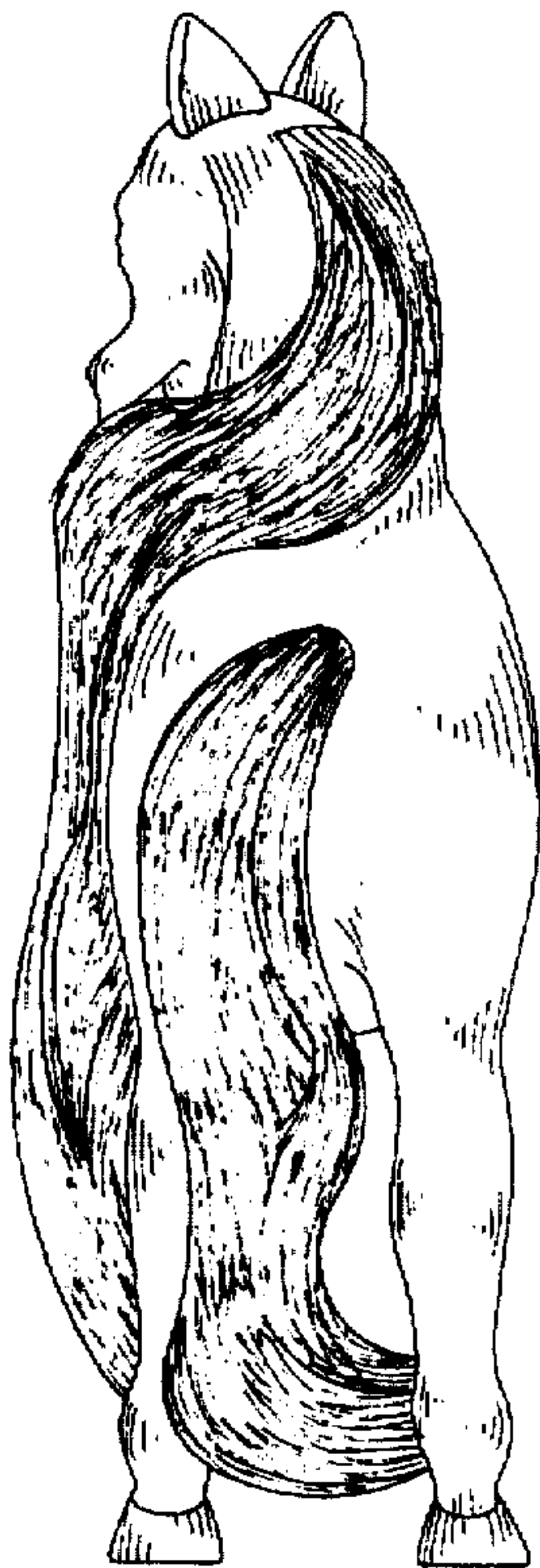

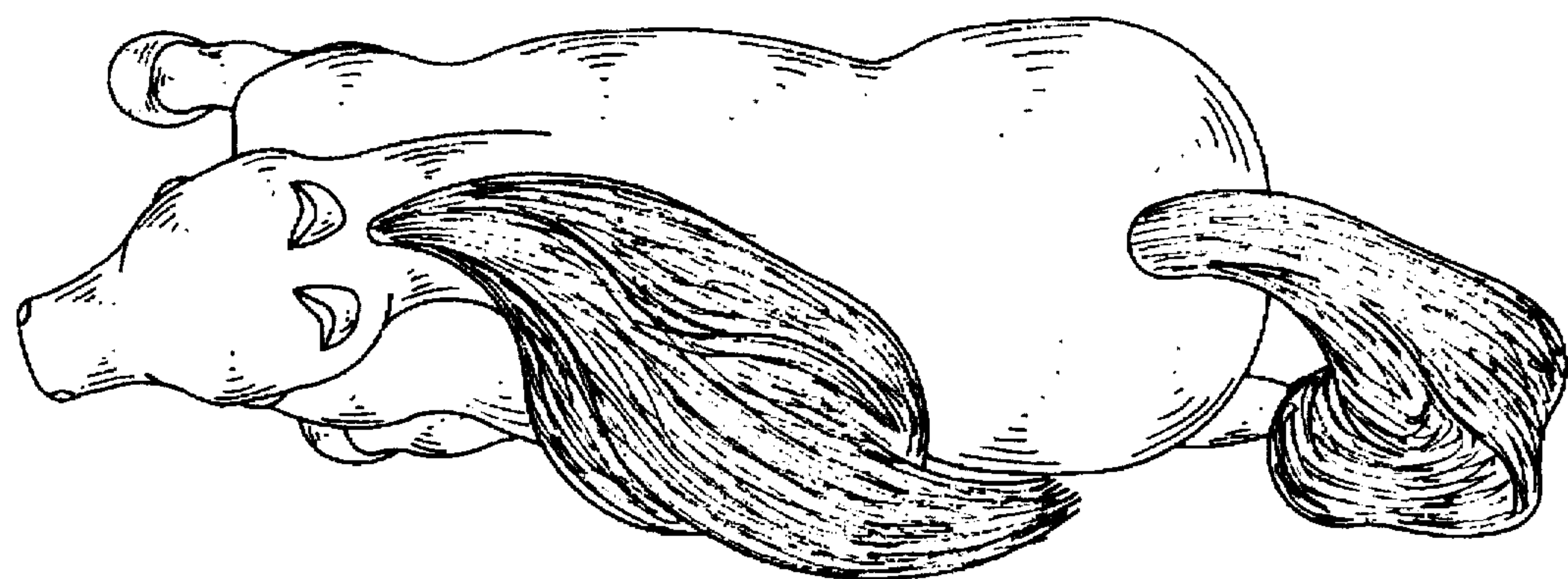

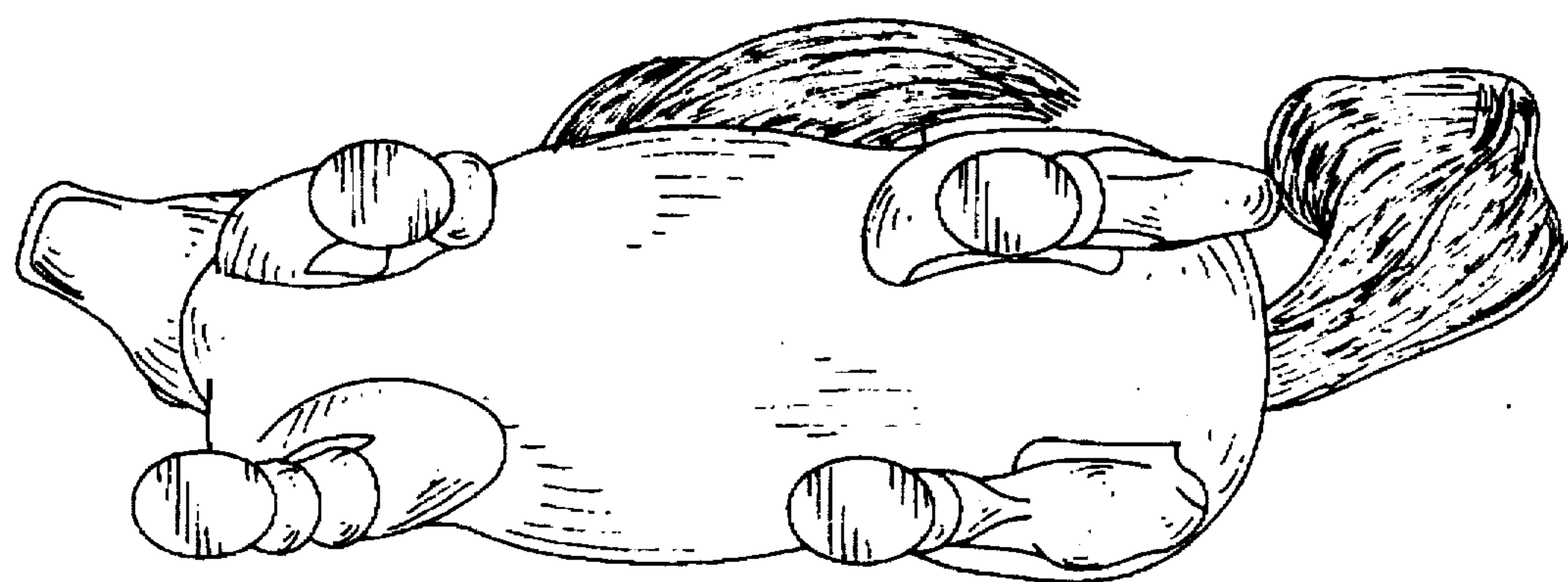

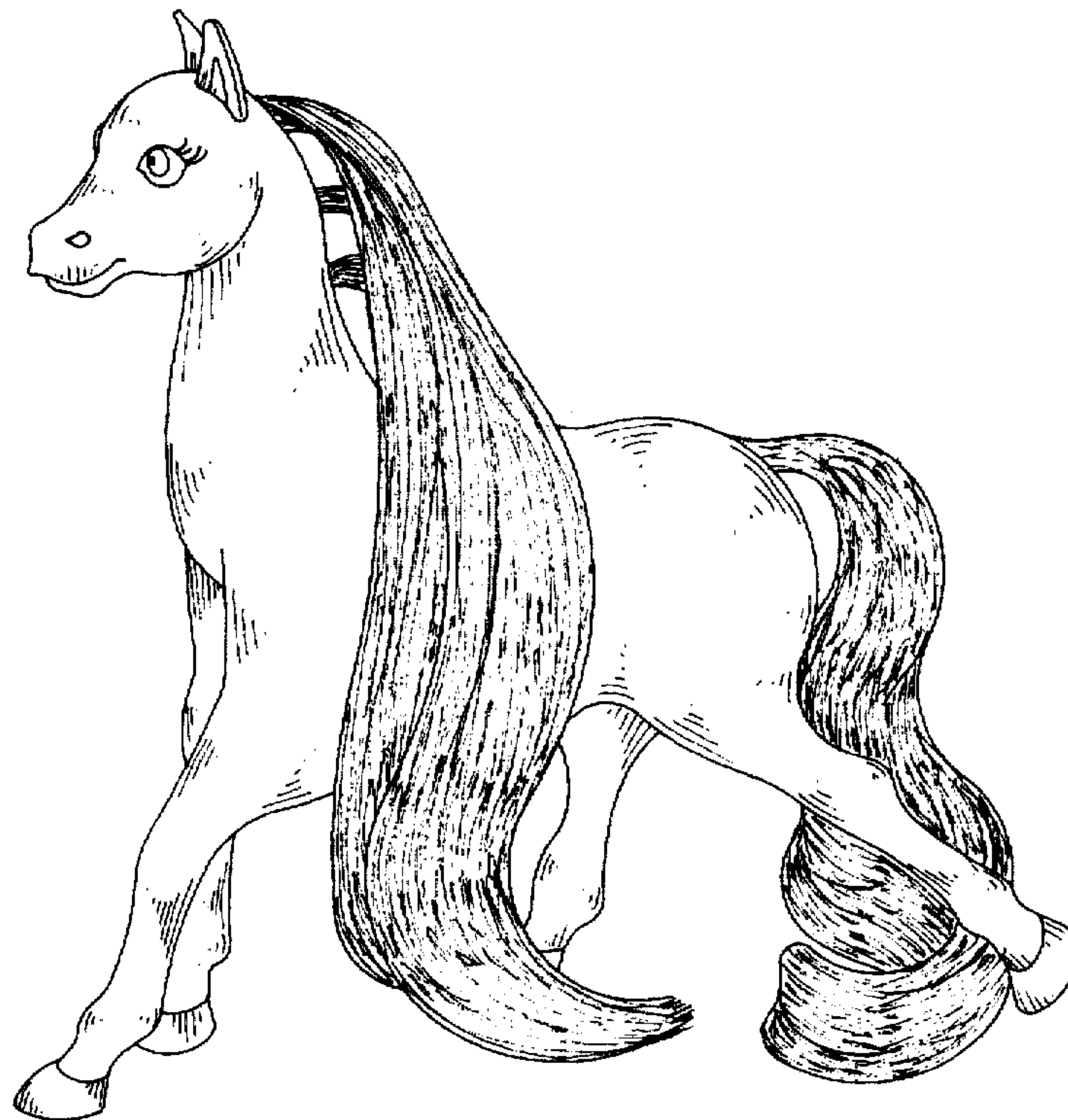

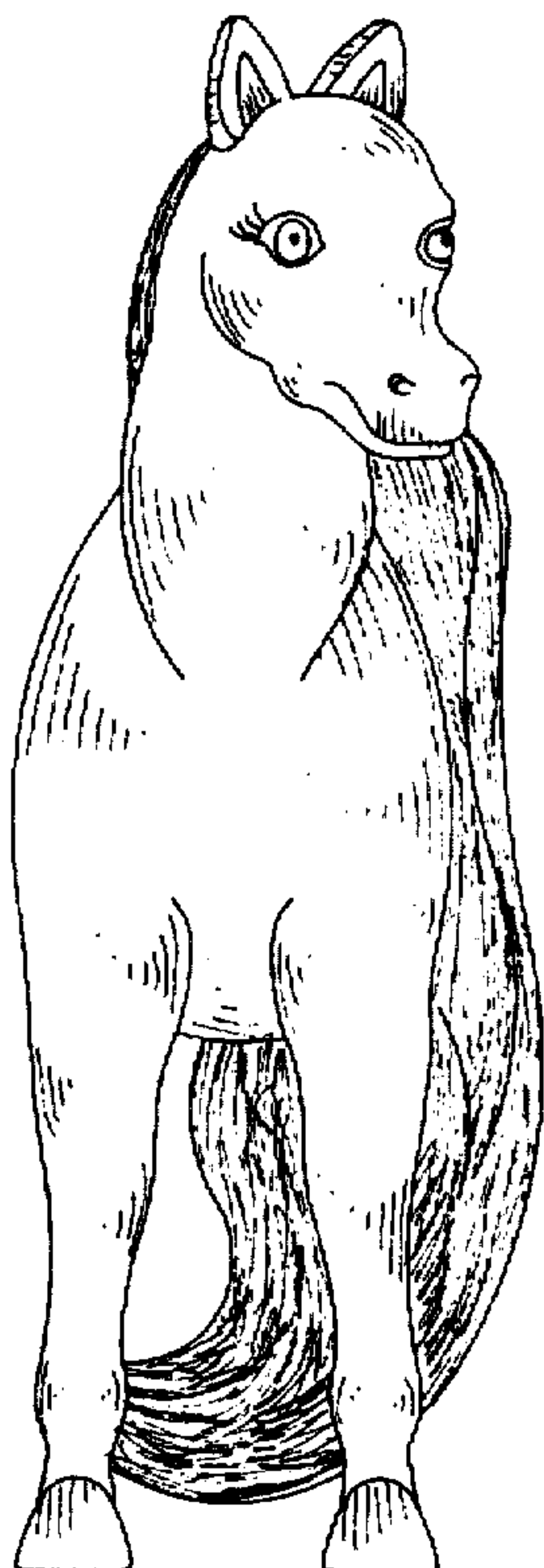

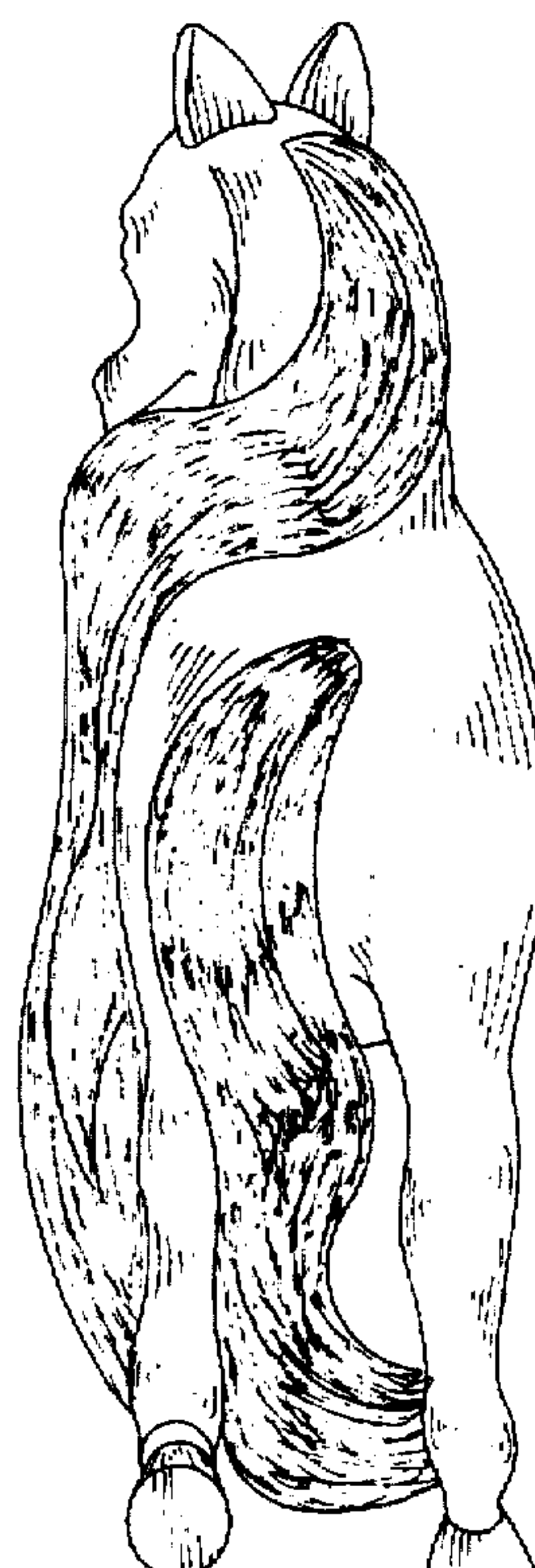

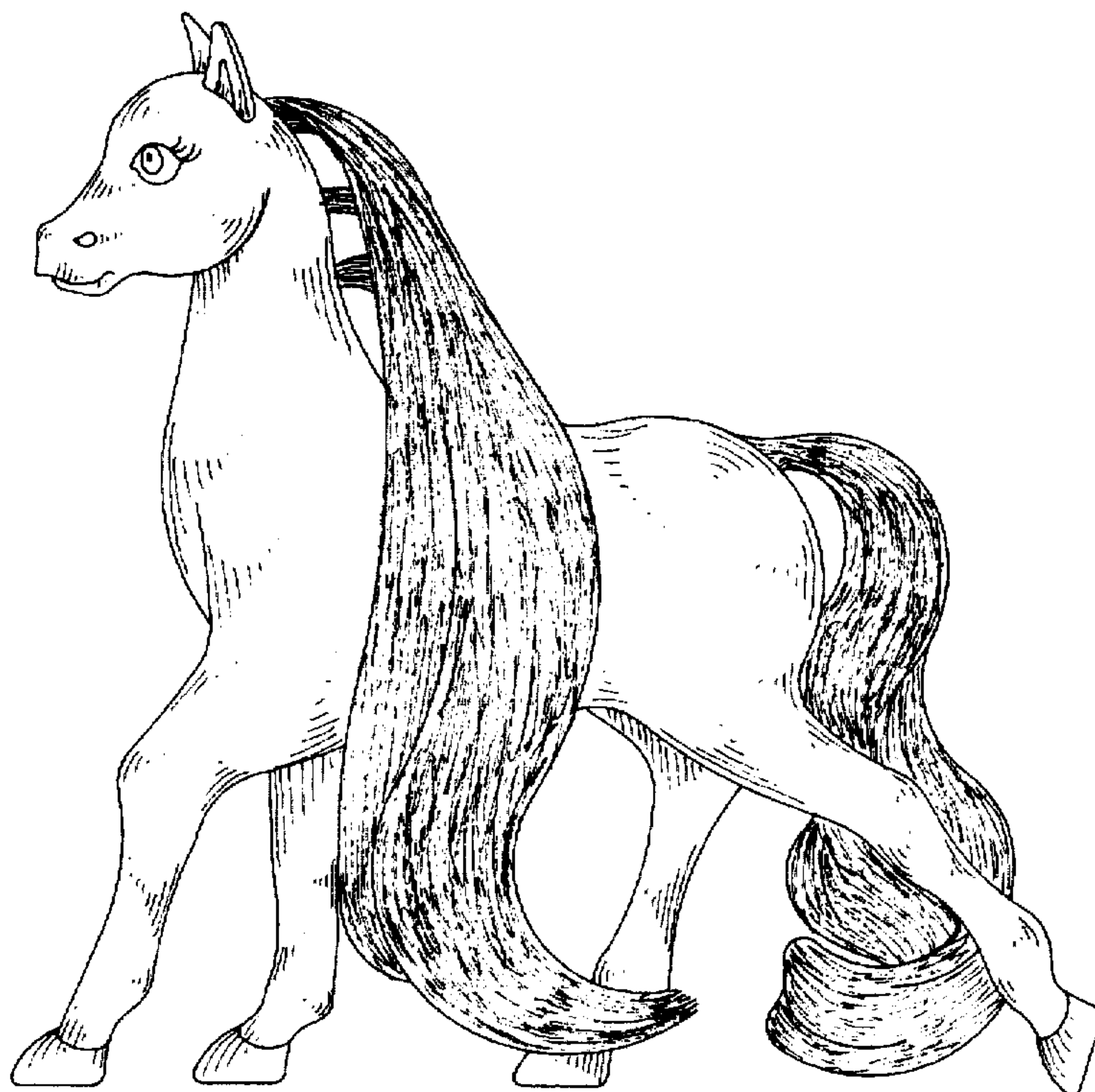

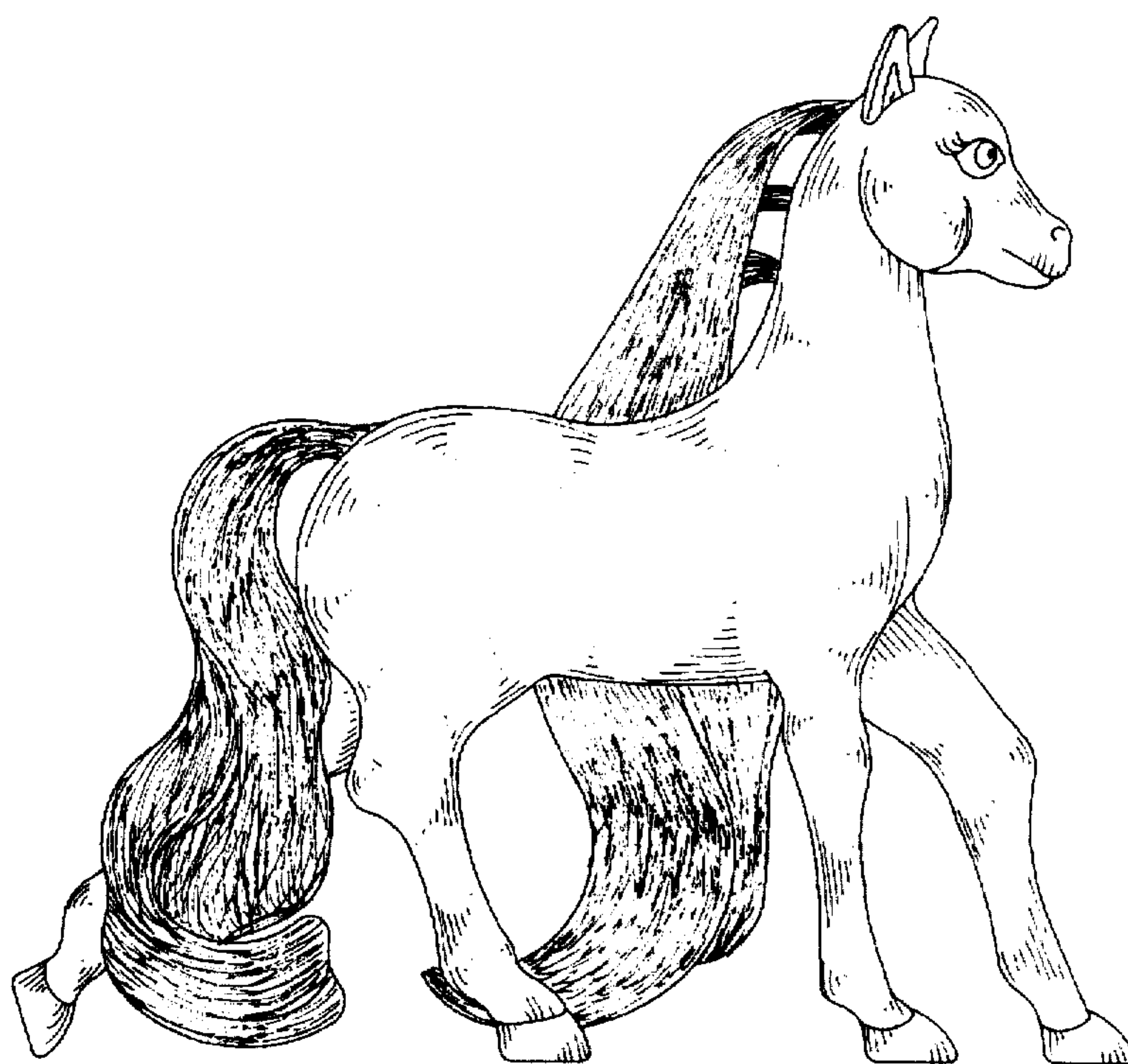

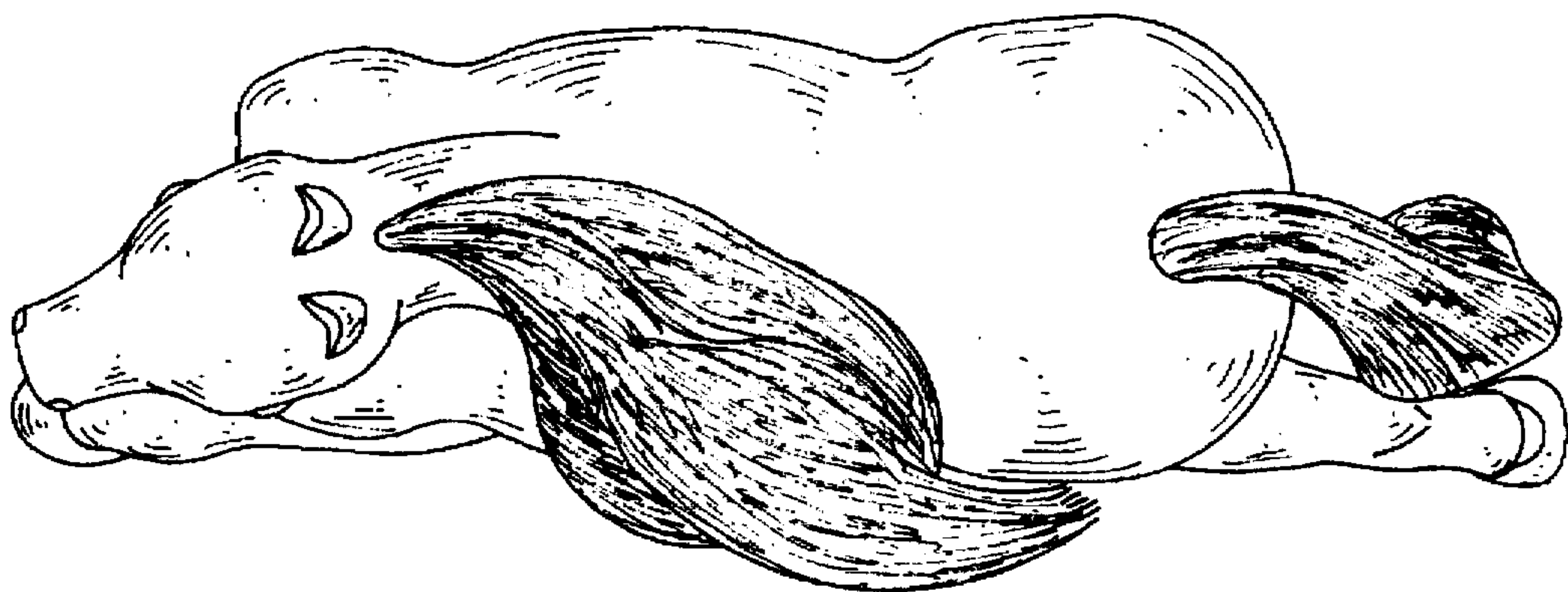

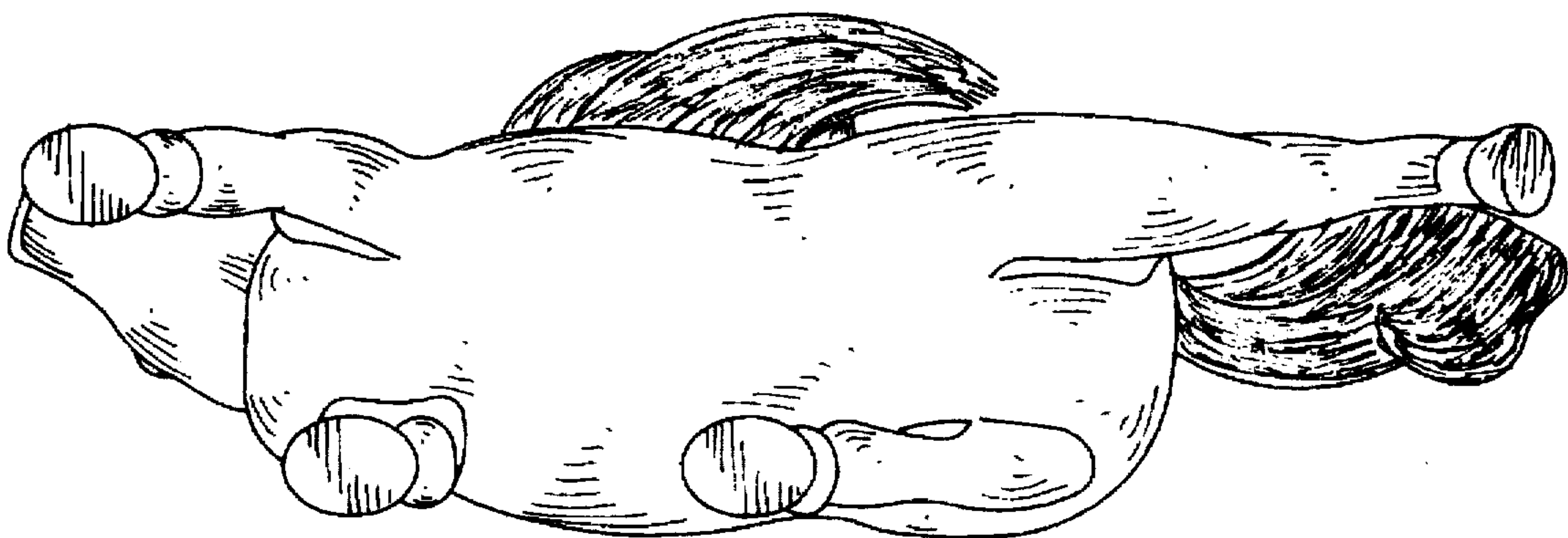
