The ornamental design for a combined dresser, gallery box and mirror, as shown and described.

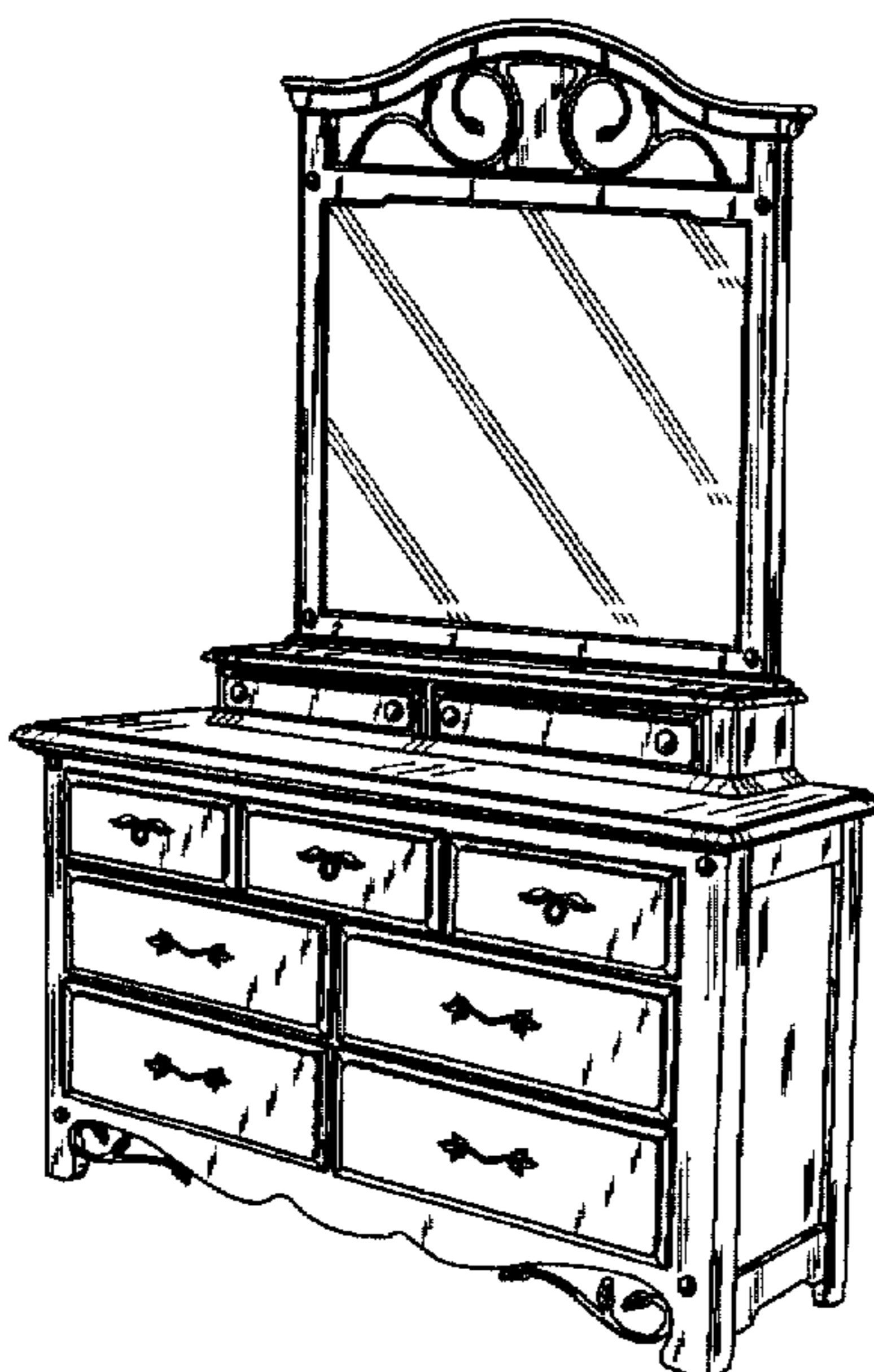
### DESCRIPTION

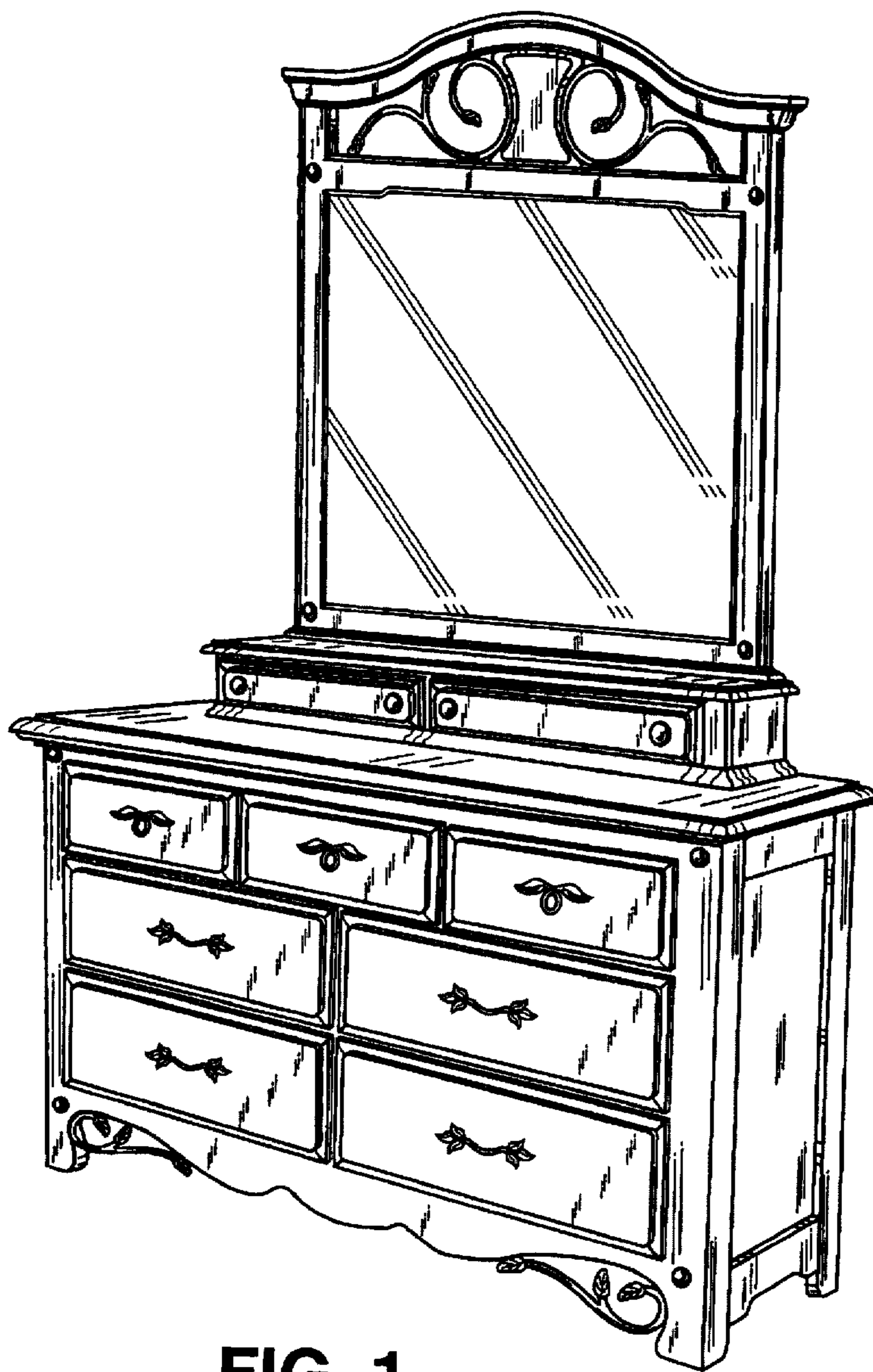

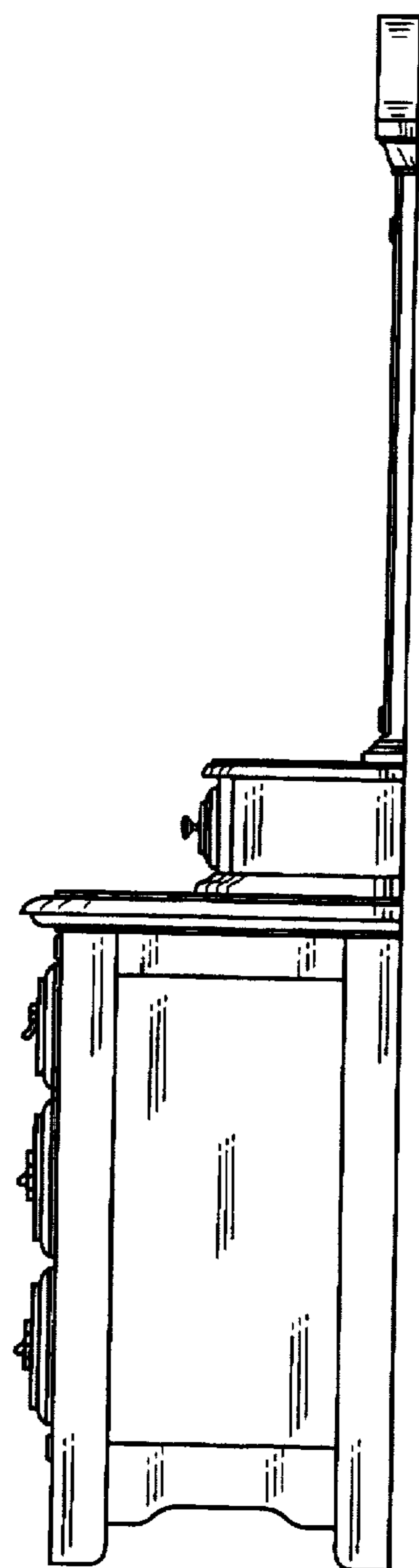

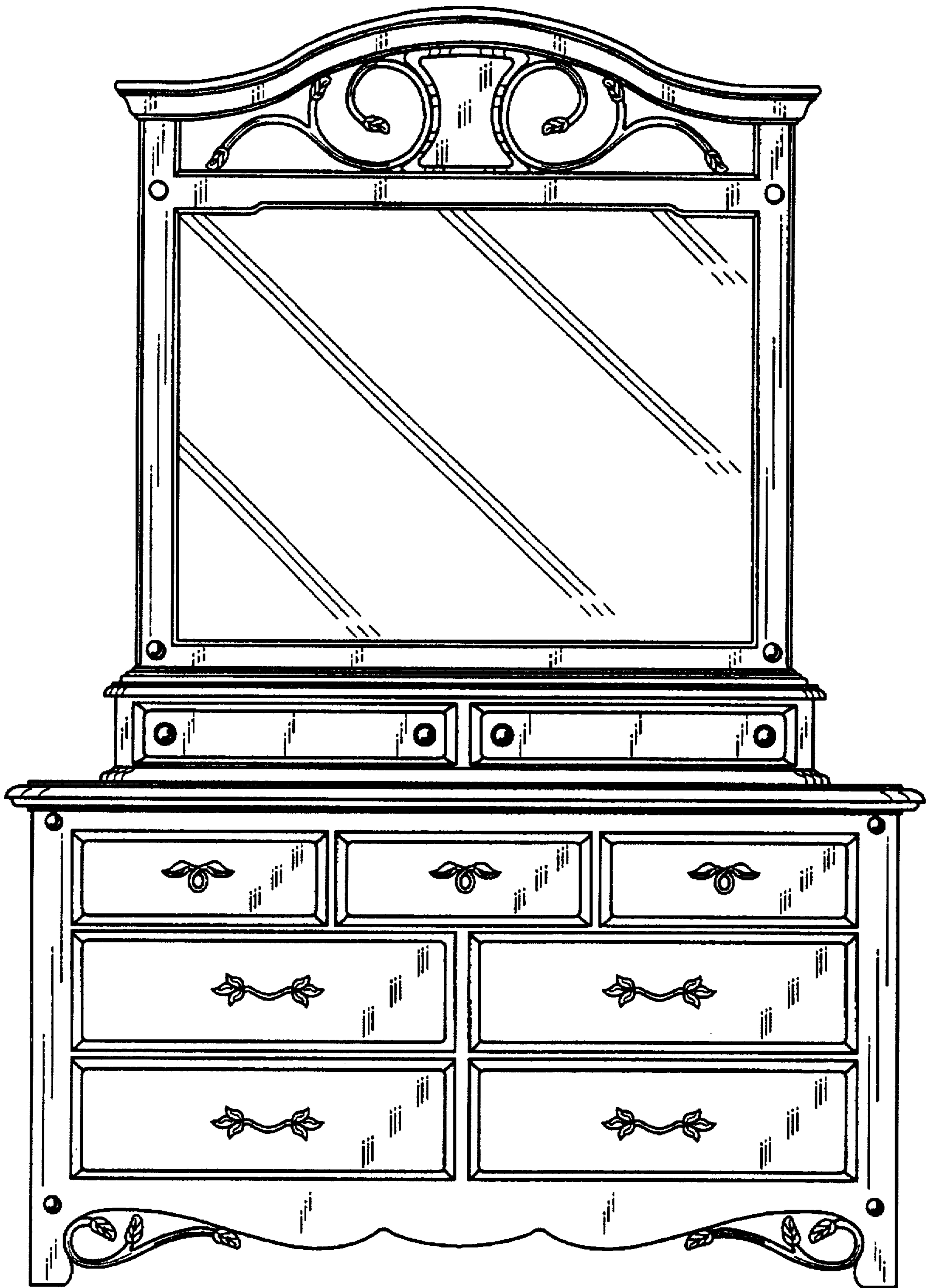
