[57] **CLAIM**

The ornamental design for a bottom profile of a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bottom profile of a shoe outsole showing my new design;
FIG. 2 is a bottom plan view thereof;
FIG. 3 is side elevational view thereof;
FIG. 4 is a side elevational view of the other side thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a front elevational view thereof;
FIG. 7 is a cross-sectional view taken along the line 7—7 of FIG. 2;
FIG. 8 is a cross-sectional view taken along the line 8—8 of FIG. 2;
FIG. 9 is a cross-sectional view taken along the line 9—9 of FIG. 2; and,
FIG. 10 is a cross-sectional view taken along the line 10—10 of FIG. 2.
The broken line showing of a shoe midsole and shoe upper shown in FIGS. 1, 5 and 6 is for illustrative purposes only and forms no part of the claimed design.

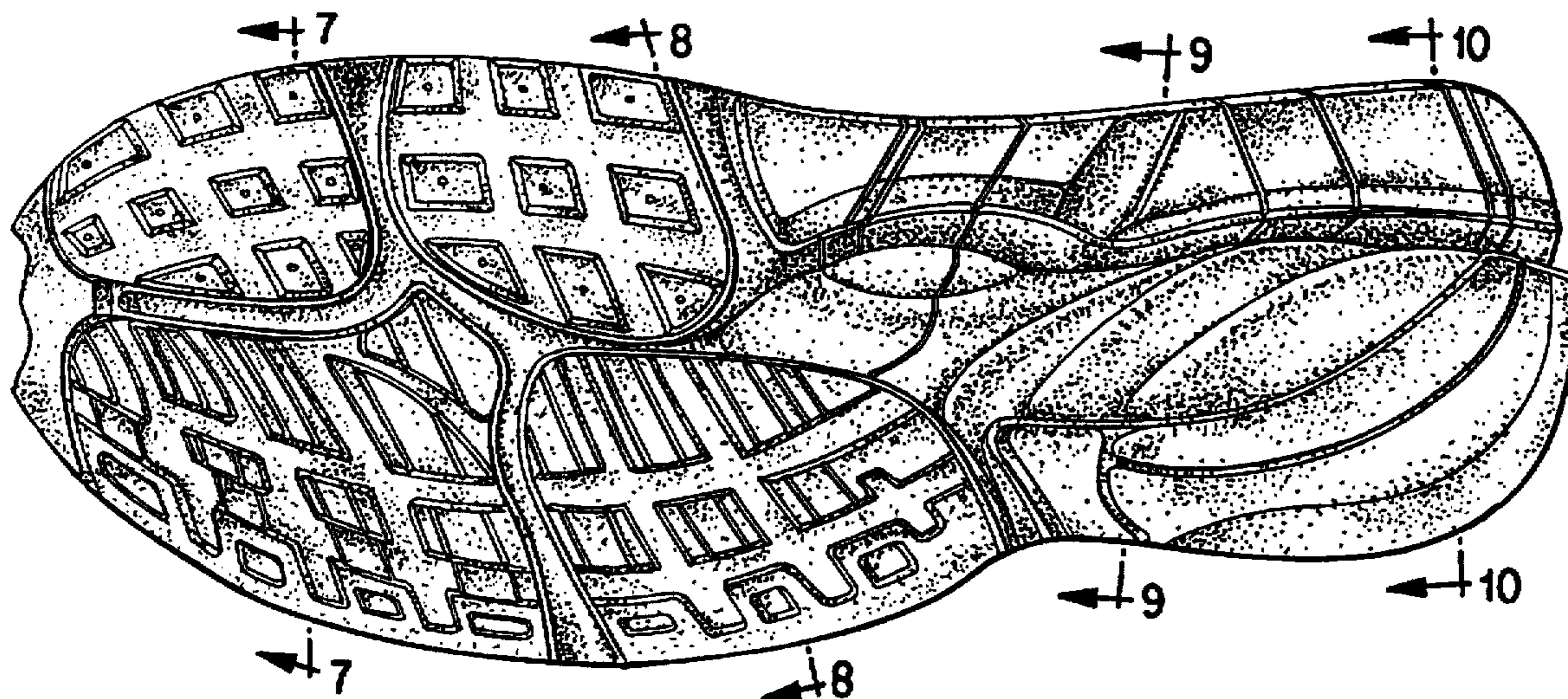

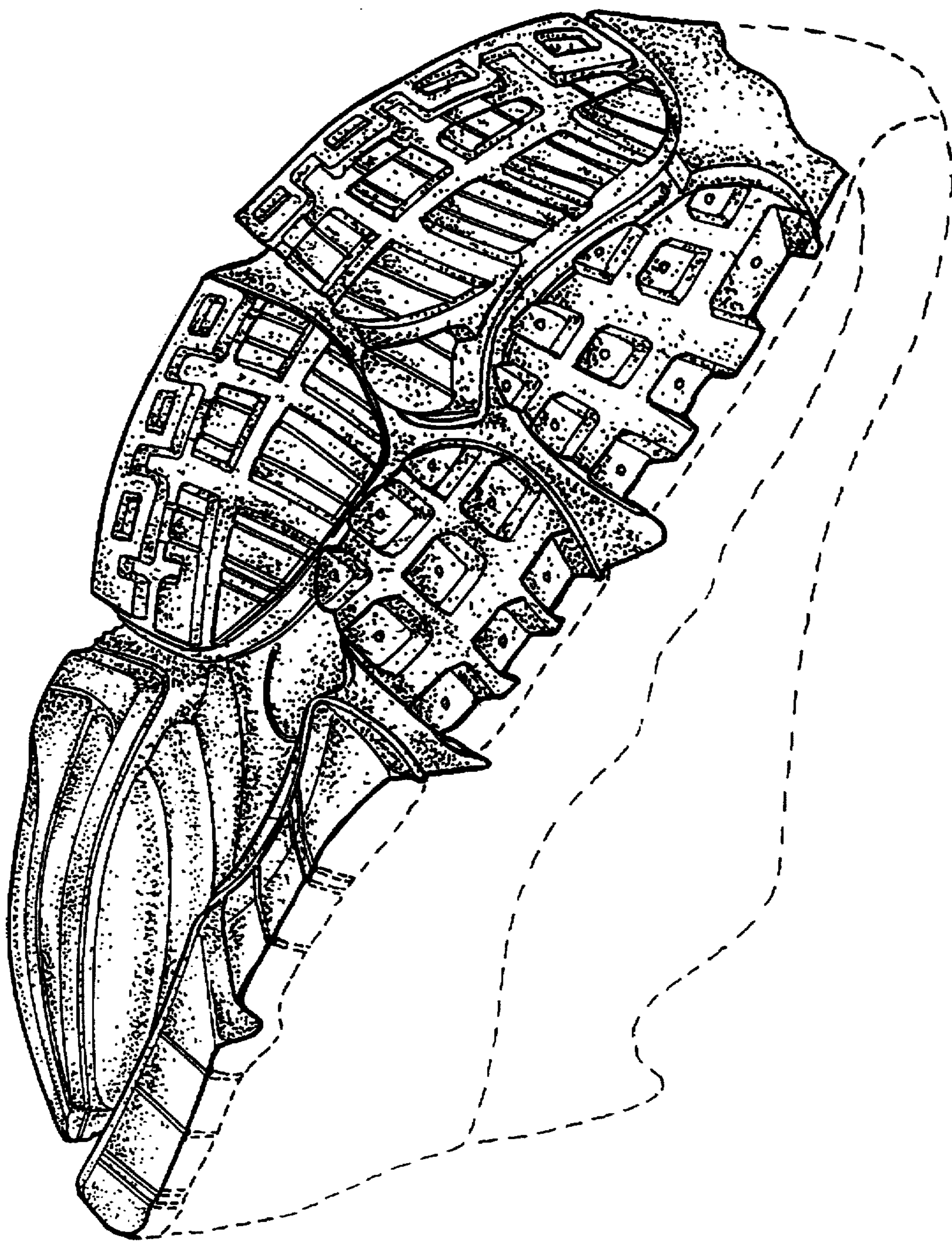

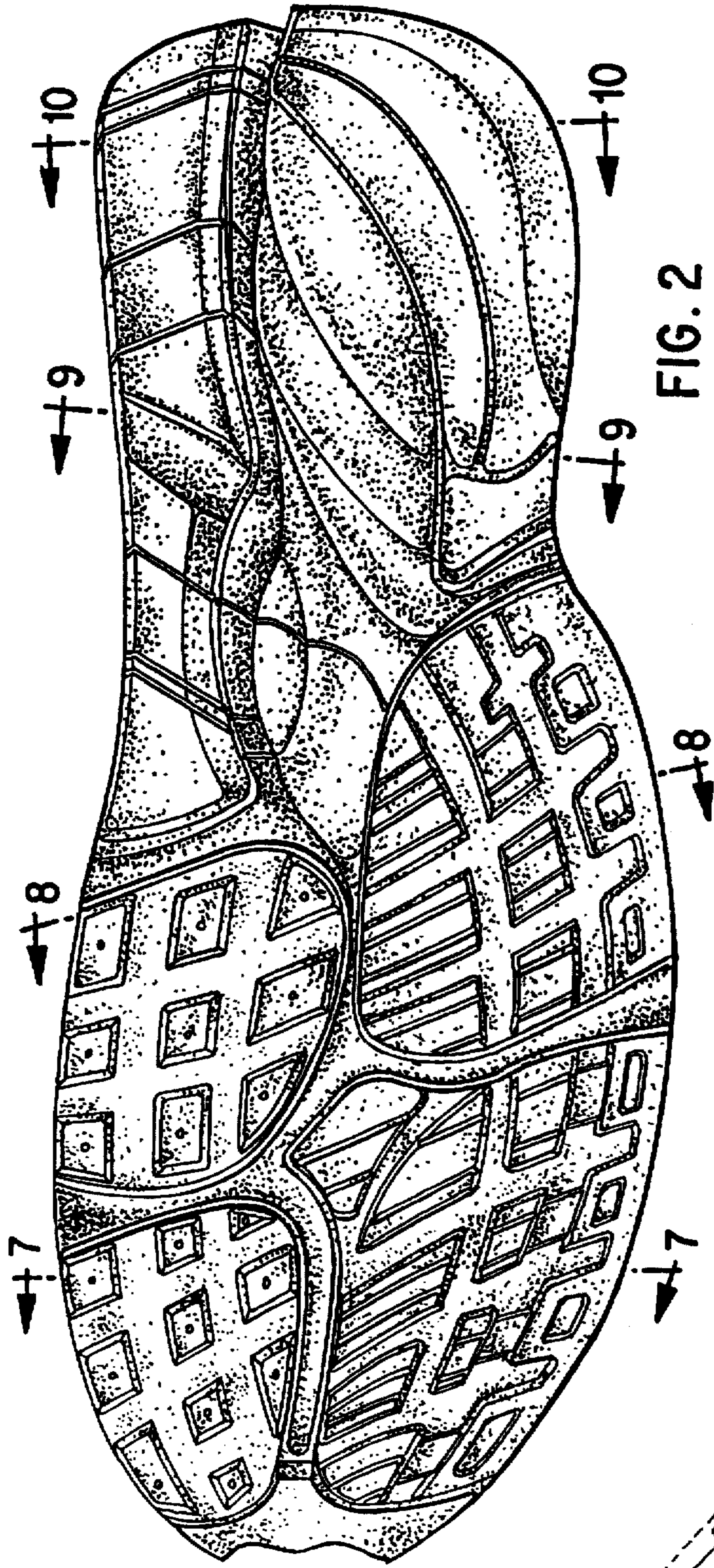

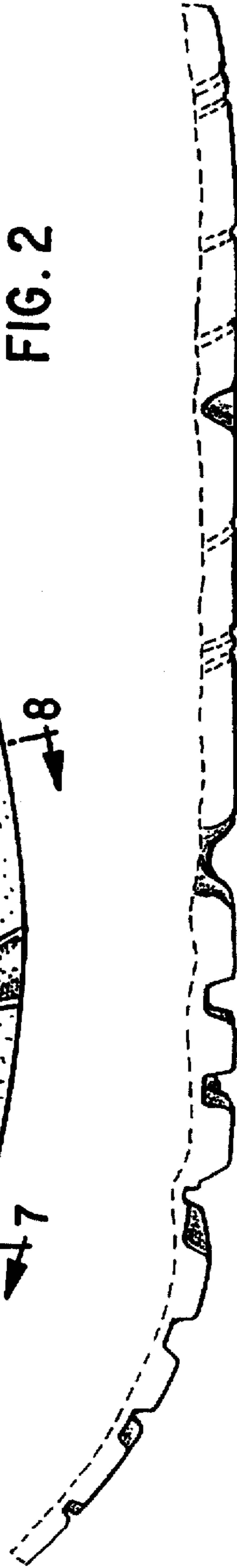

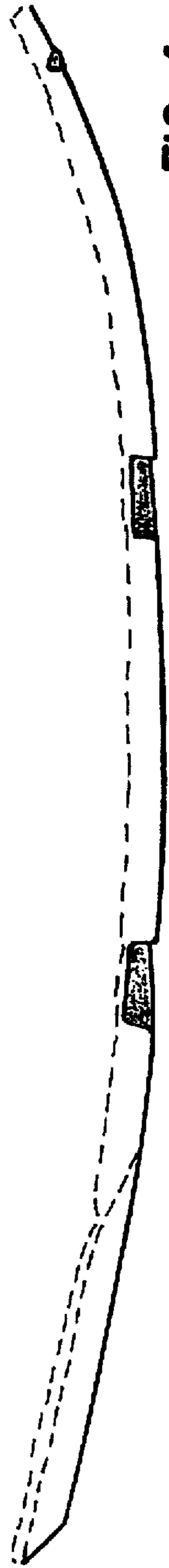

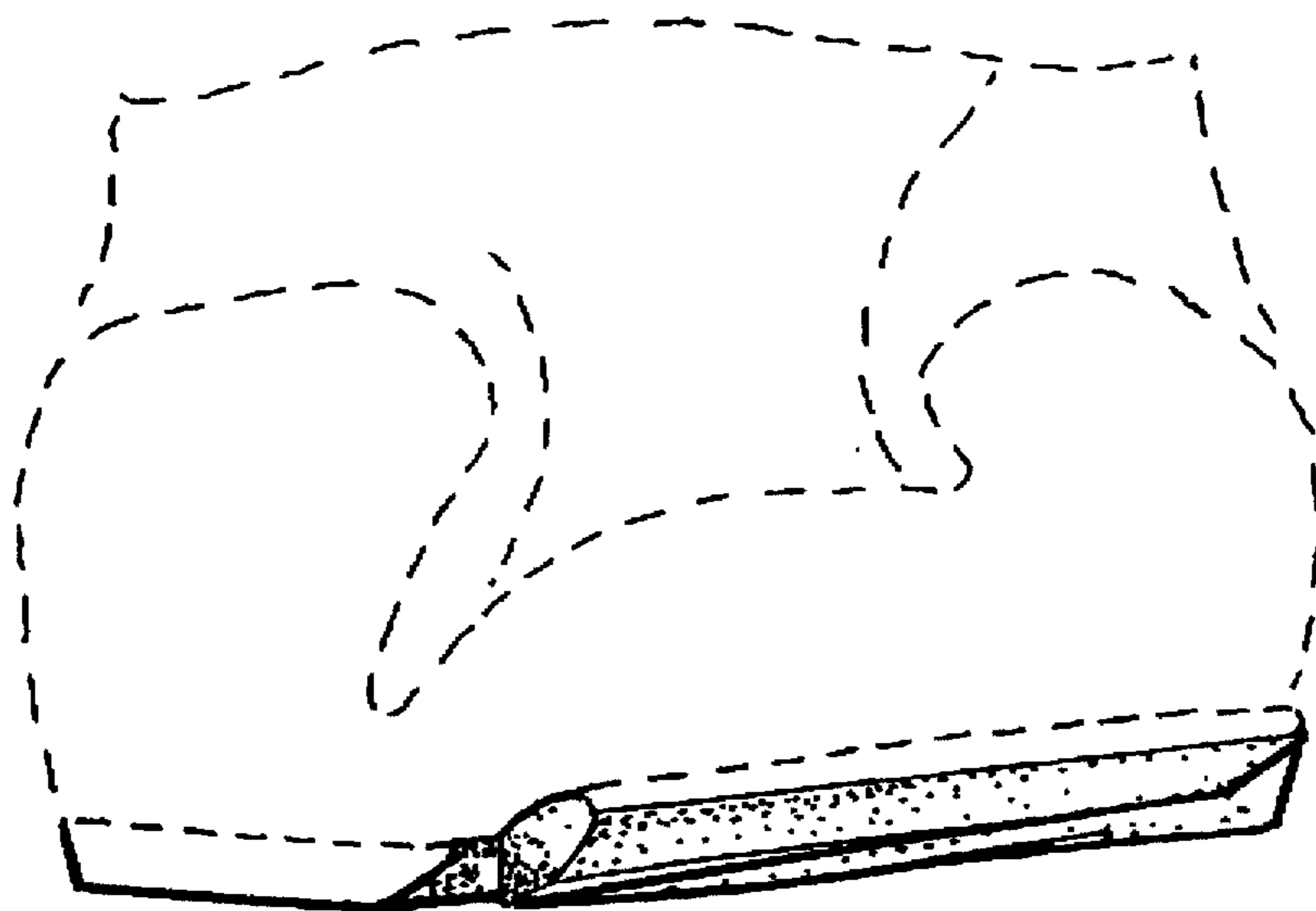

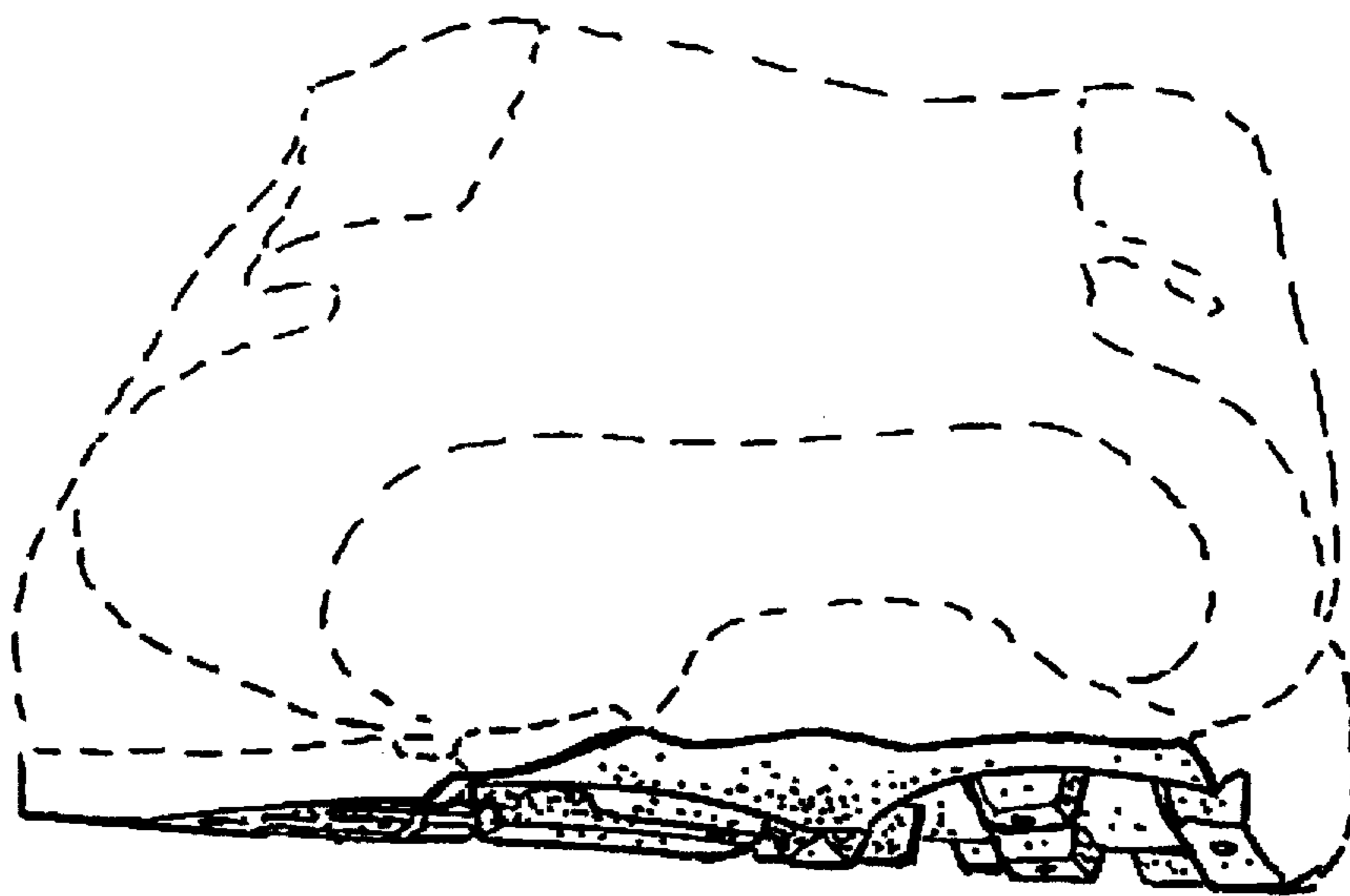

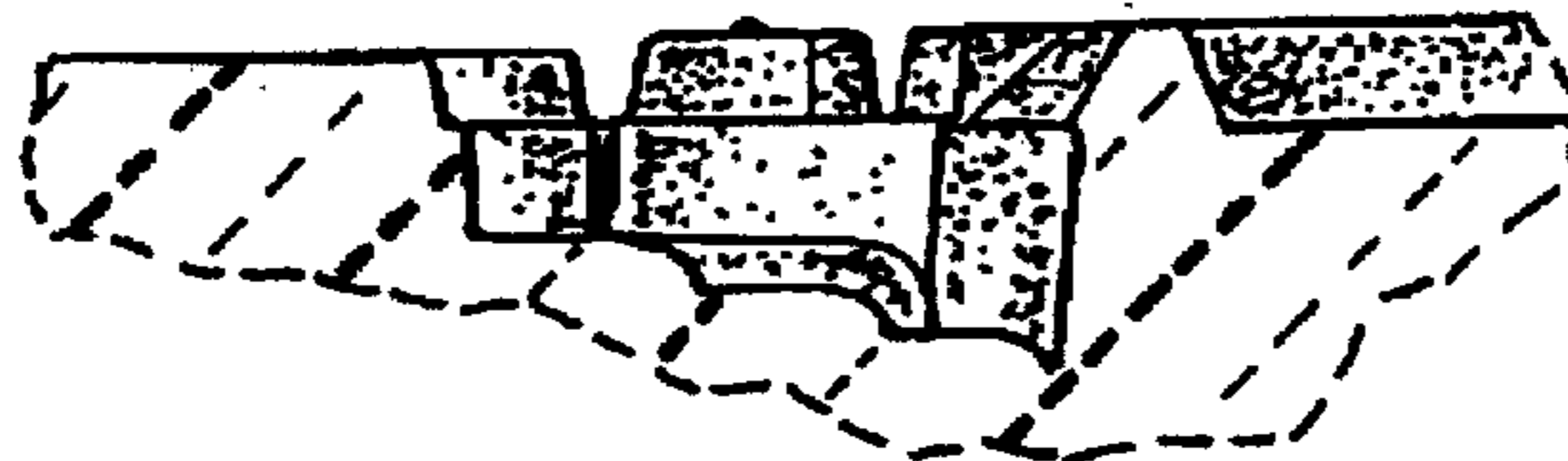
