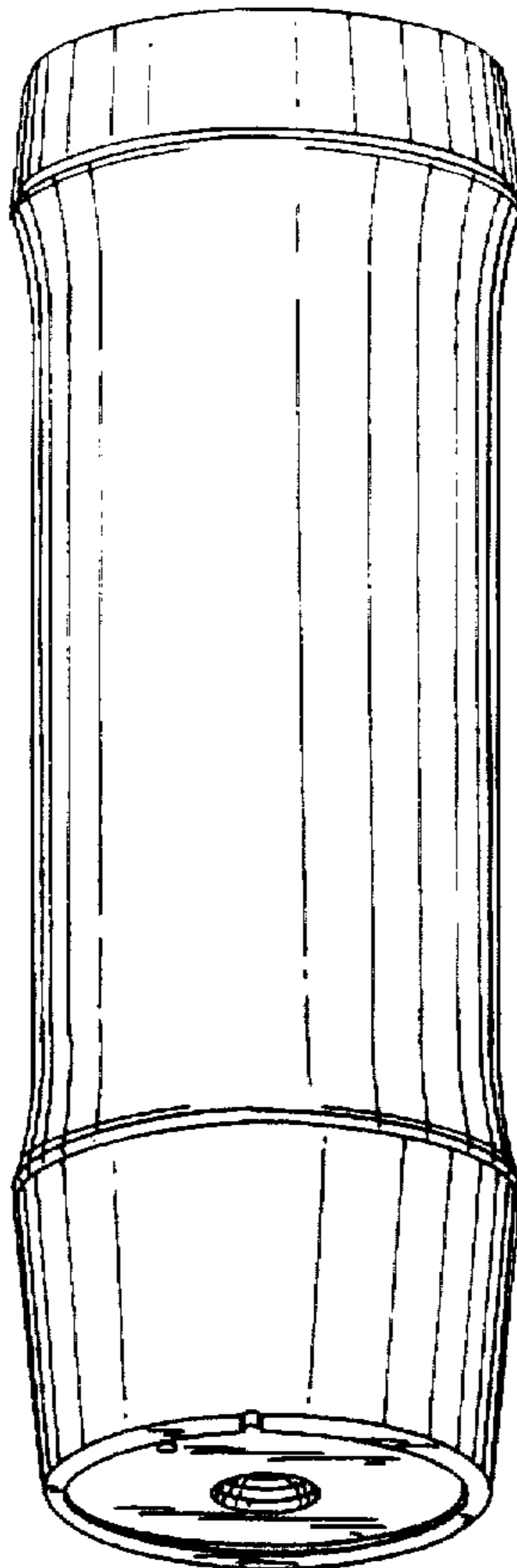
[57] **CLAIM**

The ornamental design for a combined bottle, dispensing closure and travel cap, as shown and described.

DESCRIPTION

- FIG. 1 is a perspective view;
- FIG. 2 is a bottom plan view;
- FIG. 3 is a rear elevation thereof, the side elevations are the same;
- FIG. 4 is a front thereof;
- FIG. 5 is a top plan view thereof;
- FIG. 6 is a front elevation showing the travel cap in an alternate position at the bottom of the bottle, the rear and side elevations are the same; and,
- FIG. 7 is a top plan view of FIG. 6.

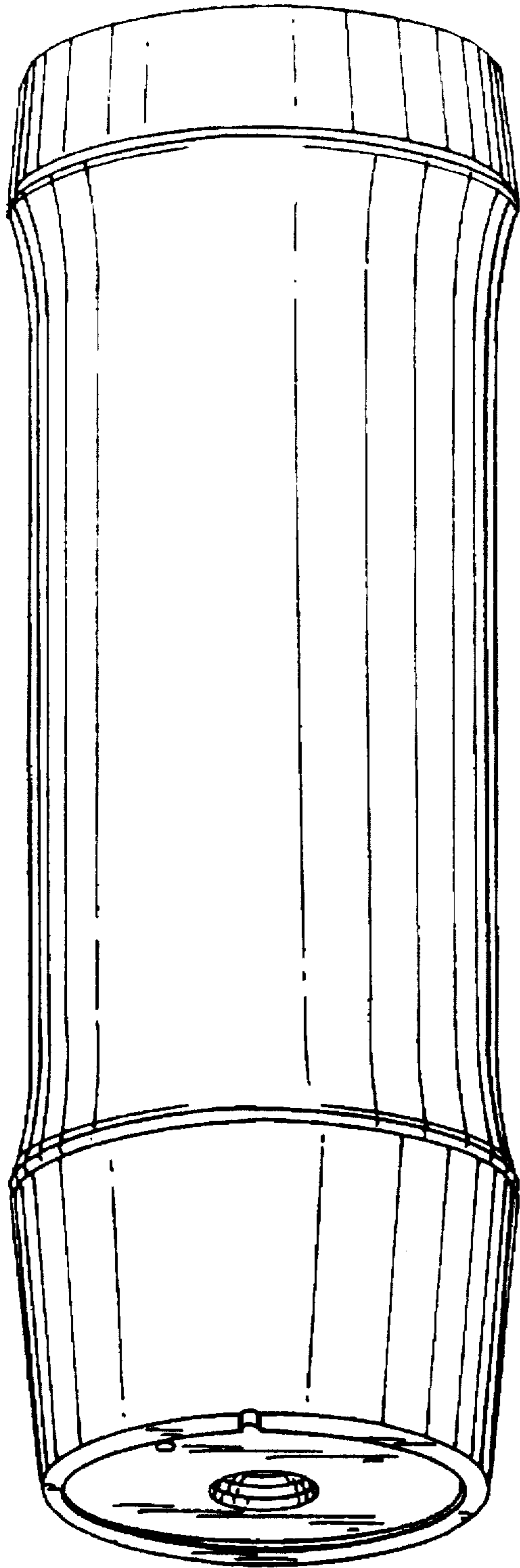

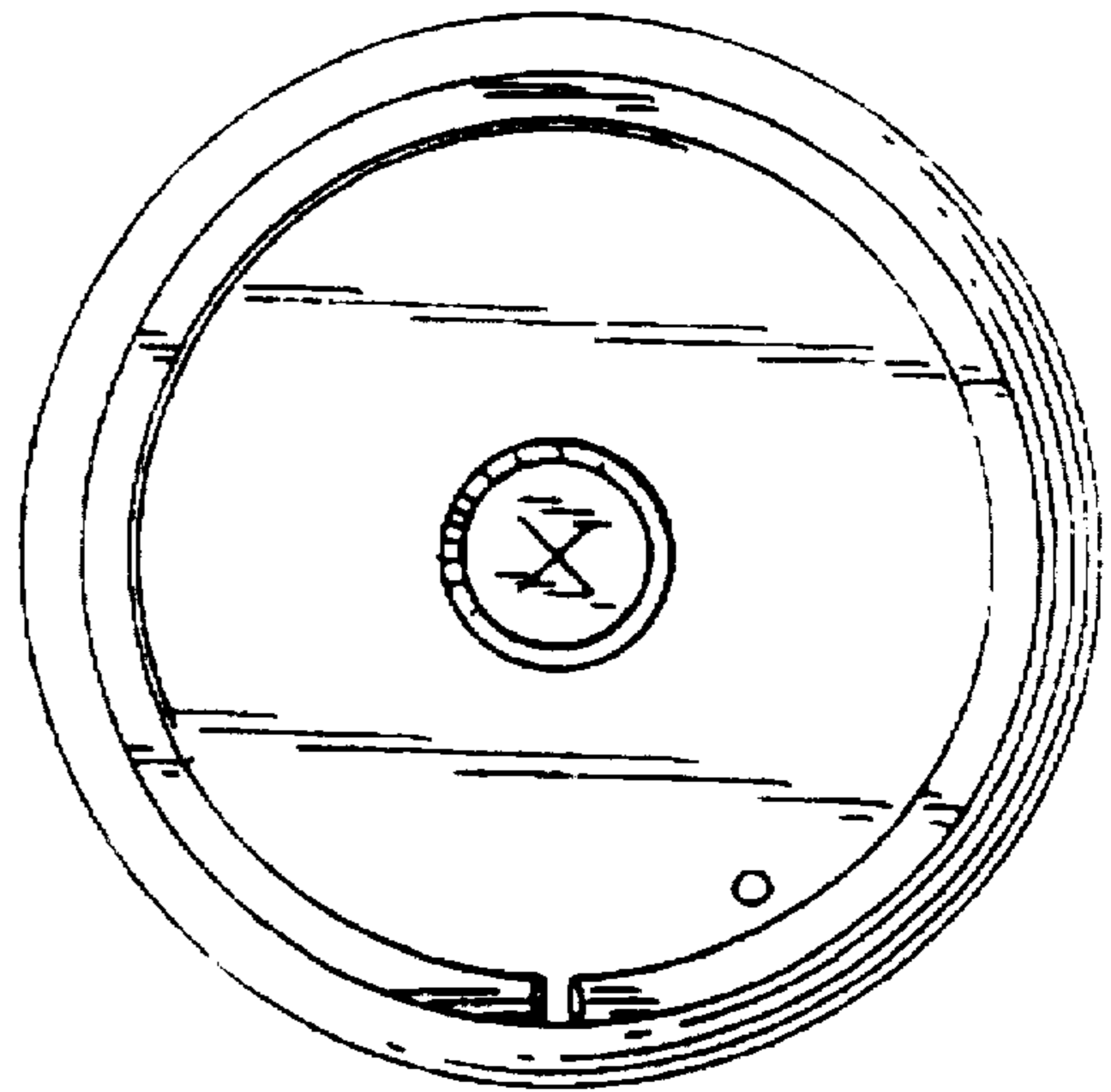

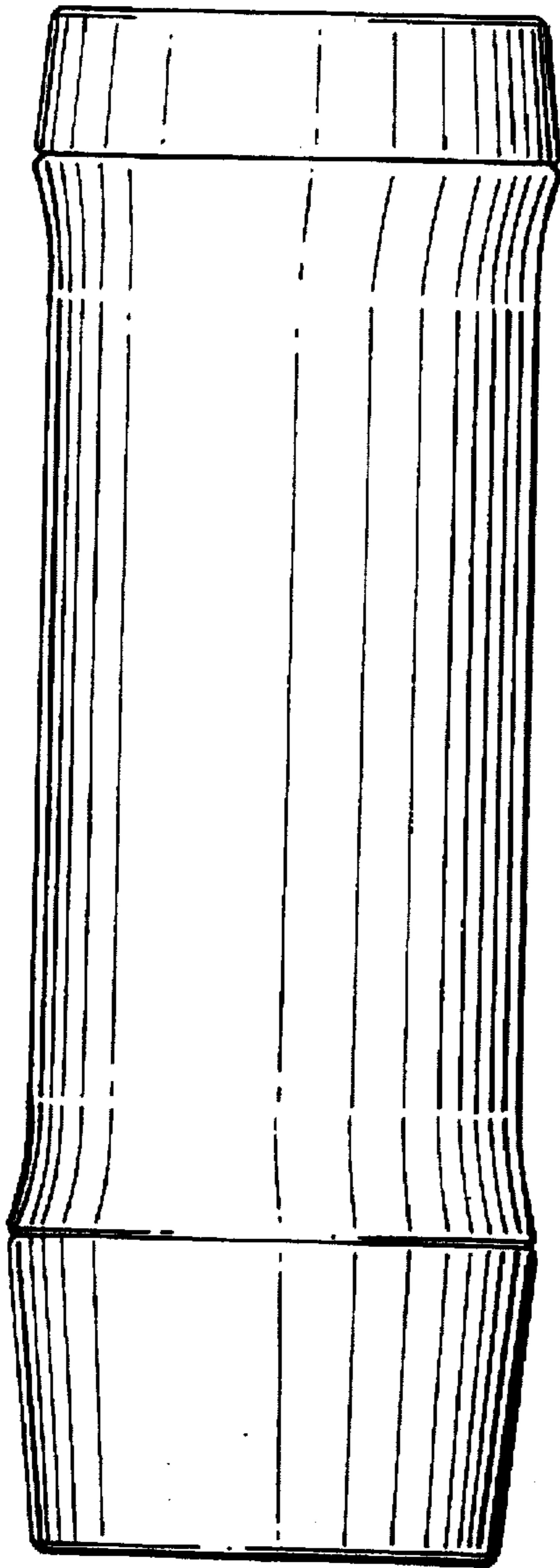

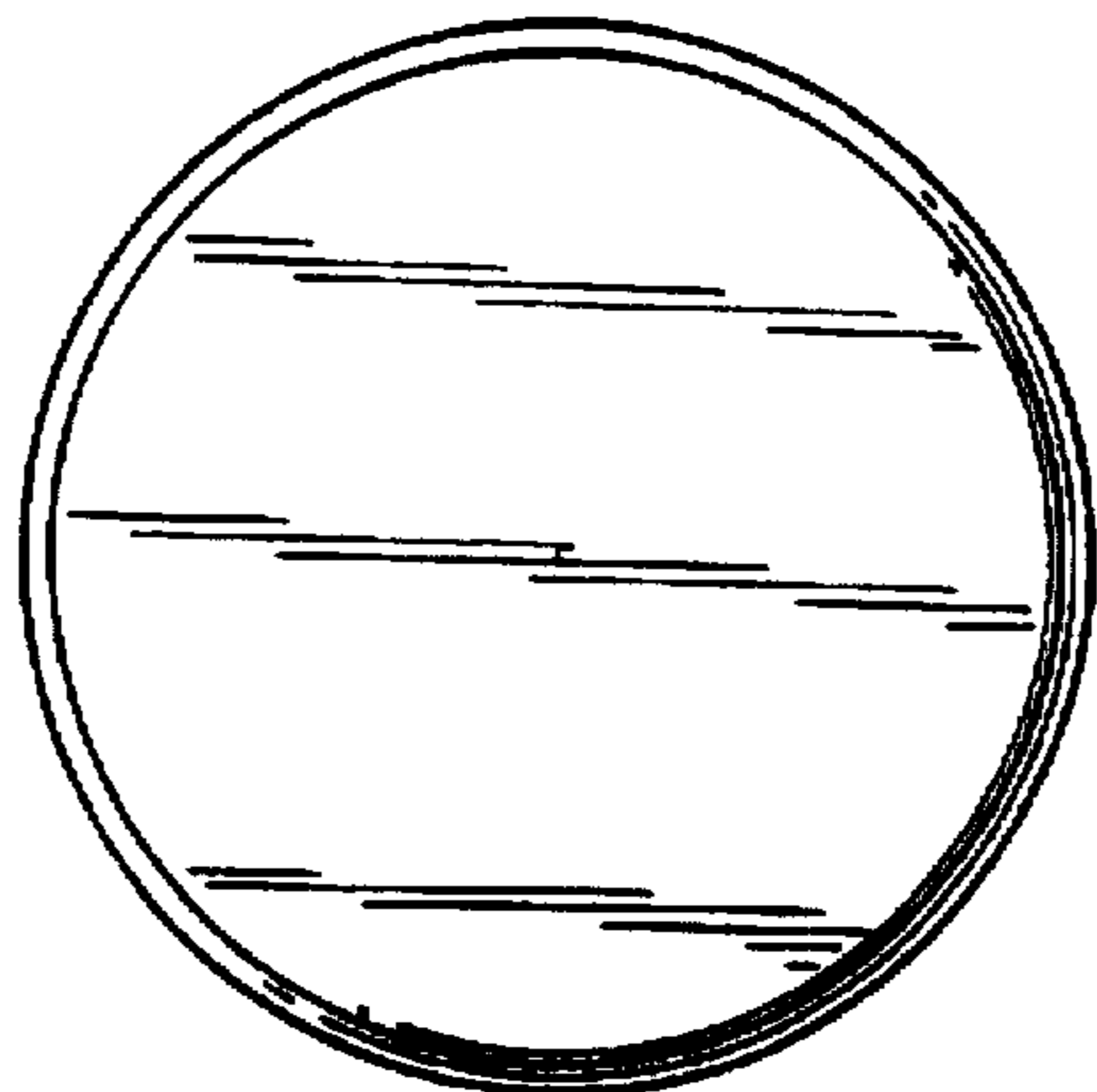
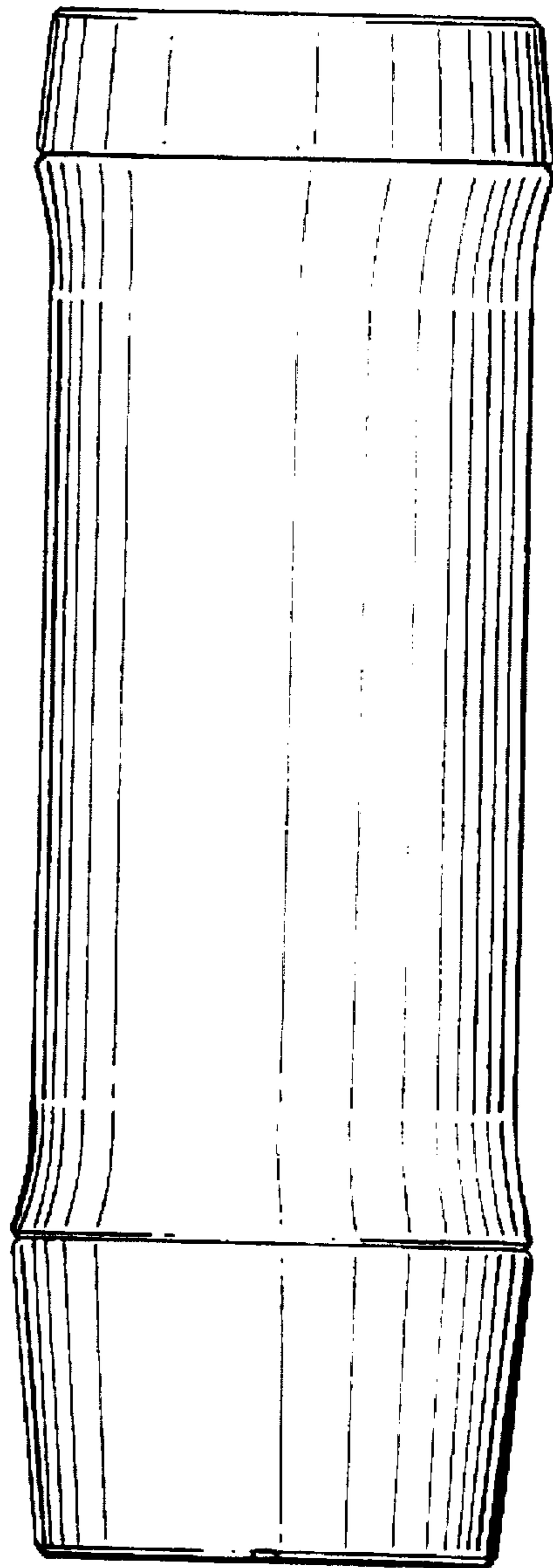

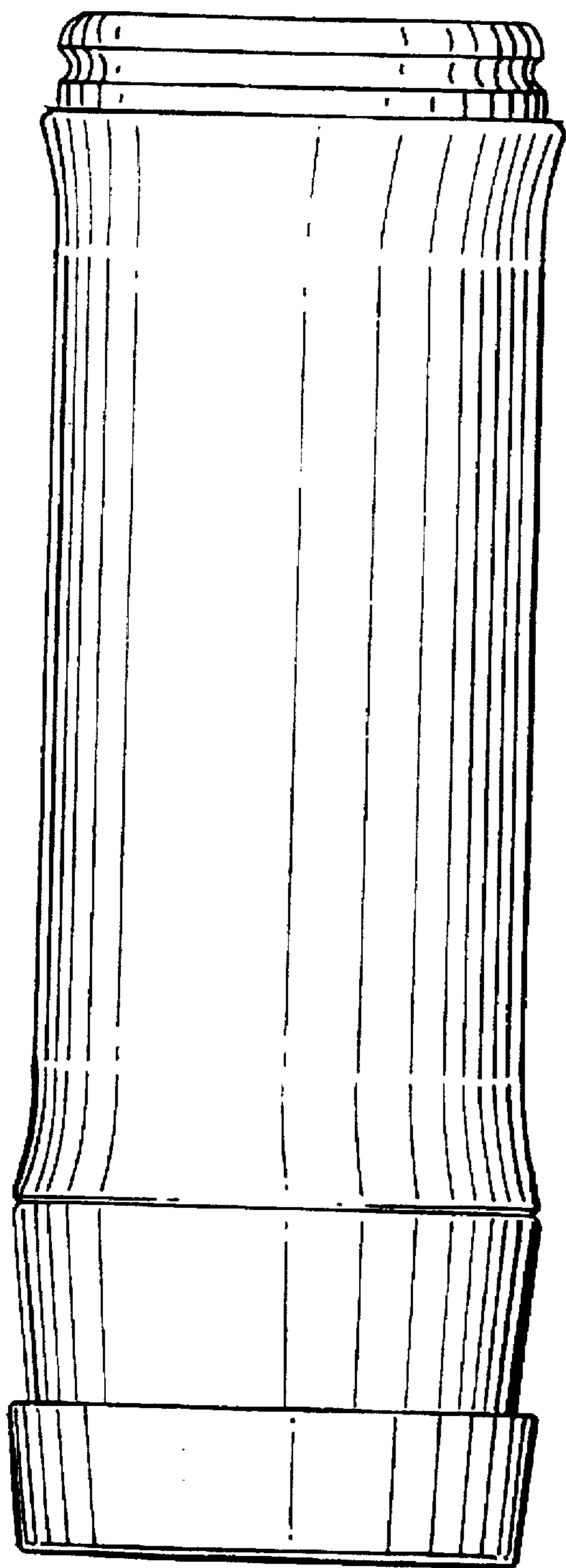

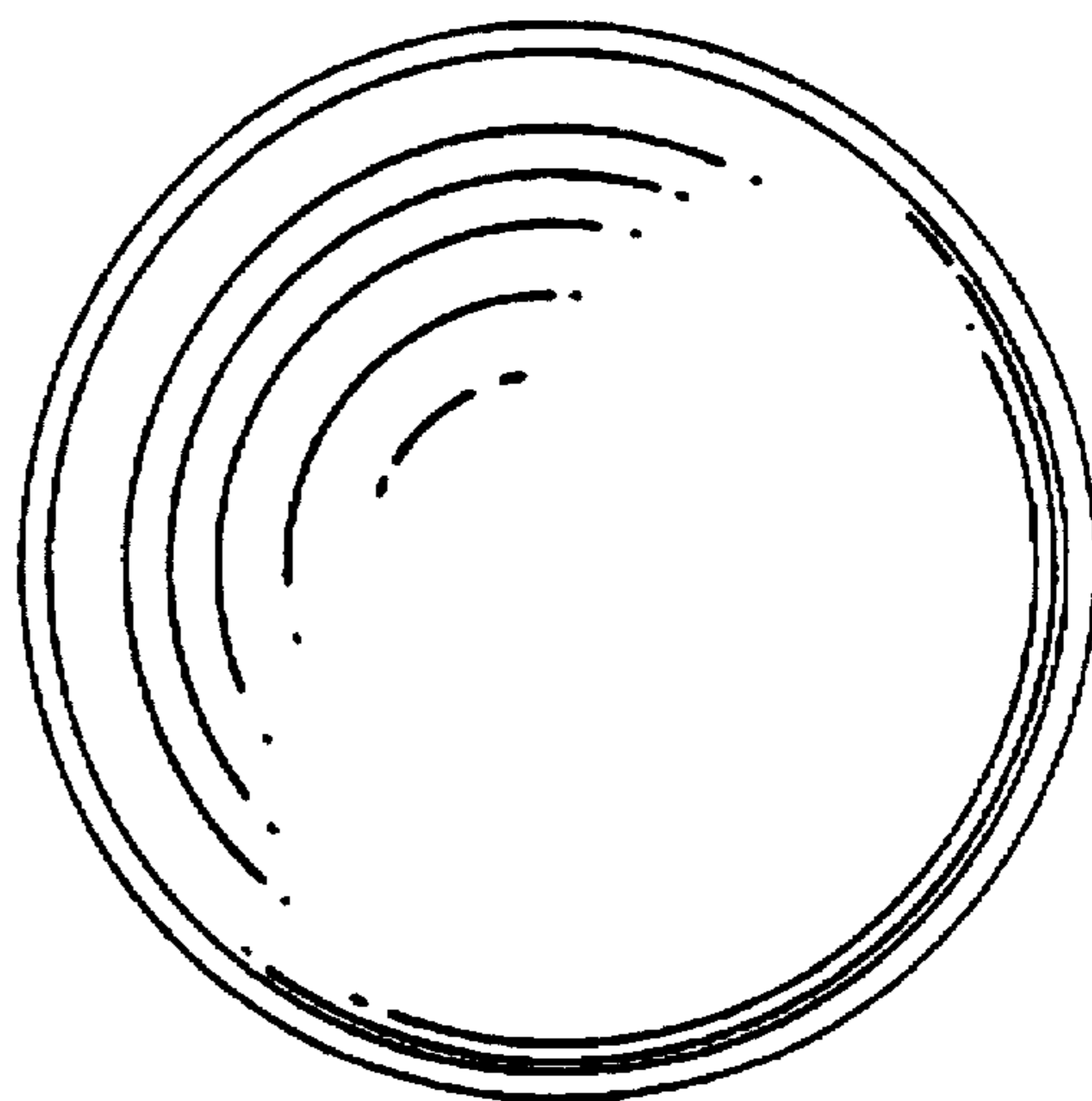
