[57] **CLAIM**

The ornamental design for a “casing for a watch”, as shown and described.

DESCRIPTION

FIG. 1 is a perspective elevational view of a “casing for a watch”;
FIG. 2 is a top plan view thereof;
FIG. 3 is a left side elevational view thereof; the other side being a mirror image is not shown;
FIG. 4 is an end elevational view thereof; the other end being a mirror image is not shown; and,
FIG. 5 is a bottom plan view thereof.

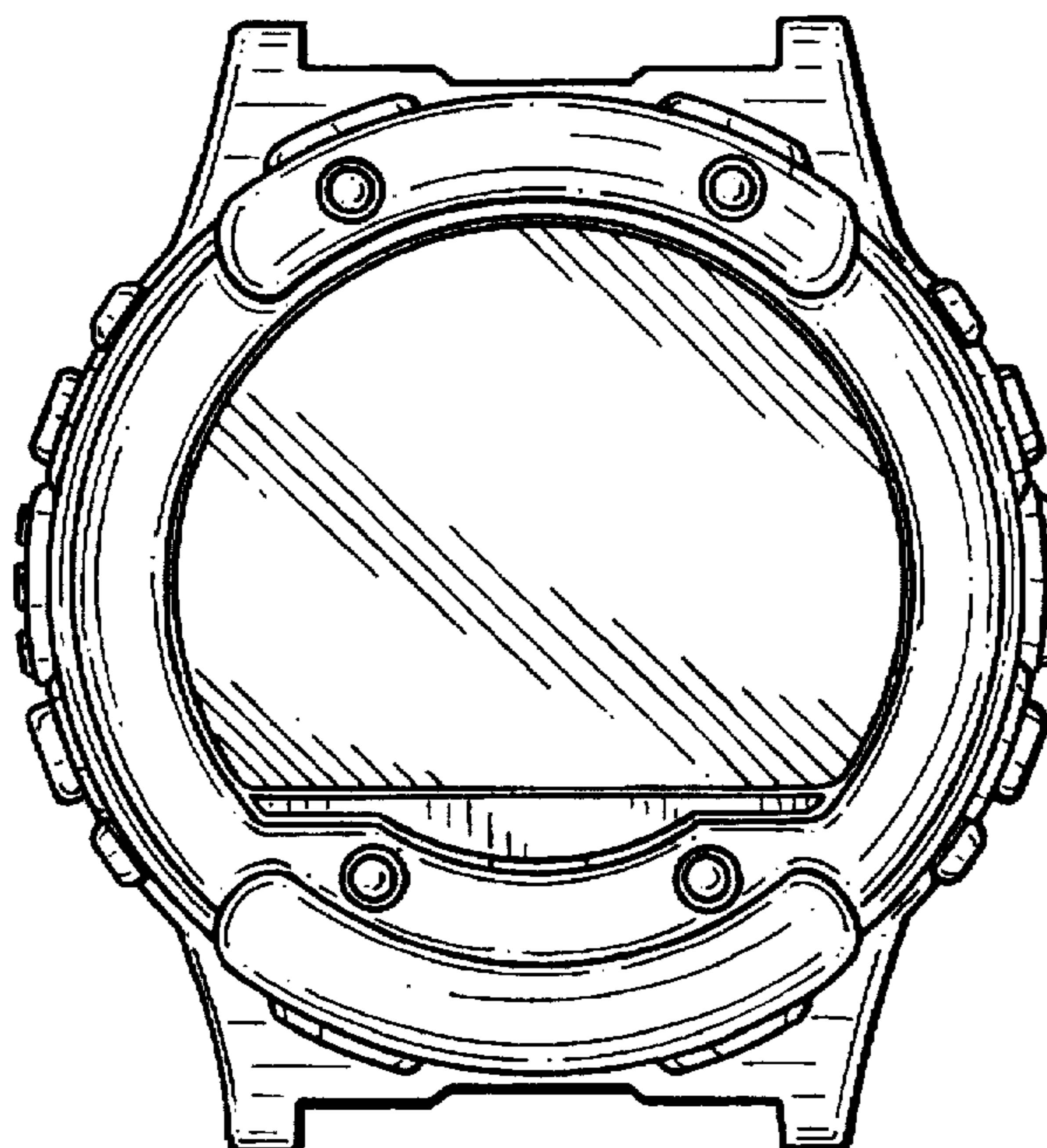

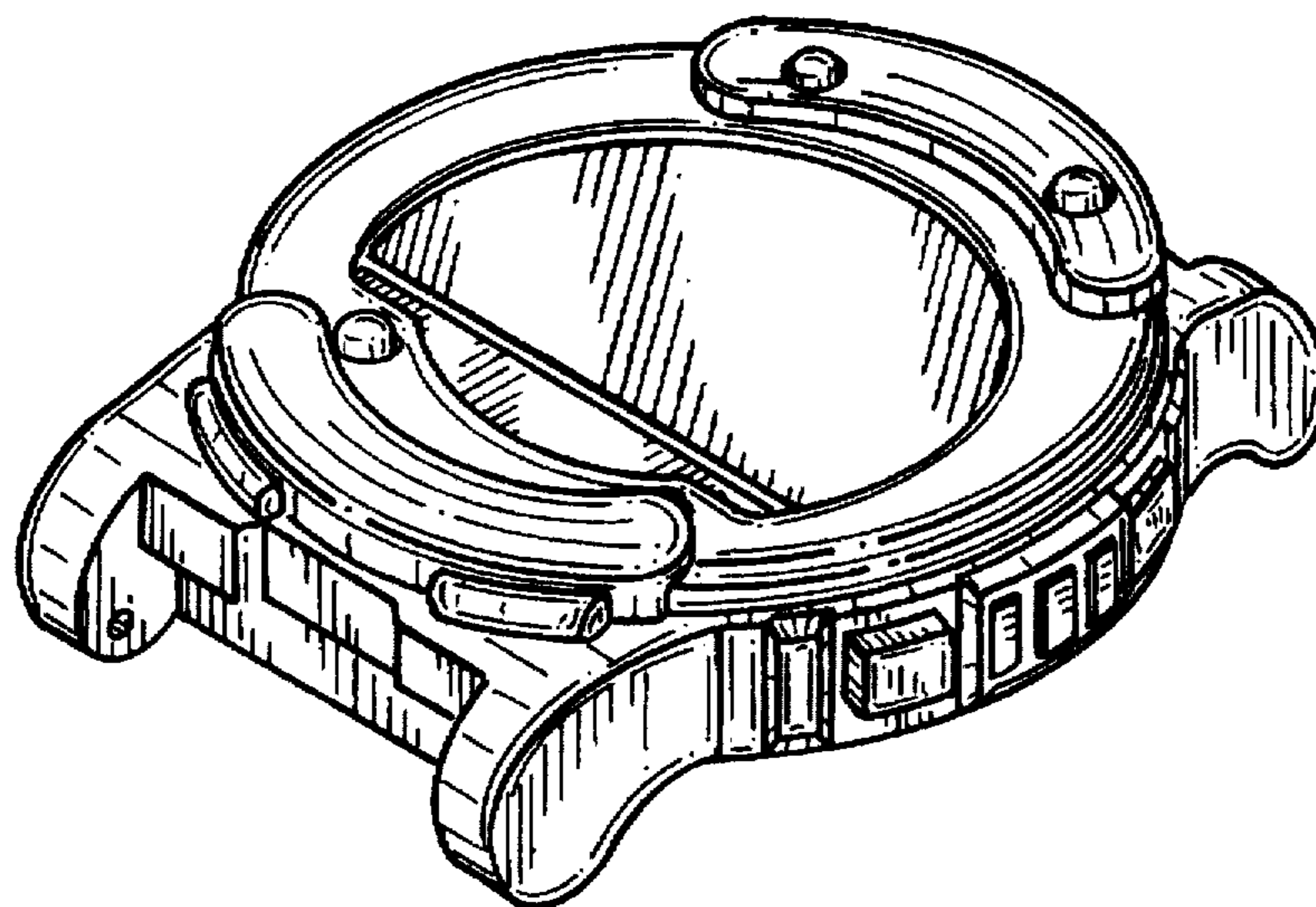

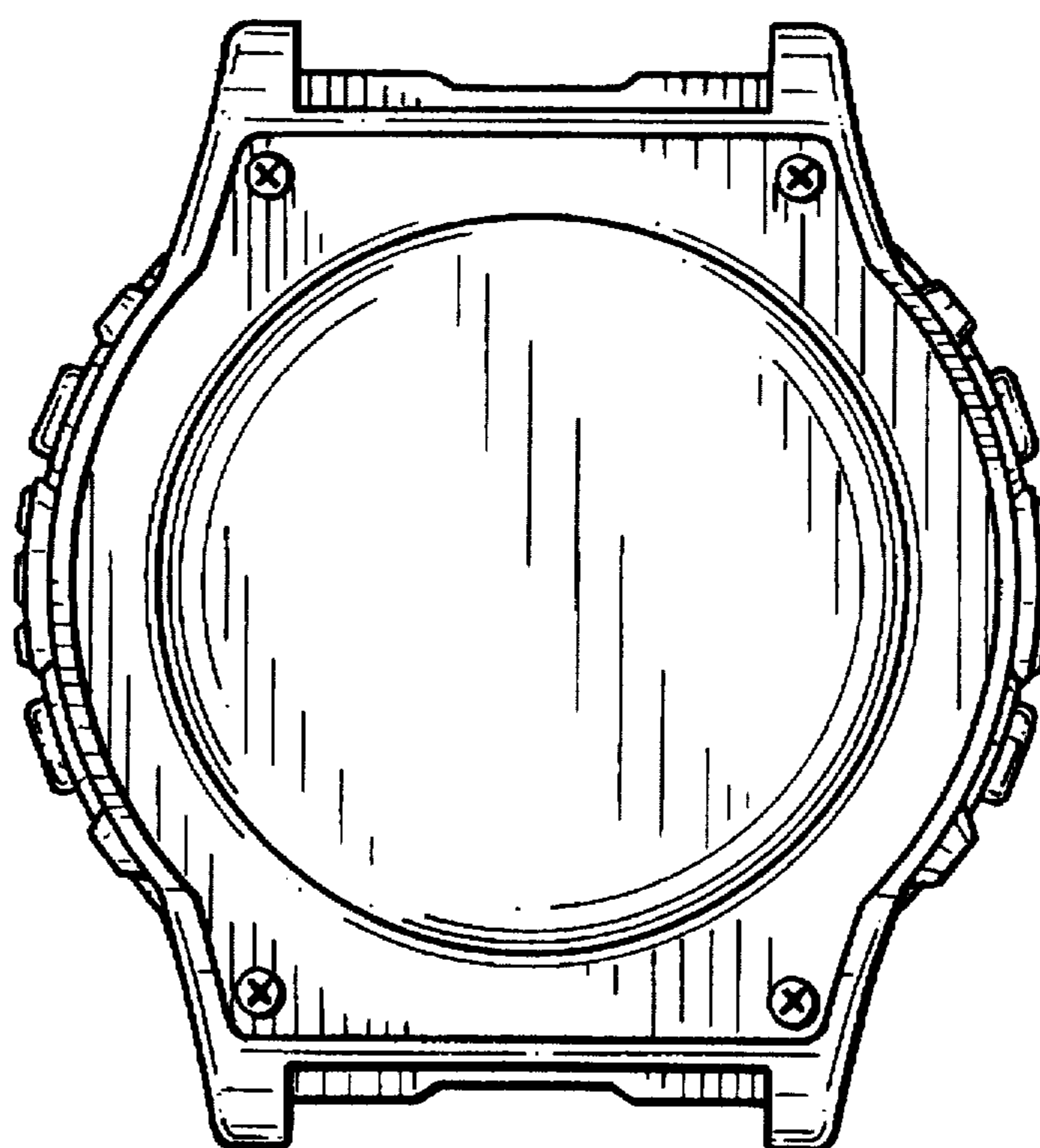

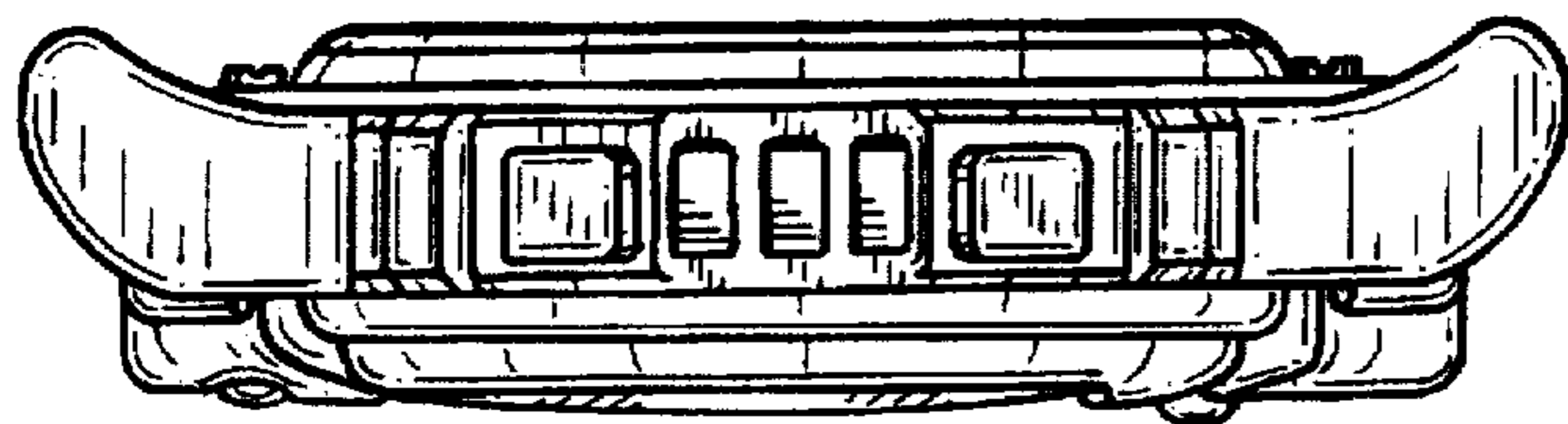

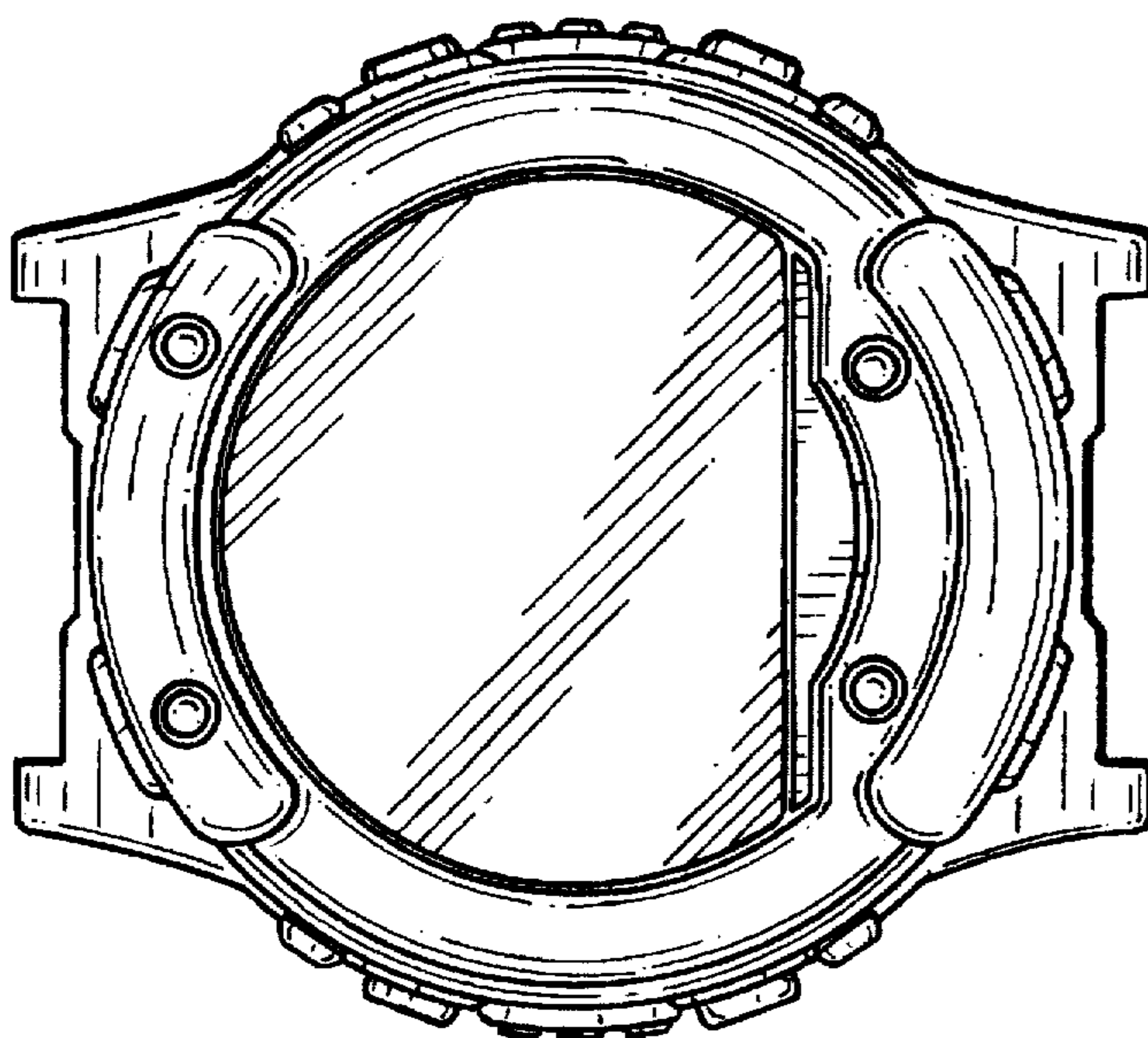
