The ornamental design for a portable radiotelephone, as shown and described.

DESCRIPTION

FIG. 1 is a front, bottom and left side perspective view of the portable radiotelephone showing our new design with a closed cover;

FIG. 2 is a front, bottom and left side perspective view of the portable radiotelephone showing our new design with an open cover;

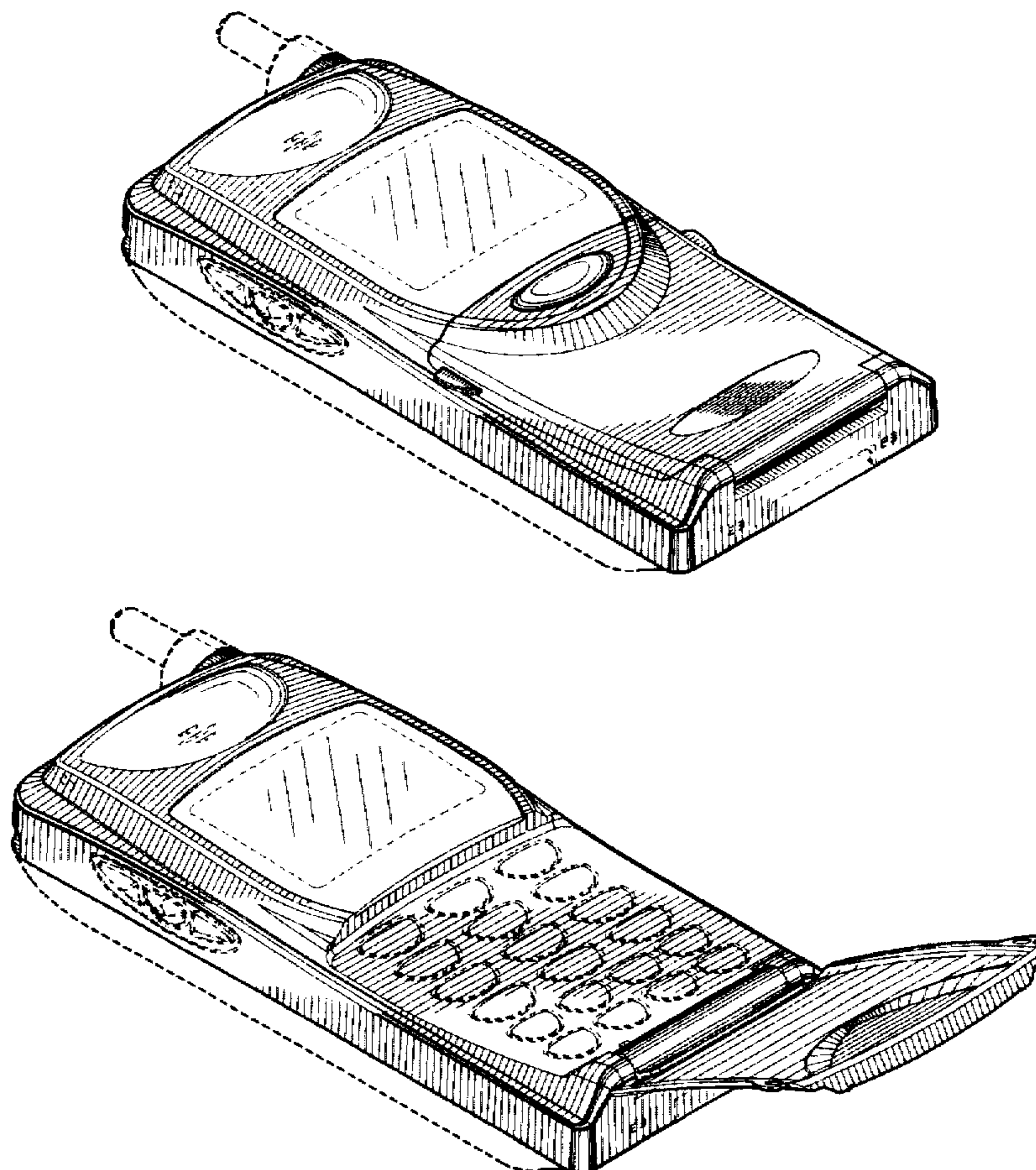
FIG. 3 is a top side view of the portable radiotelephone;

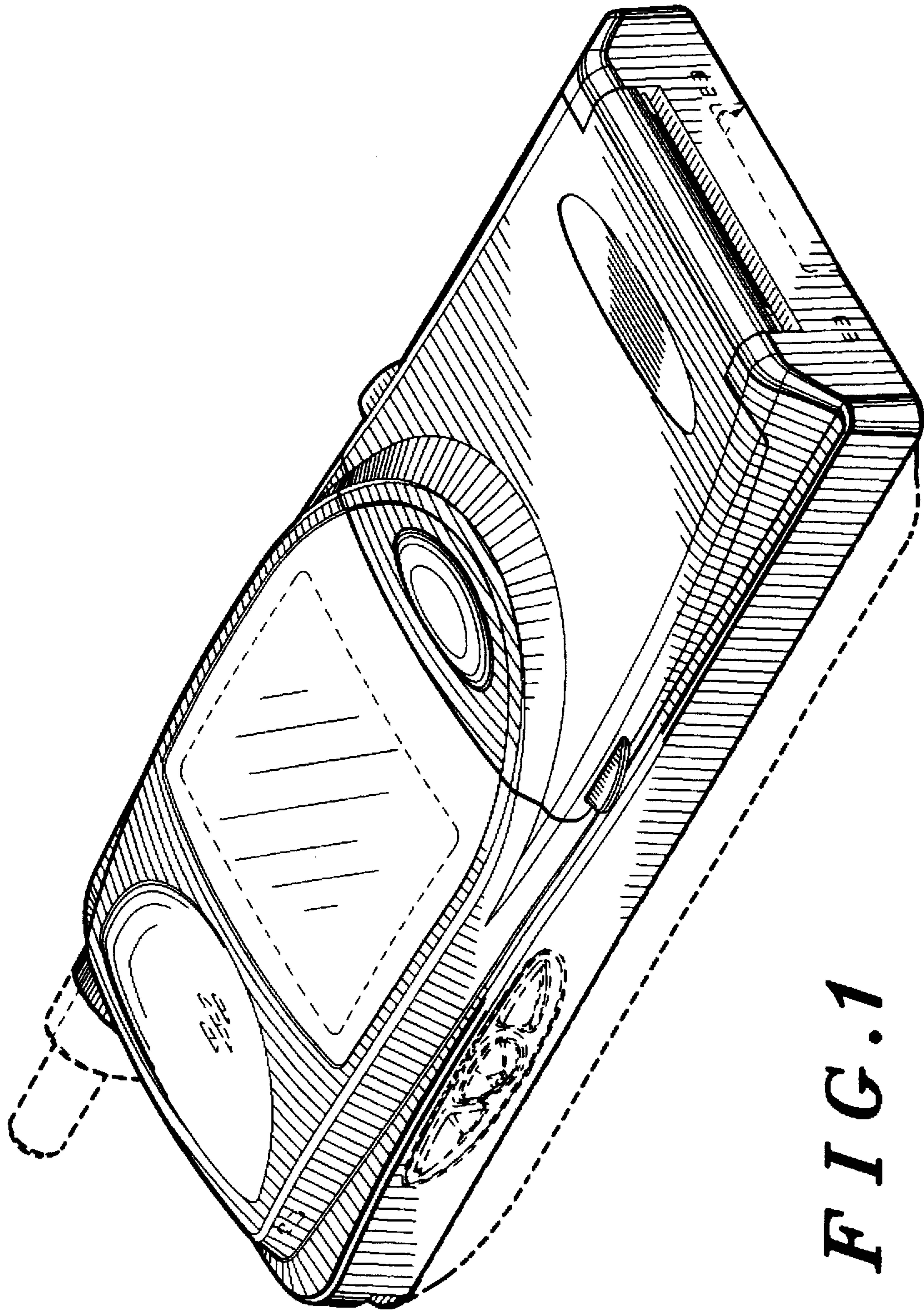

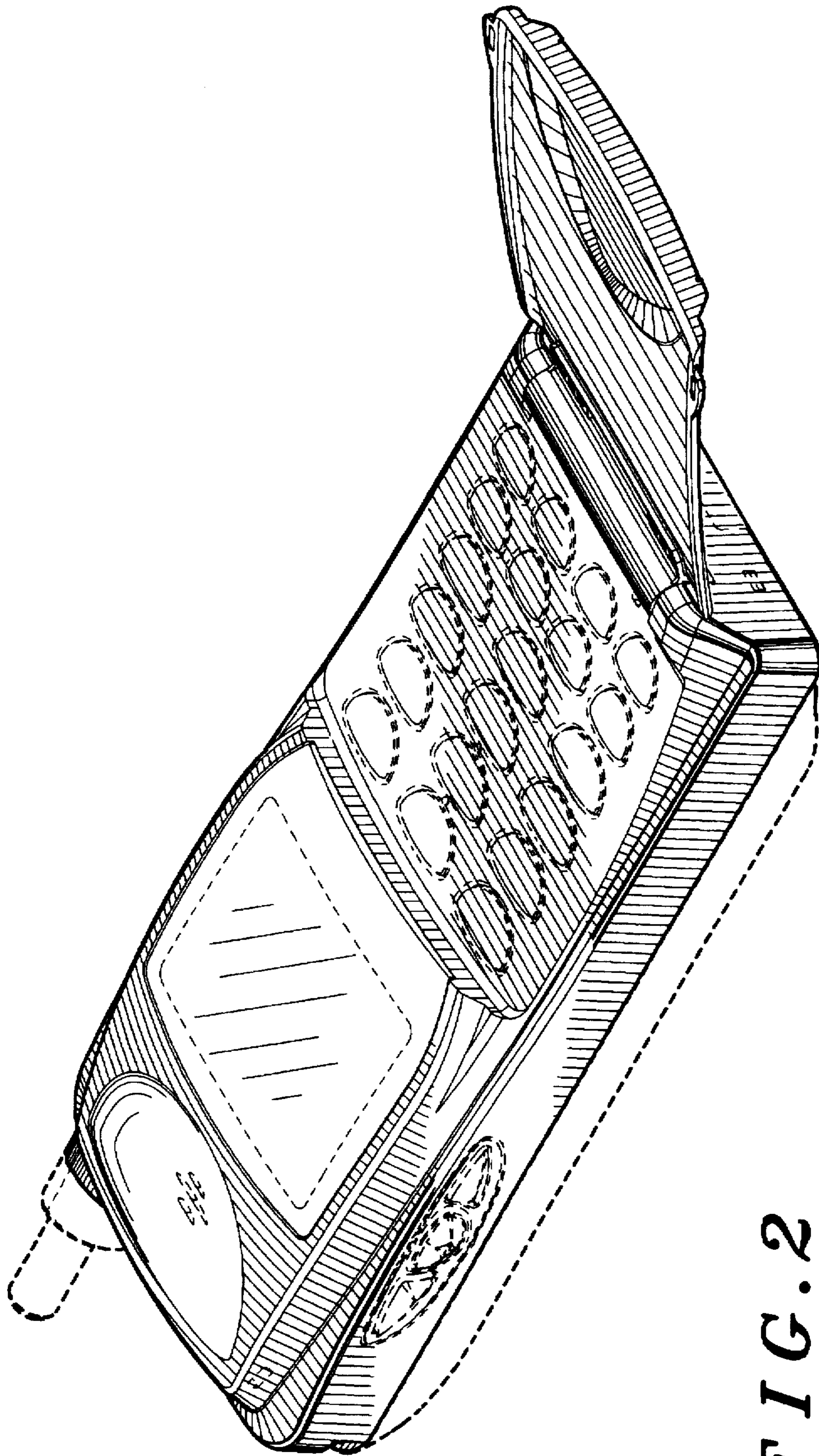

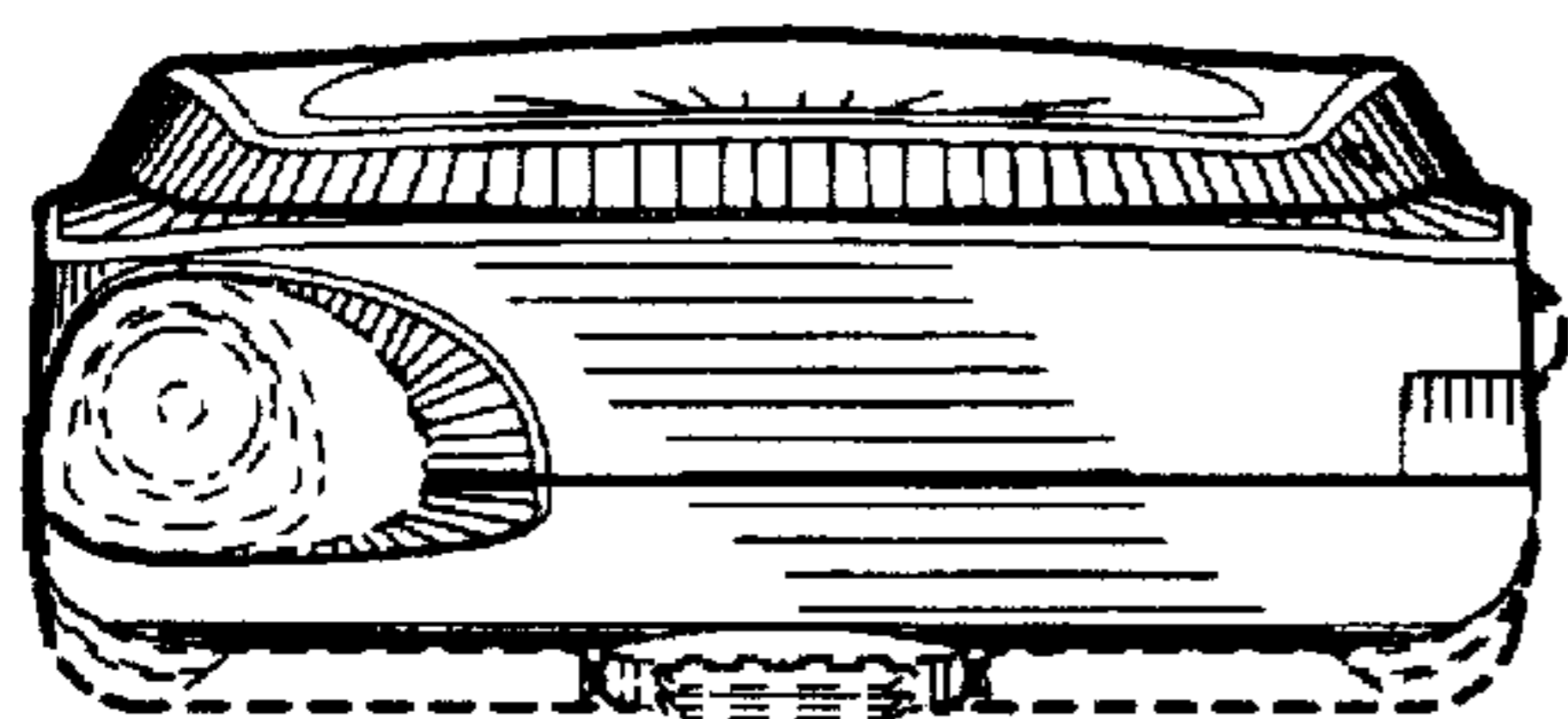

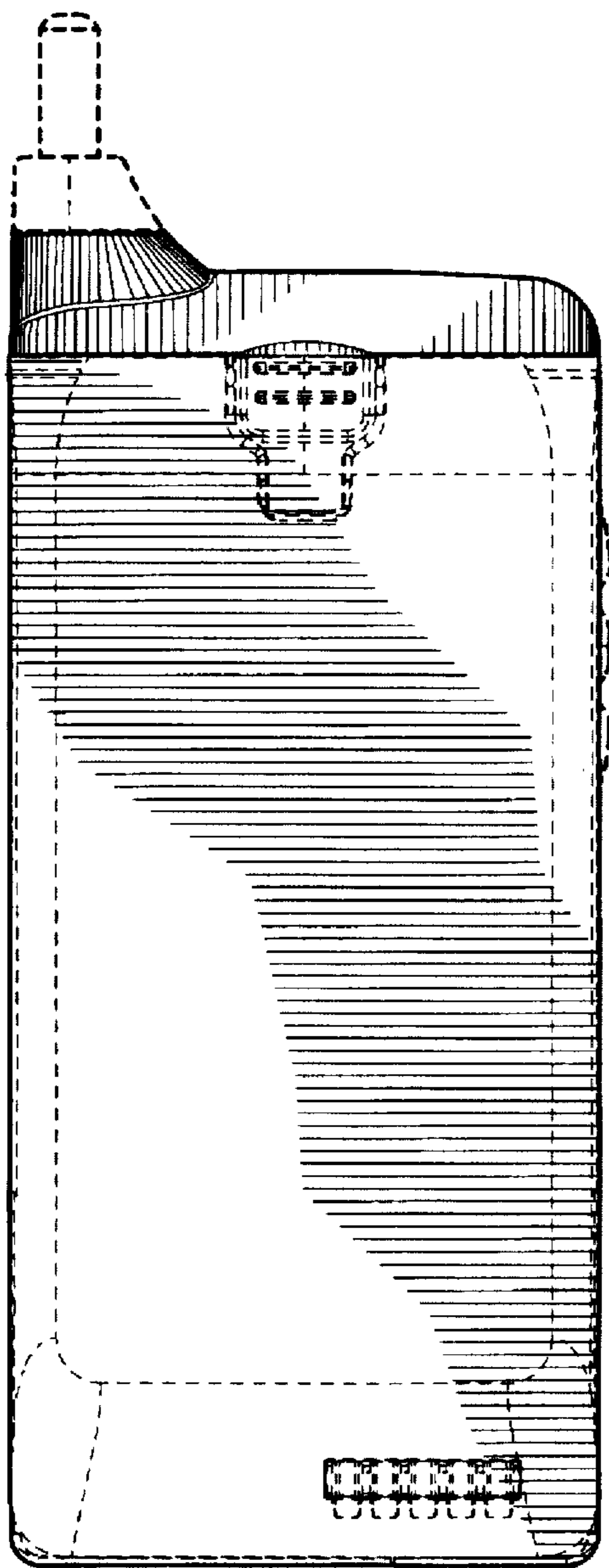

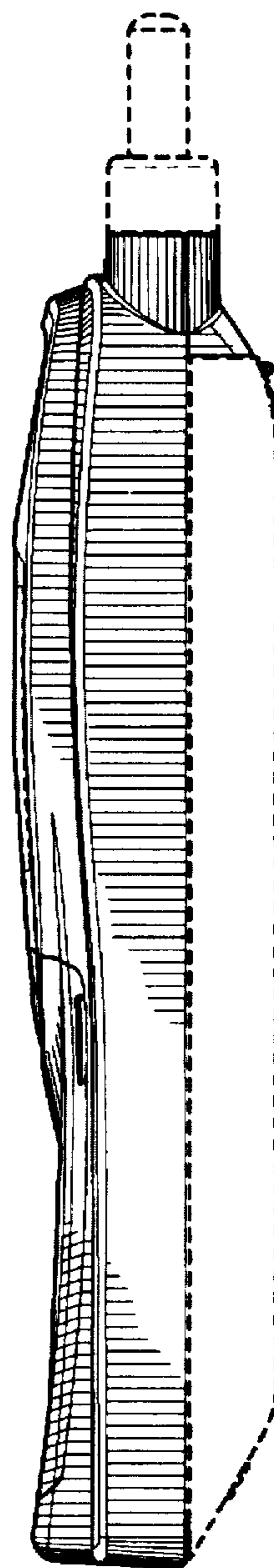
