[57] **CLAIM**

The ornamental design for a telephone, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a telephone showing our new design;

FIG. 2 is a top perspective view of the base unit of the telephone of FIG. 1;

FIG. 3 is a top plan view of the base unit of FIG. 2;

FIG. 4 is a front elevational view of the base unit of FIG. 2;

FIG. 5 is a right side elevational view of the base unit of FIG. 2;

FIG. 6 is a left side elevational view of the base unit of FIG. 2;

FIG. 7 is a bottom plan view of the base unit of FIG. 2;

FIG. 8 is a rear elevational view of the base unit of FIG. 2;

FIG. 9 is a bottom perspective view of the handset of the telephone of FIG. 1;

FIG. 10 is a top plan view of the handset of FIG. 9;

FIG. 11 is a front elevational view of the handset of FIG. 9;

FIG. 12 is a left side elevational view of the handset of FIG. 9, the right side elevational view being a mirror image thereof;

FIG. 13 is a bottom plan view of the handset of FIG. 9; and,

FIG. 14 is a rear elevational view of the handset of FIG. 9.

The telephone base and handset have been shown separately in FIGS. 2-8 and 9-14 for convenience of illustration.

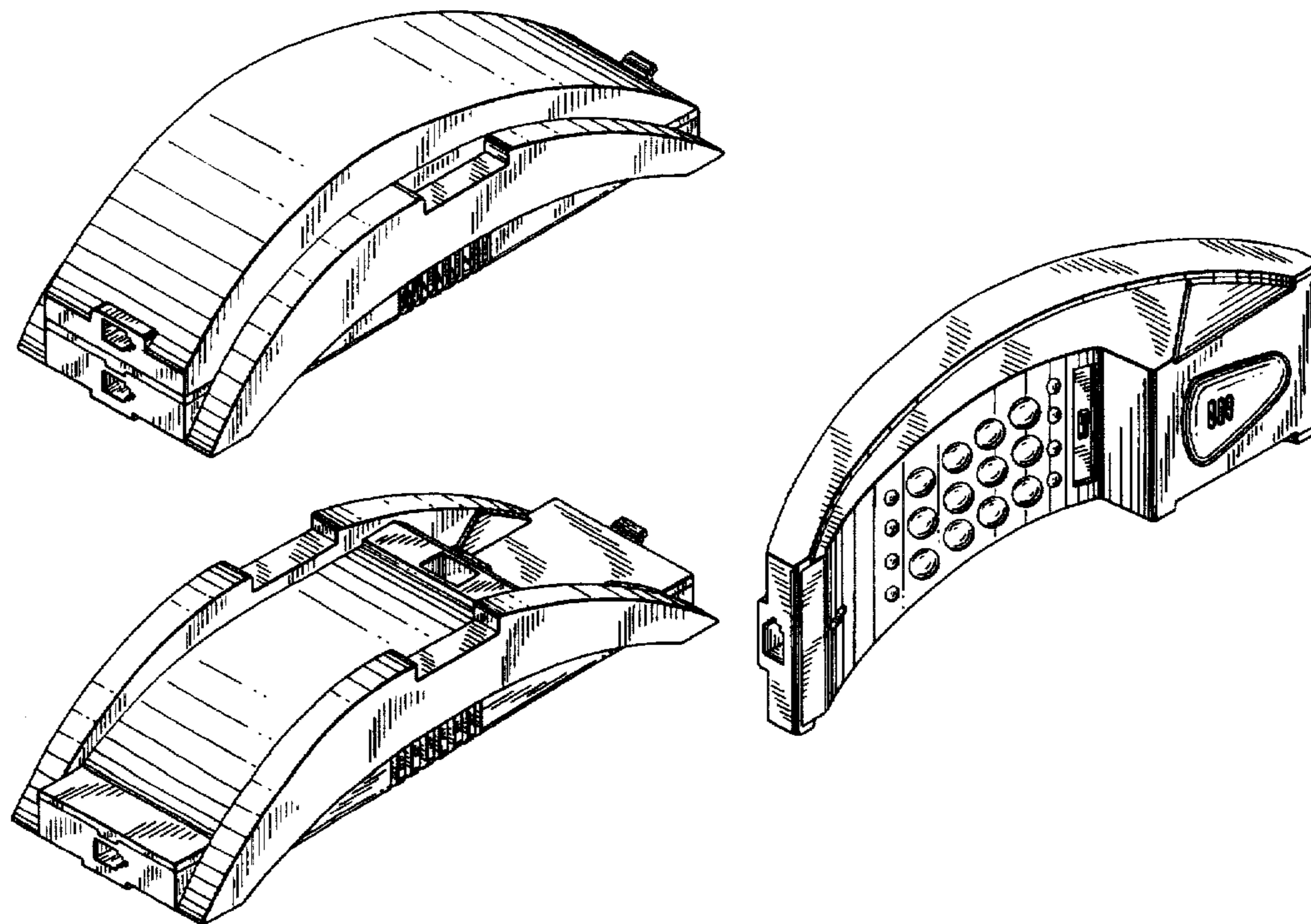

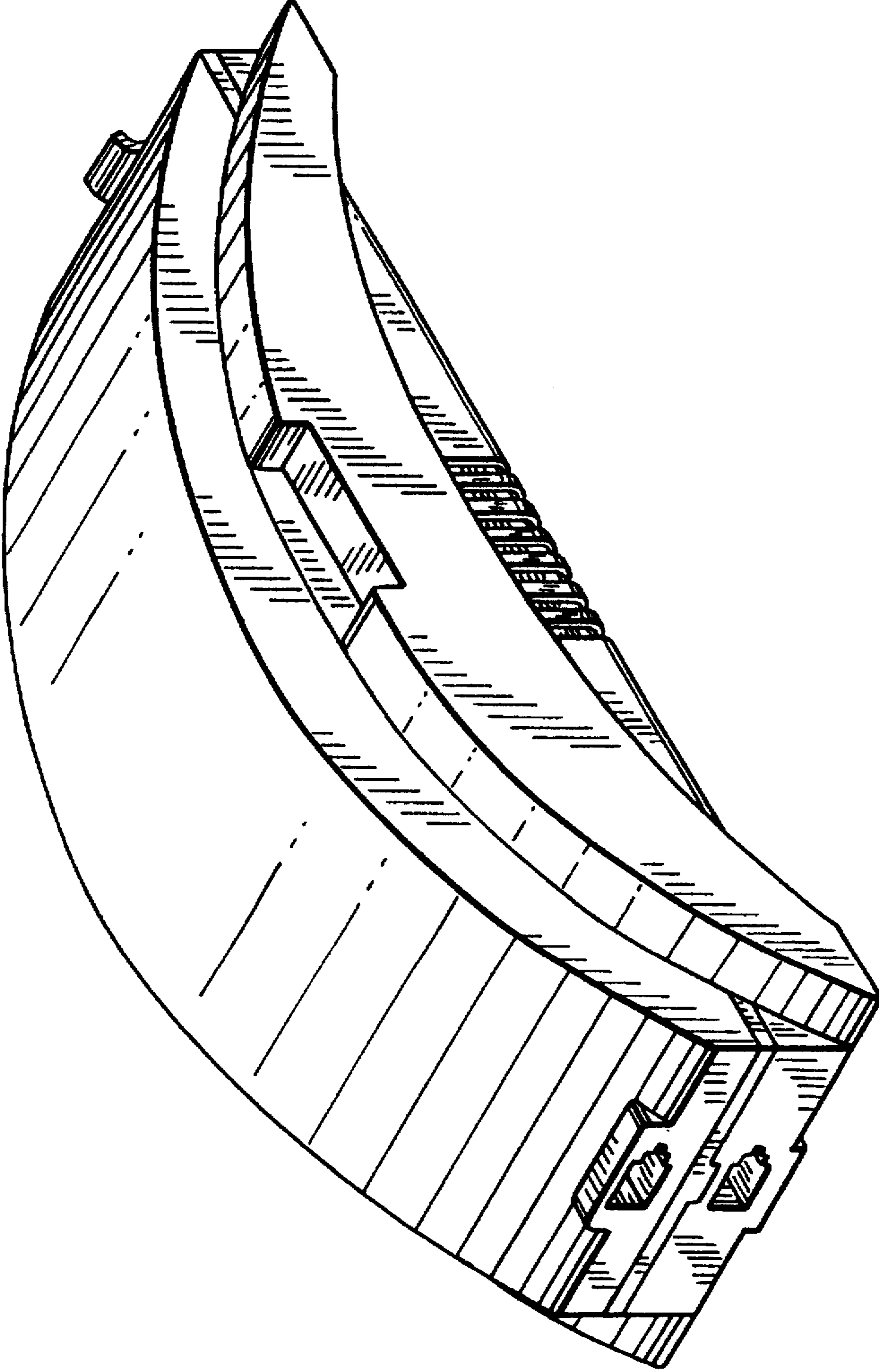
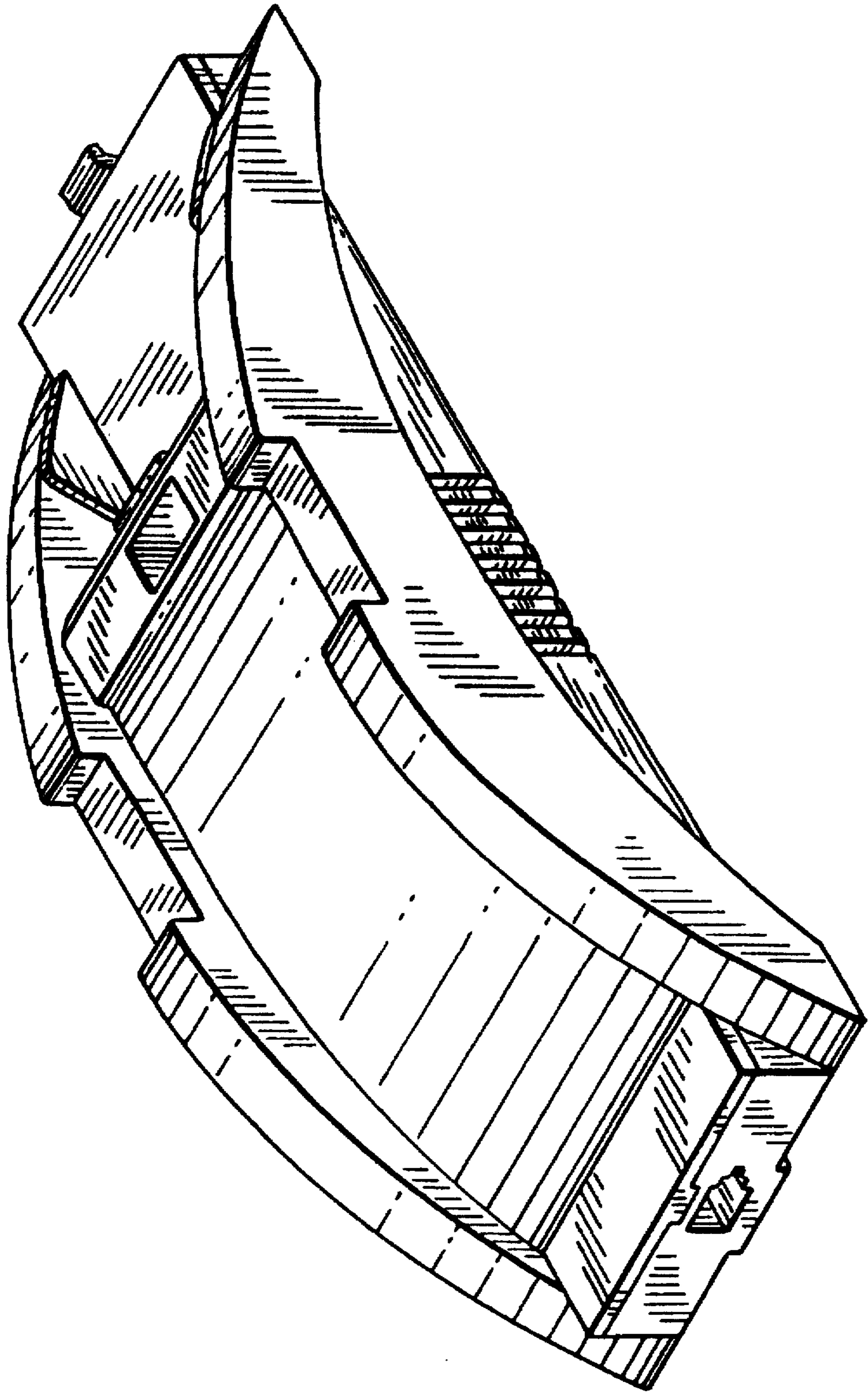

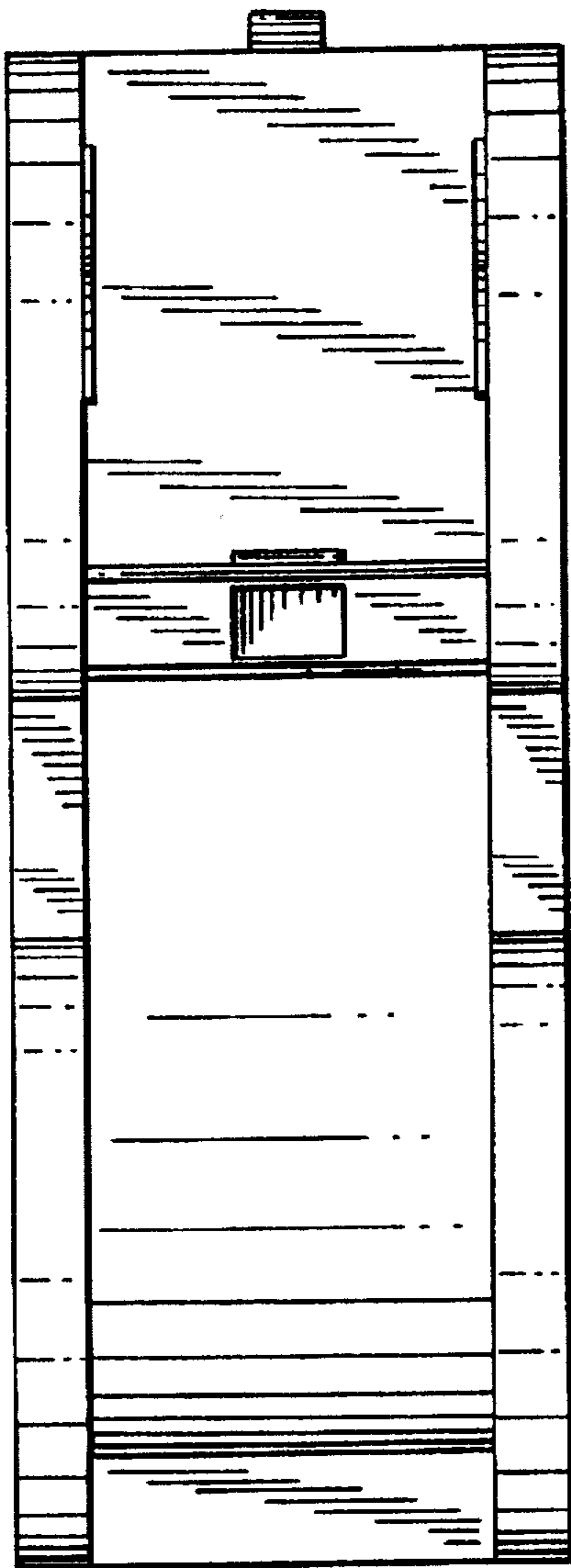

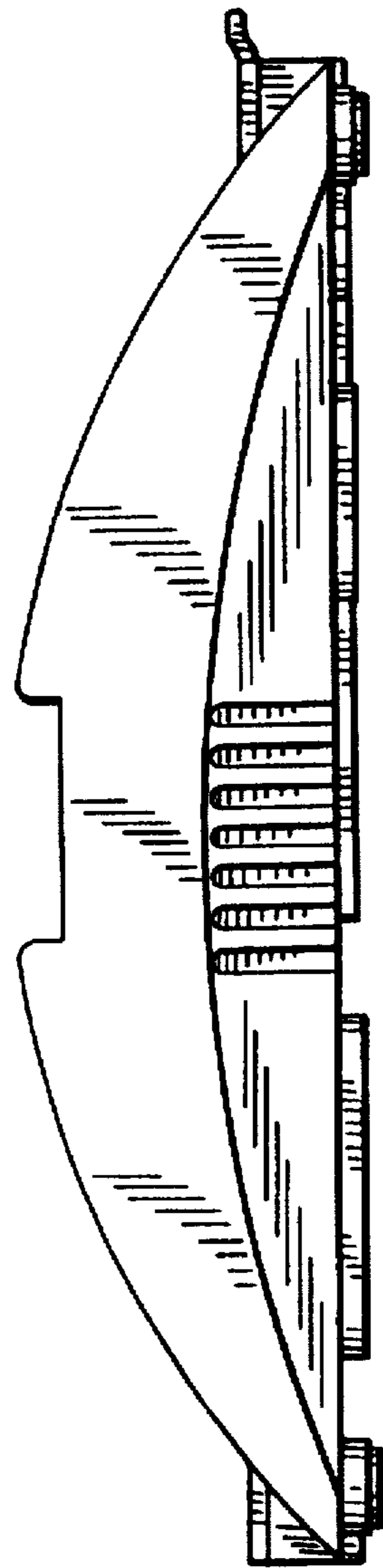

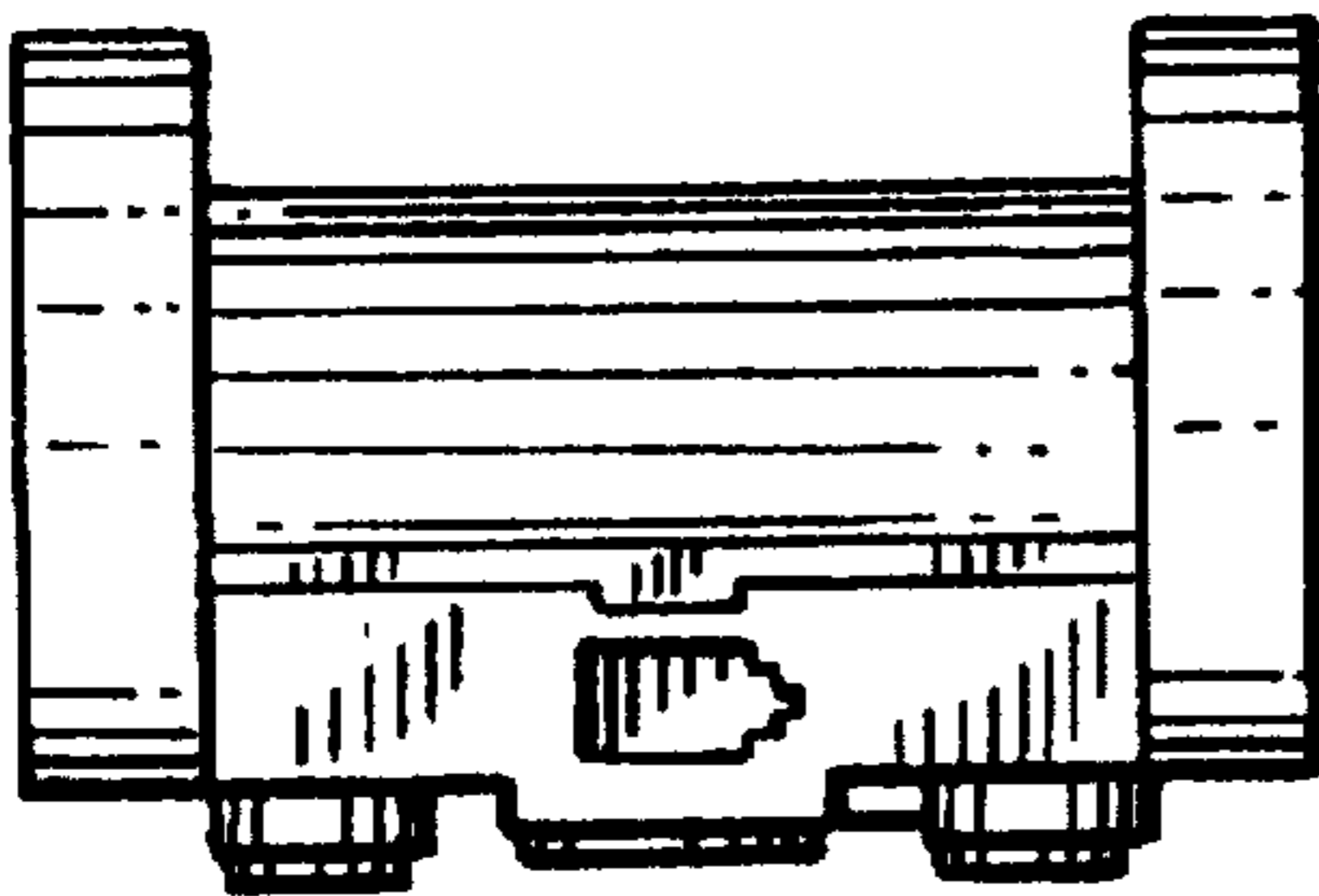

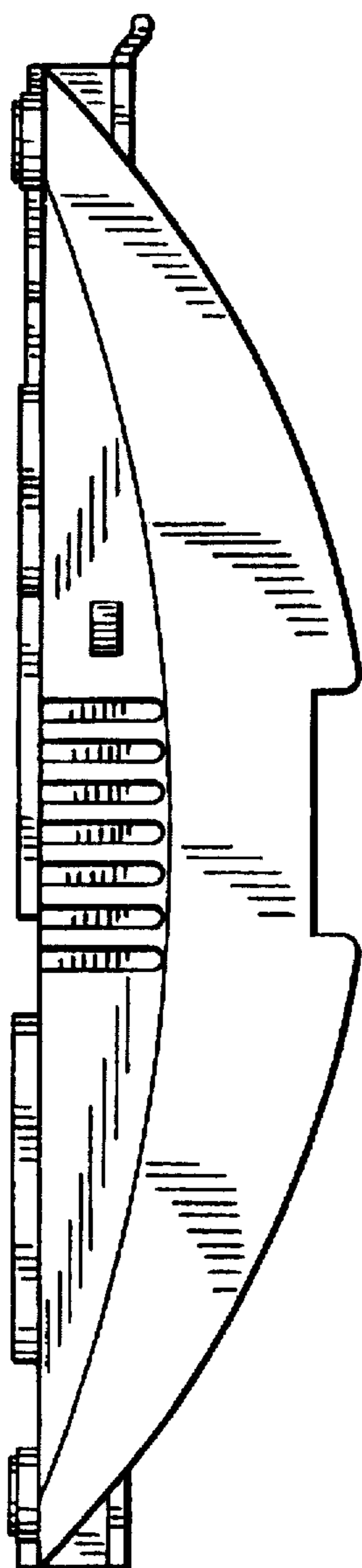

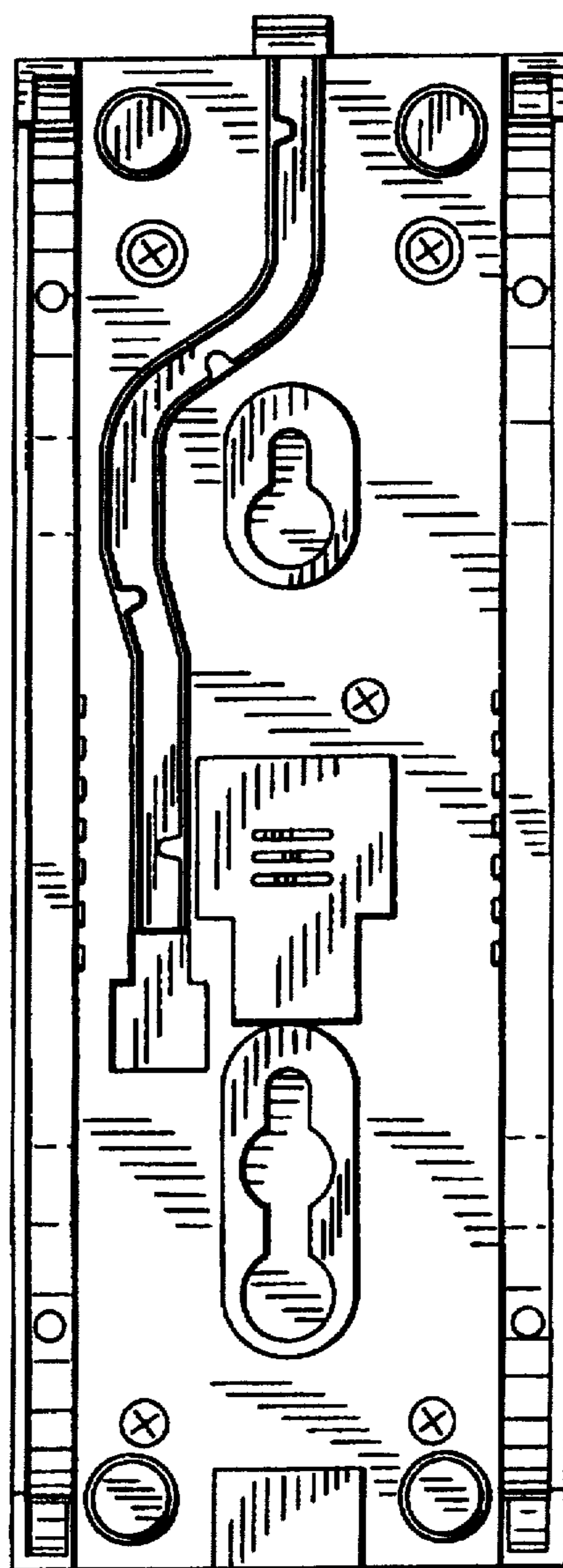

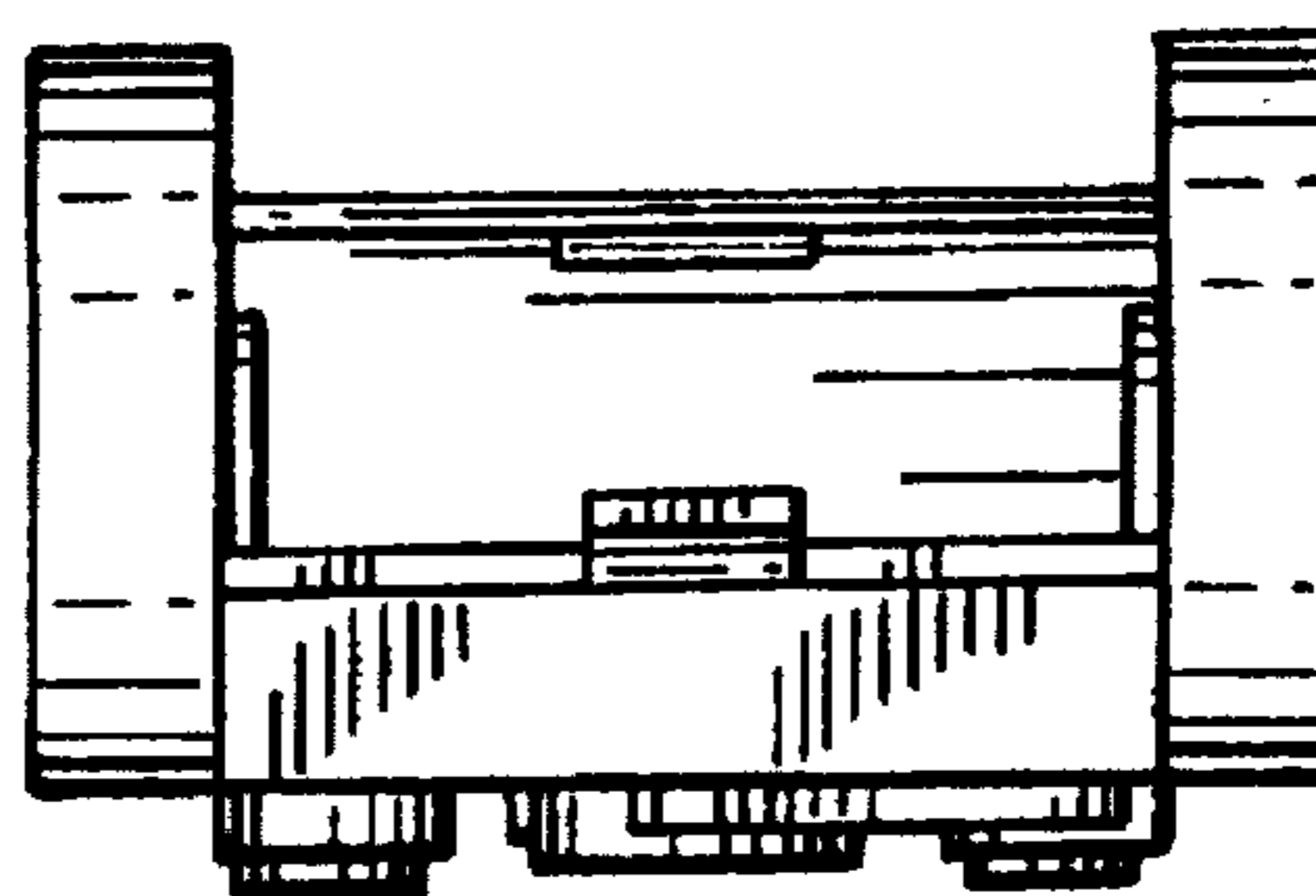

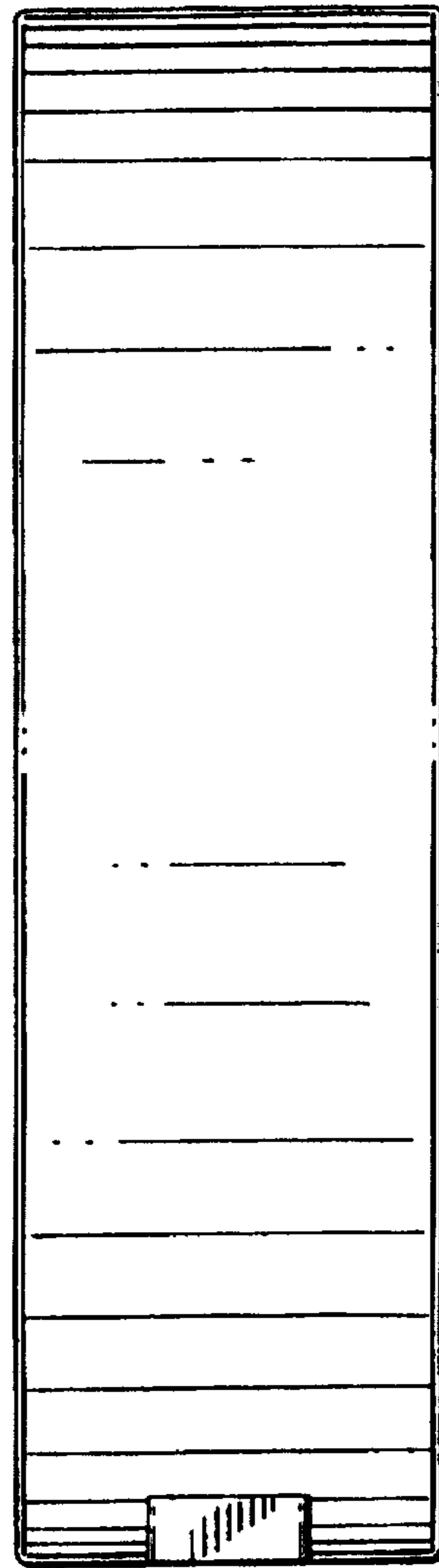
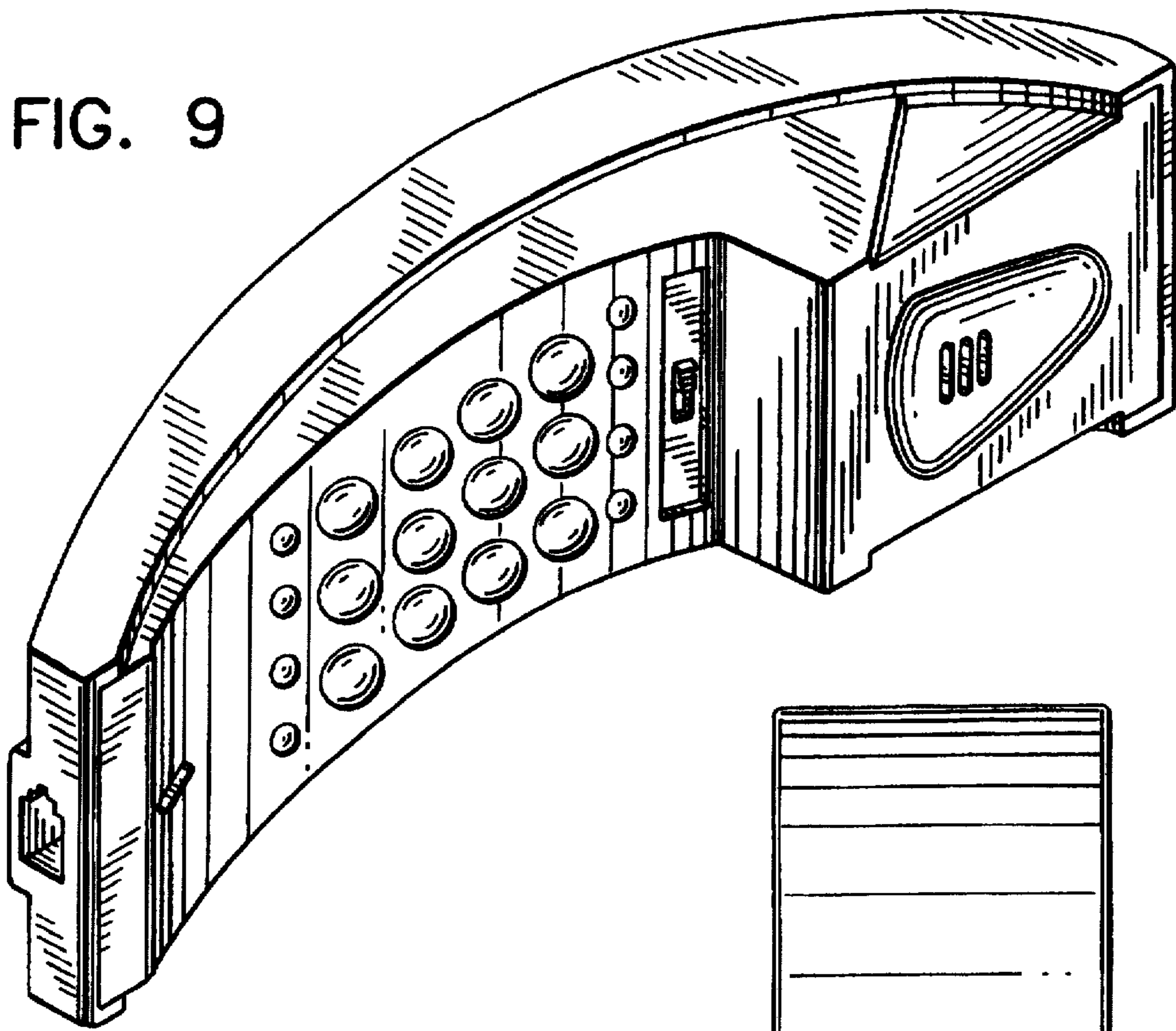

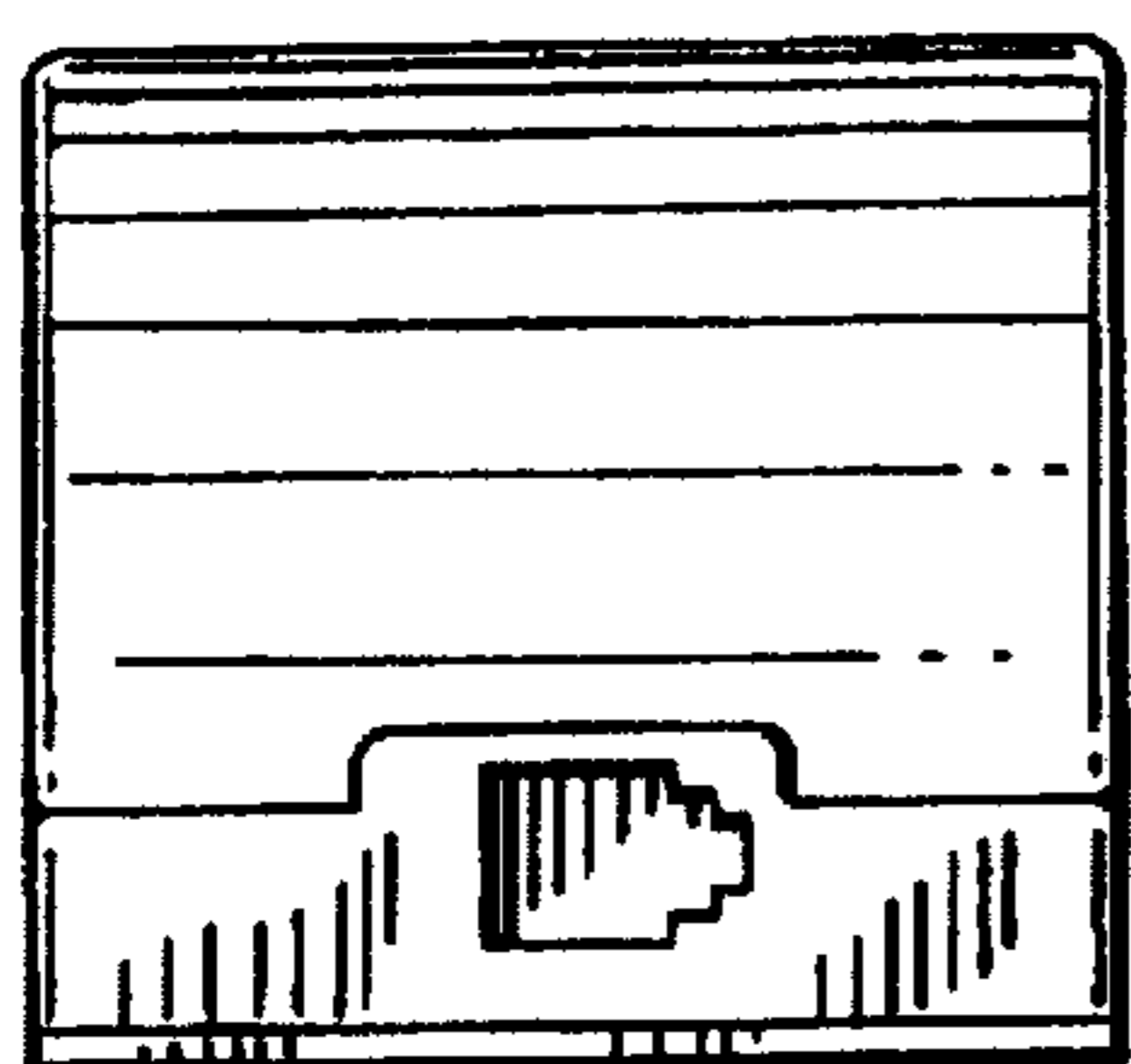

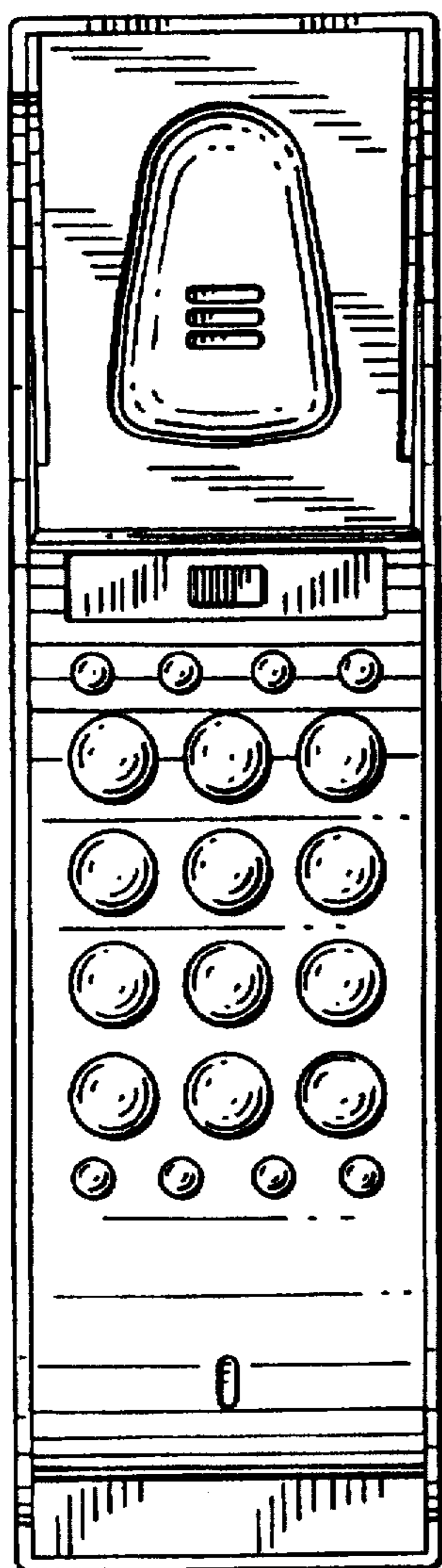

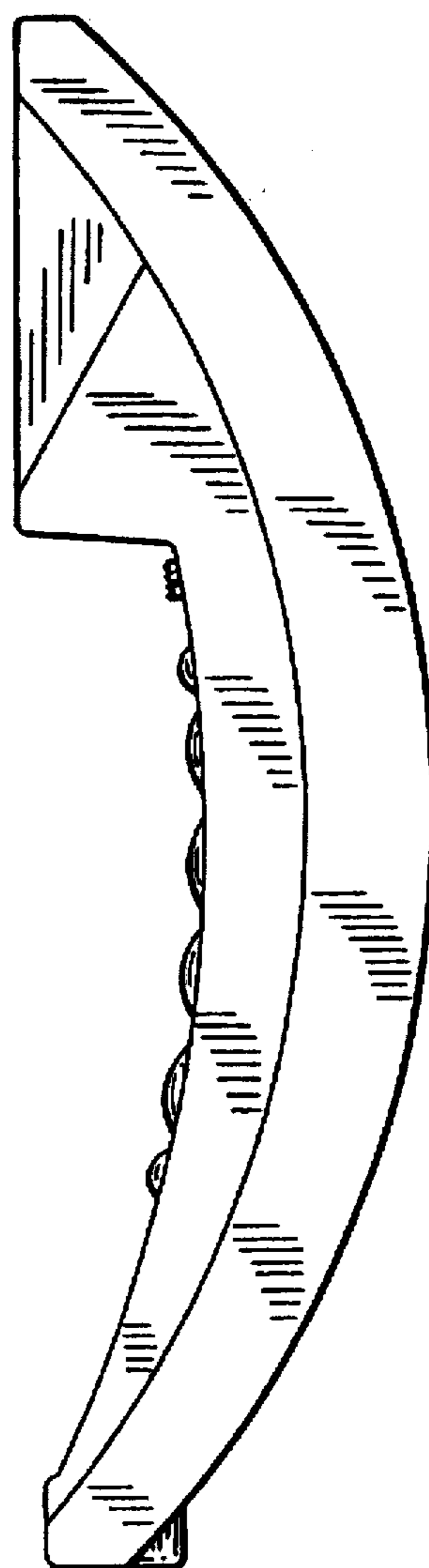

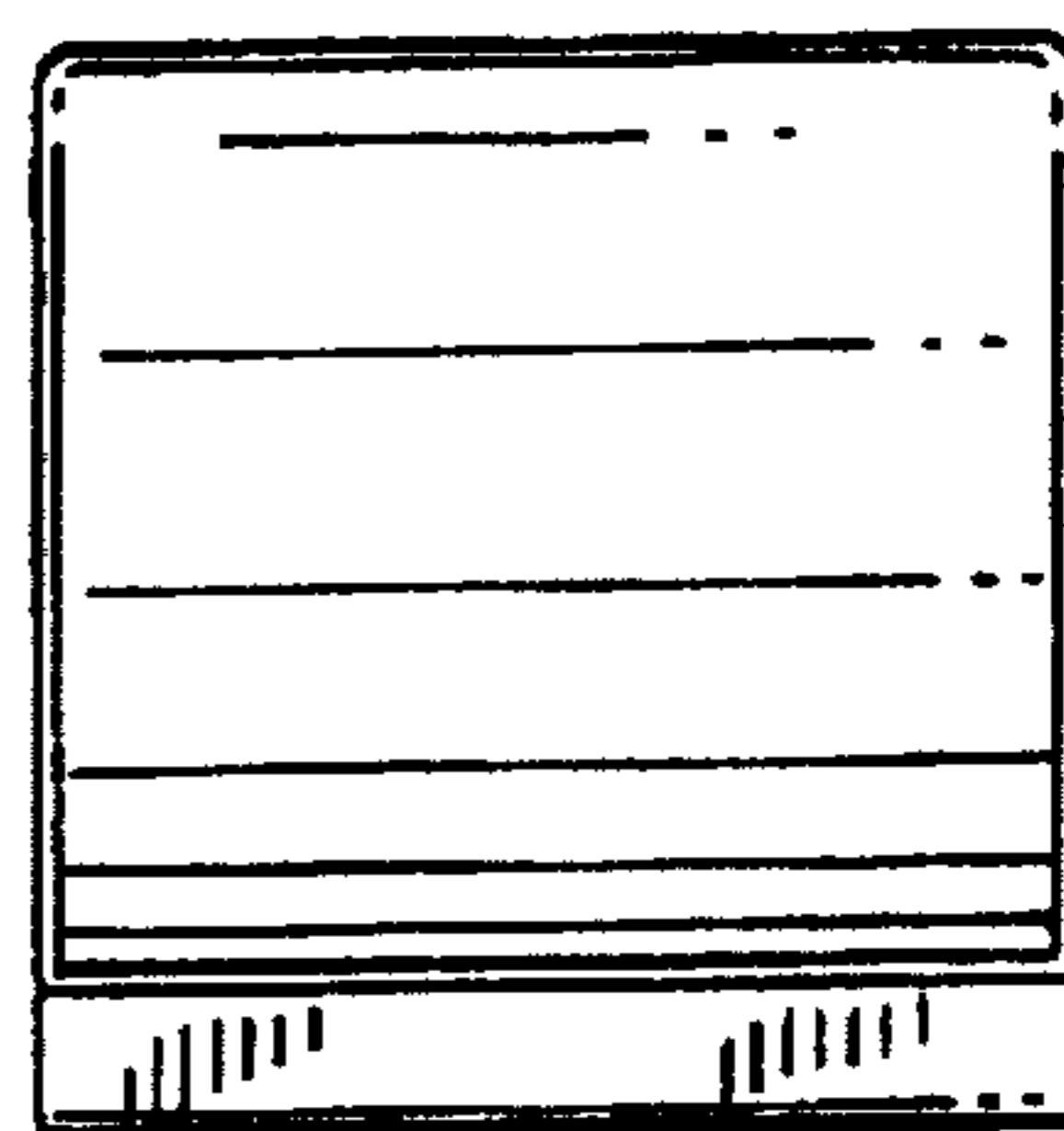
