DESCRIPTION

FIG. 1 is a top plan view of the camera comprising the invention;
FIG. 2 is a bottom plan view of the camera of FIG. 1;
FIG. 3 is a front elevation view of the camera of FIG. 1;
FIG. 4 is a rear elevation view of the camera of FIG. 1;
FIG. 5 is a side elevation view of the camera of FIG. 1 from a first side;
FIG. 6 is a side elevation view of the camera of FIG. 1 from a second side; and
FIG. 7 is a perspective view of the camera of FIG. 1.

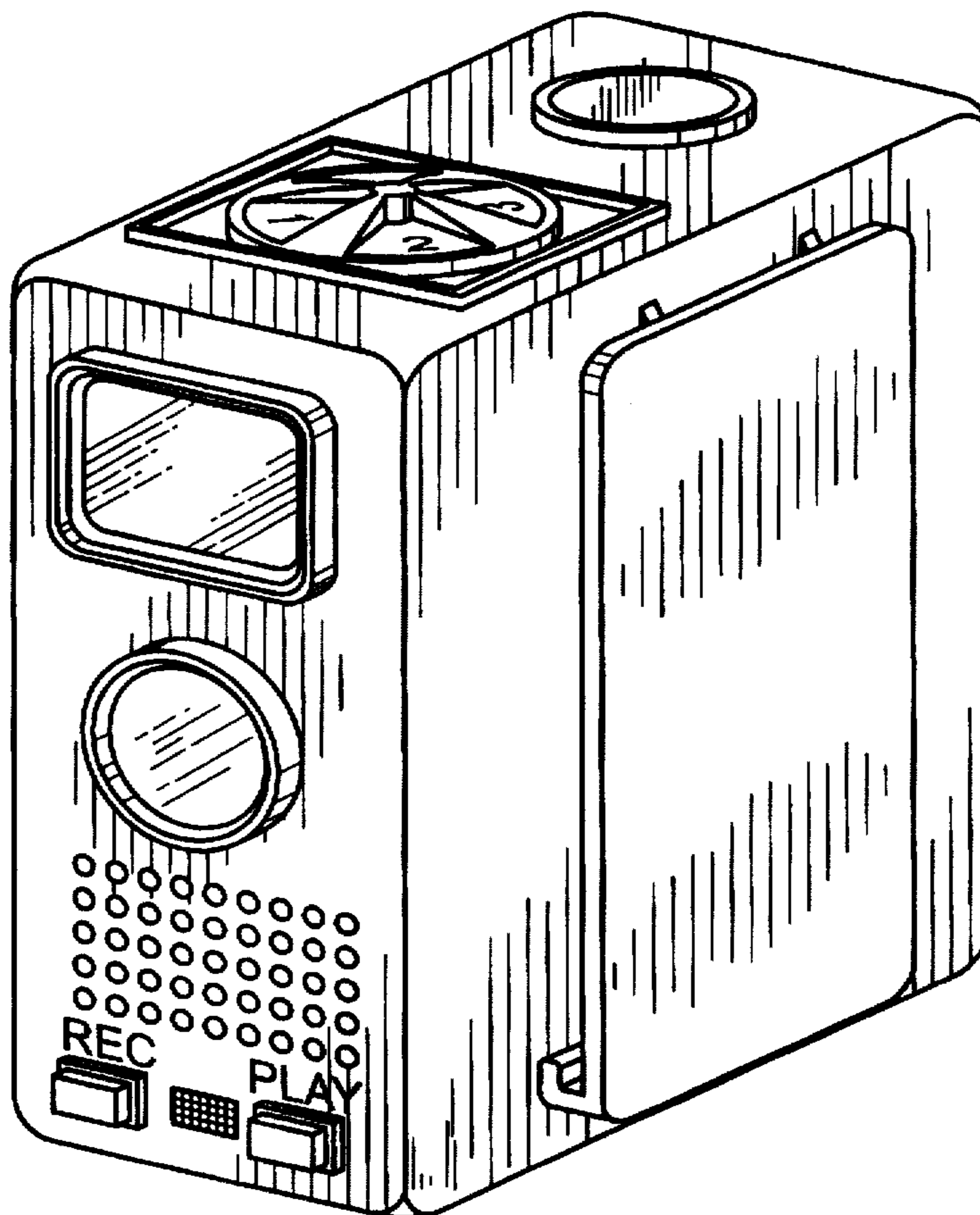

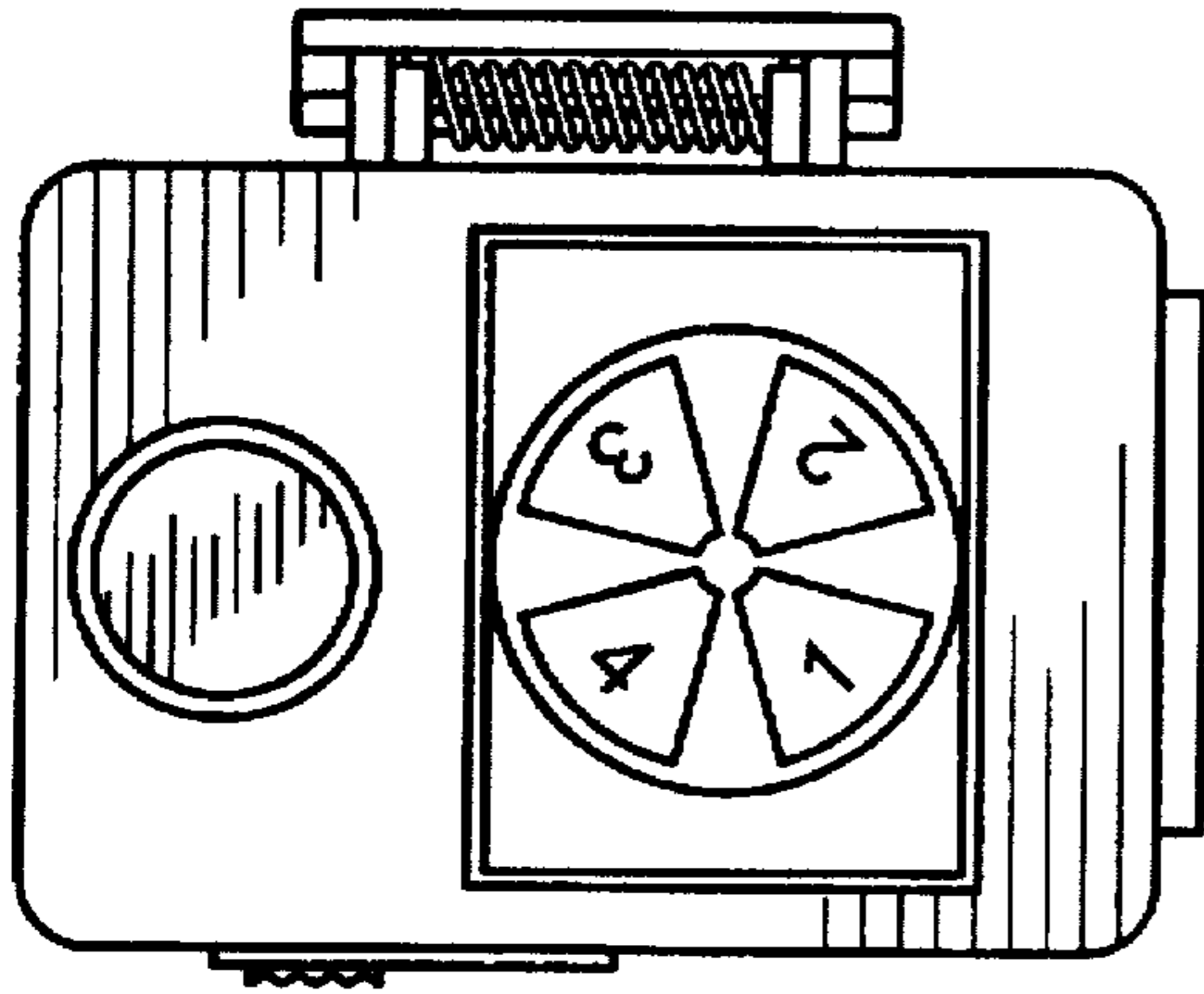

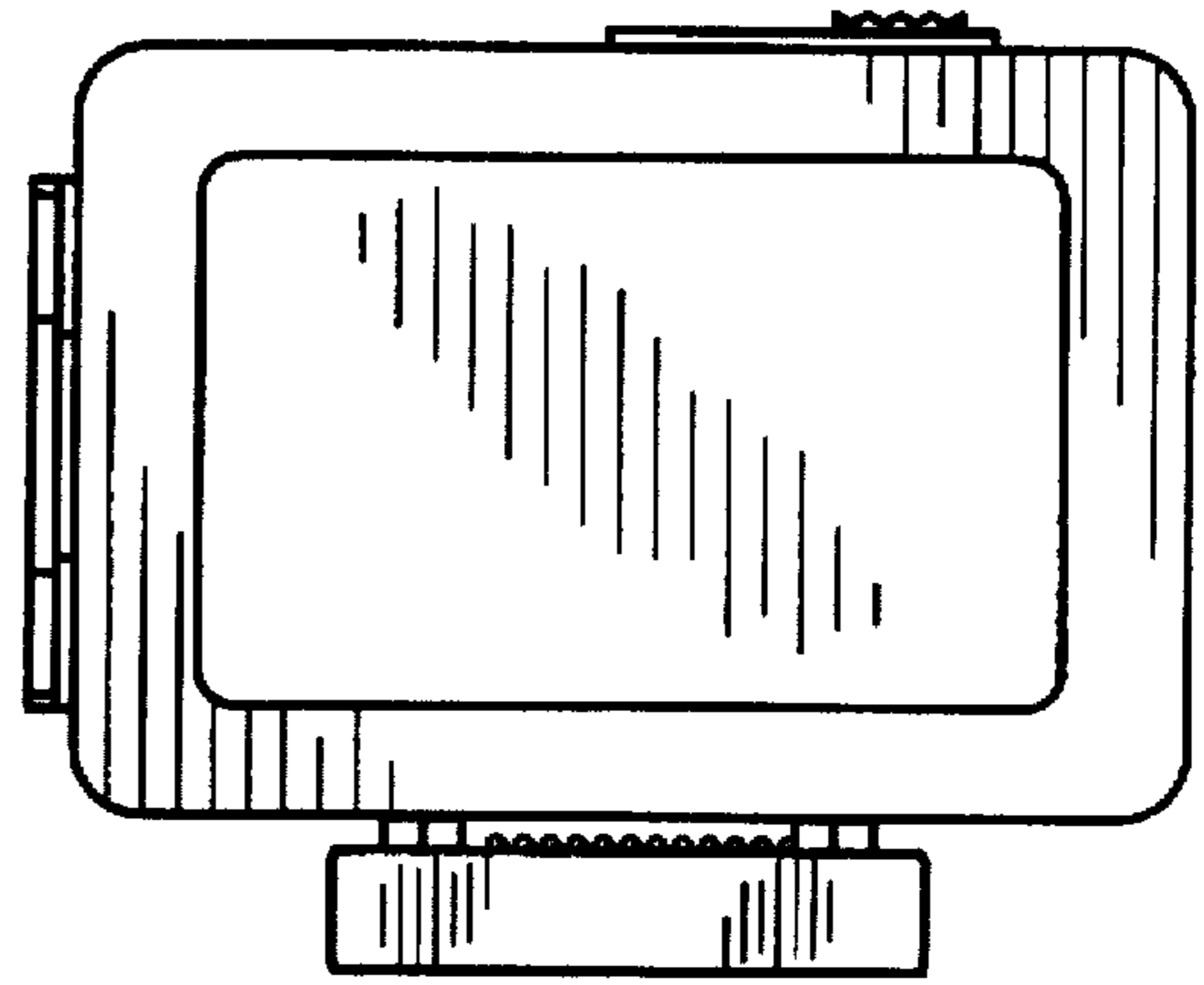

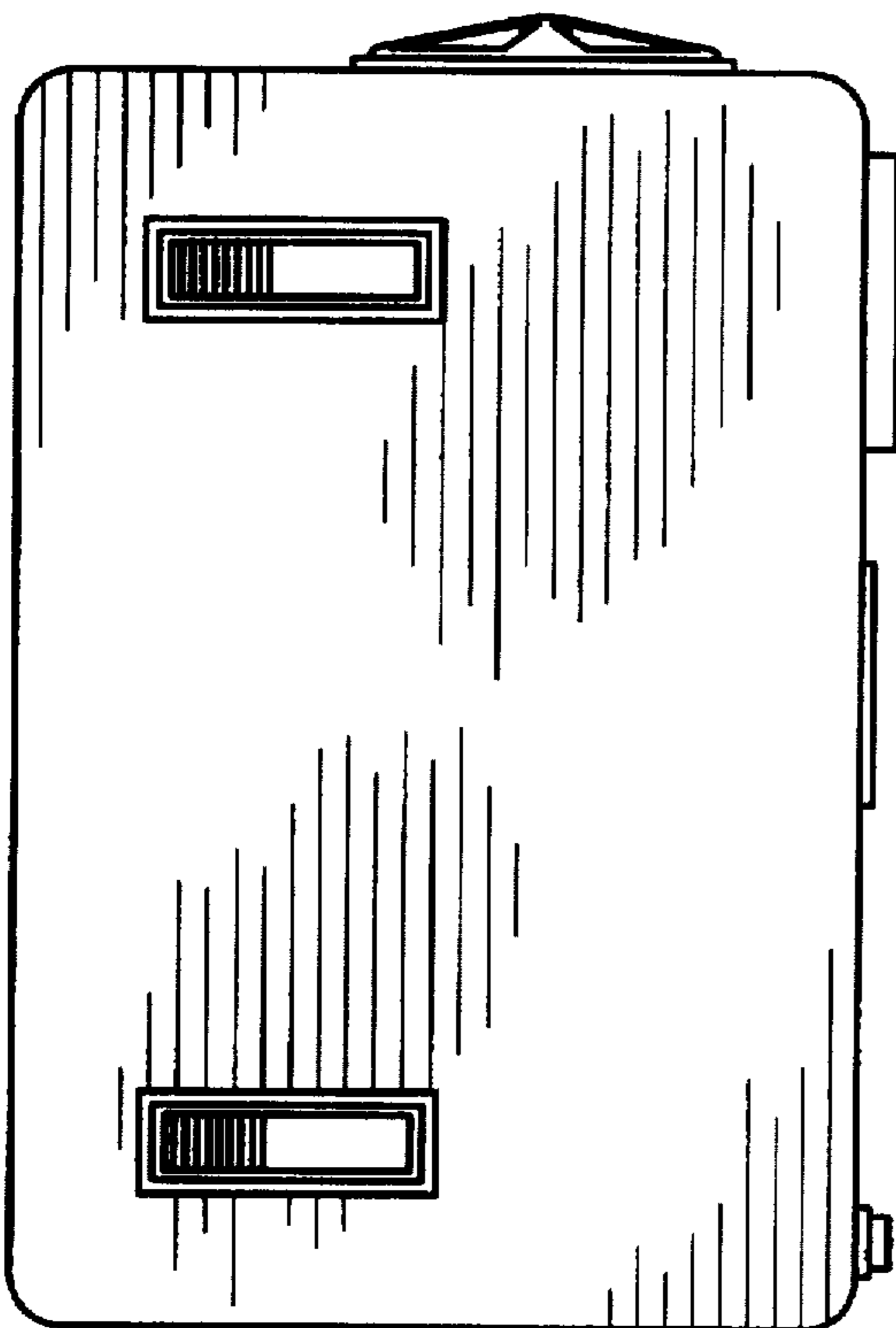

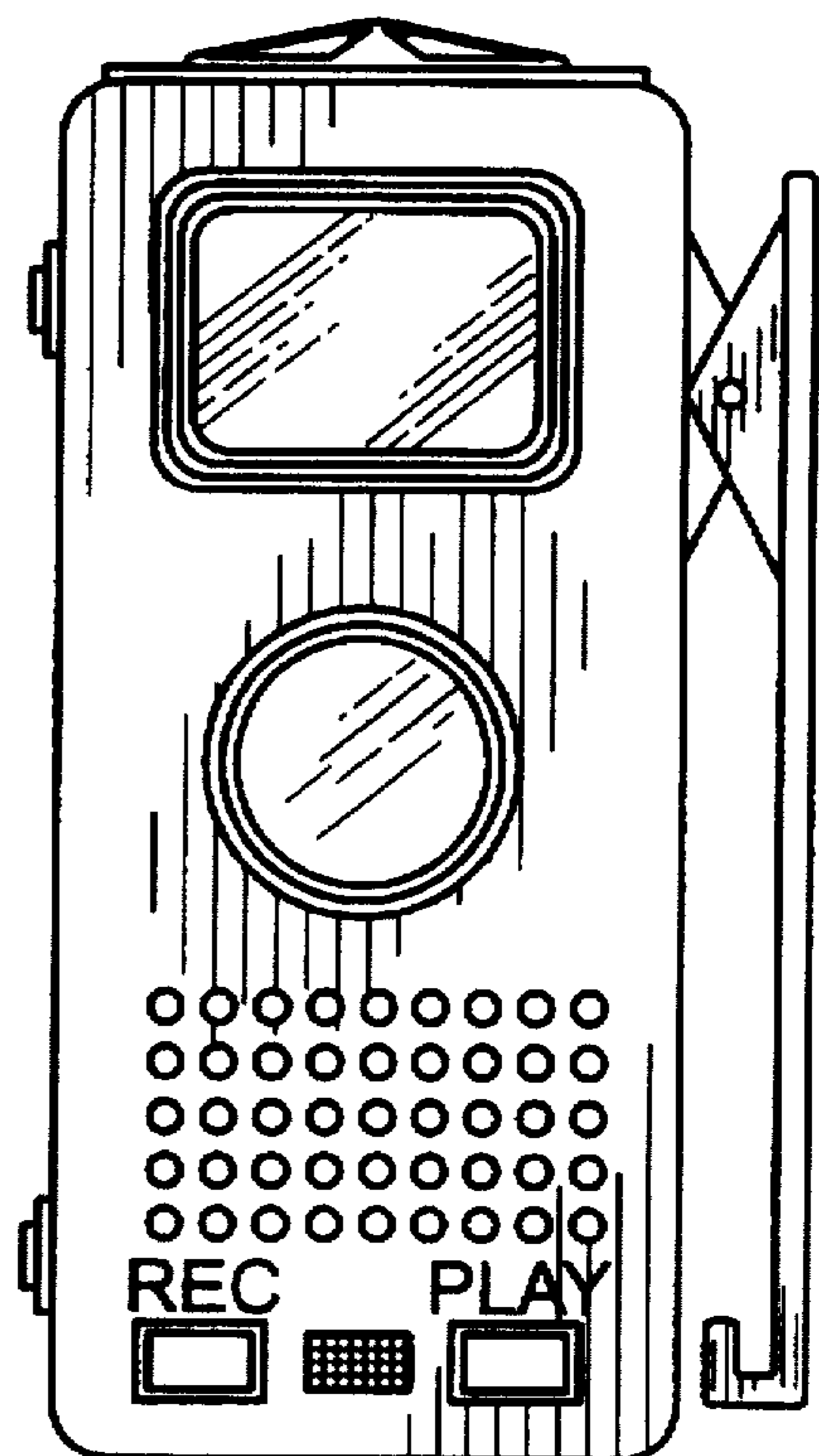

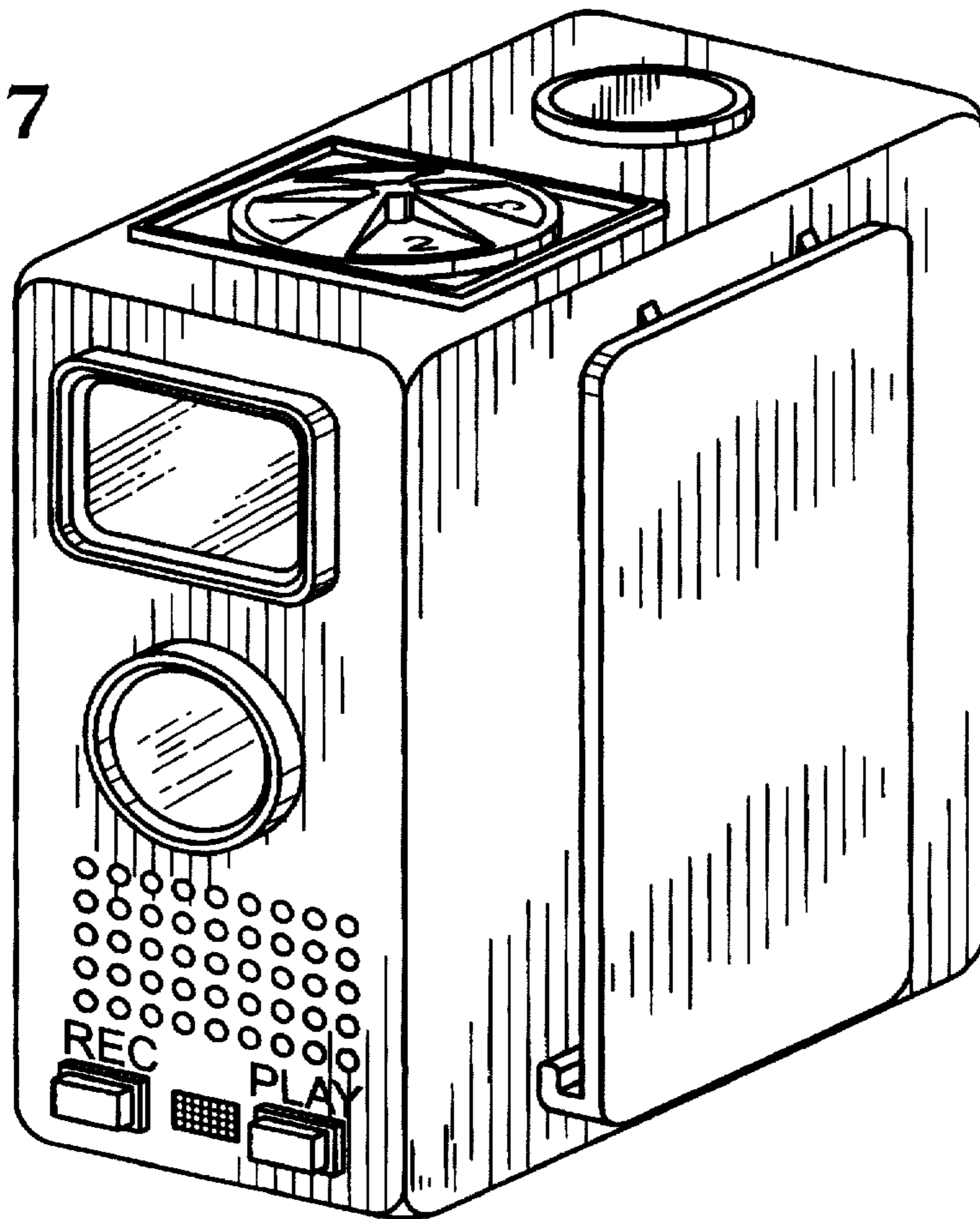

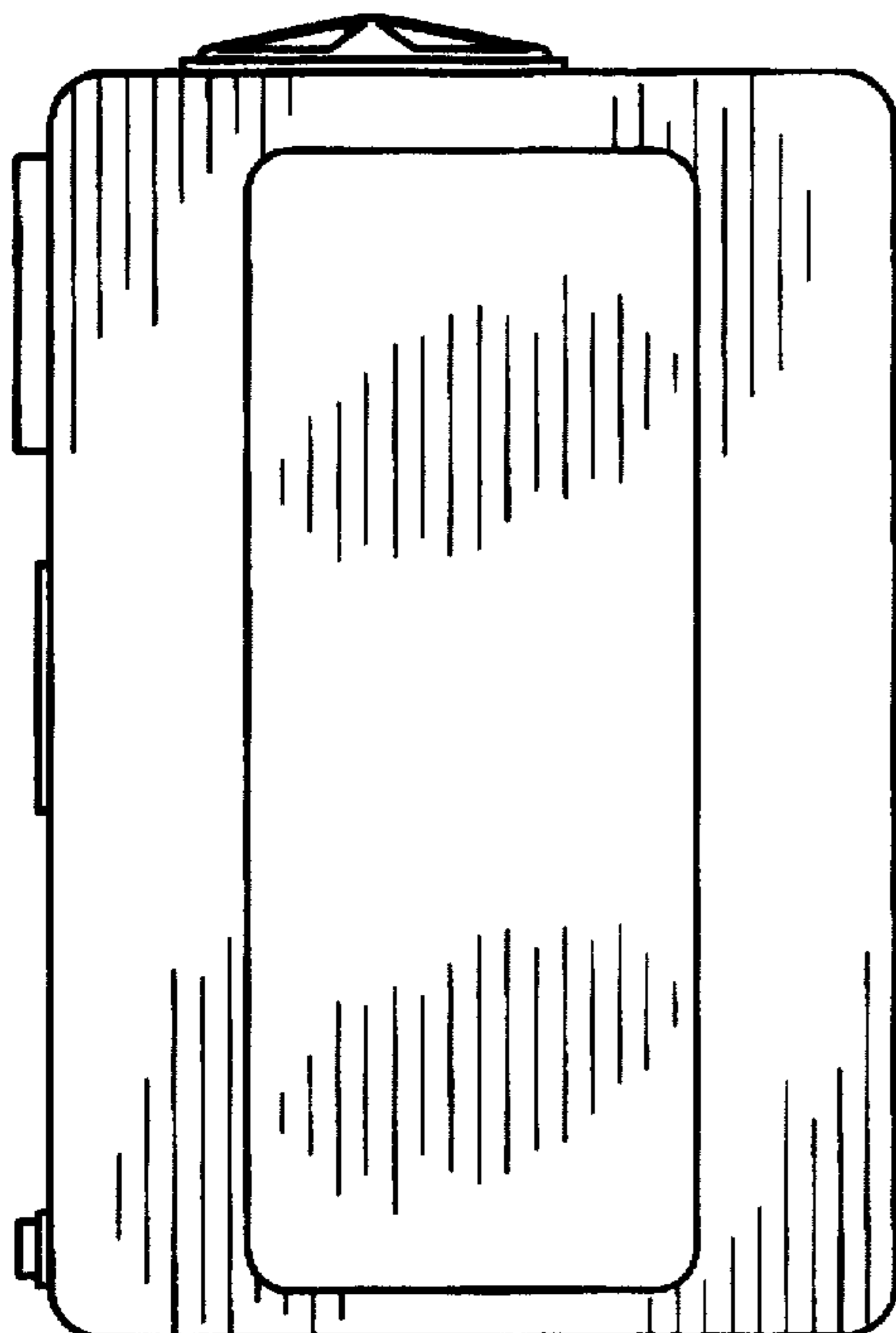
