DESCRIPTION

FIG. 1 is a front top perspective view of a guitar peghead showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a first side elevational view thereof; FIG. 4 is a second side elevational view thereof; FIG. 5 is a bottom plan view thereof; and, FIG. 6 is a front elevational view thereof. The broken lines shown in FIG. 1 are for illustrative purposes only and form no part of the claimed design. Further, to avoid an obstruction of the environmental structure shown by the broken lines, FIG. 1 does not show the opening for tuning pegs.

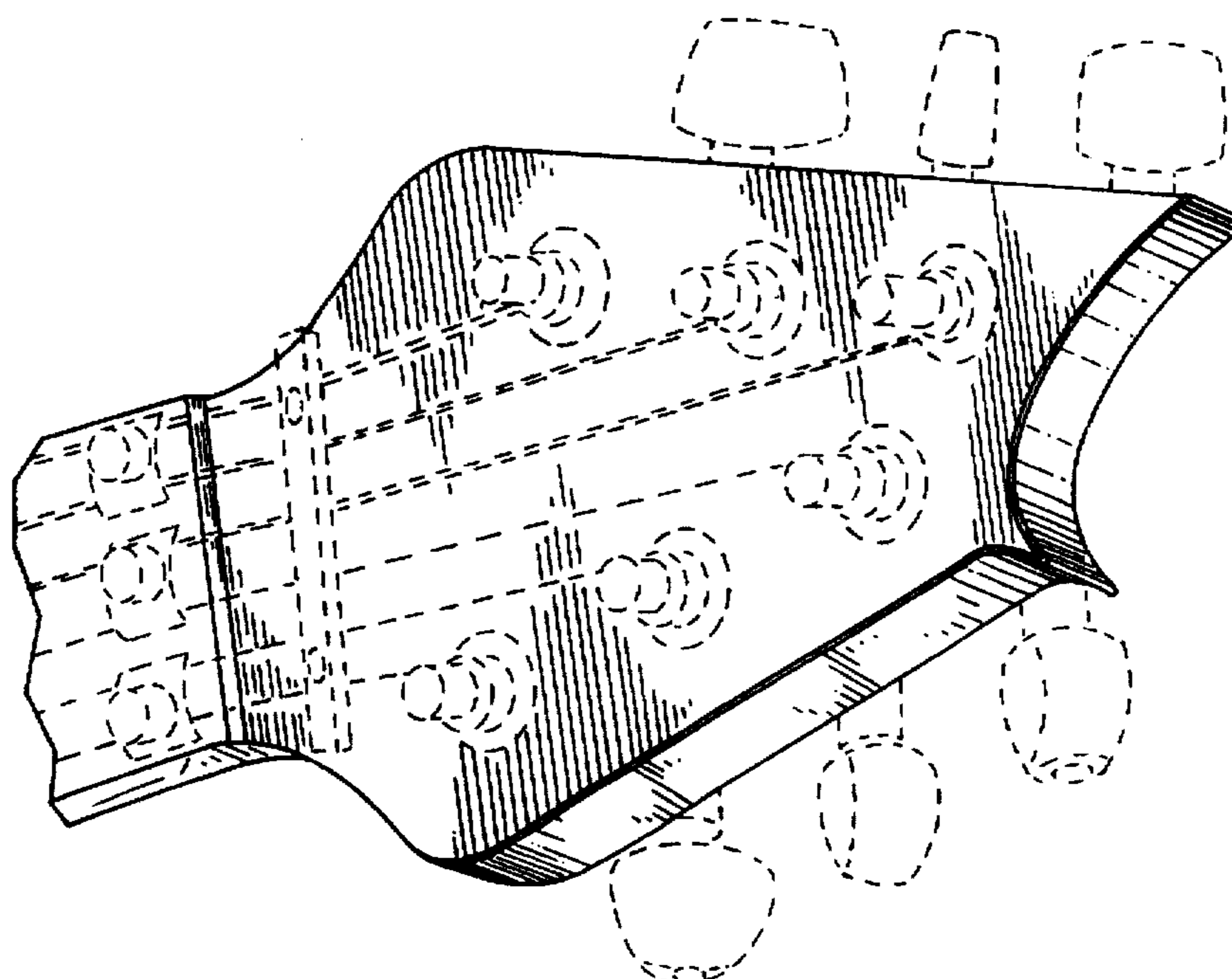

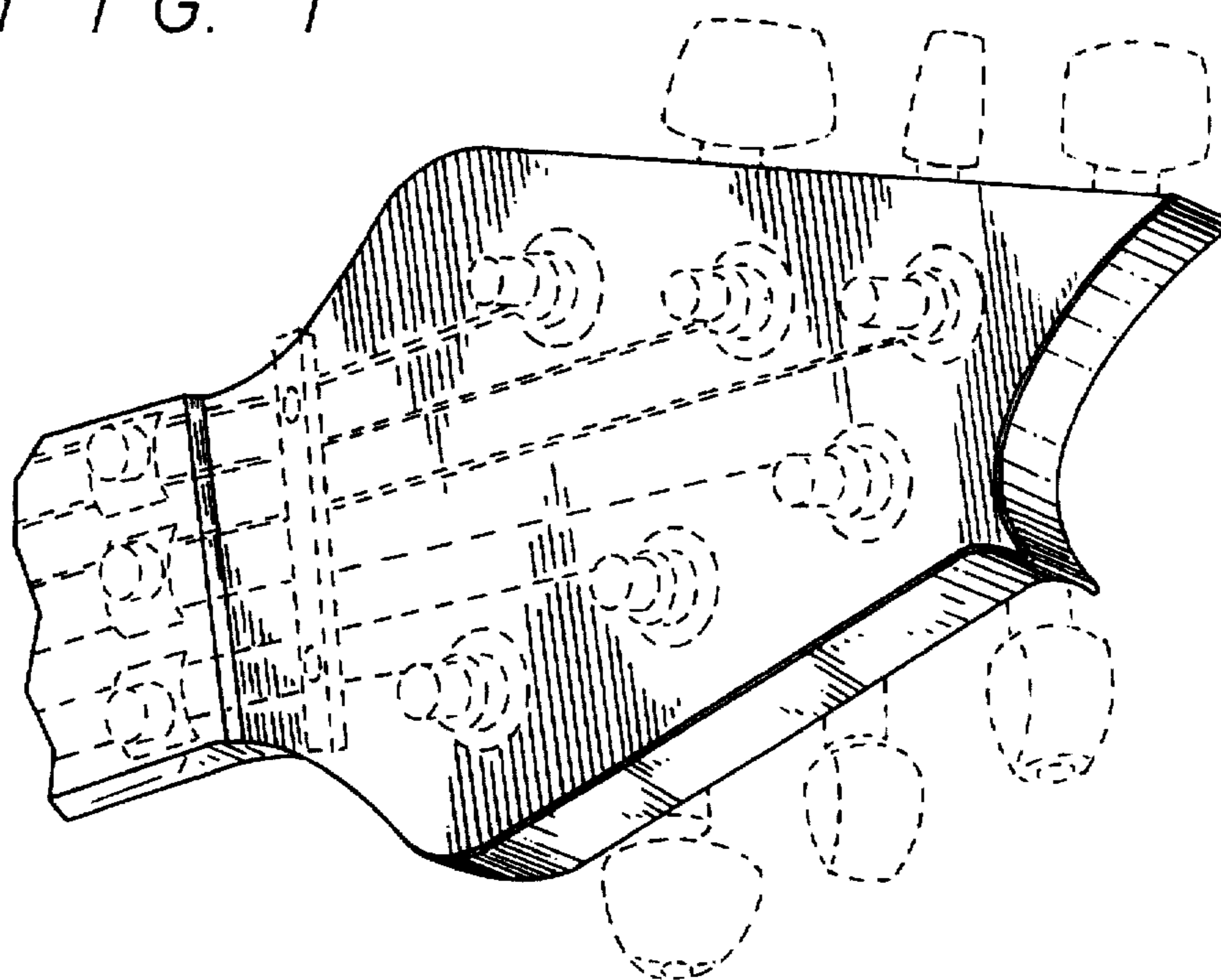

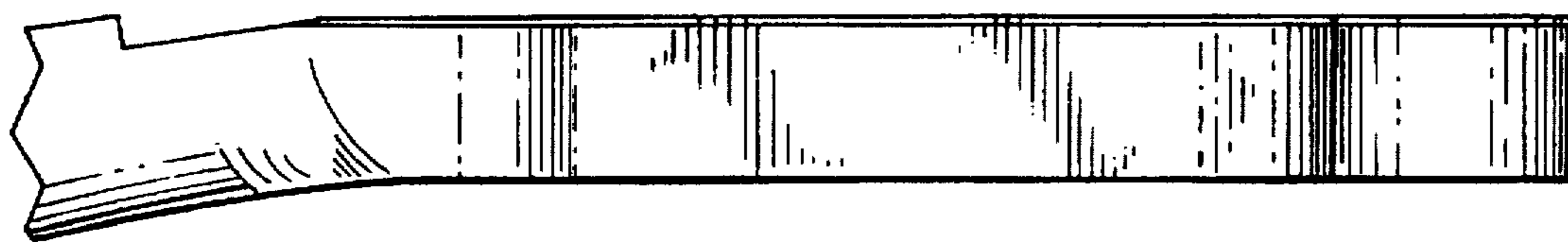
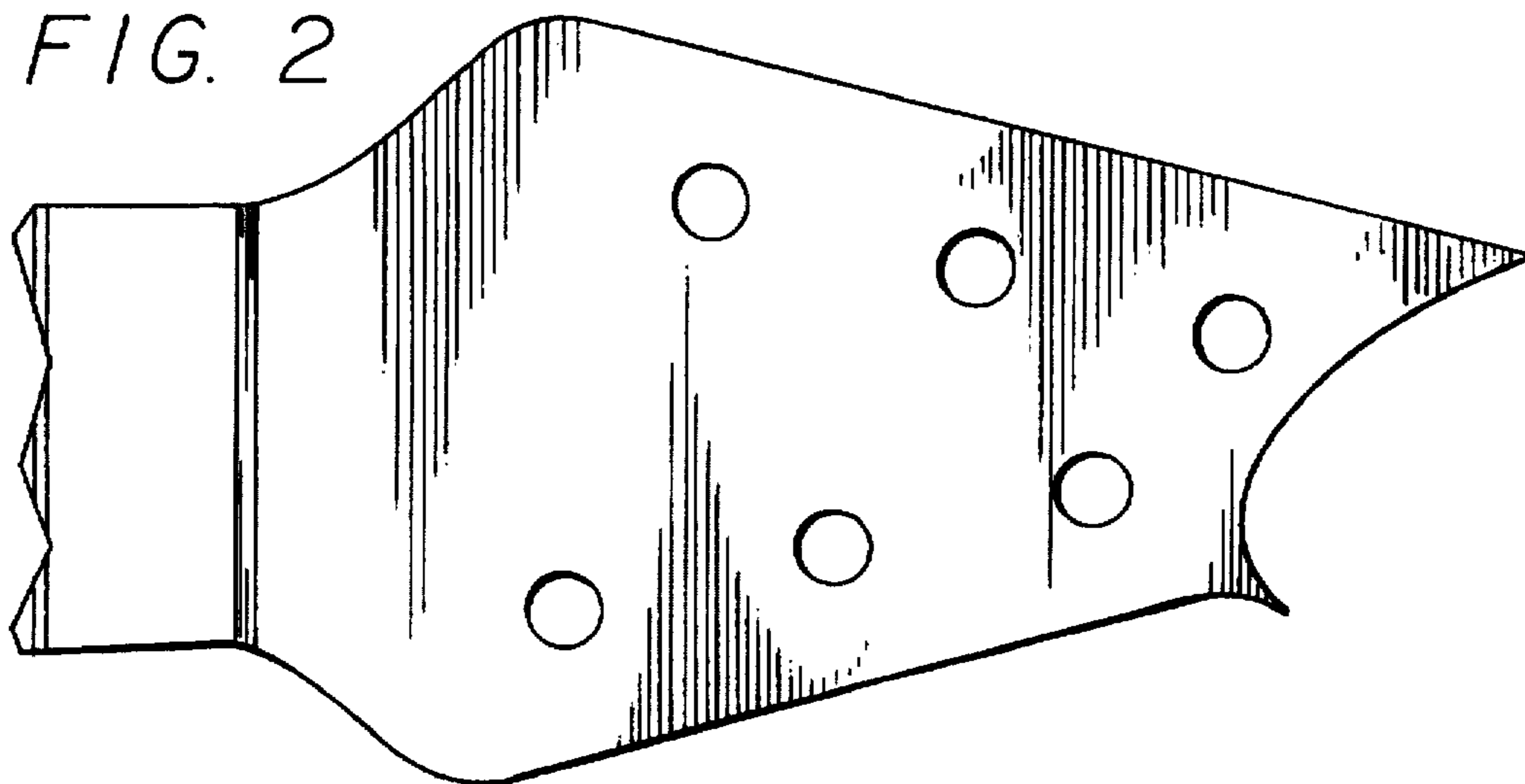

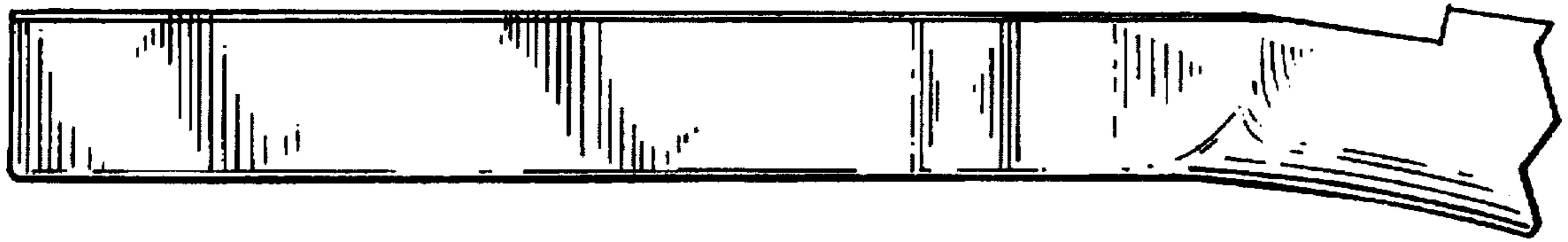

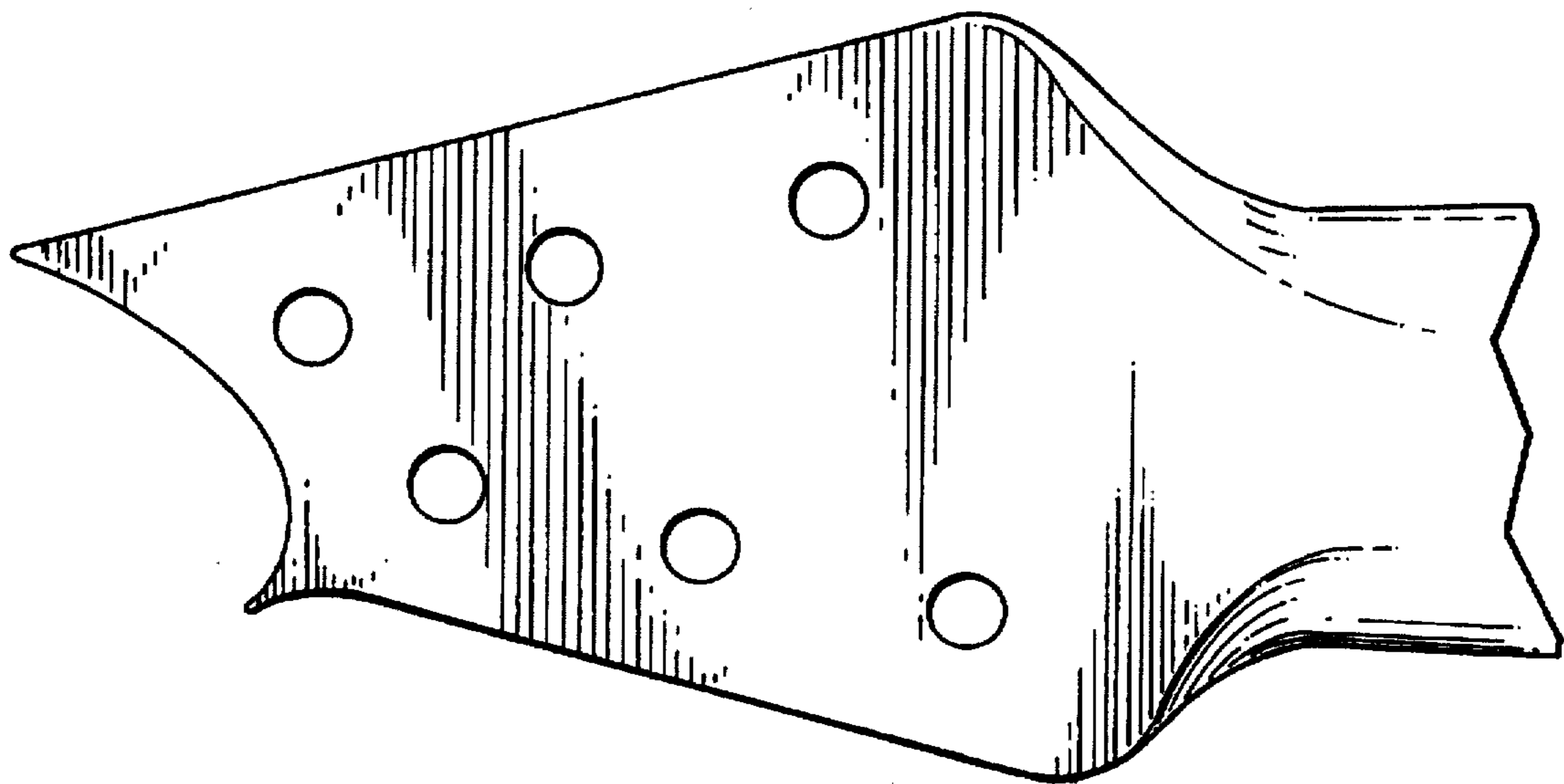

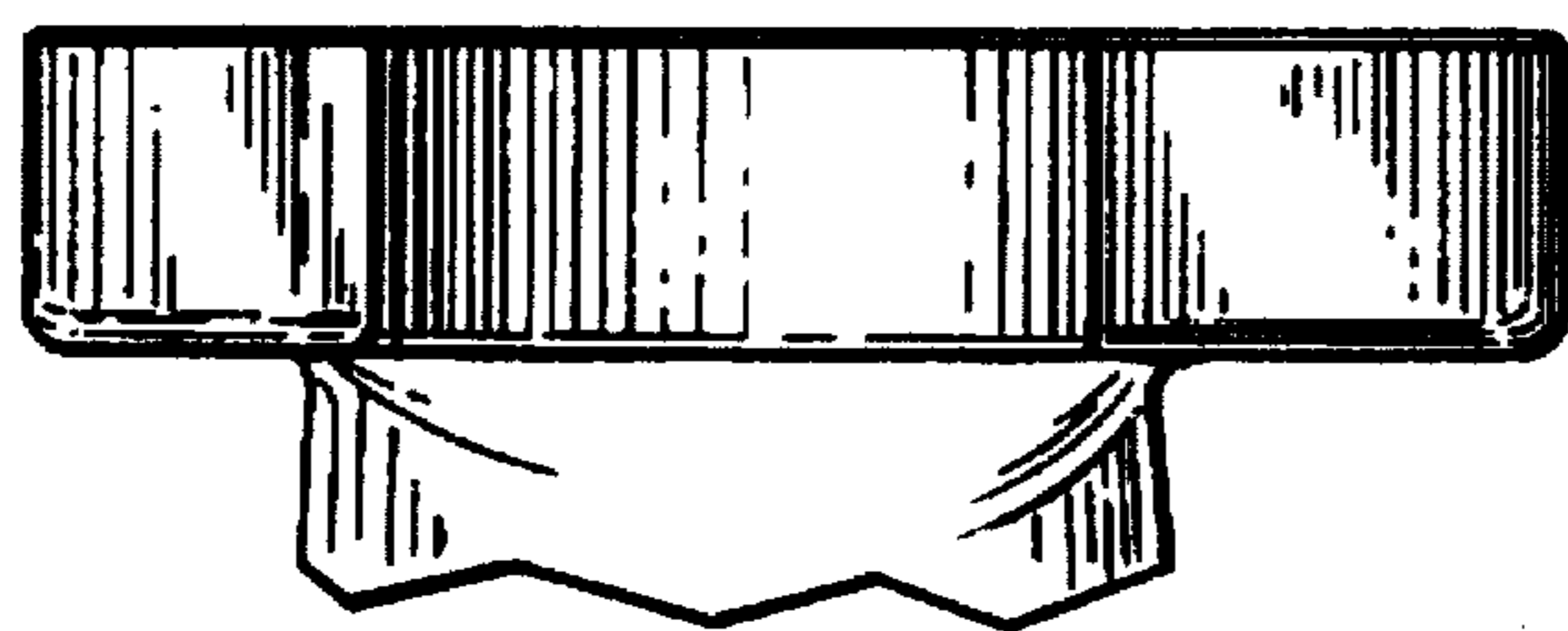
