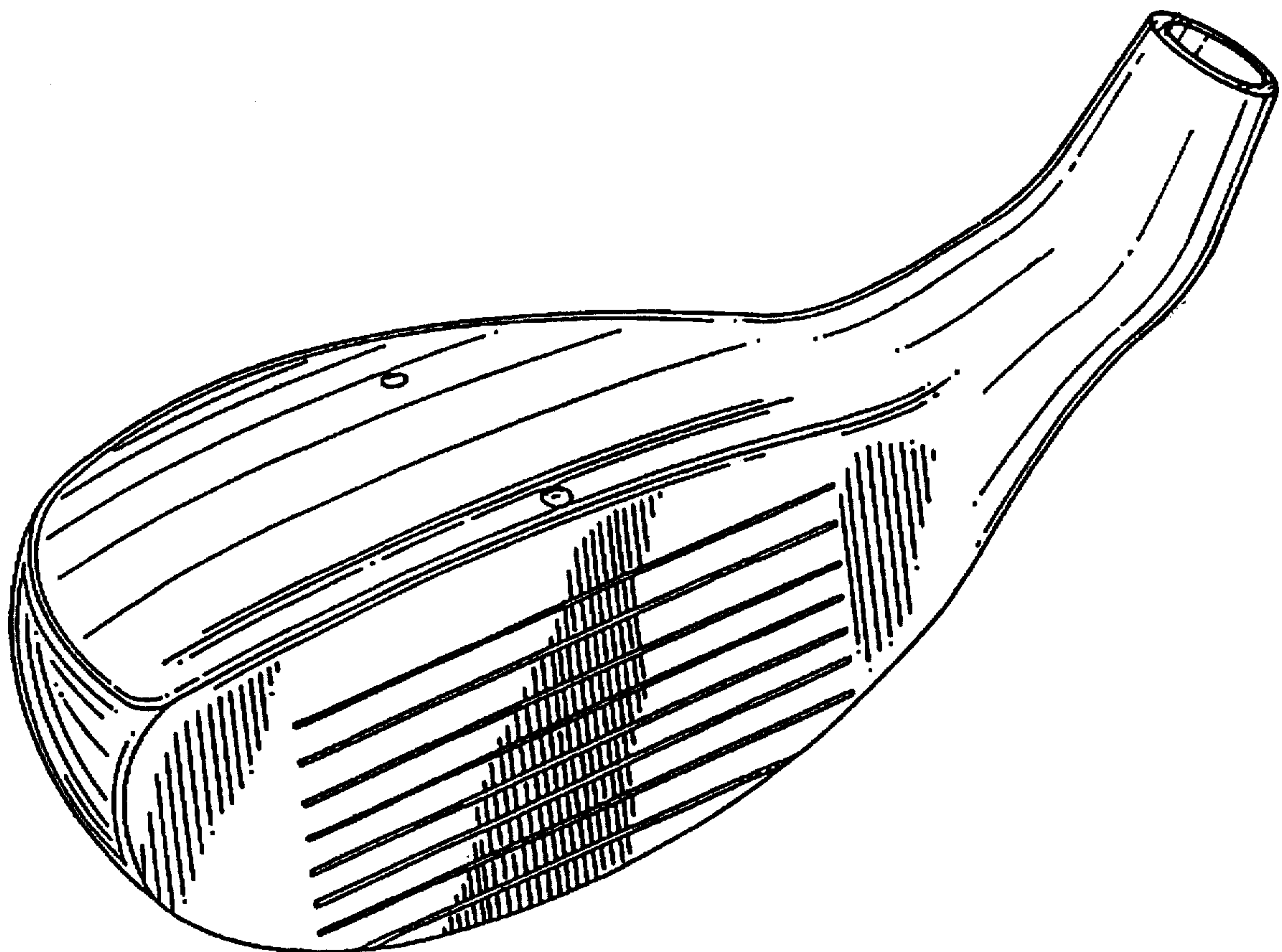
[57] **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the golf club head;
FIG. 2 is a front elevational view of the club head;
FIG. 3 is a rear elevational view of the club head;

FIG. 5 is a bottom plan view of the golf club head;
FIG. 6 is a left side view of the club head; and

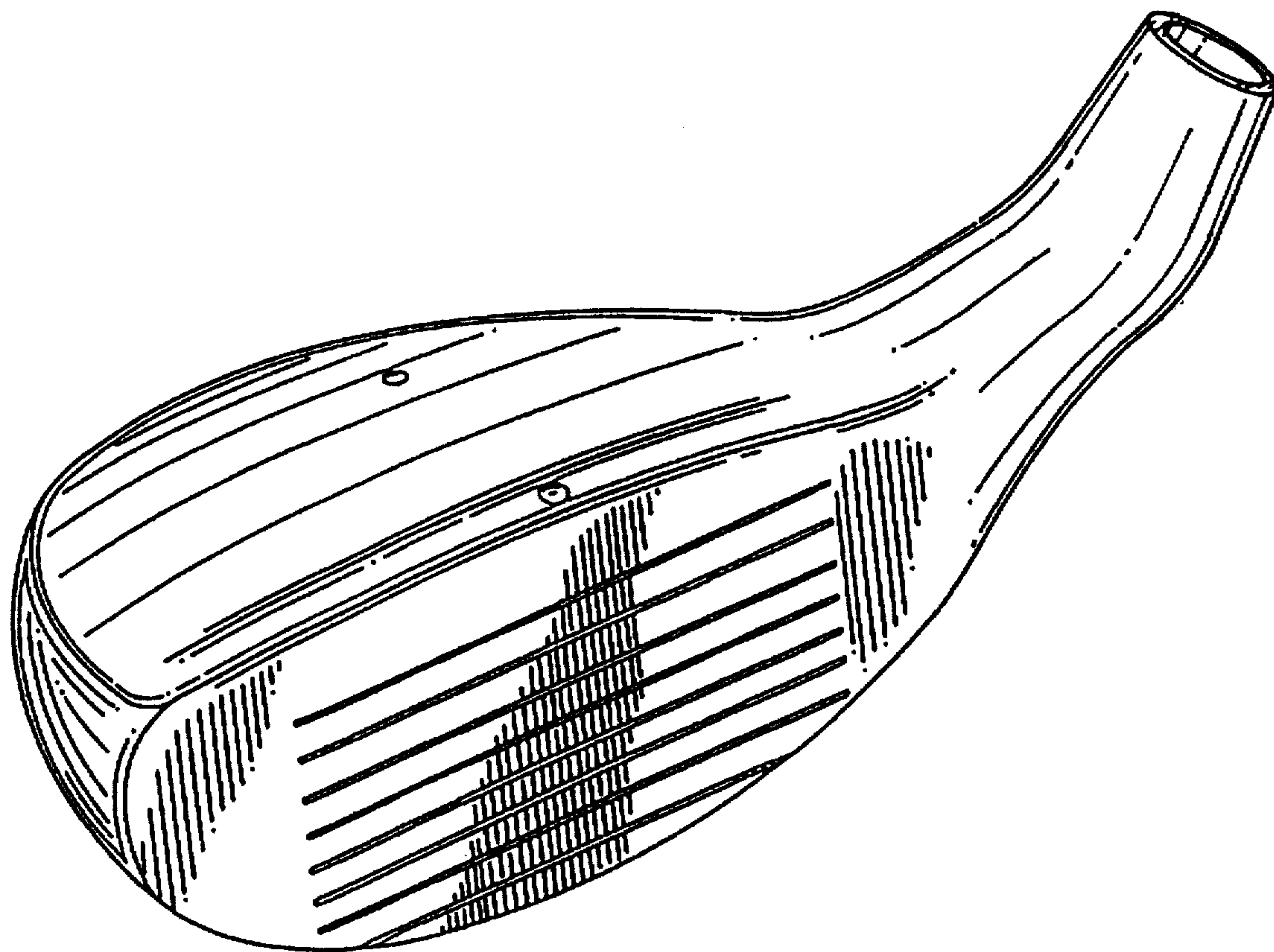

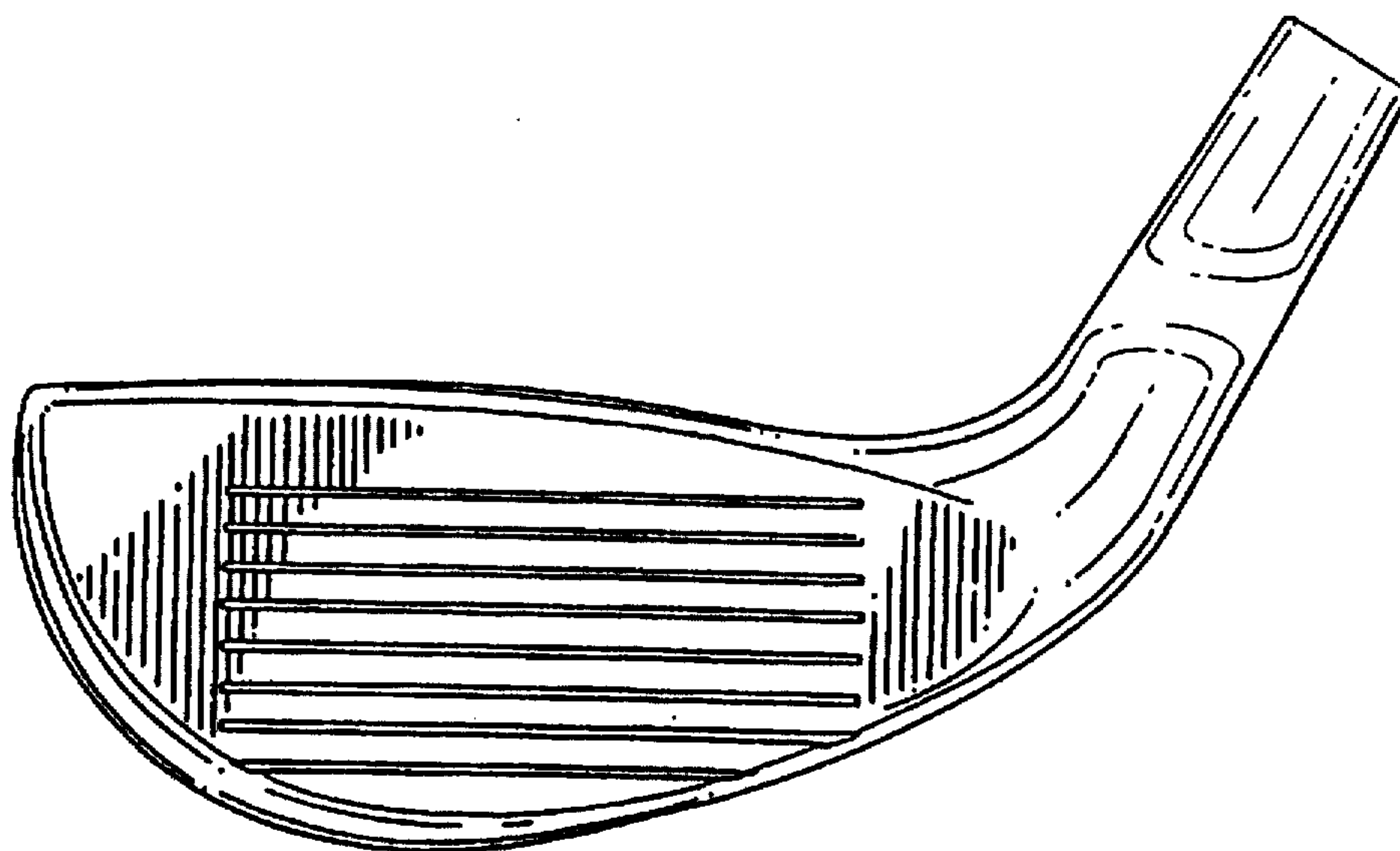

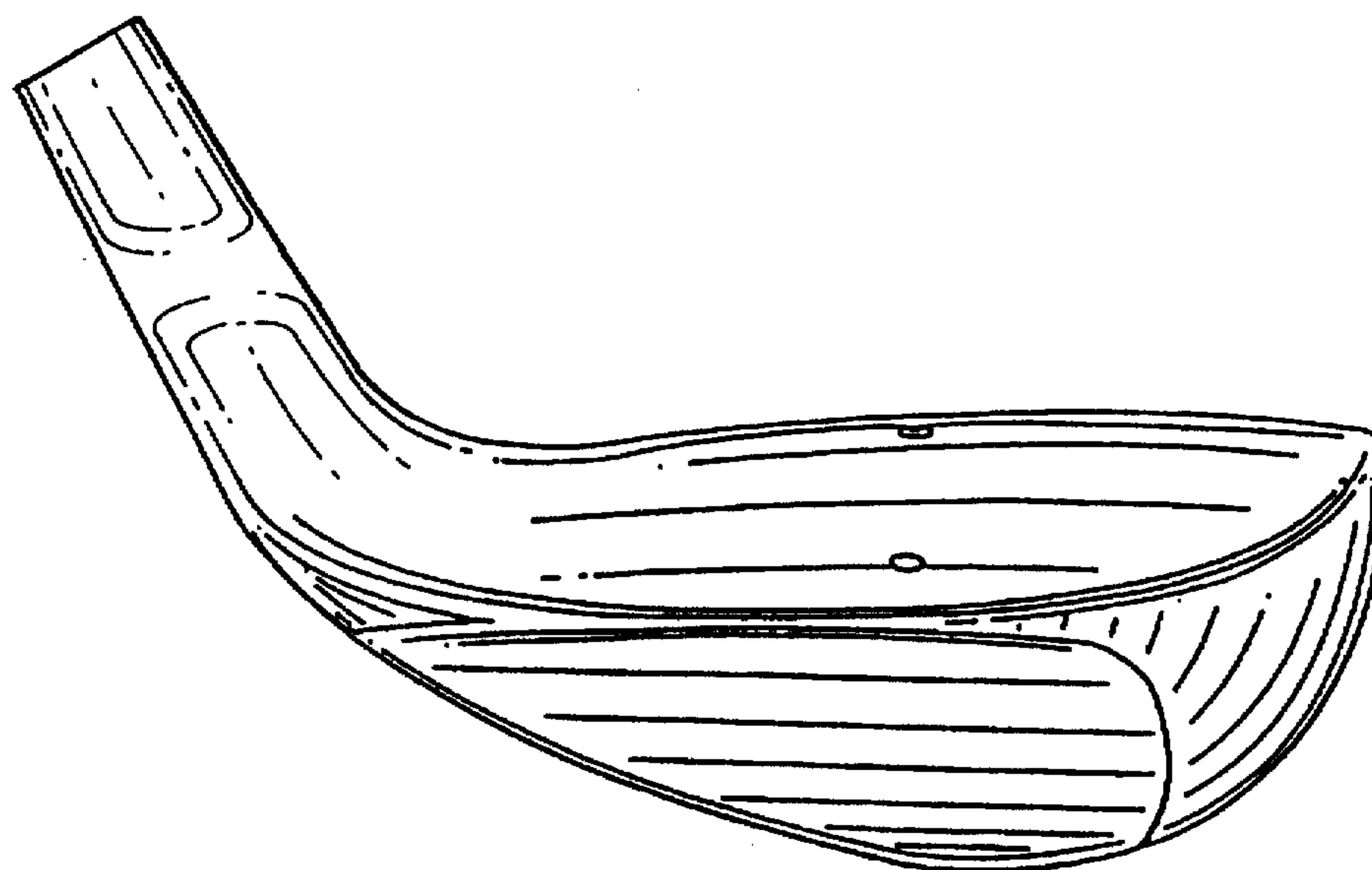

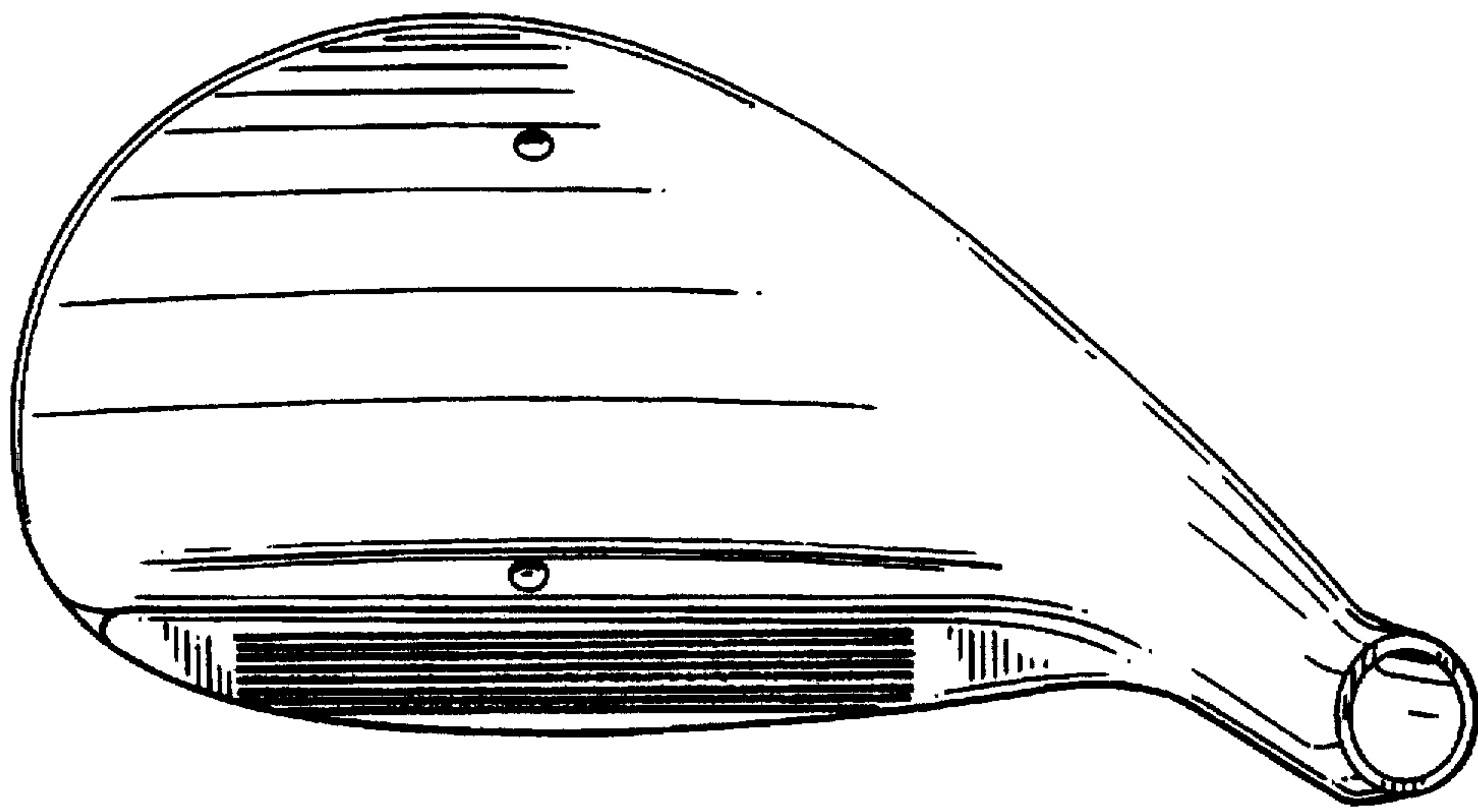

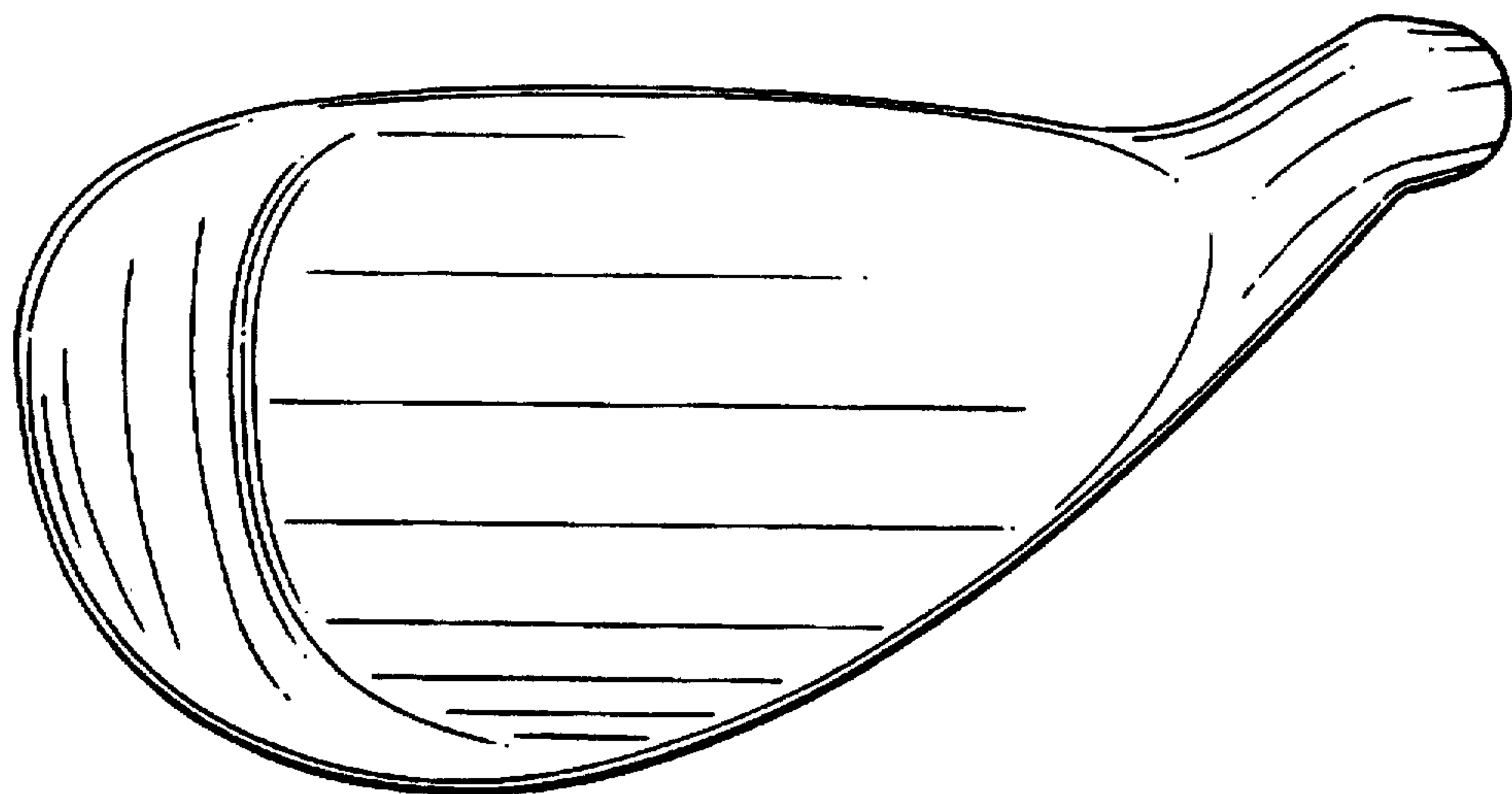

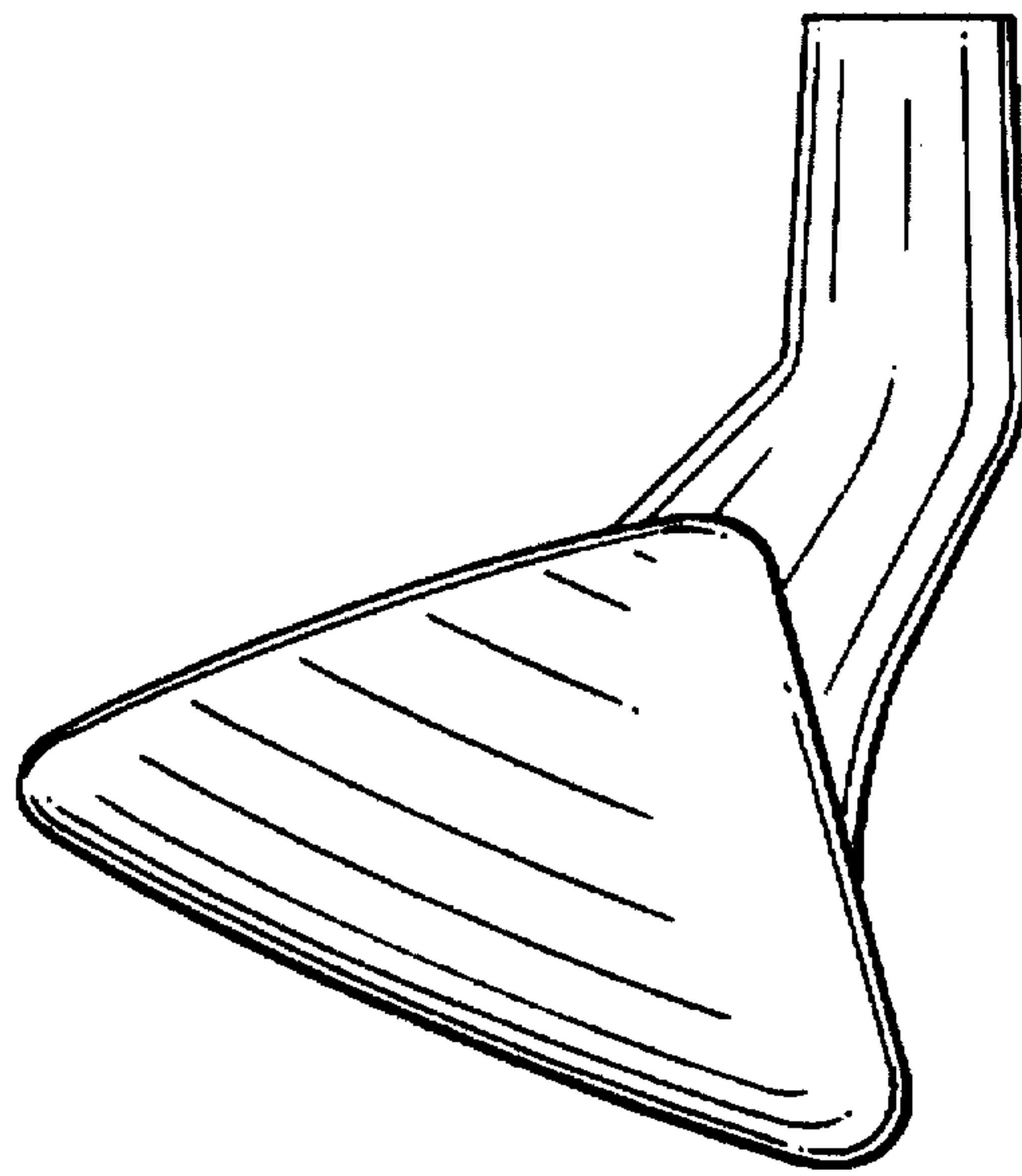

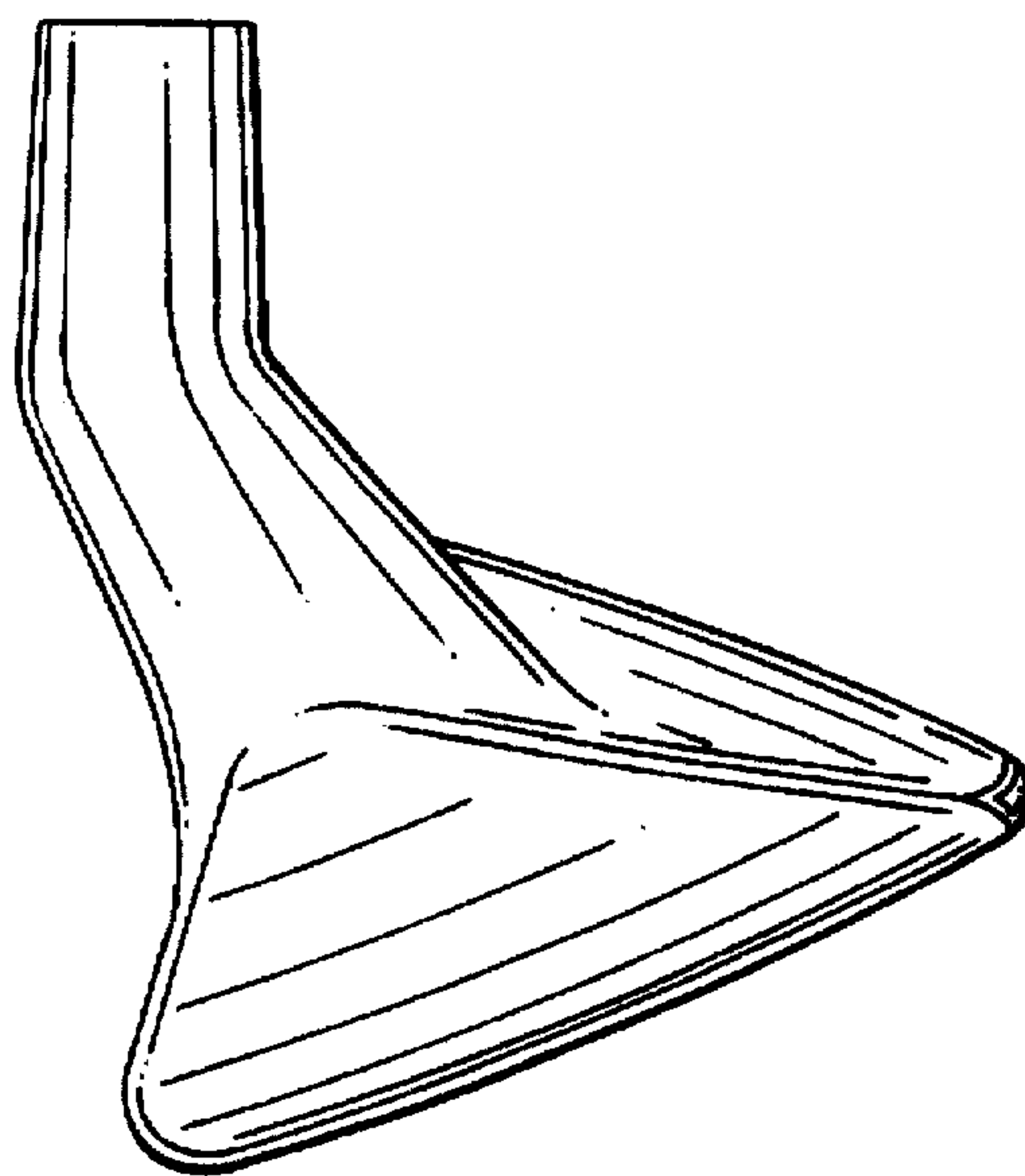
