[57] **CLAIM**

The ornamental design for a bottom surface of a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of a bottom surface of a shoe outsole showing my new design;

FIG. 2 is a cross-sectional profile view taken generally along the line 2—2 of FIG. 1;

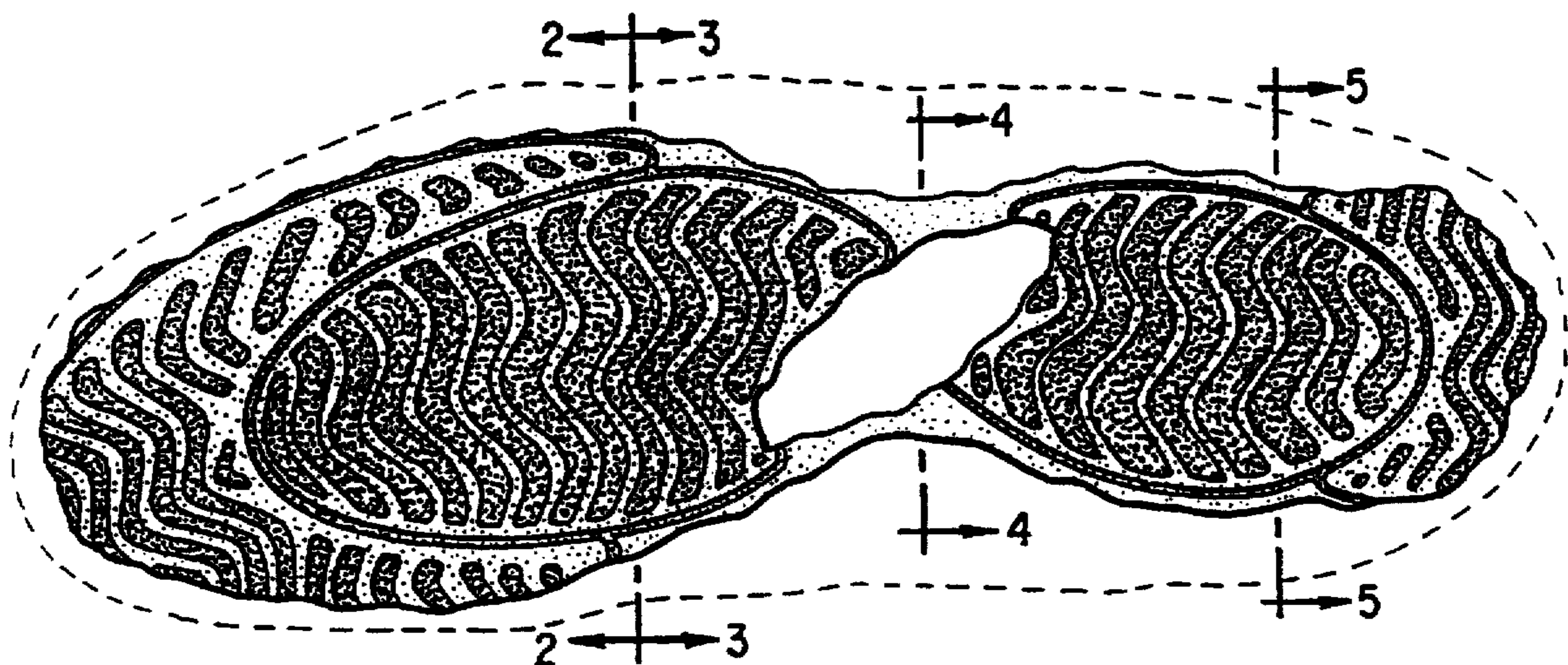
FIG. 3 is a cross-sectional profile view taken generally along the line 3—3 of FIG. 1;

FIG. 4 is a cross-sectional profile view taken generally along the line 4—4 of FIG. 1; and,

FIG. 5 is a cross-sectional profile view taken generally along the line 5—5 of FIG. 1.

The broken line showing of the shoe upper and the remainder of shoe sole is for illustration purposes only and forms no part of the claimed design.

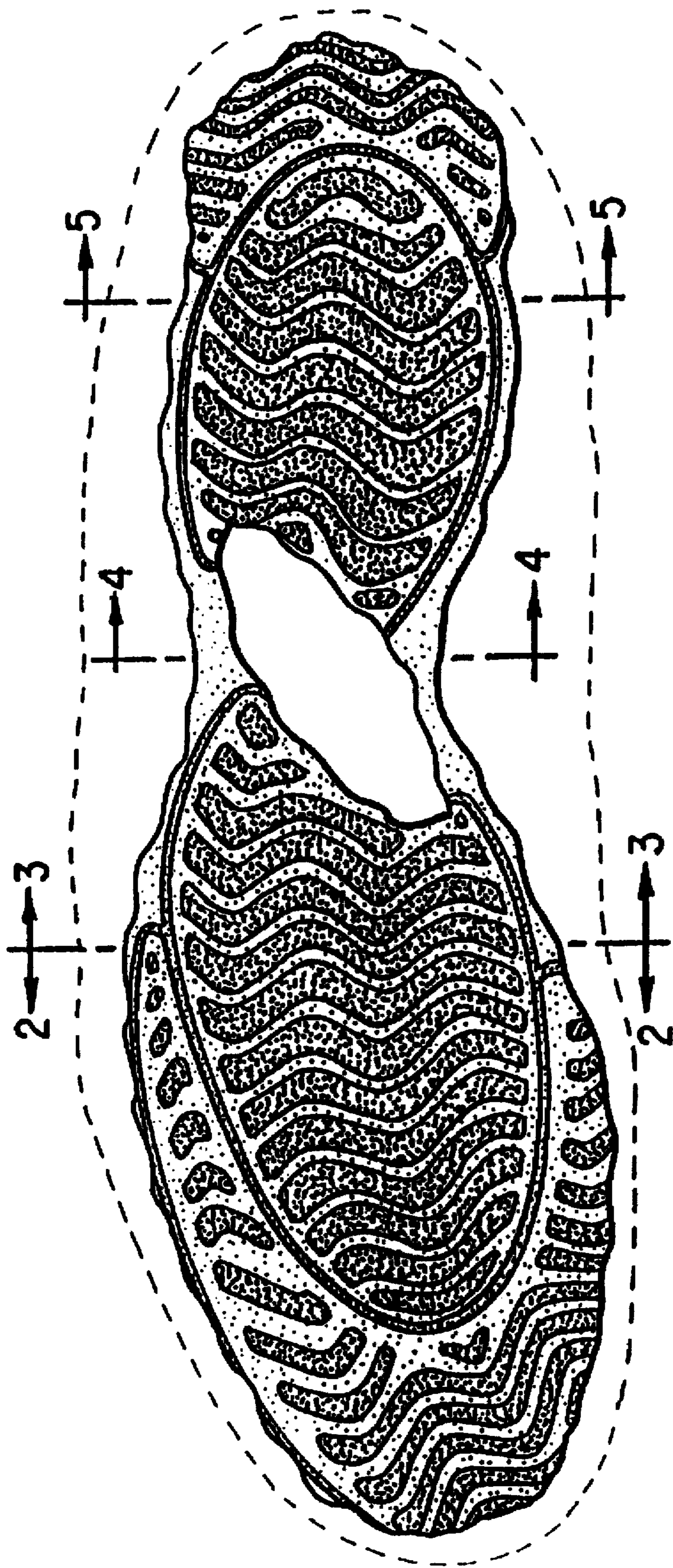

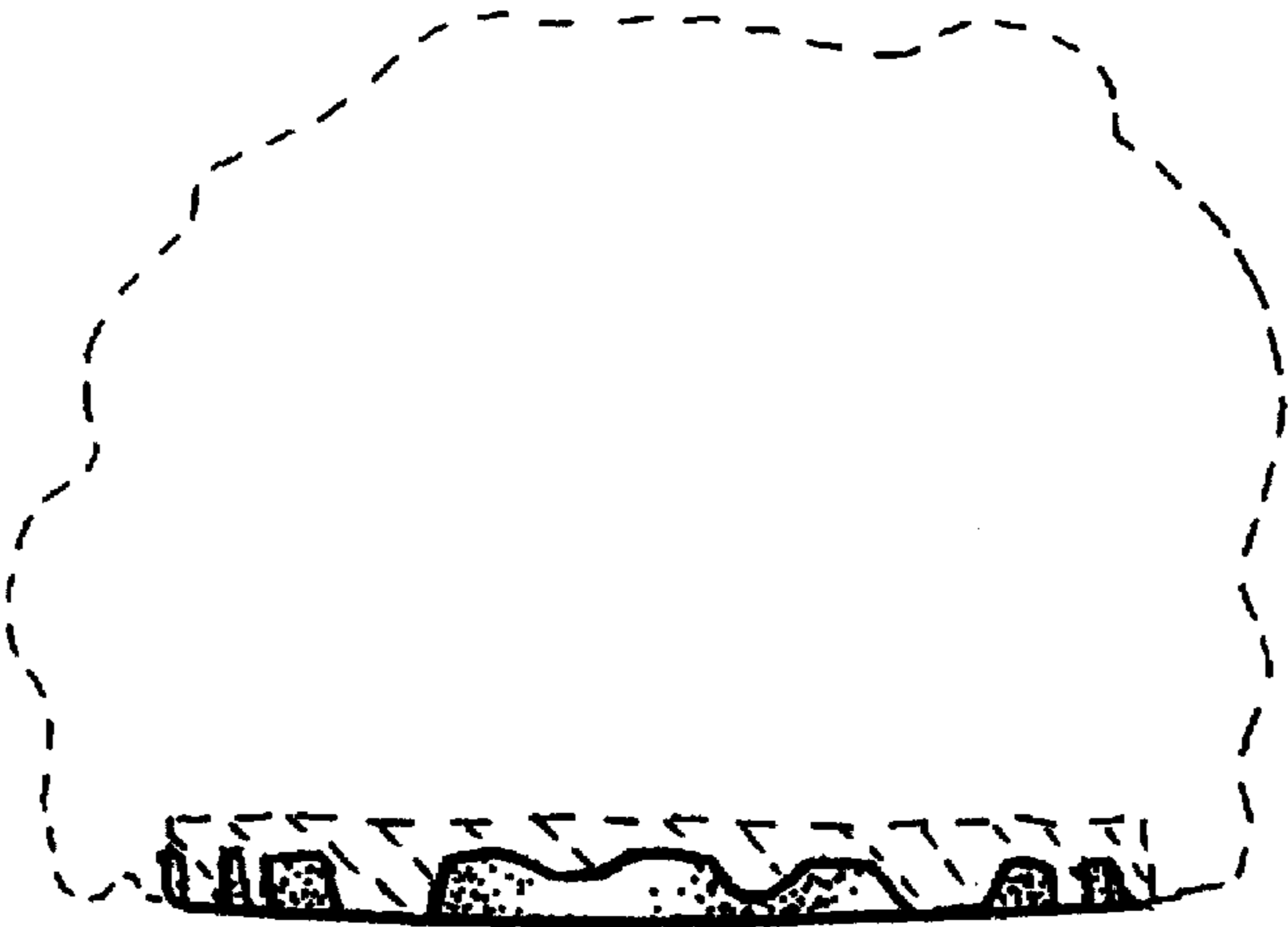

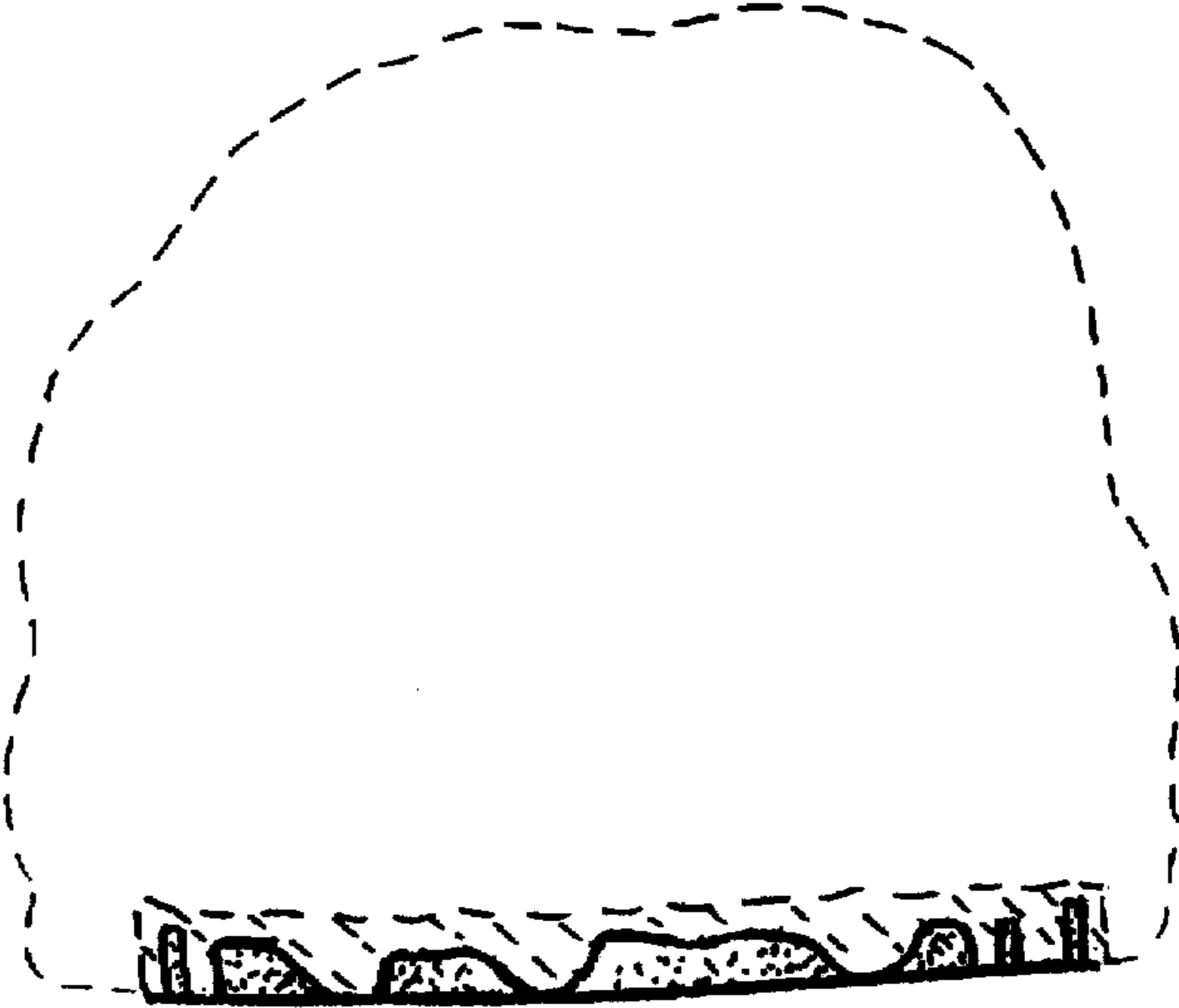

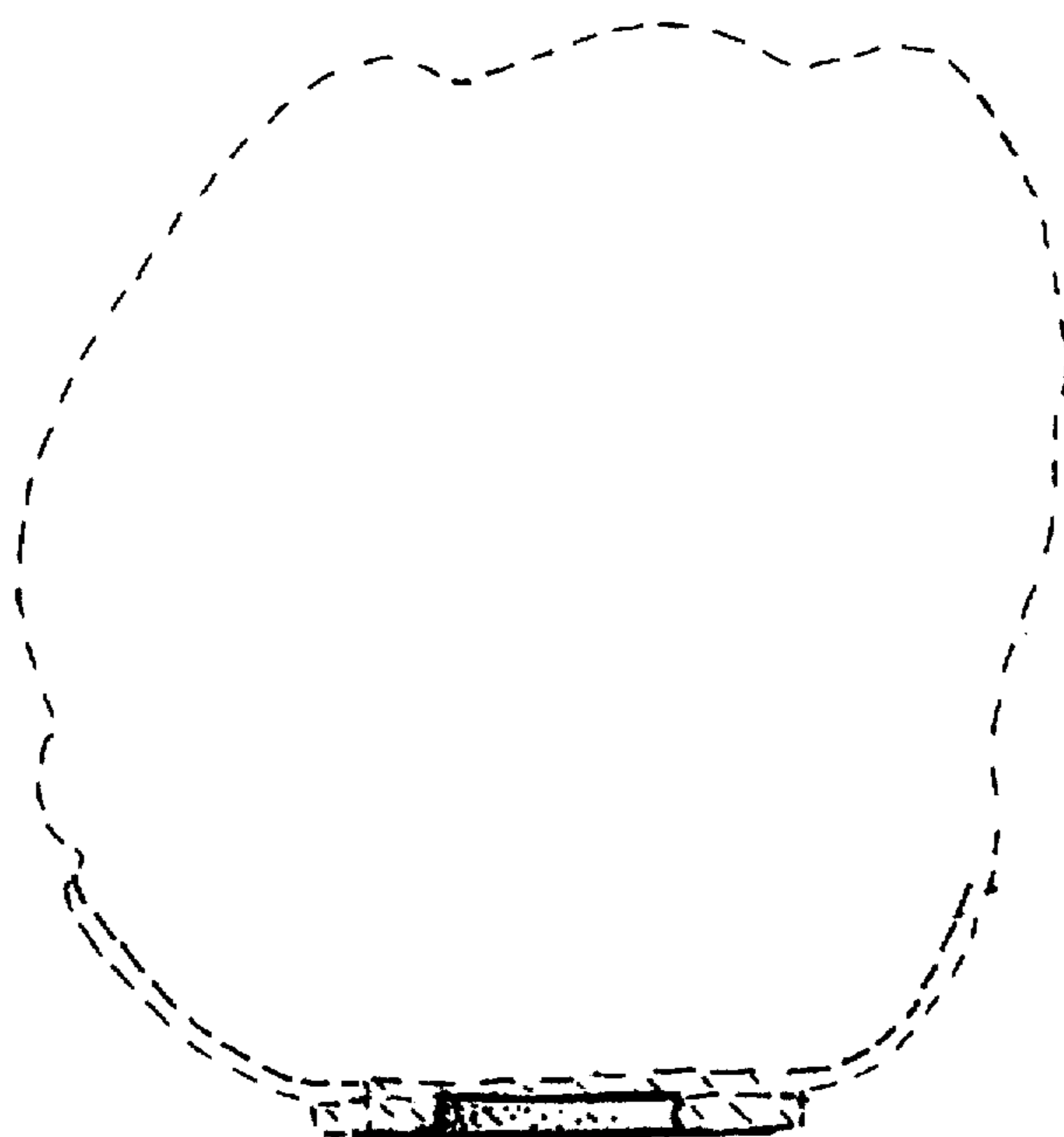

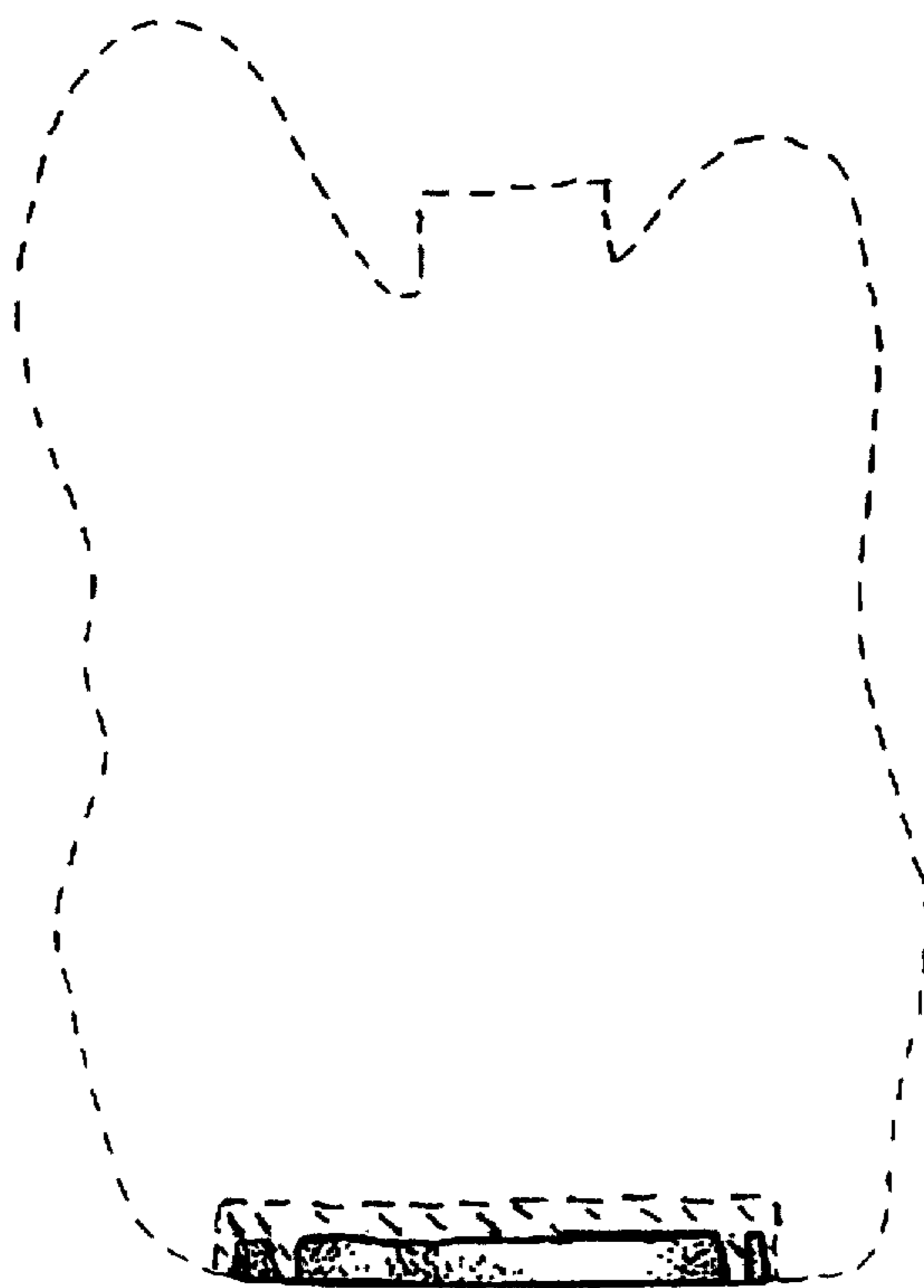
