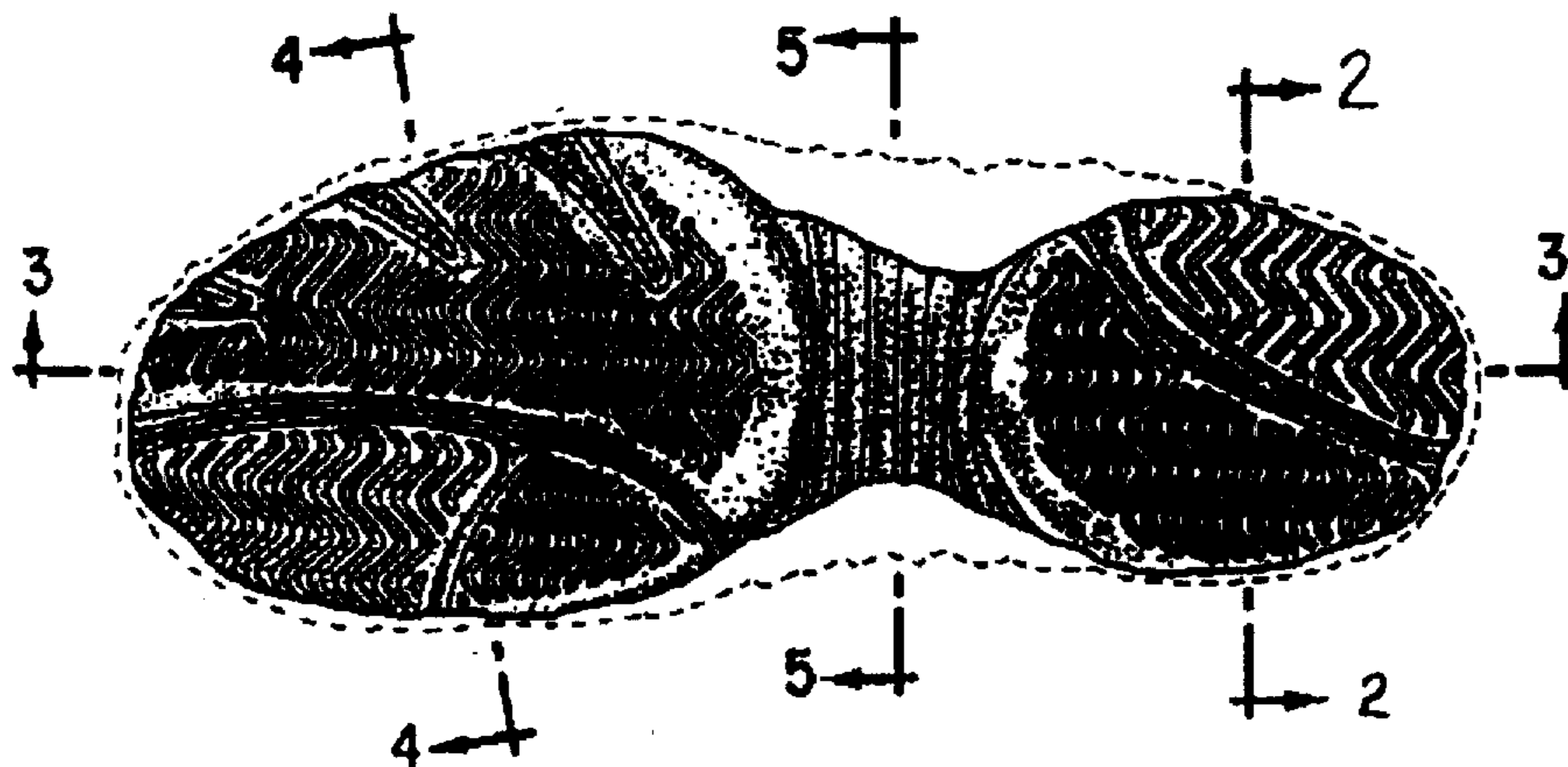
[57] **CLAIM**

The ornamental design for a portion of a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of a portion of a shoe outsole showing my new design;
FIG. 2 is a profile view taken along the line 2—2 of FIG. 1;
FIG. 3 is a profile view taken along the line 3—3 of FIG. 1;
FIG. 4 is a profile view taken along the line 4—4 of FIG. 1; and,
FIG. 5 is a profile view taken along the line 5—5 of FIG. 1. The broken line showing of environment in FIG. 1 is for illustrative purposes only and forms no part of the claimed design.

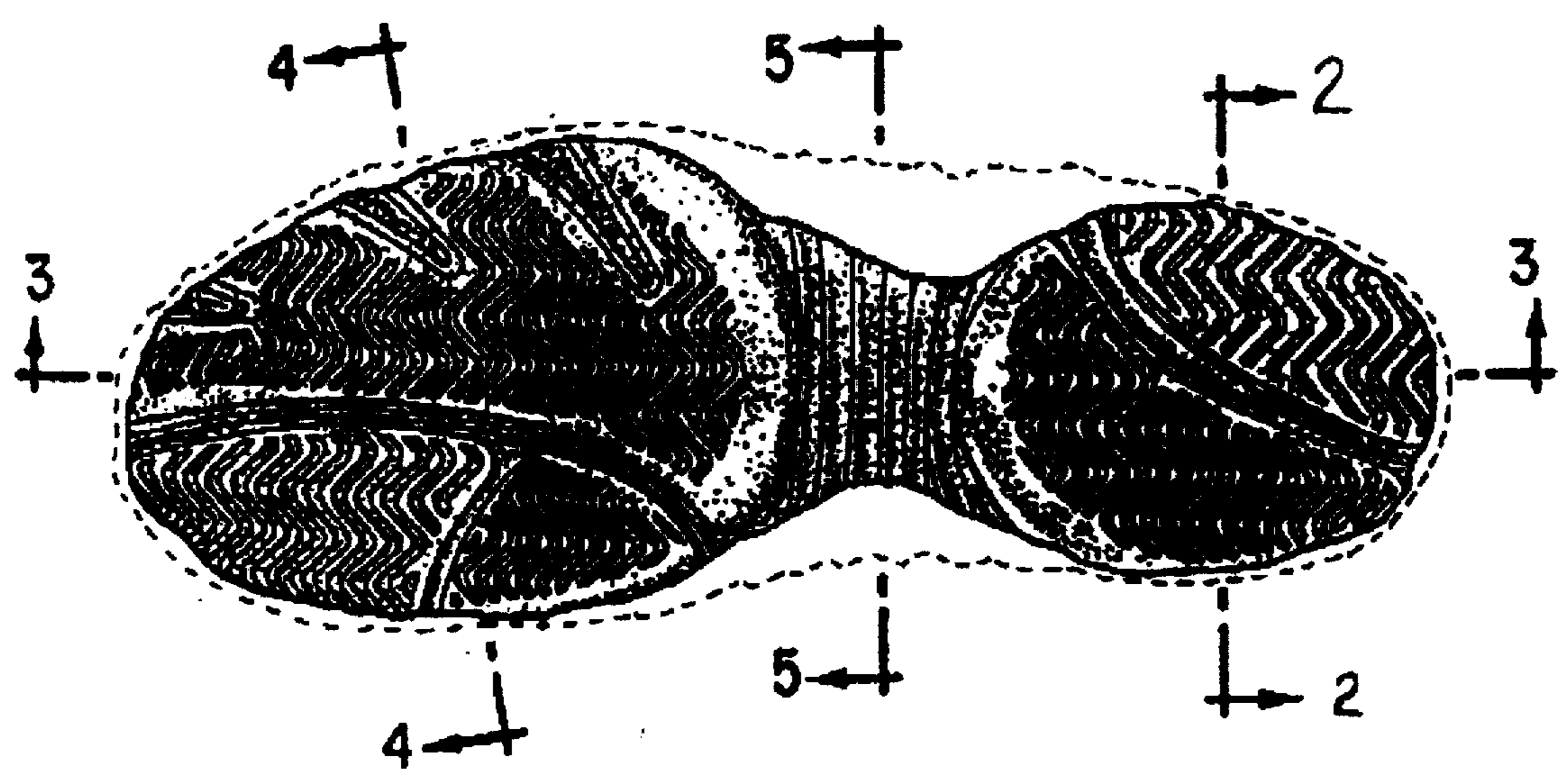
