[57] **CLAIM**

The ornamental design for a portion of a shoe upper, as shown and described.

**DESCRIPTION**

FIG. 1 is a side elevational view of a portion of a shoe upper showing my new design;

FIG. 2 is a front elevational view of the portion of a shoe upper shown in FIG. 1;

FIG. 3 is a rear elevational view of the portion of a shoe upper shown in FIG. 1; and,

FIG. 4 is a top plan view of the portion of a shoe upper shown in FIG. 1.

The broken line showing of the remainder of the shoe is for illustration purposes only and forms no part of the claimed design.








