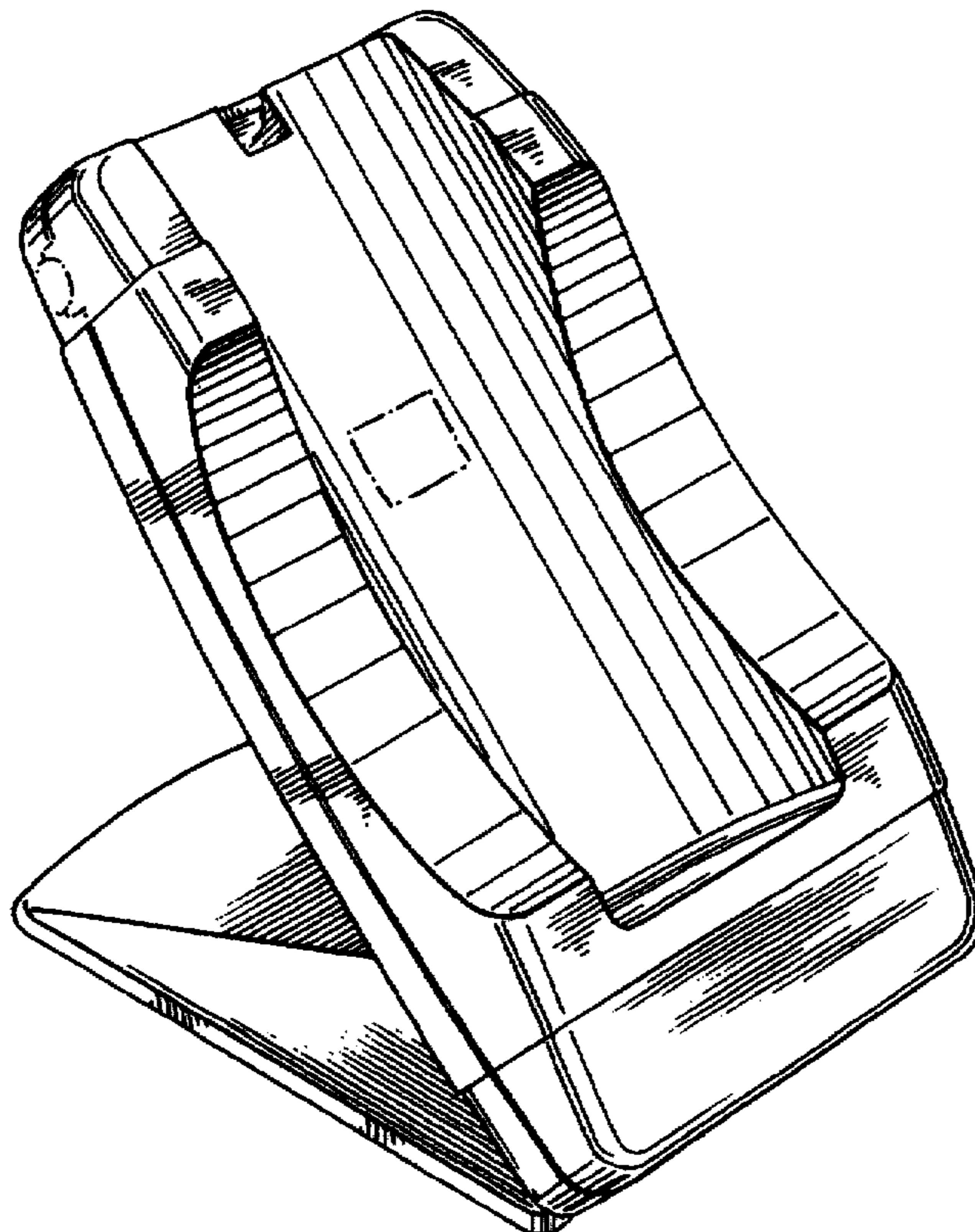
[57] **CLAIM**

The ornamental design for a telephone base and stand, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of the telephone base and stand showing my new design;  
FIG. 2 is a rear elevational view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a left-hand side view thereof;  
FIG. 6 is a right-hand side view thereof; and,  
FIG. 7 is a front elevational view thereof.

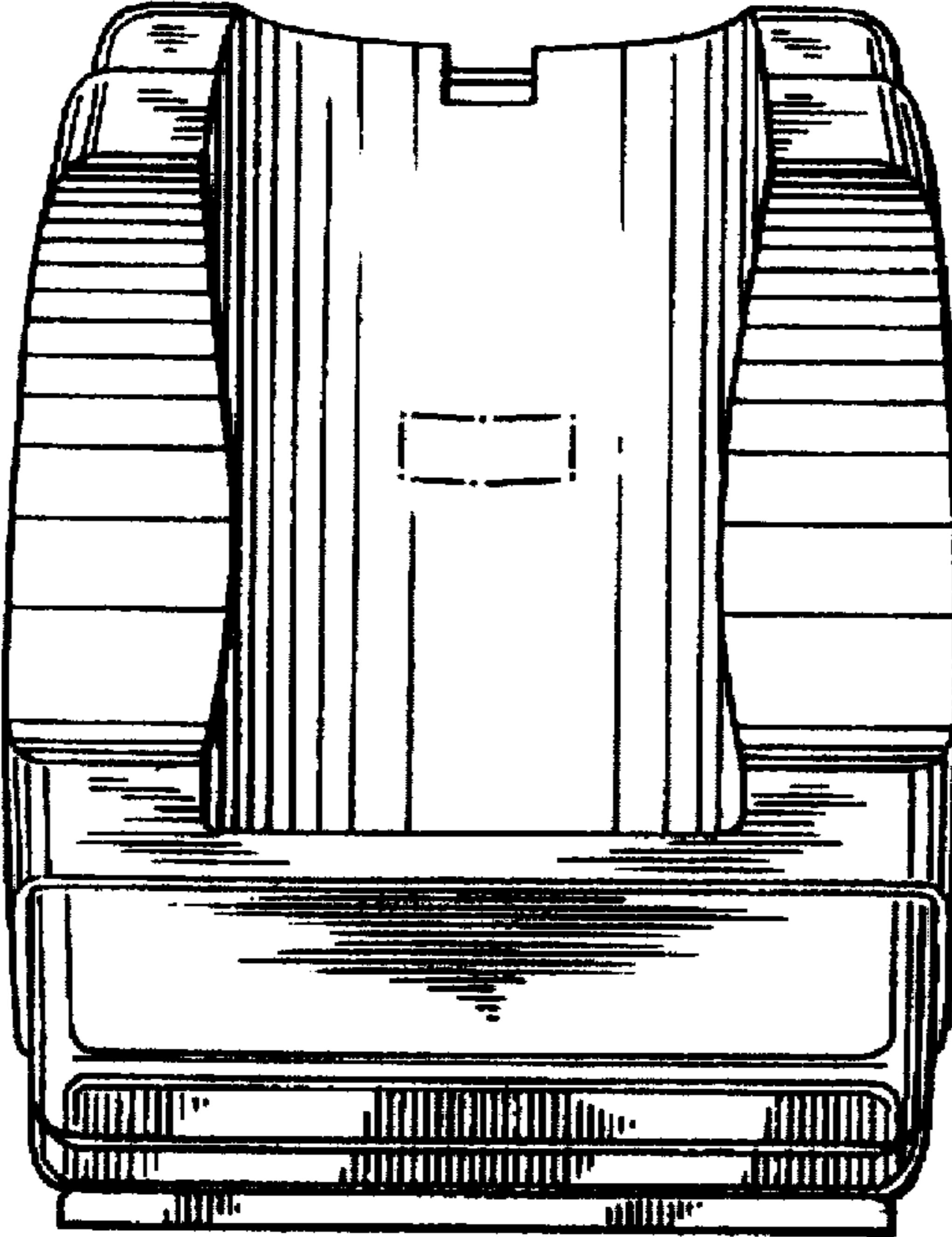

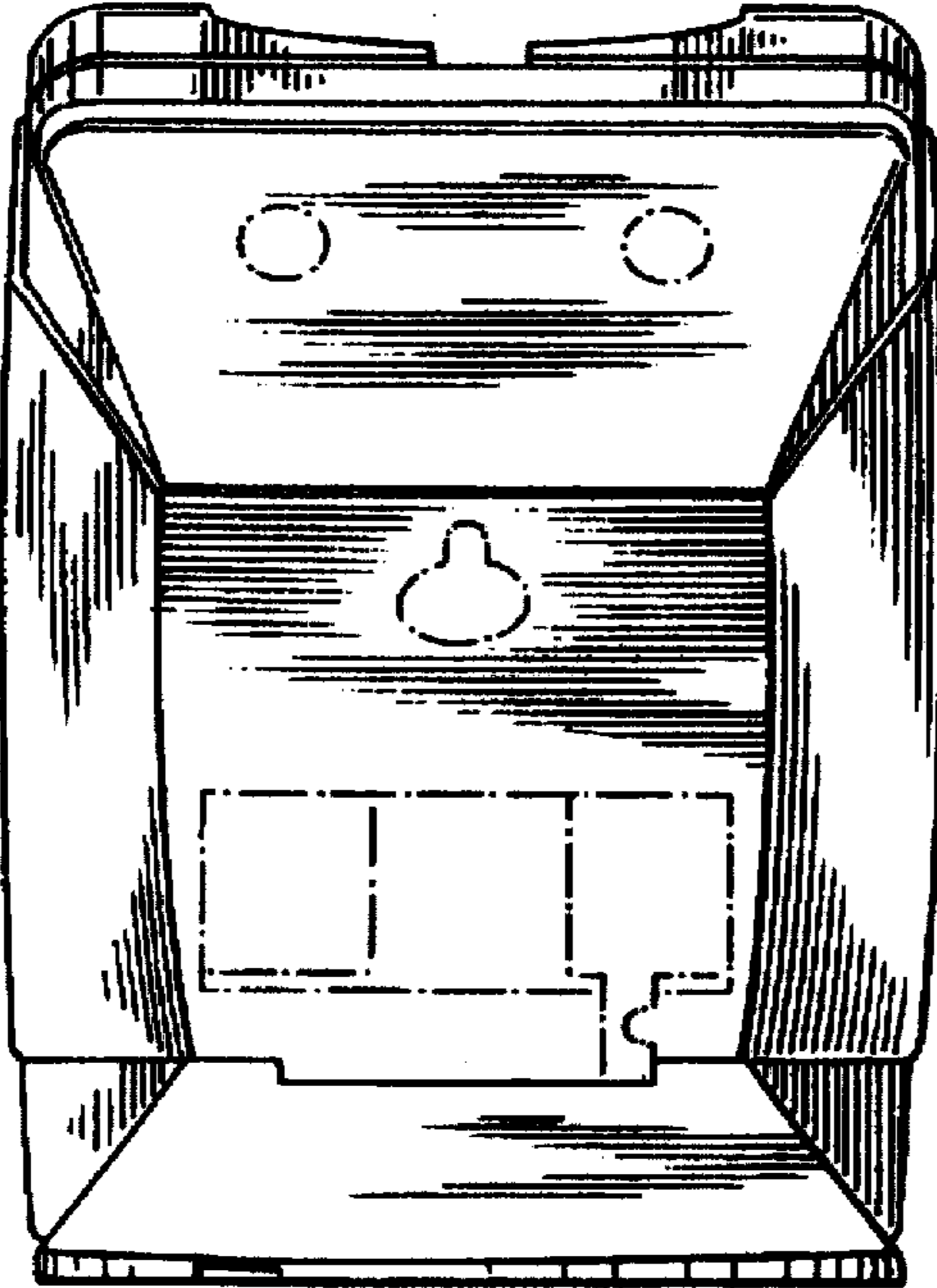

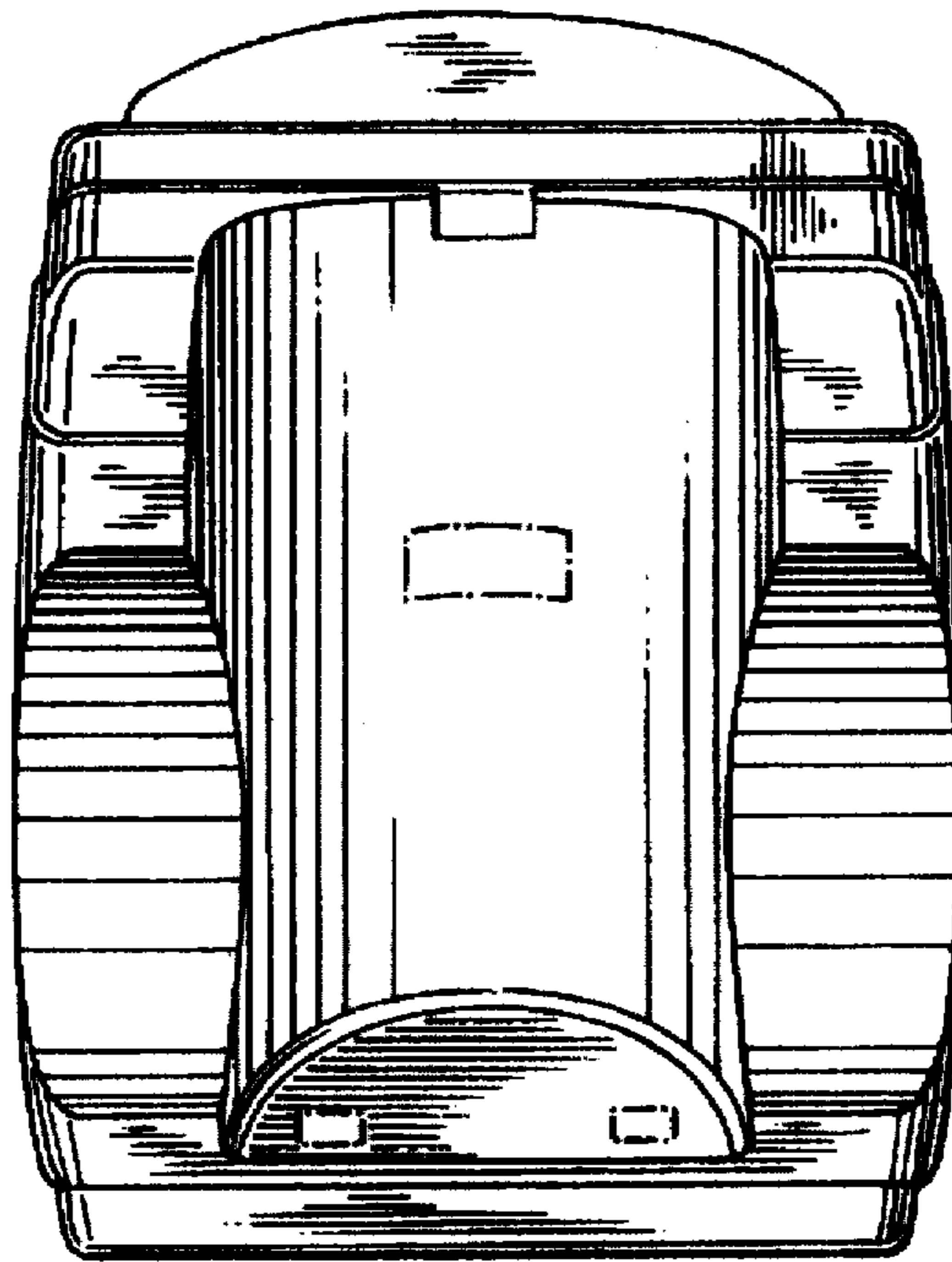

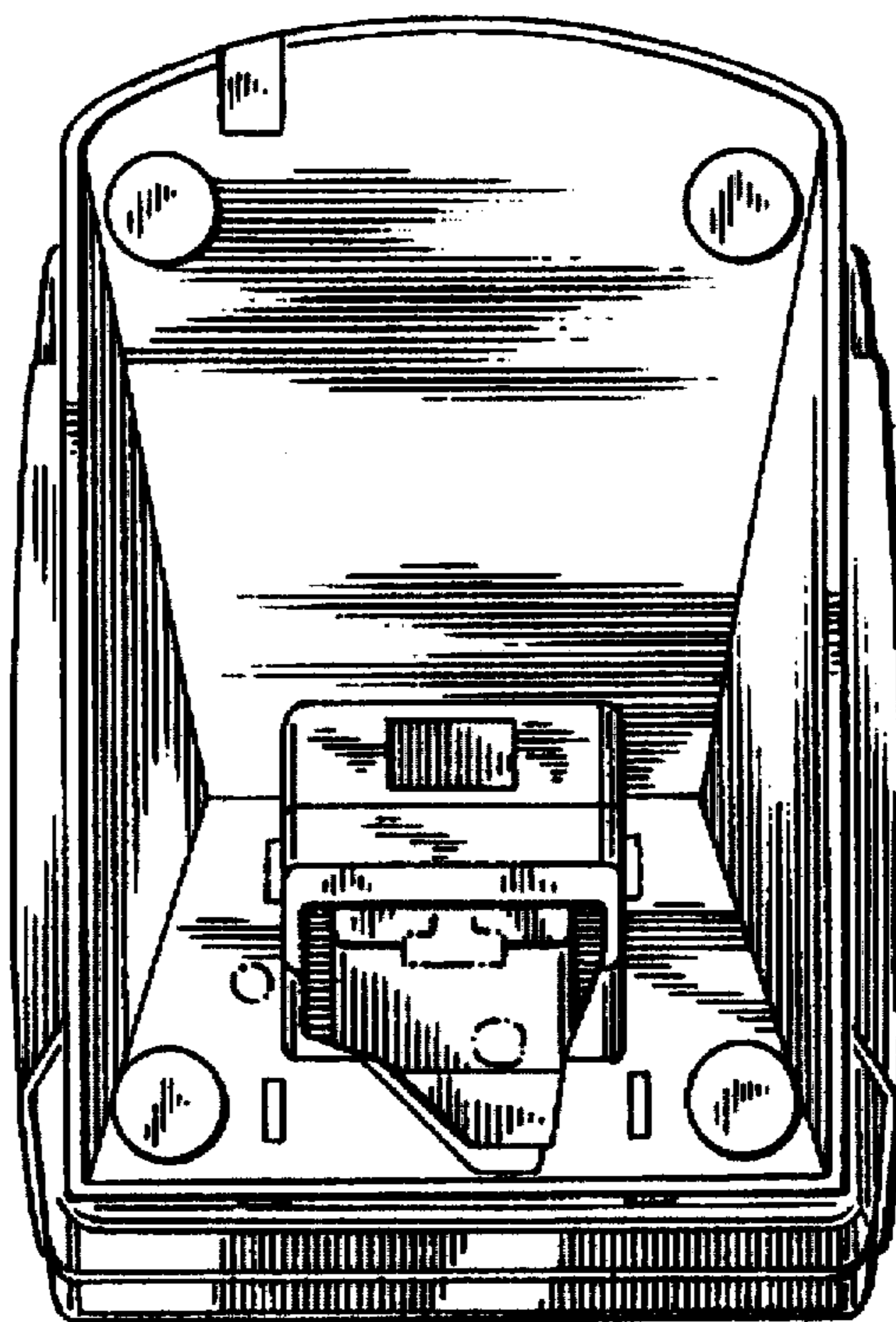

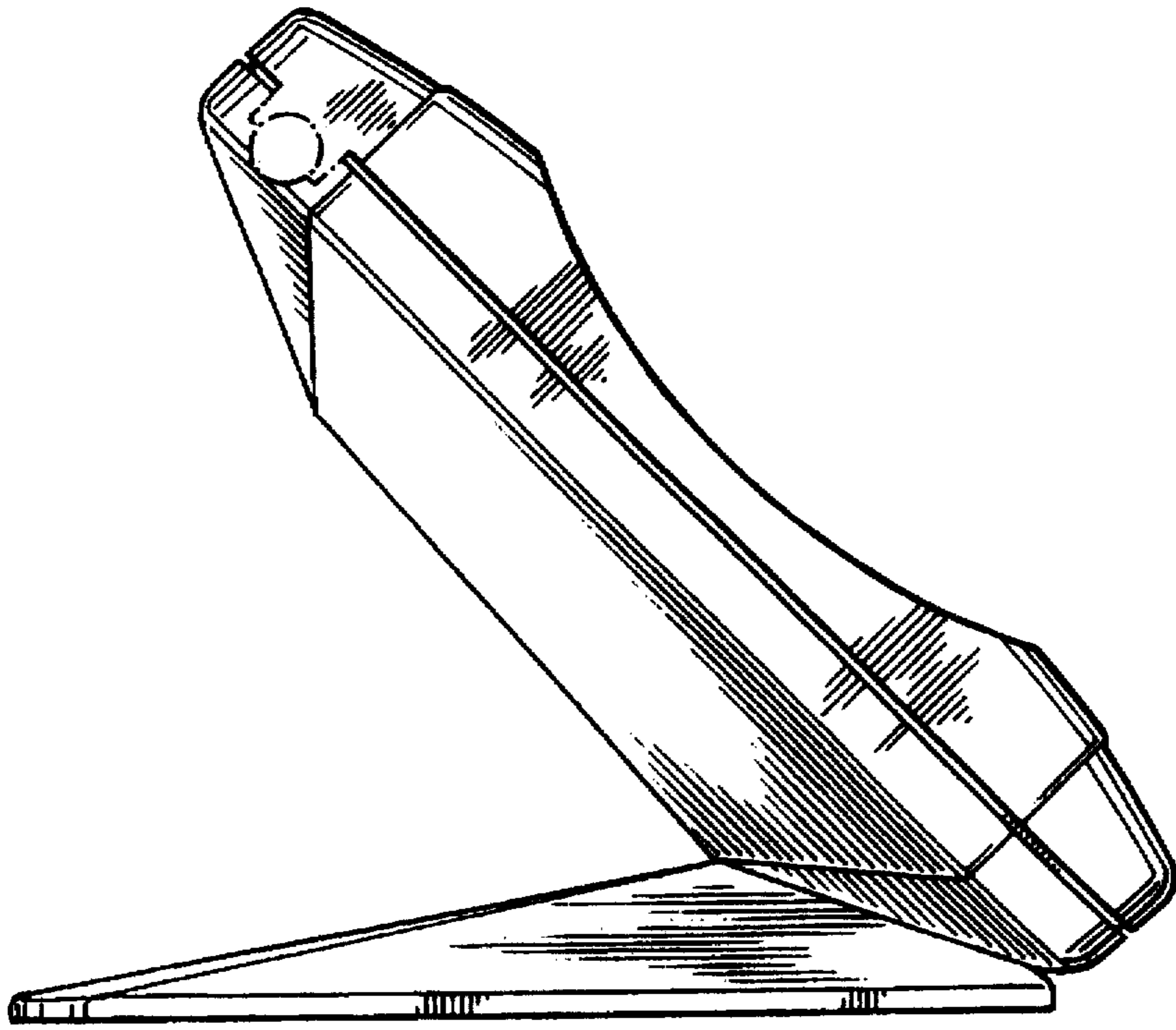

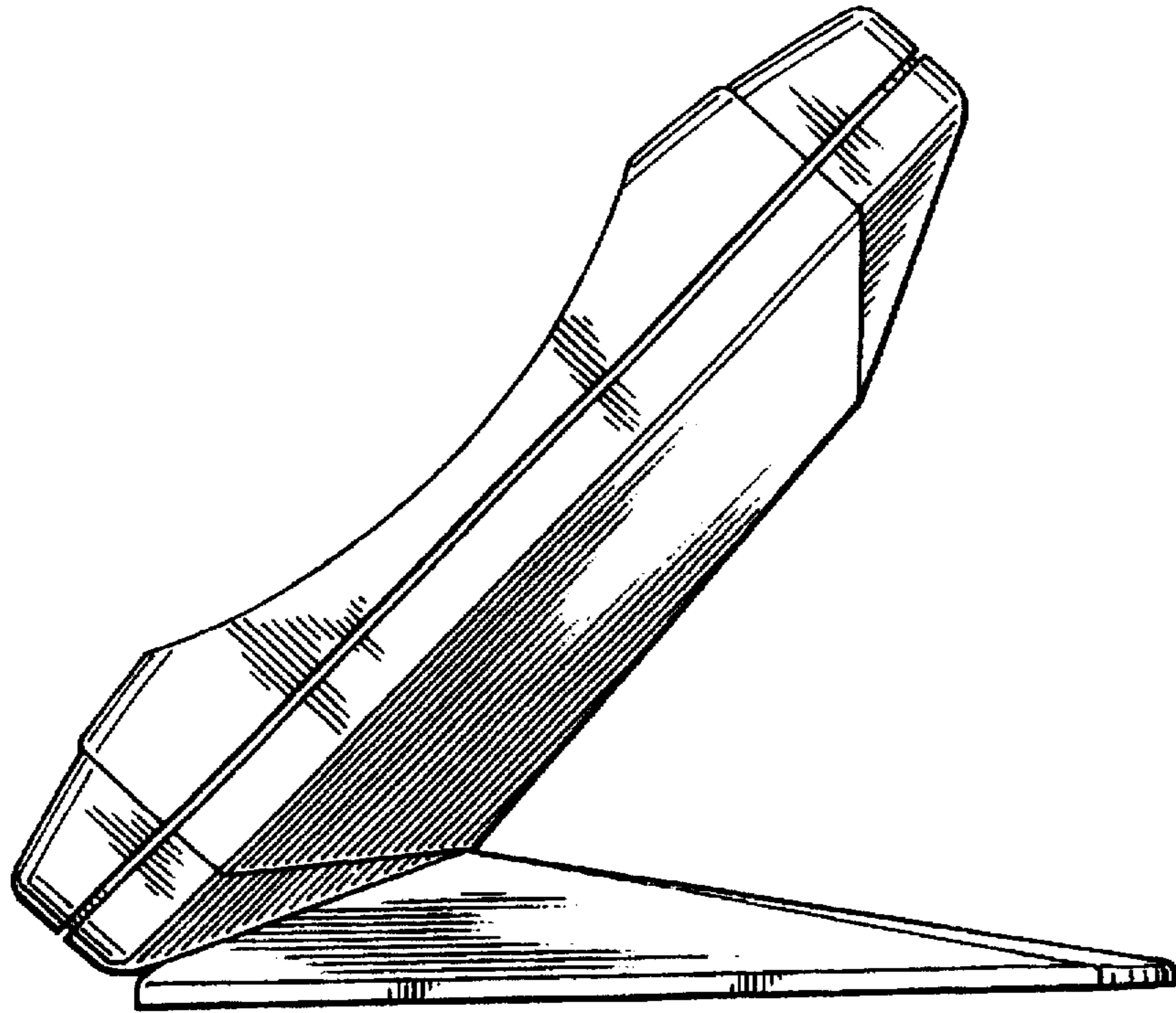

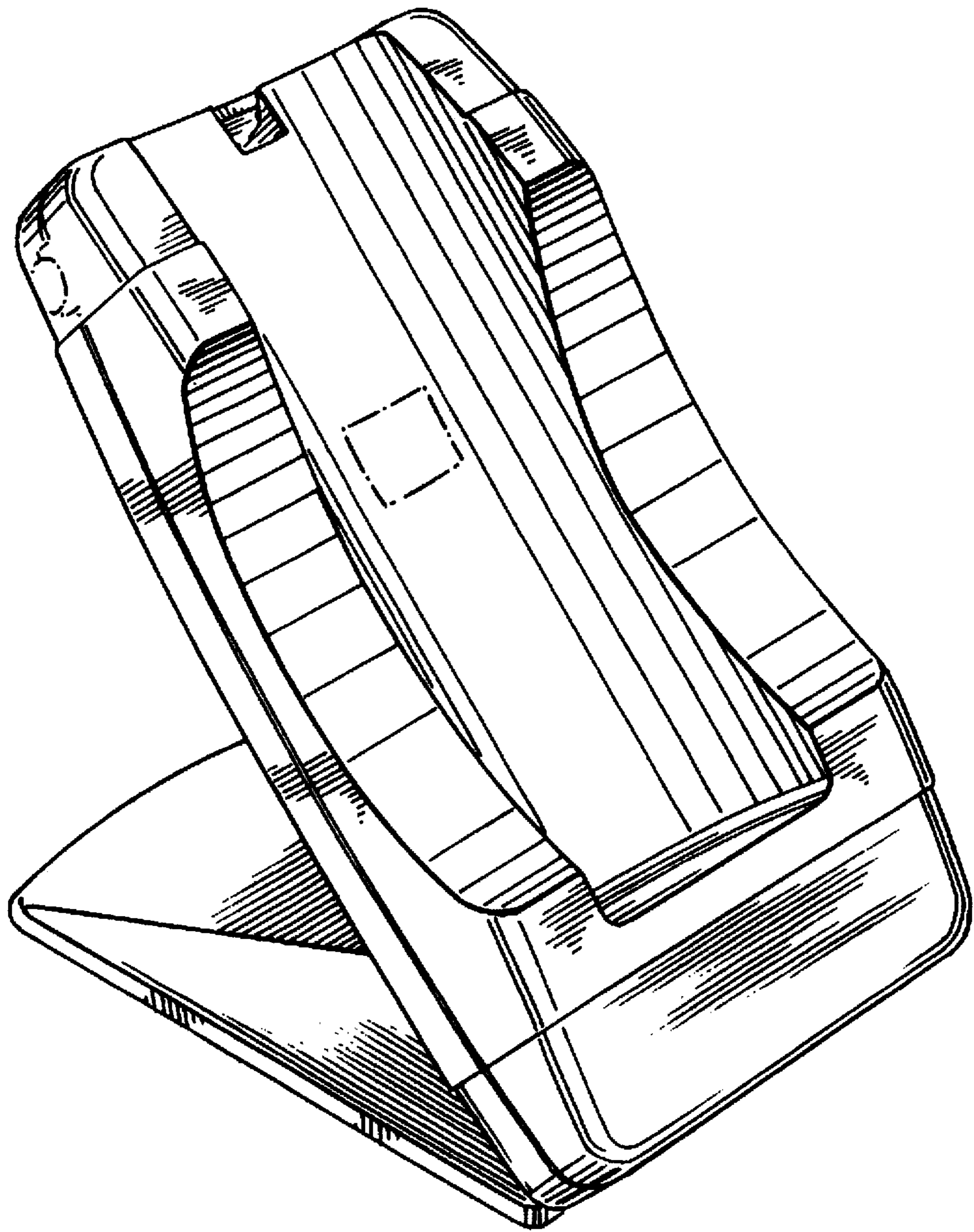
