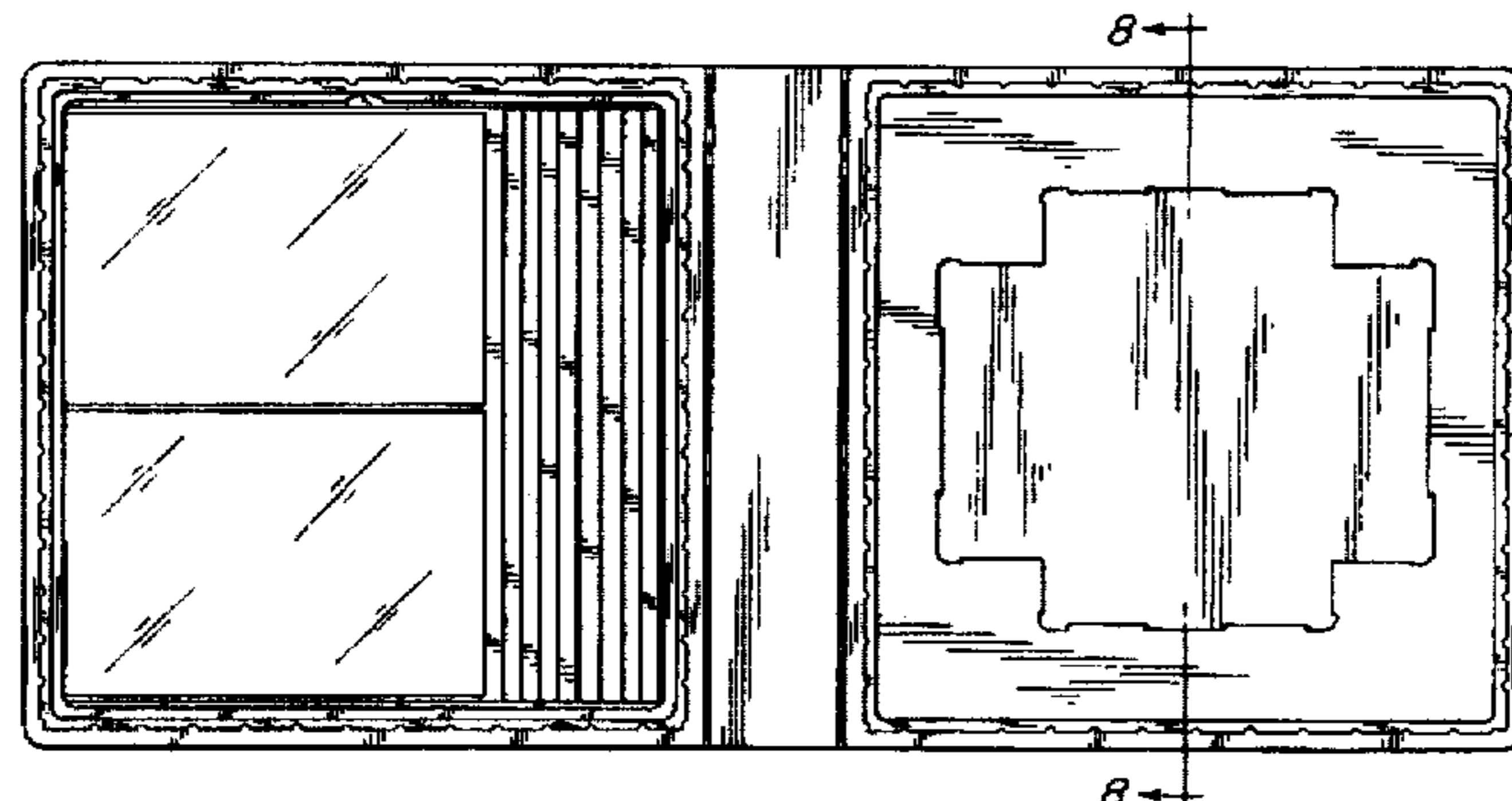
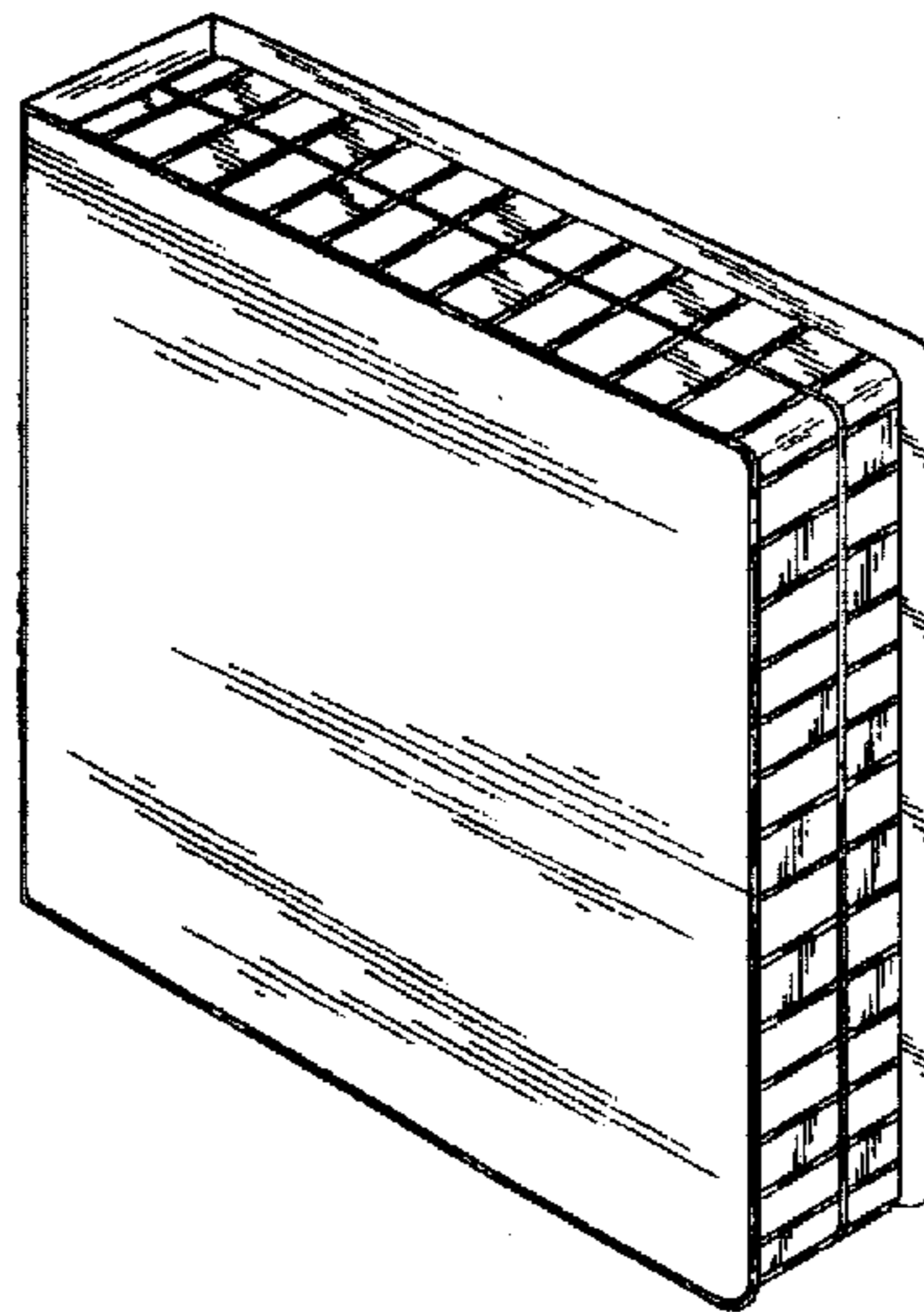
## [57] CLAIM

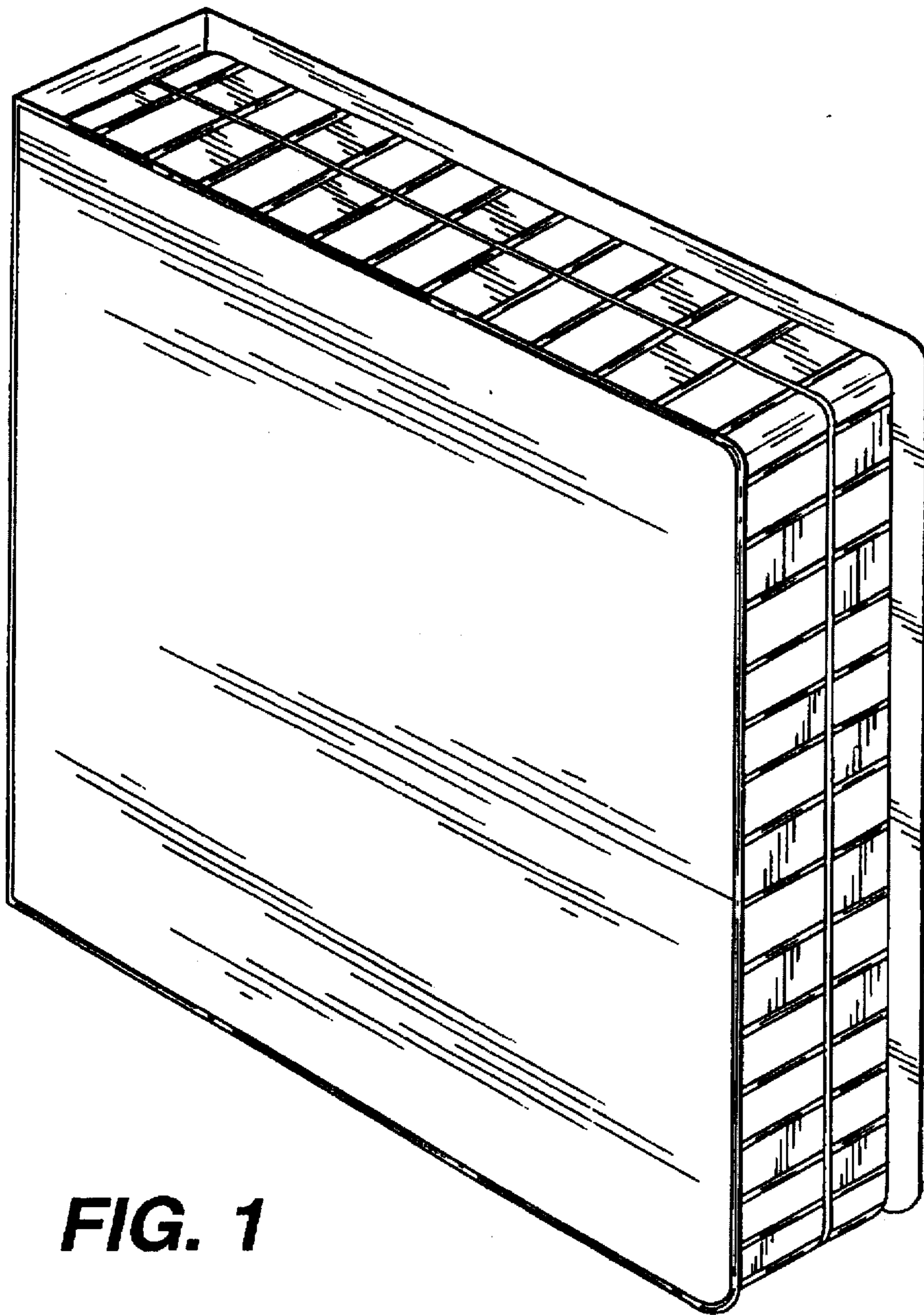
The ornamental design for a photo album and video cassette holder, as shown.

## DESCRIPTION

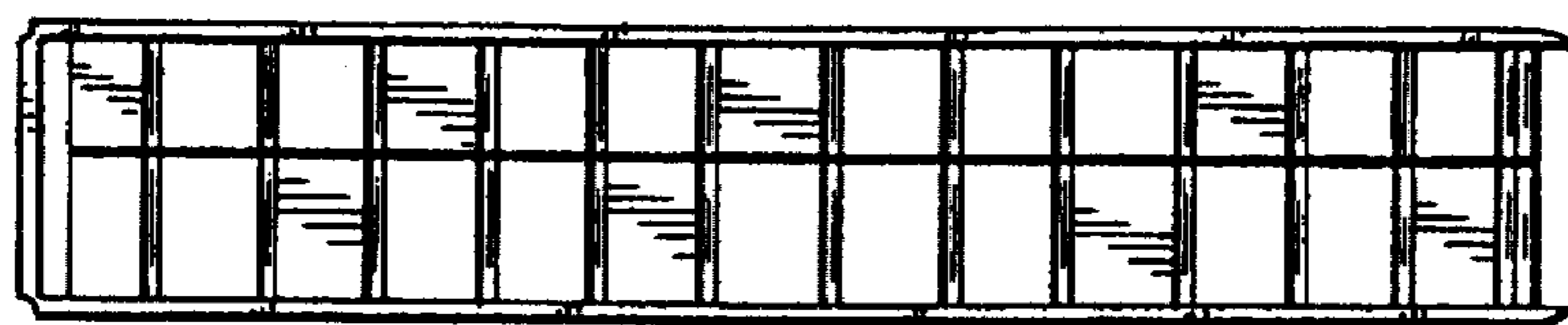
FIG. 1 is a perspective view of a photo album and video cassette holder showing my new design in a first mode of normal use; and,  
 FIG. 2 is a front elevational view thereof, the back being a mirror image; and,  
 FIG. 3 is a top plan view thereof the bottom being a mirror image; and,  
 FIG. 4 is a left side elevational view thereof; and,  
 FIG. 5 is a right side elevational view thereof; and,  
 FIG. 6 is a front elevational view of a photo album and video cassette holder showing my new design in a second mode of normal use; and,  
 FIG. 7 is a front elevational view of a photo album and video cassette holder showing my new design in a third mode of normal use;  
 FIG. 8 is a cross-sectional view showing the depth of my new design, taken along the sectional line 8—8 in FIG. 6, no claim is being made to that portion of the device concealed during normal use;  
 FIG. 9 is a partial cross-sectional view showing the depth of my new design, taken along the sectional line 9—9 in FIG. 7, no claim is being made to that portion of the device concealed during normal use.

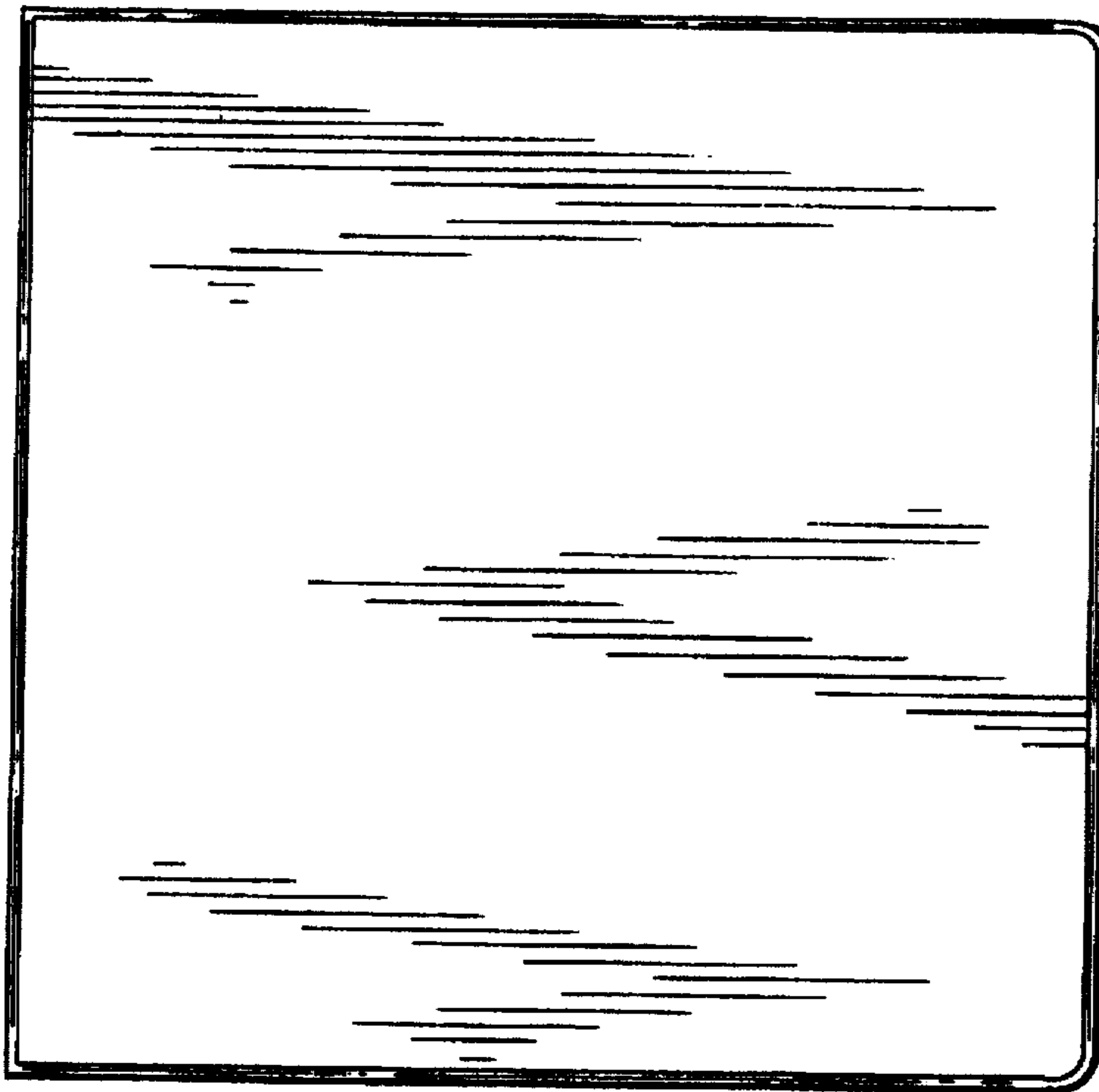




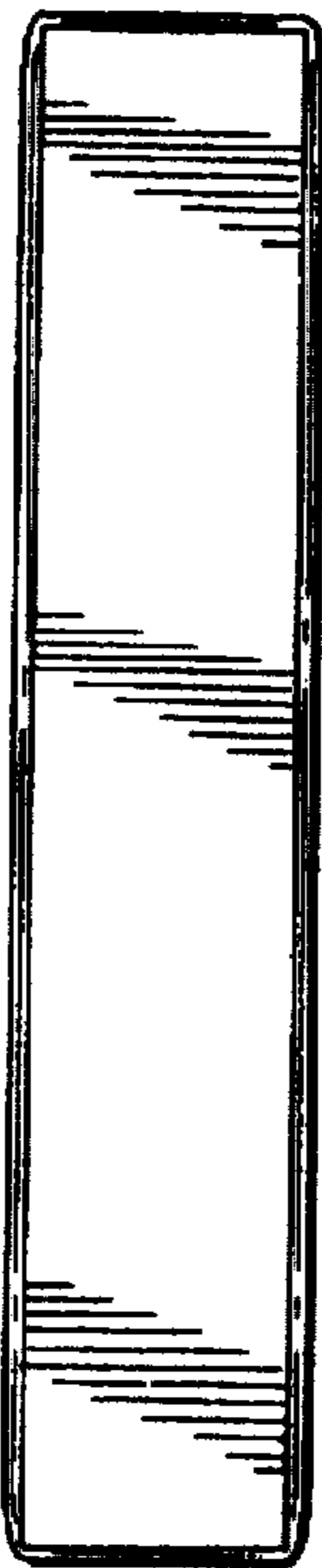

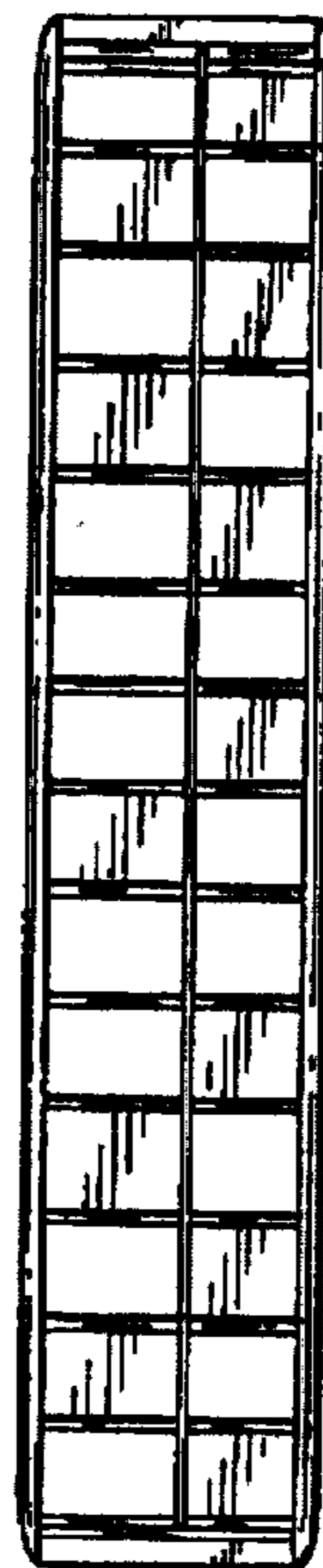

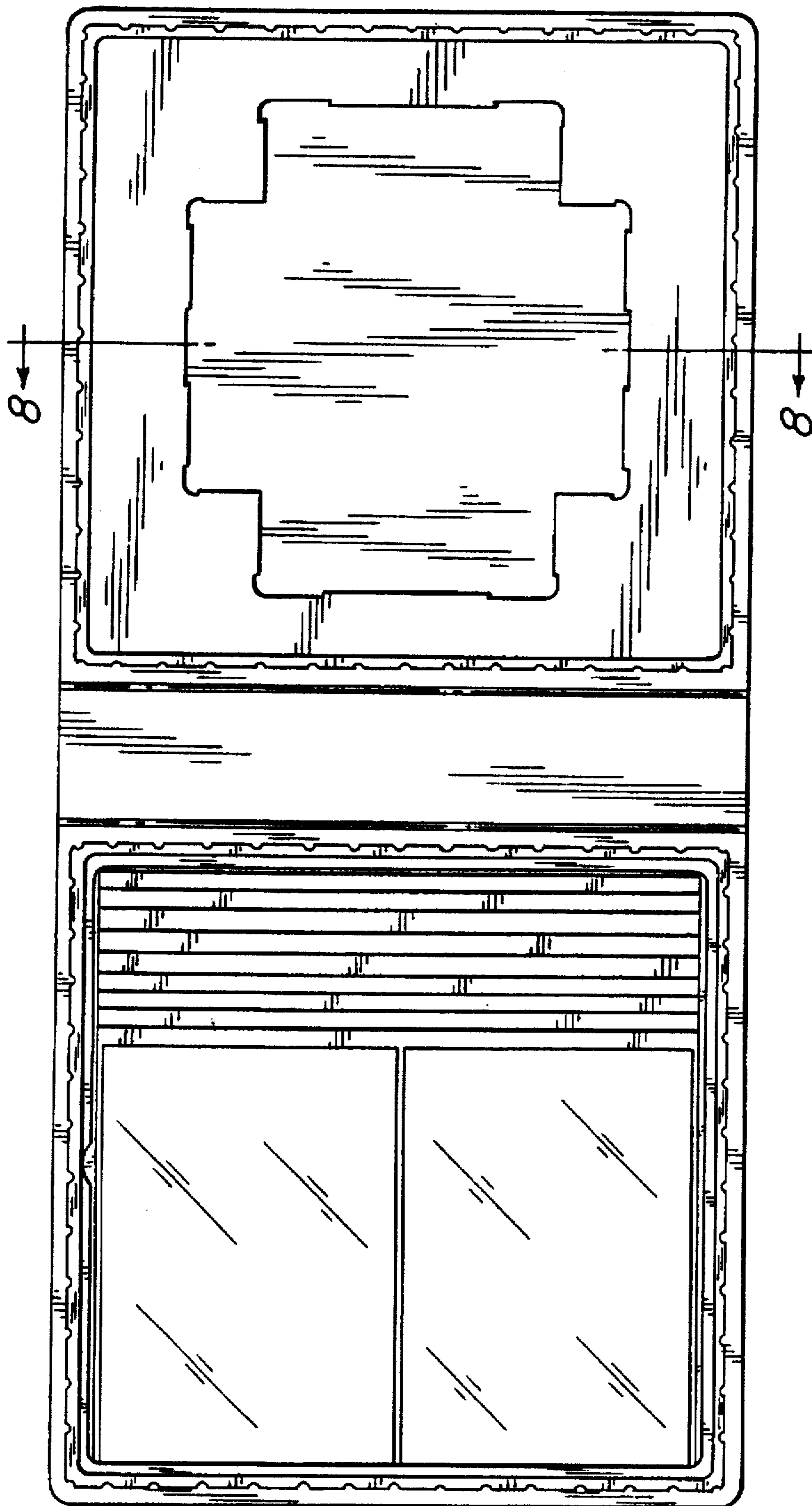

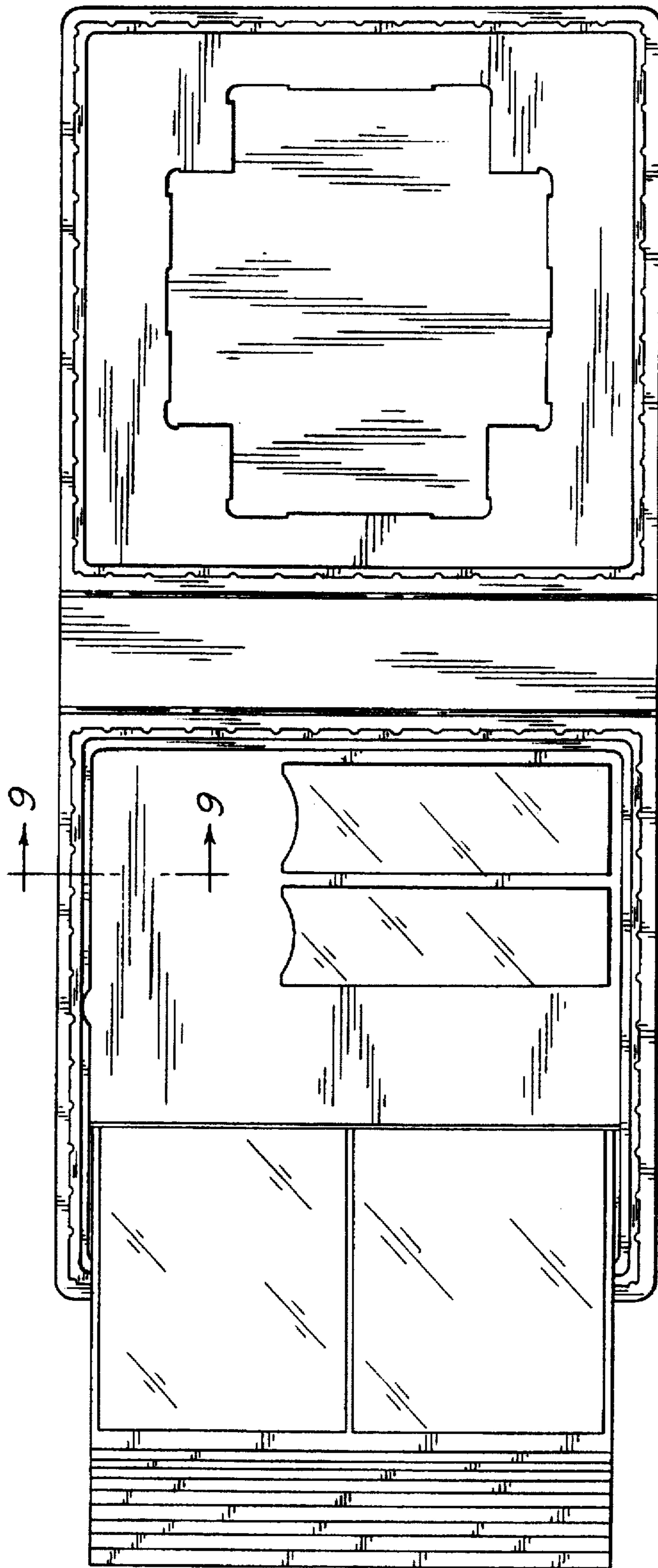
