FIG. 8 is a rear elevational view of FIG. 1.

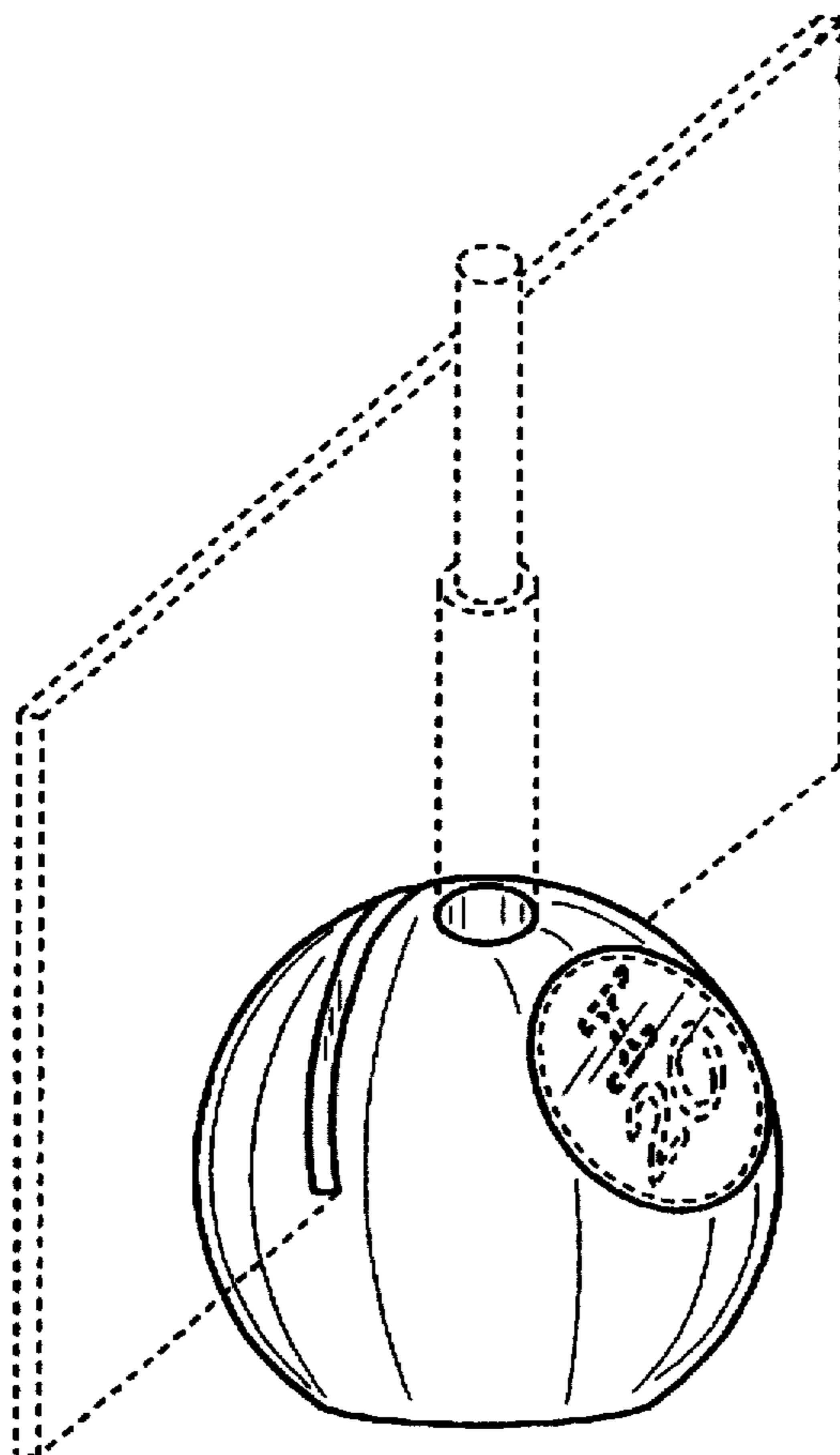

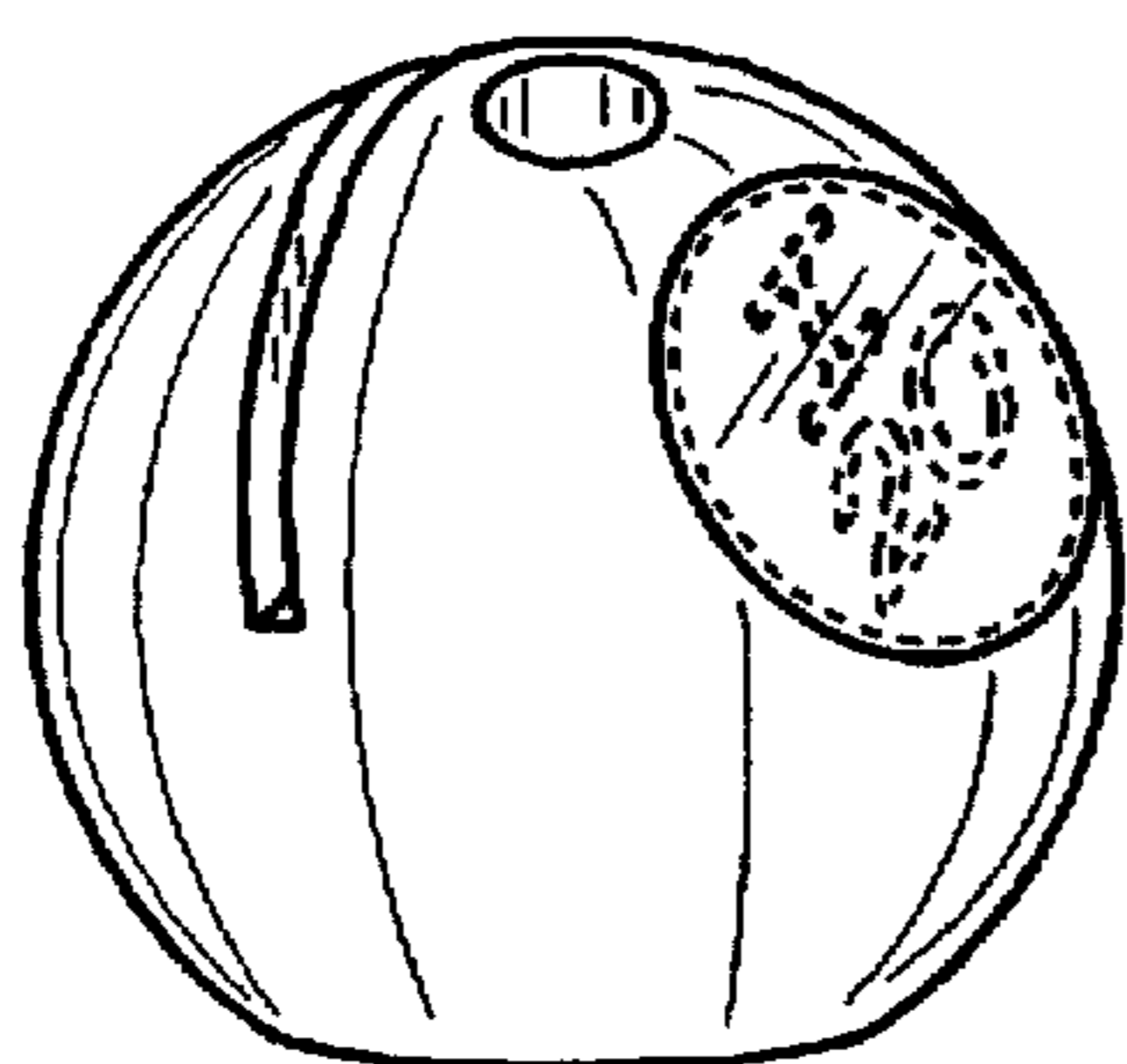

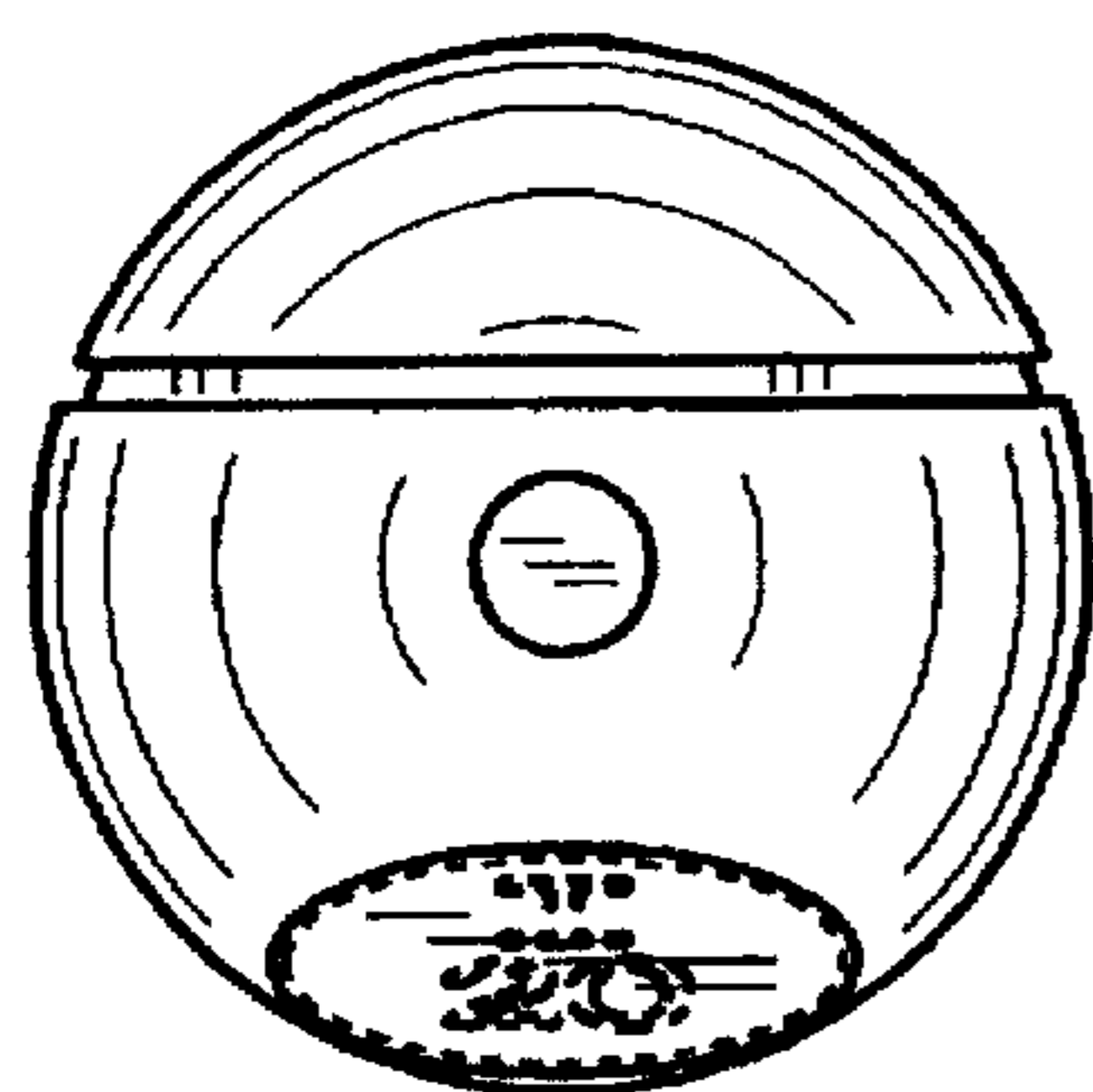

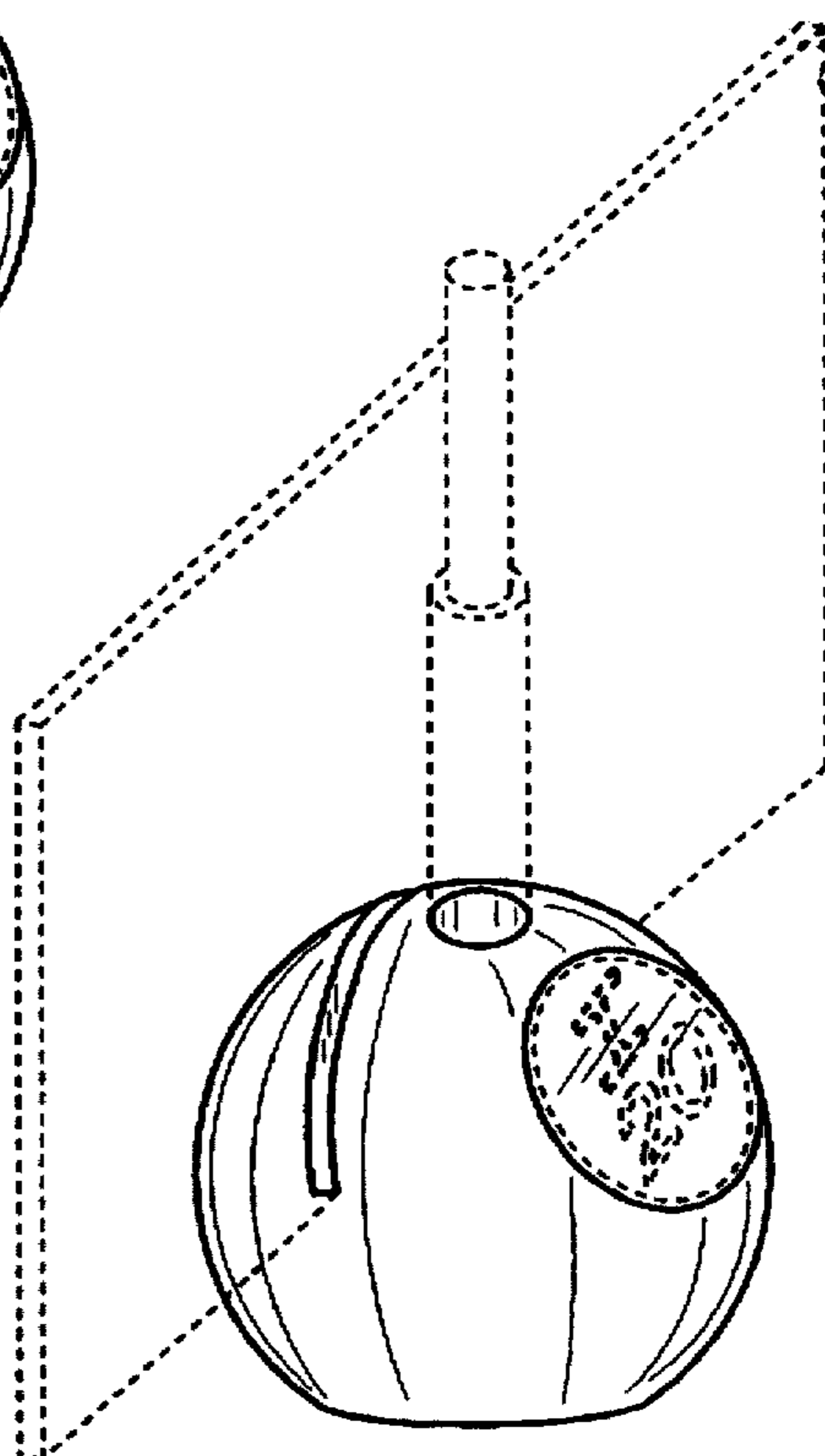

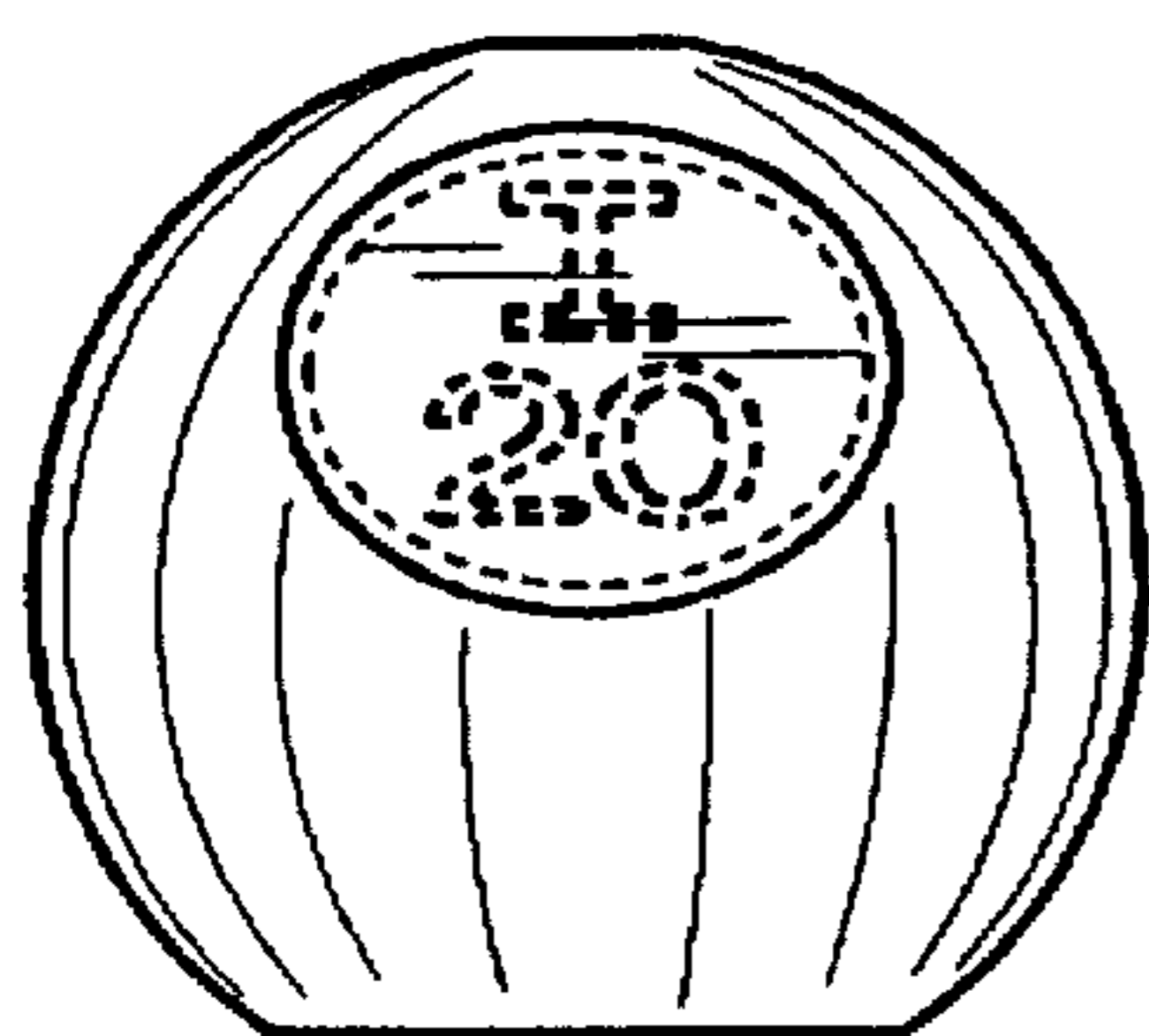

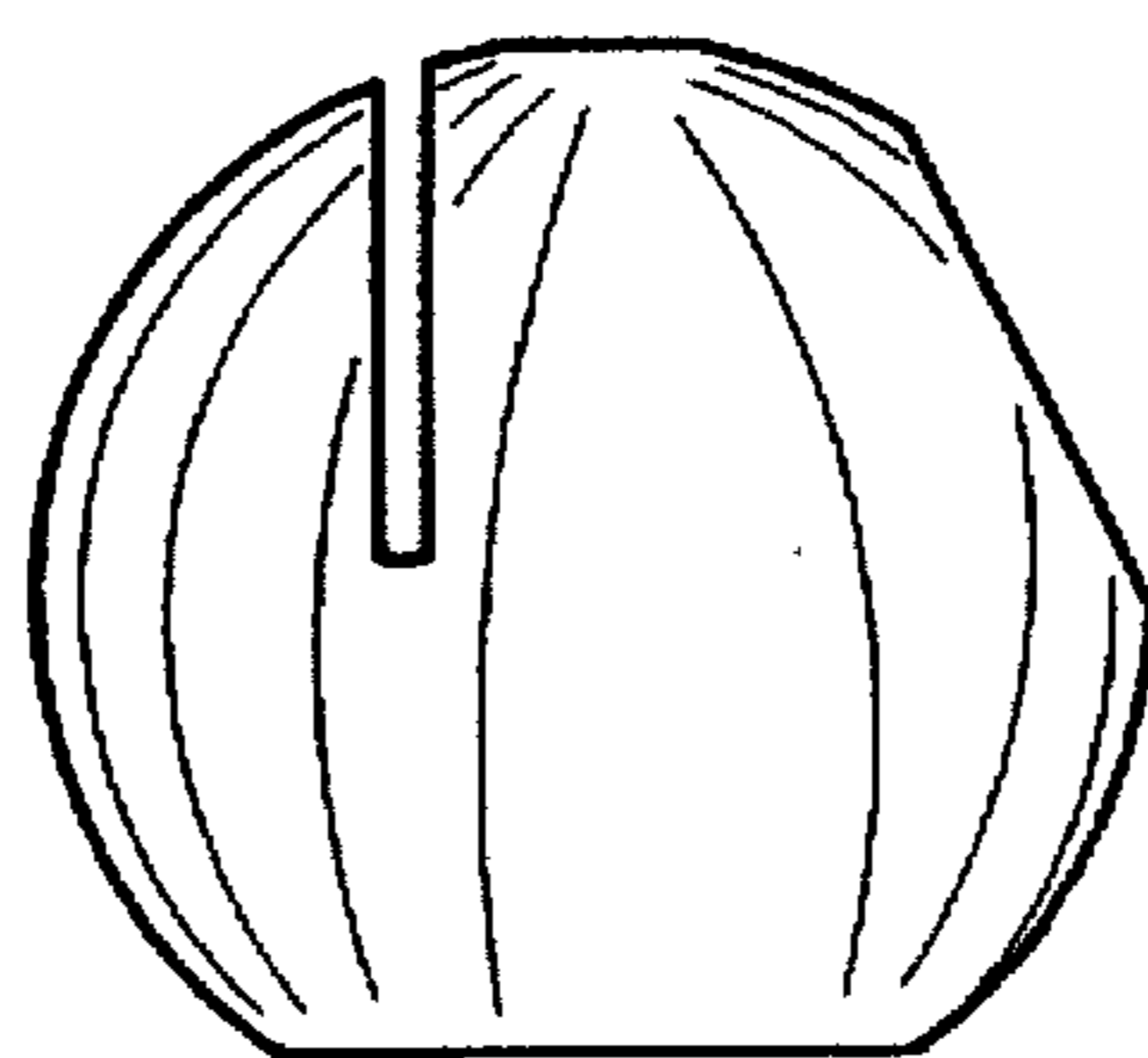

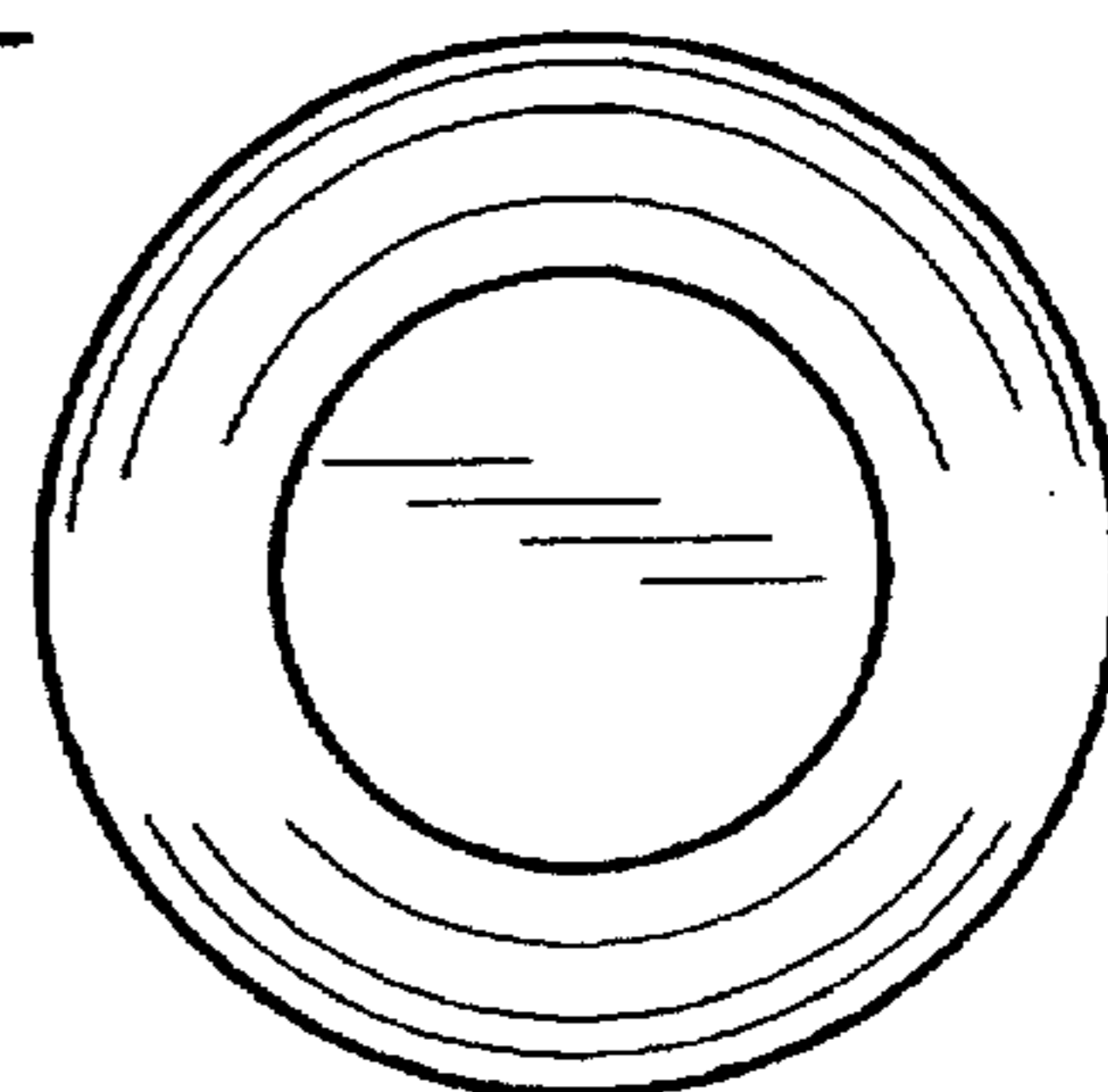

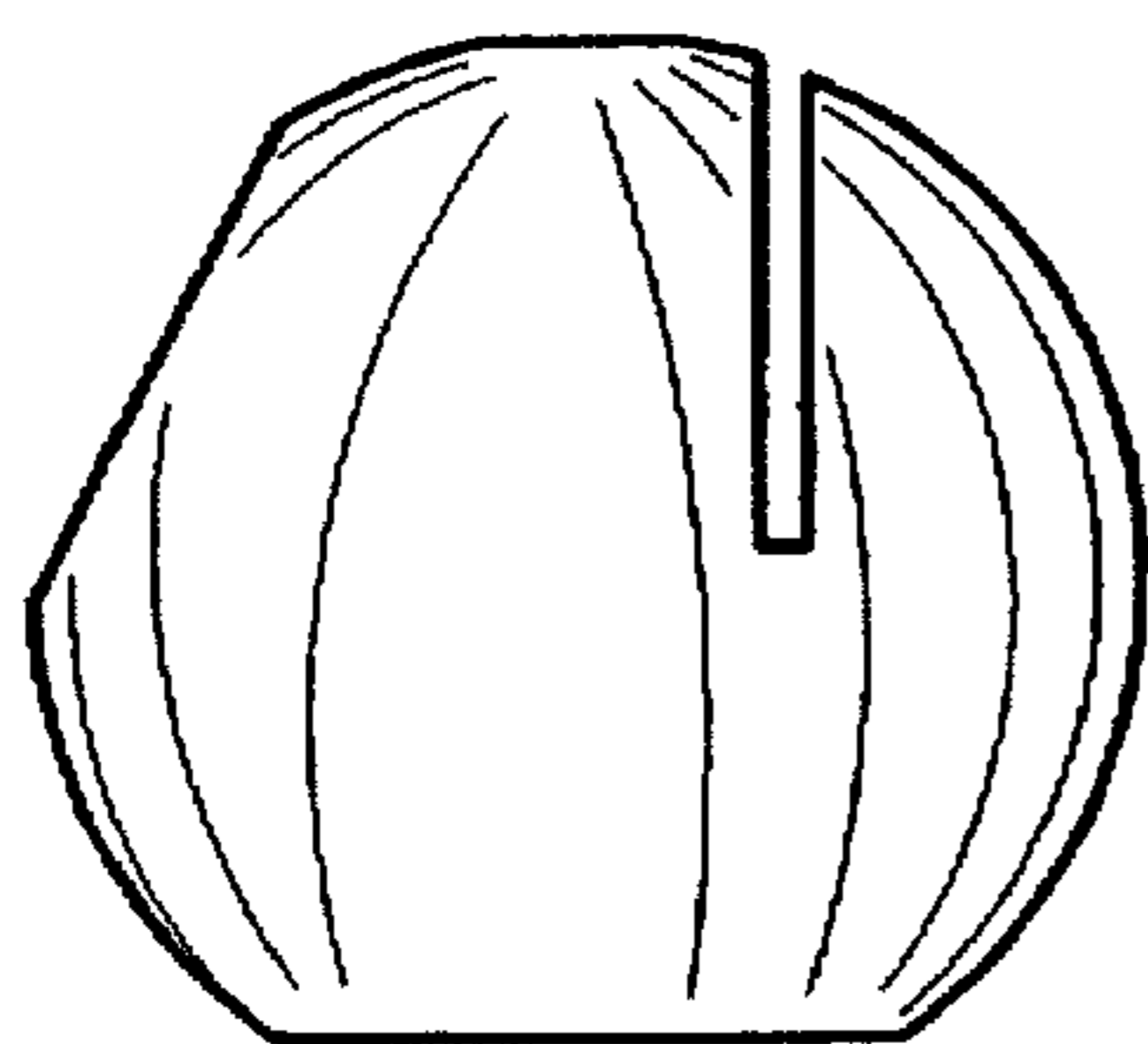

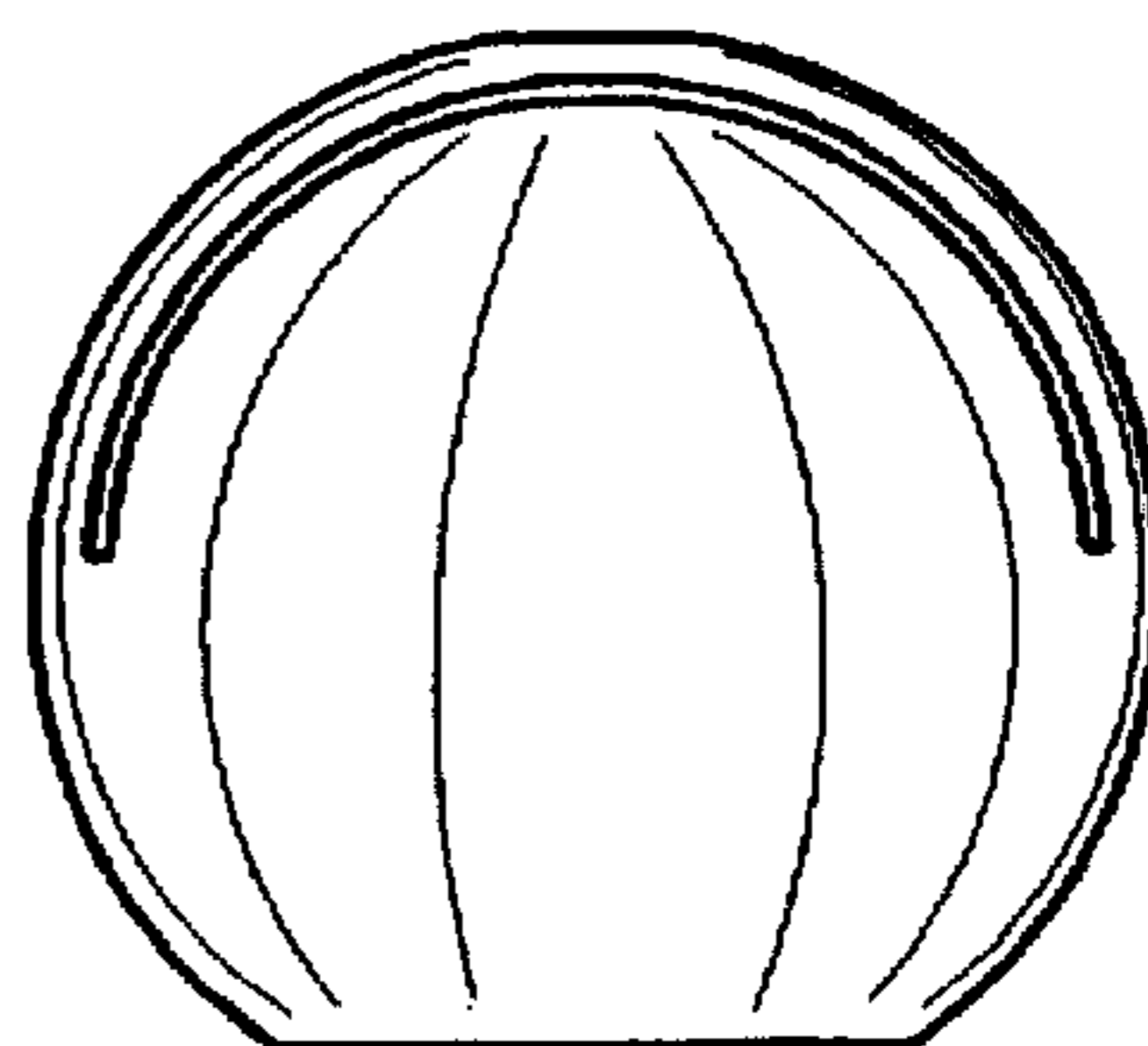
