[57] CLAIM

The ornamental design for an air treatment unit with removable feet therefor, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the air treatment unit with

removable feet therefor embodying the new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a left side elevational view thereof, the right side elevational view being the mirror image thereof;

FIG. 7 is a perspective view of the body portion of the air treatment unit with removable feet therefor, shown separately with the feet removed for clarity of illustration;

FIG. 8 is a top plan view of the body portion of the air treatment unit with removable feet therefor, shown separately with the feet removed for clarity of illustration;

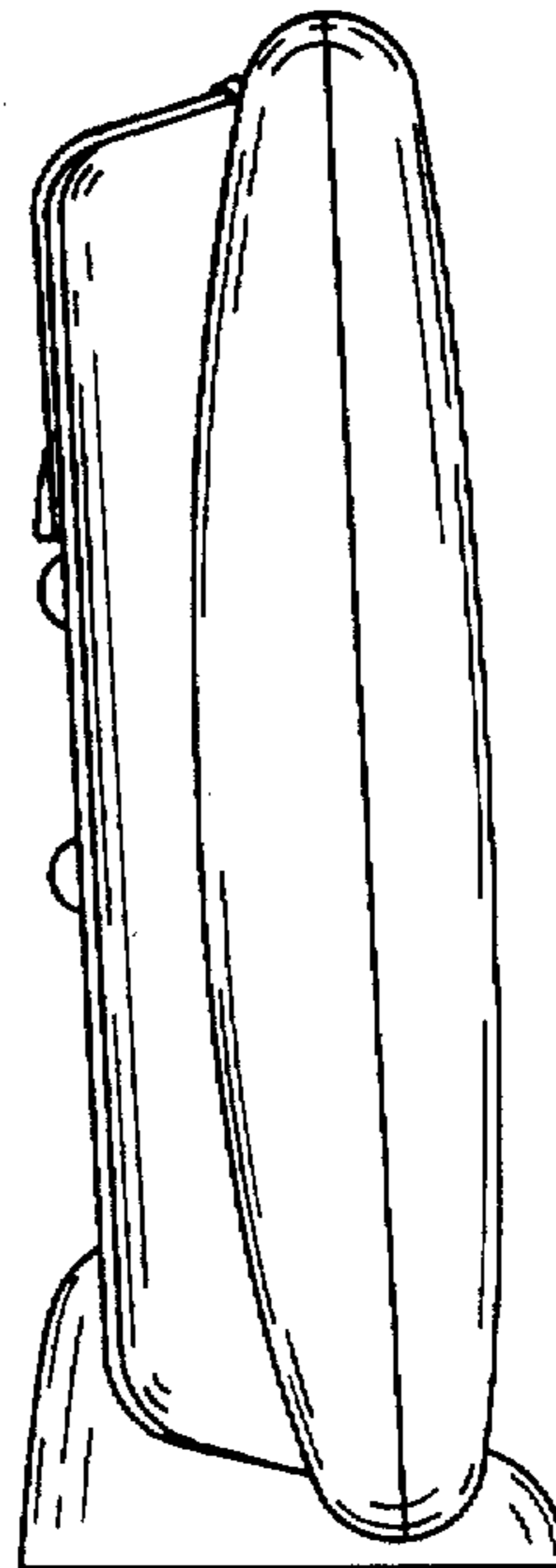
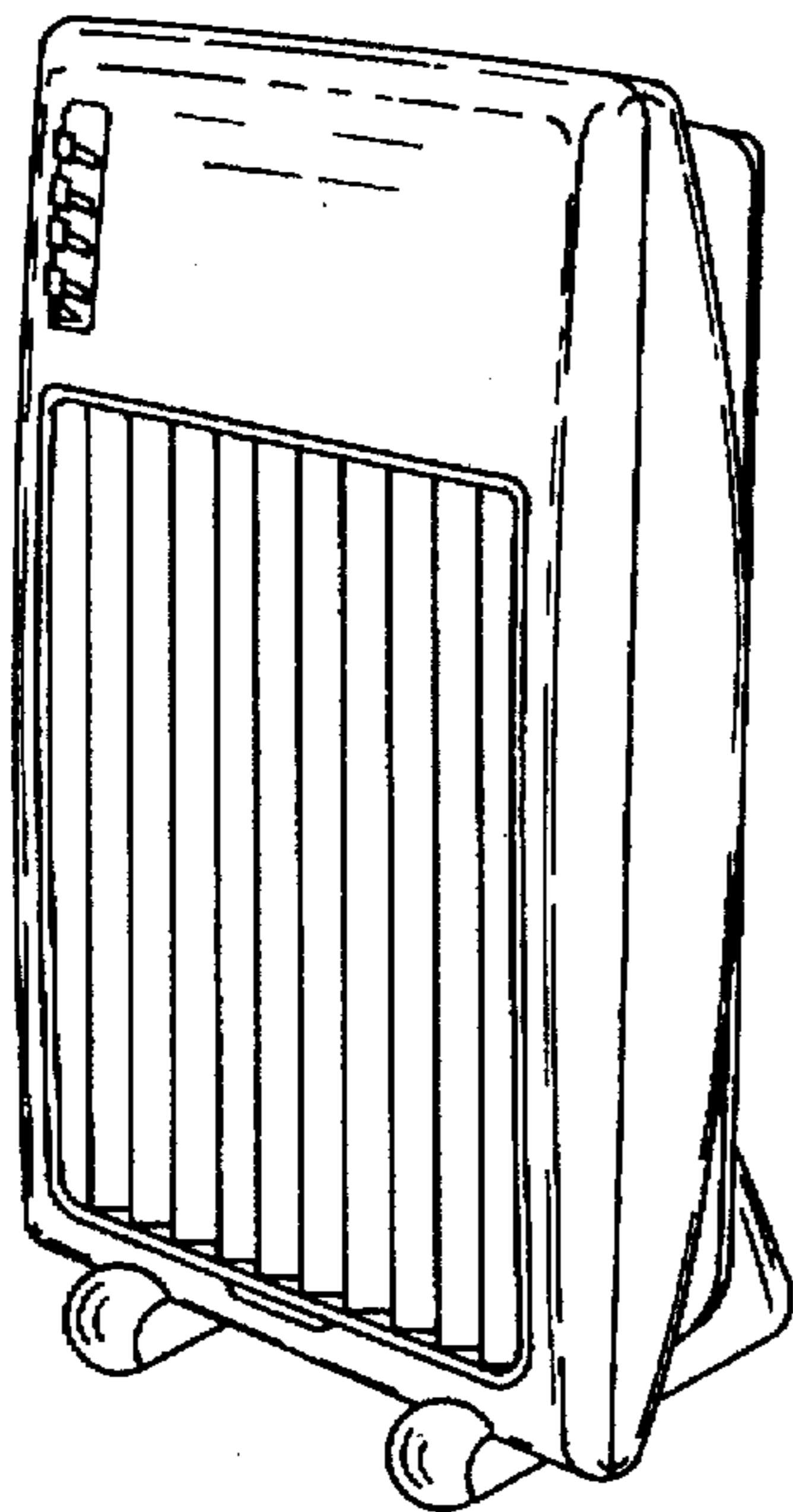
FIG. 9 is a bottom plan view of the body portion of the air treatment unit with removable feet therefor, shown separately with the feet removed for clarity of illustration;

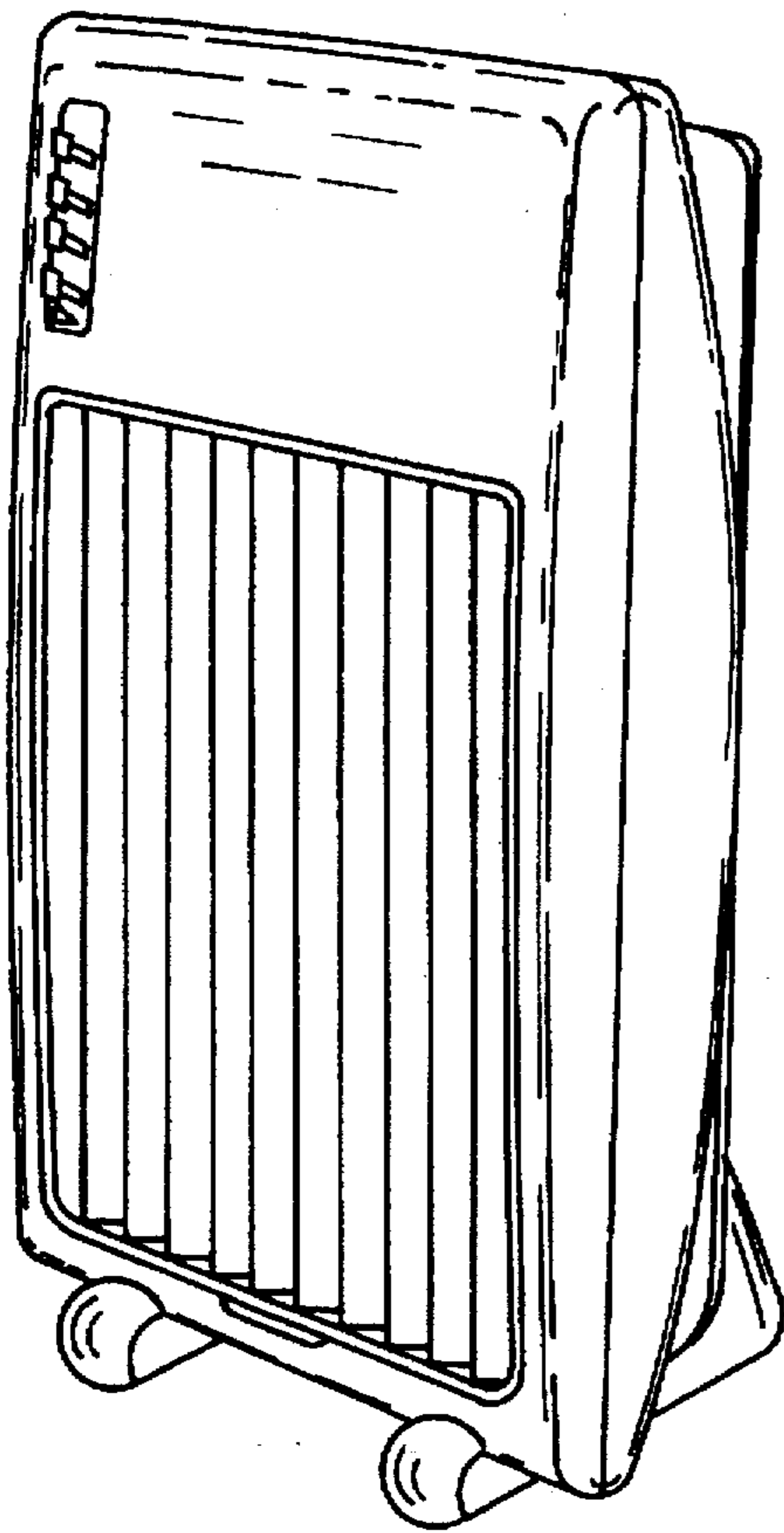

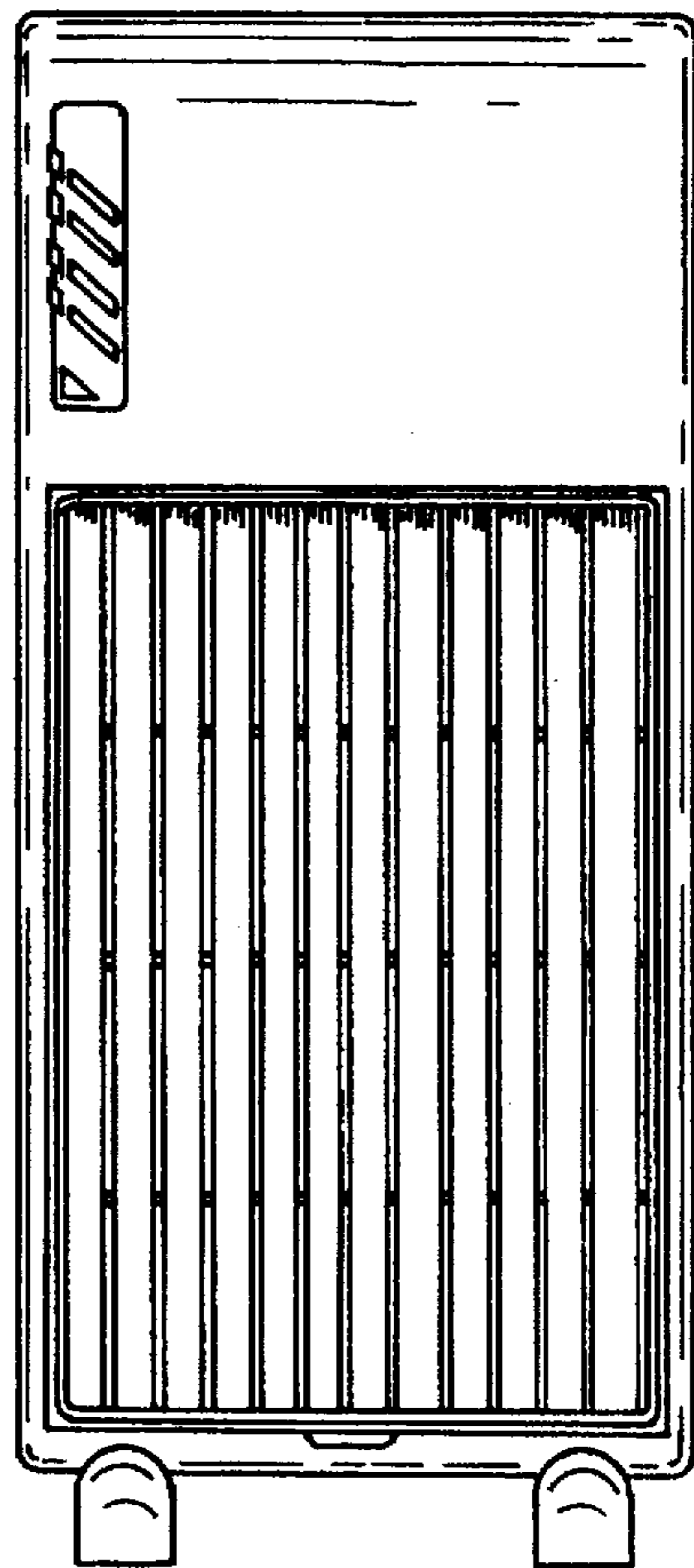

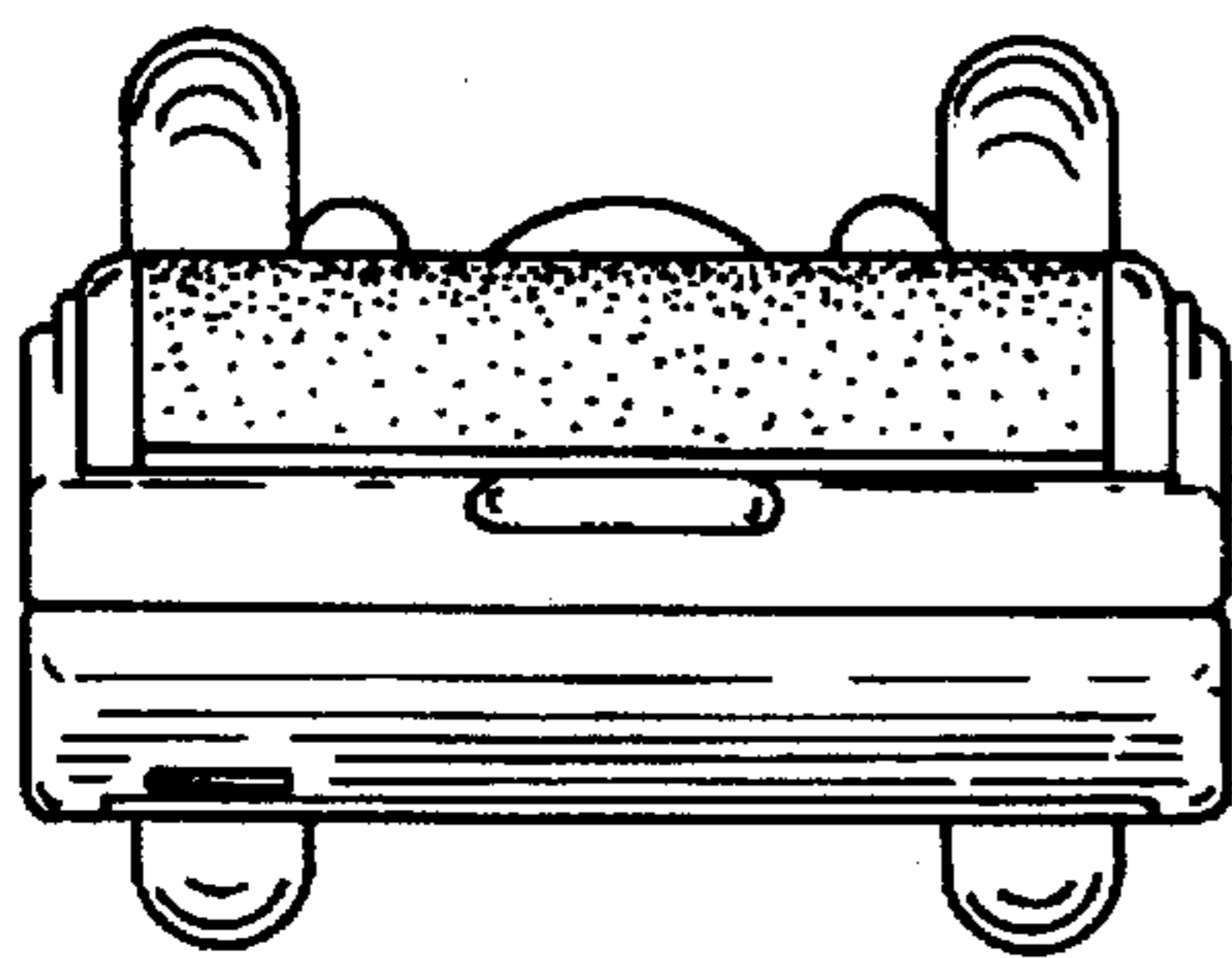

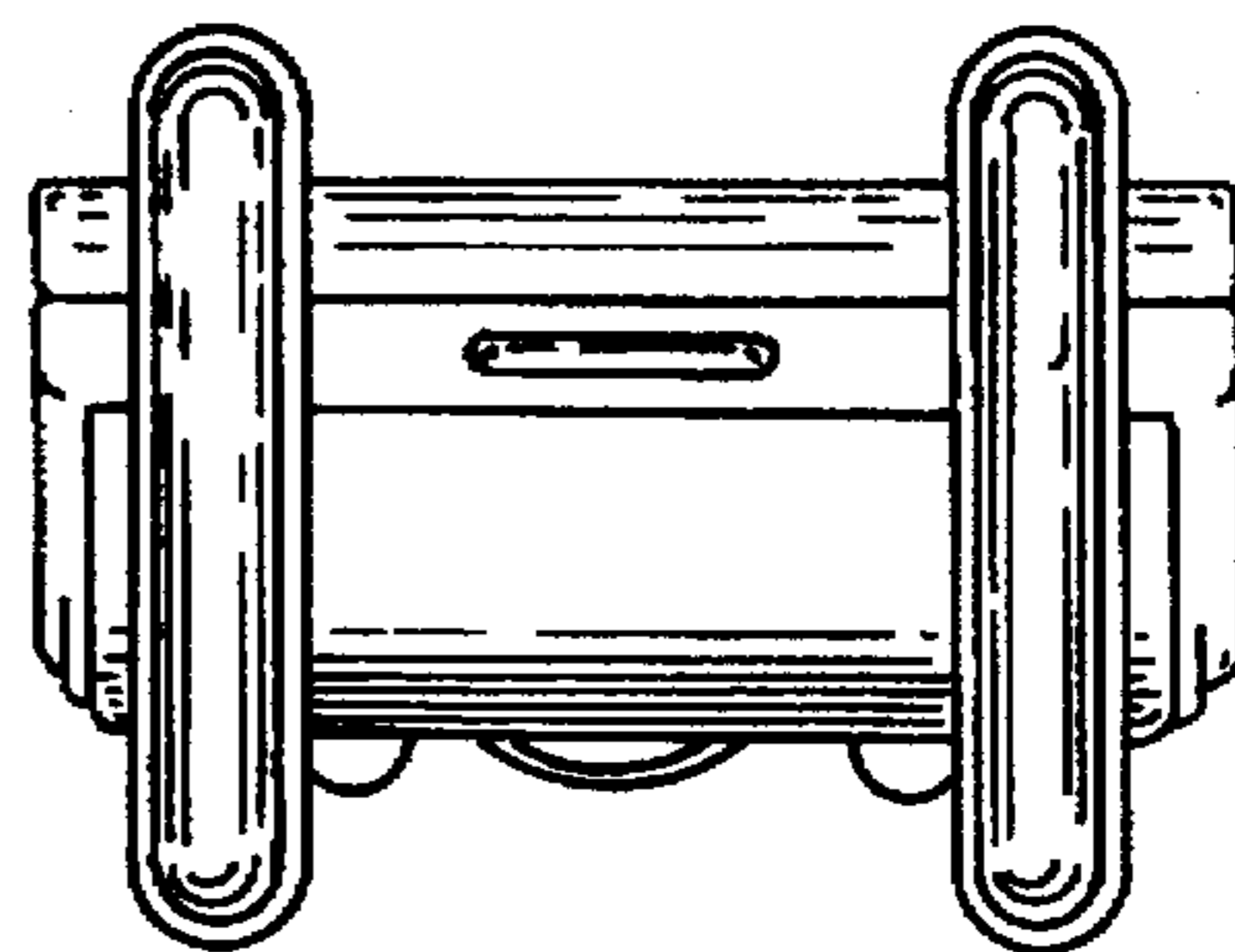

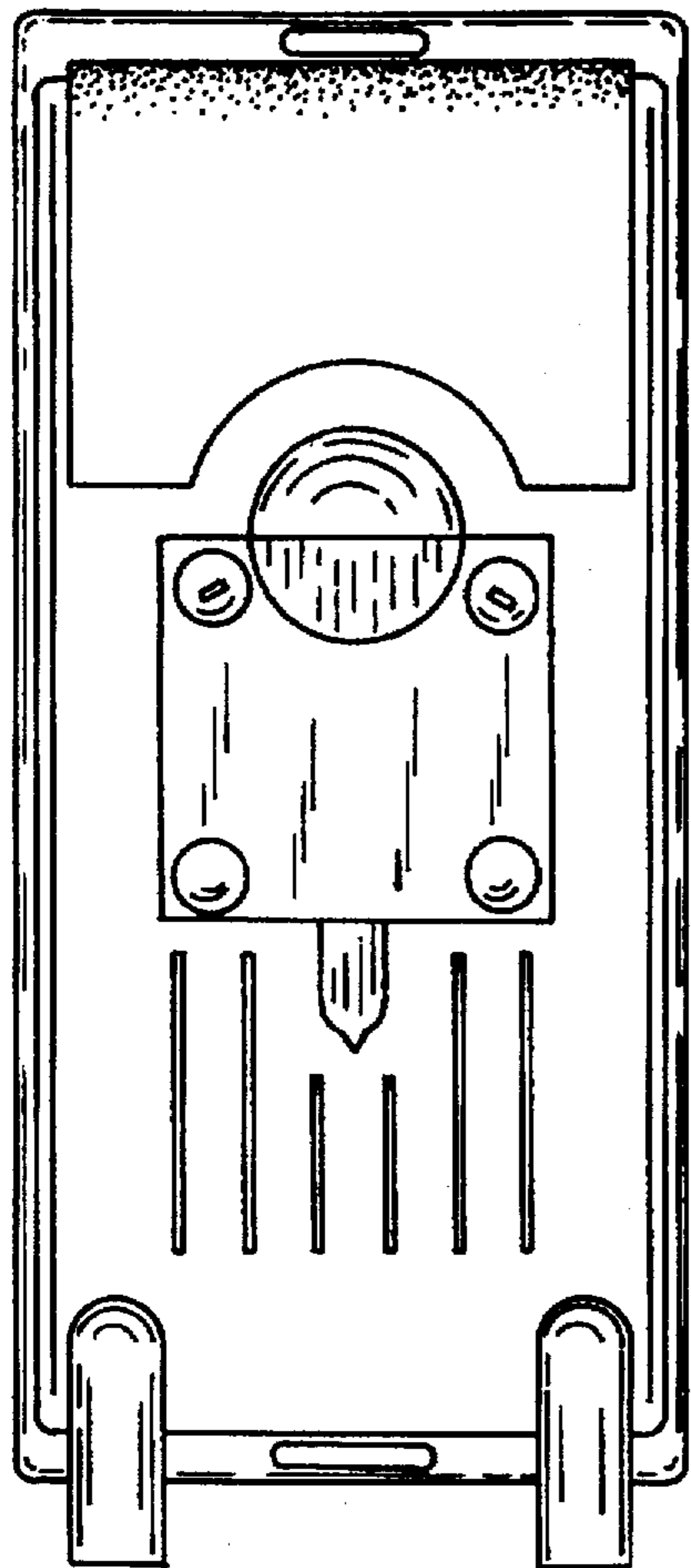

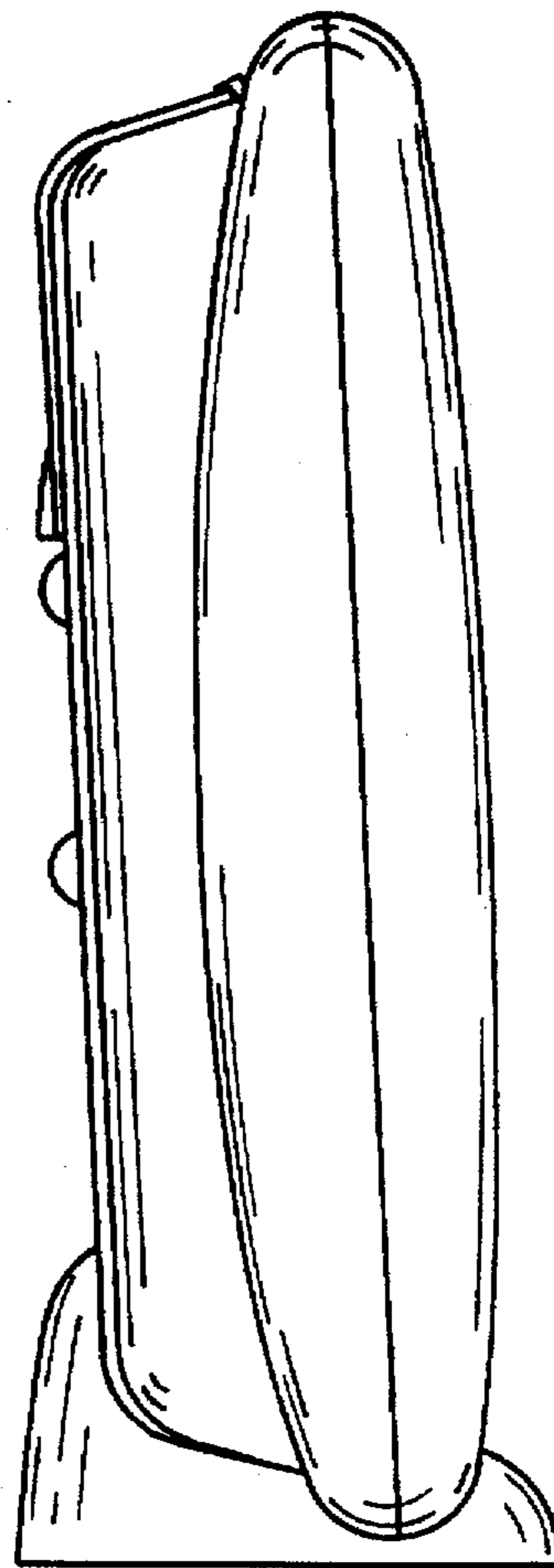

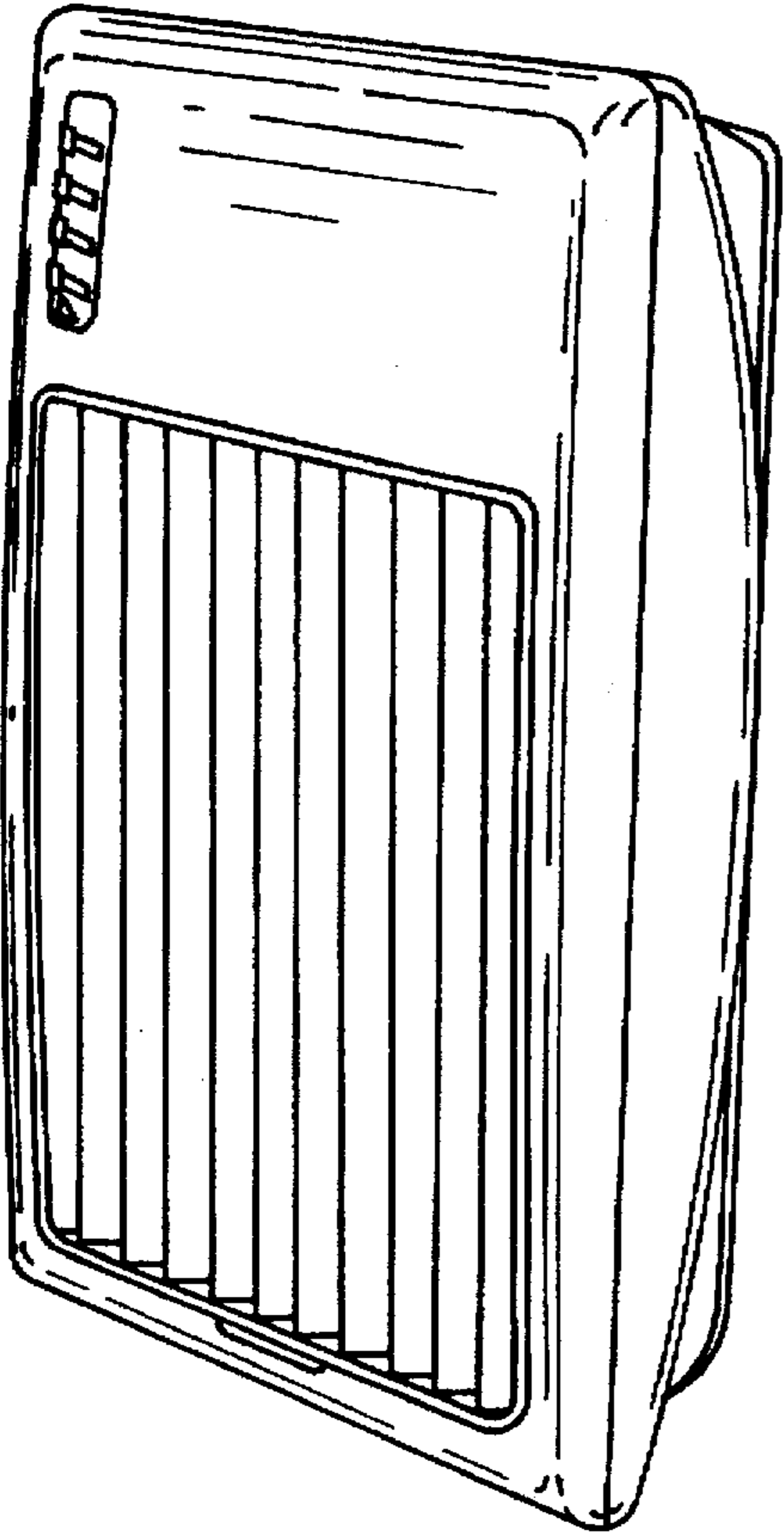

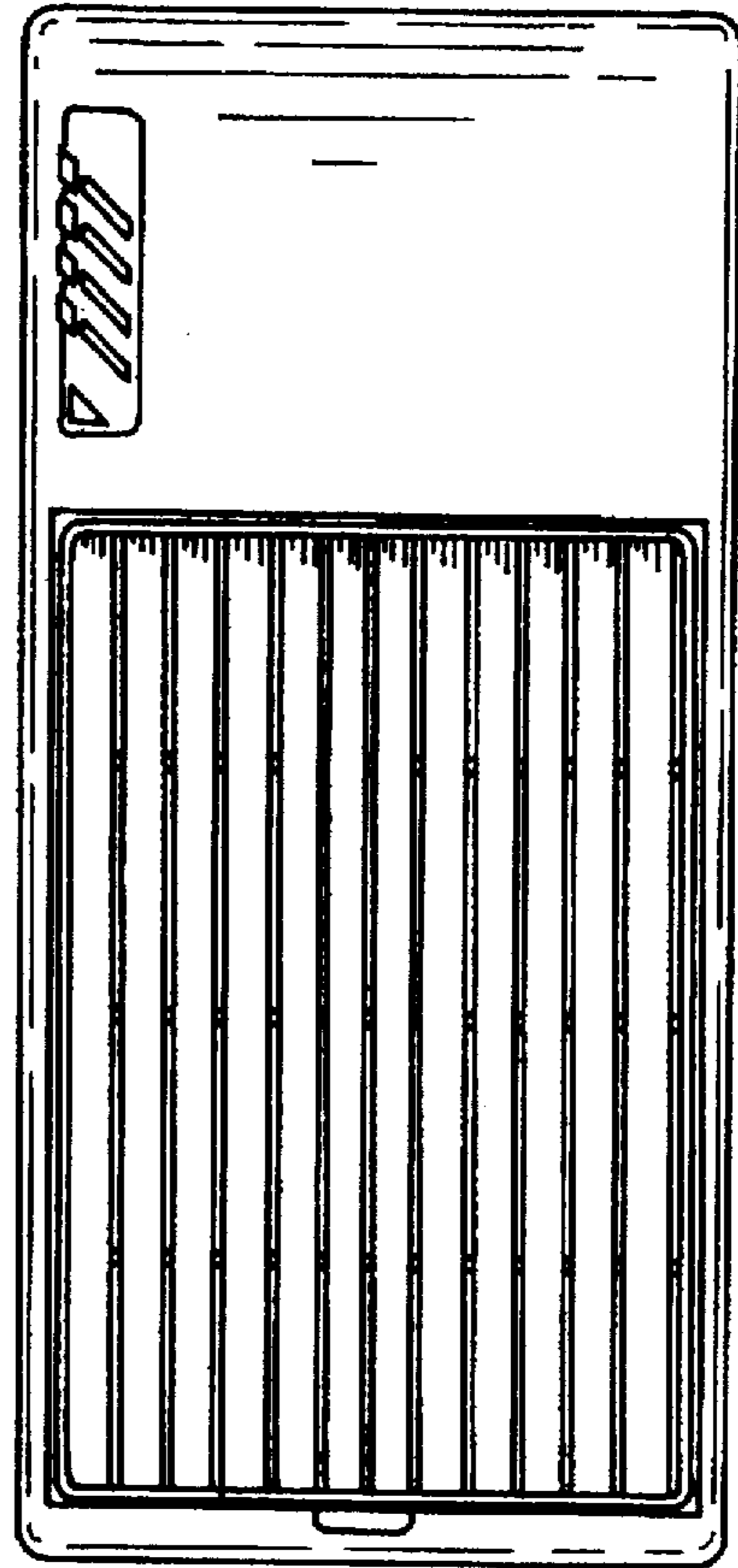

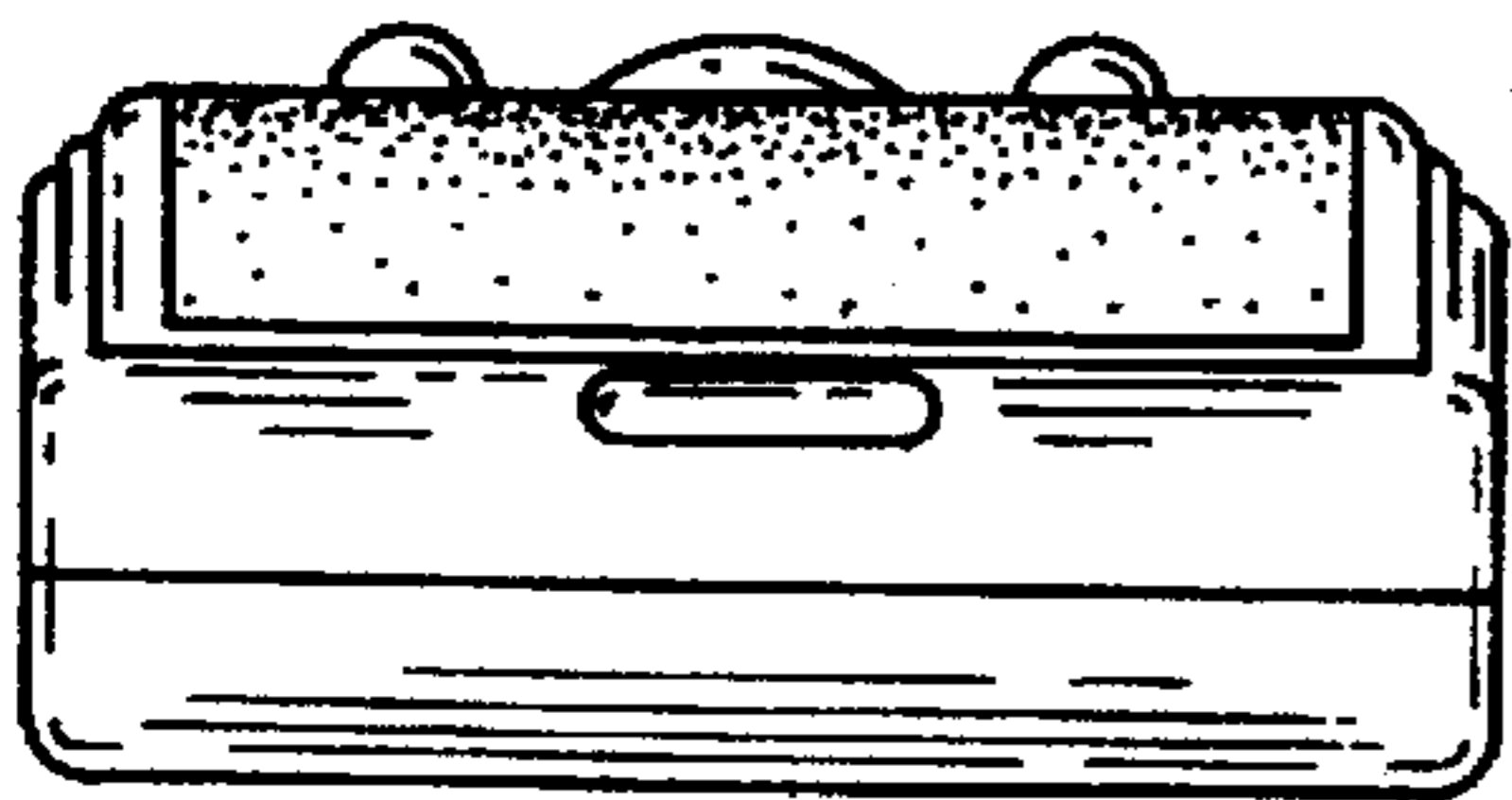

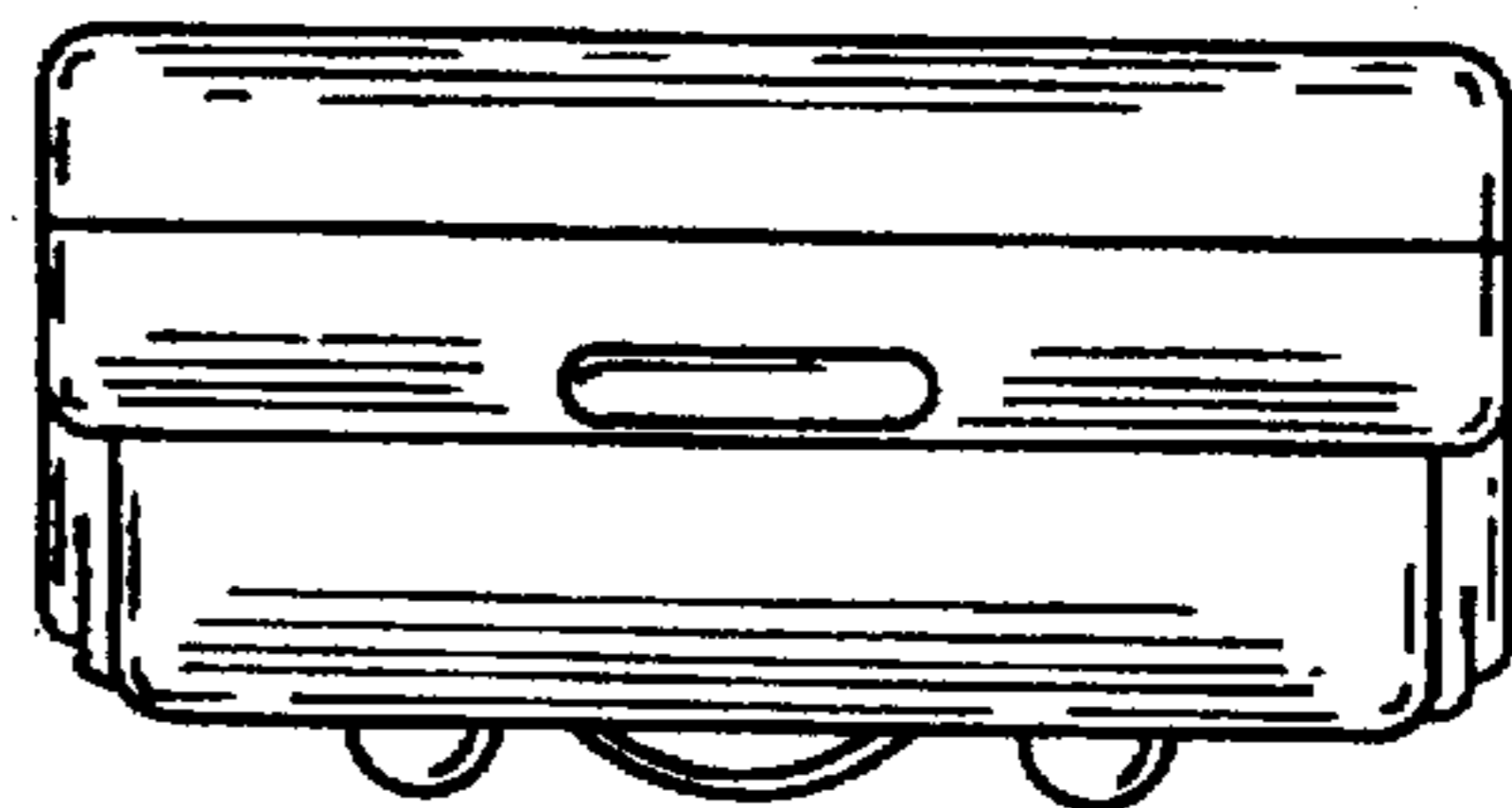

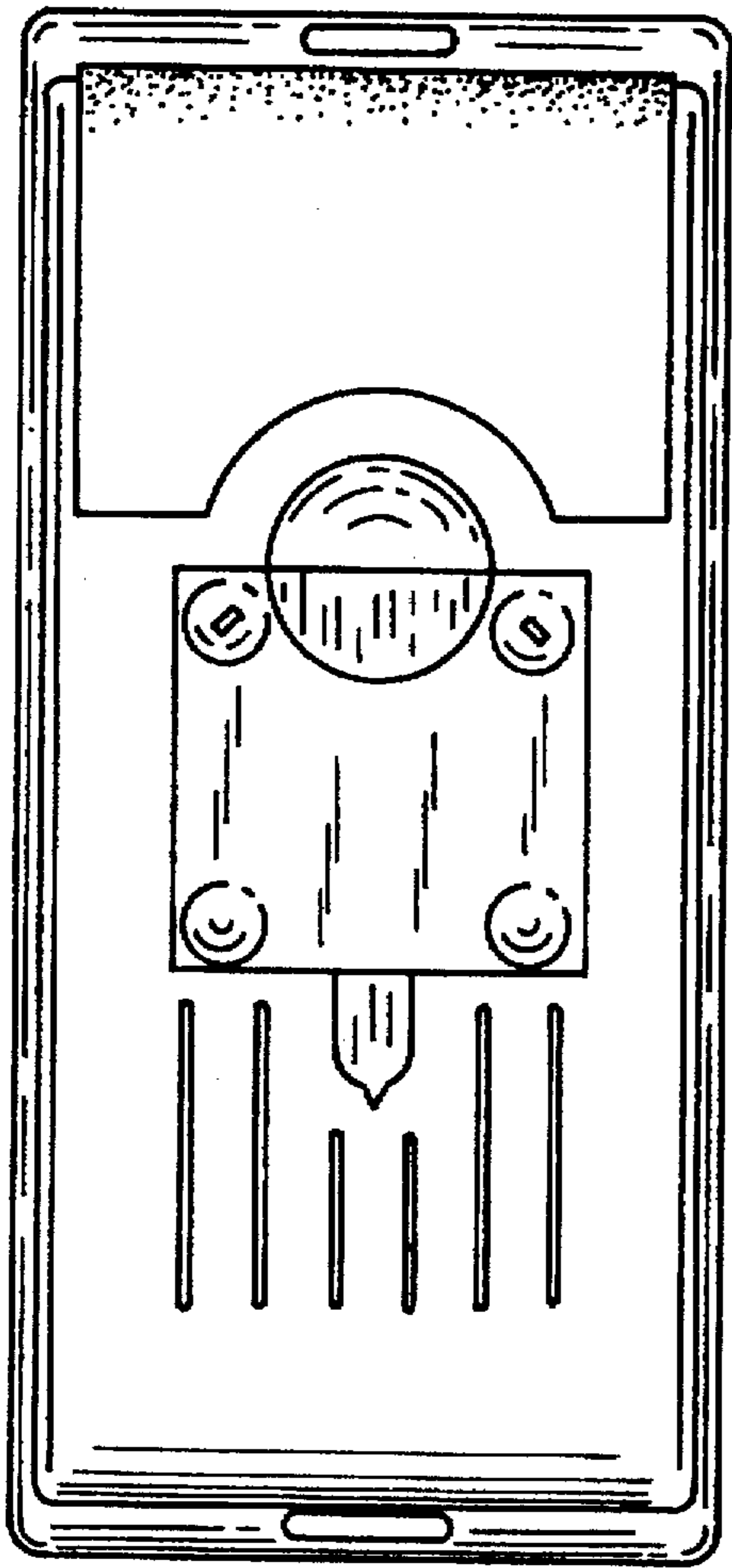

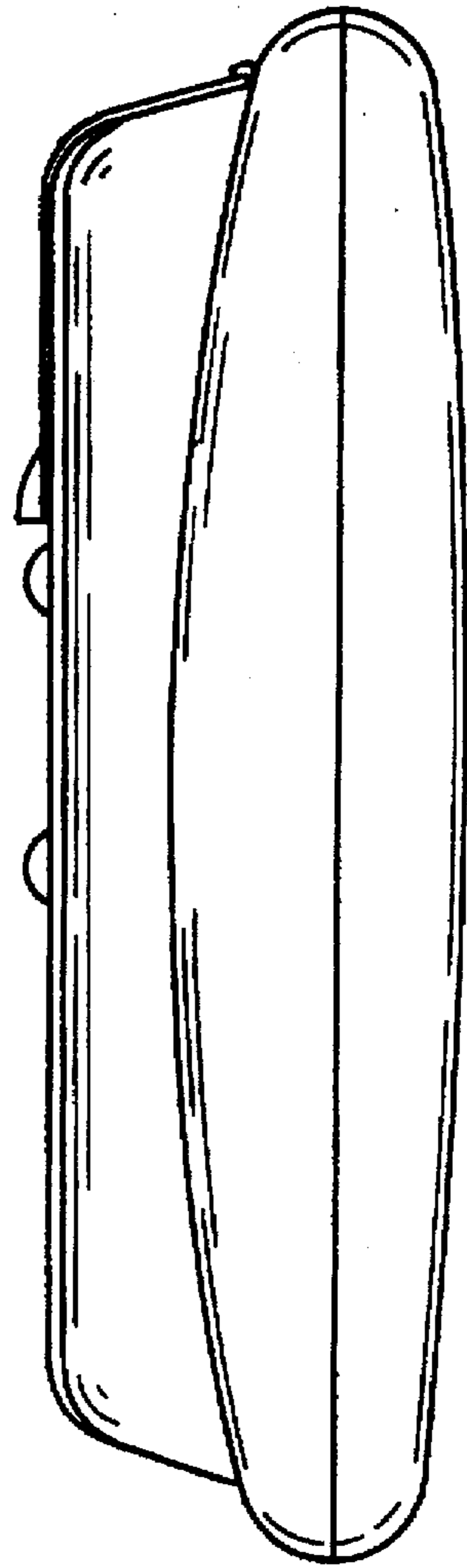
