The ornamental design for a humidifier housing unit, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view of the design for a humidifier housing unit in accordance with the present invention;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

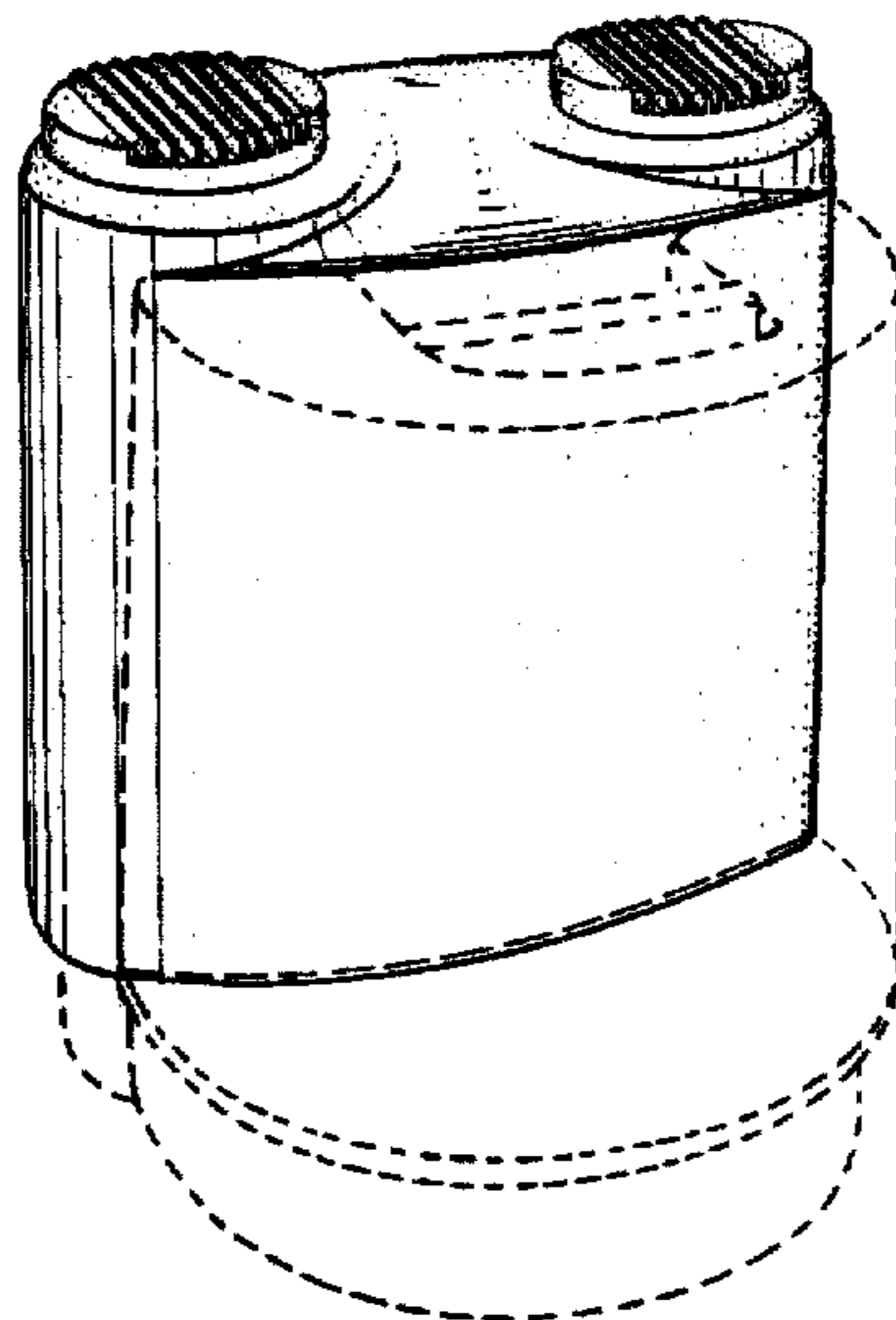
FIG. 5 is a right side elevational view thereof;

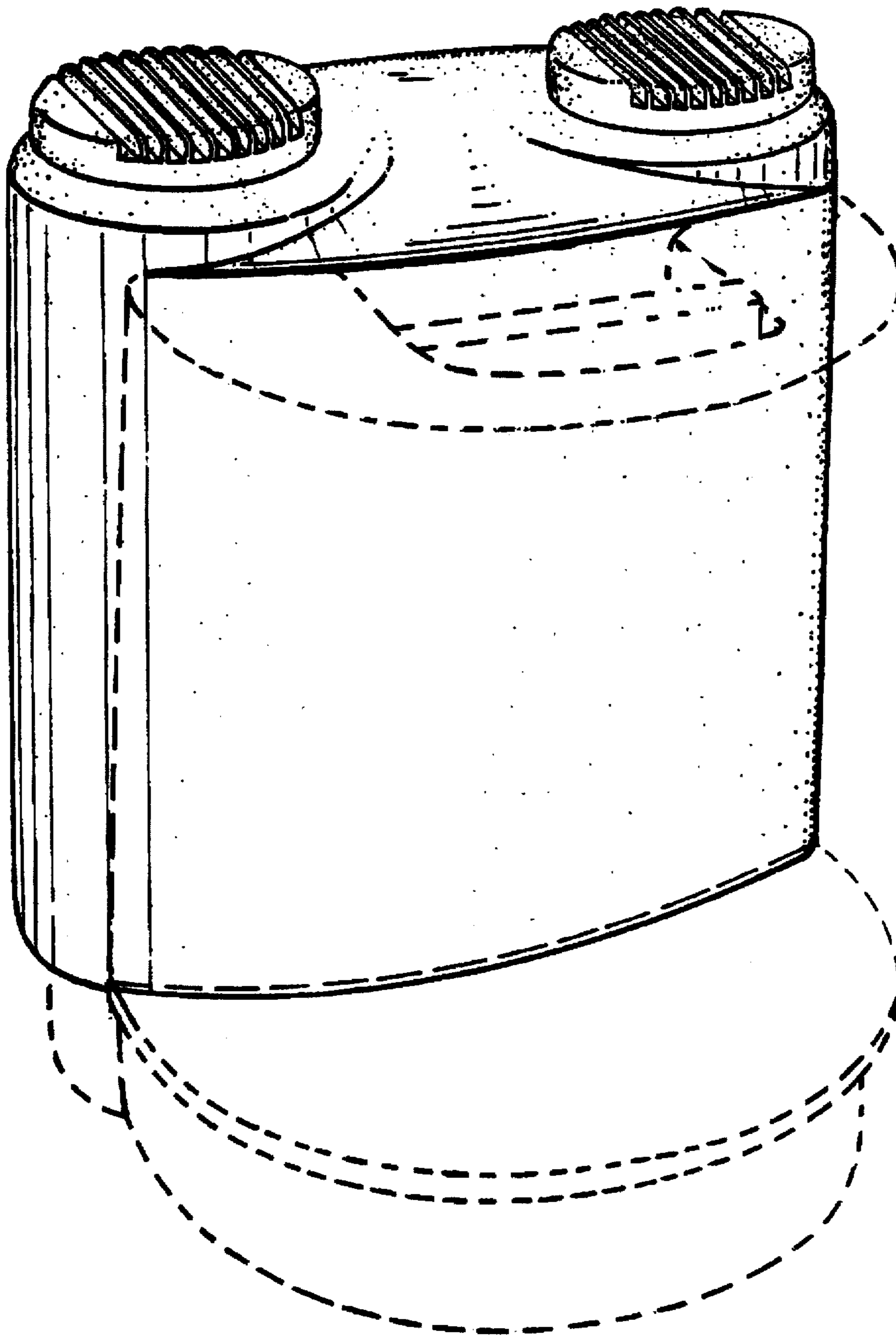

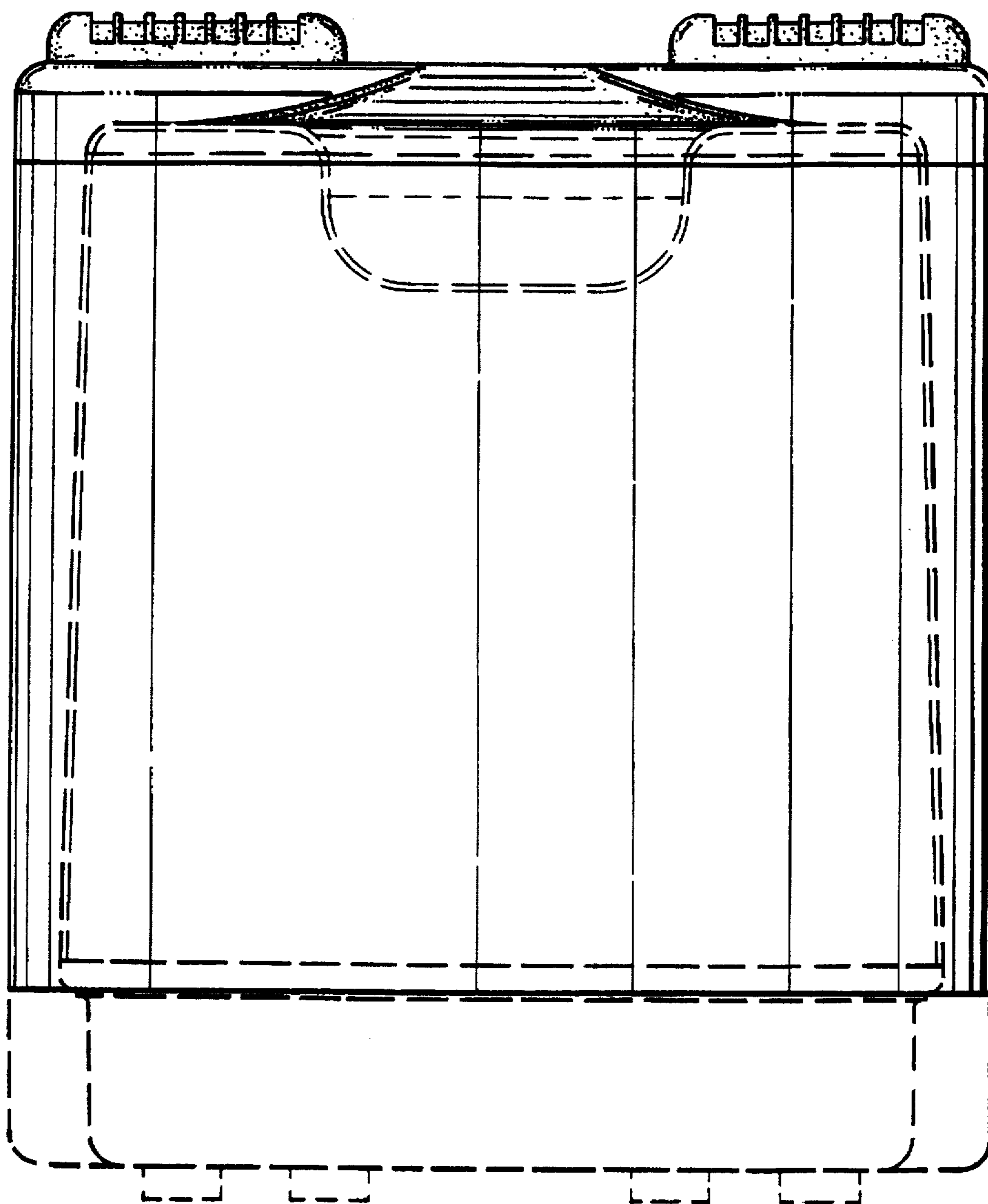

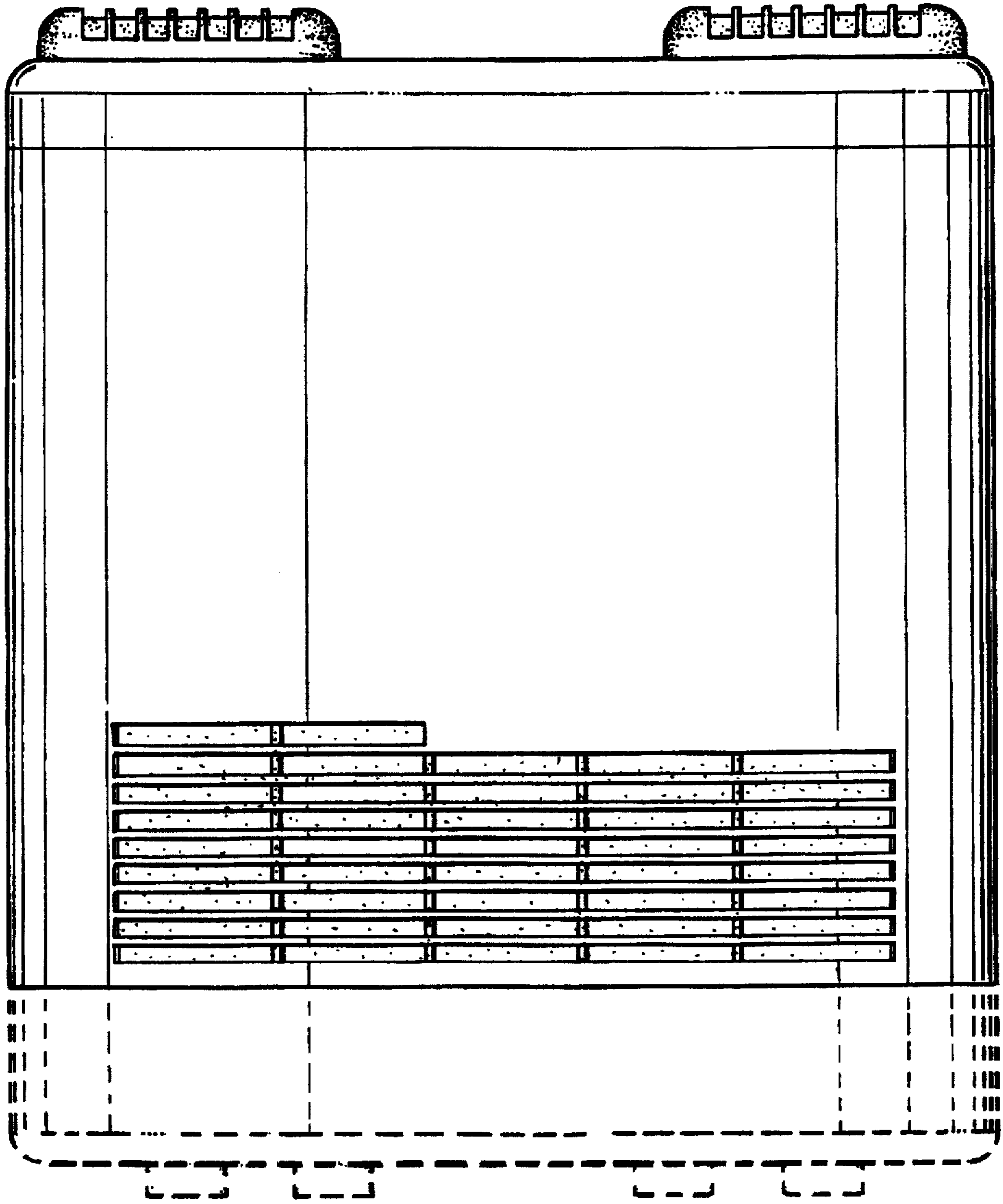

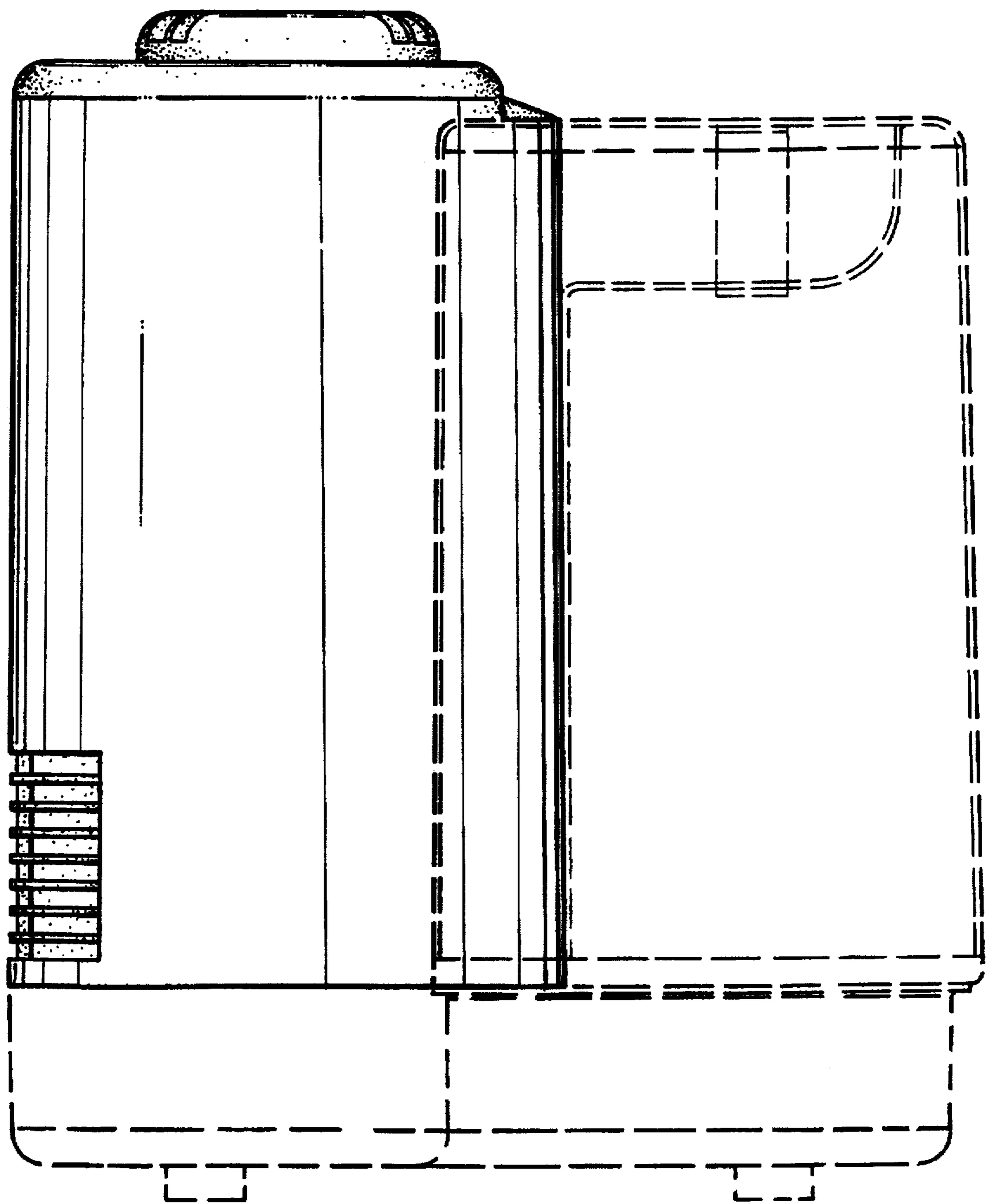

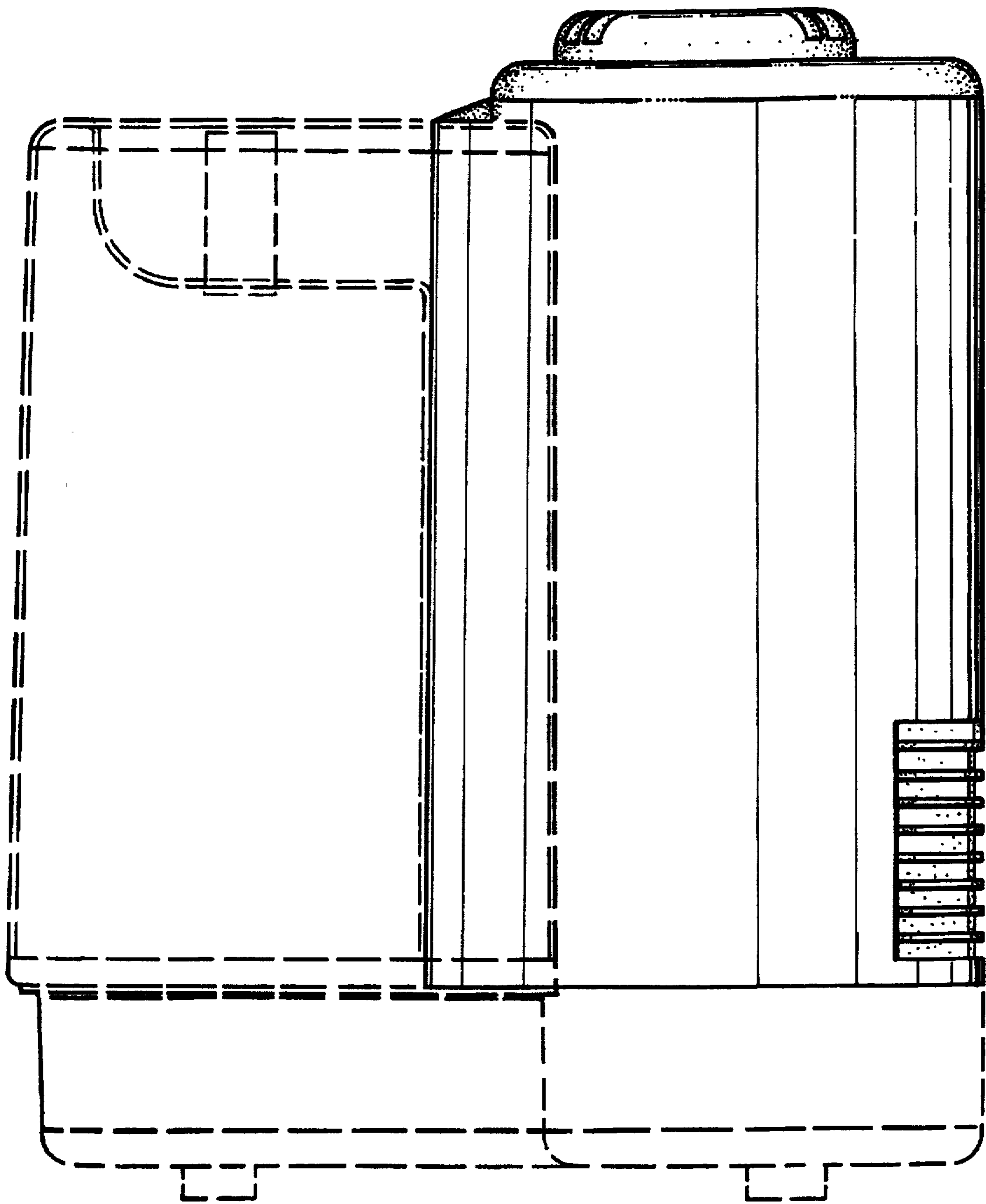

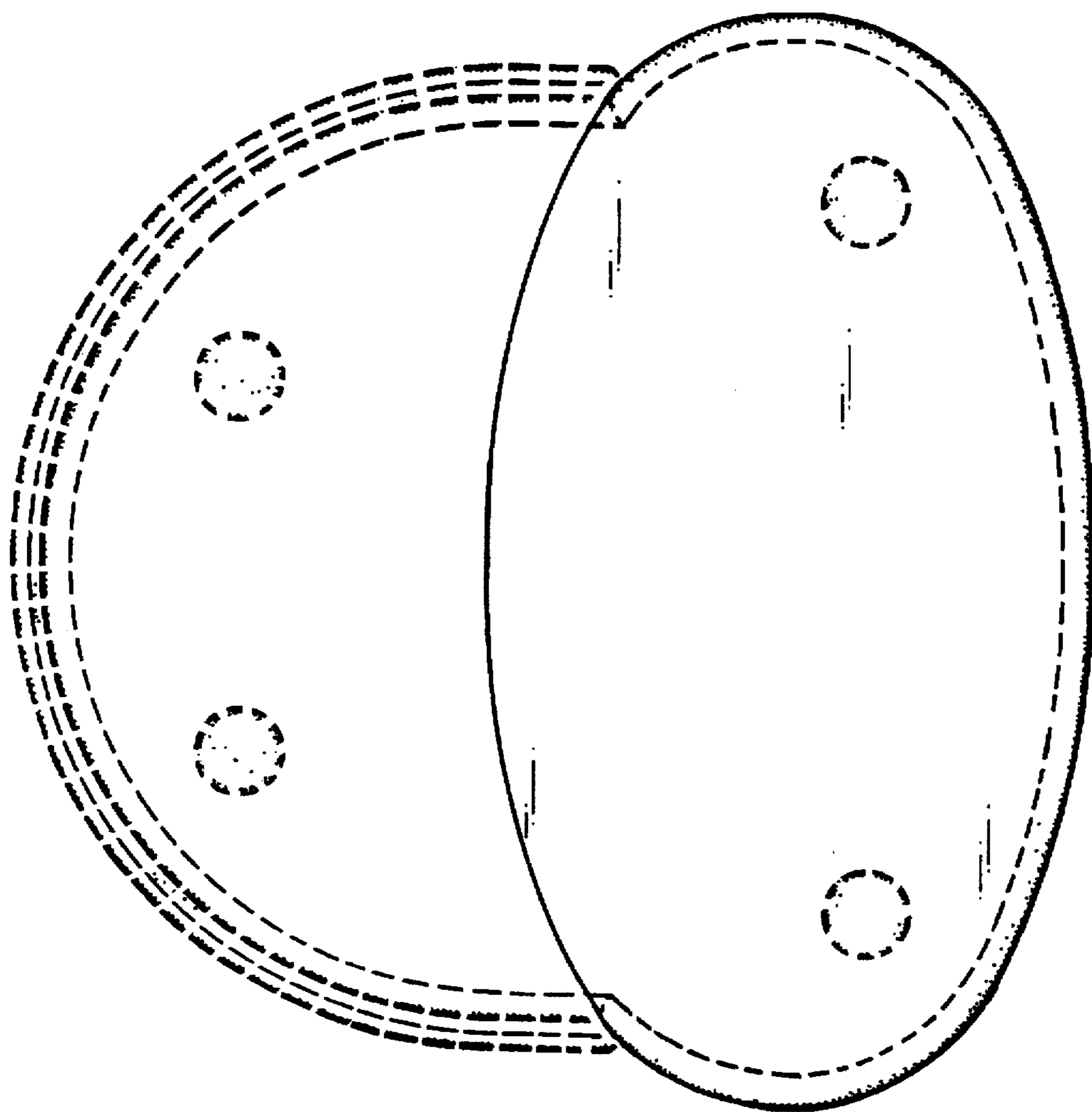

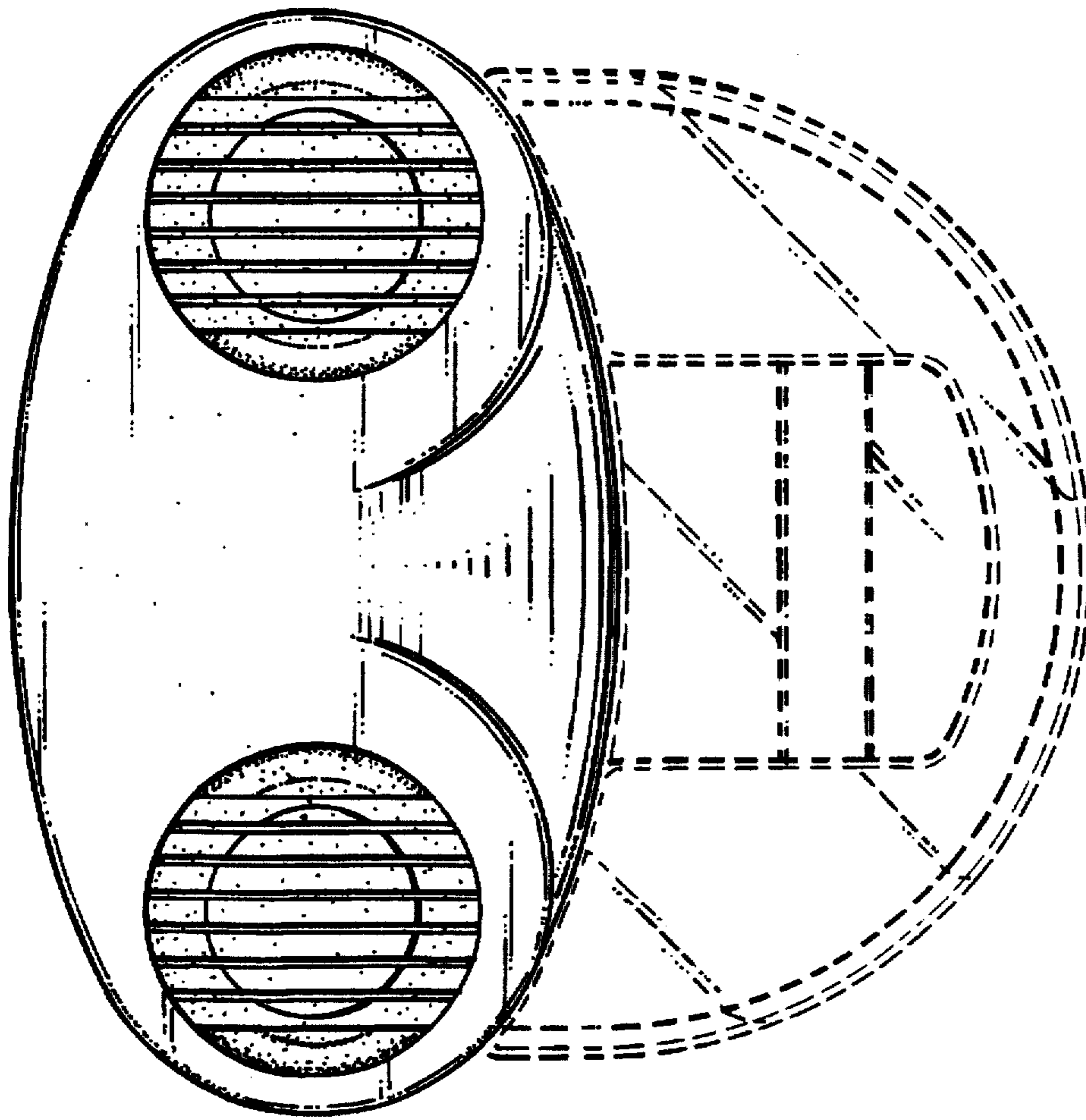
