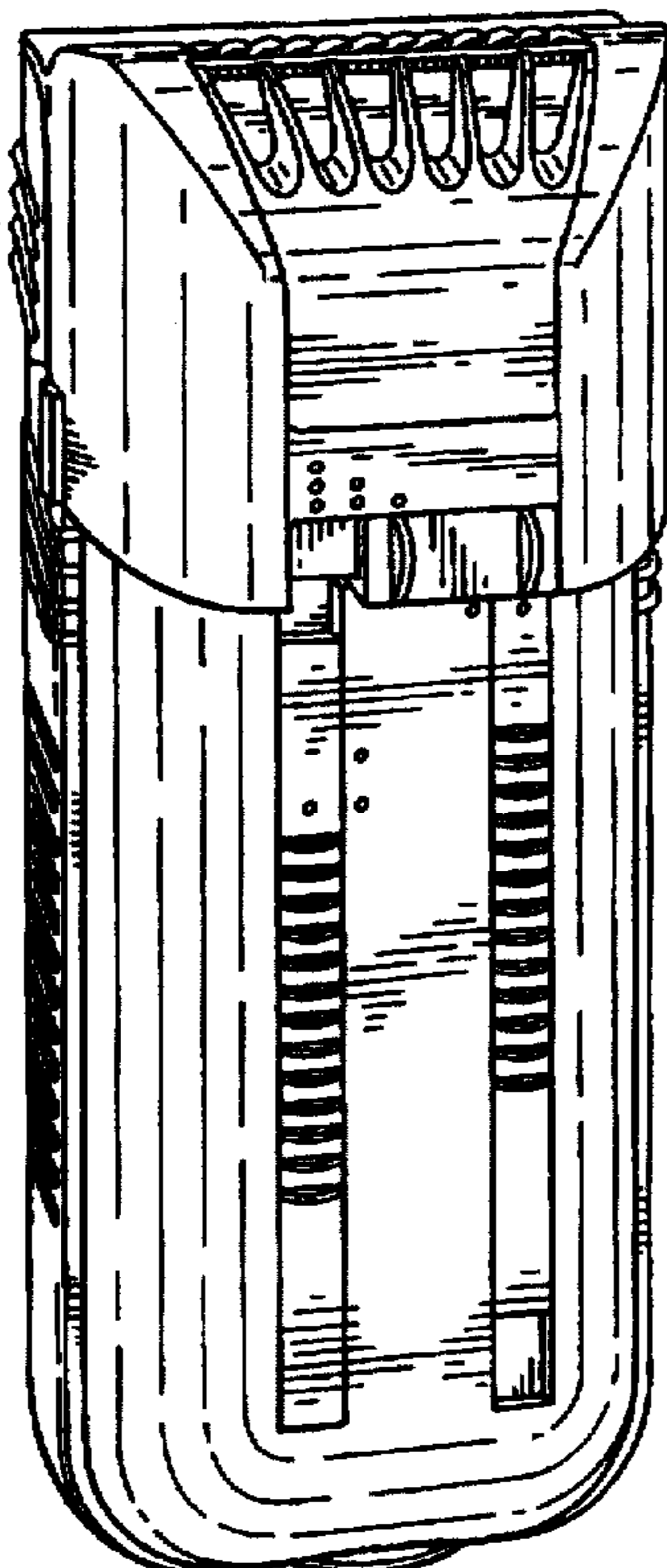

The unshaded region within the circular boundary of the bottom surface enclosing the oblong and rectangular regions forms no part of the claimed design.

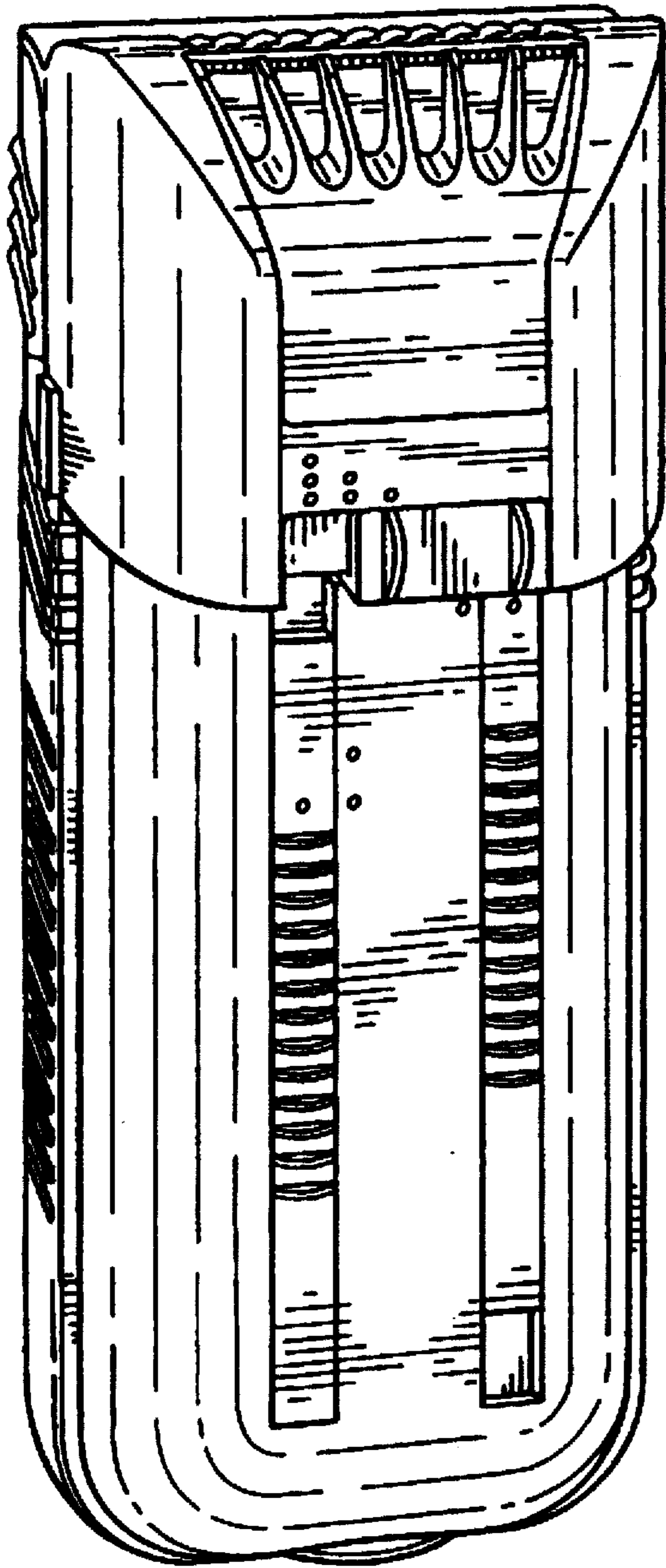

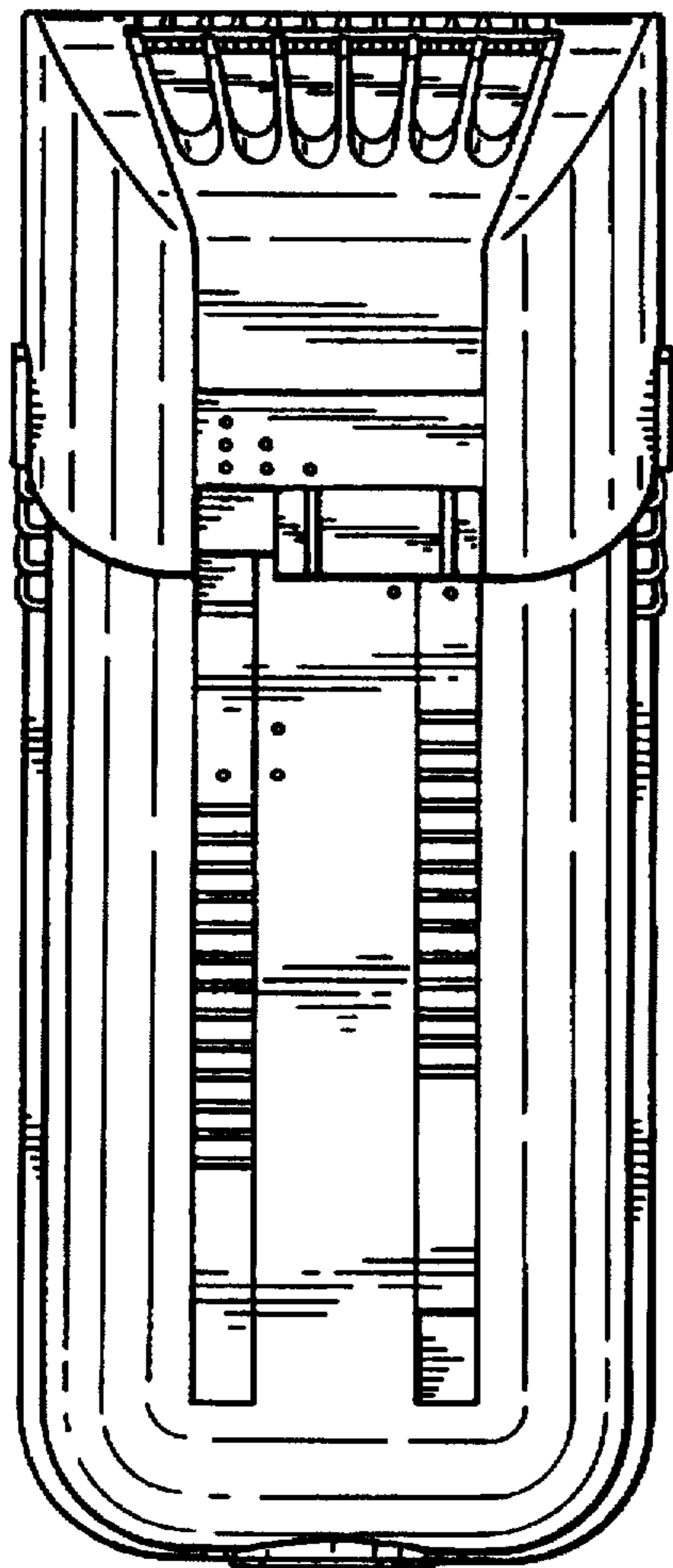

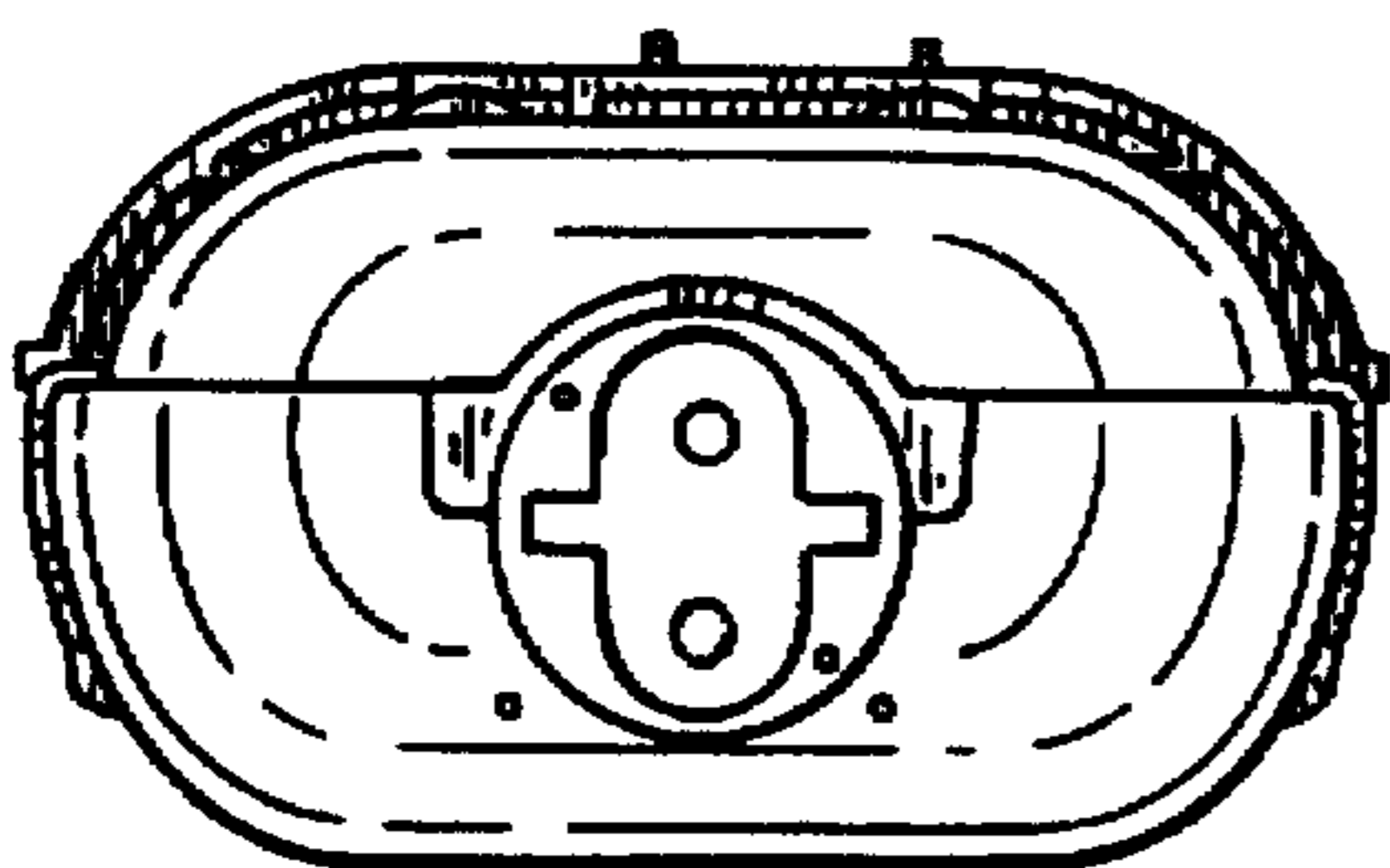
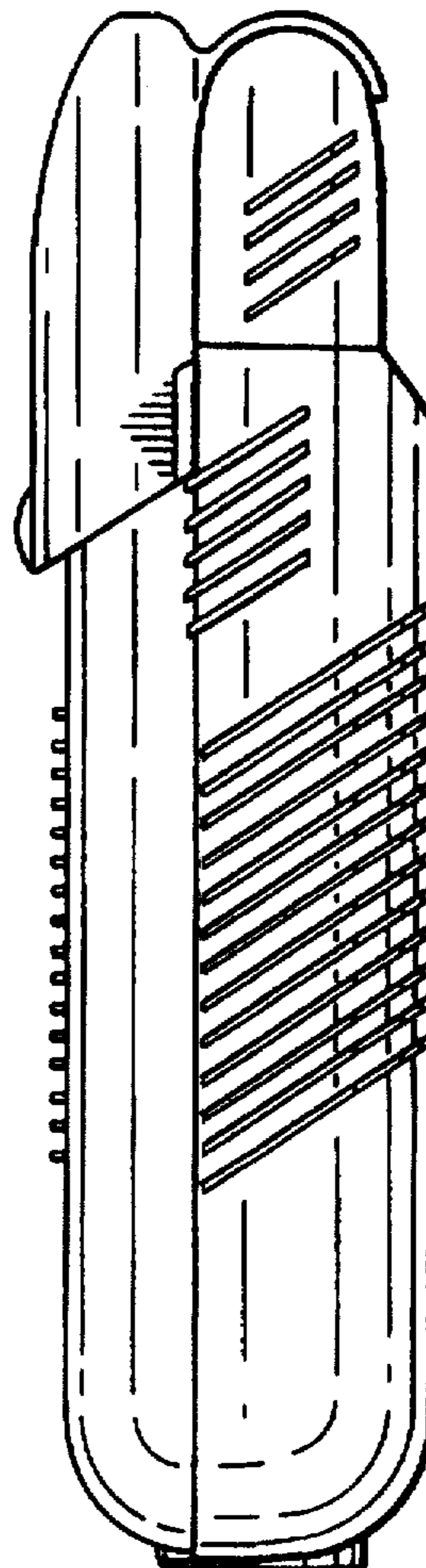

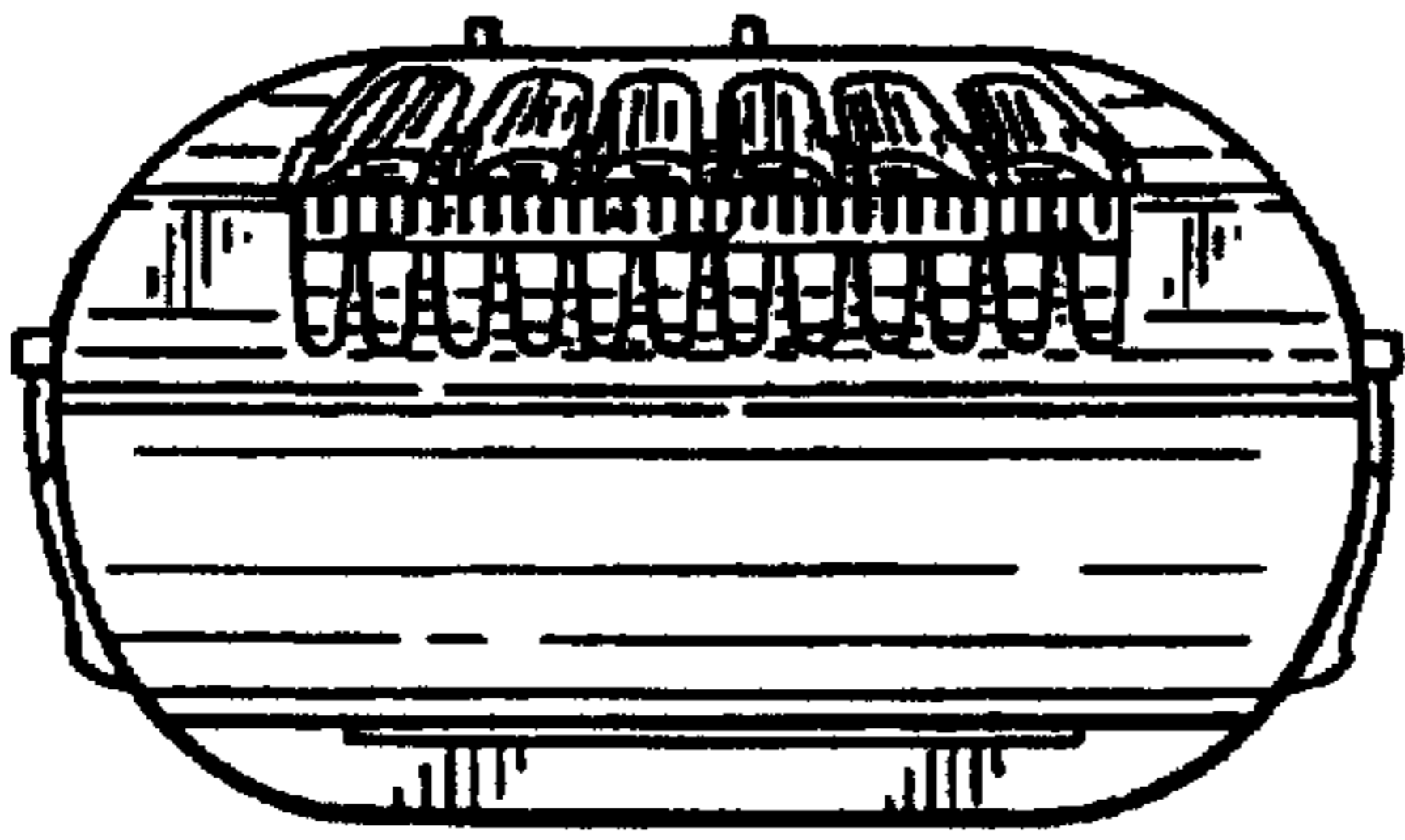

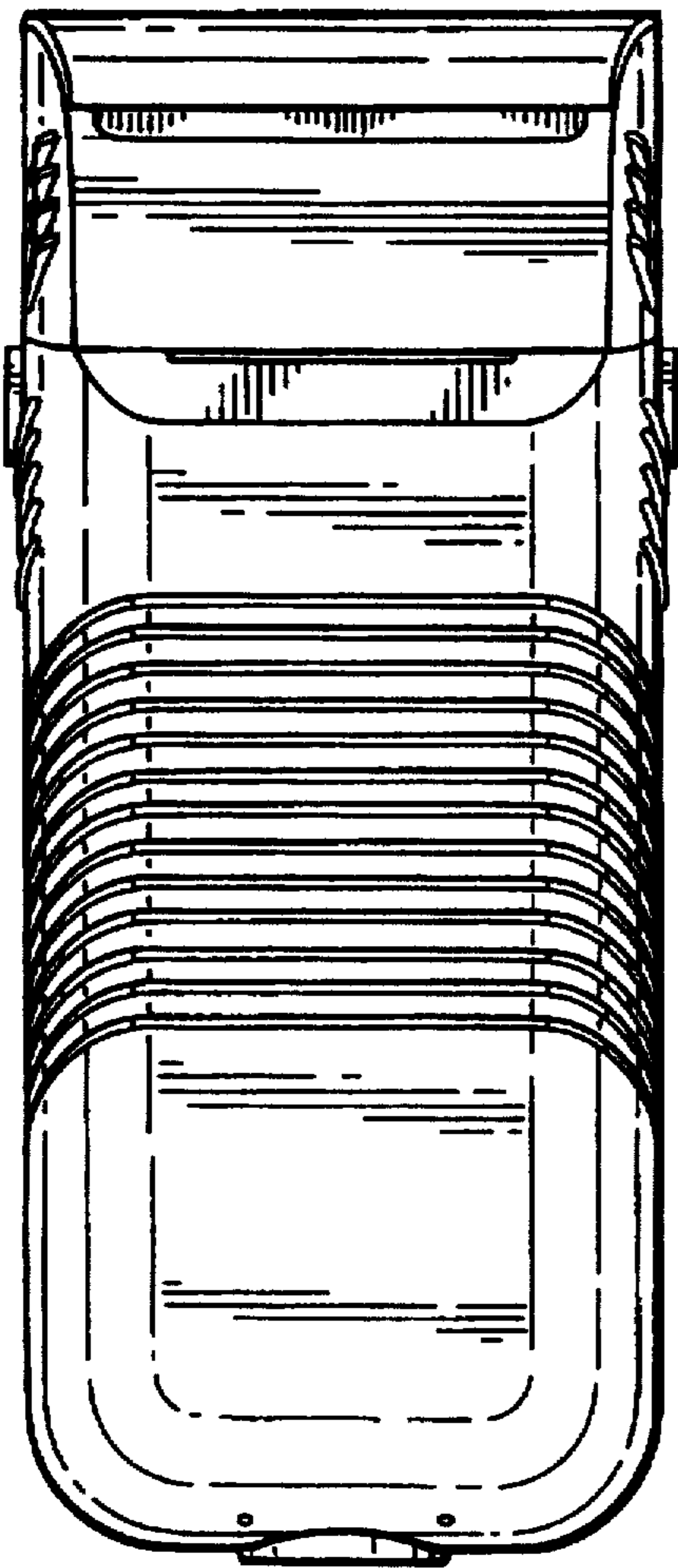

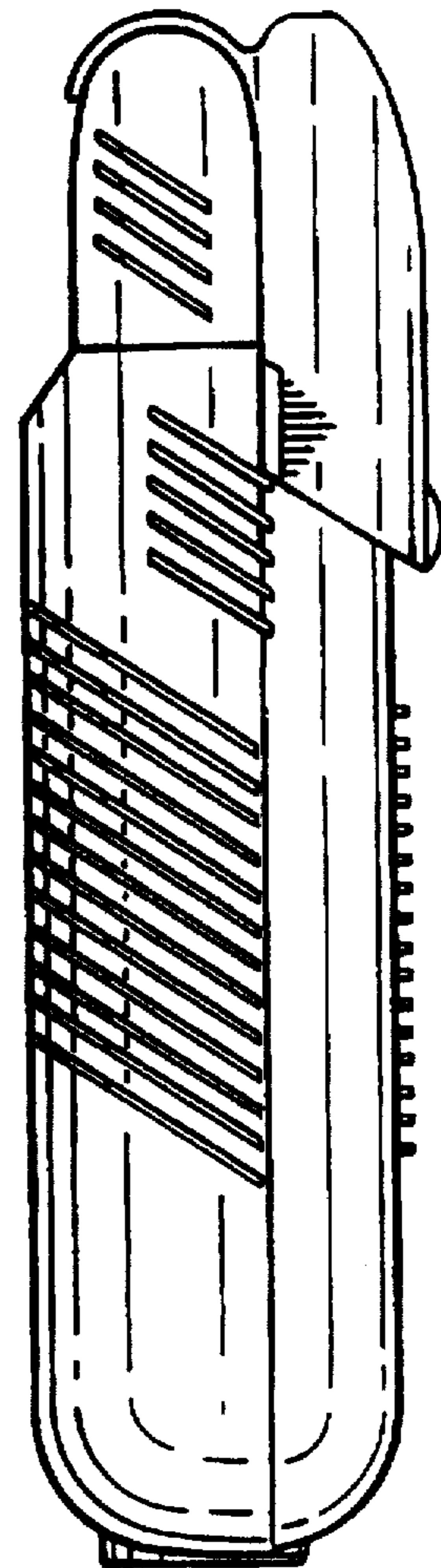
