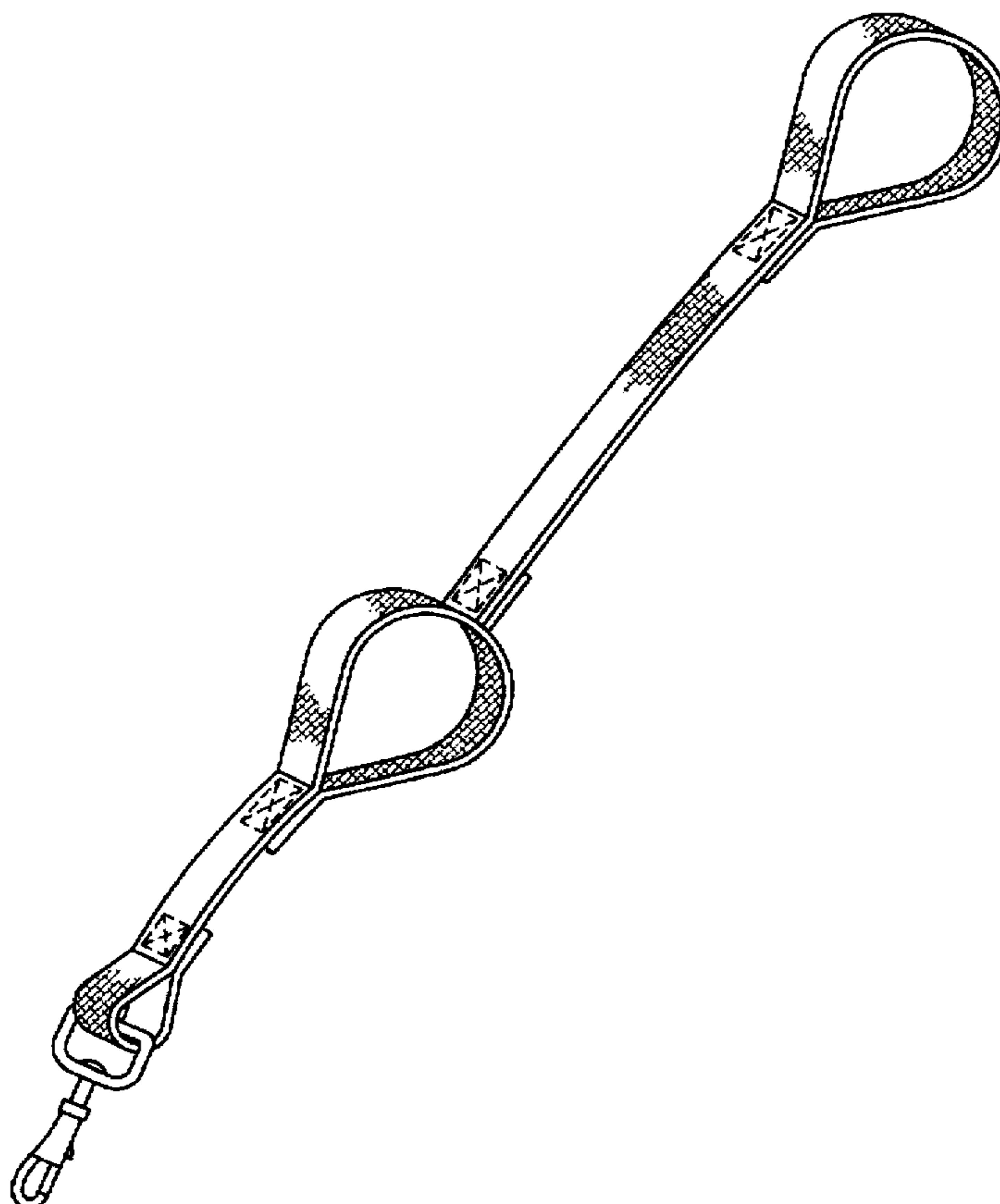

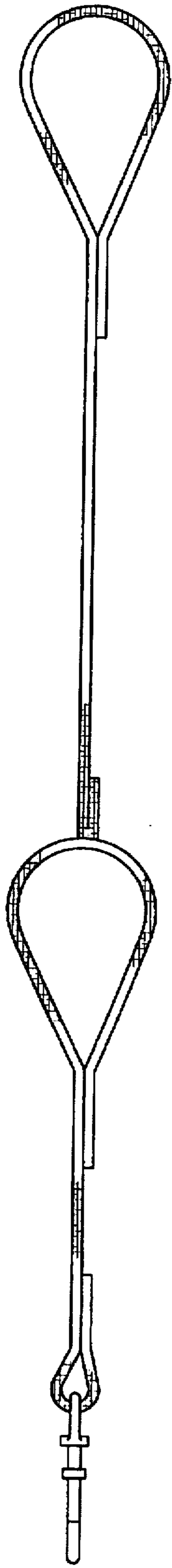

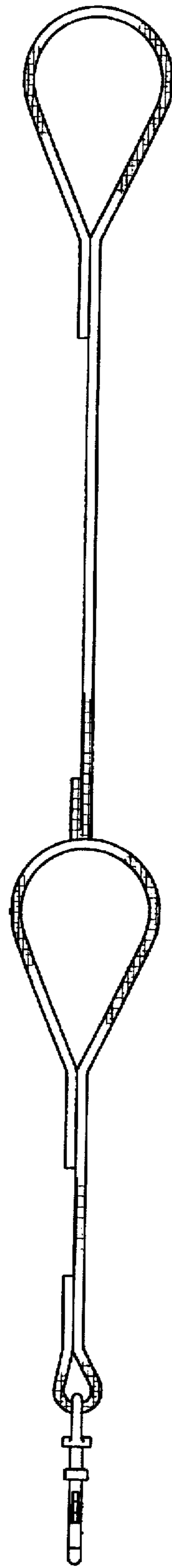
FIG. 1 is a right side view of the dog leash showing my new design;

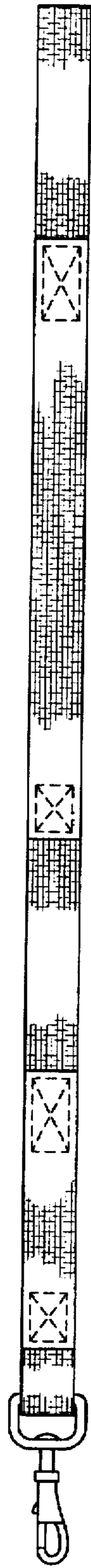




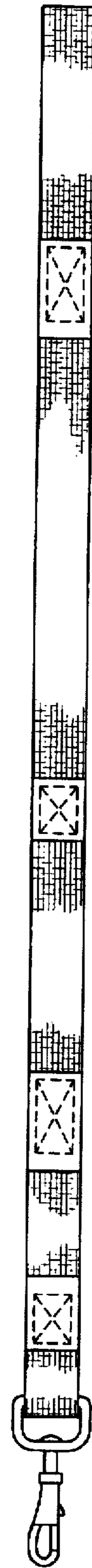

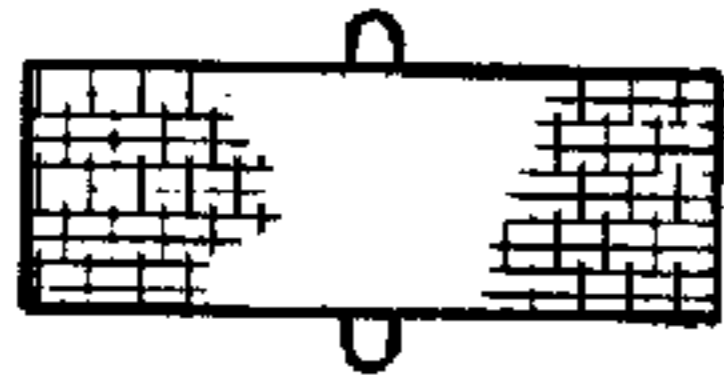

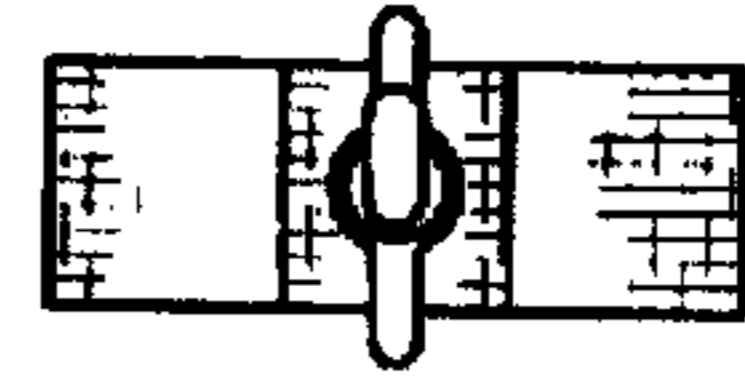

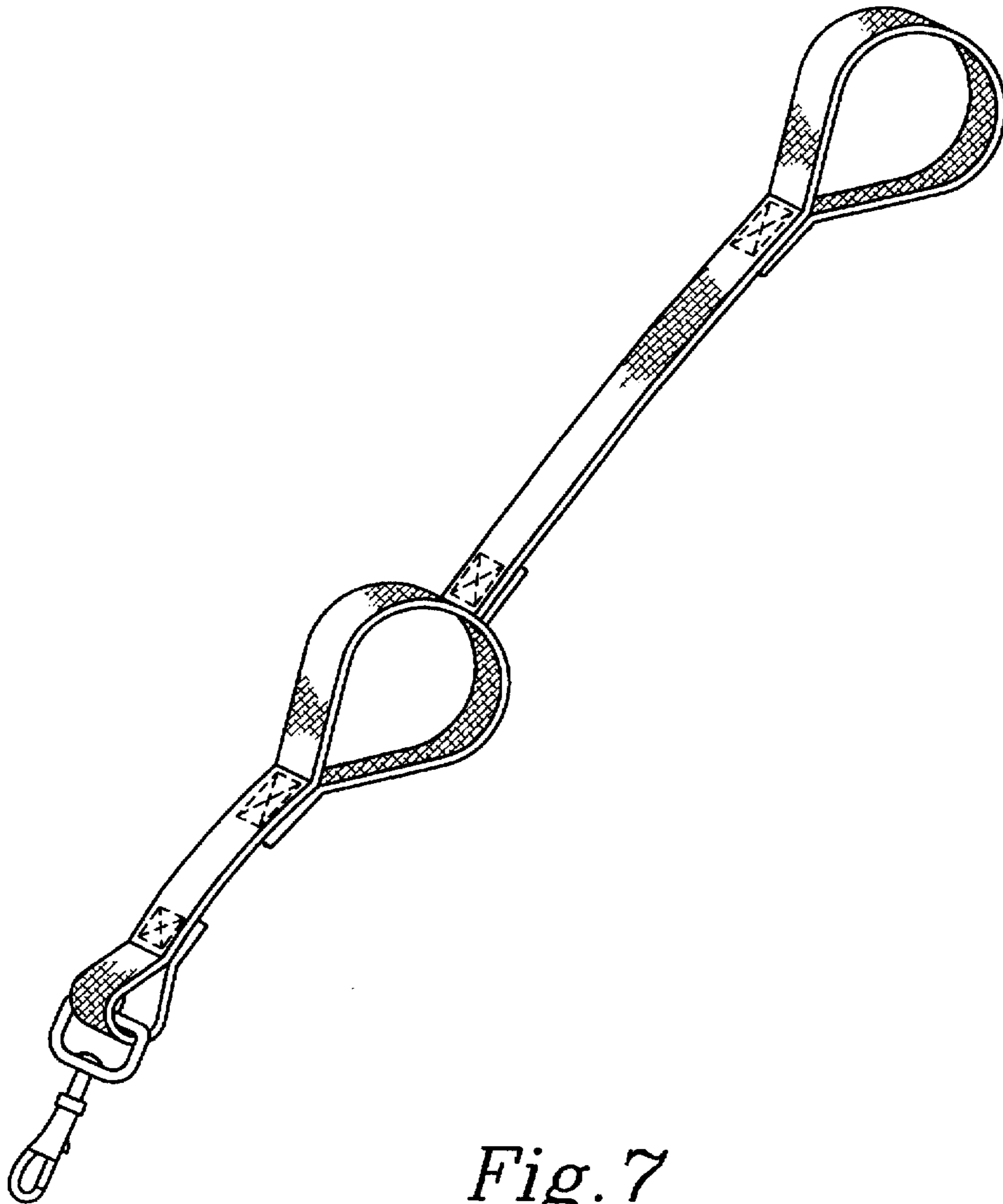
