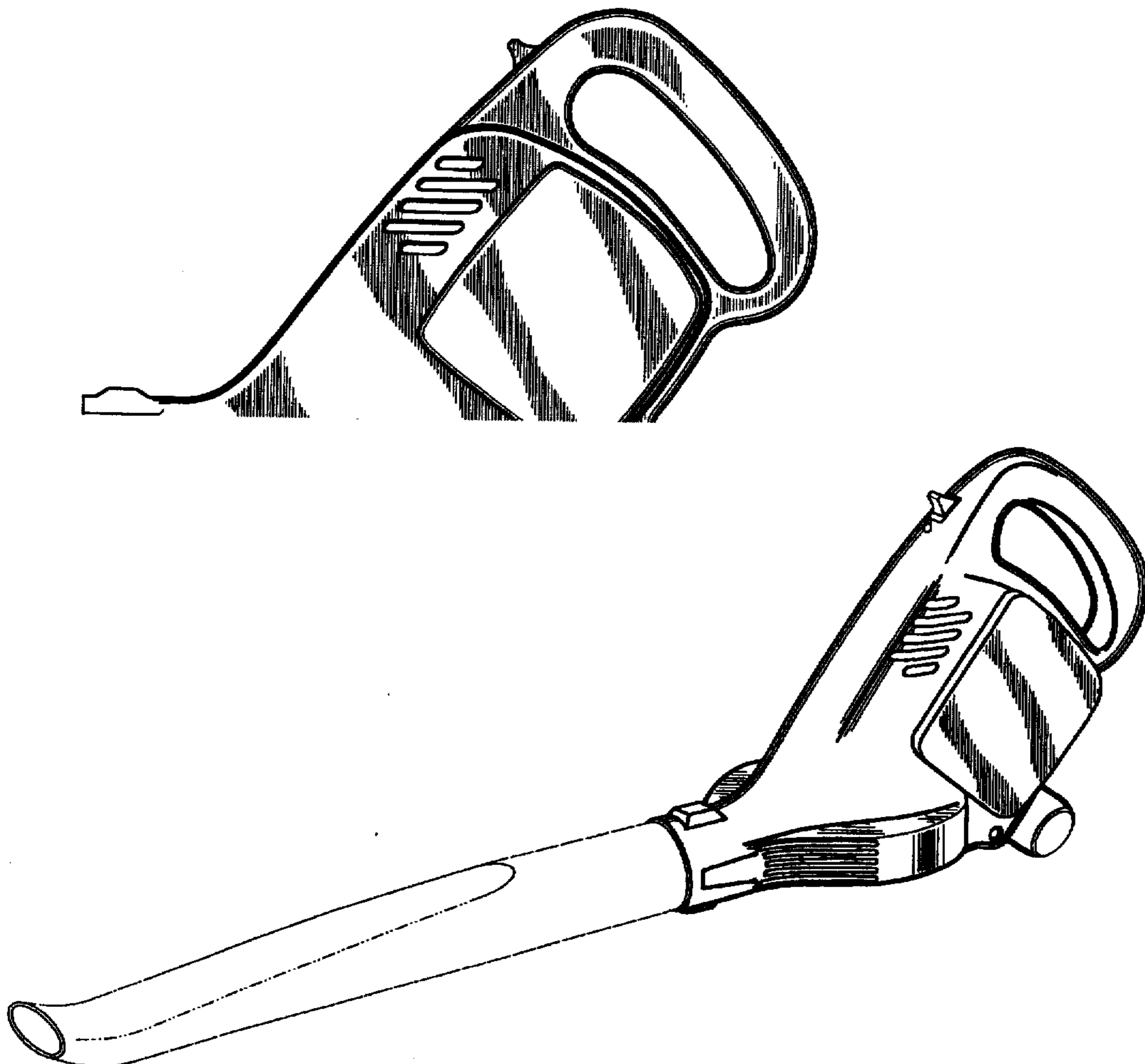

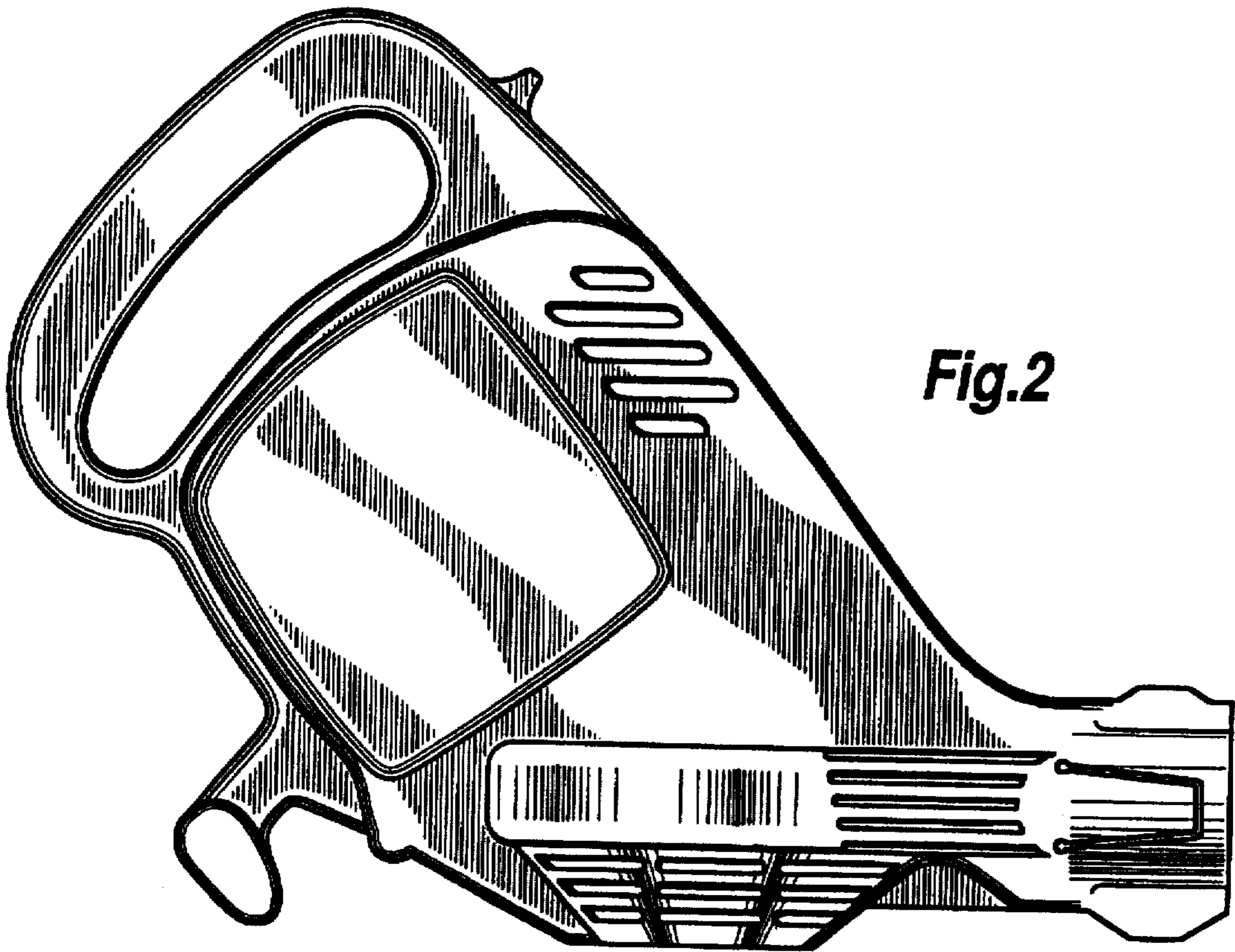
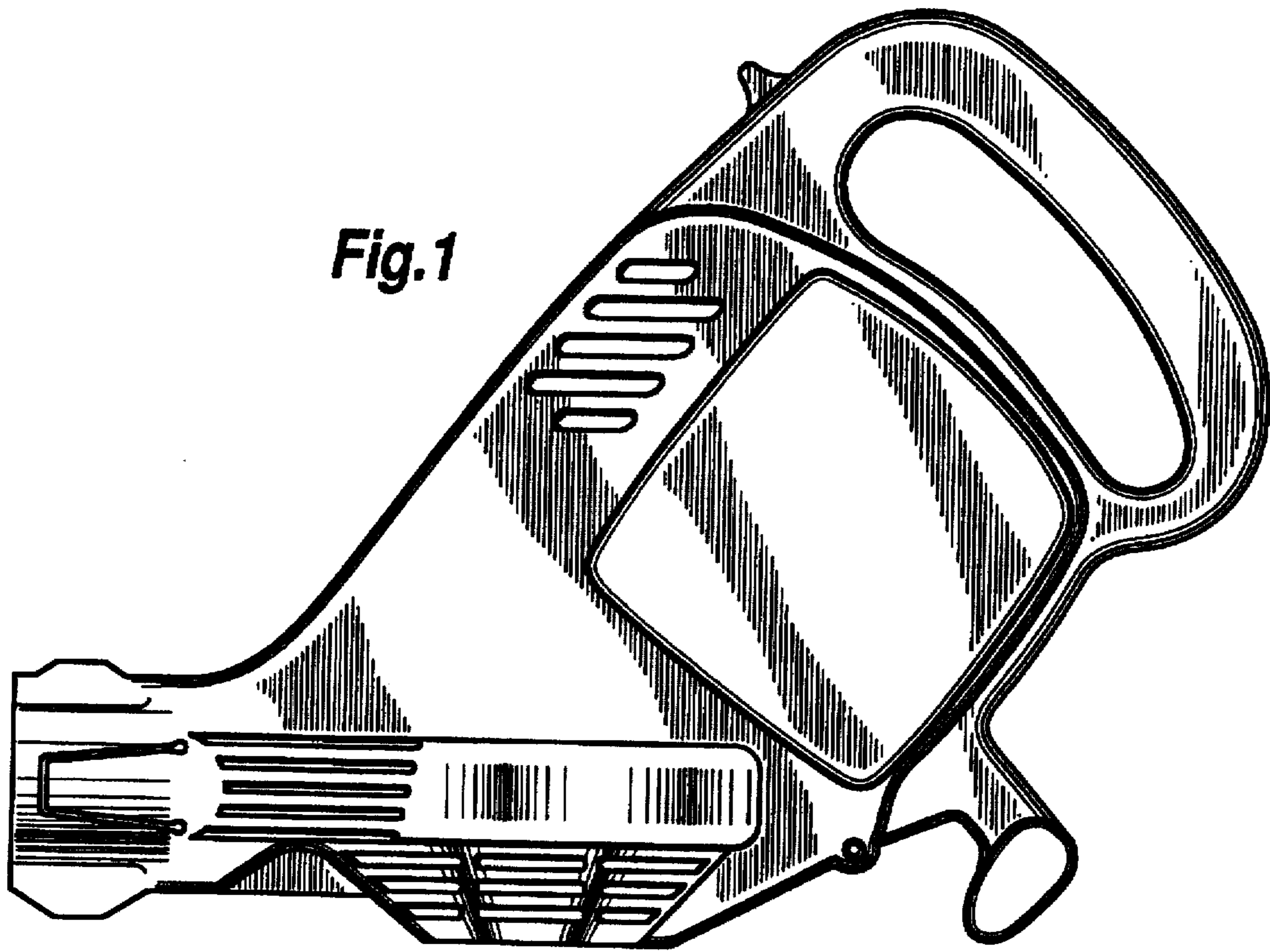
FIG. 1 is a left side elevational view of a cordless electric blower showing the design;

The air nozzle indicated by broken lines is for illustrative purposes only and forms no part of the claimed design.

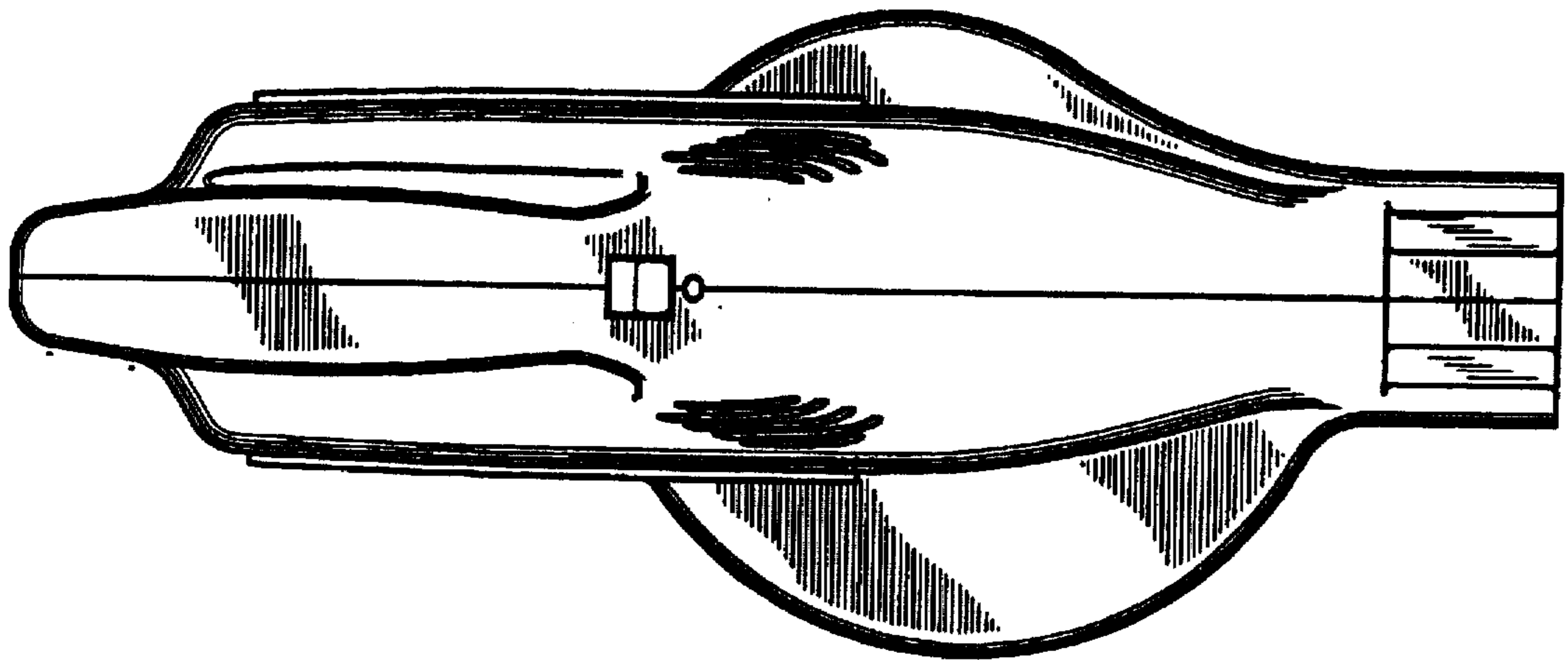

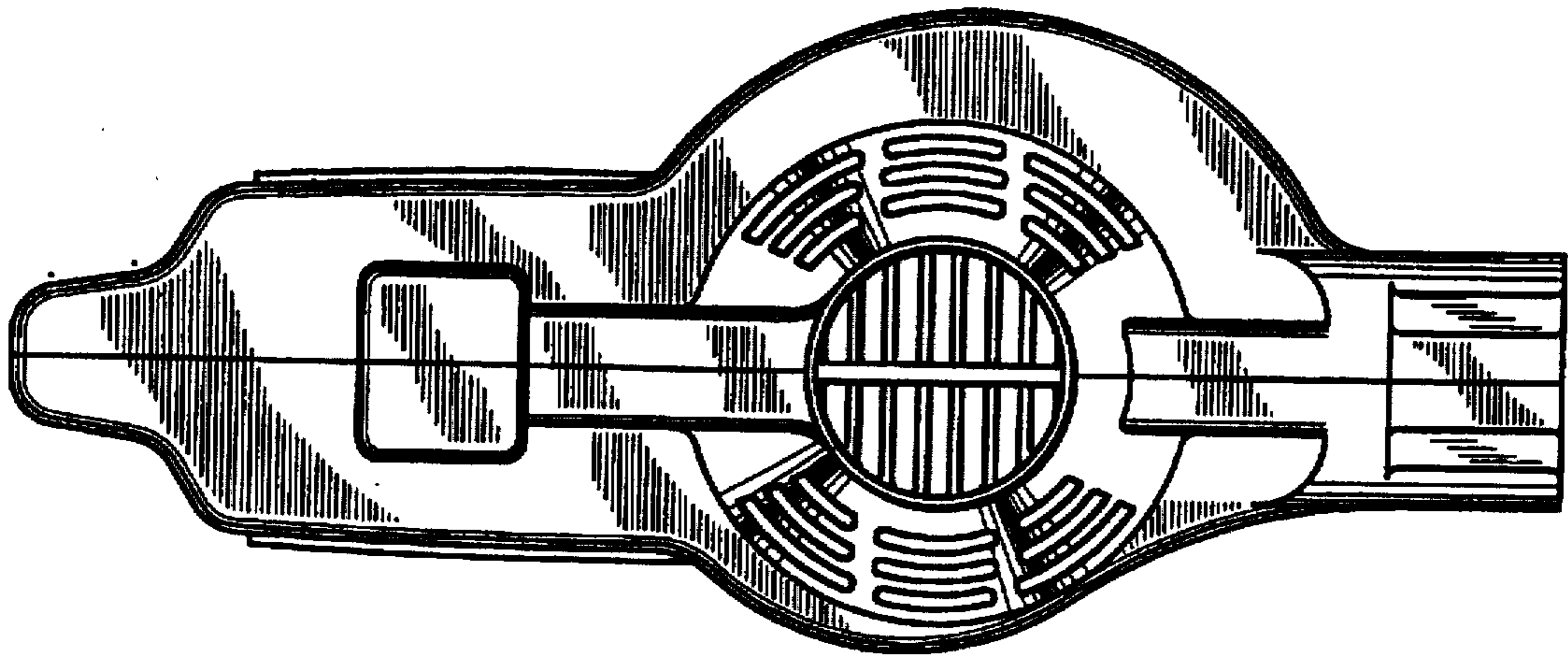

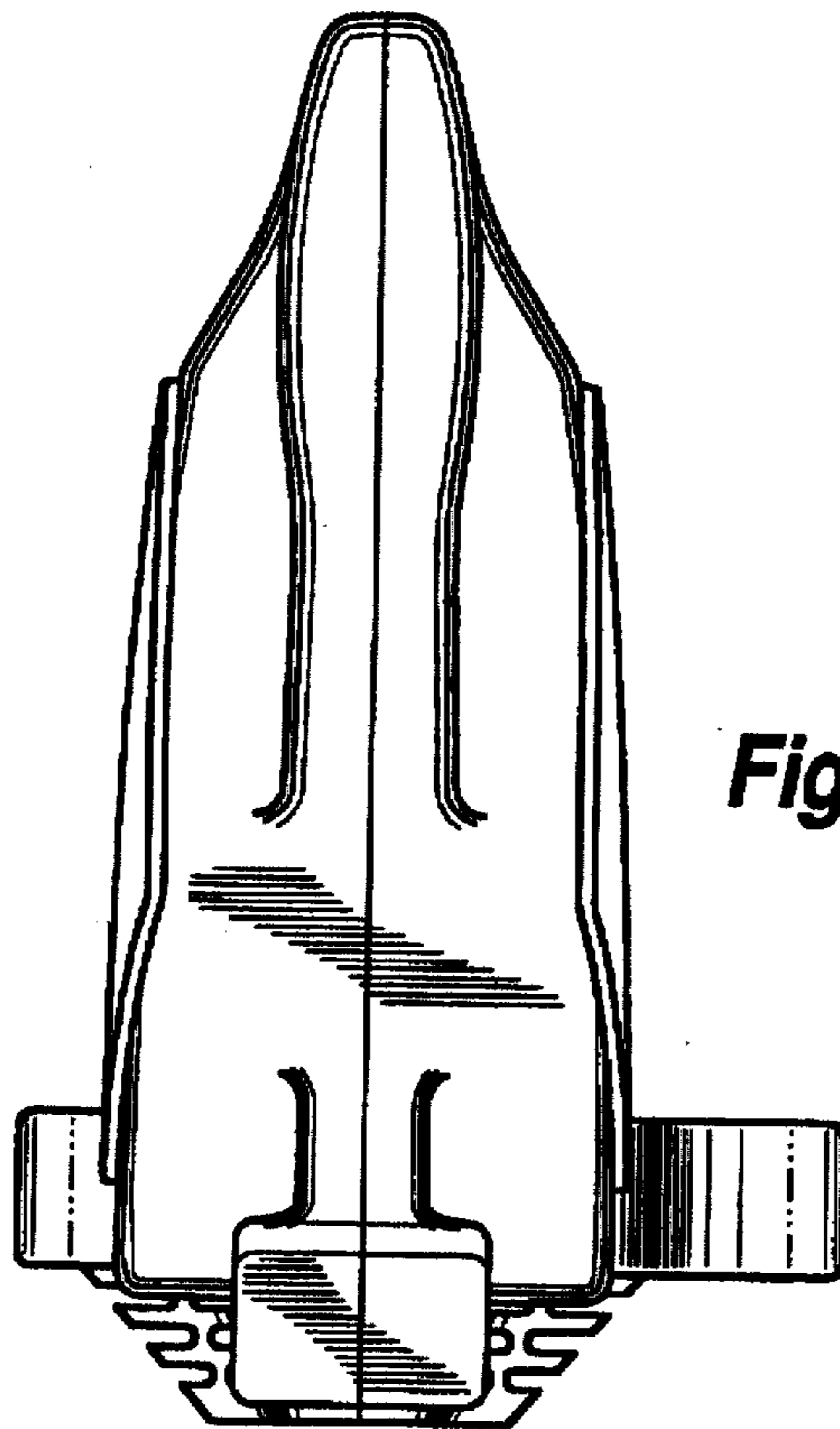

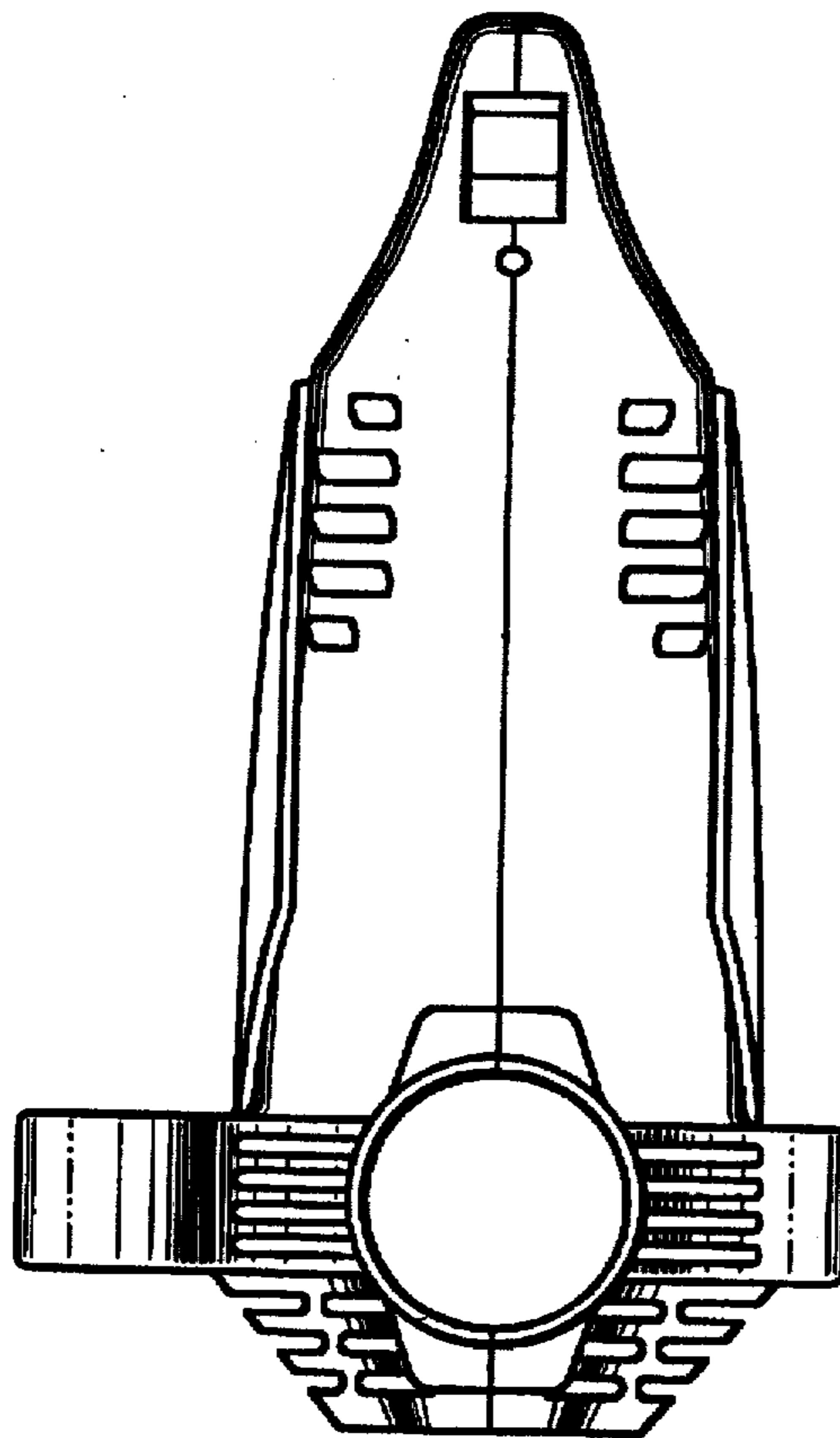

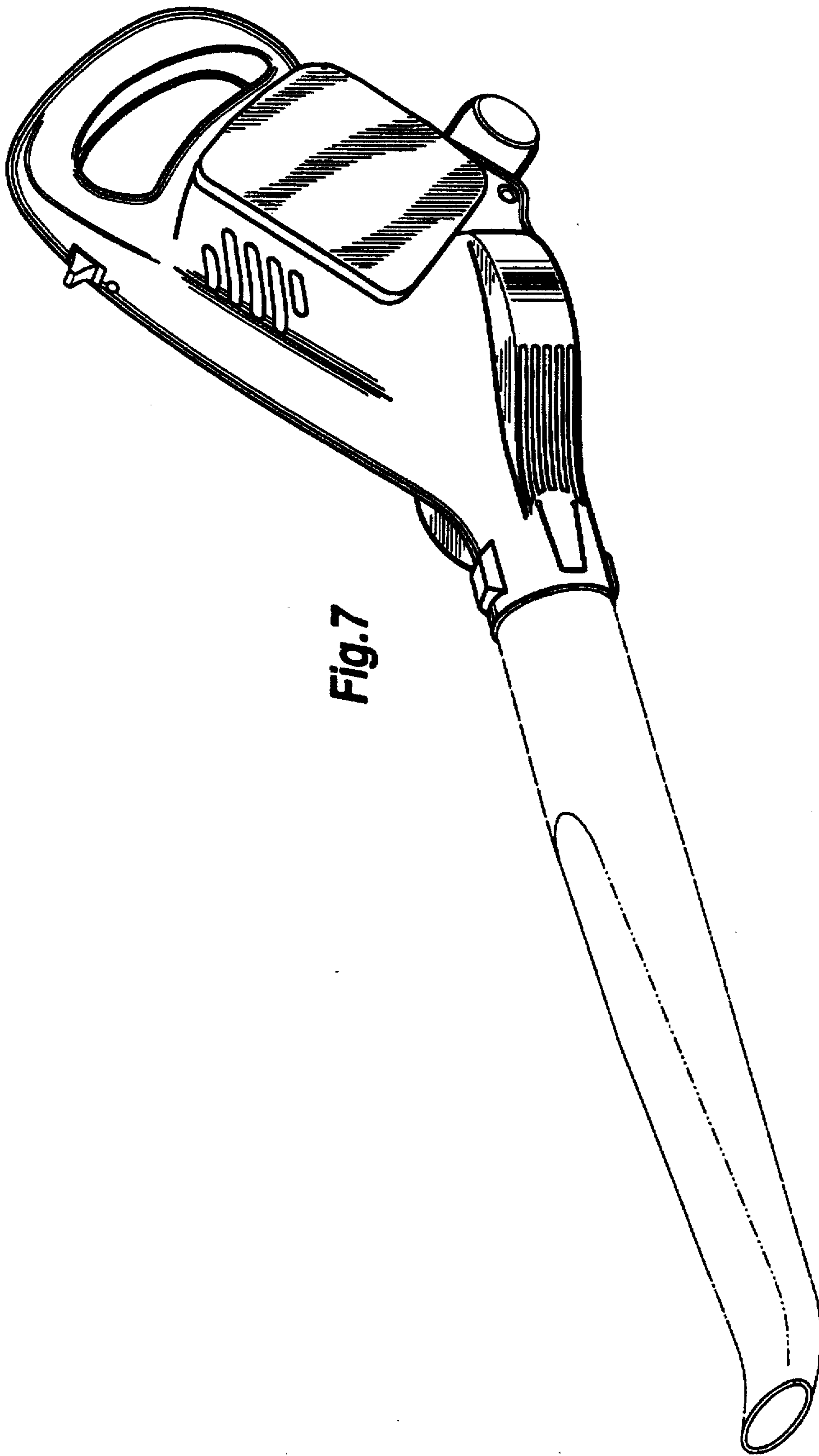
