FIG. 2 is a front elevational view of the cleaning tool;

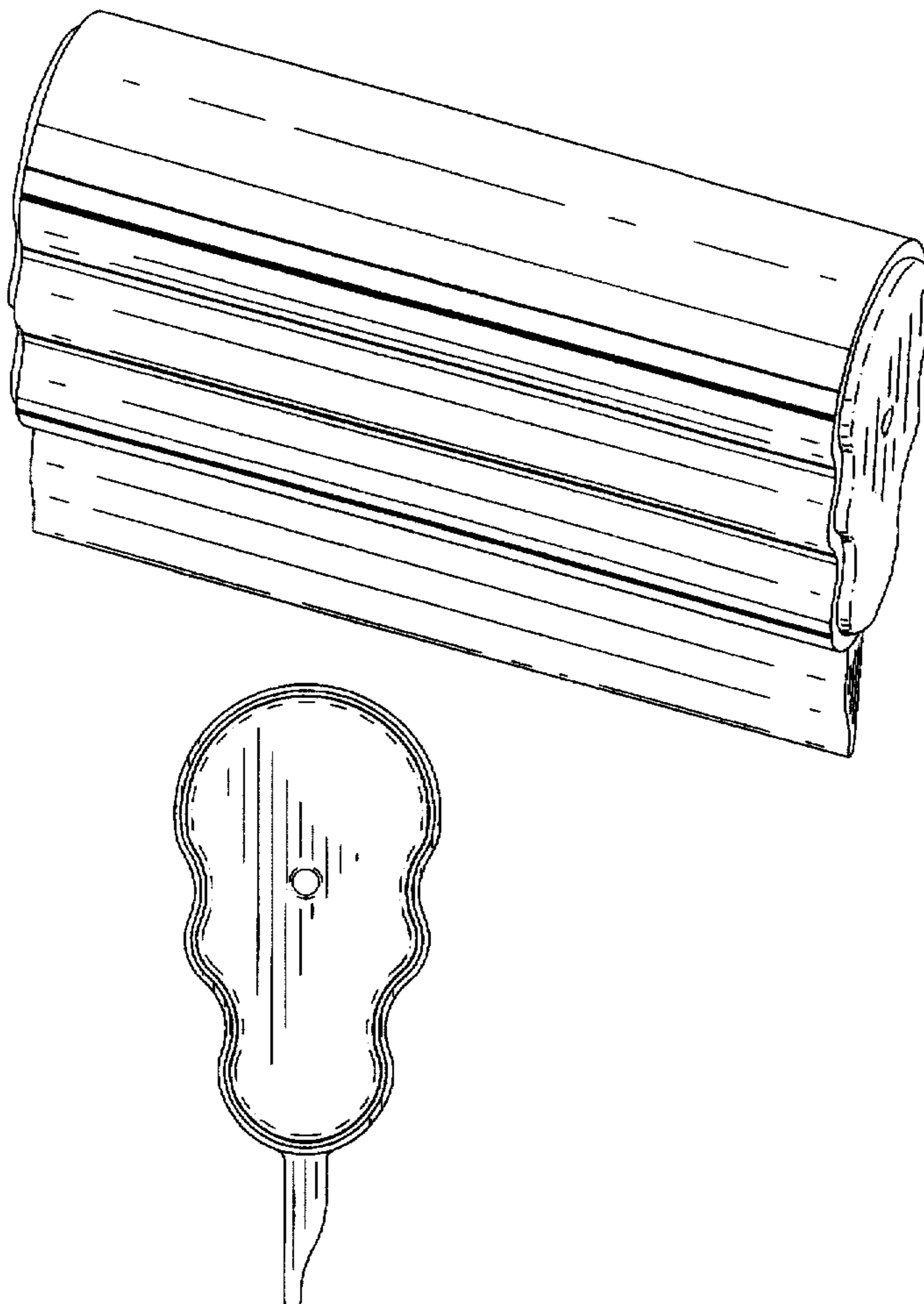
FIG. 3 is a rear elevational view of the cleaning tool;

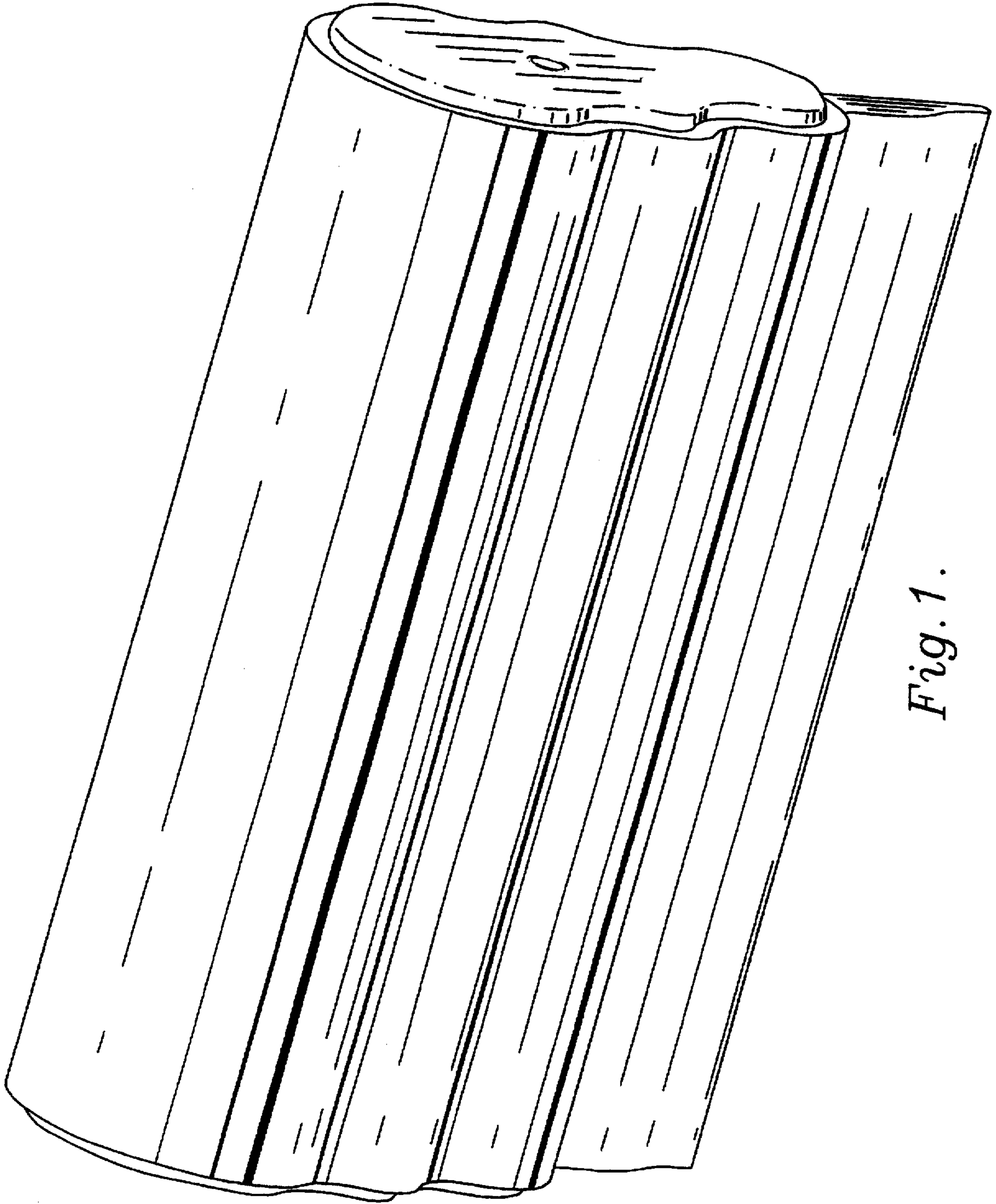
FIG. 4 is an end view of the cleaning tool;

FIG. 5 is a top plan view of the cleaning tool; and,

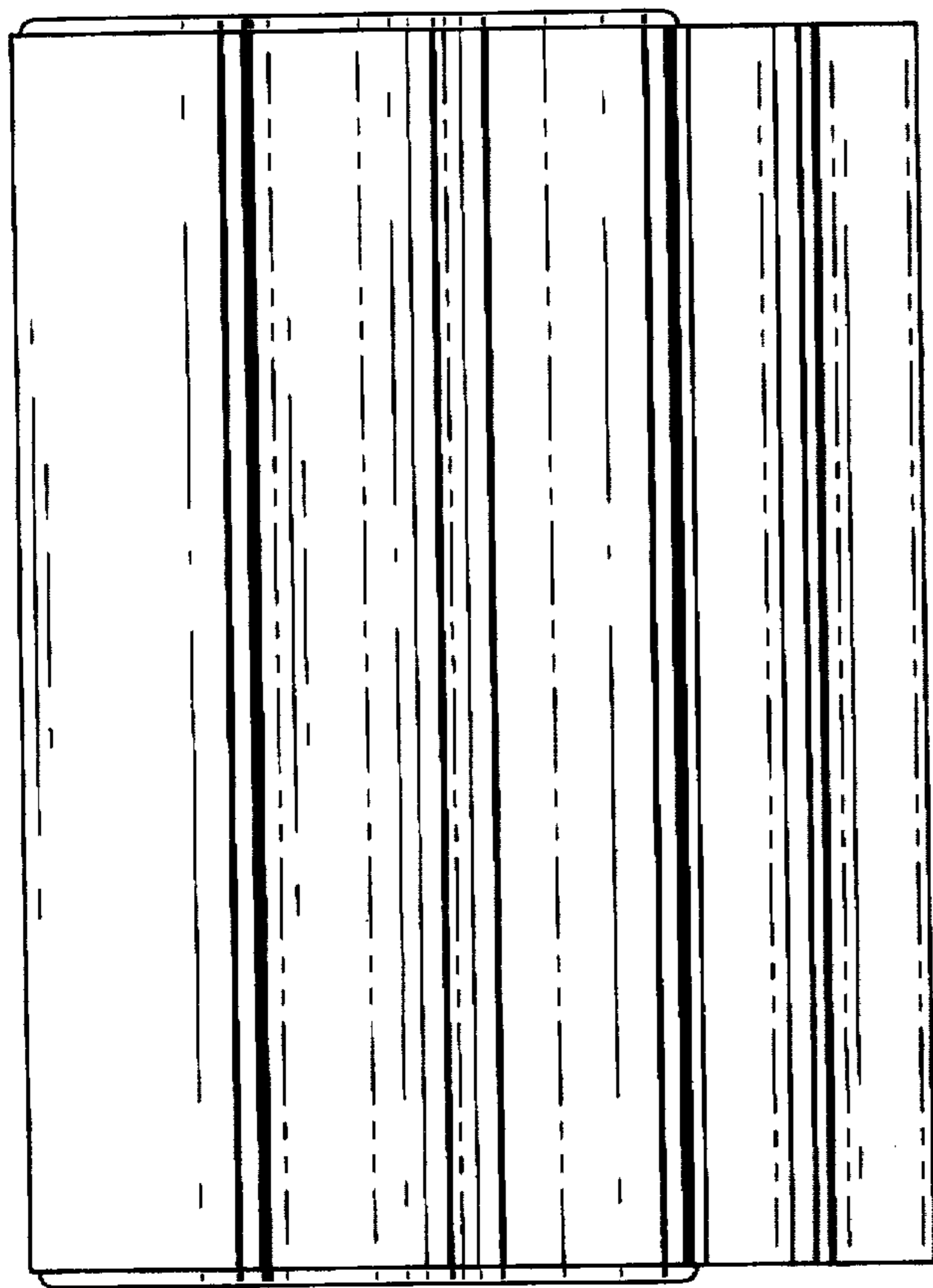
FIG. 6 is a bottom plan view of the cleaning tool.

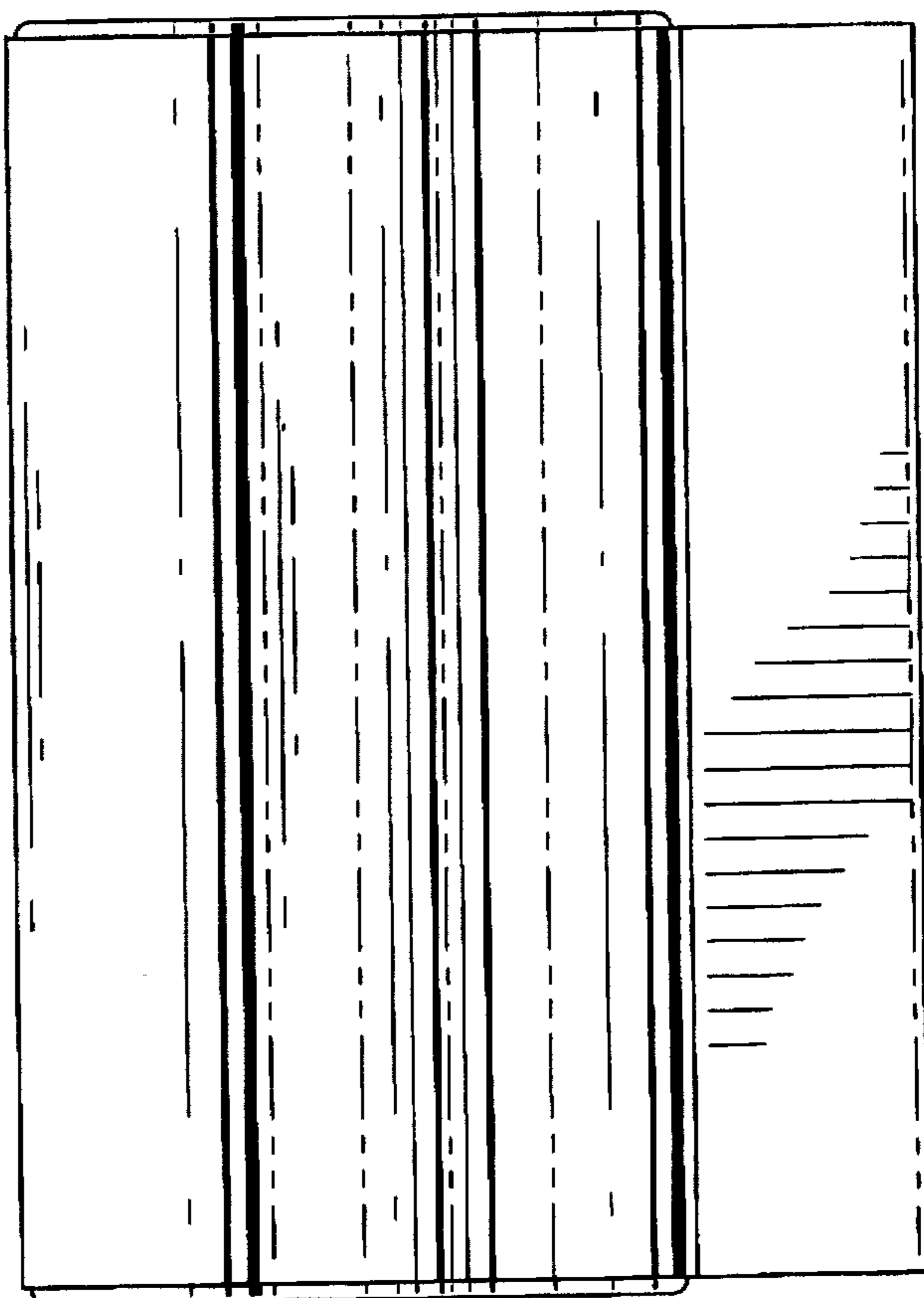


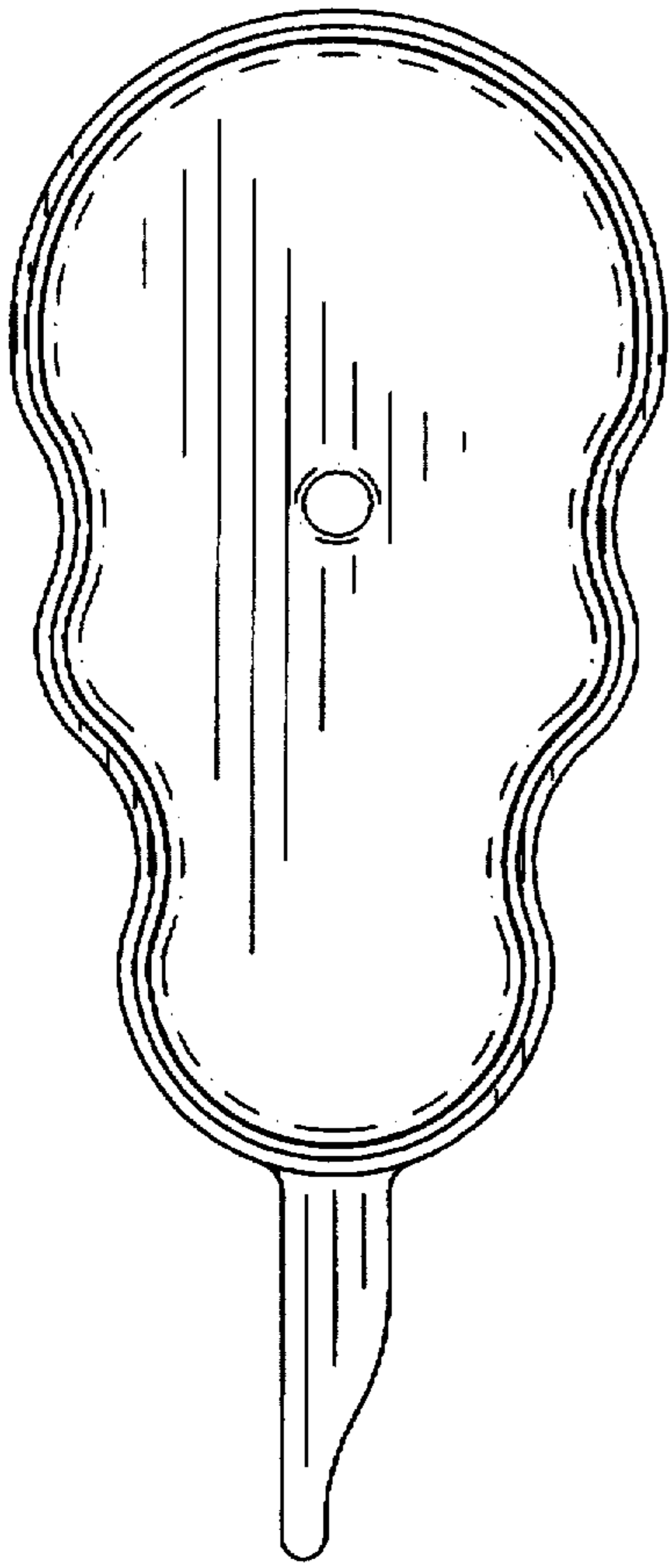

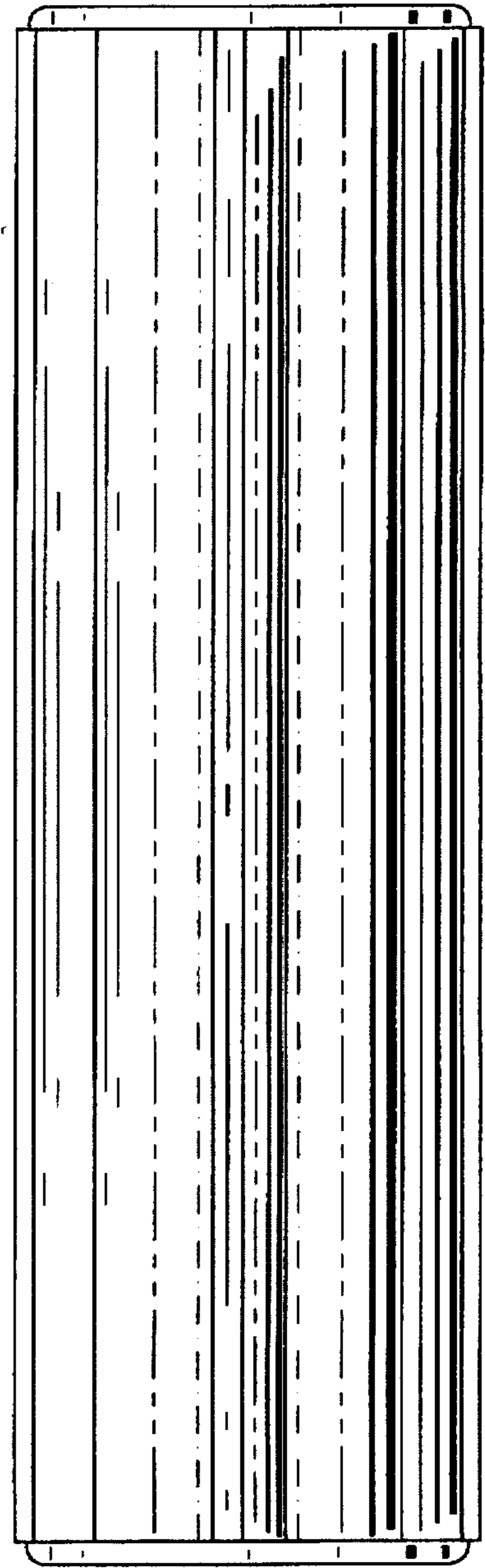
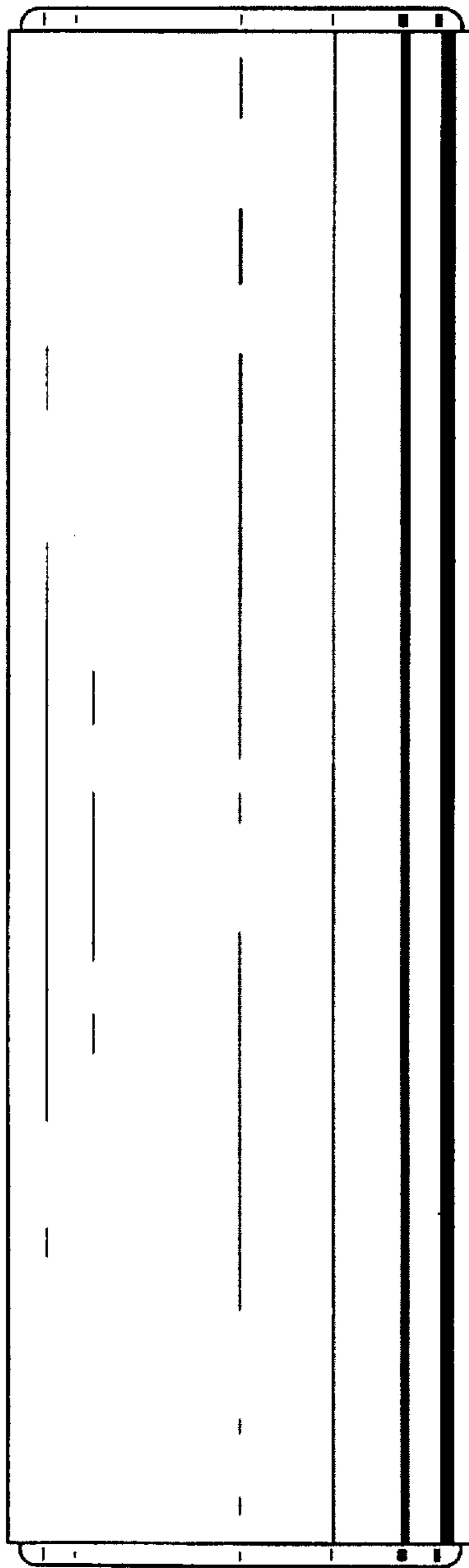
