[57] **CLAIM**

The ornamental design for a head wrap of soft fabric, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation of a head wrap of soft fabric in place on a wearer's head, showing the wrap being worn in a downward position; the broken line drawing of a person's head is for illustrative purposes only and forms no part of the claimed design;

FIG. 2 is a rear elevation thereof;

FIG. 3 is a right side elevation thereof;

FIG. 4 is a left side elevation thereof;

FIG. 5 is a front elevation of a head wrap of soft fabric in place on a wearer's head, showing the wrap being worn in an upward position; the broken line drawing of a person's head is for illustrative purposes only and forms no part of the claimed design;

FIG. 6 is a rear elevation thereof;

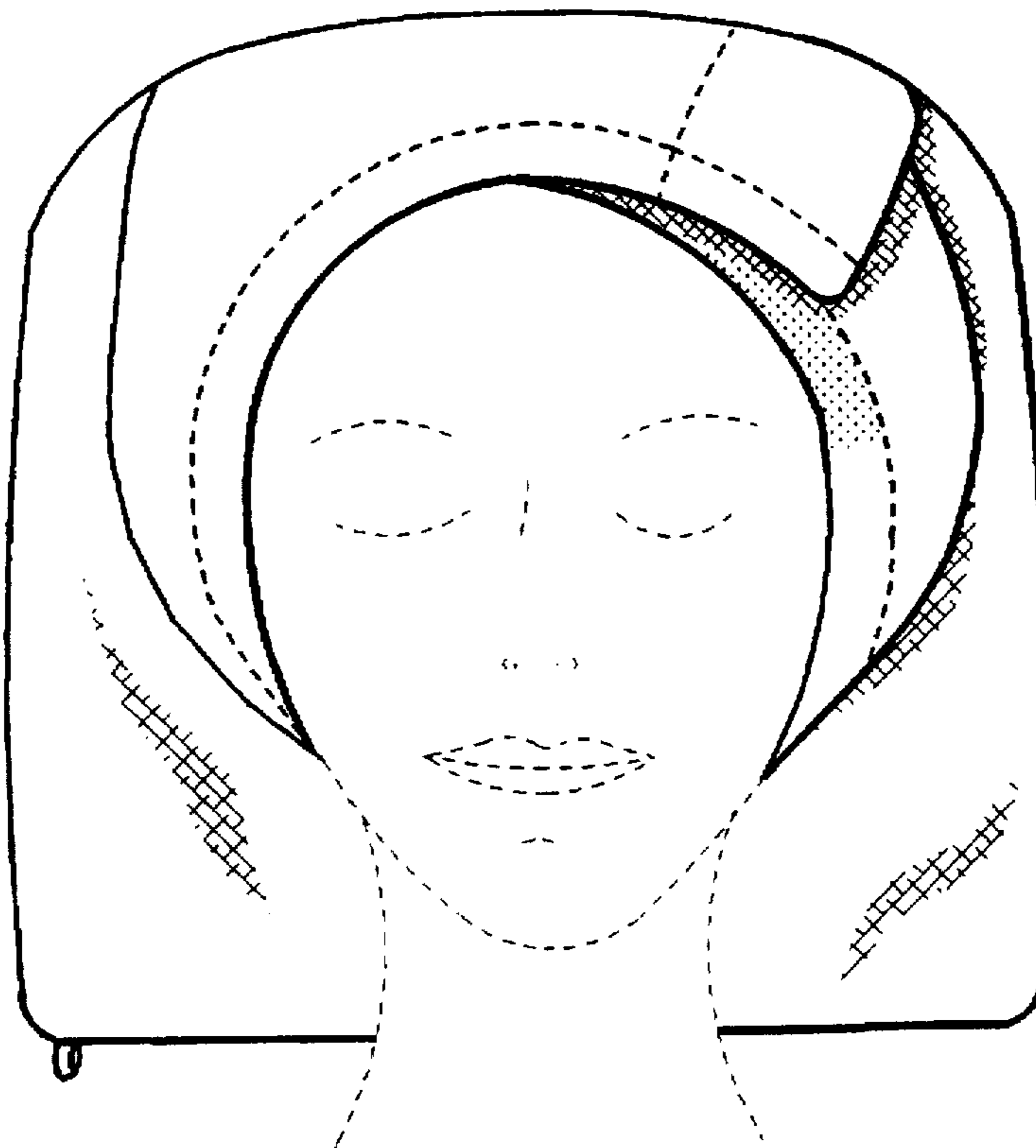
FIG. 7 is a right side elevation thereof;

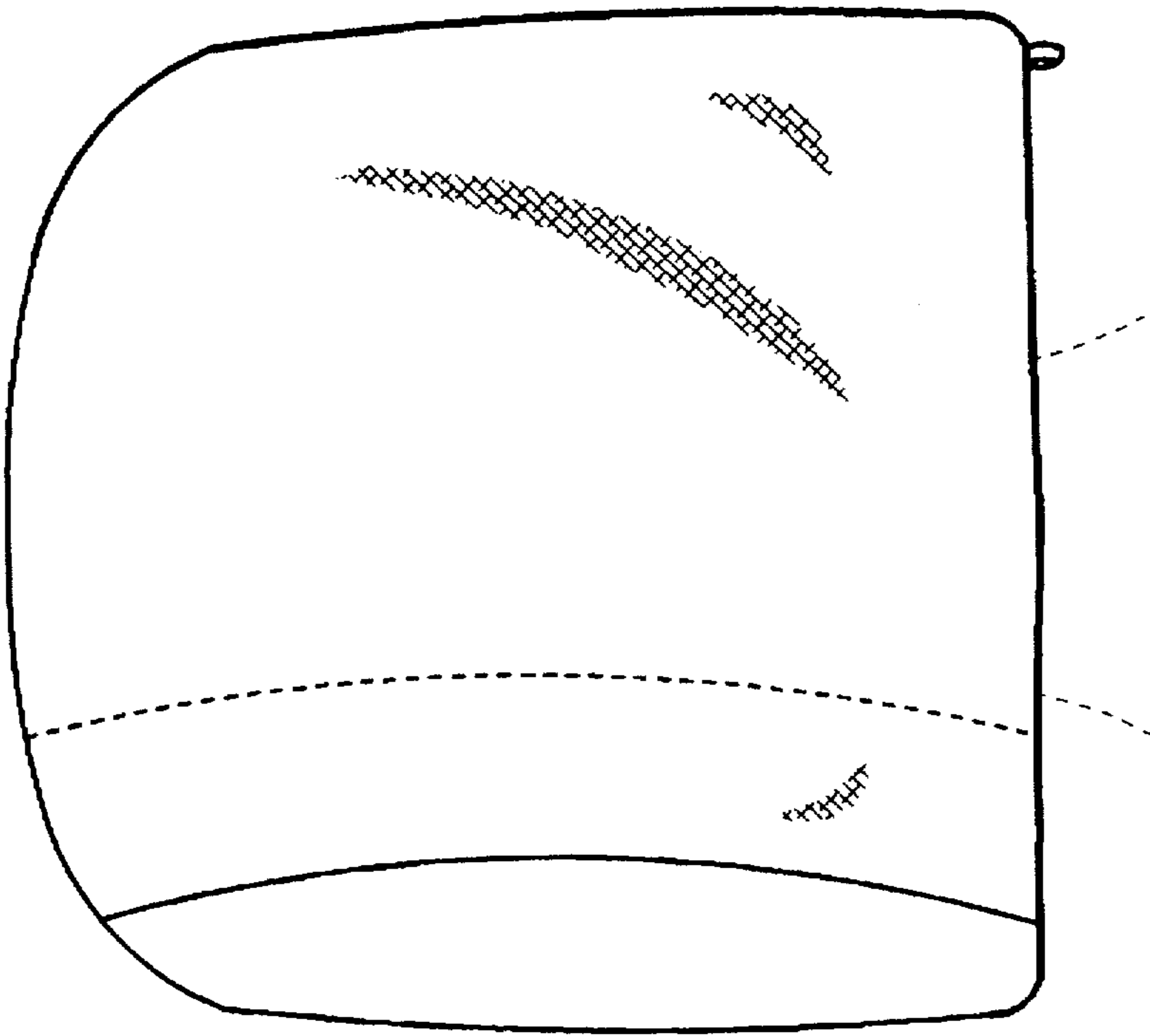

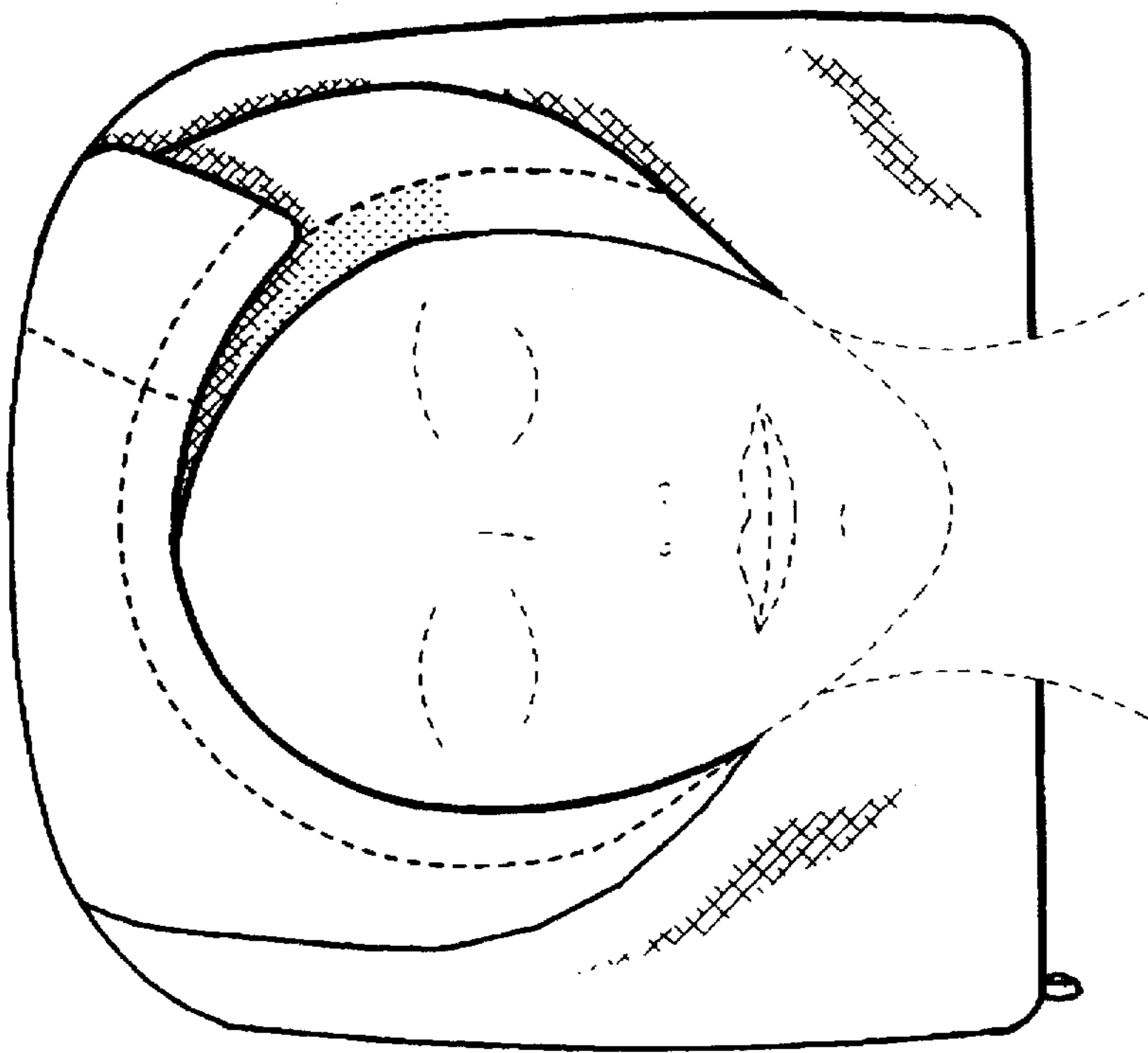

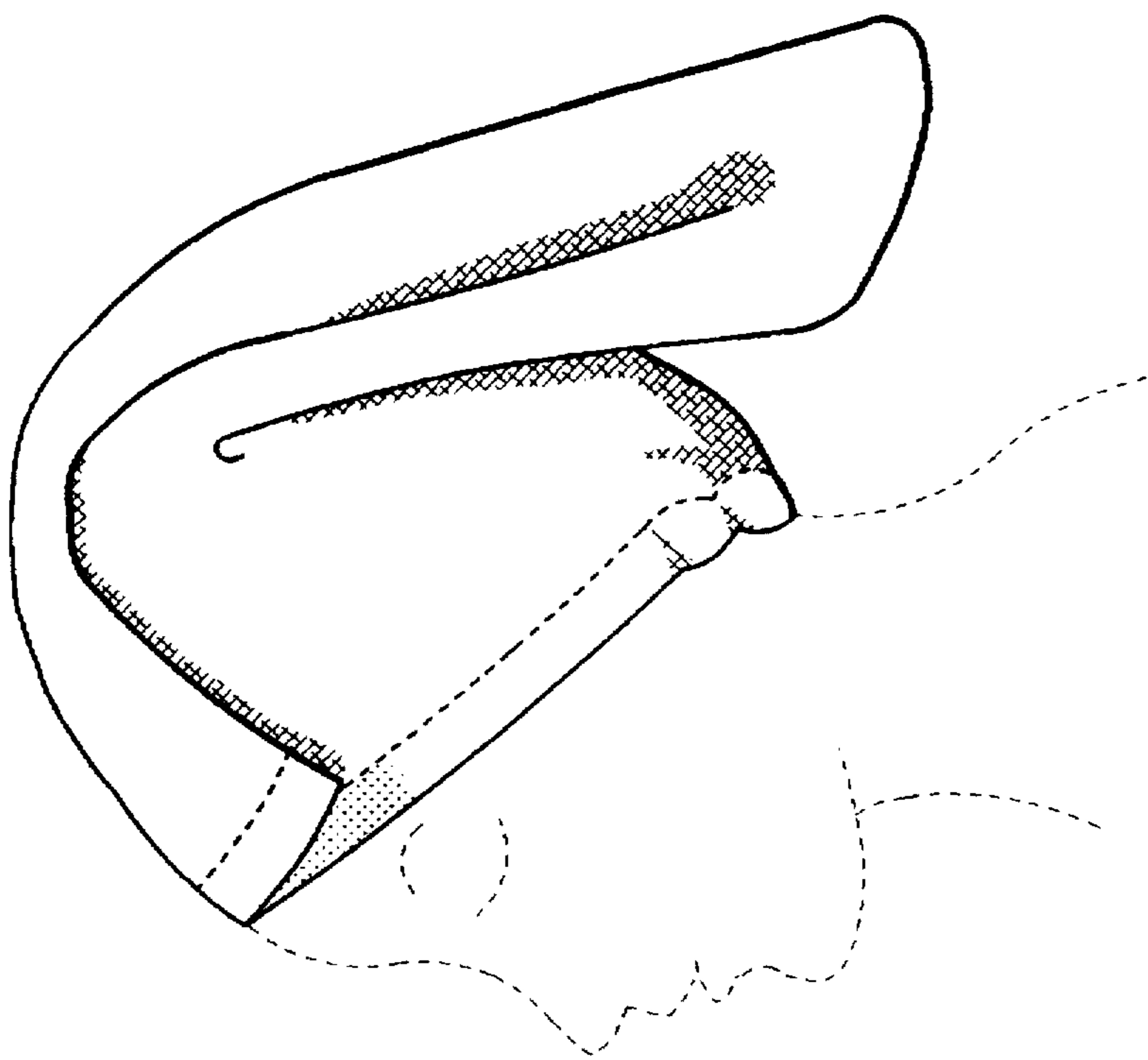

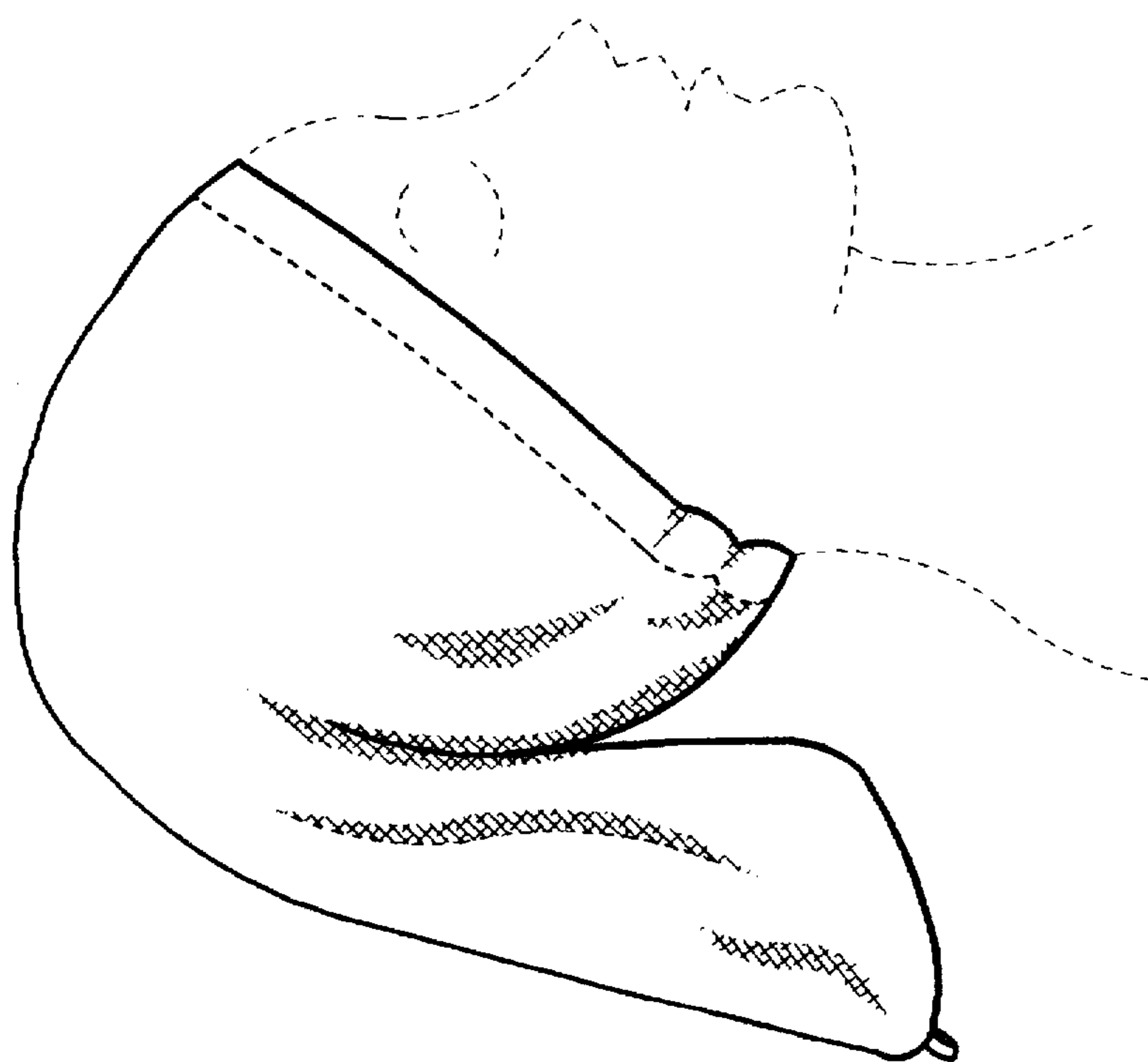

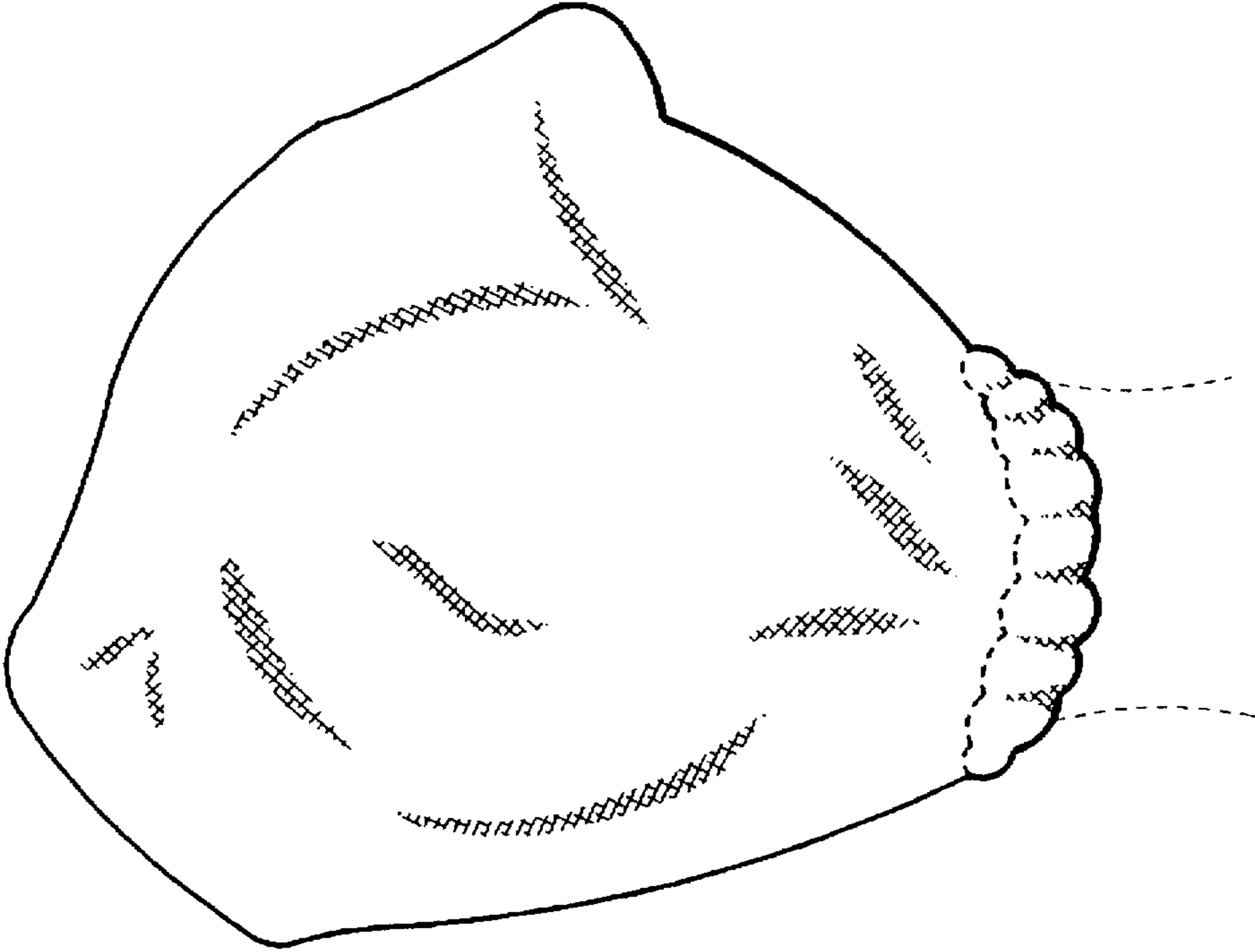

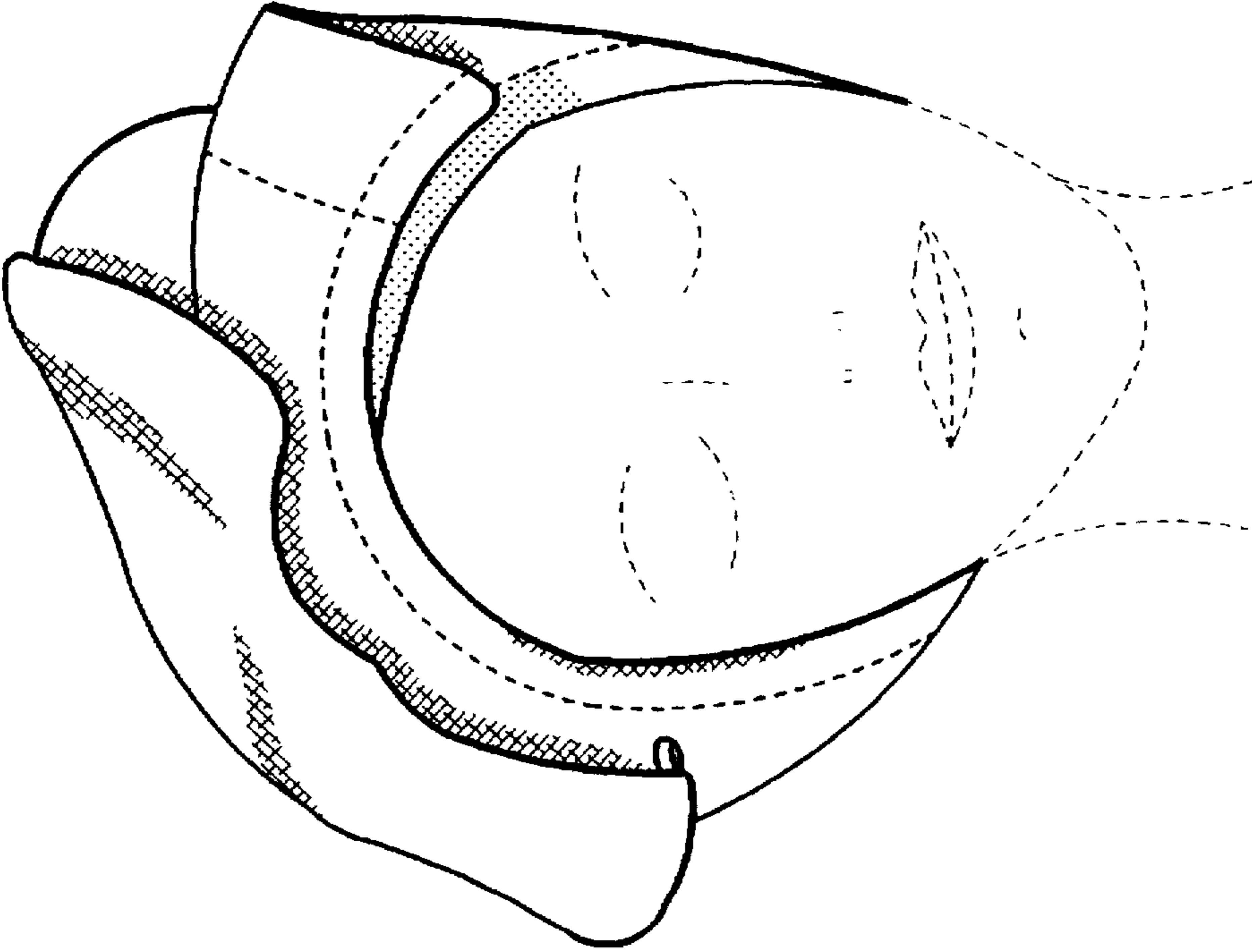

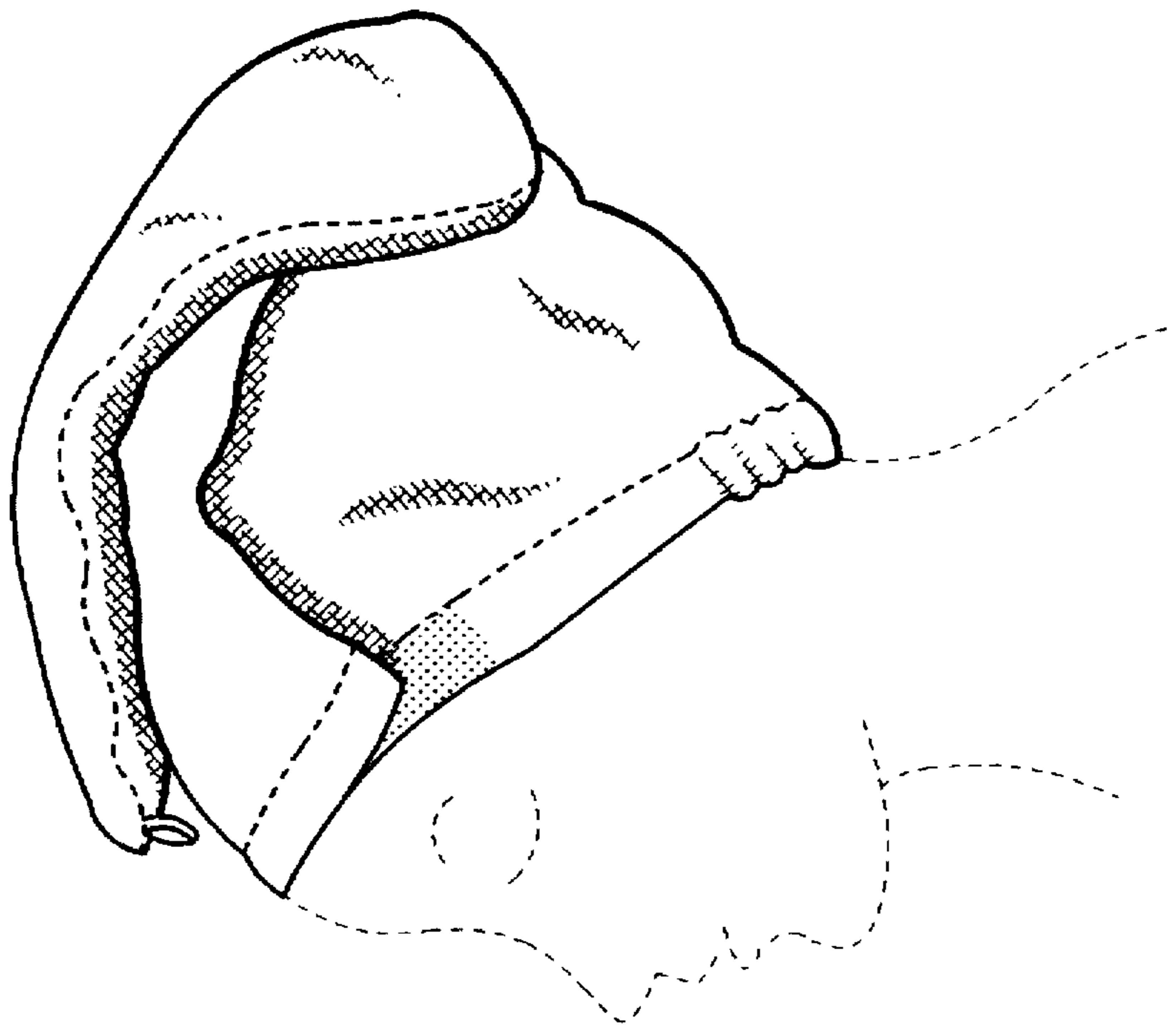

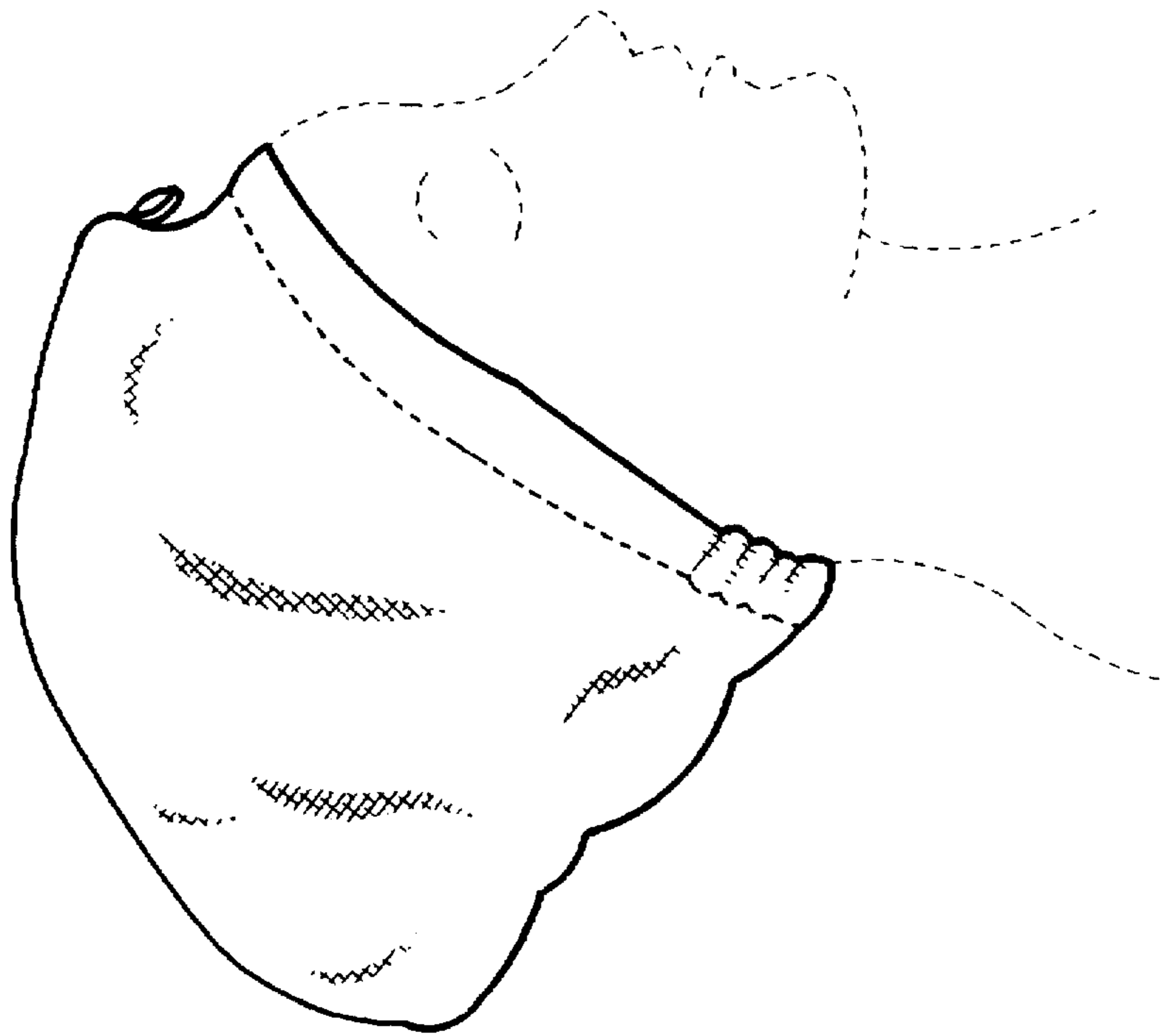

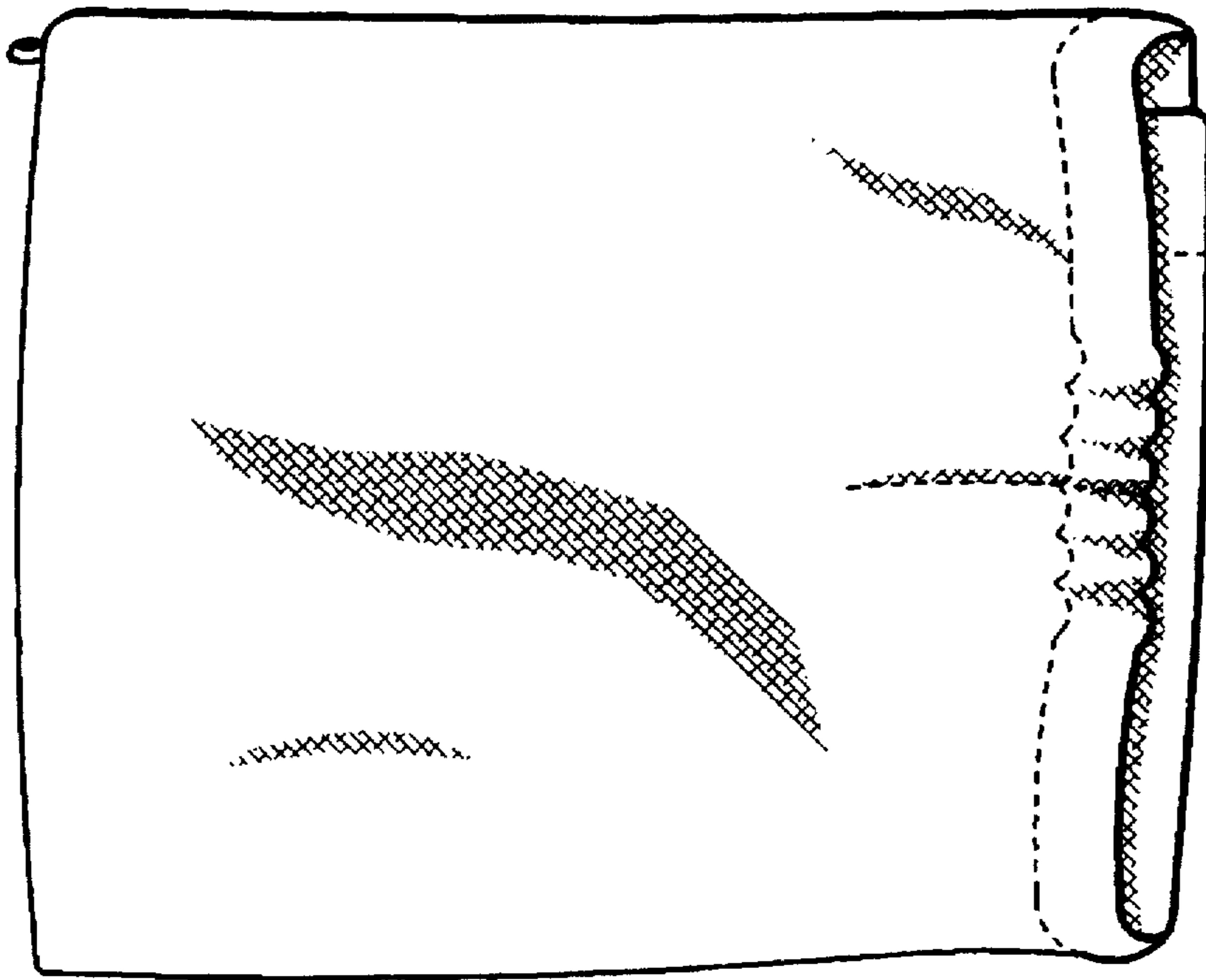

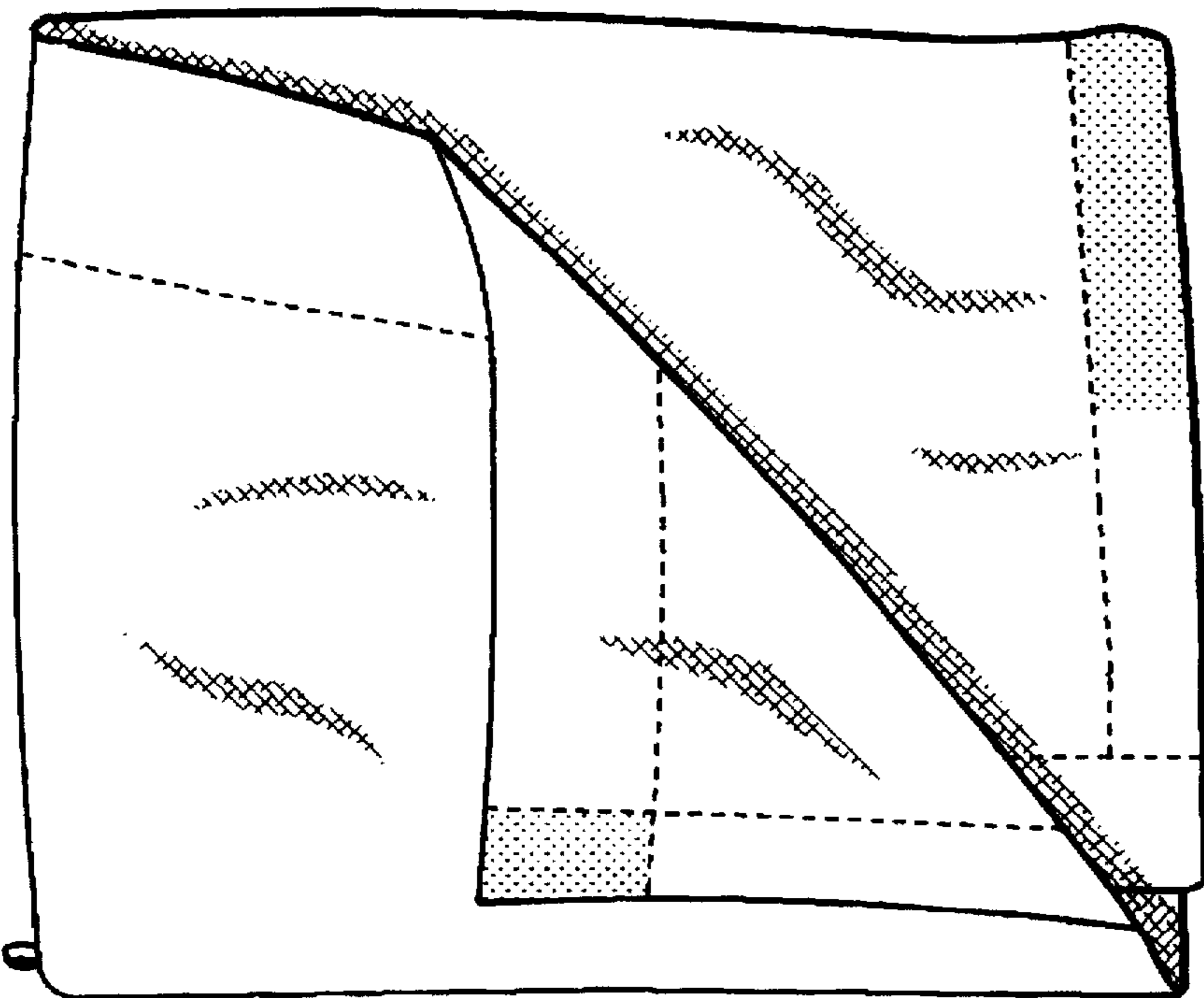
