DESCRIPTION

FIG. 9 is a top plan view of FIG. 7;

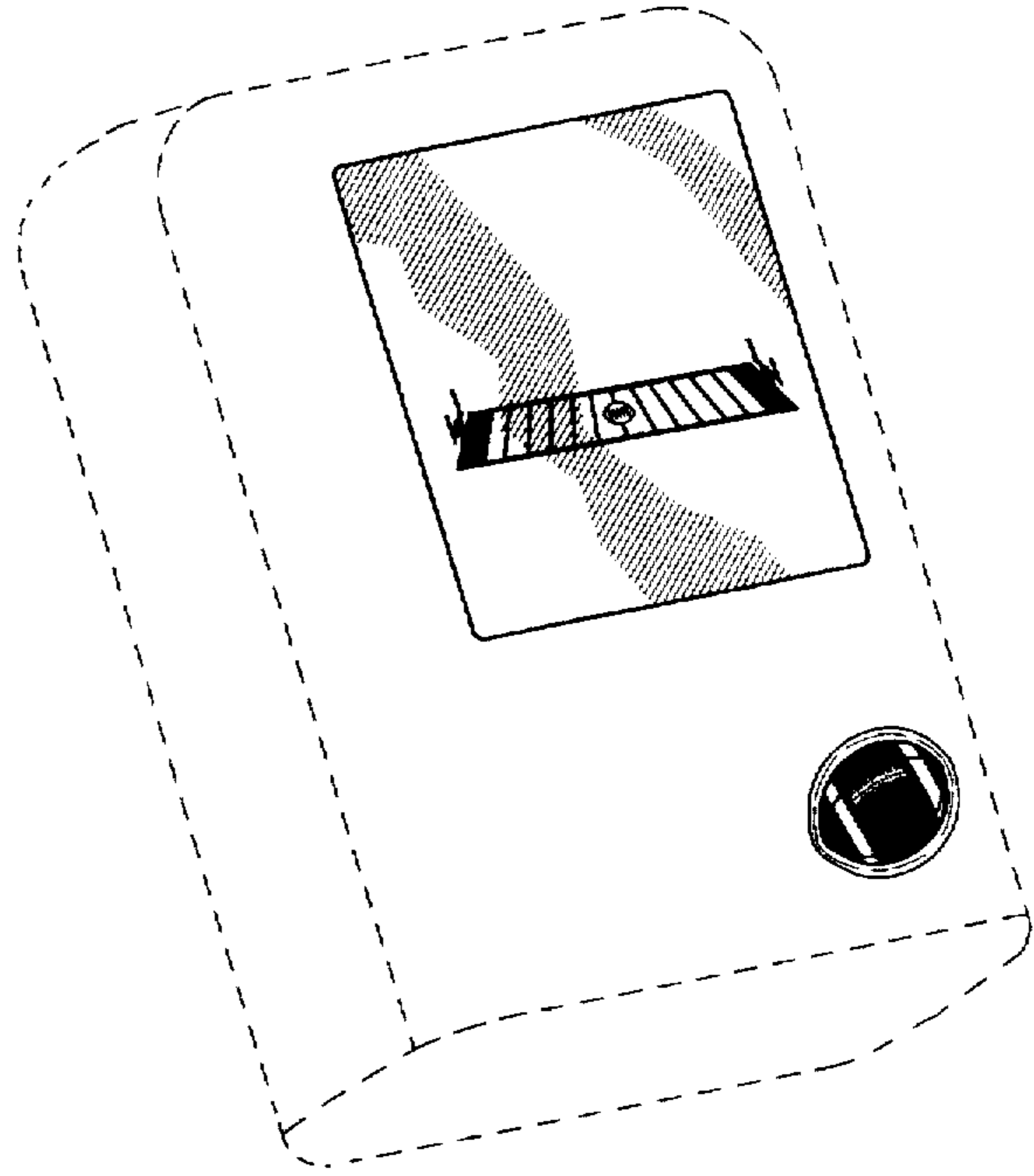
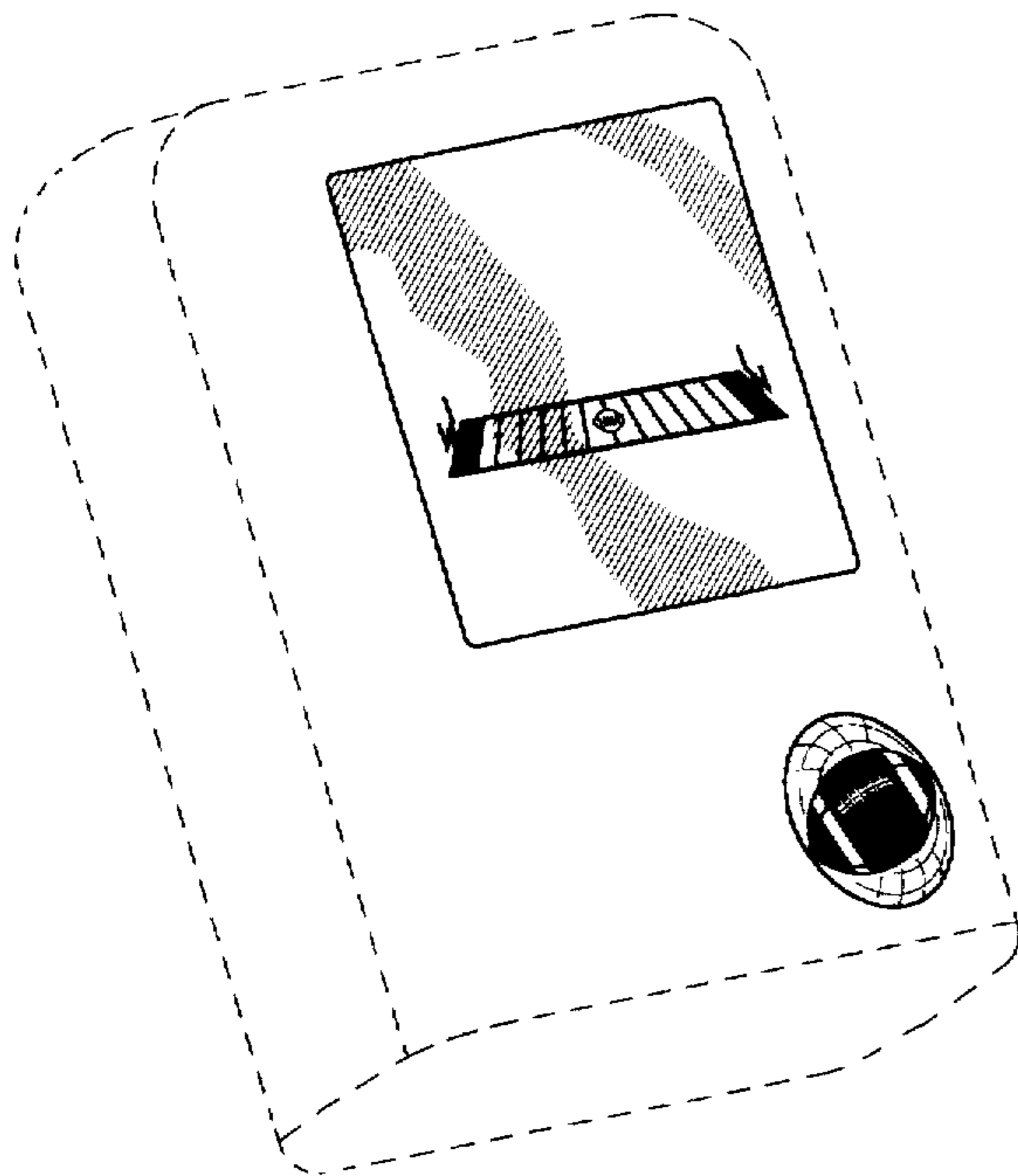
FIG. 10 is a left side elevational view of FIG. 7;

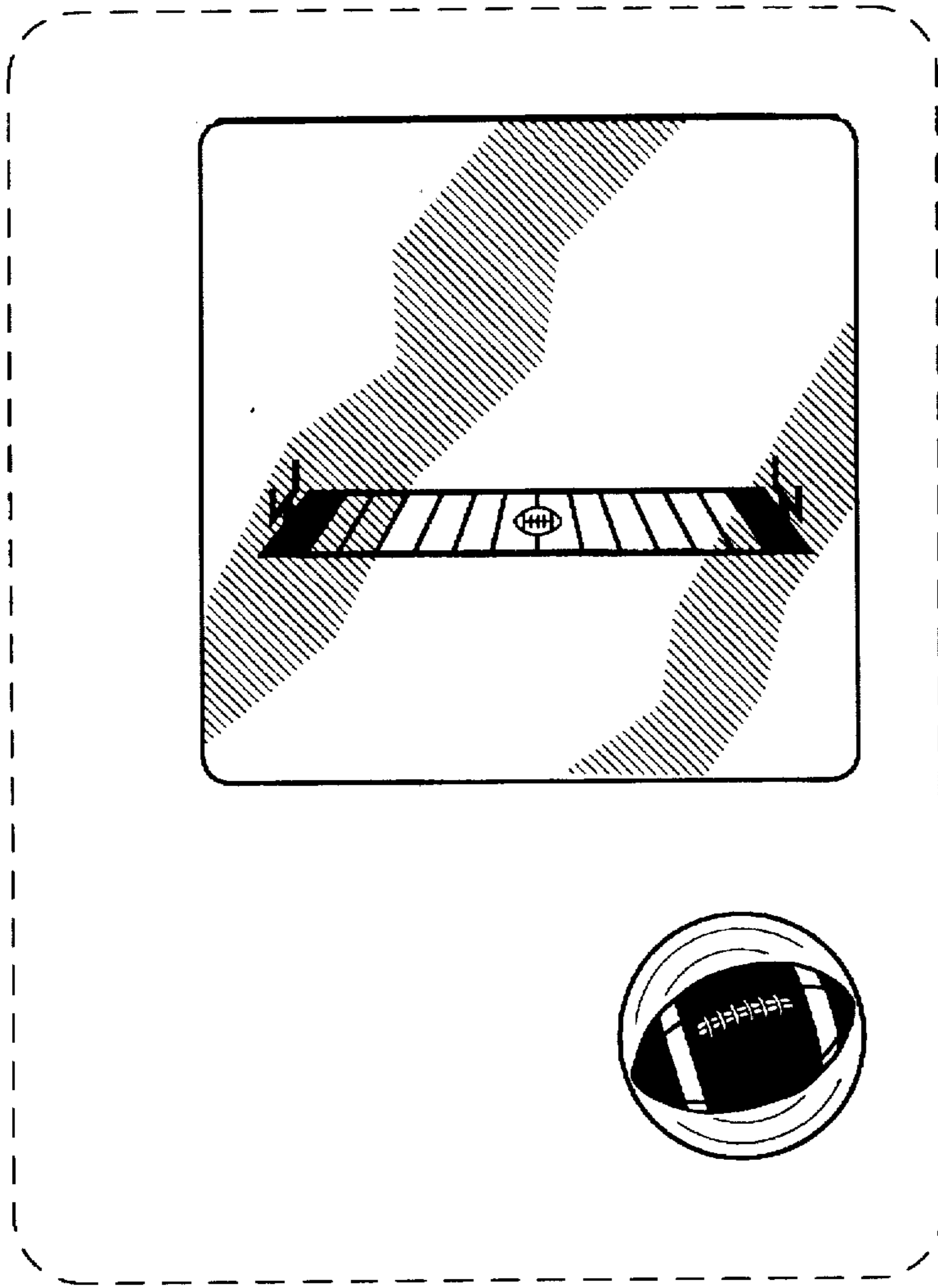

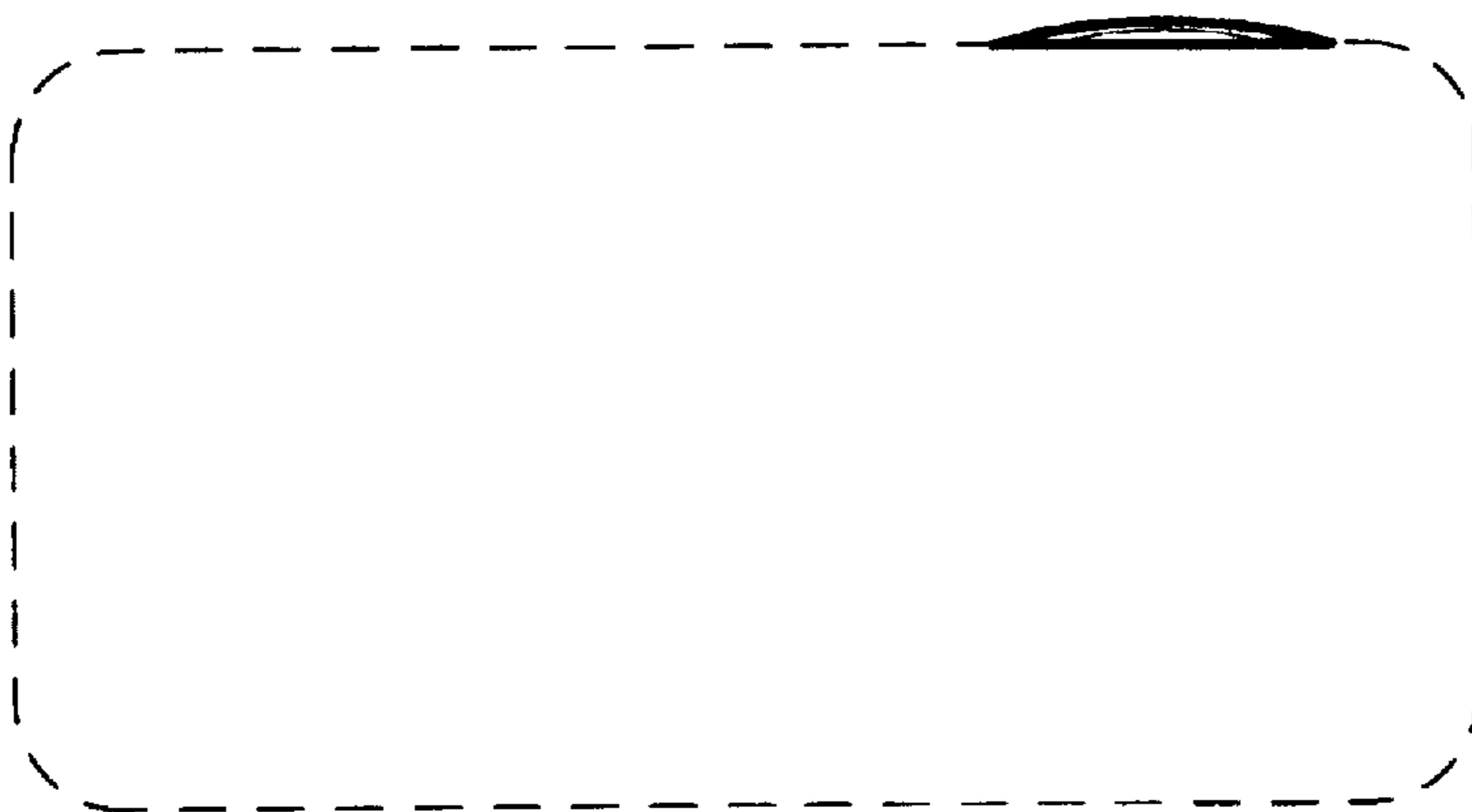

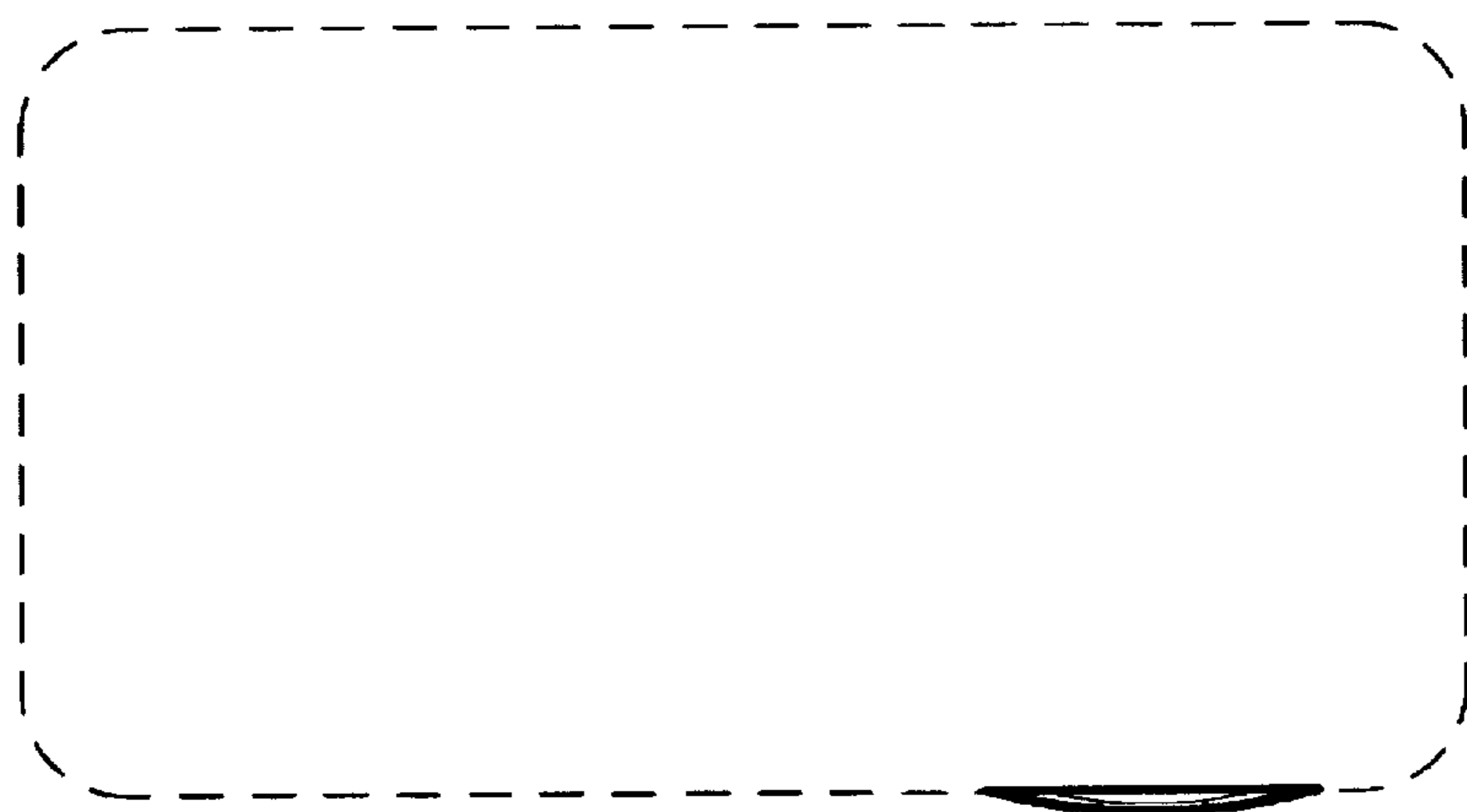

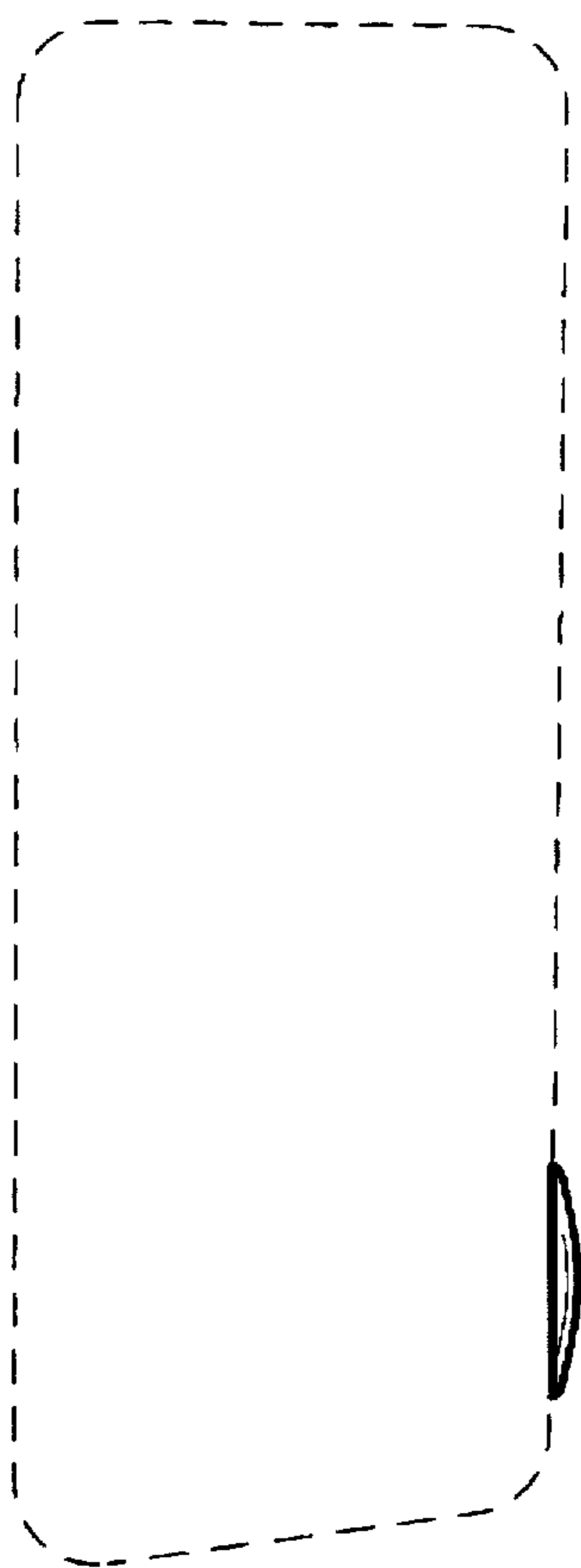

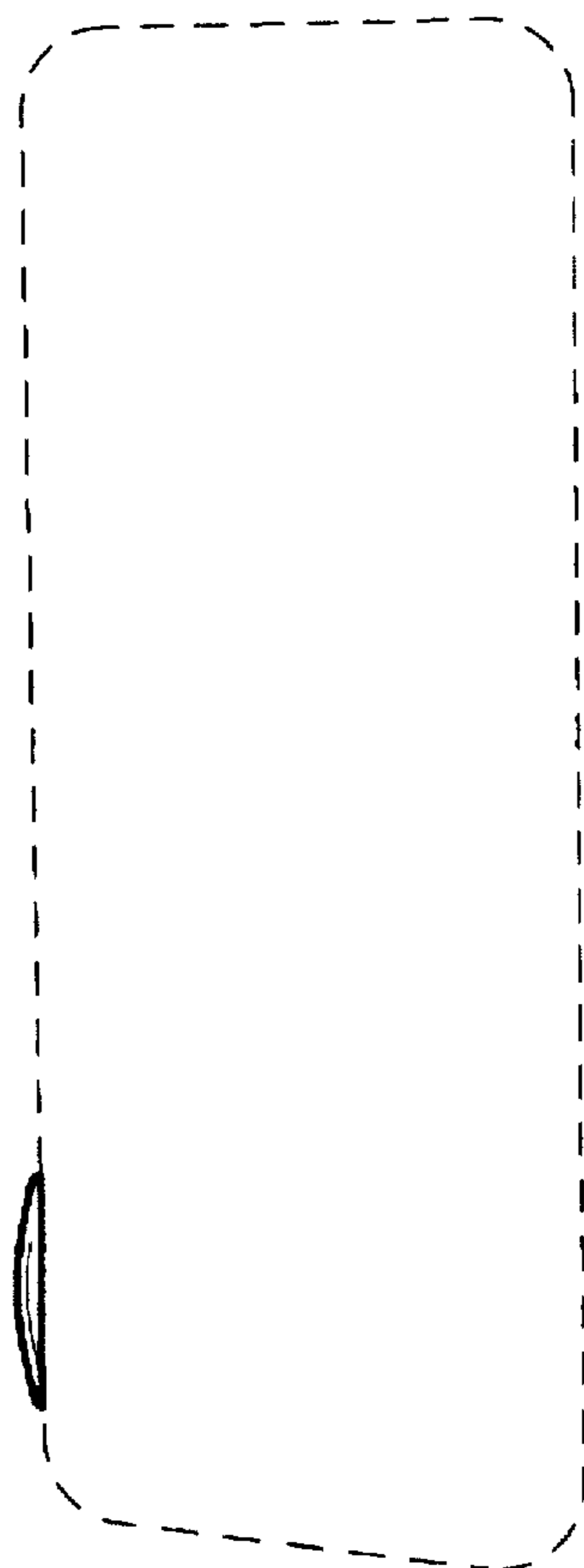

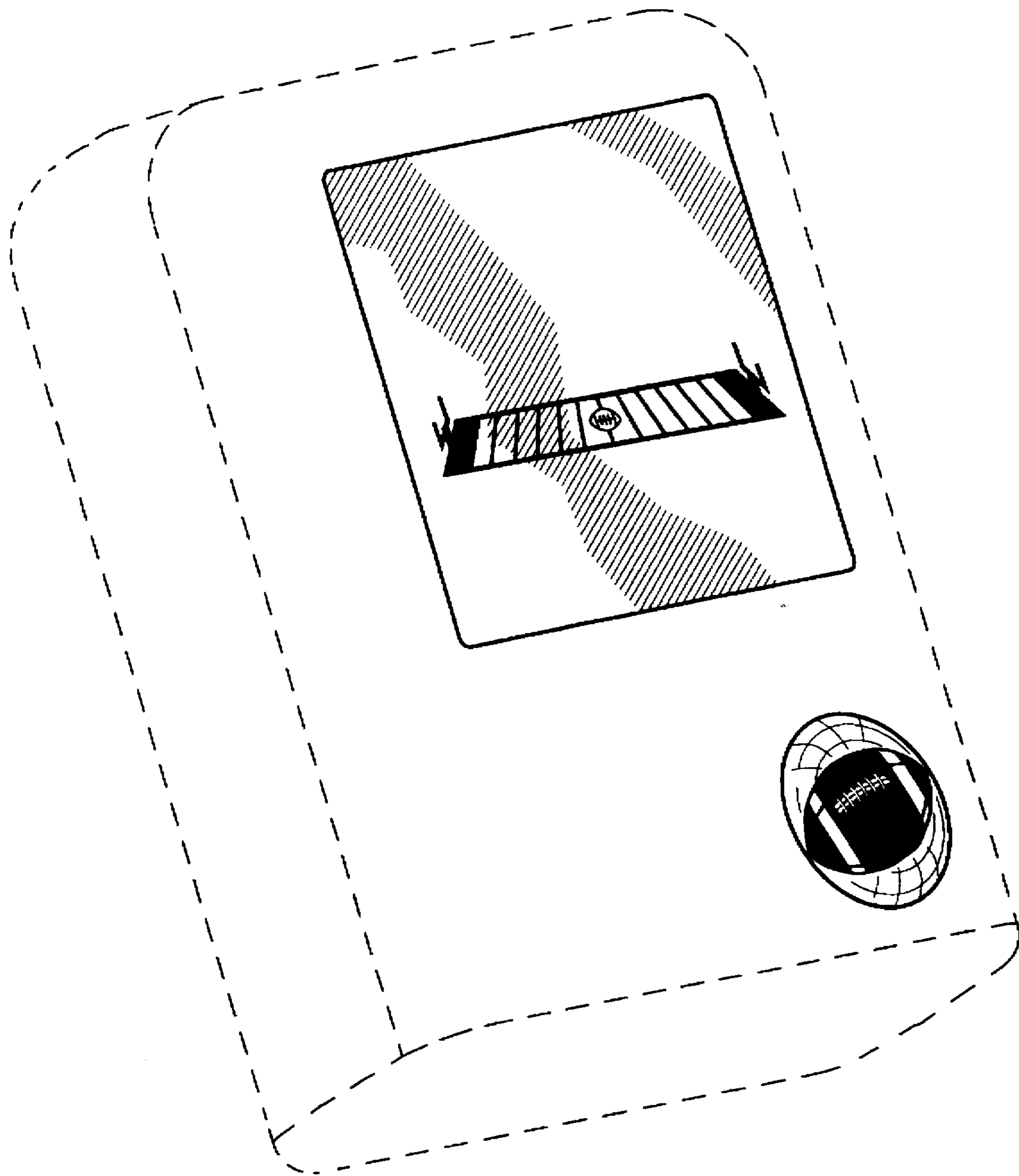

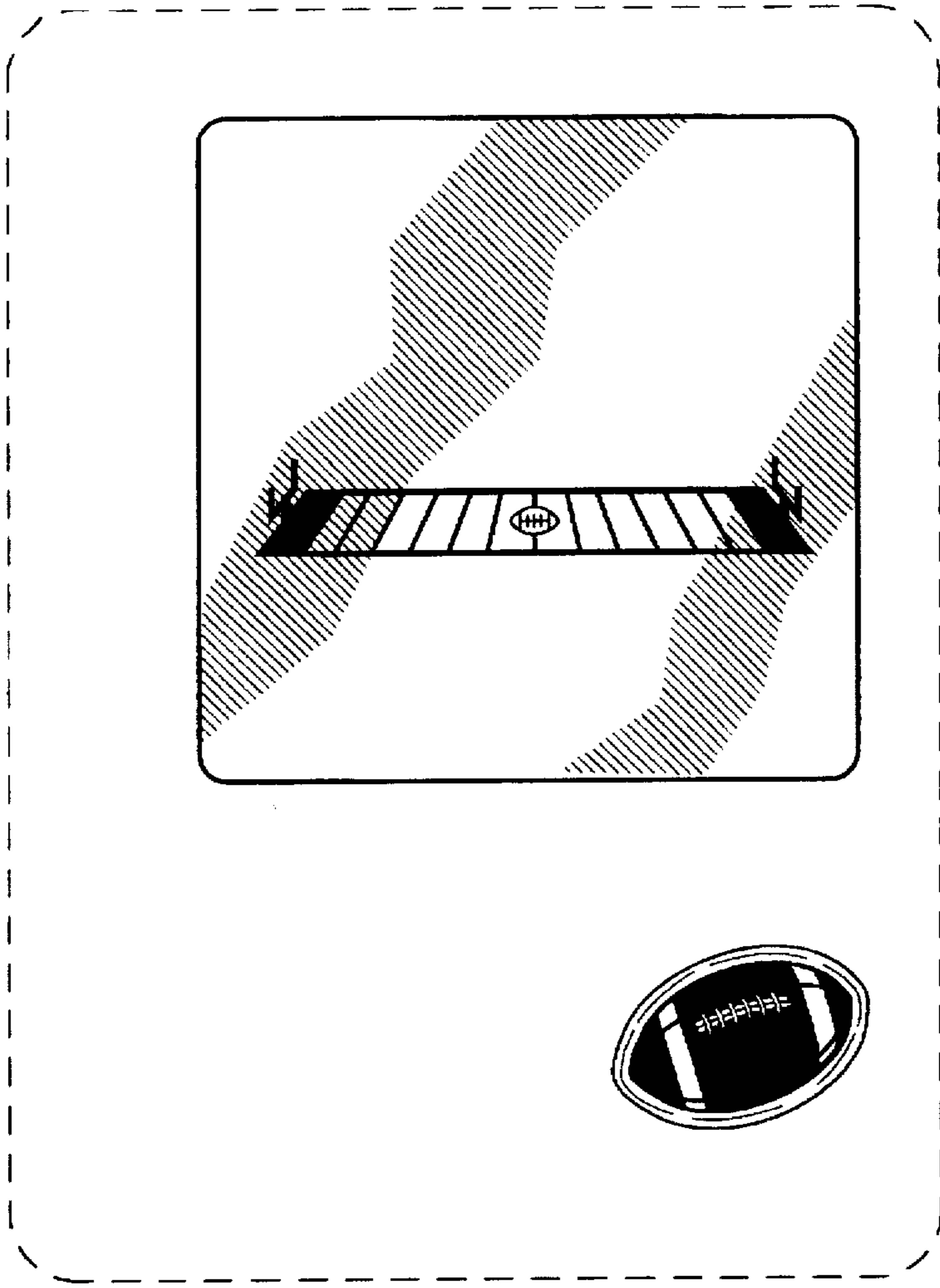

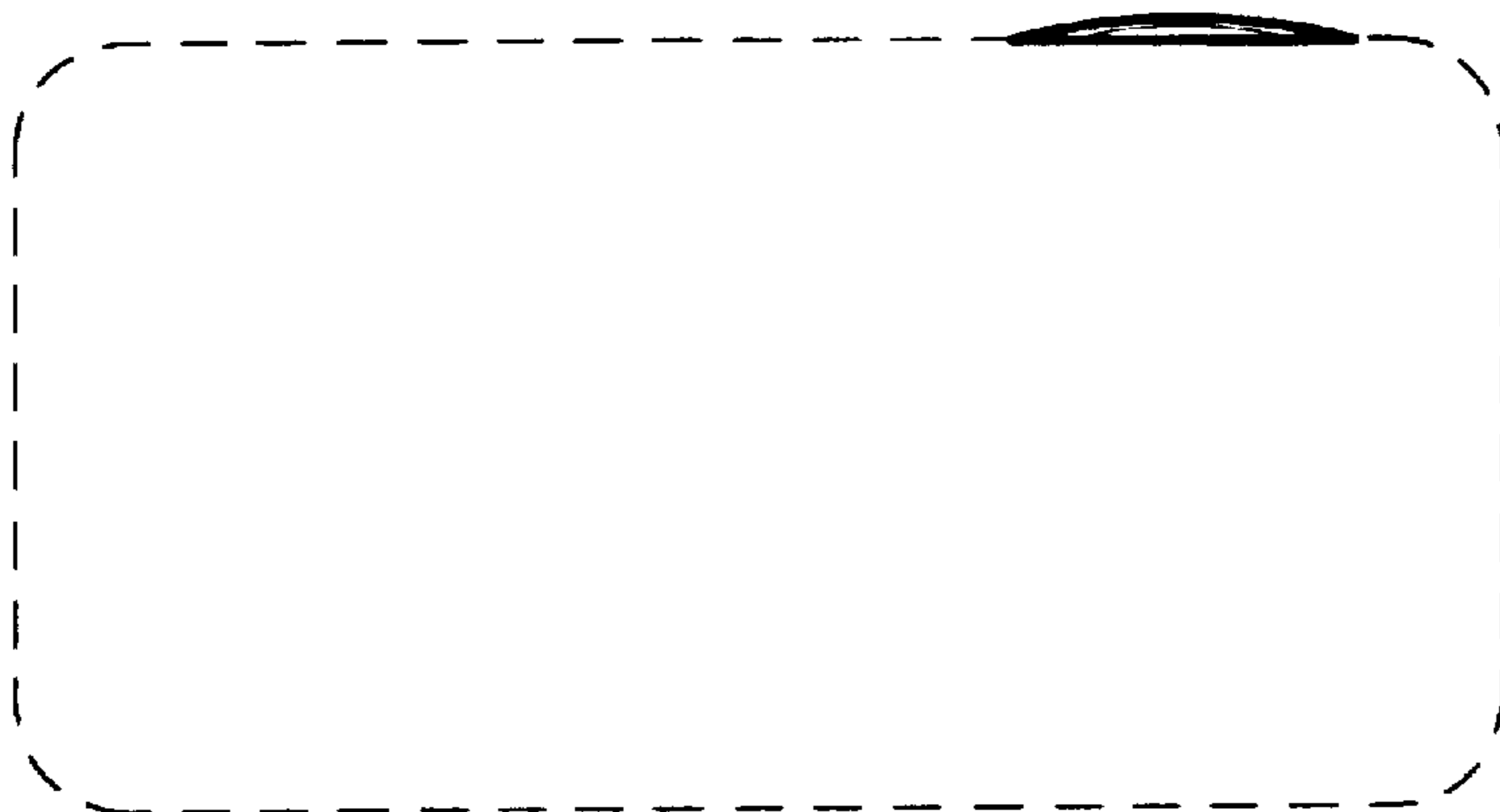

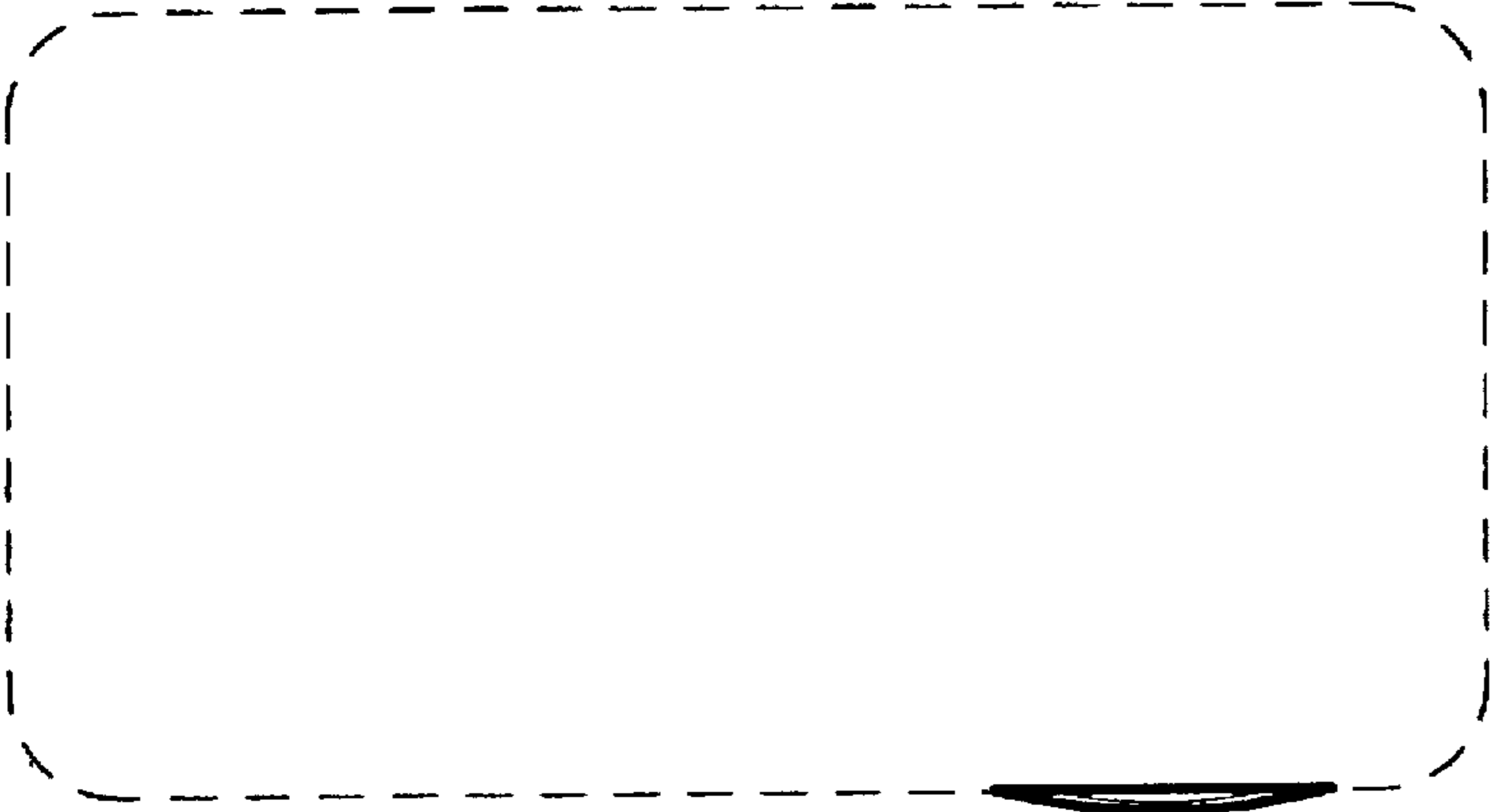

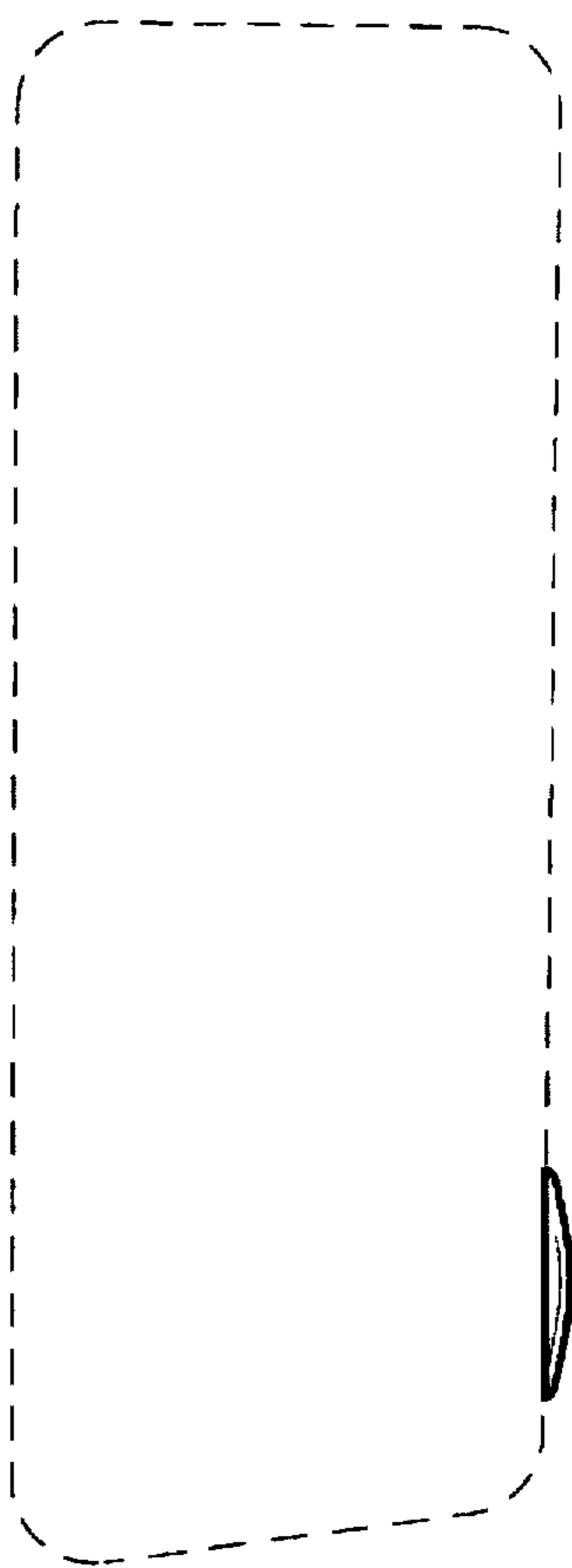

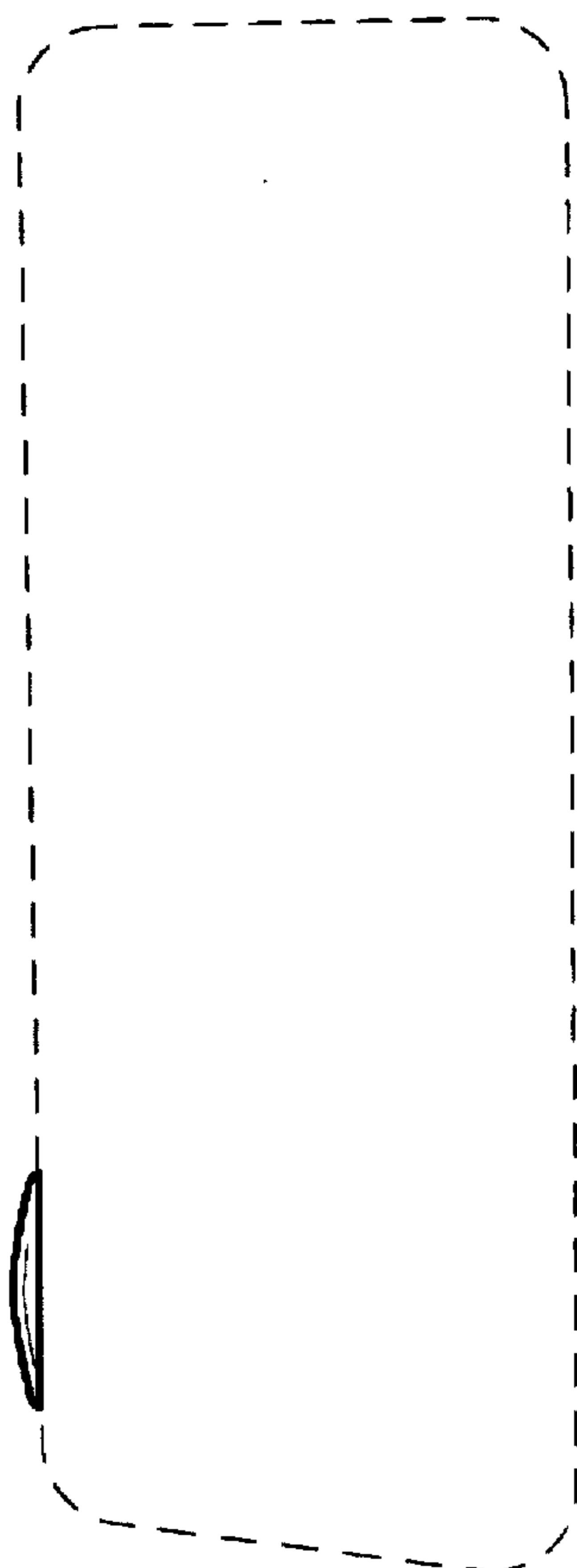

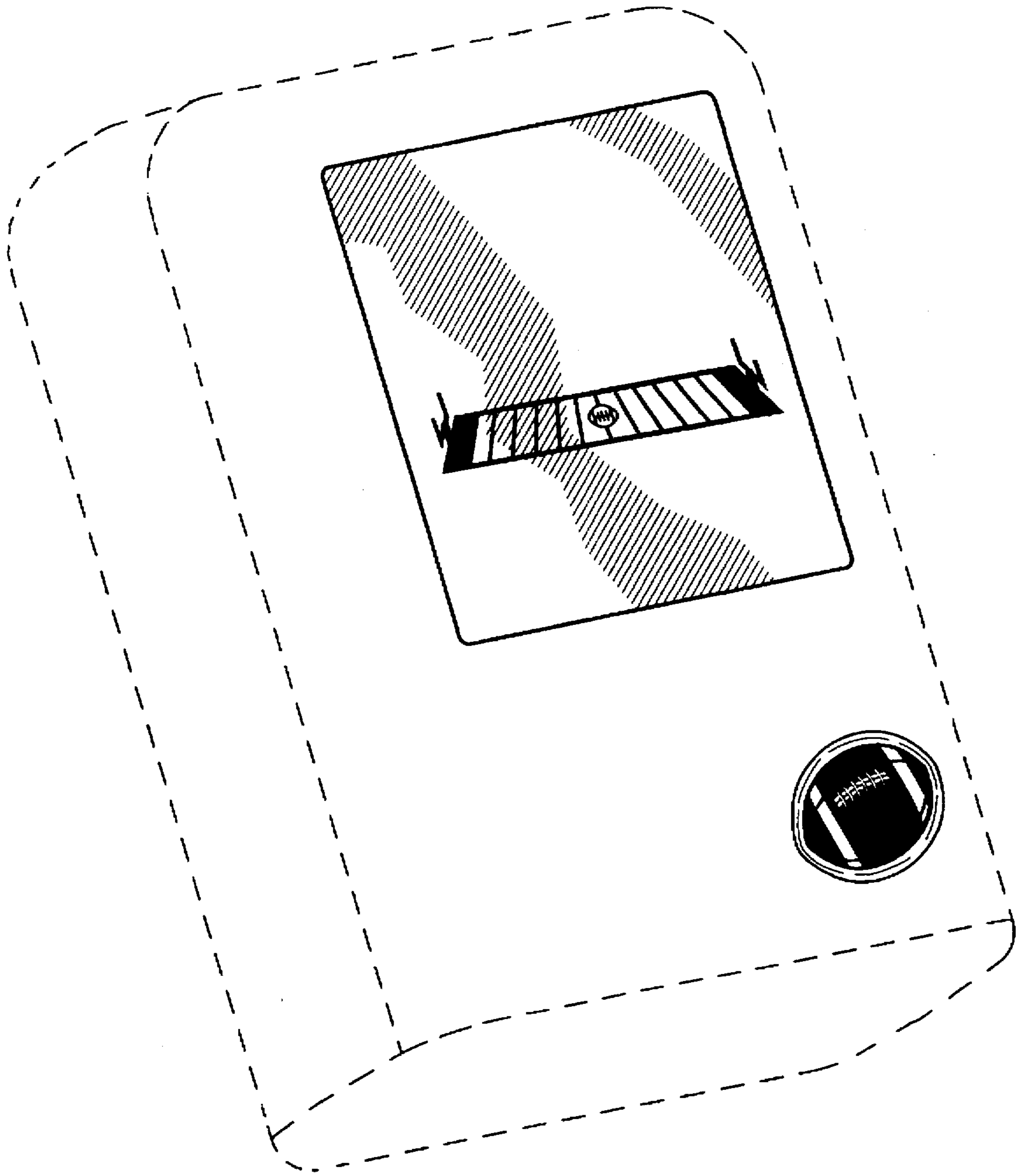
