[57] **CLAIM**

The ornamental design for a car interior lamp, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from the front, bottom and left

side of a car interior lamp showing one embodiment of my design;

FIG. 2 is a front view of the car interior lamp shown in FIG. 1 (the rear view being a mirror image thereof);

FIG. 3 is a left side elevational view of the car interior lamp shown in FIG. 1 (the right side being a mirror image thereof);

FIG. 4 is a top plan view of the car interior lamp shown in FIG. 1;

FIG. 5 is a bottom plan view of the car interior lamp shown in FIG. 1;

FIG. 6 is a perspective view from the front, bottom and left side of a car interior lamp showing a second embodiment of my design;

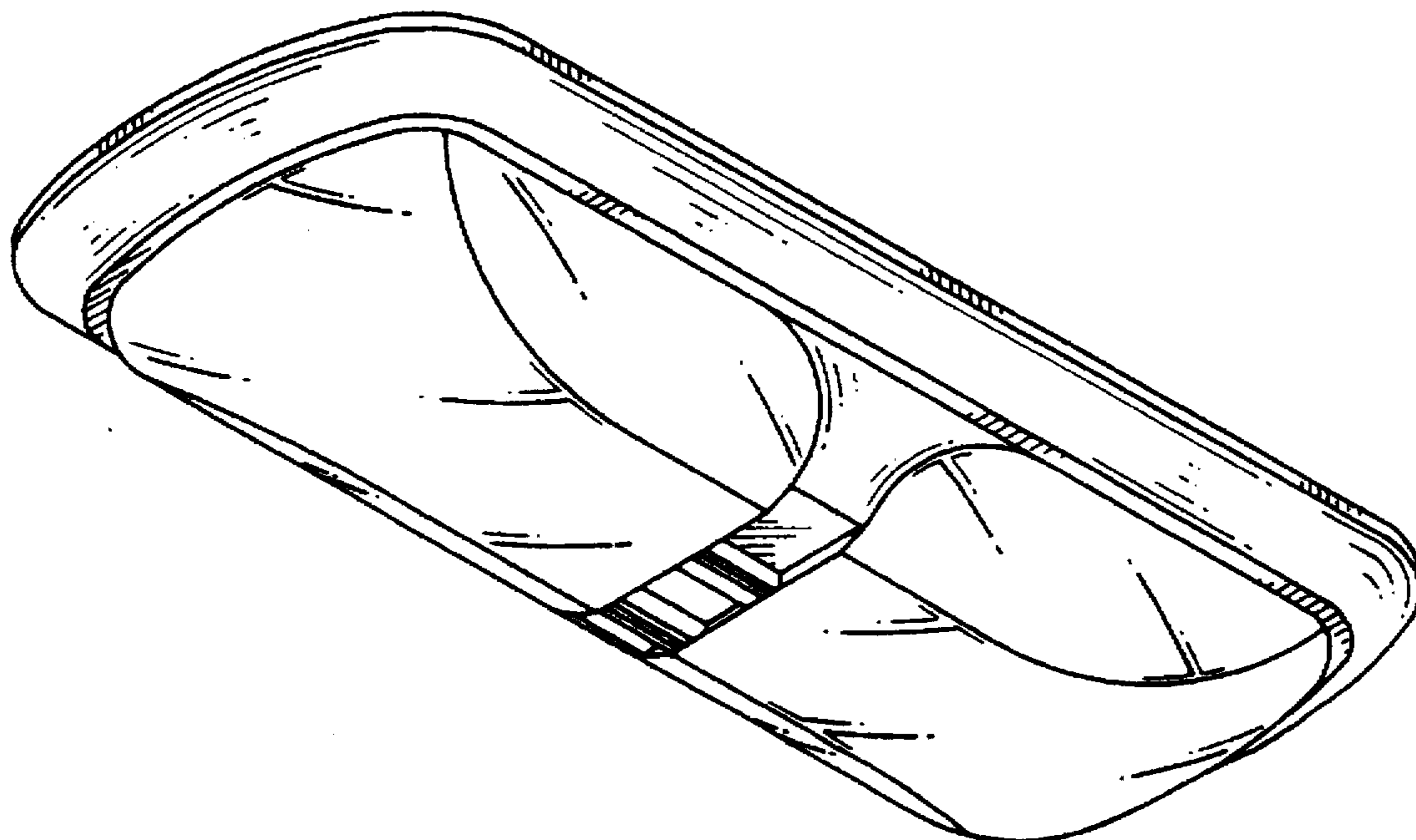
FIG. 7 is a front view of the car interior lamp shown in FIG. 6 (the rear view being a mirror image thereof);

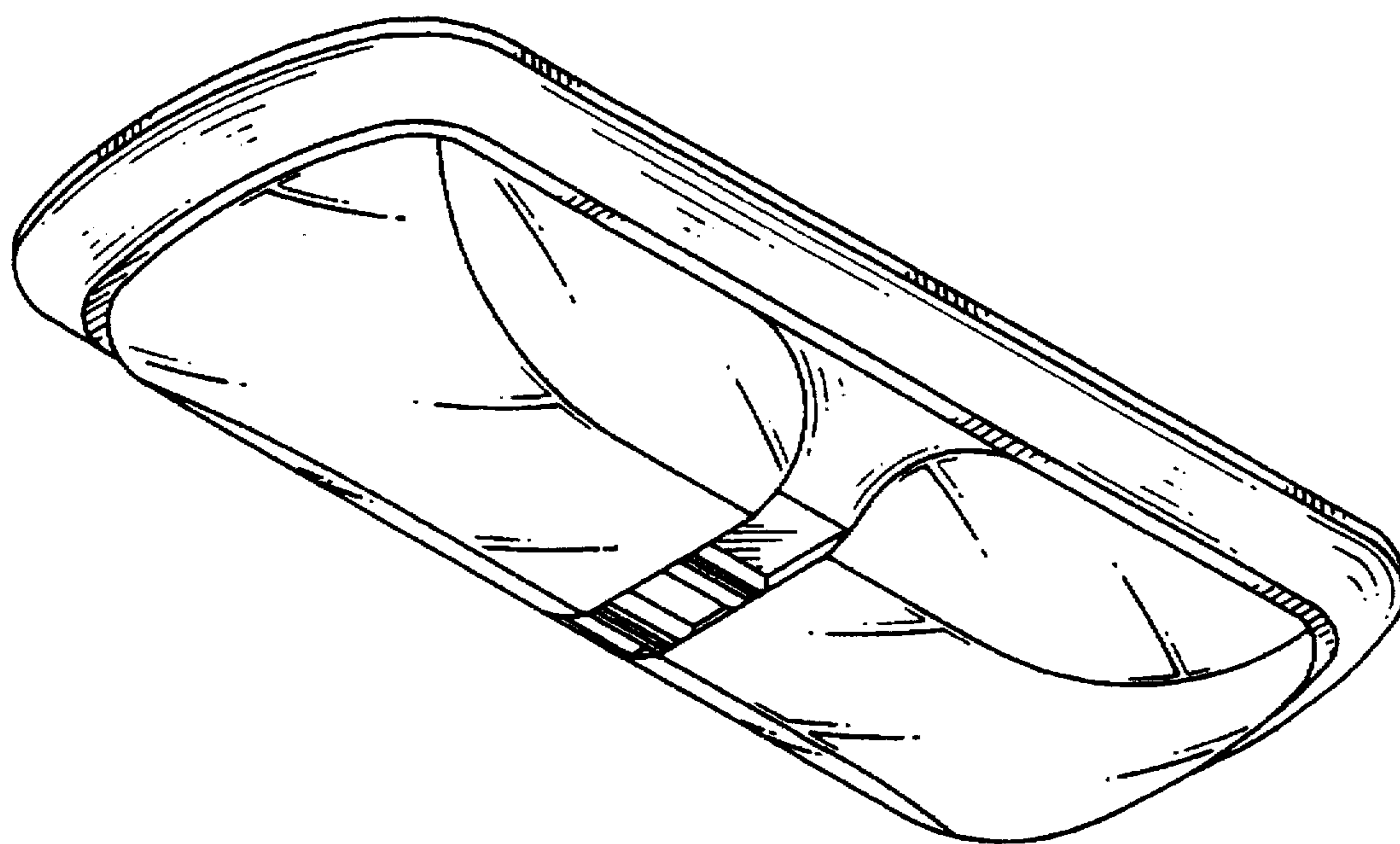

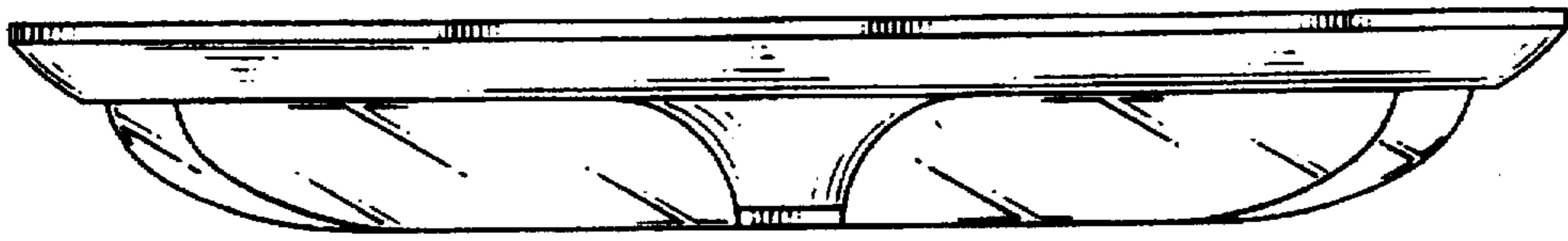

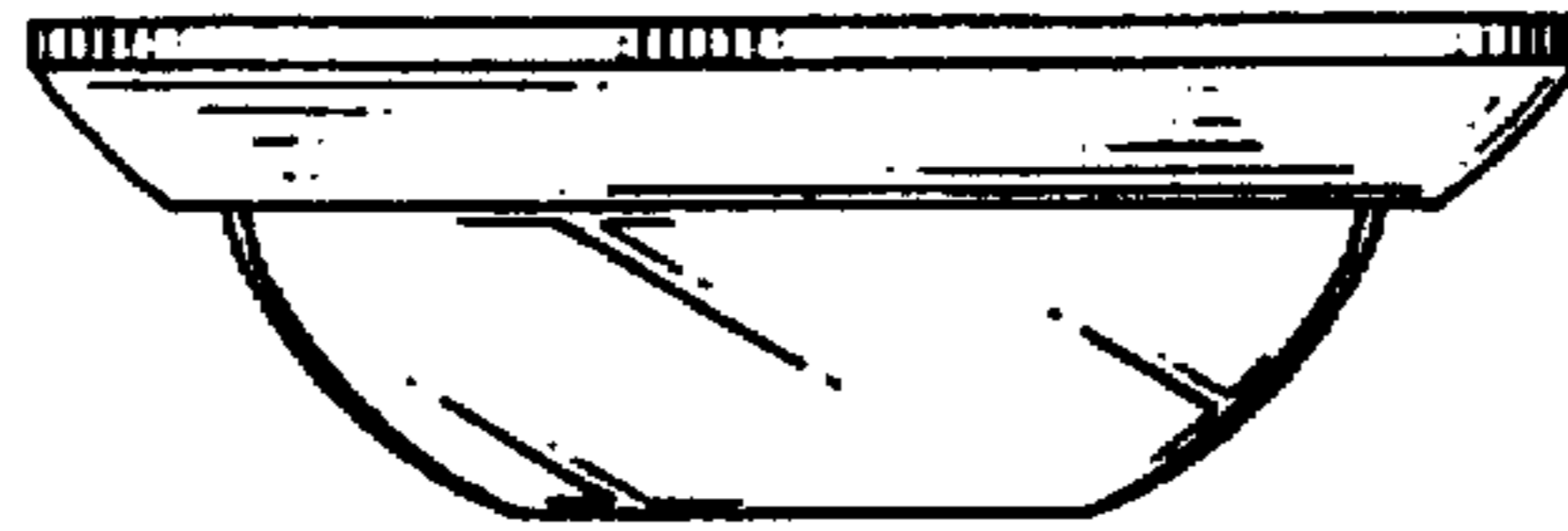

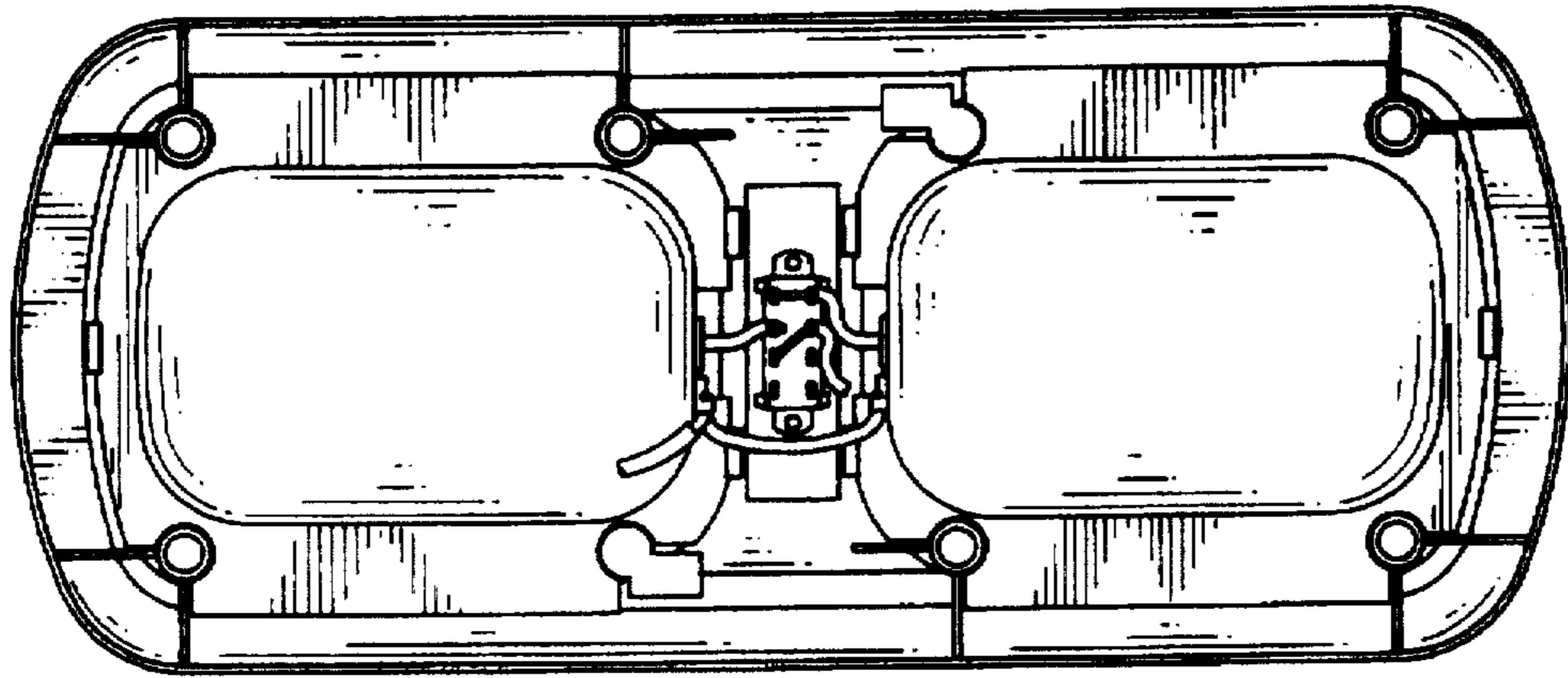

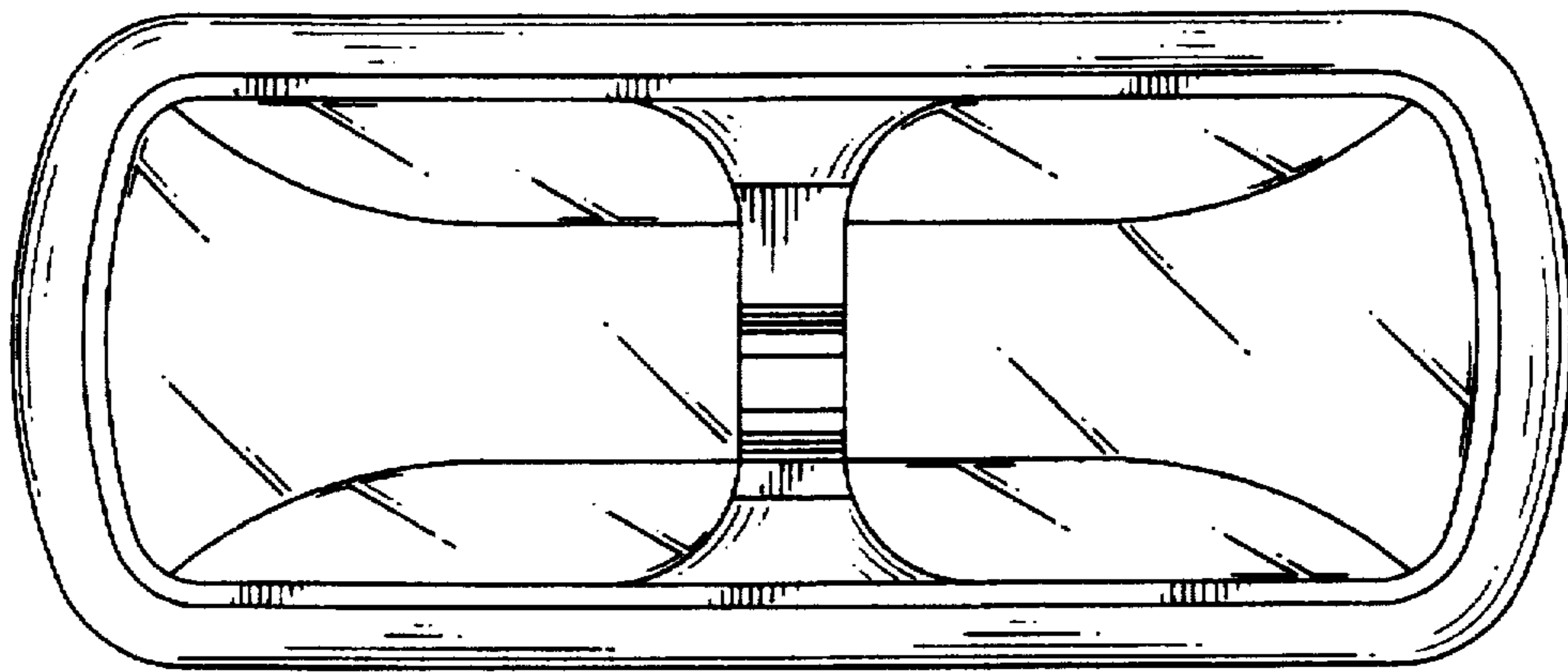

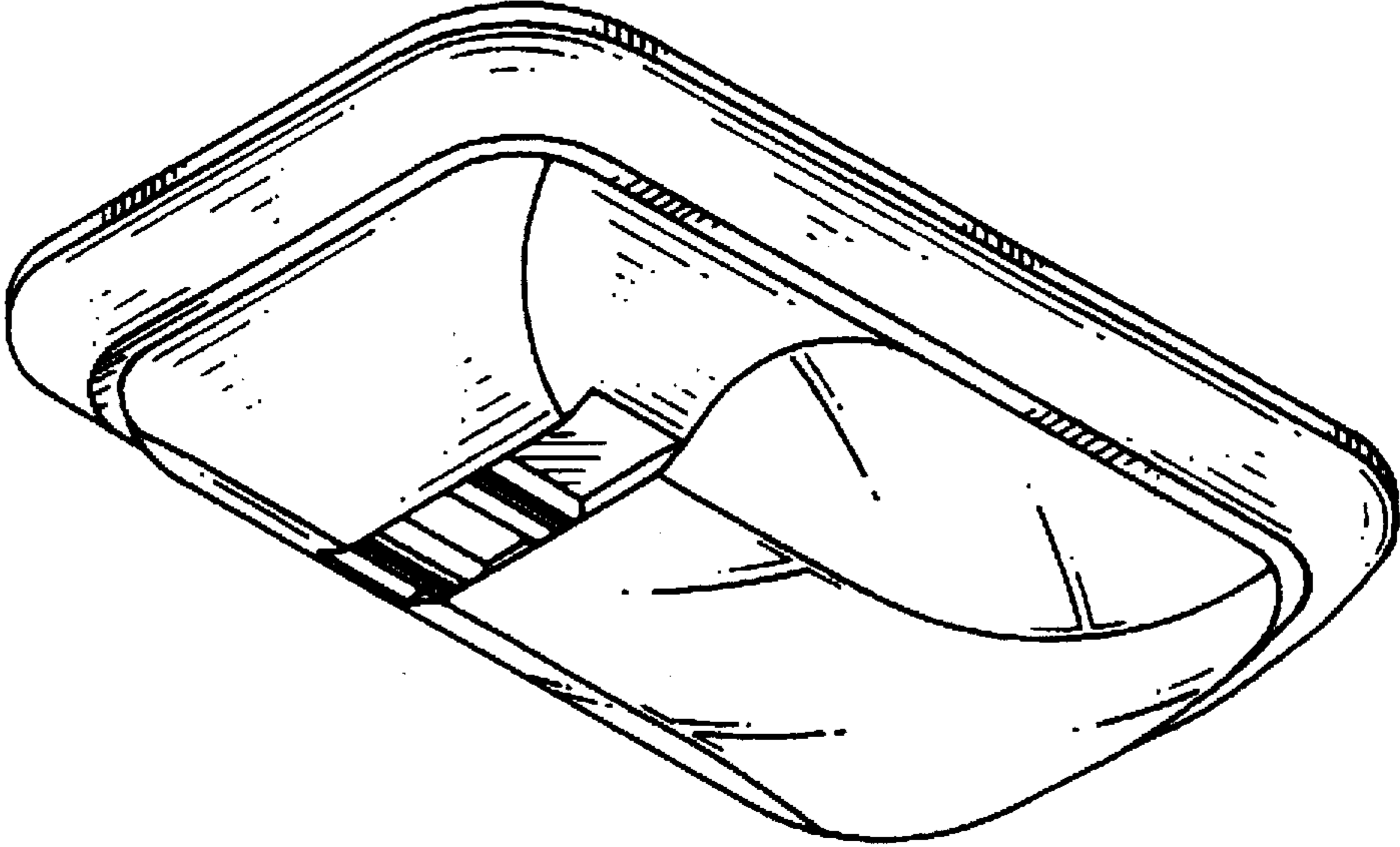

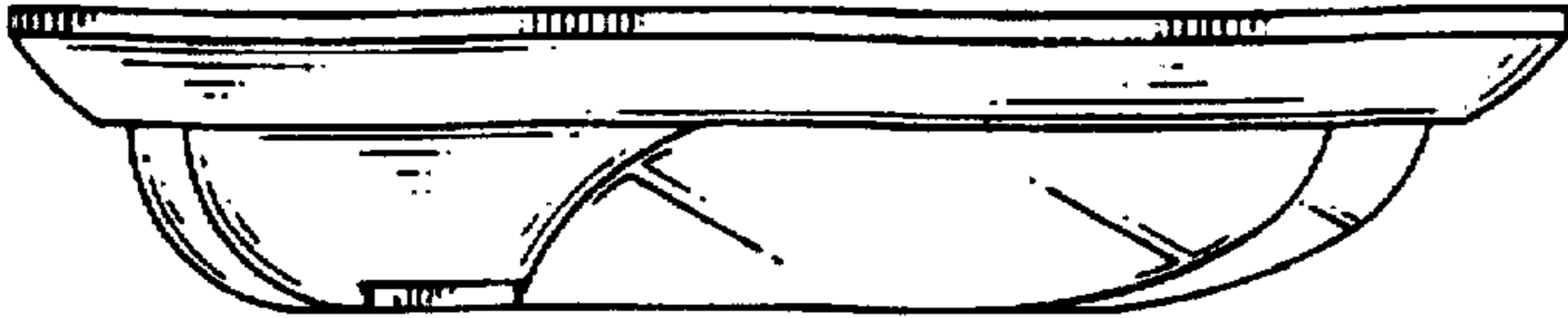

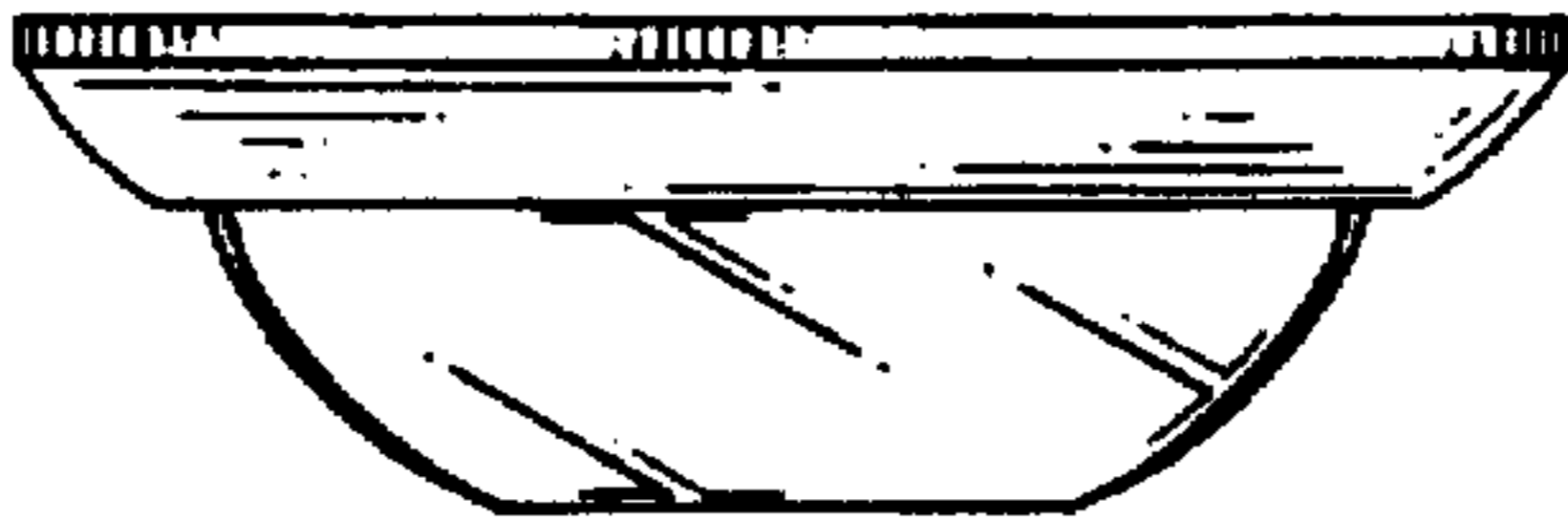

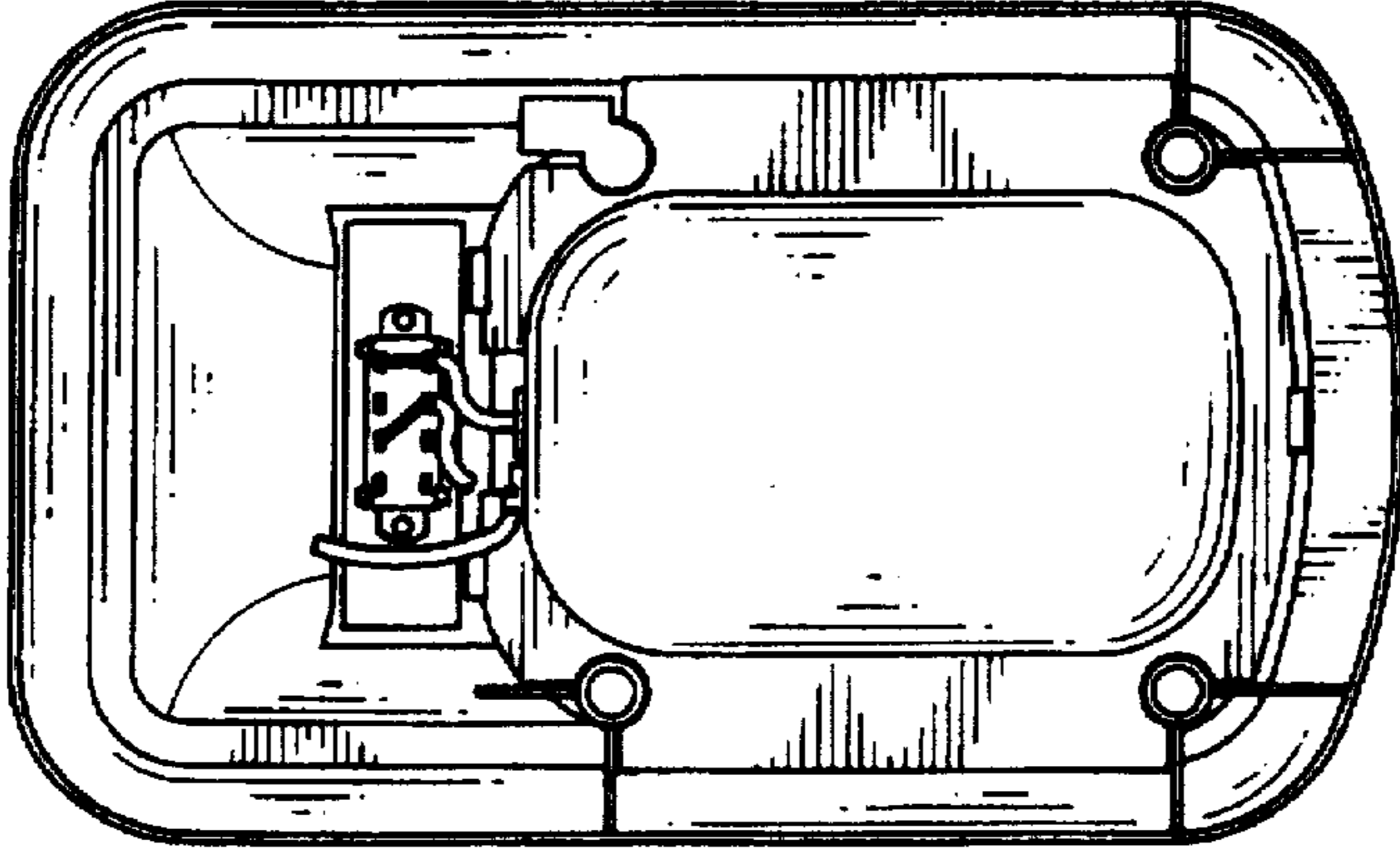

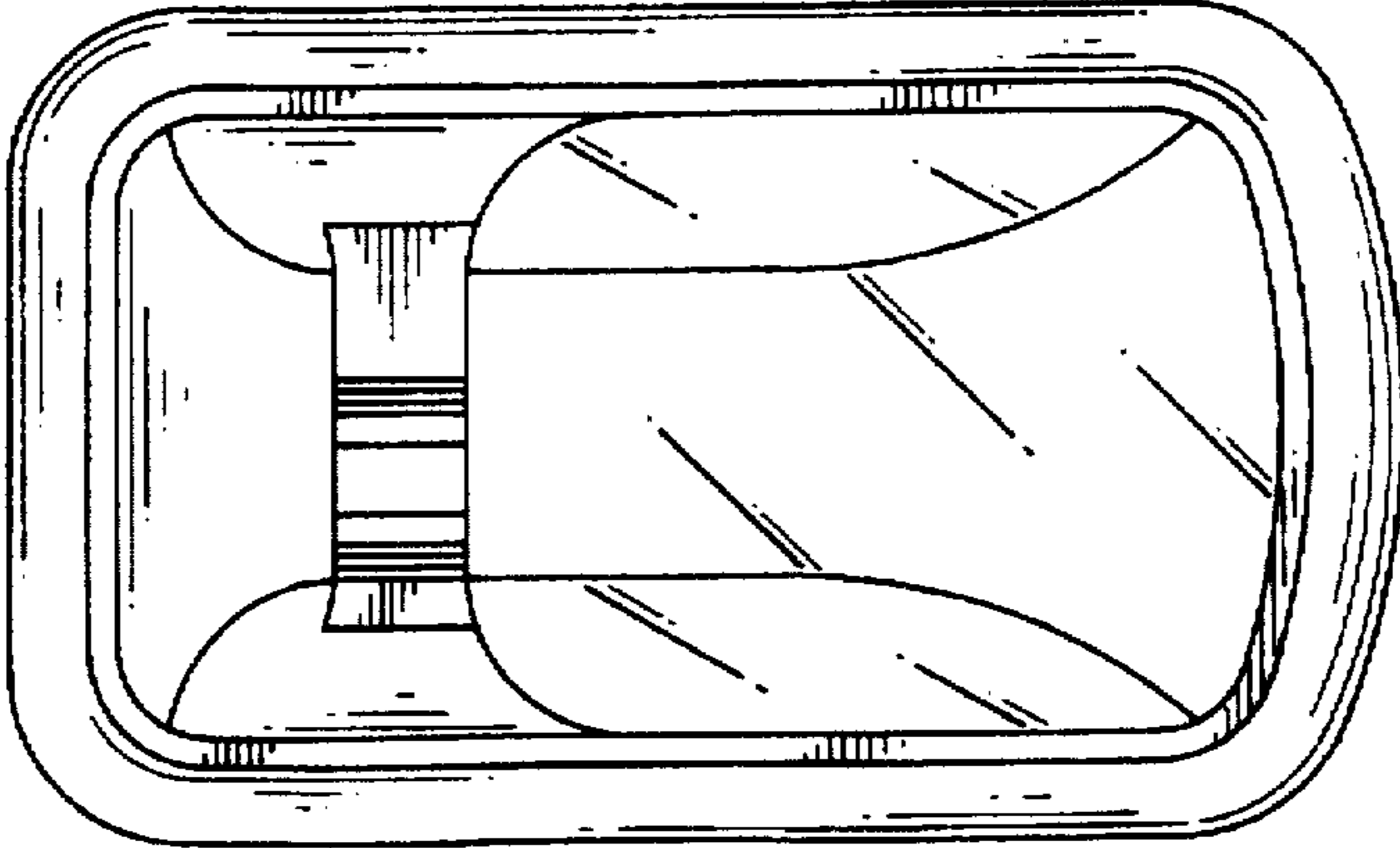
