[57] **CLAIM**

The ornamental design for an exerciser for pets, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a exerciser for pets showing my new design according to a first preferred embodiment; FIG. 2 is a left side view thereof, with the right side view being a mirror image;

FIG. 3 is a front view thereof;

FIG. 10 is a top view thereof;

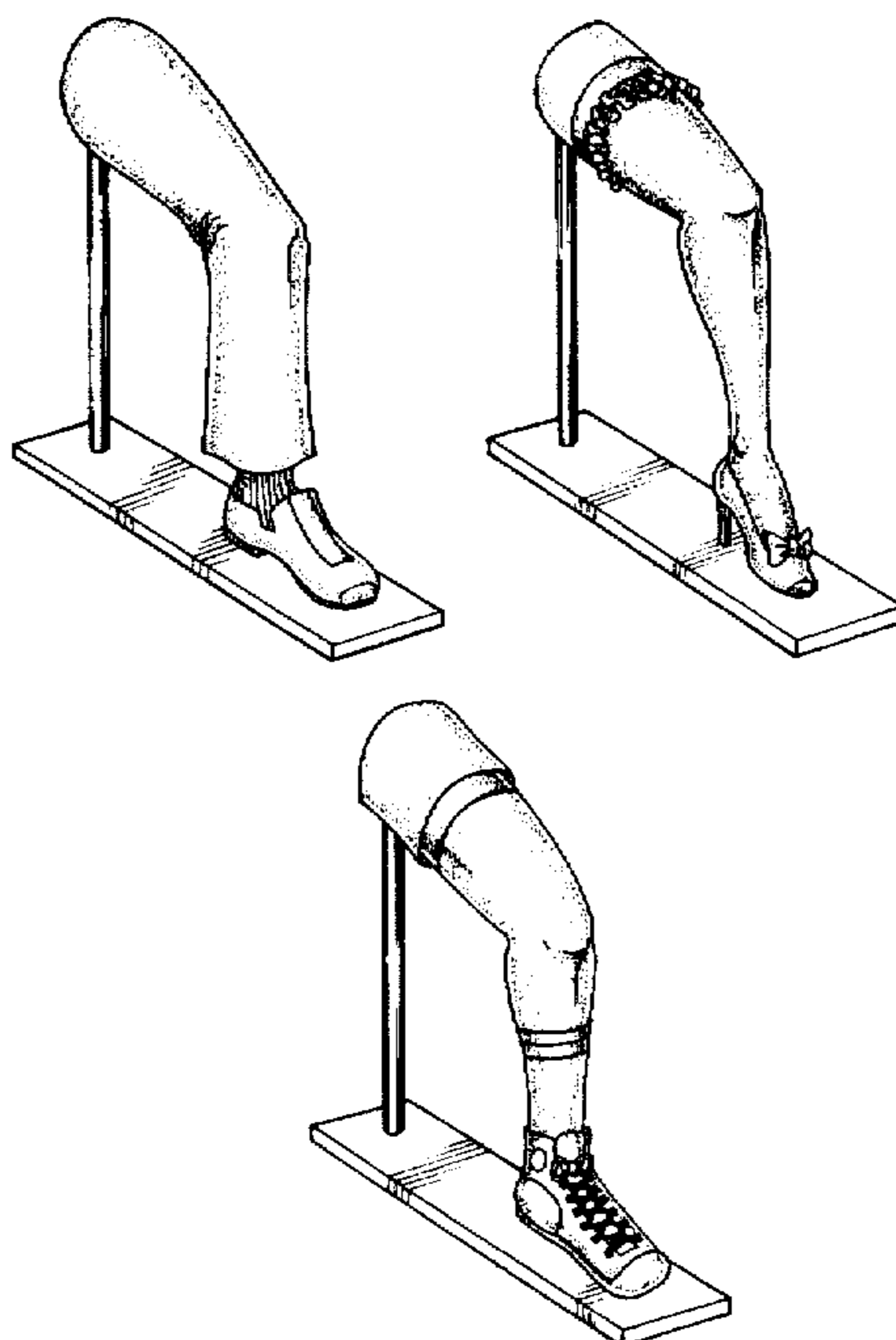

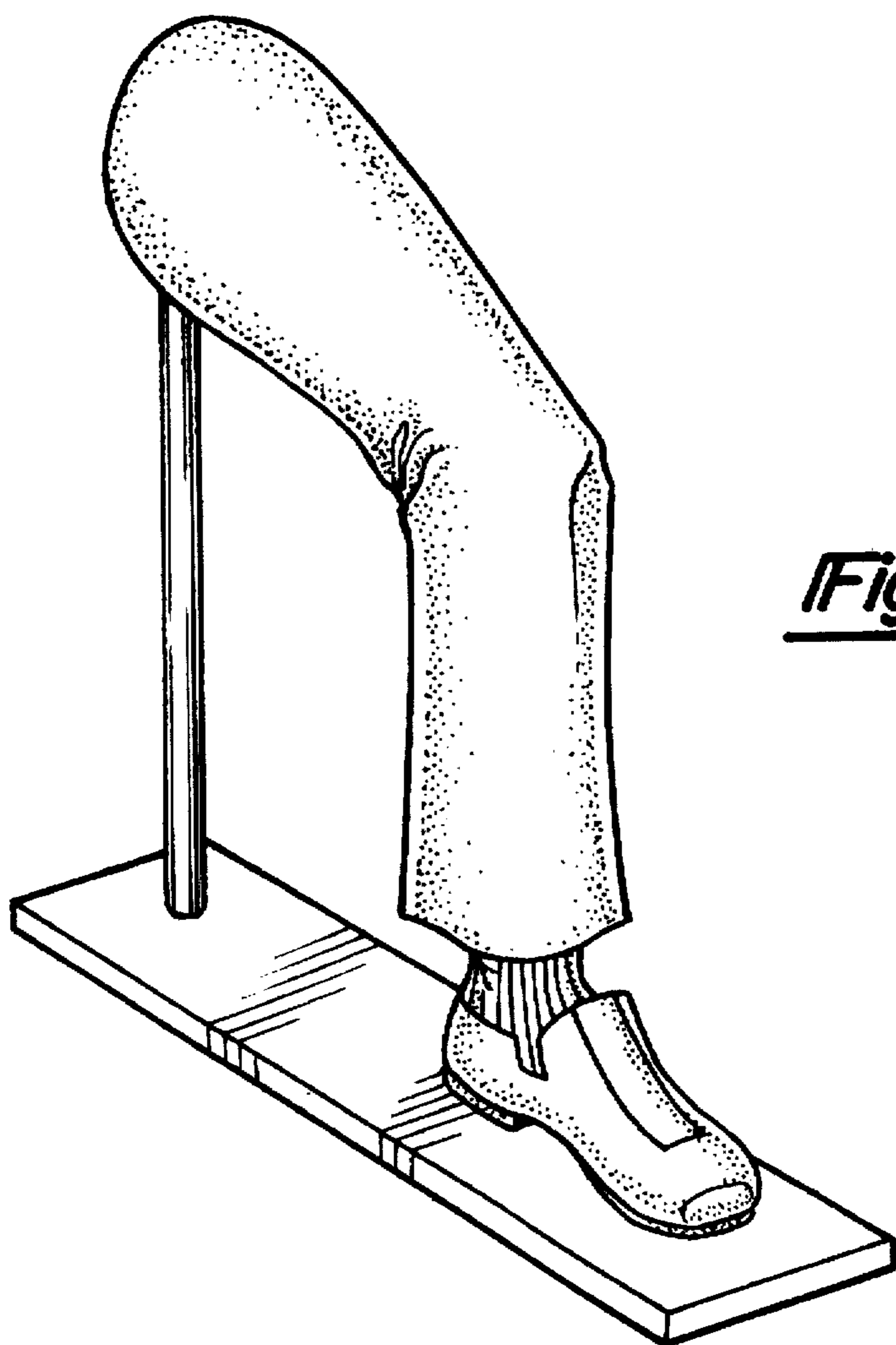
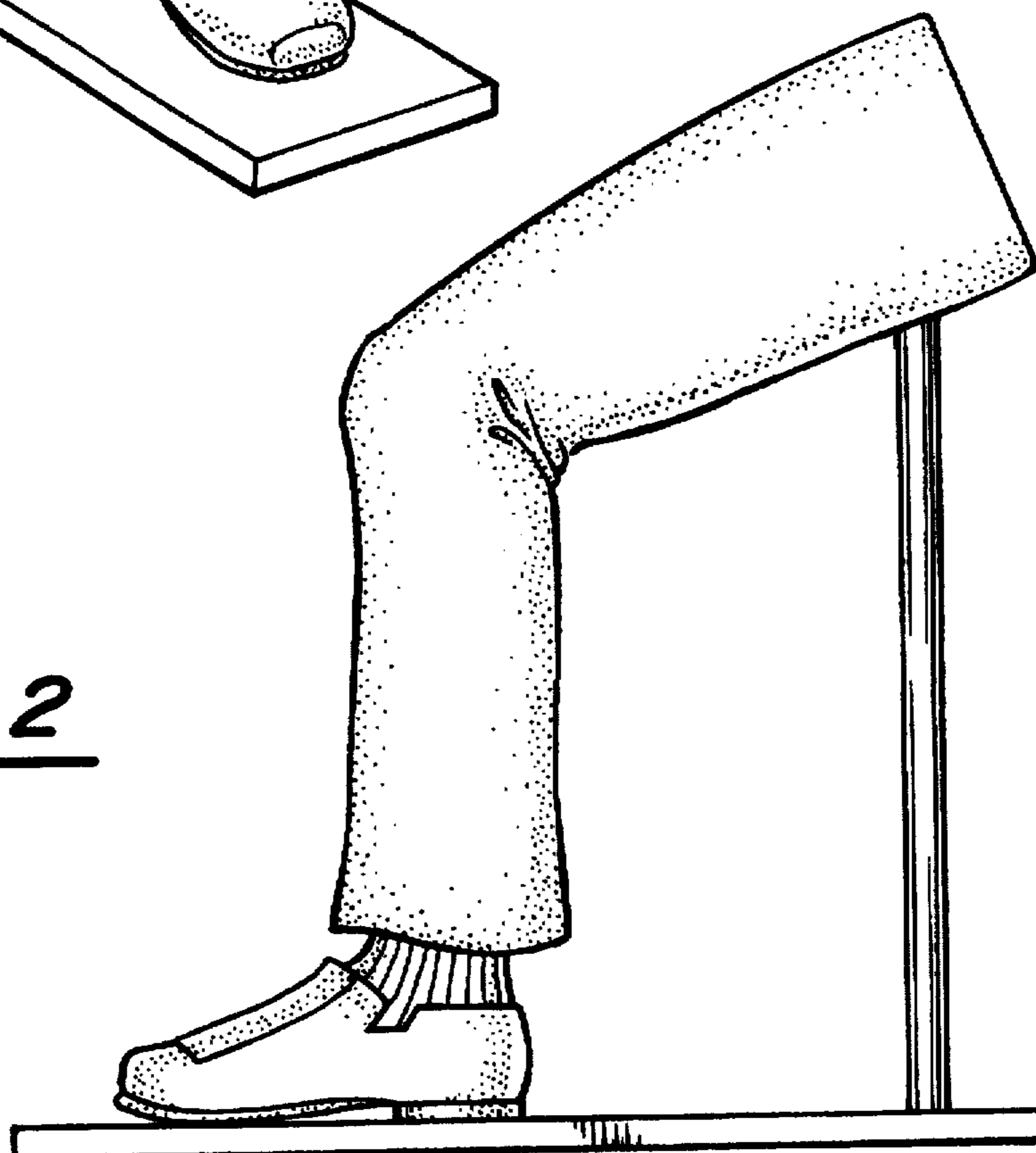

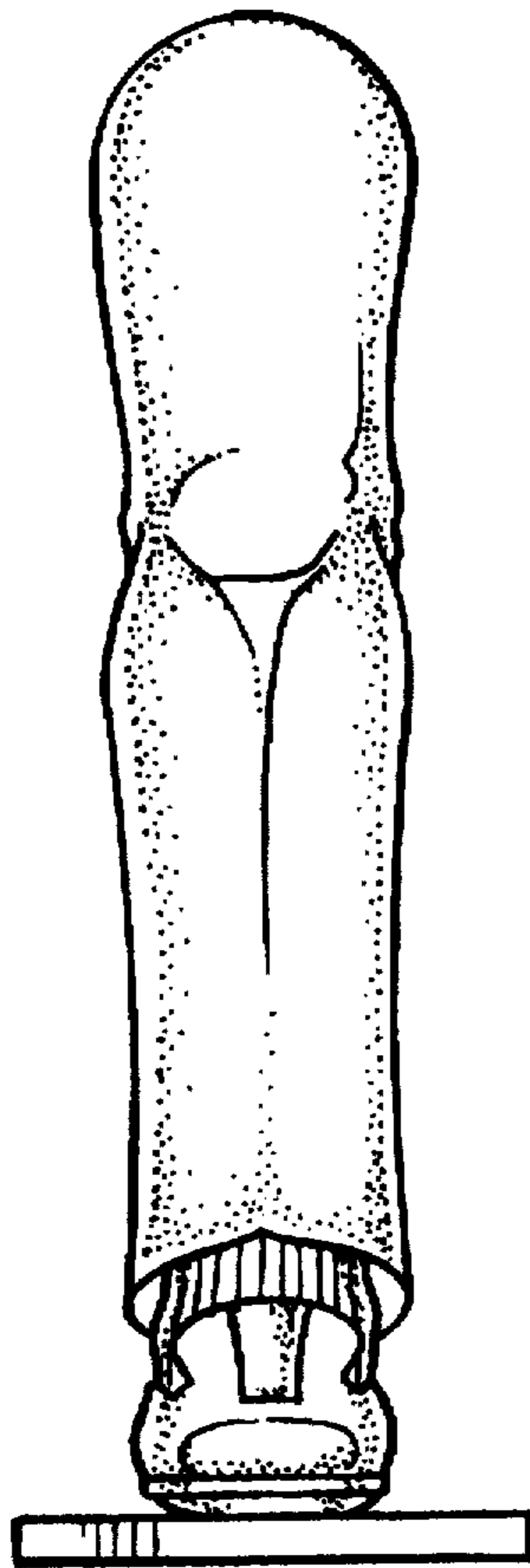

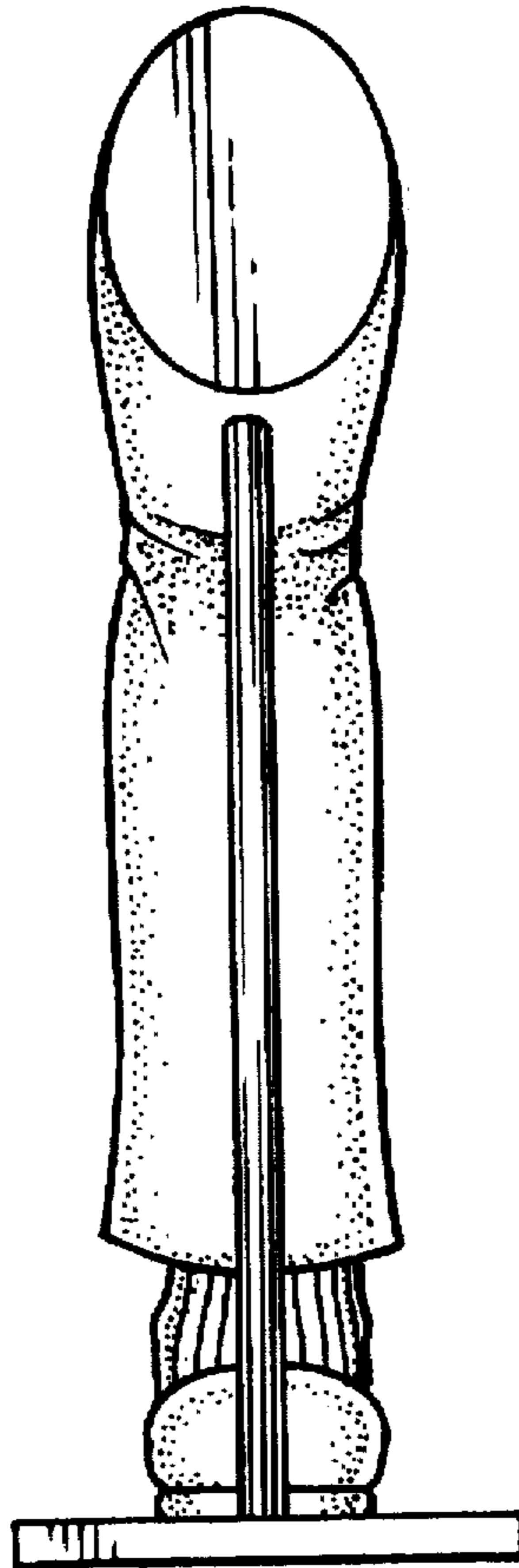

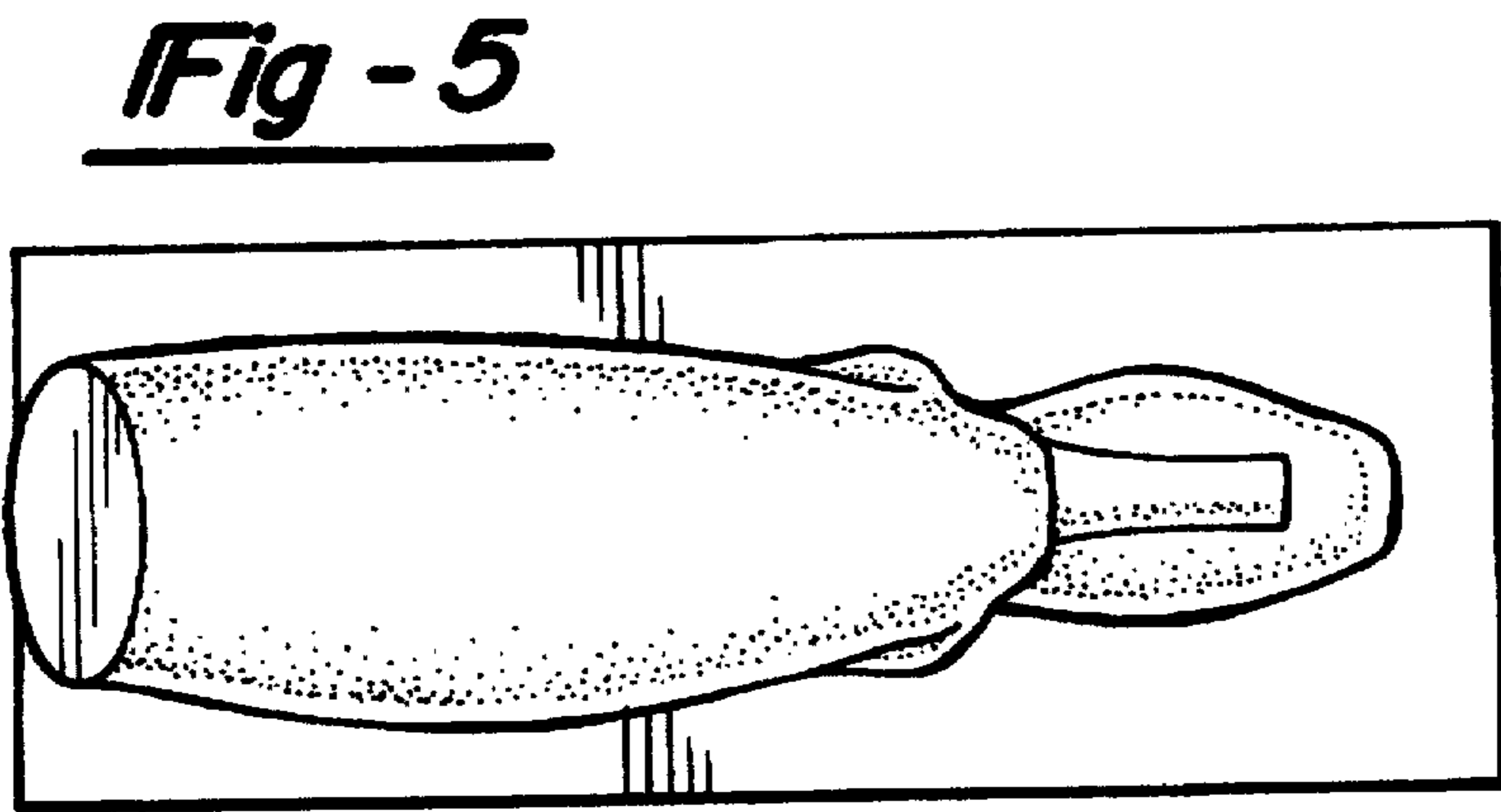

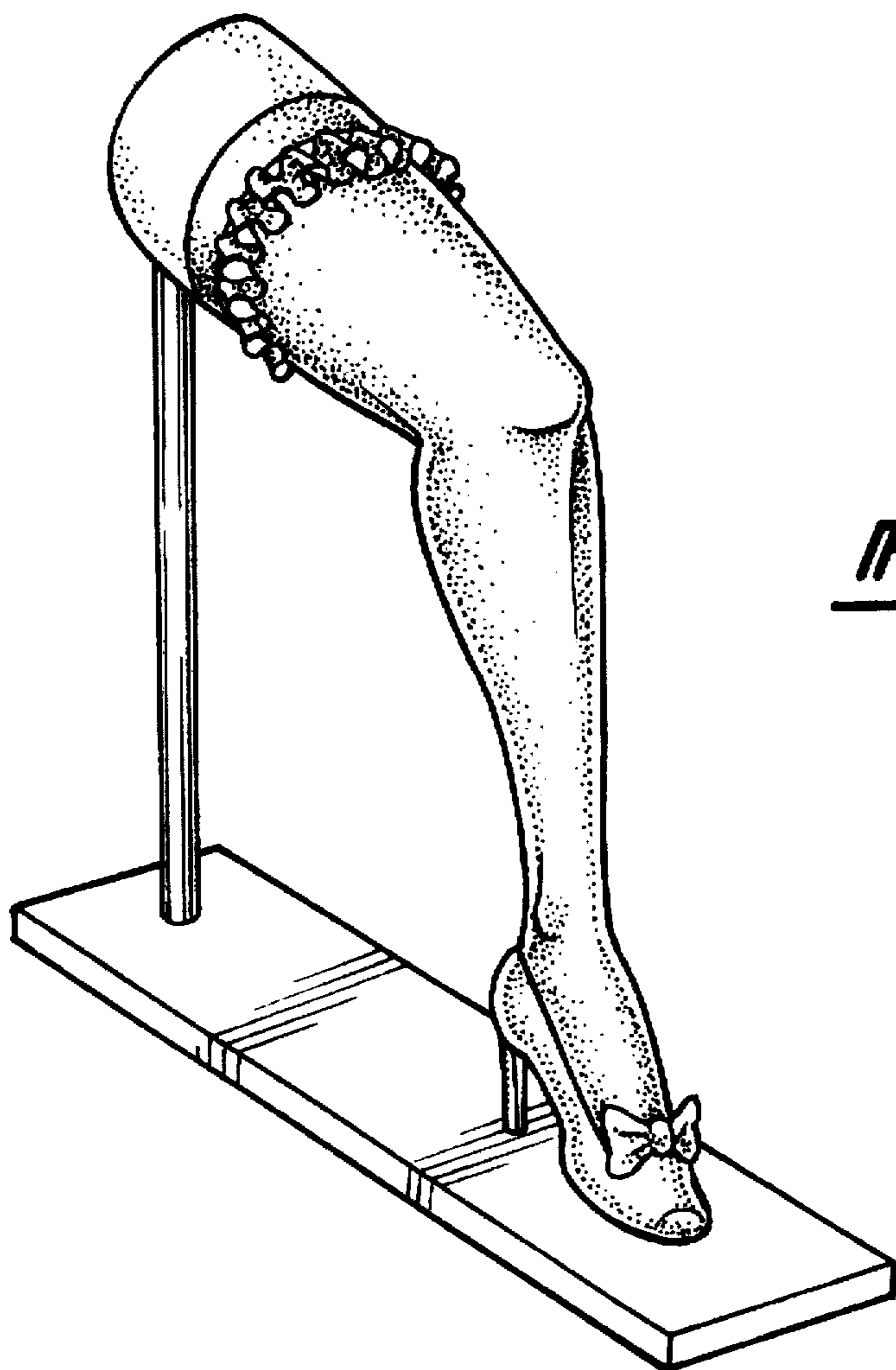
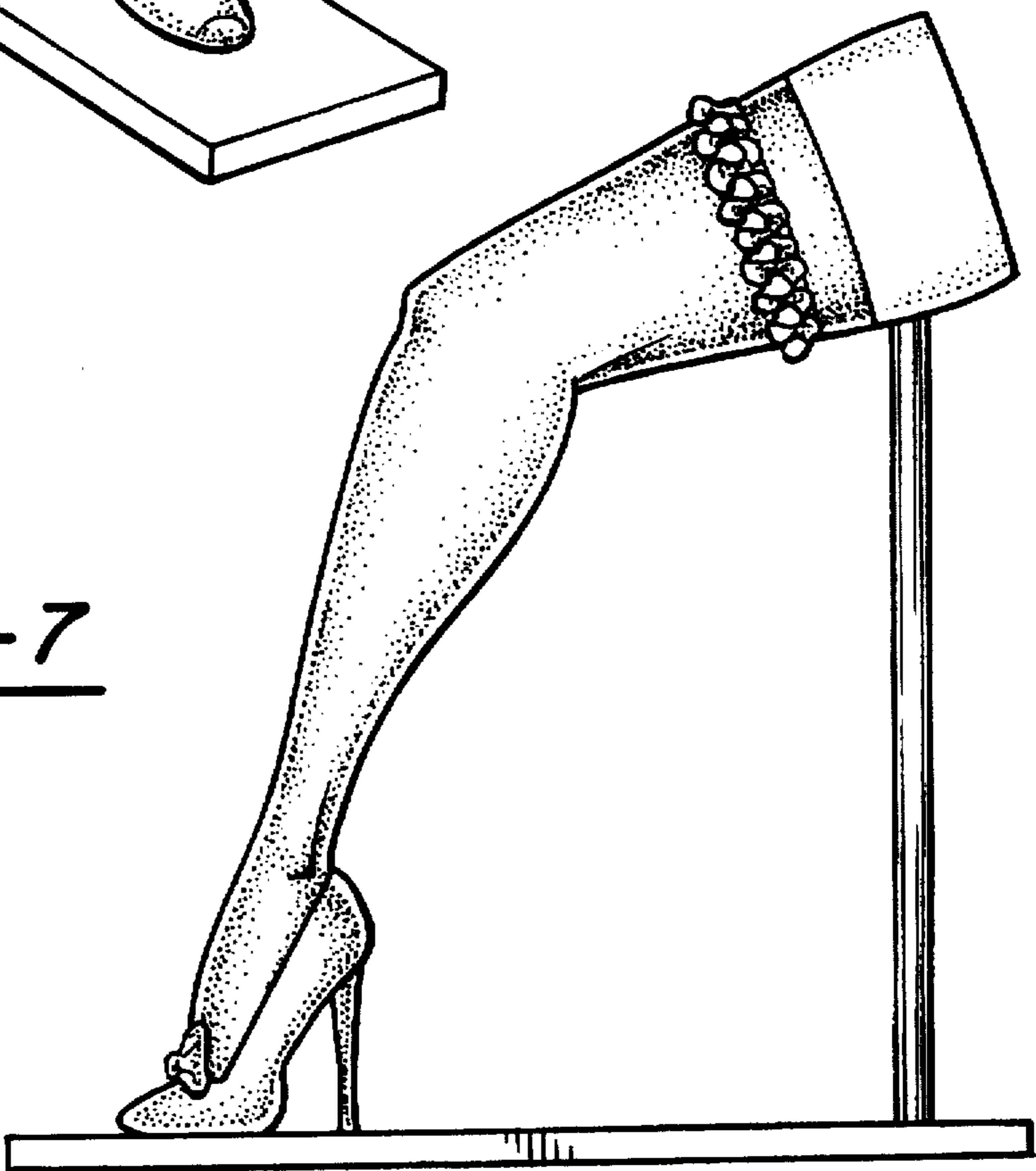

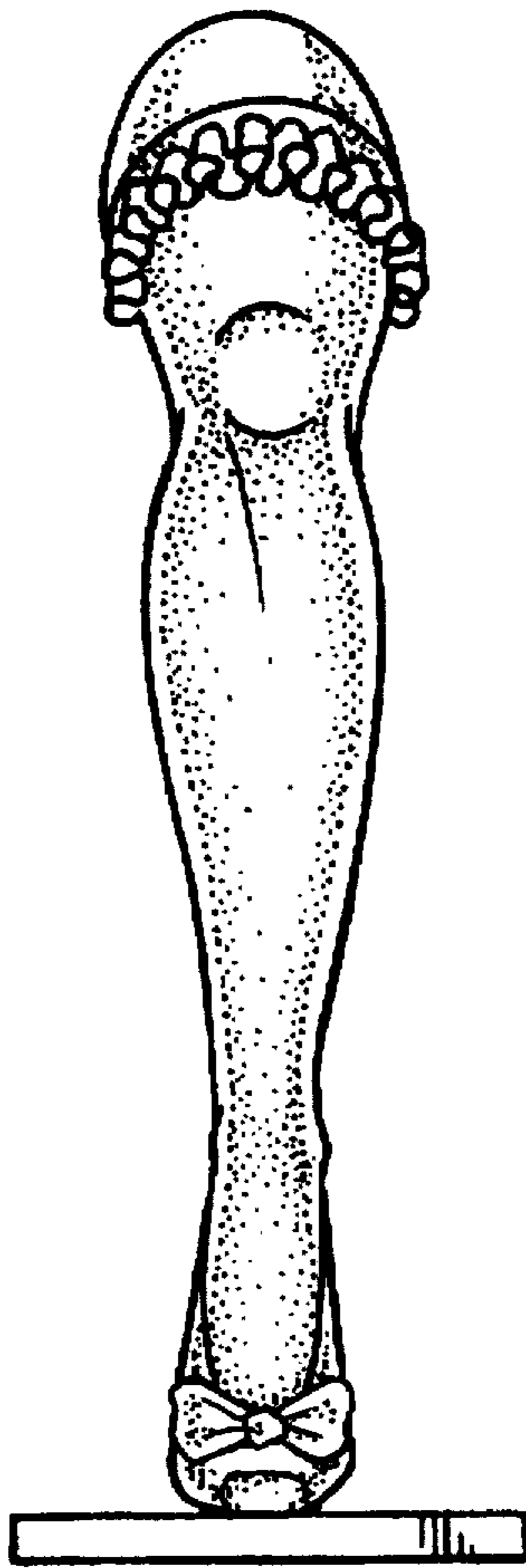

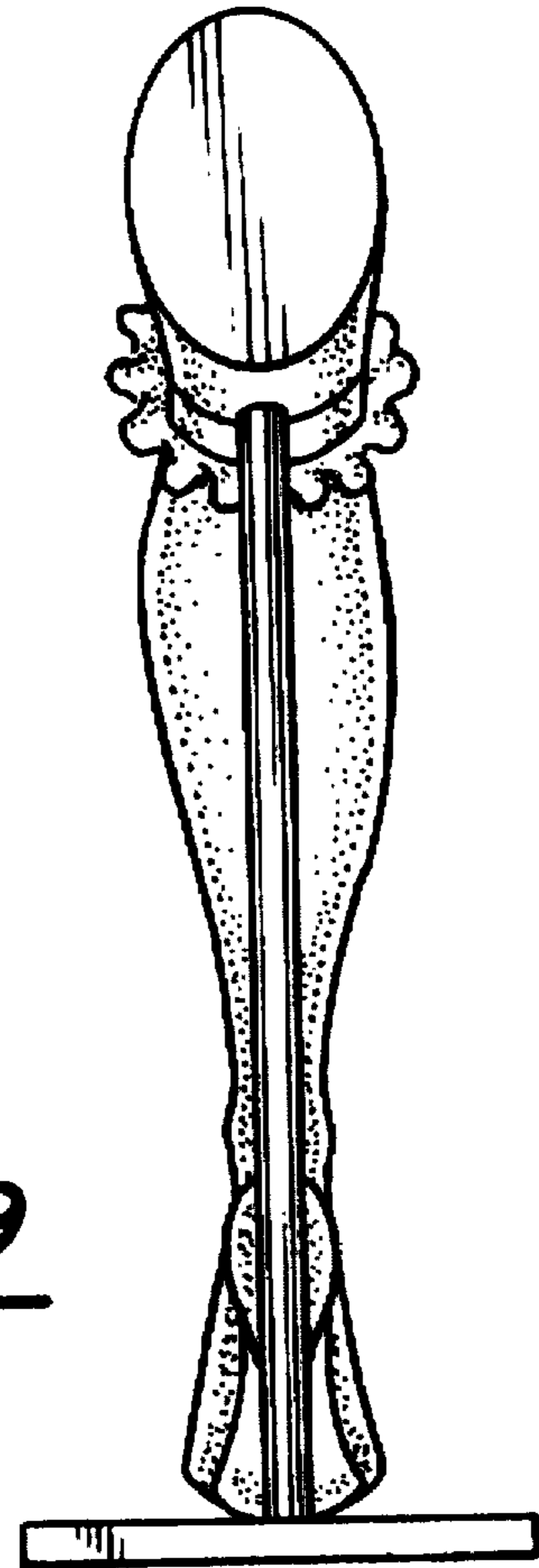

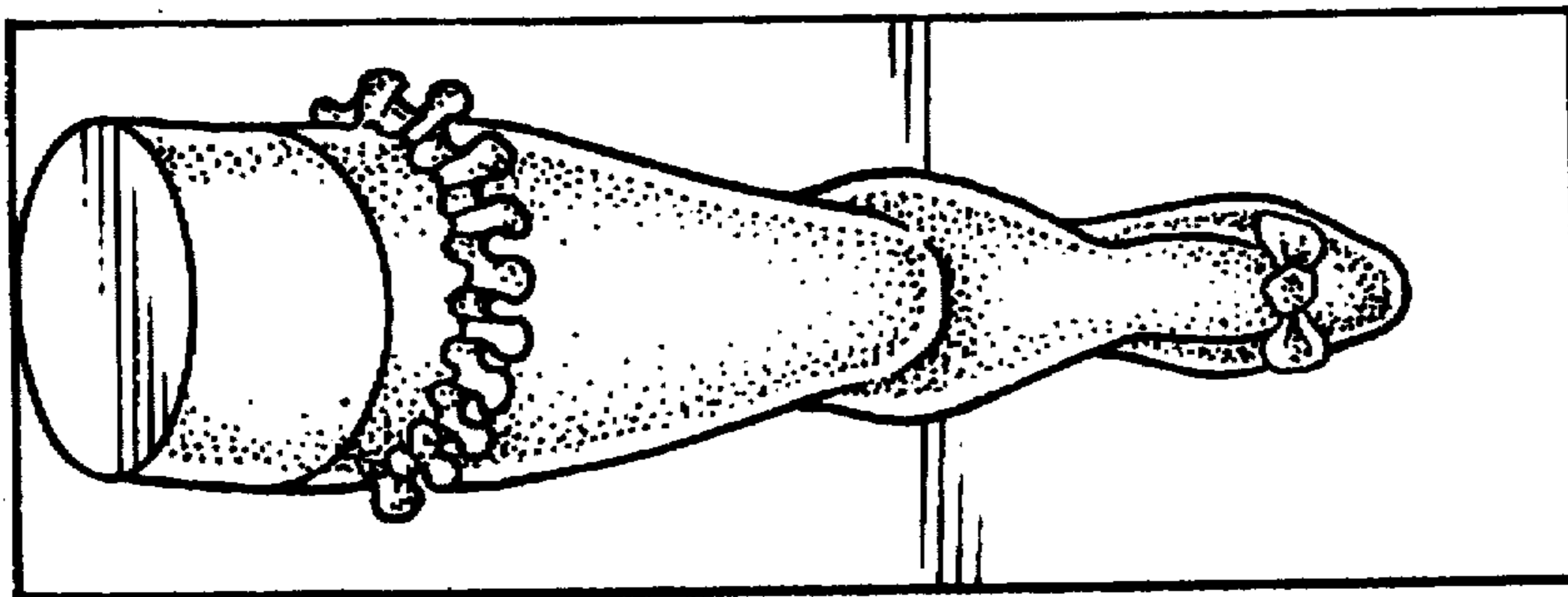

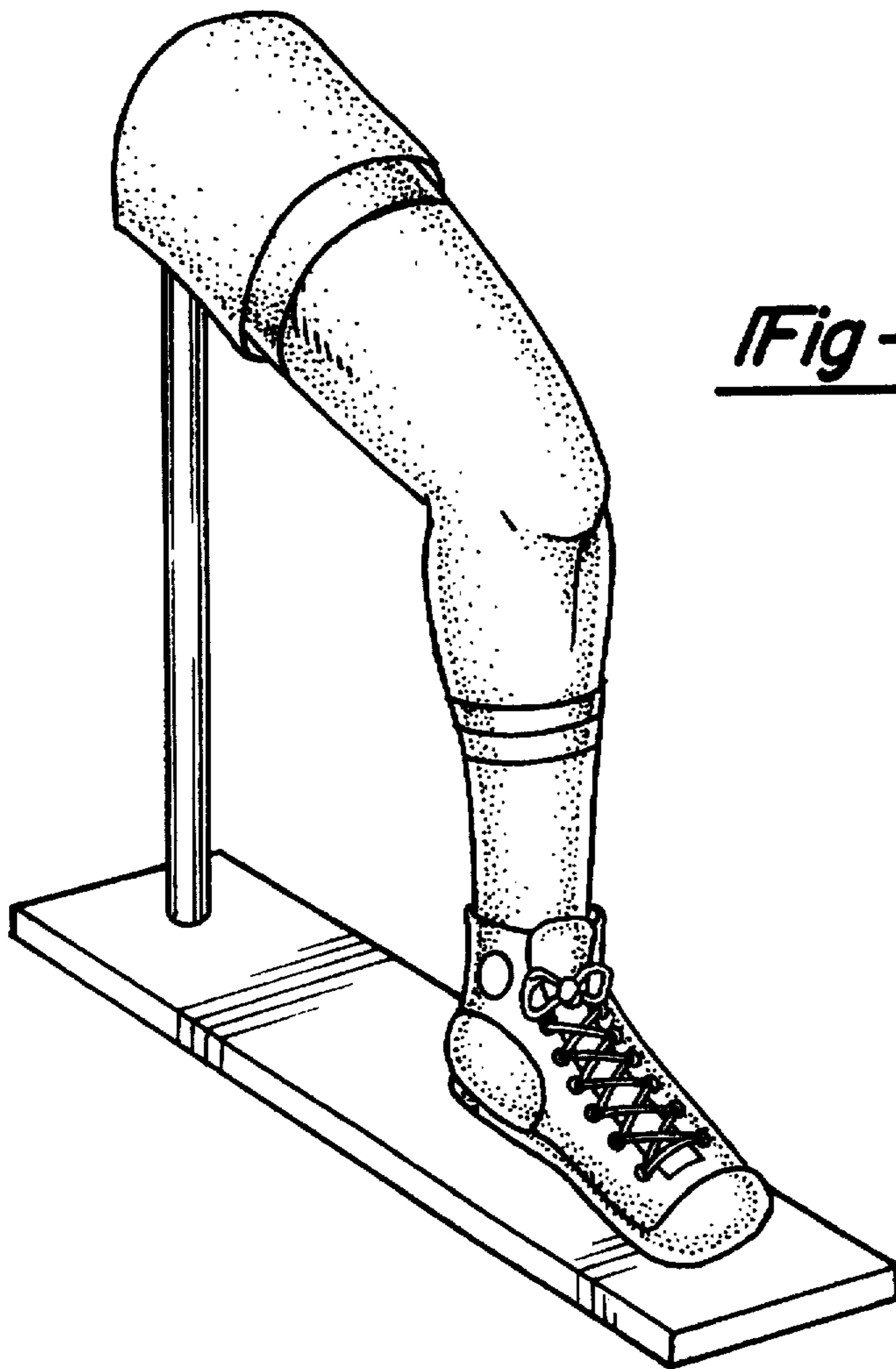

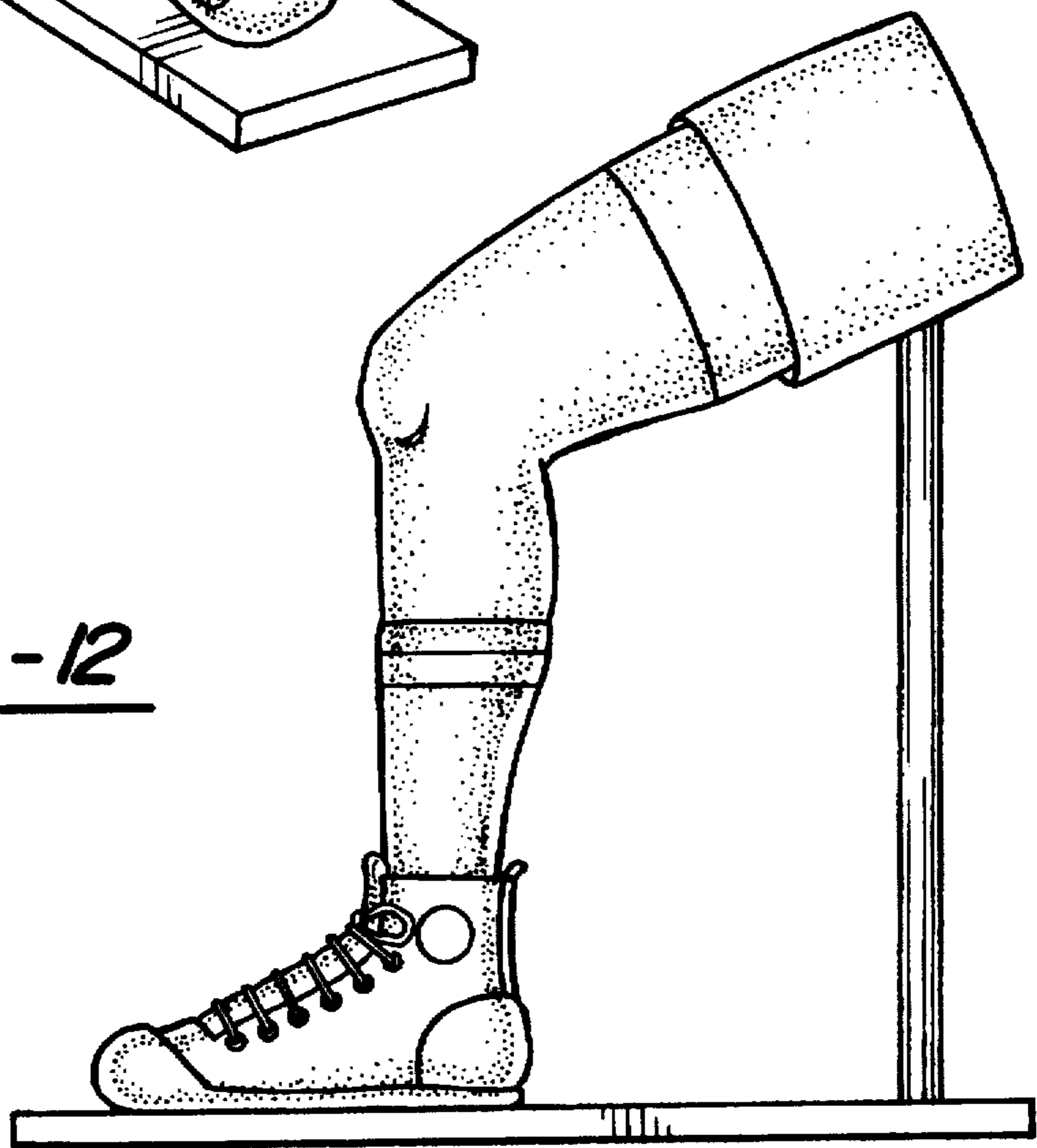

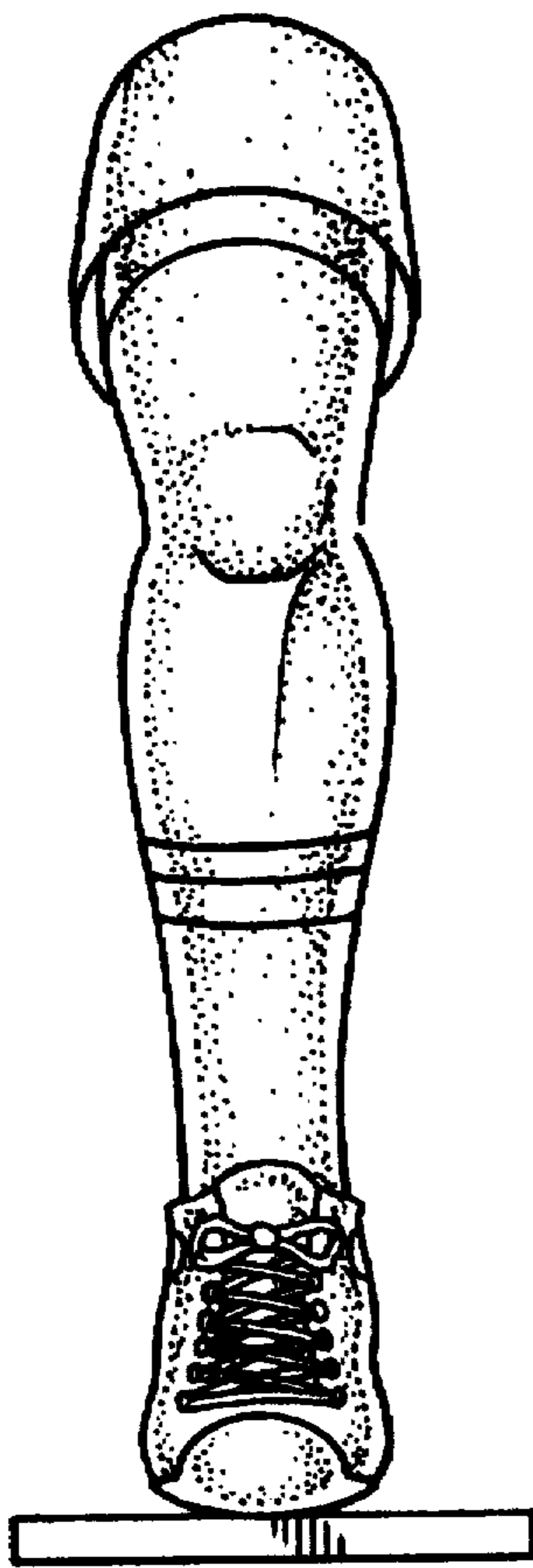

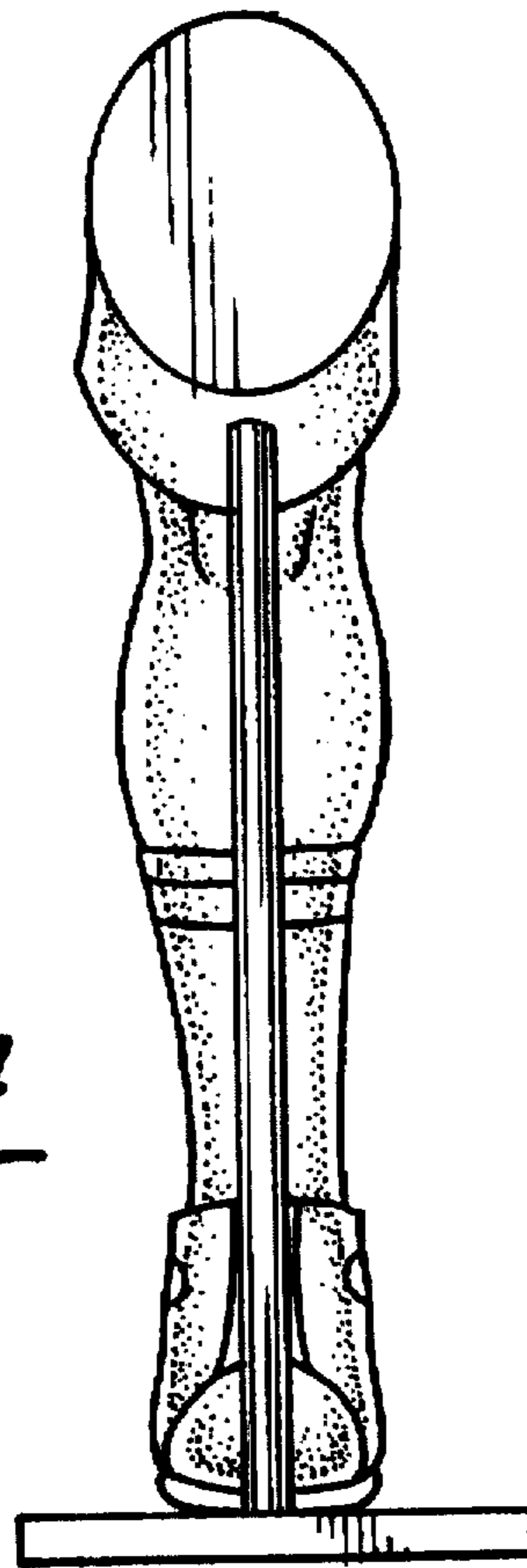

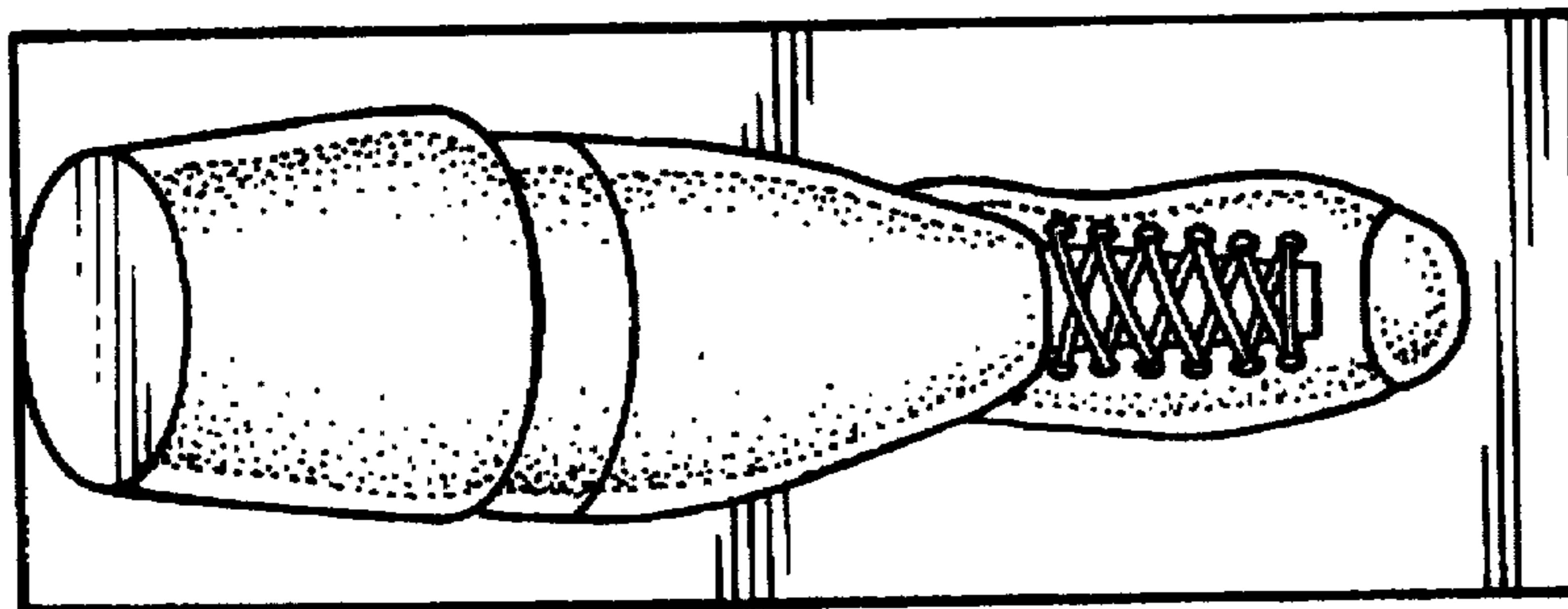
