[57] **CLAIM**

The design for a cat's ventilated litter house, as shown and described.

DESCRIPTION

FIG. 1 is a side view of the cat's ventilated litter house showing my new design. And the opposite side is a mirror image of the side shown;

FIG. 2 is a top plan view of the design shown in FIG. 1;

FIG. 3 is a front elevational view of the design shown in FIG. 1;

FIG. 4 is a rear elevational view of the design shown in FIG. 1;

FIG. 5 is a bottom plan view of the design shown in FIG. 1;

FIG. 6 is a top plan view of the drawer design shown in FIG. 1; and,

FIG. 7 is a perspective view of the design shown in FIG. 1.

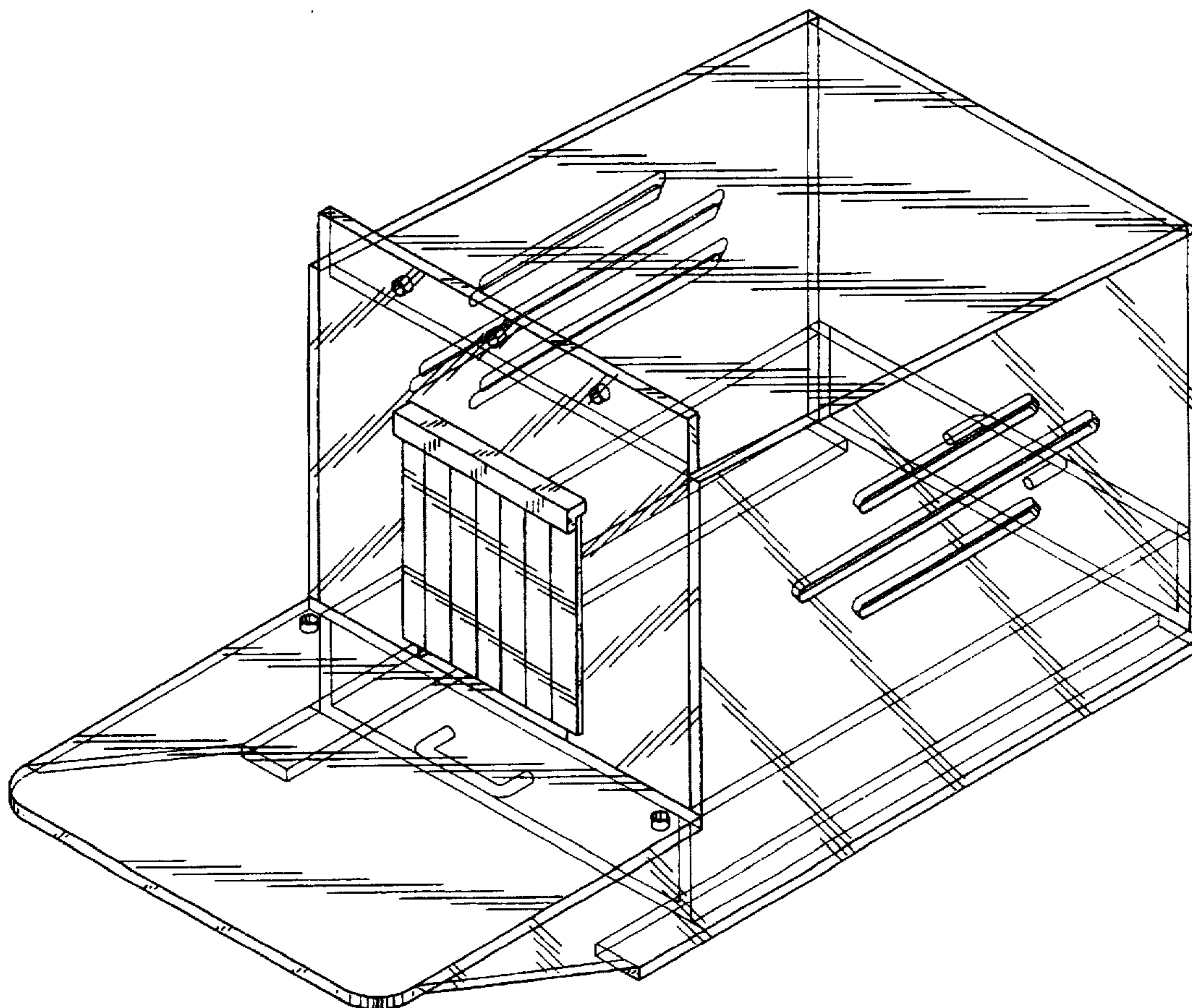

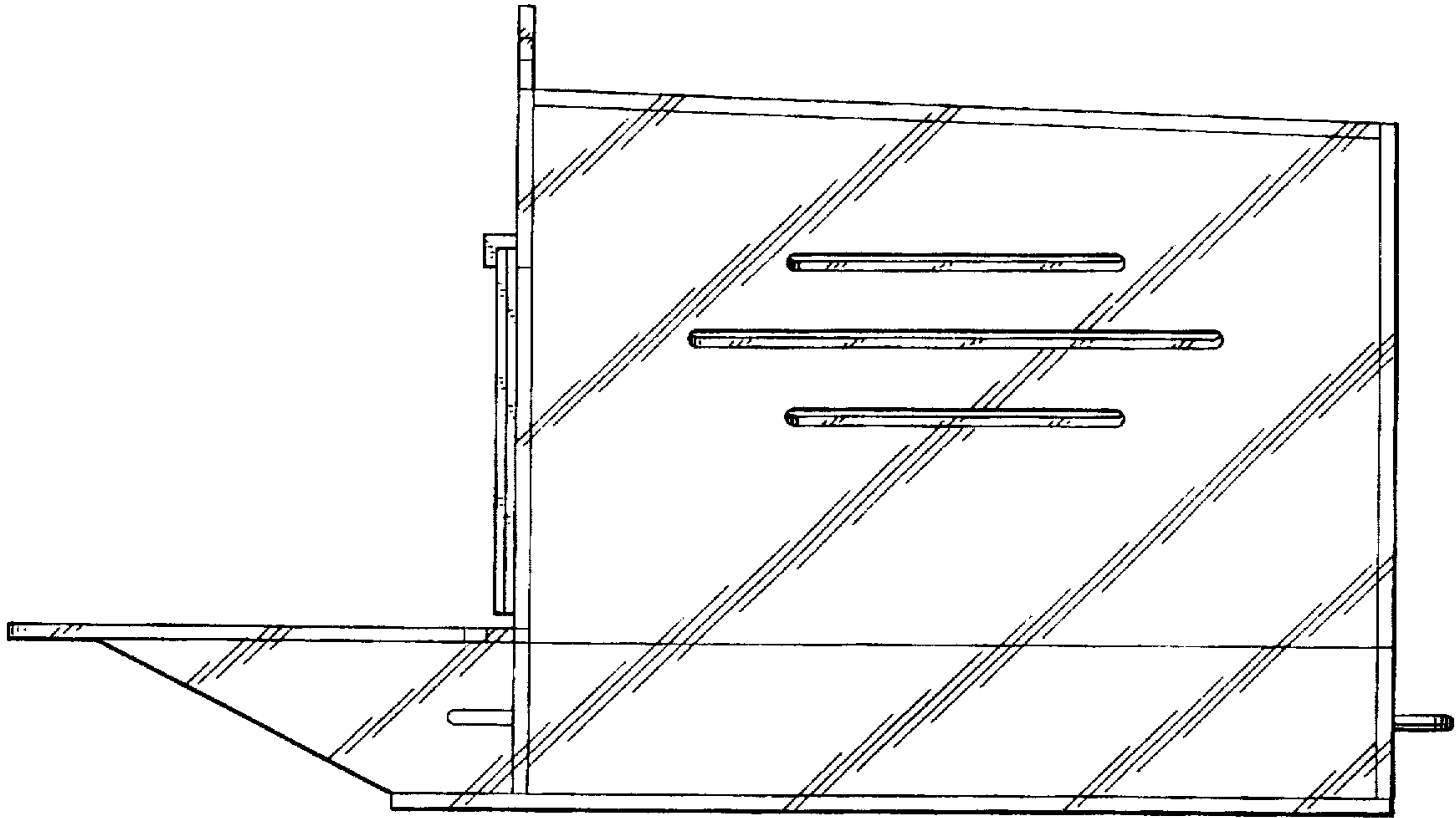

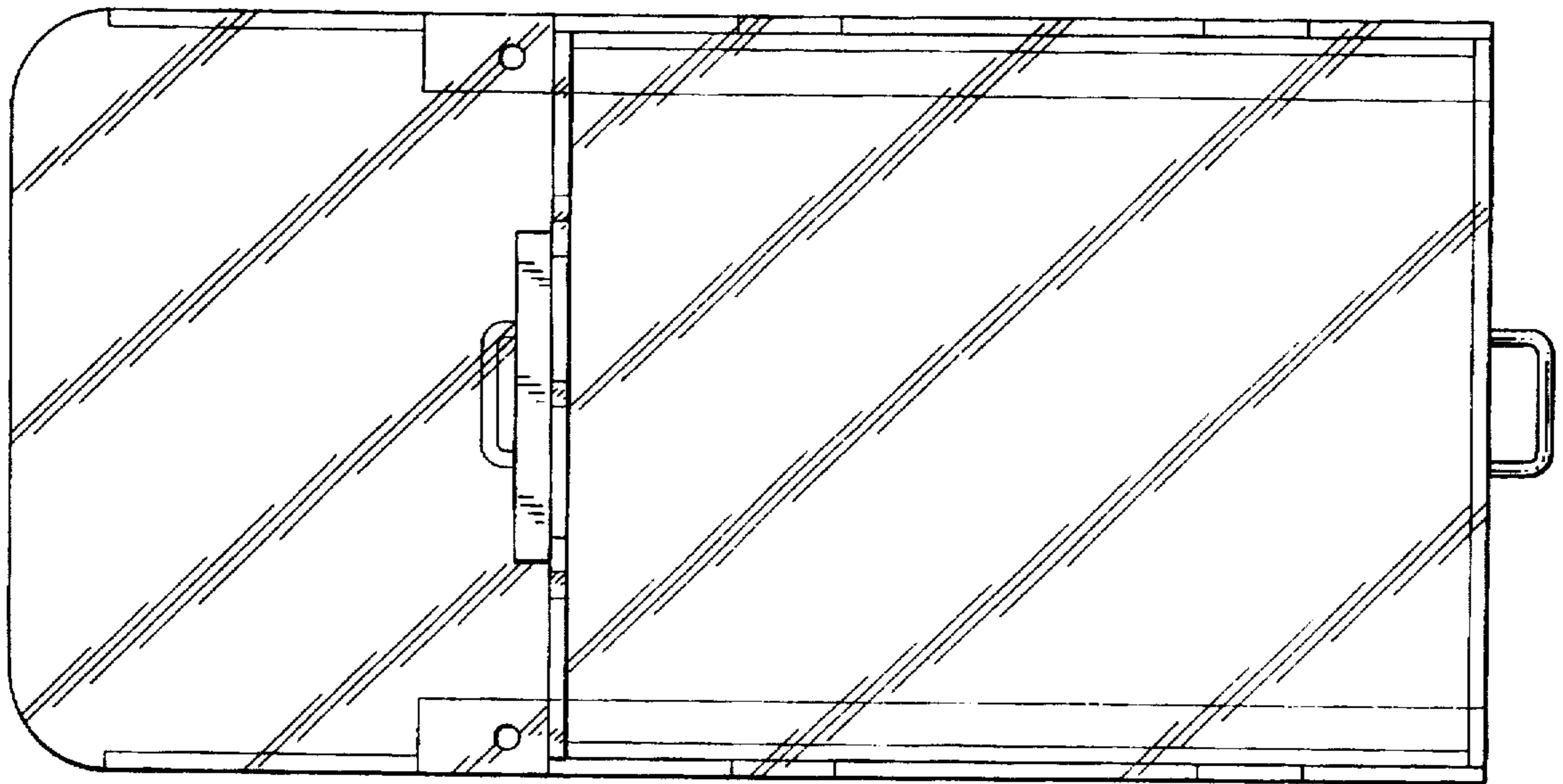

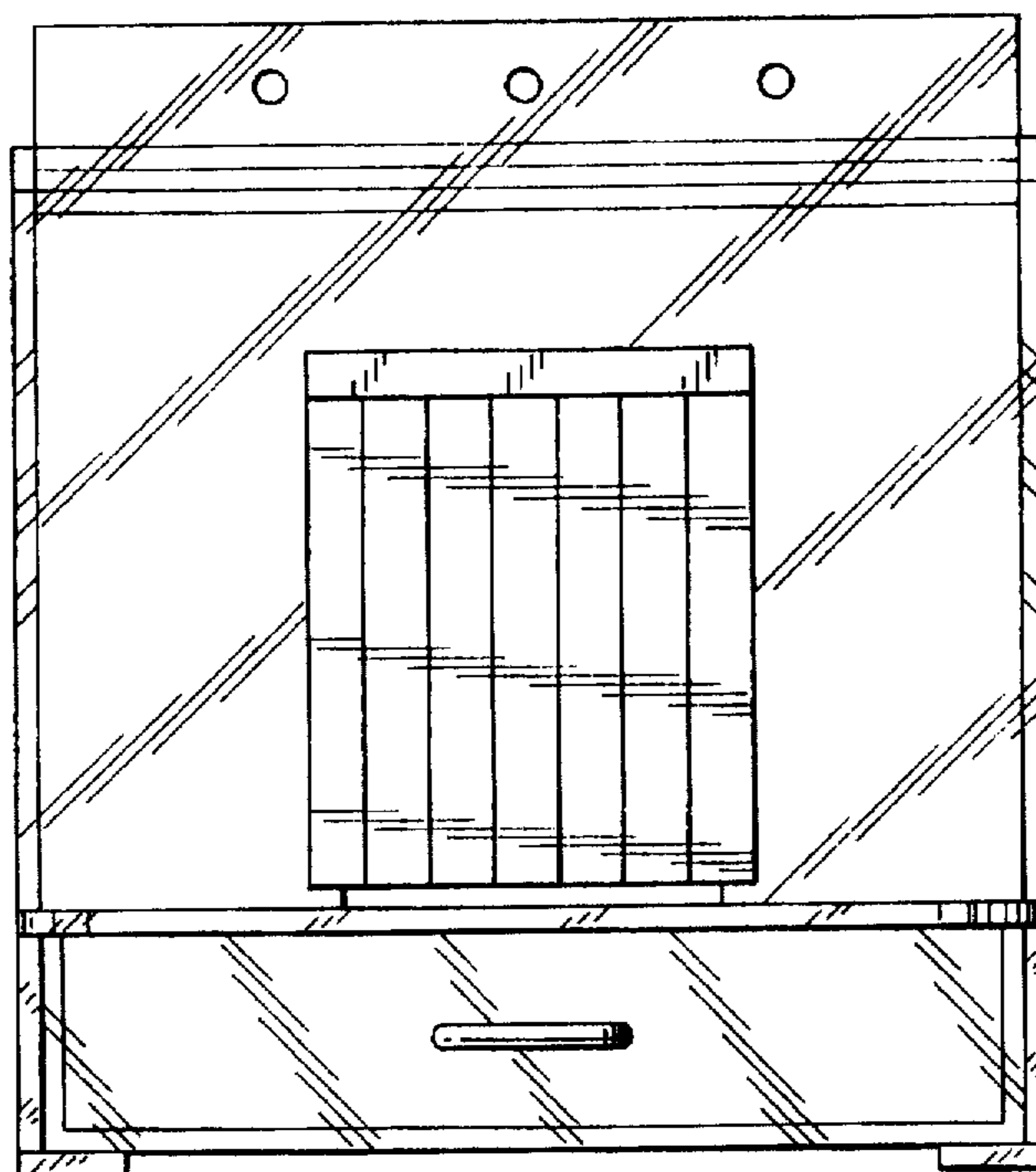

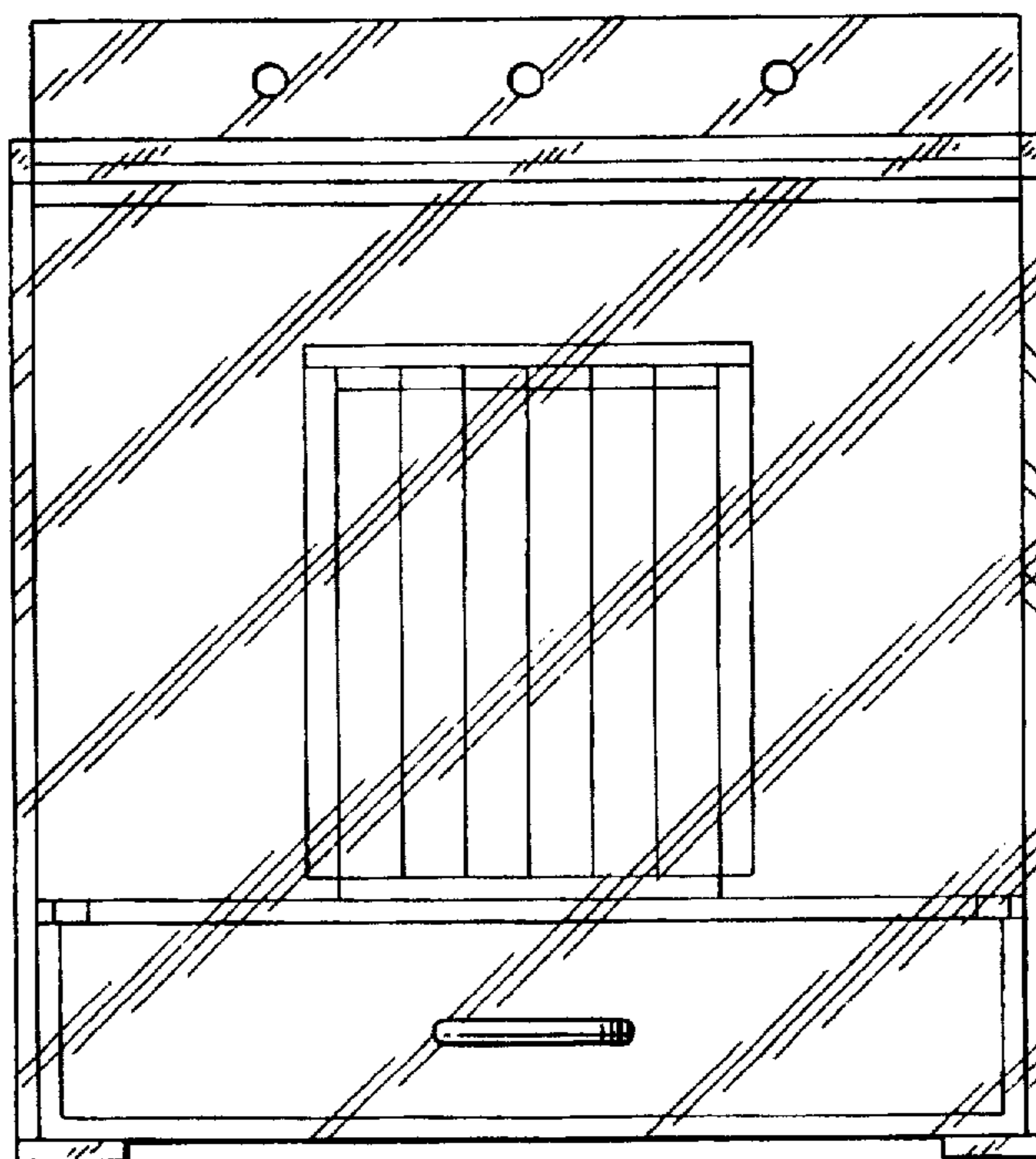

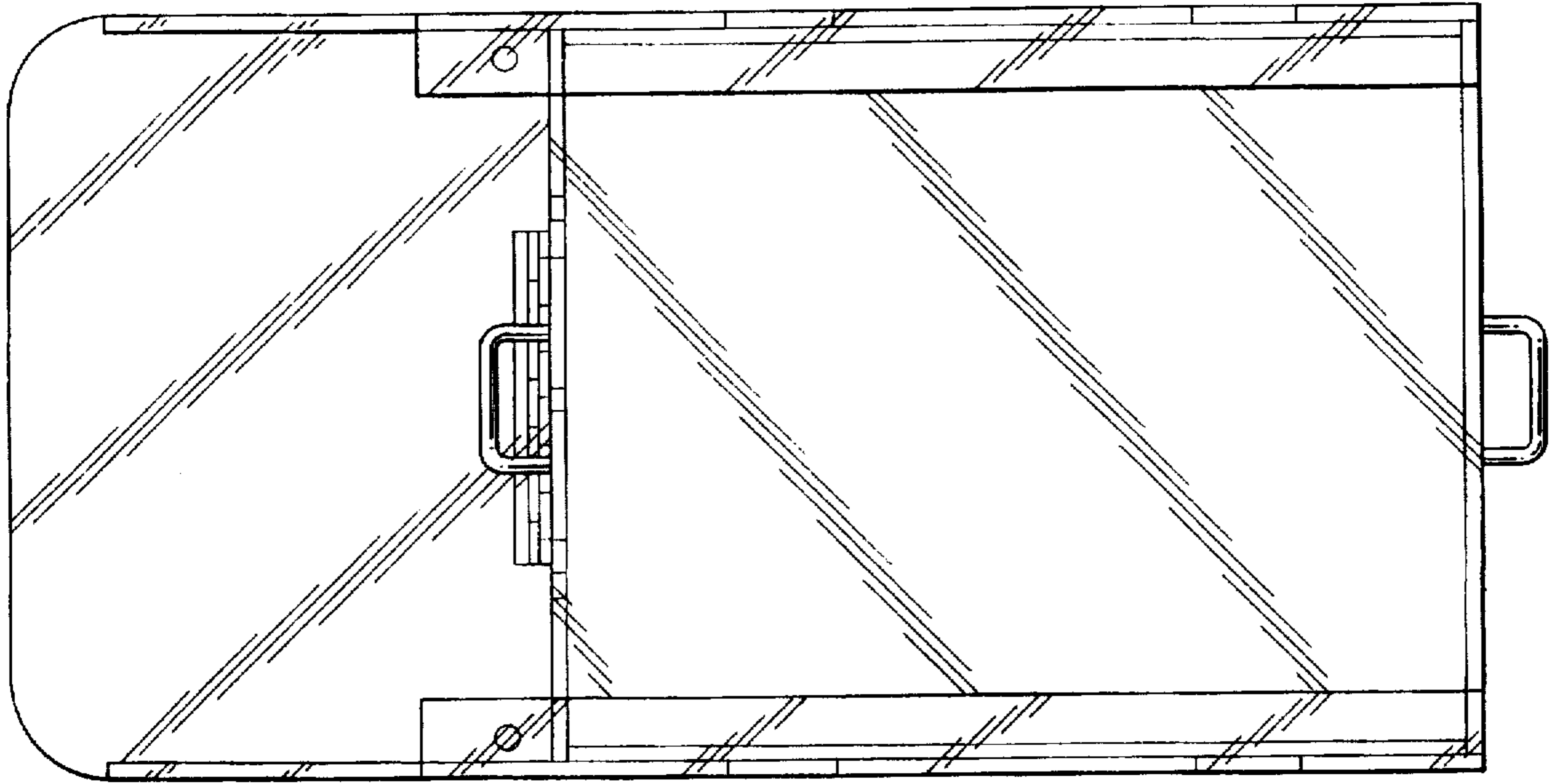
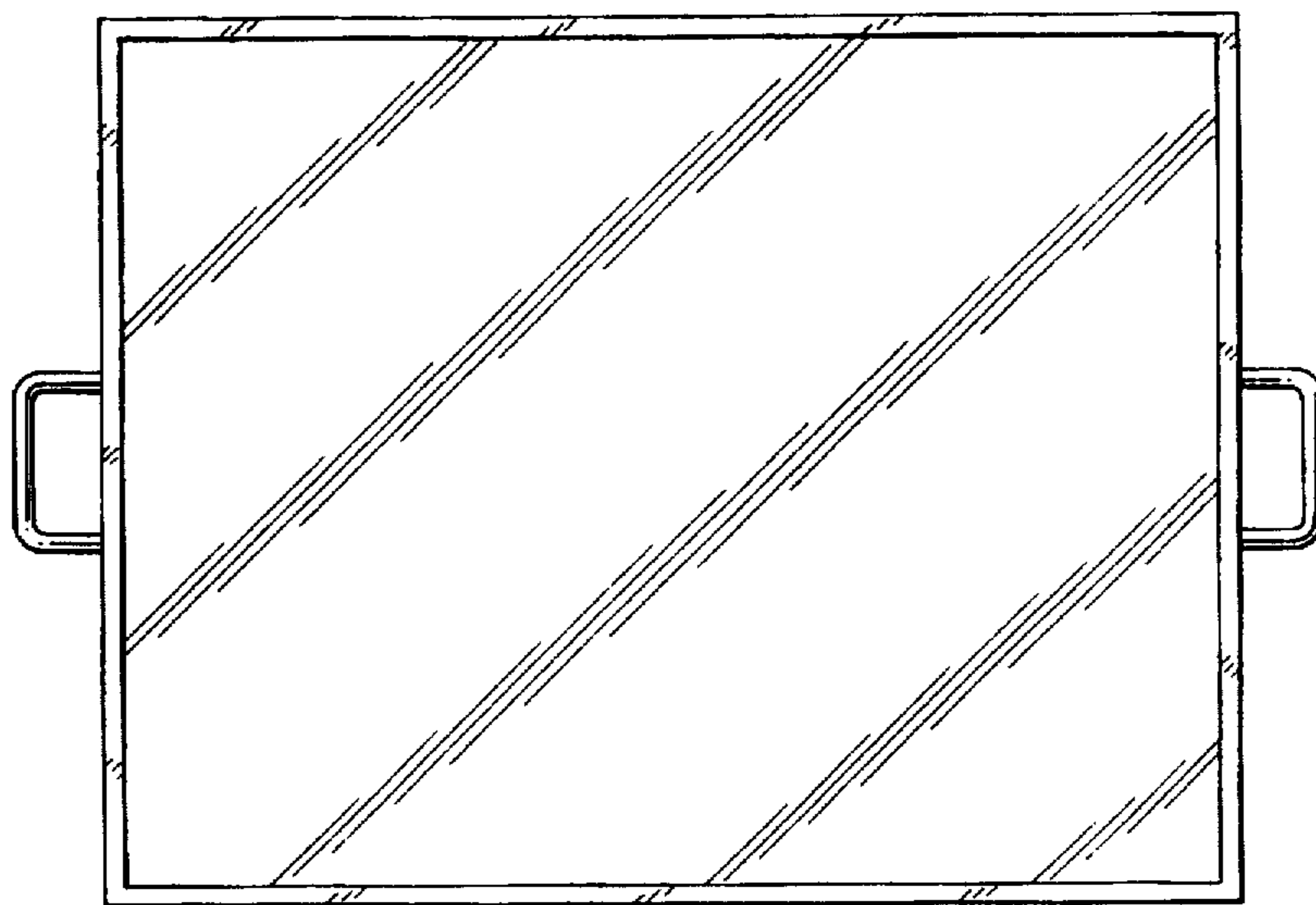

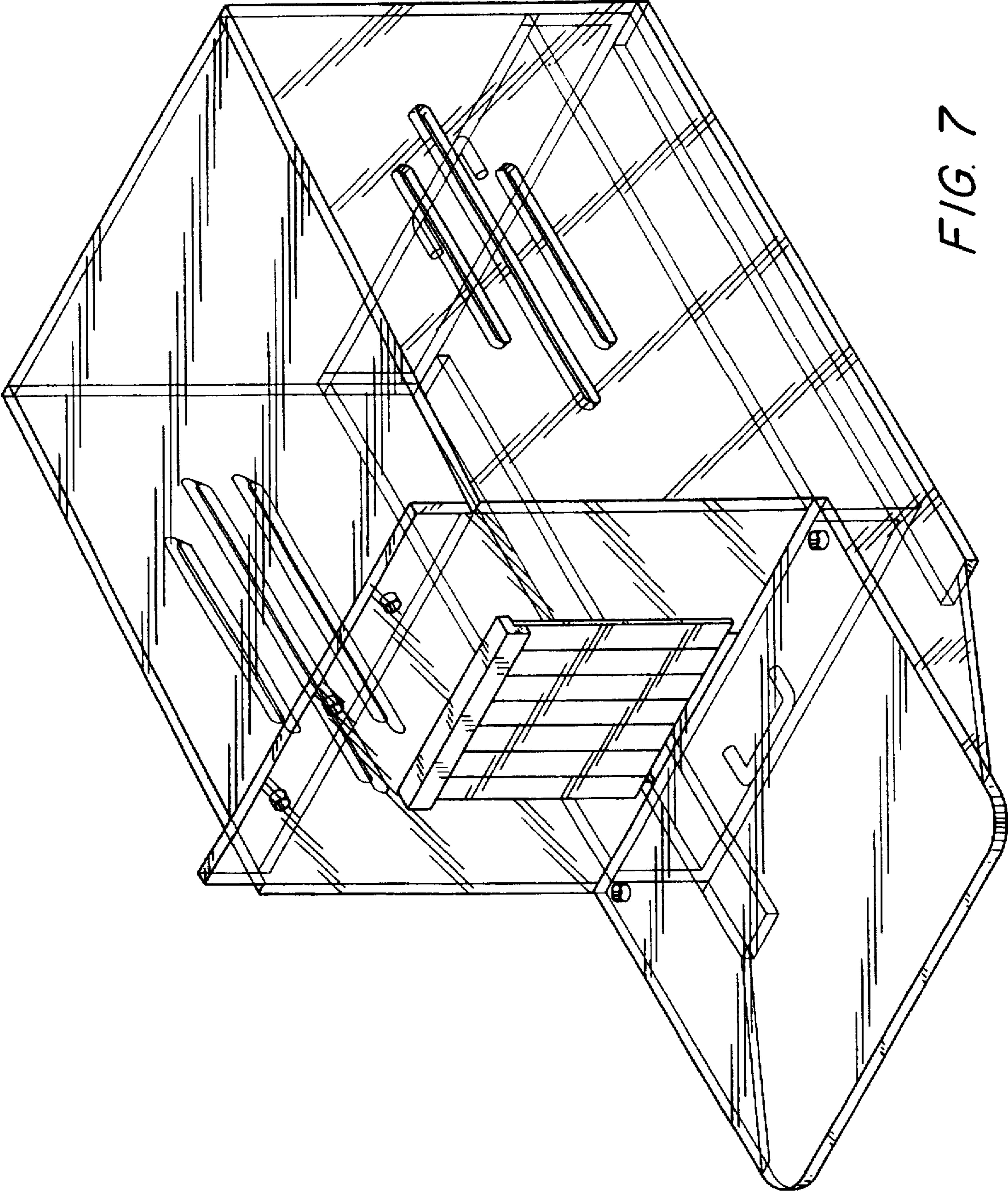
