[57] **CLAIM**

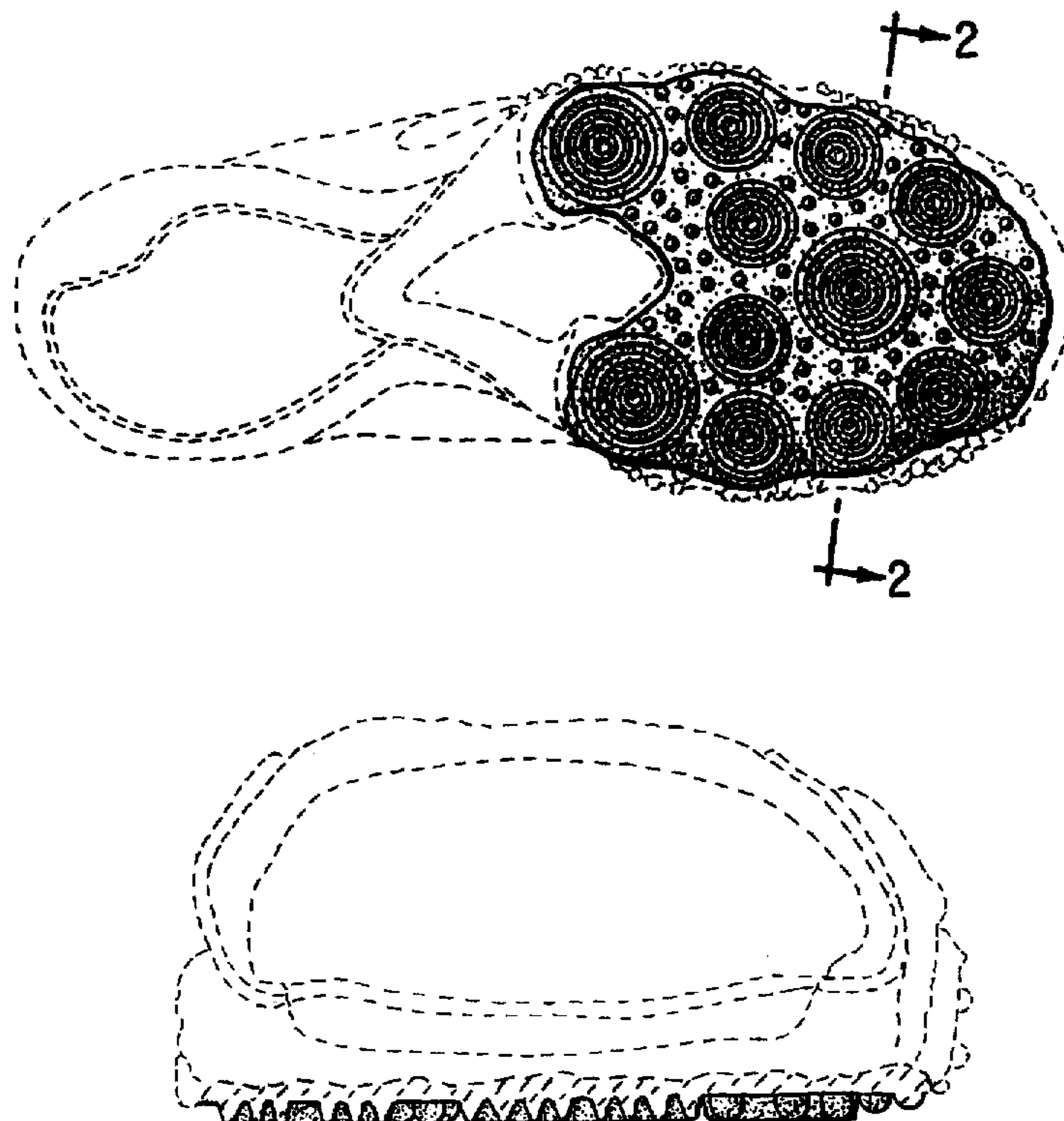
The ornamental design for a portion of sole bottom surface, as shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of a portion of a side bottom surface showing my new design; and, FIG. 2 is an enlarged cross-sectional view taken on line 2—2 of FIG. 1.

The broken line showing of the remainder of the sole outsole is for illustration purposes only and forms no part of the claimed design.

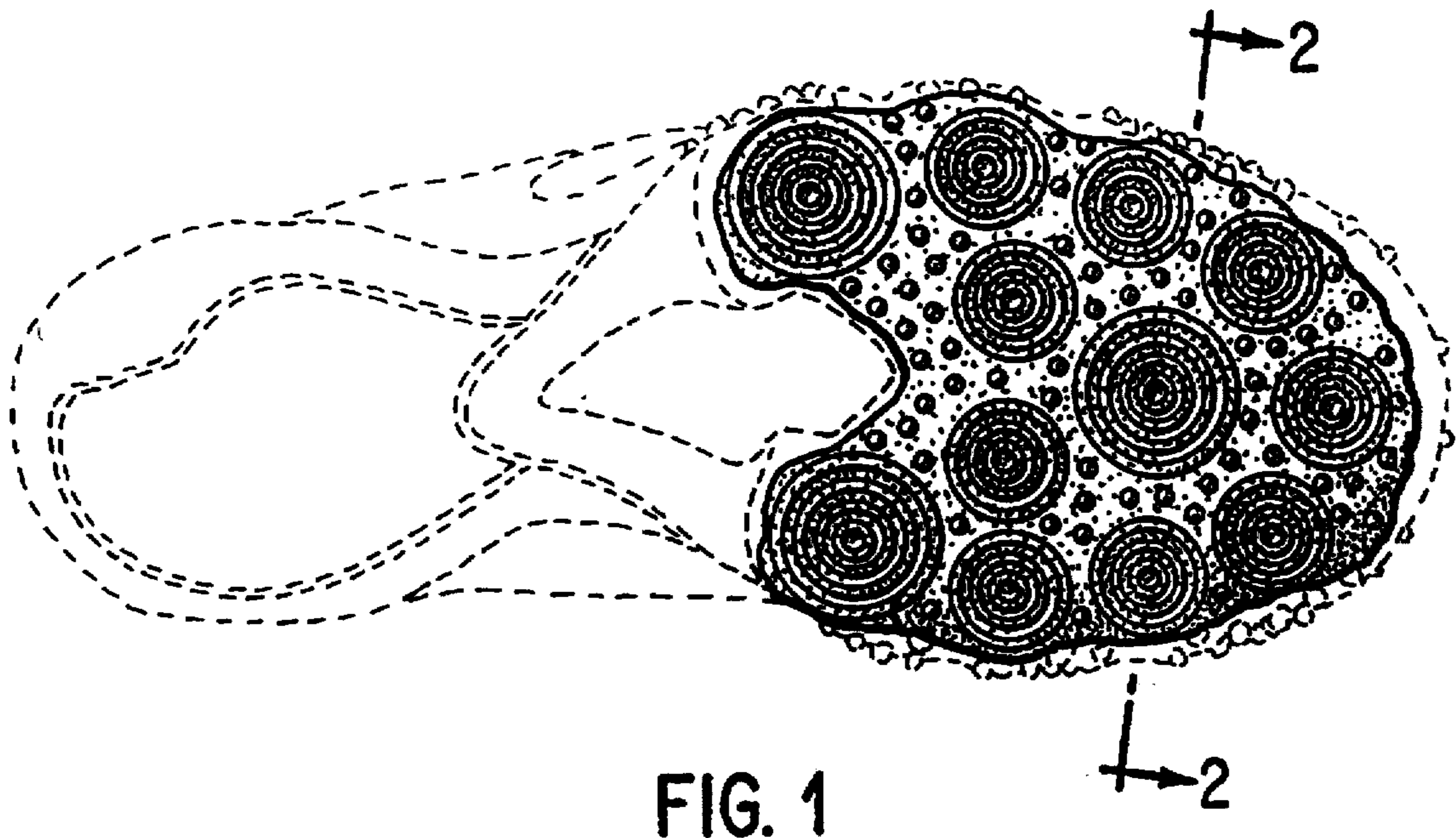

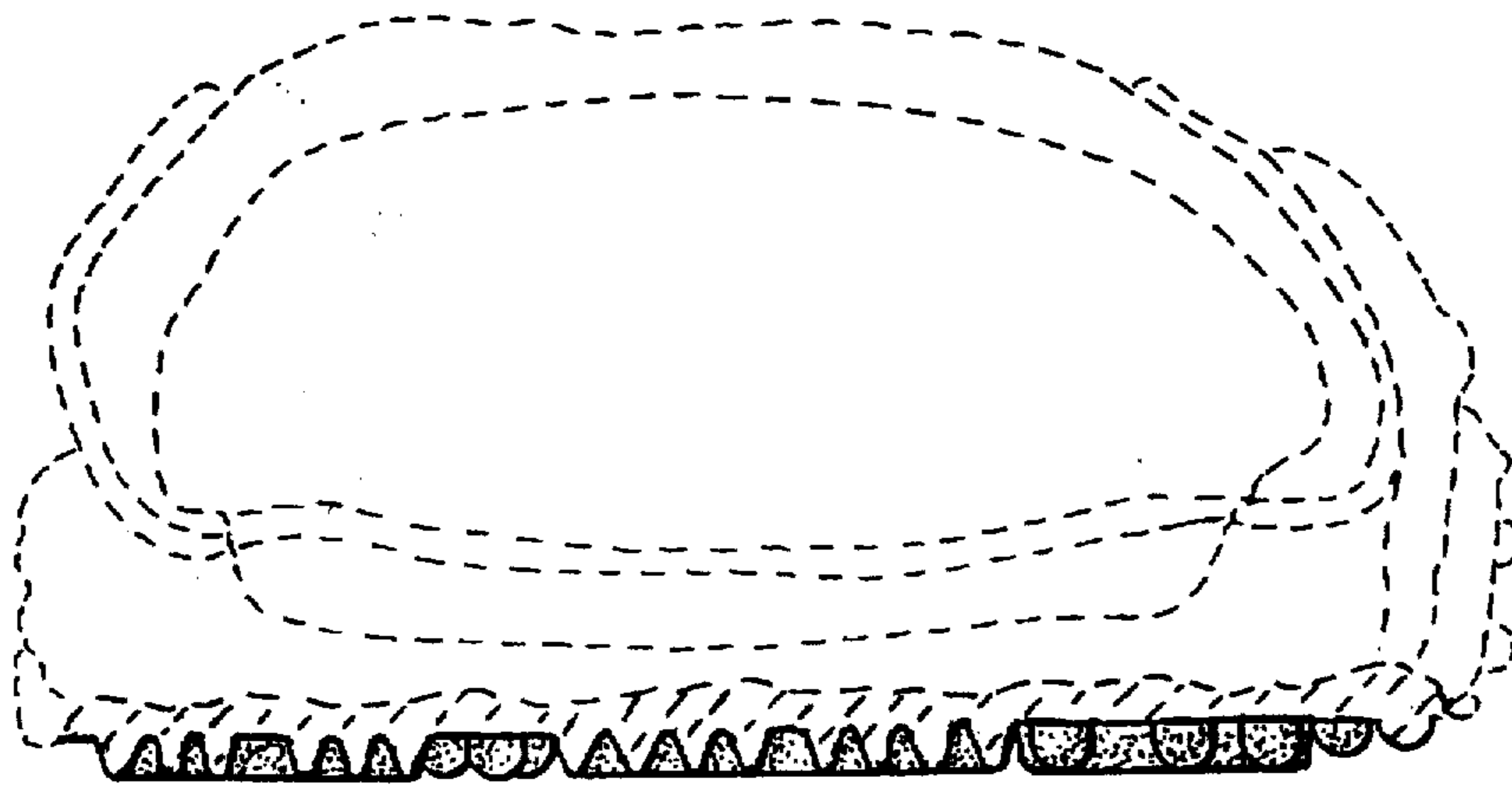
