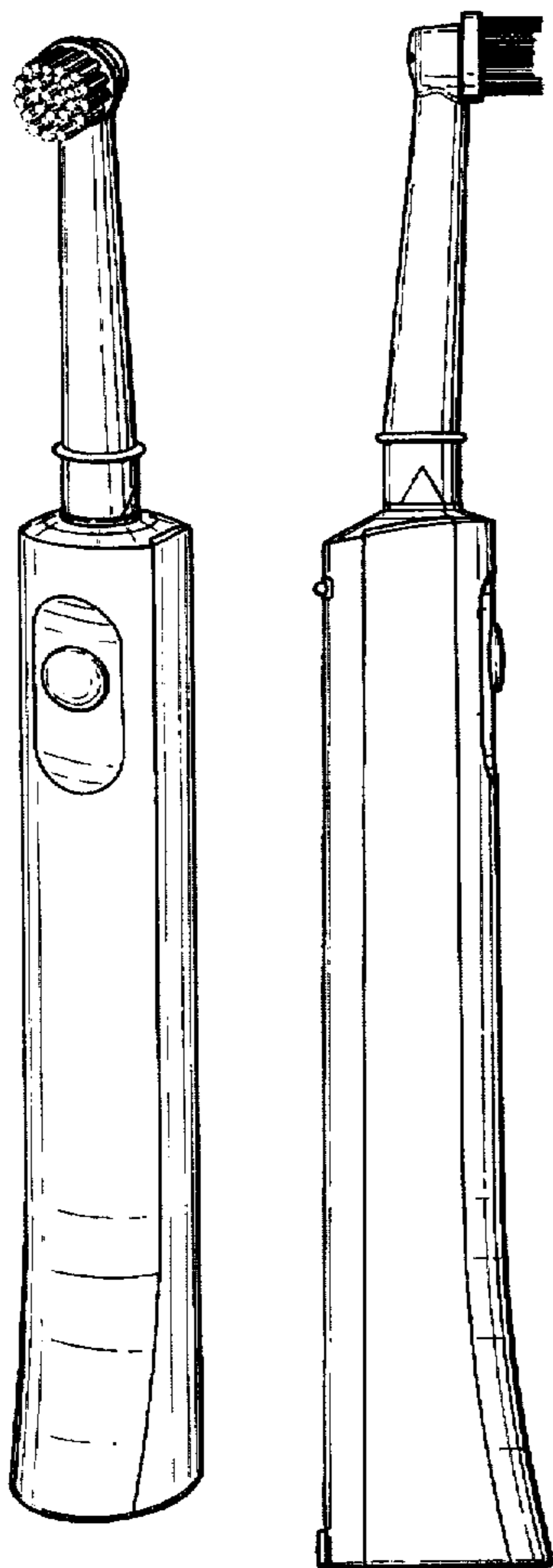
[57] **CLAIM**

The ornamental design for an electric toothbrush, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an electric toothbrush from above, showing my design;  
FIG. 2 is a front view of the appliance of FIG. 1;  
FIG. 3 is a right-side view of the appliance of FIG. 2;  
FIG. 4 is a left-side view of the appliance of FIG. 2;  
FIG. 5 is a rear view of the appliance of FIG. 2;  
FIG. 6 is a top plan view of the appliance of FIG. 2, and,  
FIG. 7 is a bottom plan view of the appliance of FIG. 2.

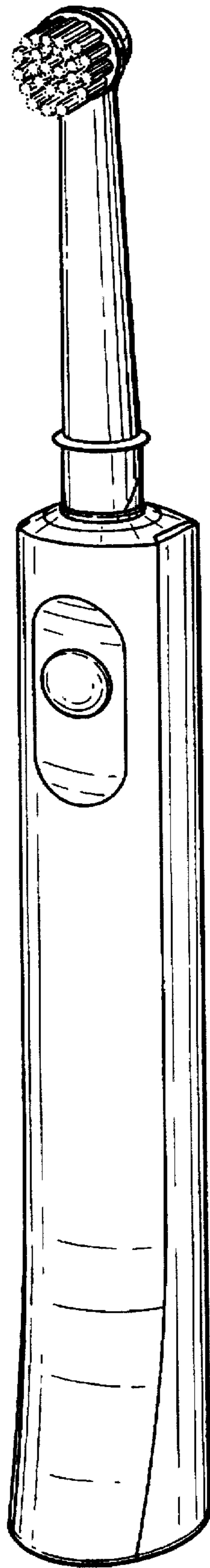

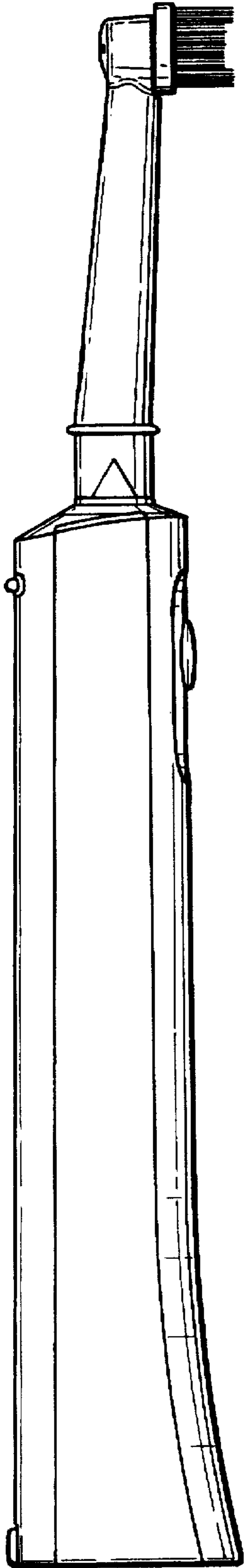

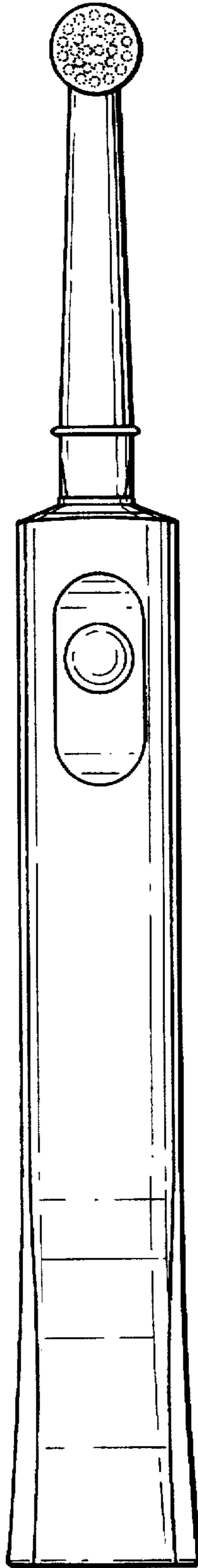

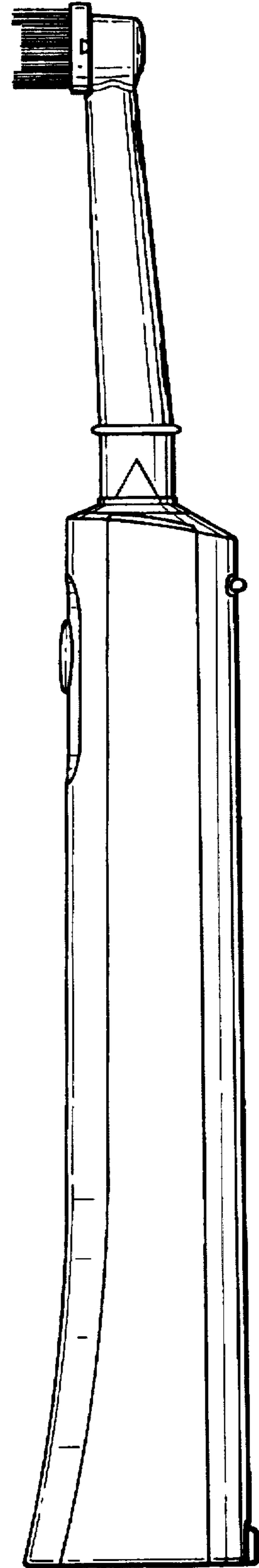

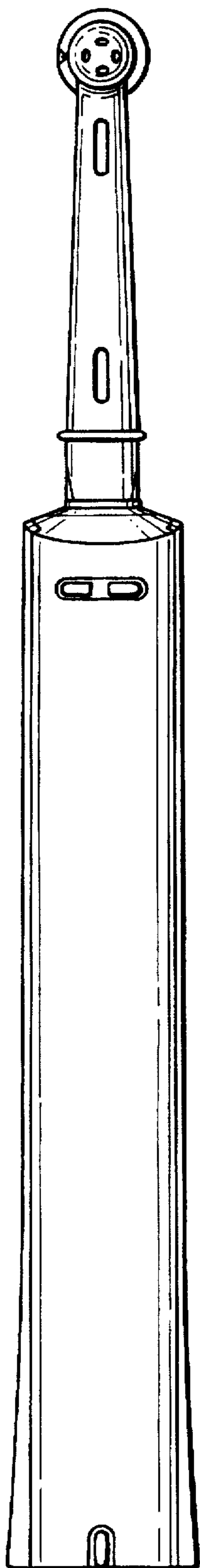

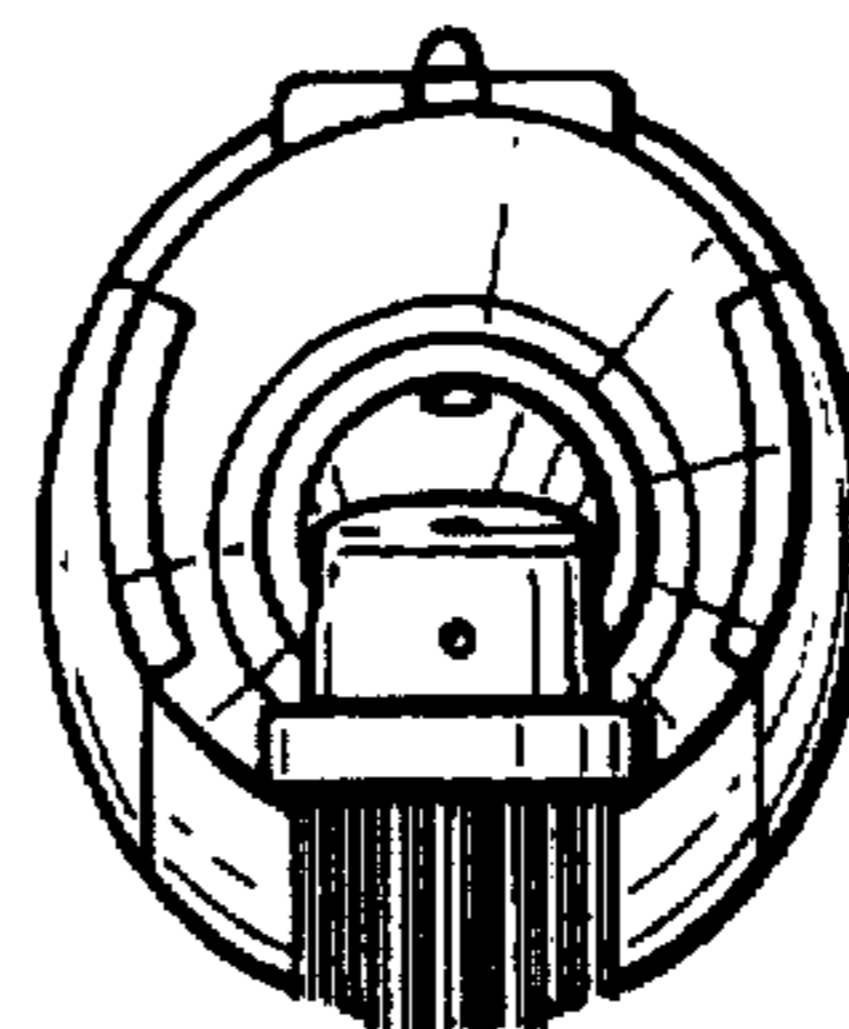

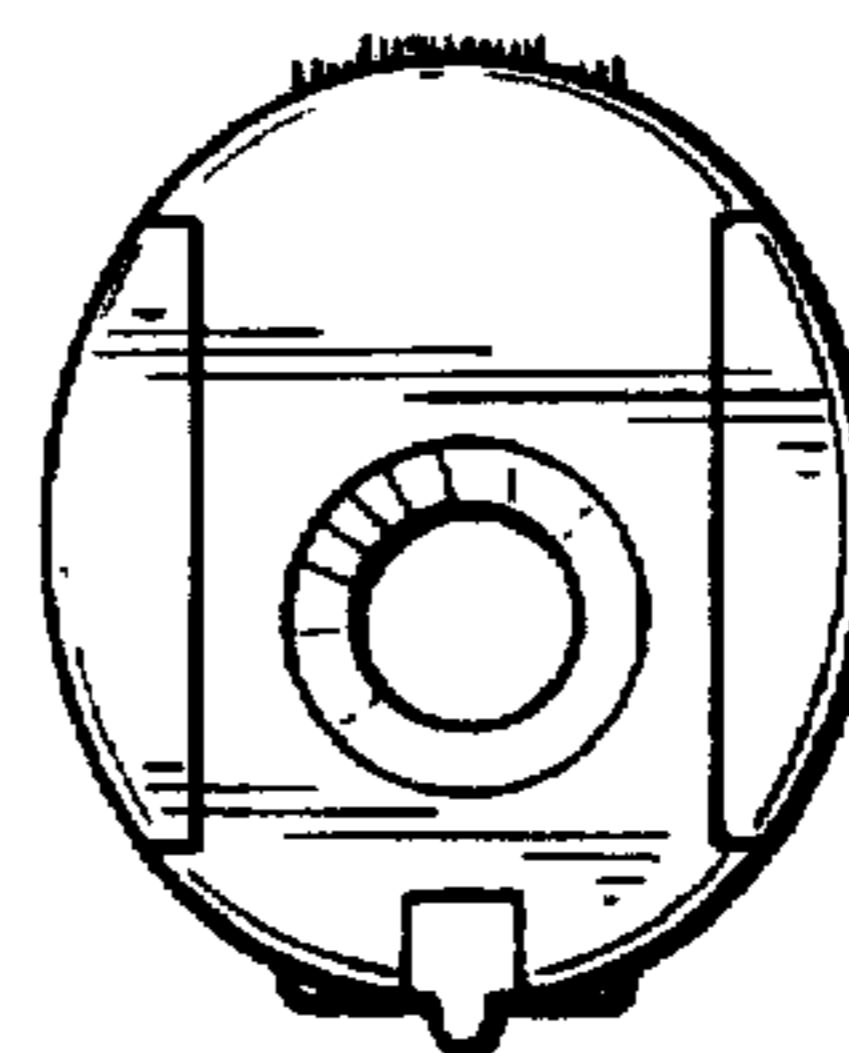
