[57] CLAIM

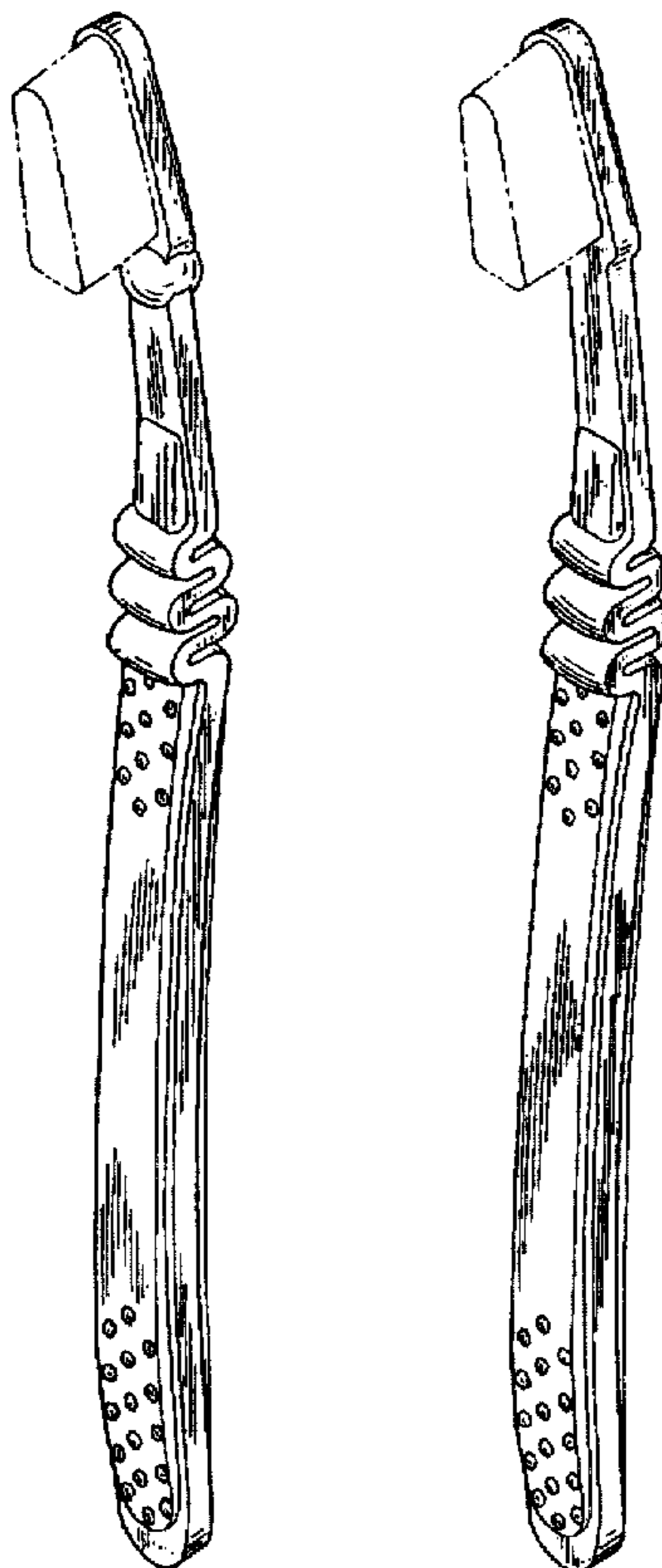
The ornamental design of a toothbrush handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from the front and one side; FIG. 2 is a rear elevational view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a side elevational view thereof; FIG. 5 is a cross sectional view taken along line 5—5 of FIG. 3; FIG. 6 is a cross sectional view taken along line 6—6 of FIG. 3; FIG. 7 is a cross sectional view taken along line 7—7 of FIG. 3; FIG. 8 is a perspective view of a second embodiment; FIG. 9 is a rear elevational view of FIG. 8; FIG. 10 is a front elevational view of FIG. 8; FIG. 11 is a side elevational view of FIG. 8; FIG. 12 is a cross sectional view taken along line 12—12 of FIG. 10; FIG. 13 is a cross sectional view taken along line 13—13 of FIG. 10; and, FIG. 14 is a cross sectional view taken along line 14—14 of FIG. 10.

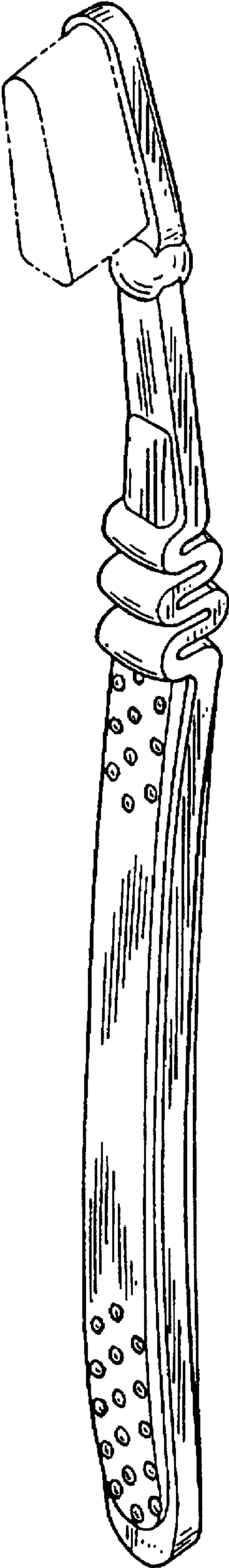

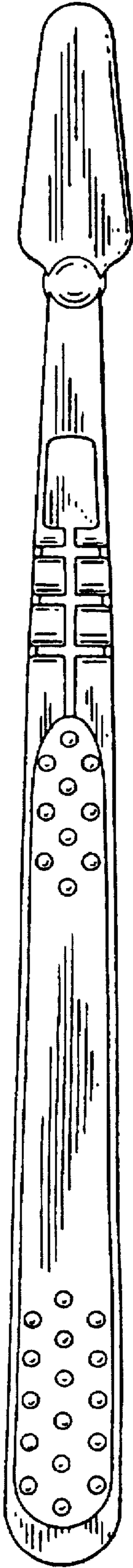

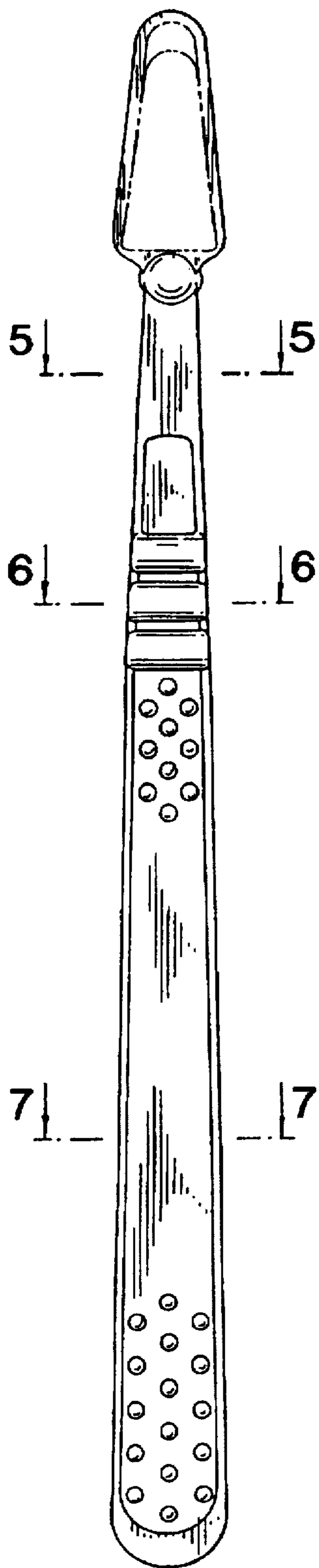

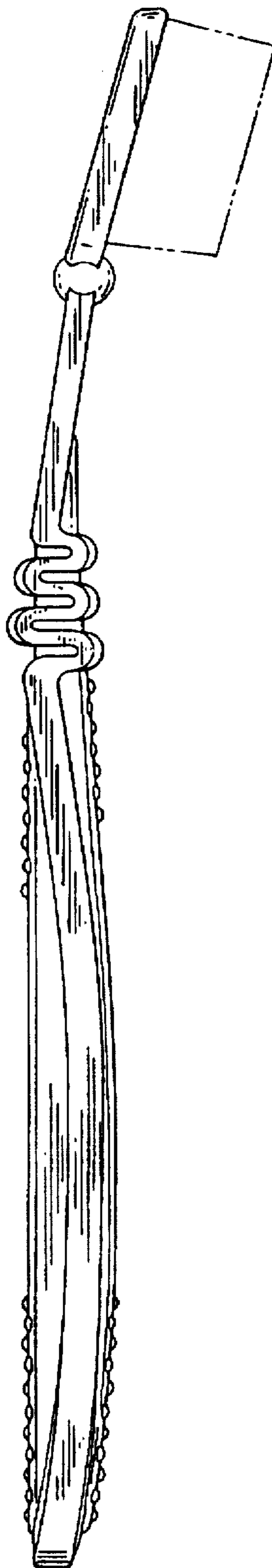

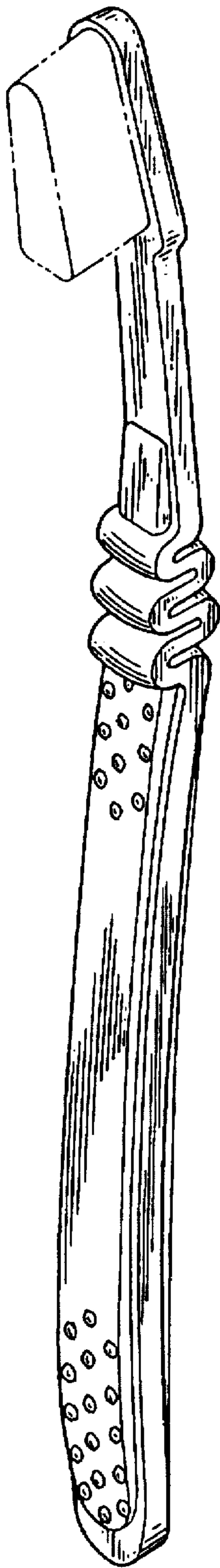

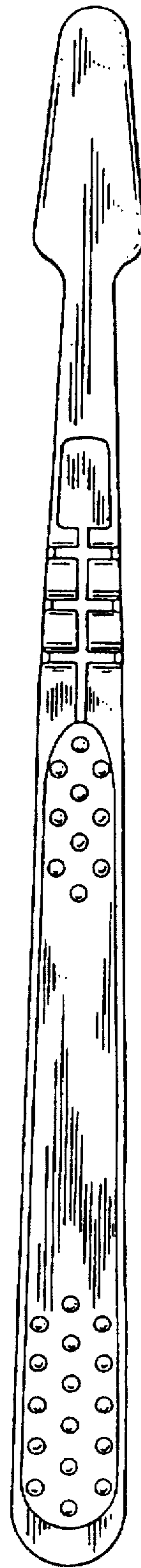

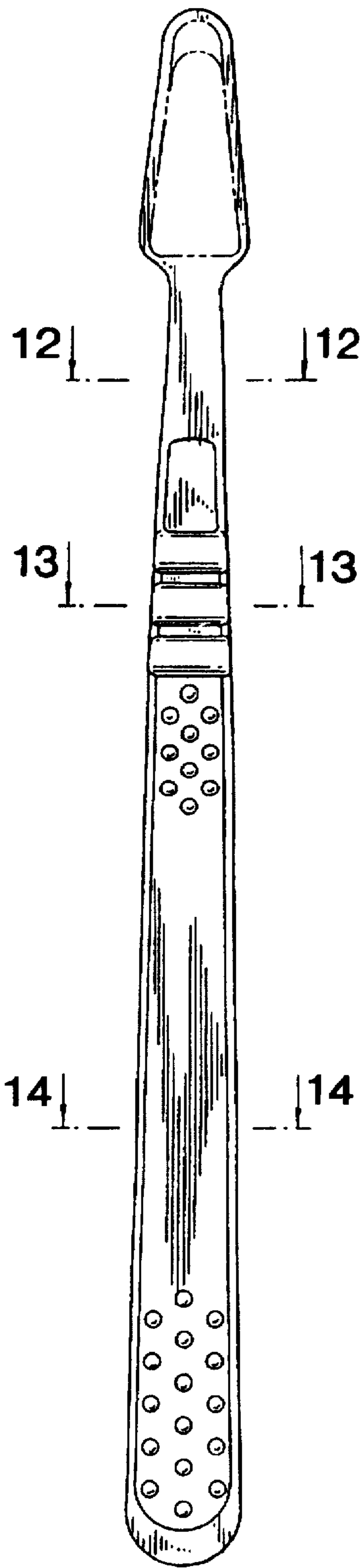

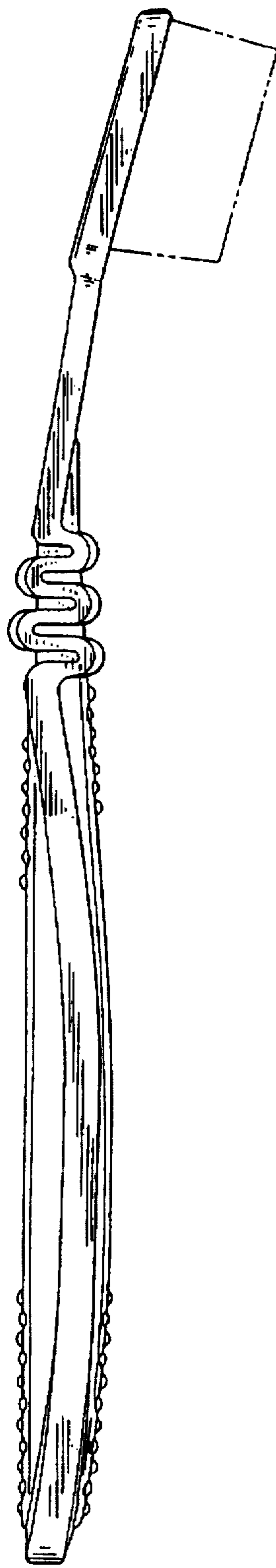
