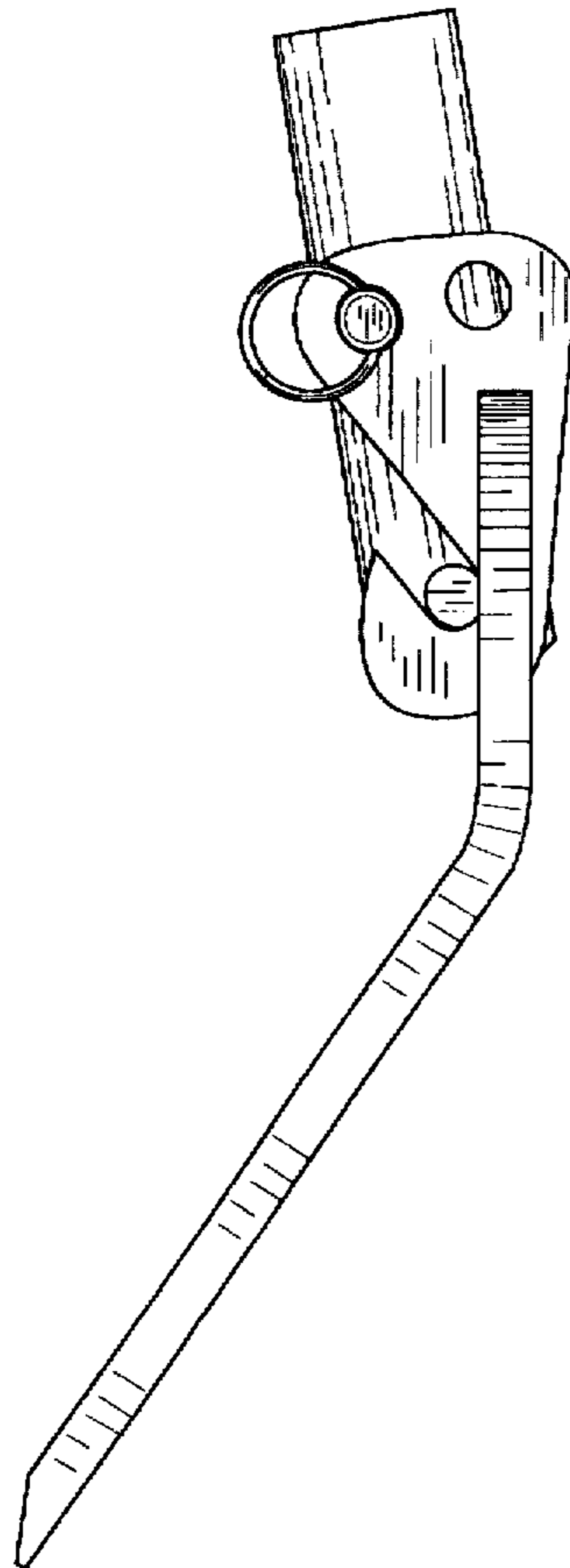
[57] **CLAIM**

The ornamental design for an adjustable shovel head, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an adjustable shovel head showing my new design;
FIG. 2 is an exploded perspective;
FIG. 3 is a bottom rear perspective view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof; and,
FIG. 7 is a right side elevational view thereof, showing the pin in an alternate hole.
The broken line showing of a handle is for illustrative purposes only and forms no part of the claimed design.

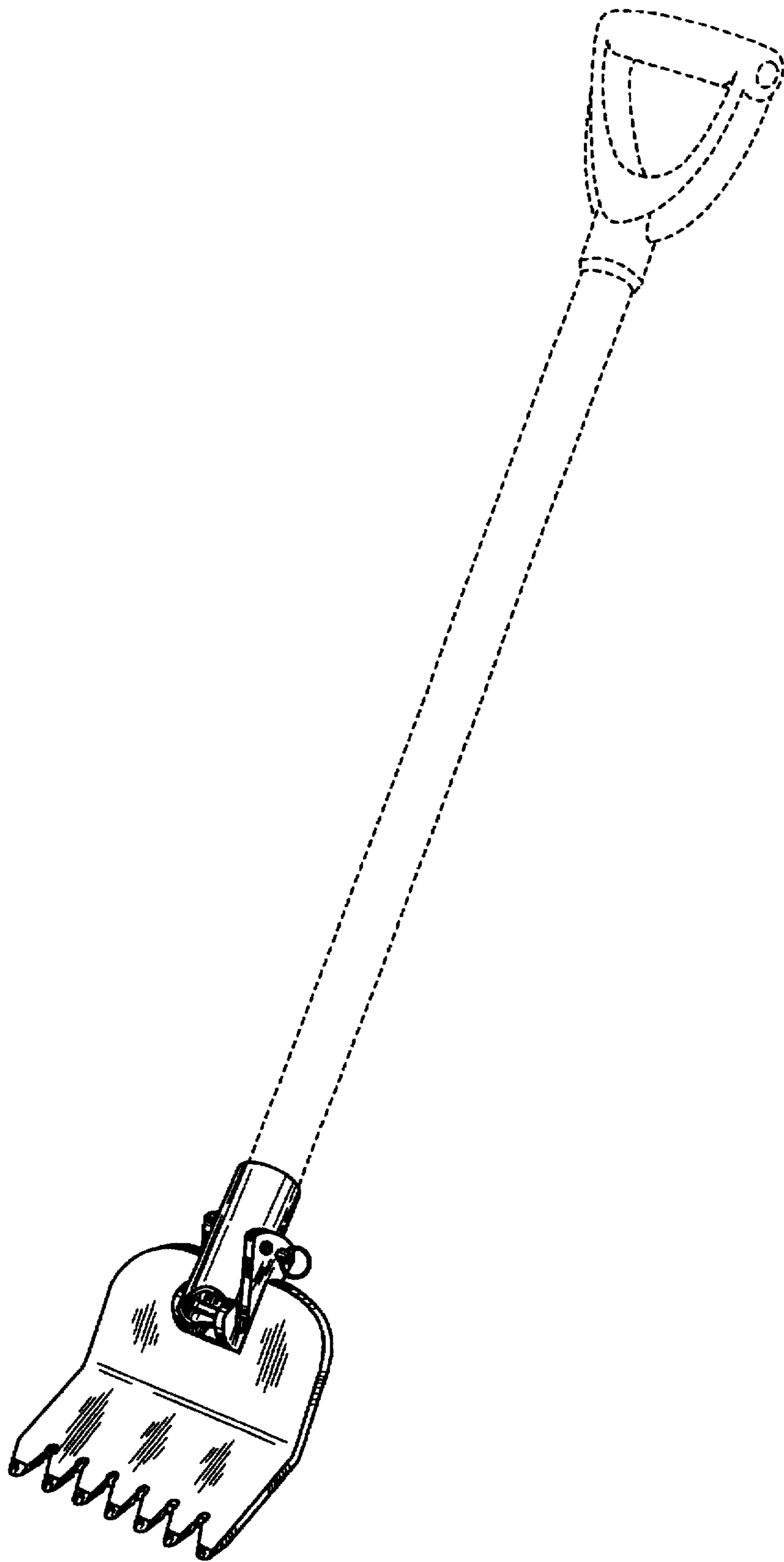

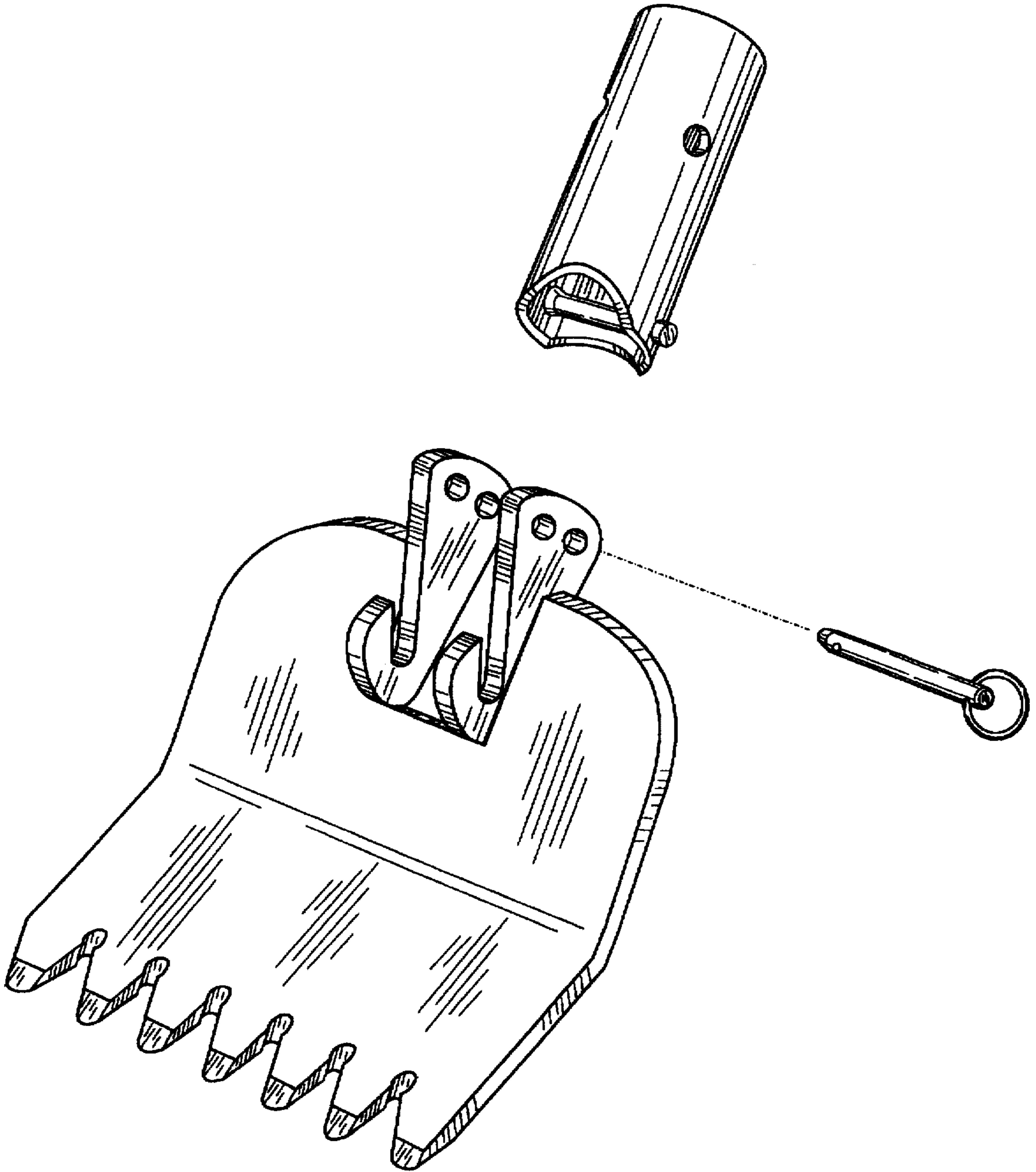

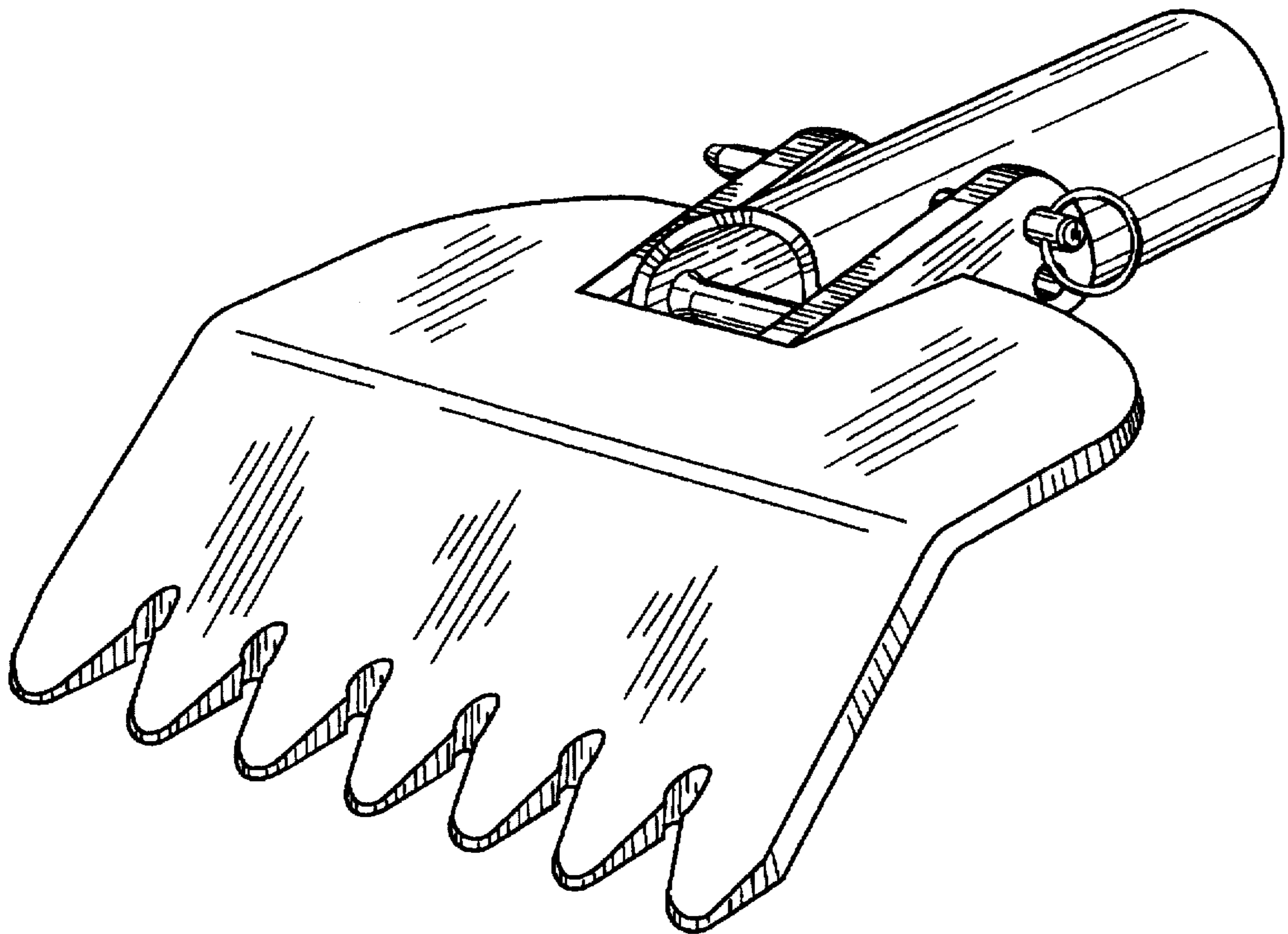

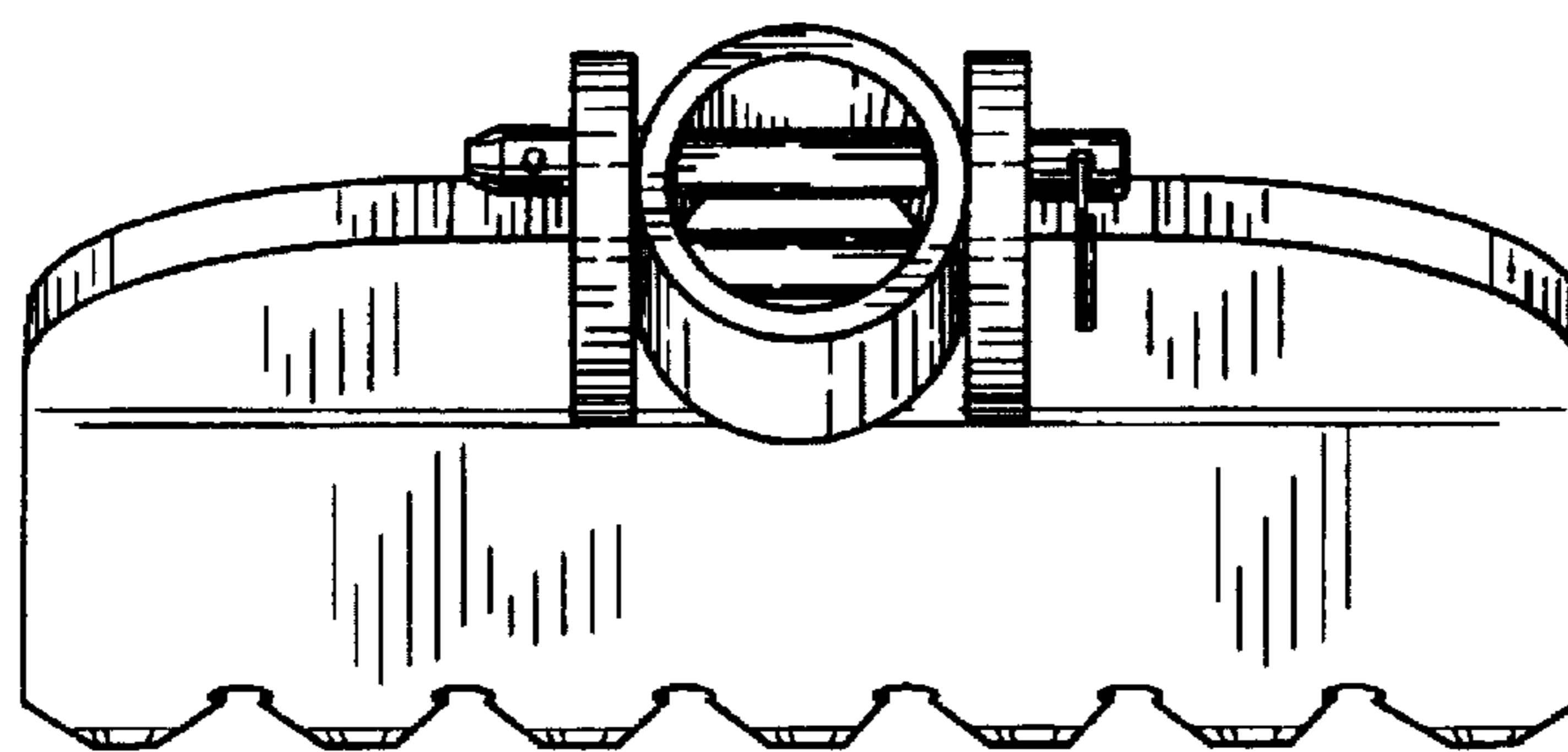

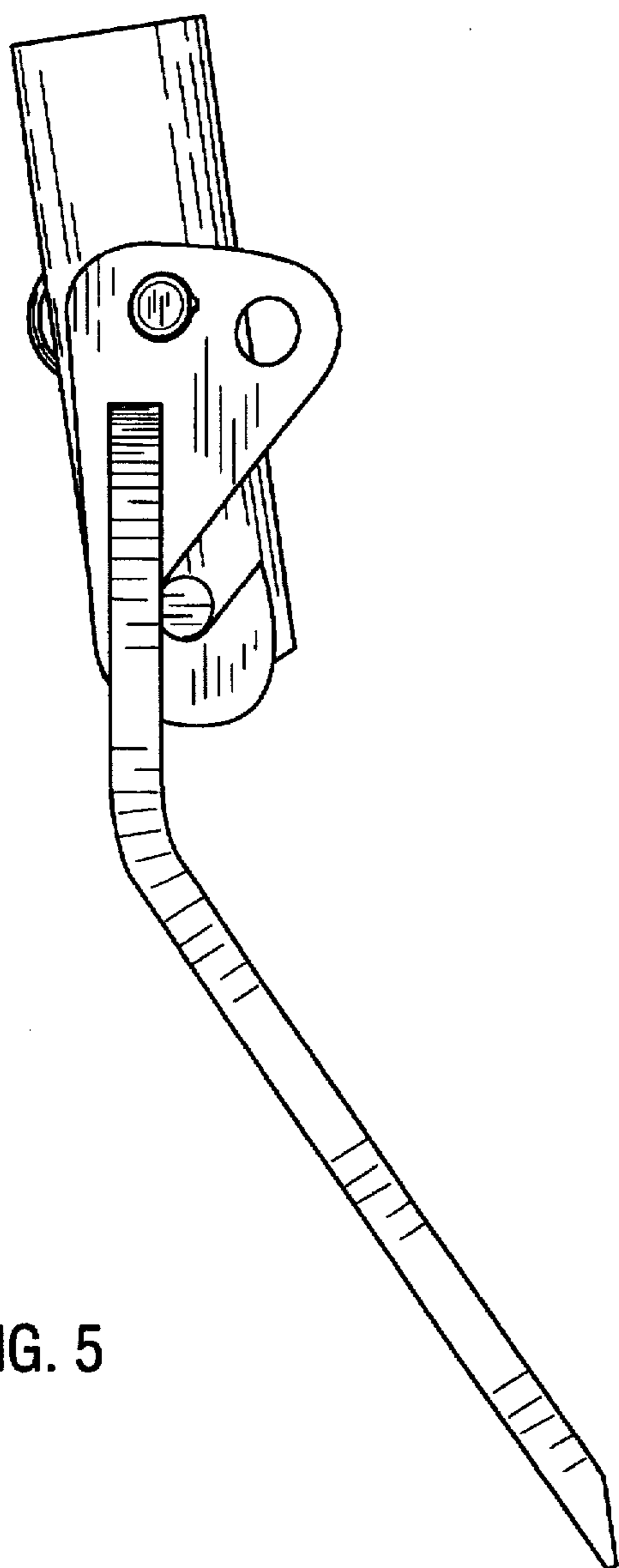

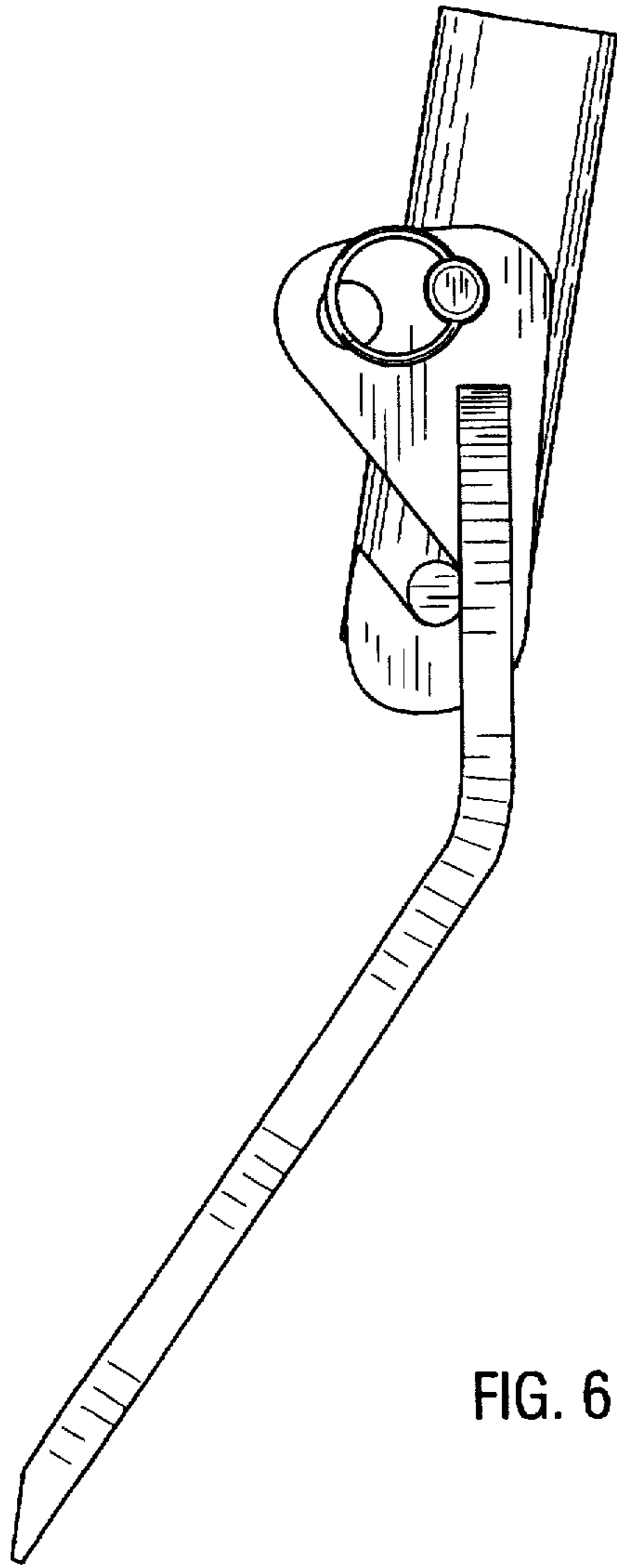

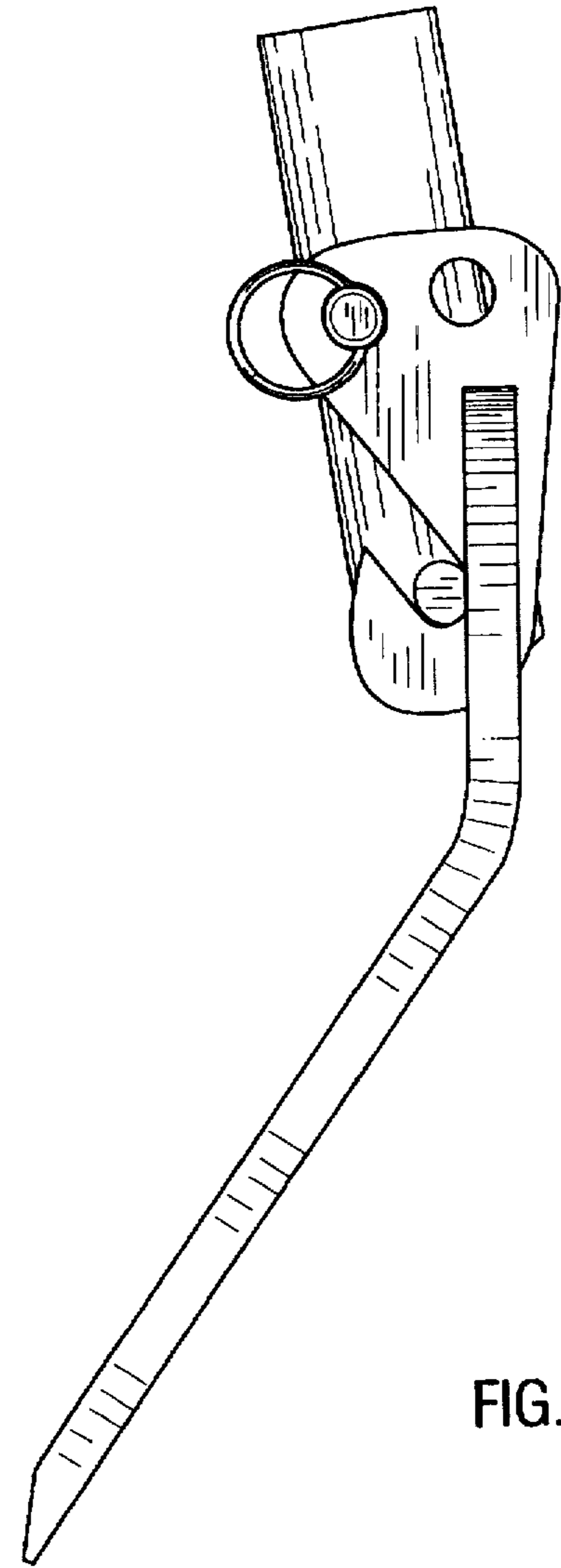
