The ornamental design for a scale, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and right side perspective view of a scale in accordance with a first embodiment of the new design;

FIG. 2 is a top plan view in accordance with the first embodiment thereof;

FIG. 3 is a right side view in accordance with the first embodiment thereof and the left side view is a mirror image of the right side view;

FIG. 4 is a front elevational view in accordance with the first embodiment view thereof;

FIG. 5 is a rear elevational view in accordance with the first embodiment thereof; and

FIG. 6 is a top, front and right side perspective view of a scale in accordance with a second embodiment of the new design;

FIG. 7 is a top plan view in accordance with the second embodiment thereof;

FIG. 8 is a right side view in accordance with the second embodiment thereof and the left side view is a mirror image of the right side view except for the arrangement of which keys are visible in the left side view;

FIG. 9 is a front elevational view in accordance with the second embodiment thereof;

FIG. 10 is a rear elevational view in accordance with the second embodiment thereof; and

FIG. 11 is a top, front and right side perspective view of a scale in accordance with a third embodiment of the new design;

FIG. 12 is a top plan view in accordance with the third embodiment thereof;

FIG. 13 is a right side view in accordance with the third embodiment thereof and the left side view is a mirror image of the right side view except for the arrangement of which keys are visable in the left side view;

FIG. 14 is a front elevational view in accordance with the third embodiment thereof;

FIG. 15 is a rear elevational view in accordance with the third embodiment thereof; and

FIG. 16 is a top, front and right side perspective view of a scale in accordance with a fourth embodiment of the new design;

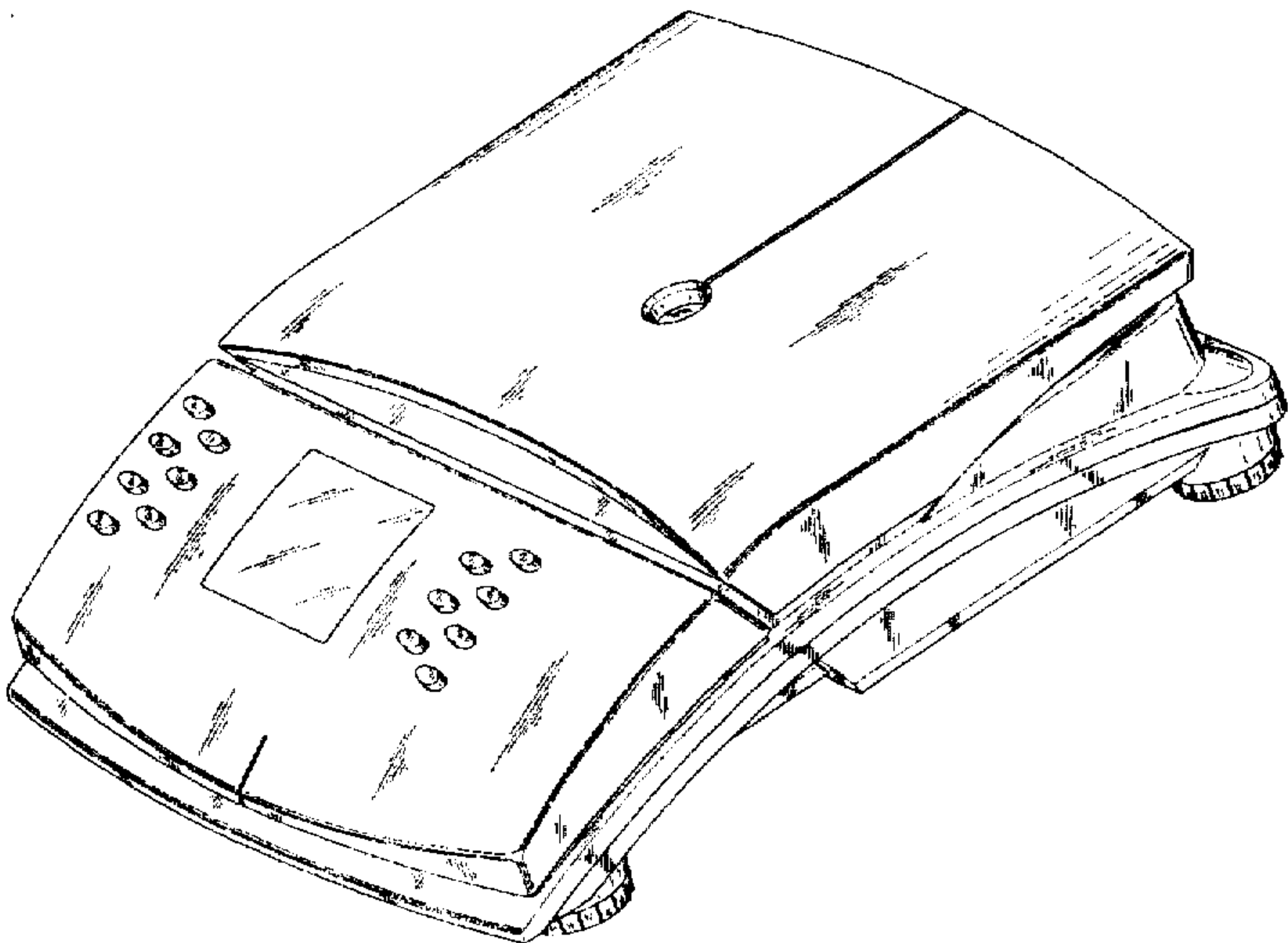
FIG. 17 is a top plan view in accordance with the fourth embodiment thereof;

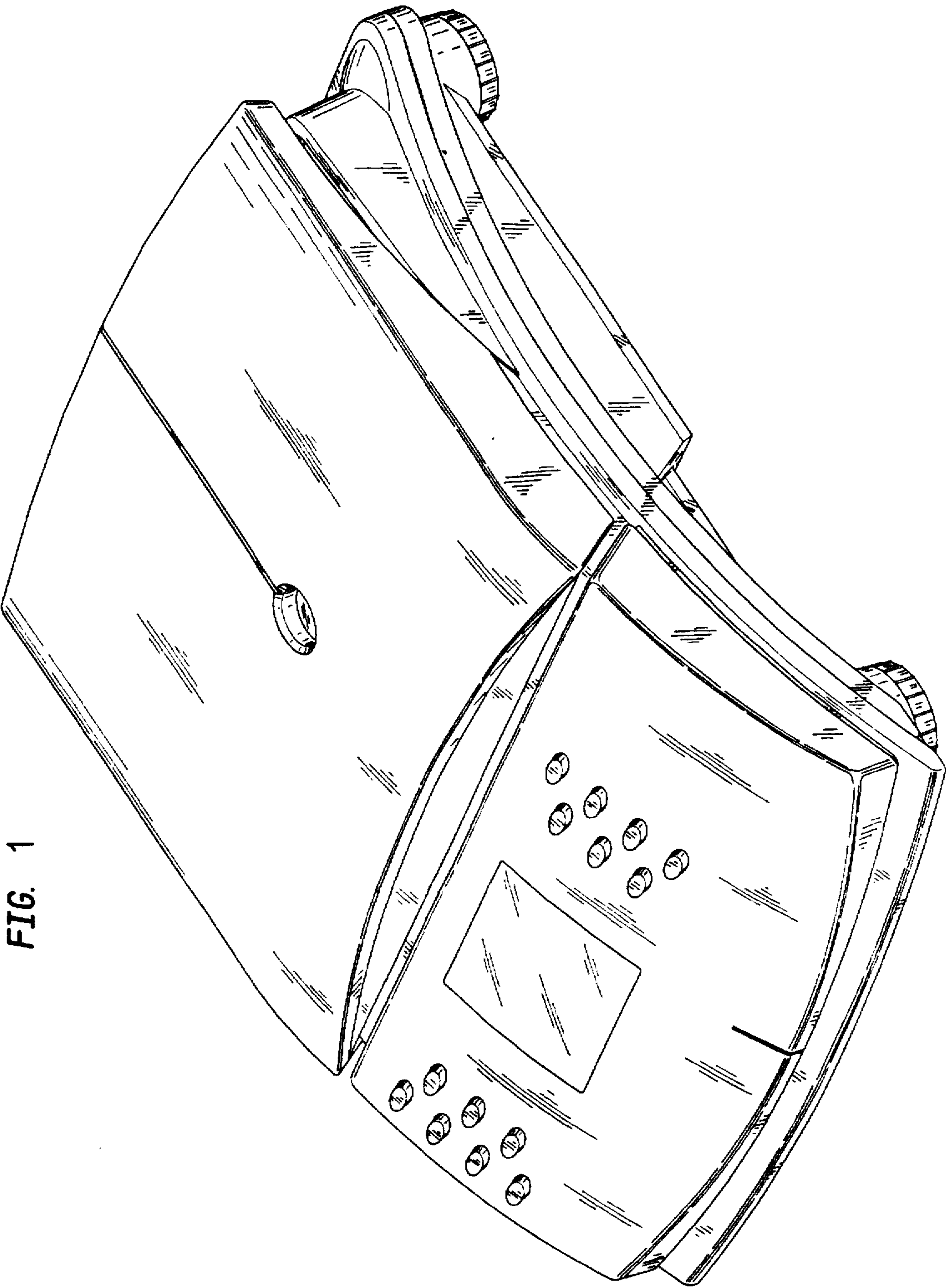

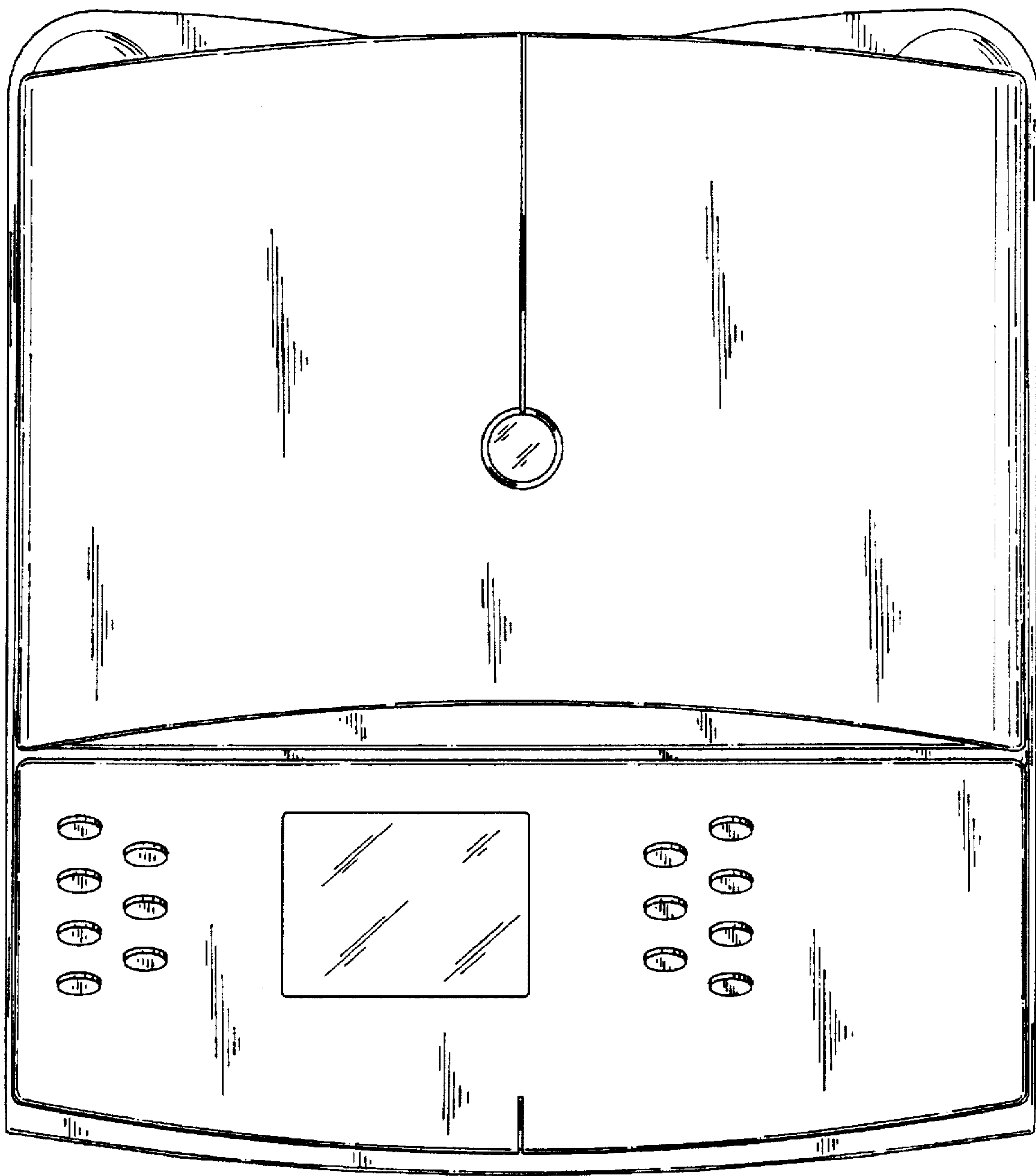

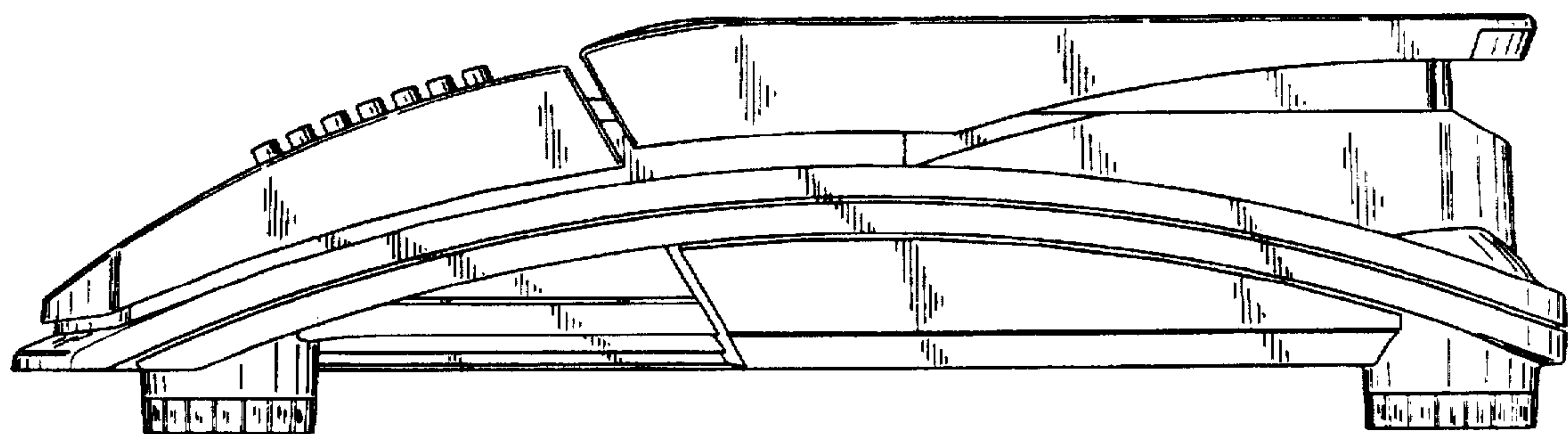
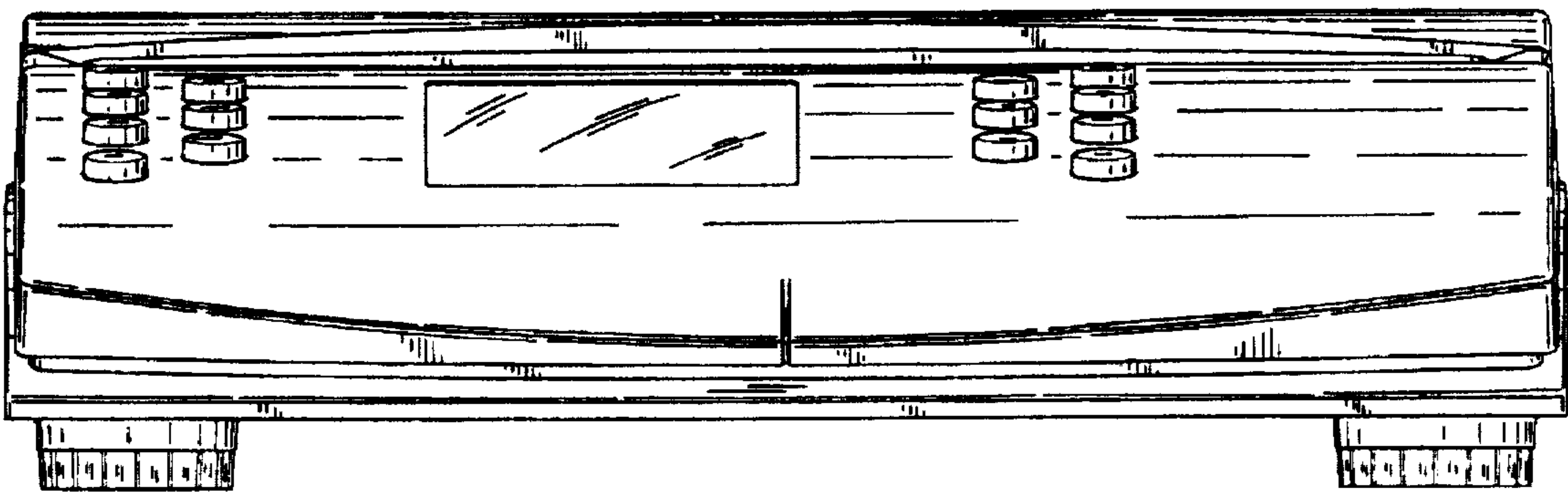
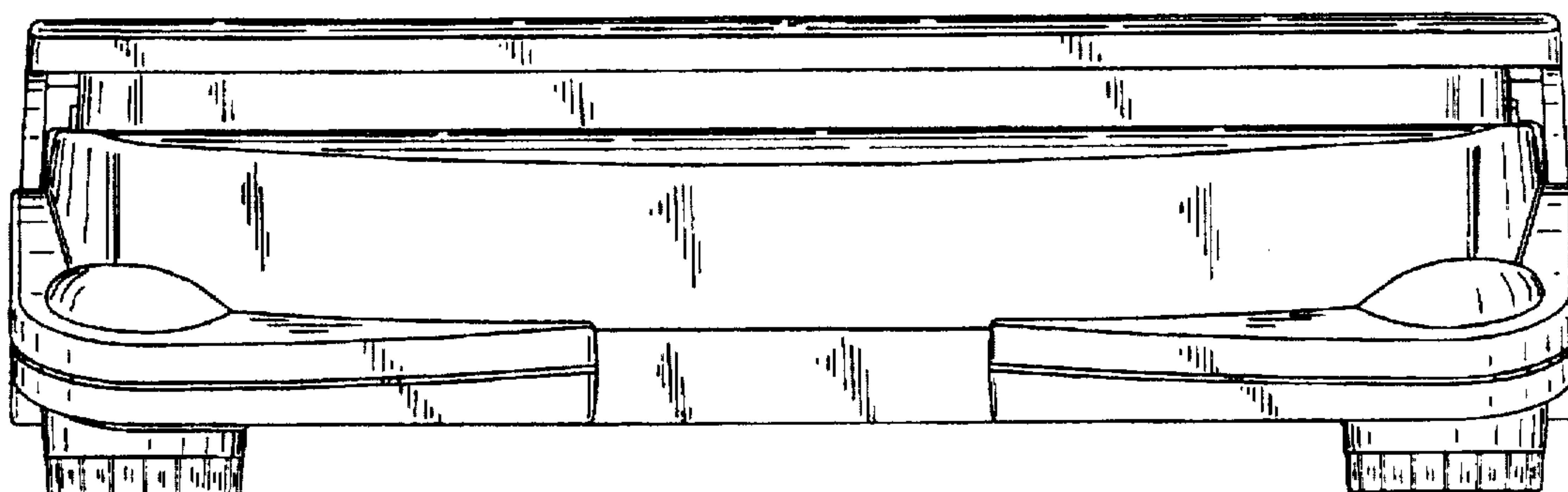

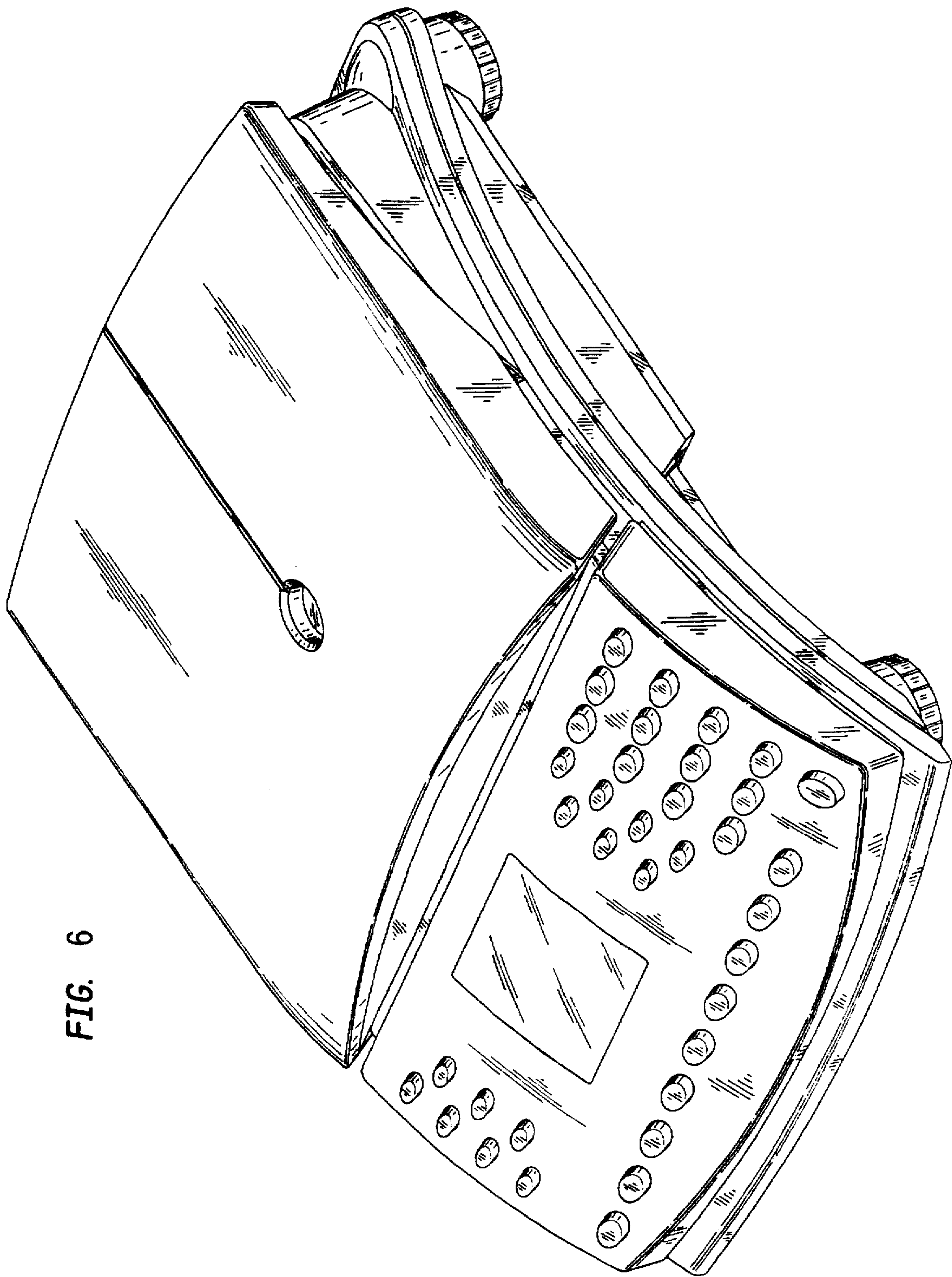

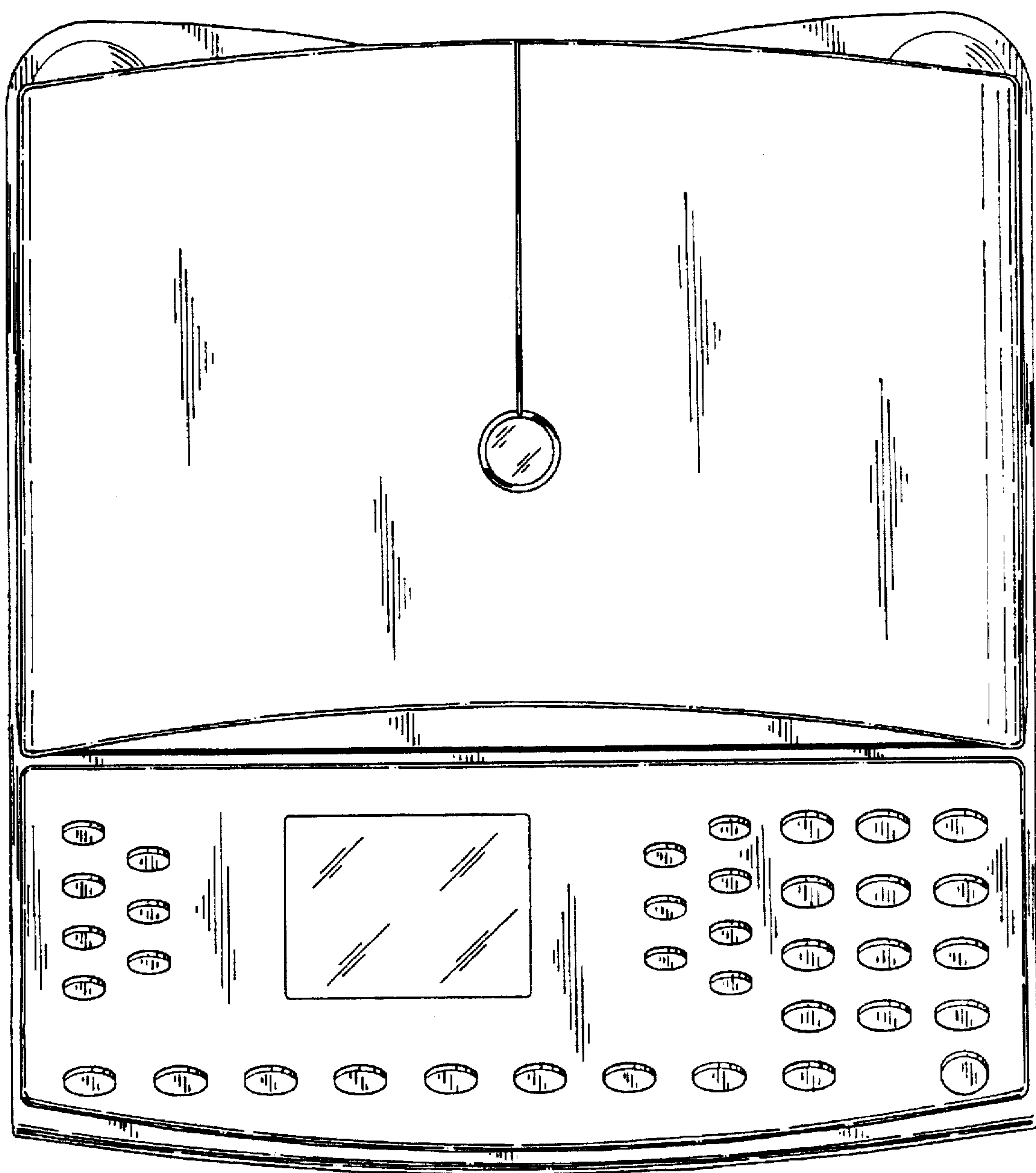

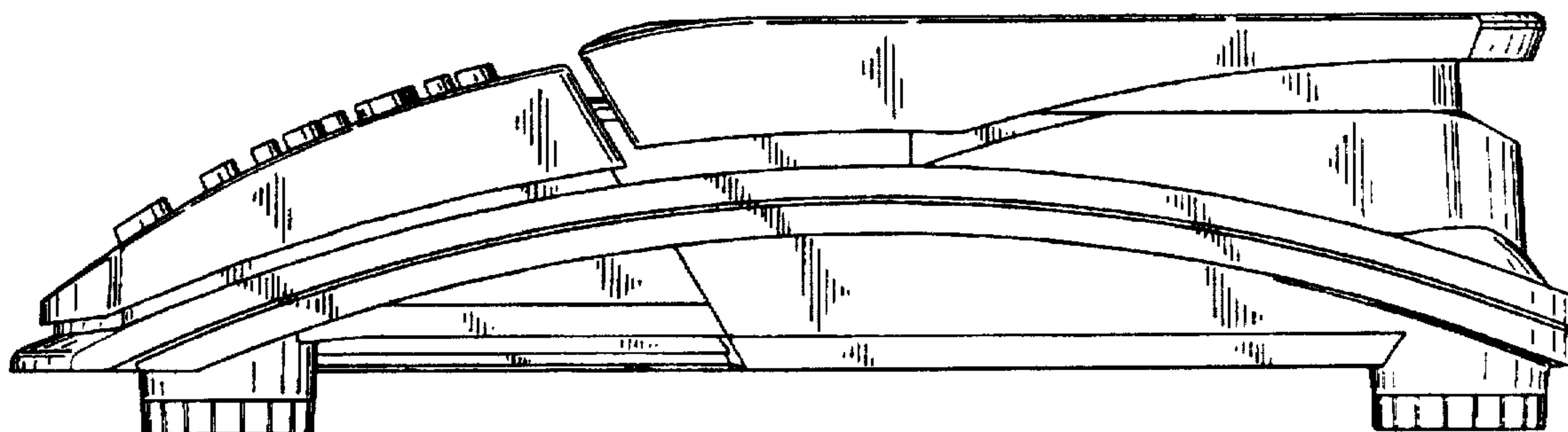
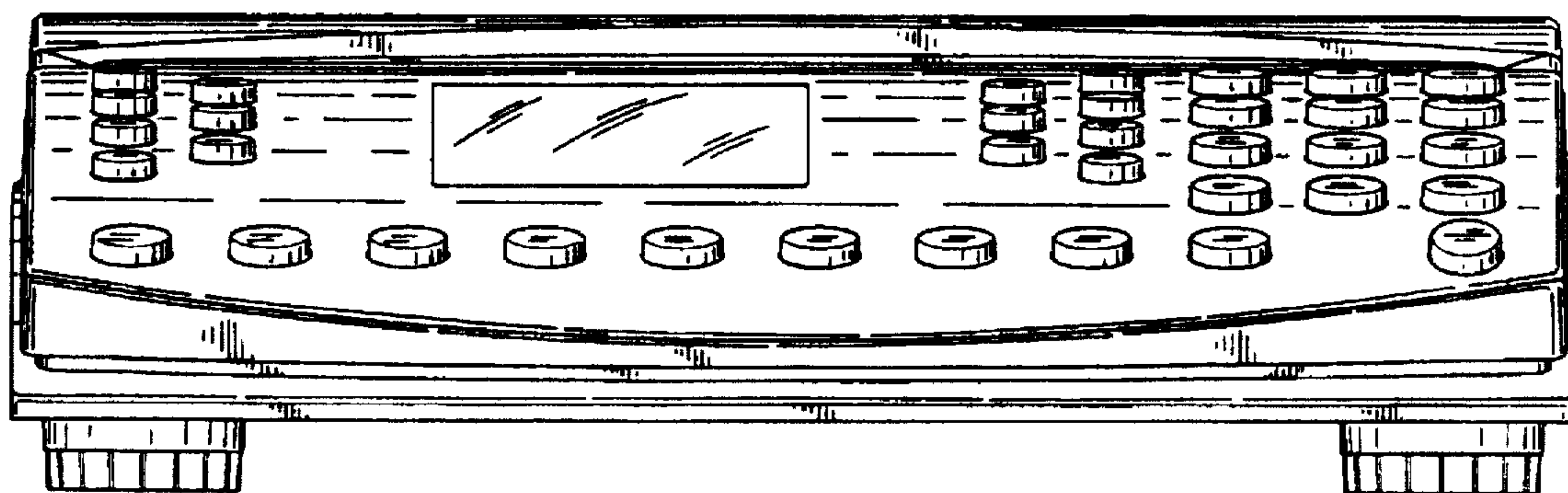
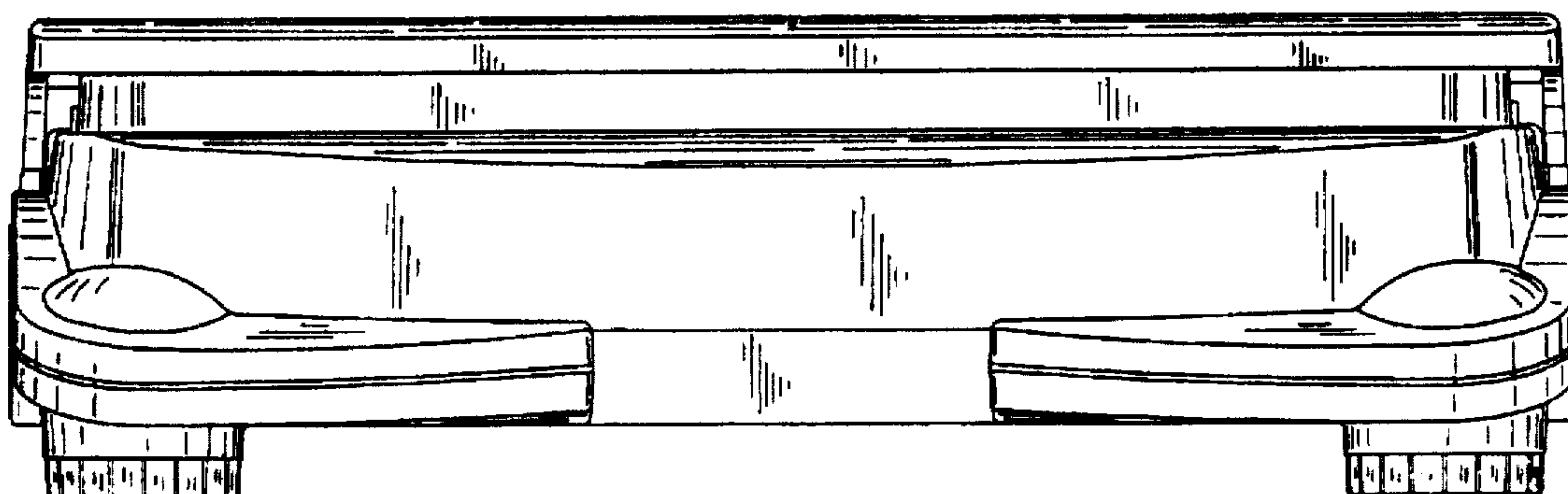

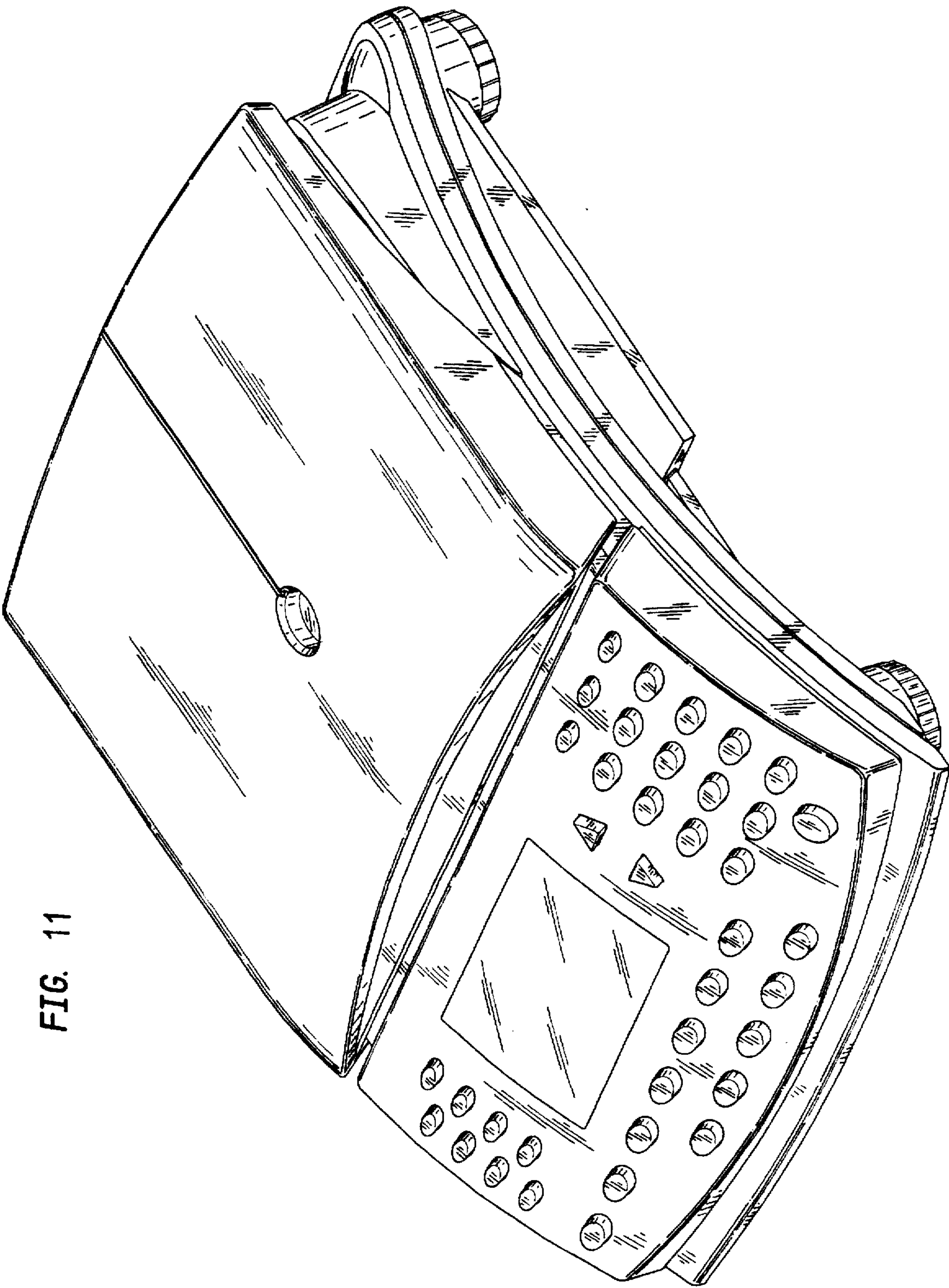

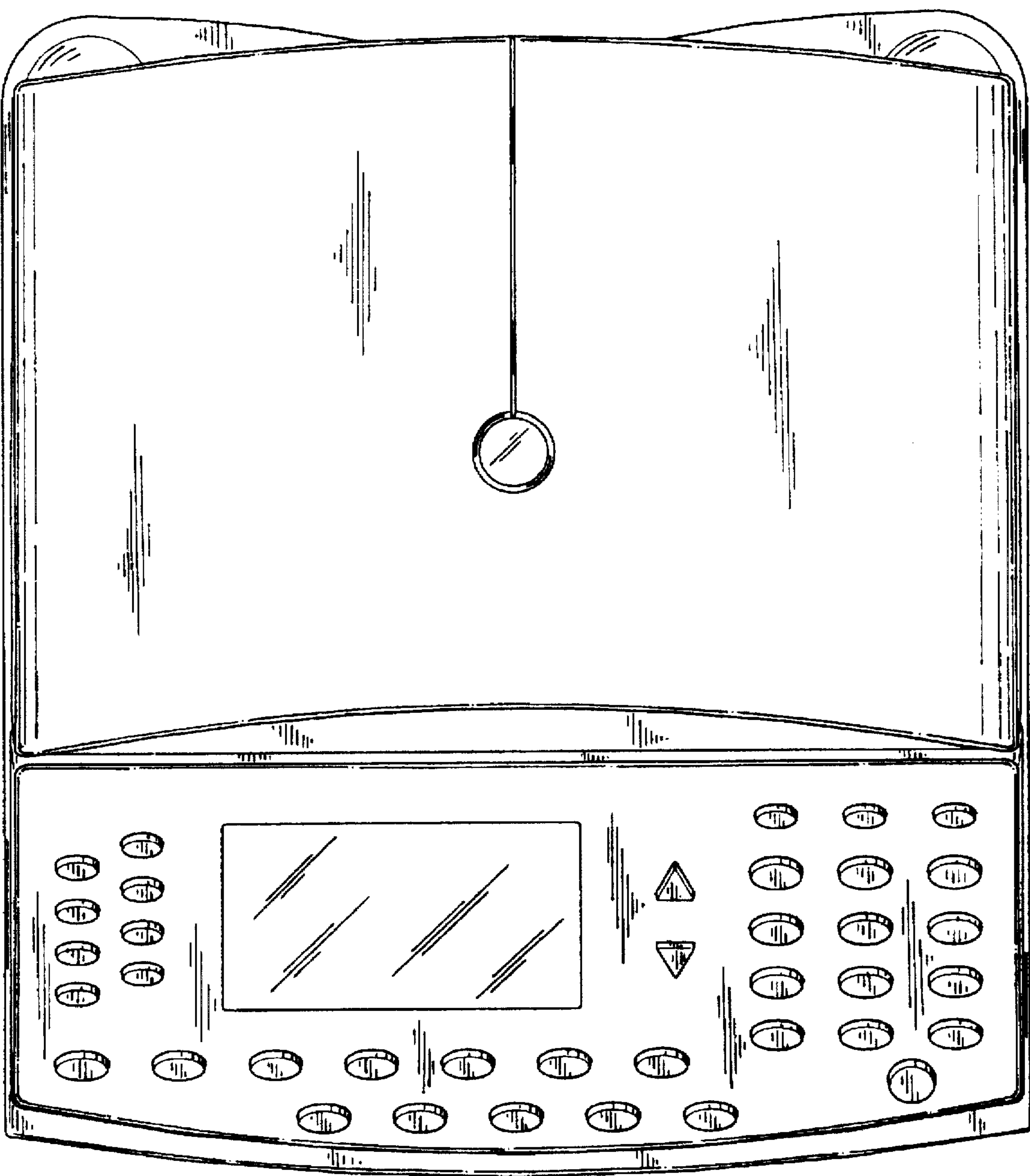

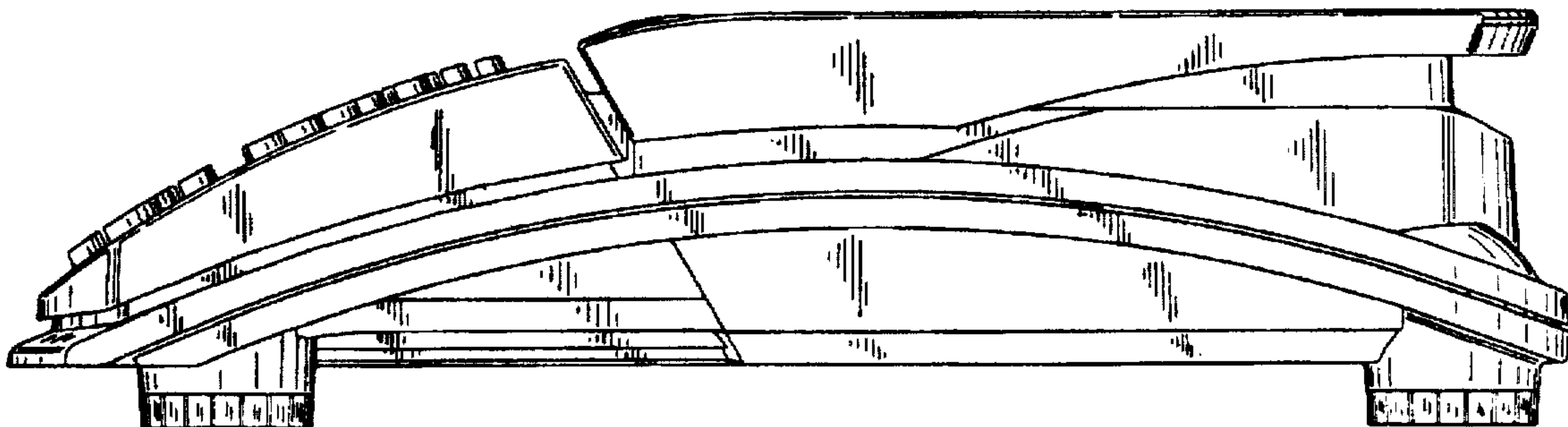
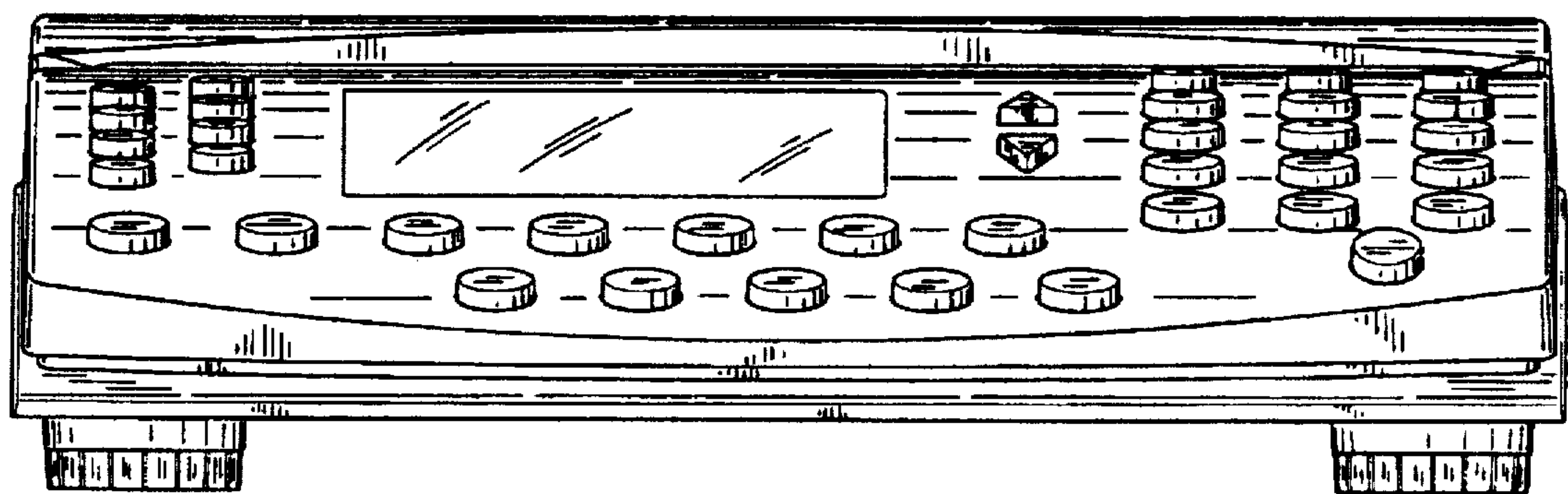
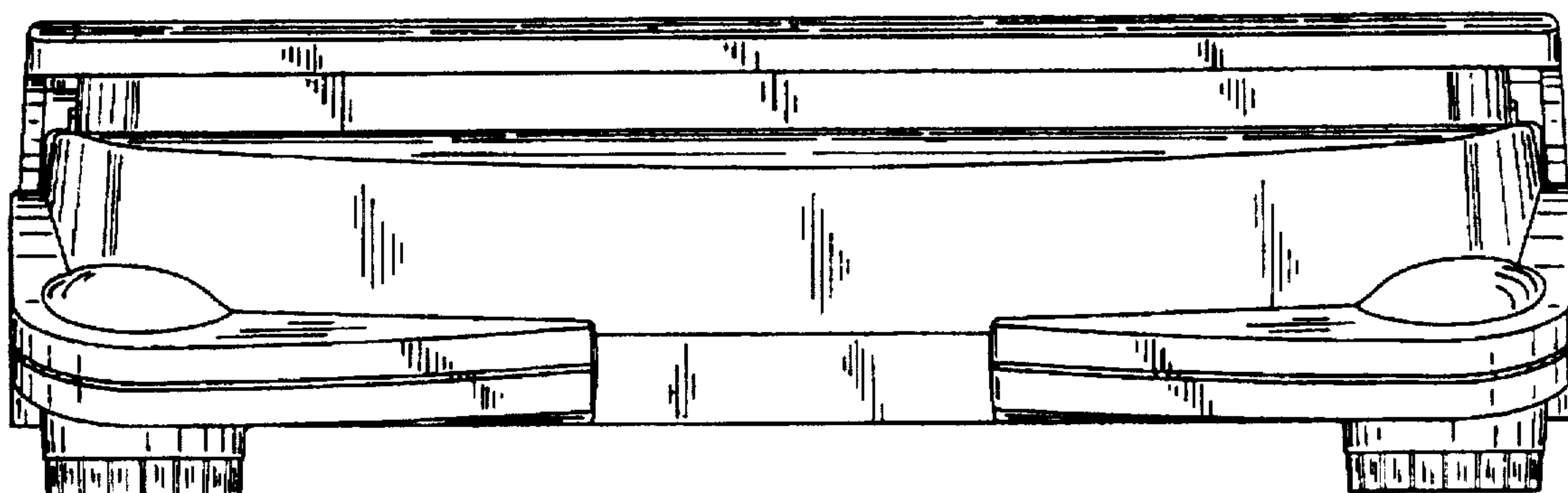

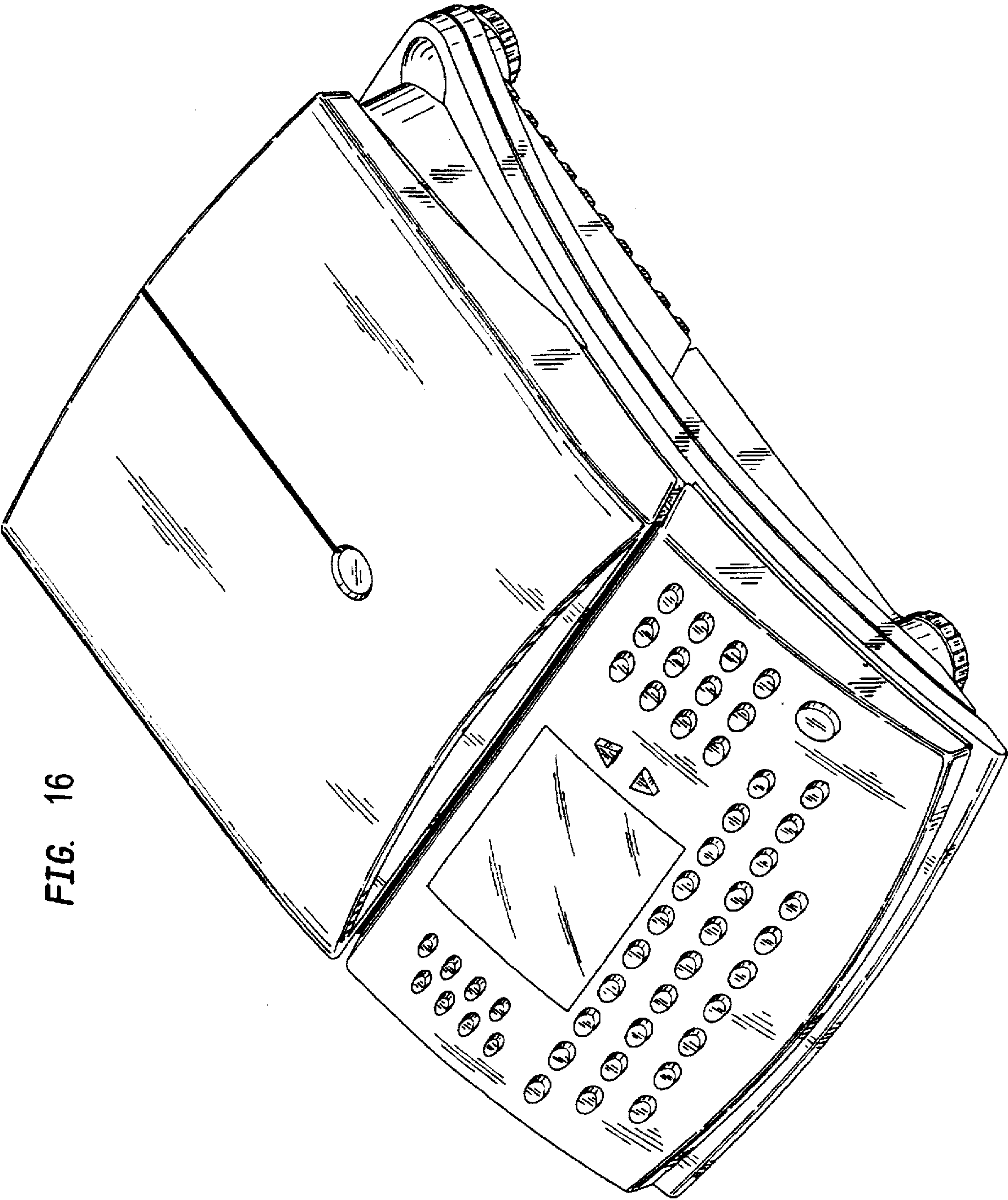

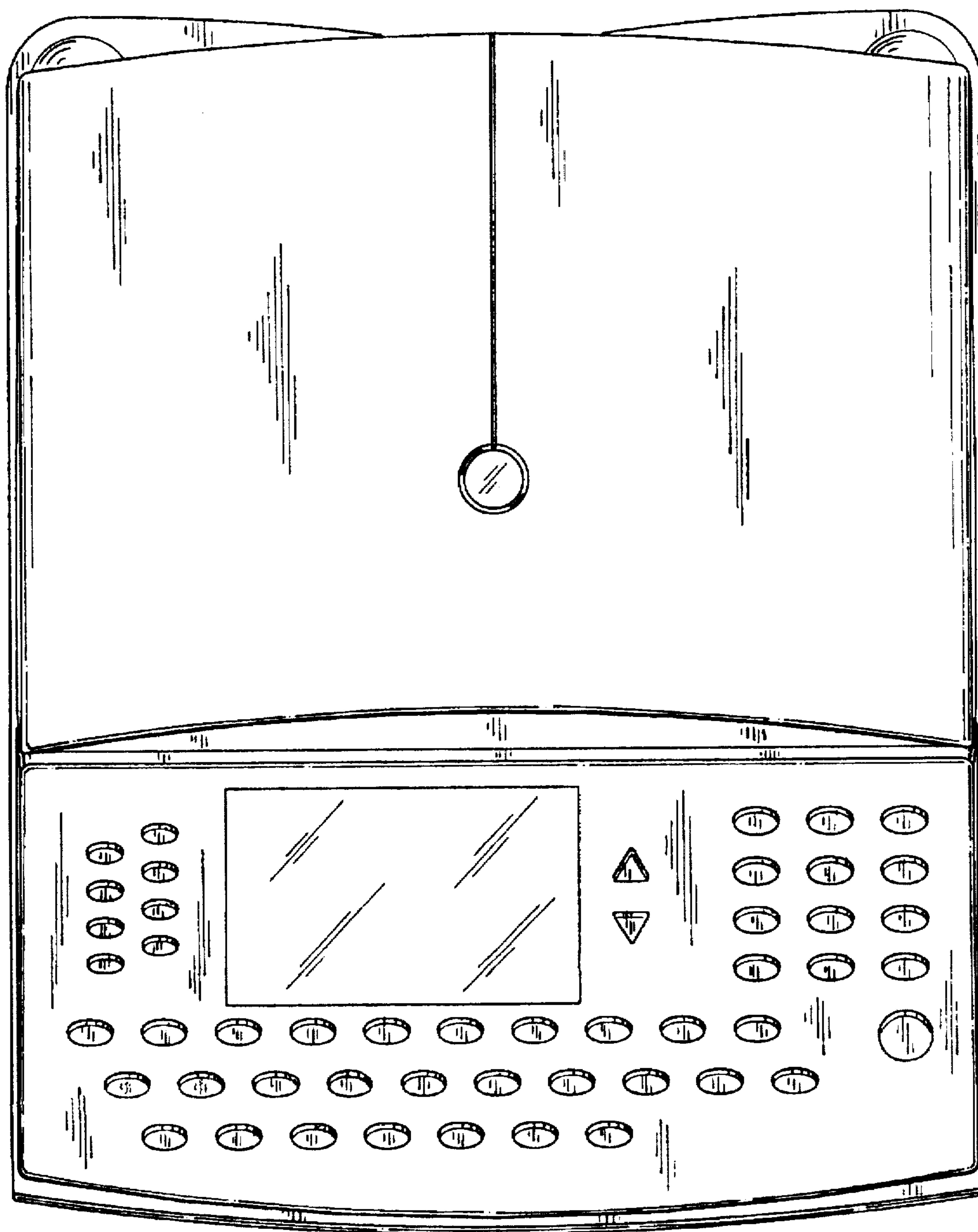
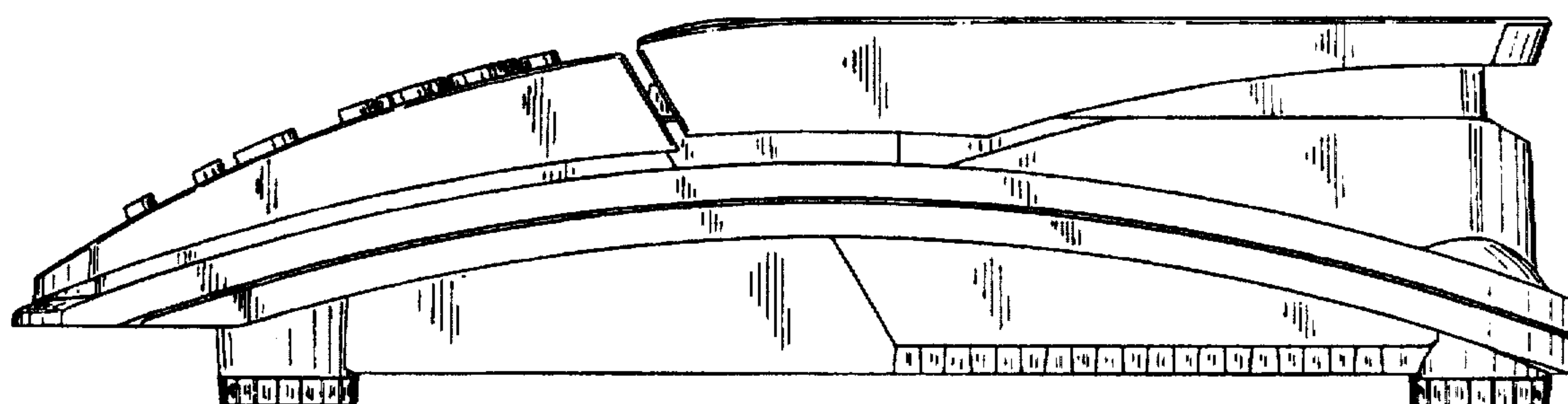

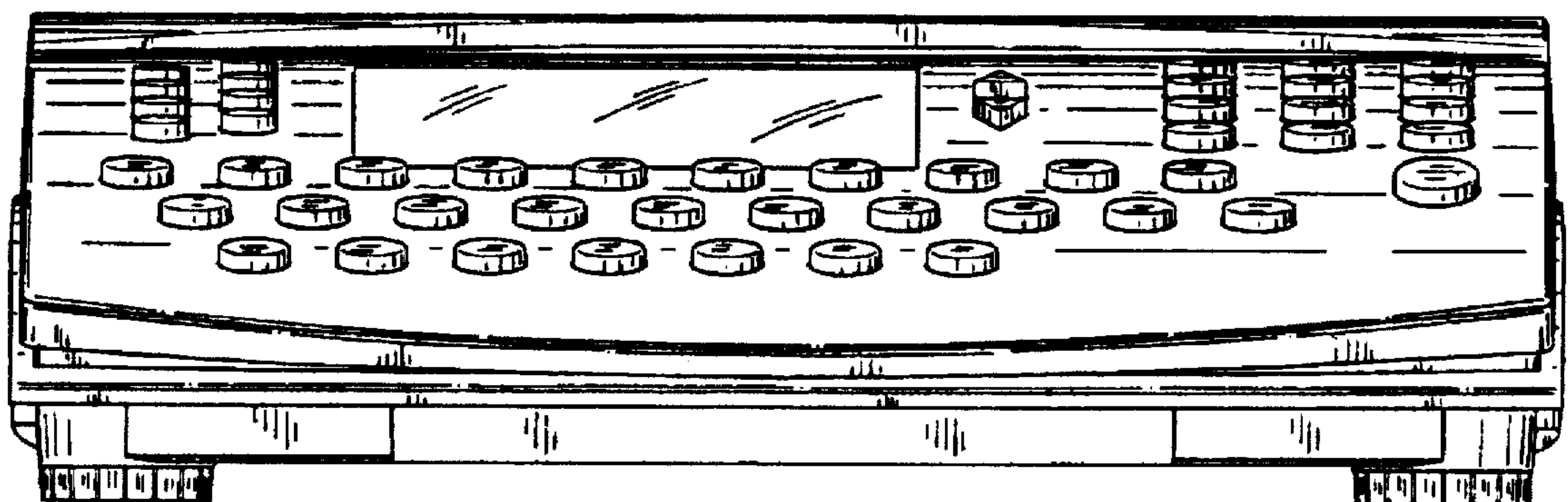
