[57] **CLAIM**

The ornamental design for a cartridge for a stamper, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a cartridge for a stamper;  
FIG. 2 is a front view of the cartridge for a stamper;  
FIG. 3 is a bottom plan view of the cartridge for a stamper;  
FIG. 4 is a left side view of the cartridge for a stamper;  
FIG. 5 is a perspective of the cartridge for a stamper;  
FIG. 6 is a perspective view of the cartridge for a stamper with its cover member removed;  
FIG. 7 is a top plan view of a second embodiment of the cartridge for a stamper;  
FIG. 8 is a front view of the second embodiment of the cartridge for a stamper;  
FIG. 9 is a bottom plan view of the second embodiment of the cartridge for a stamper;  
FIG. 10 is a left side view of the second embodiment of the cartridge for a stamper;  
FIG. 11 is a perspective view of the second embodiment of the cartridge for a stamper; and,  
FIG. 12 is a perspective of the second embodiment of the cartridge for a stamper with its cover member removed.

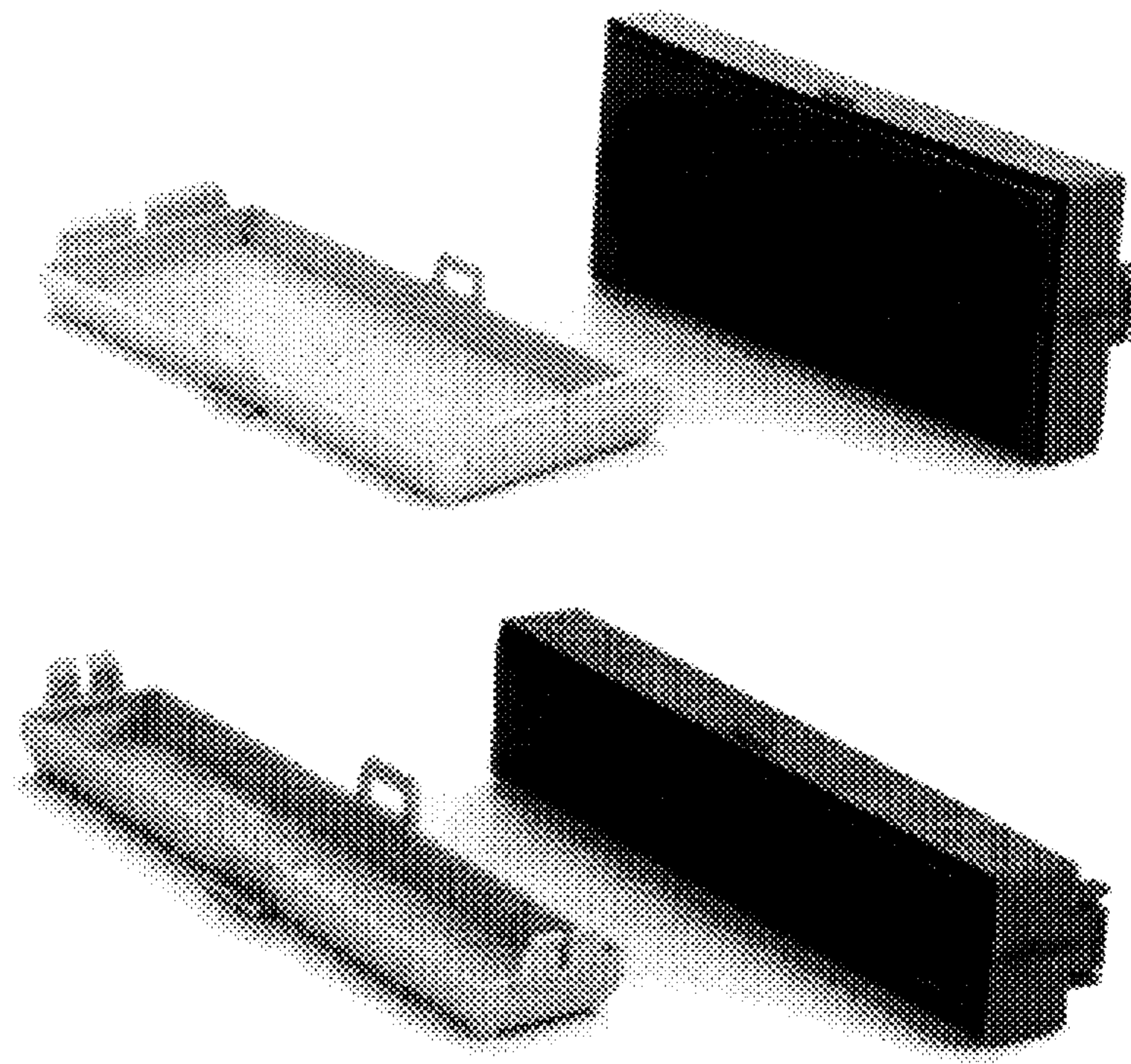

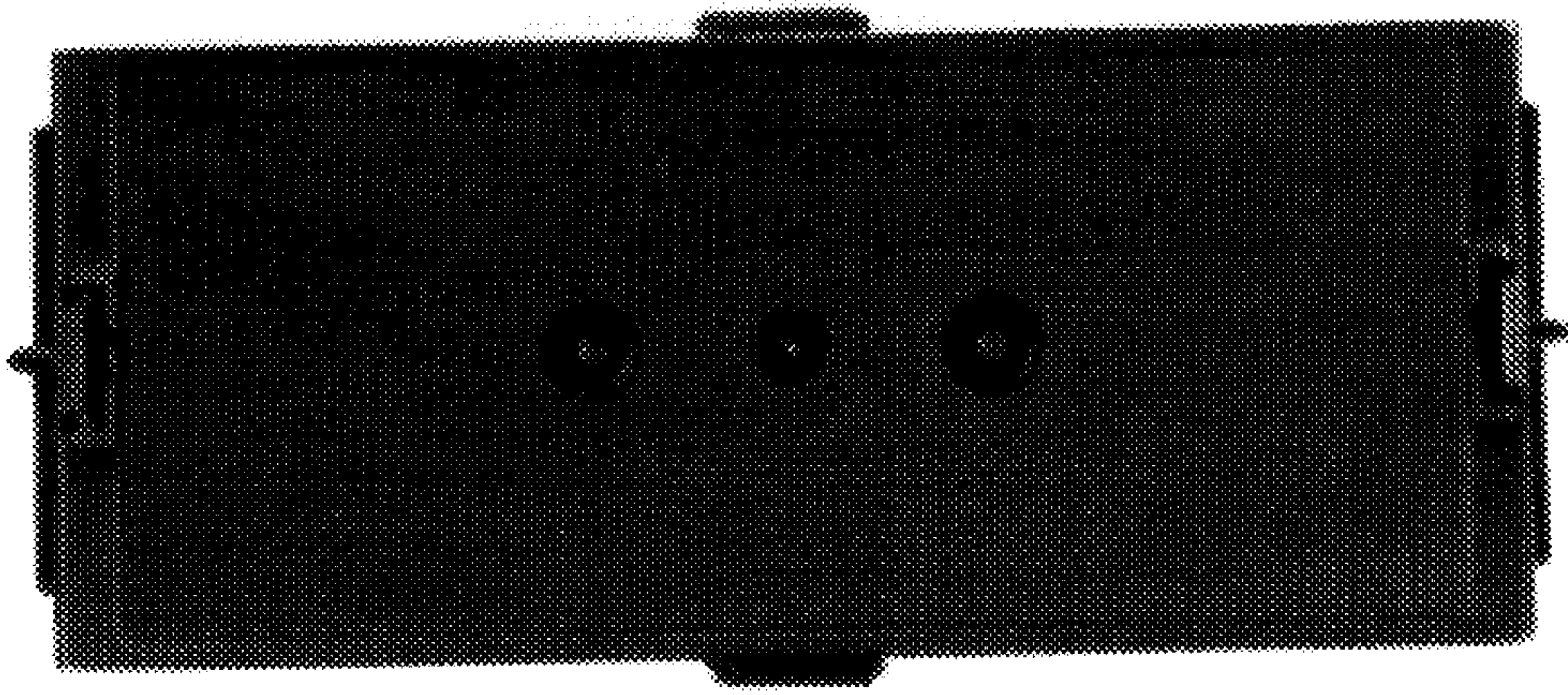

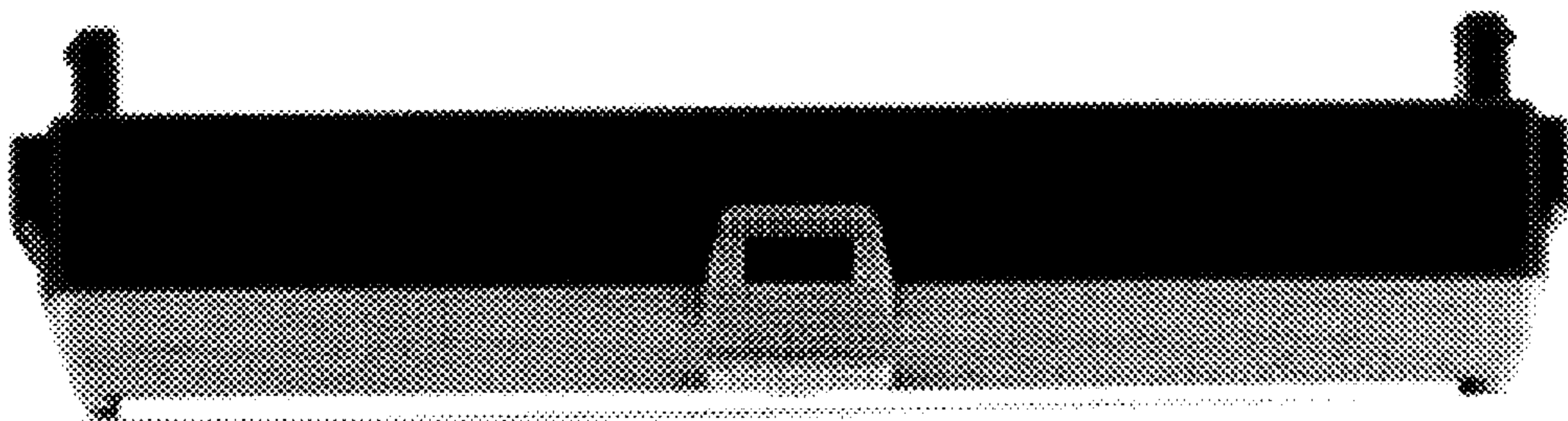

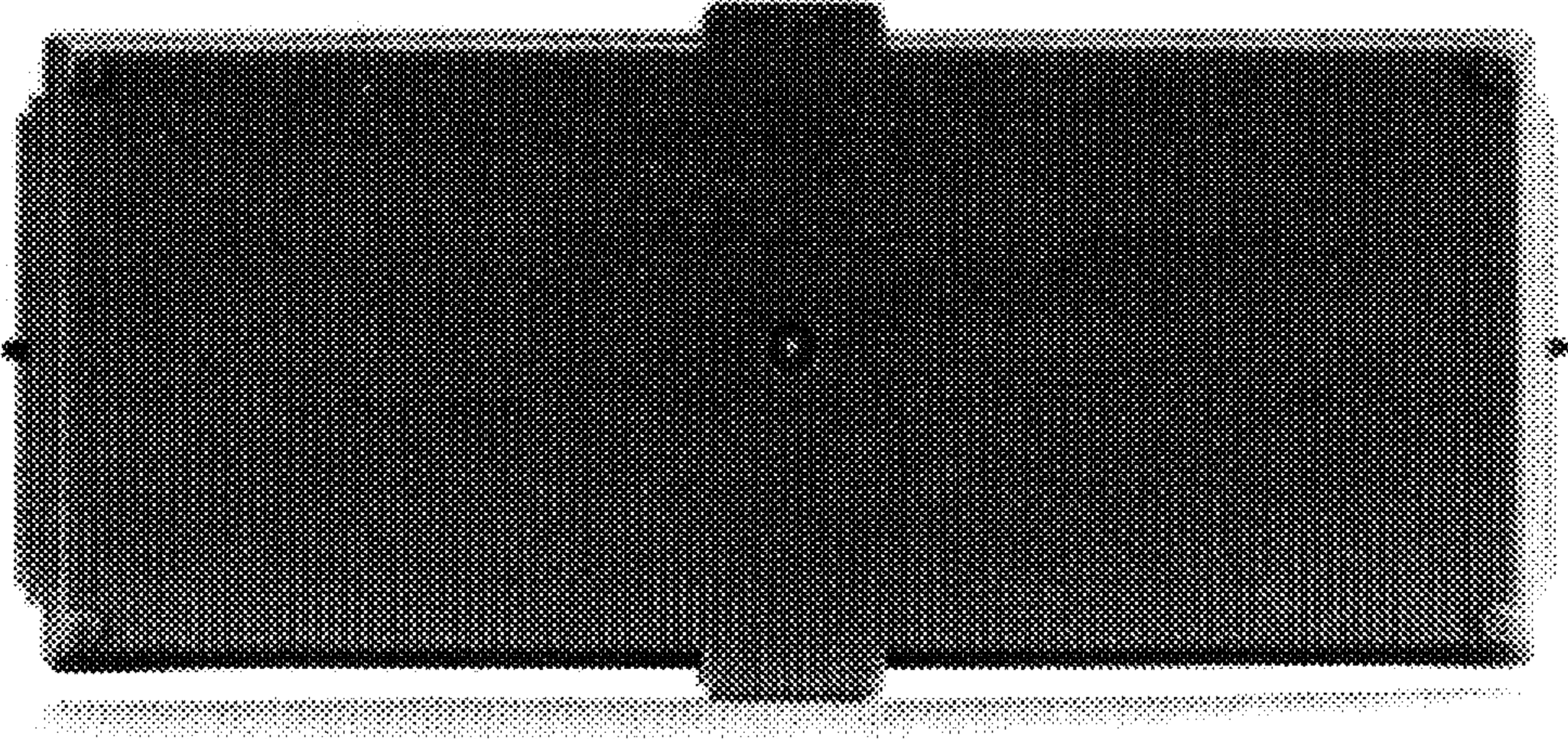

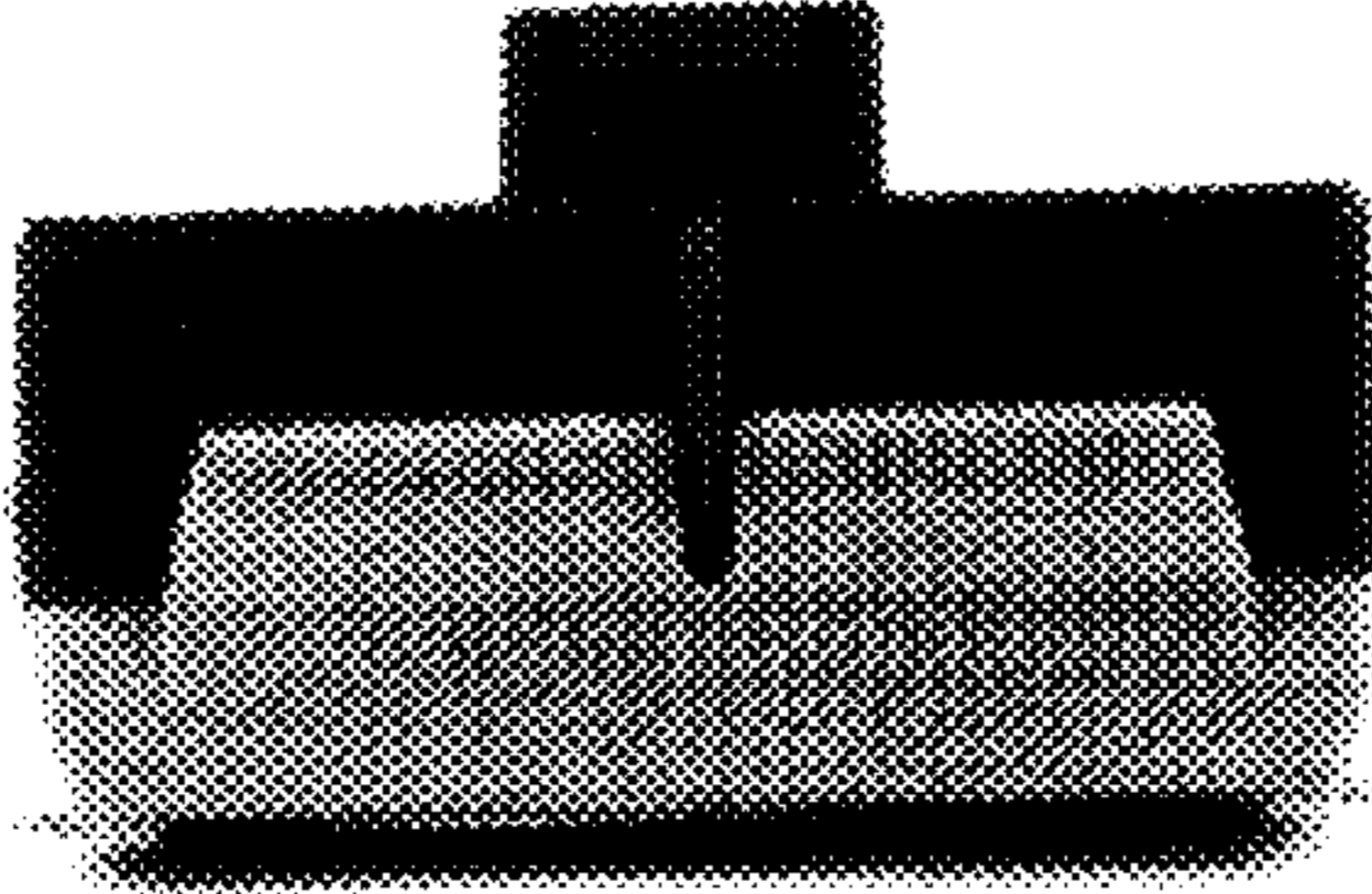

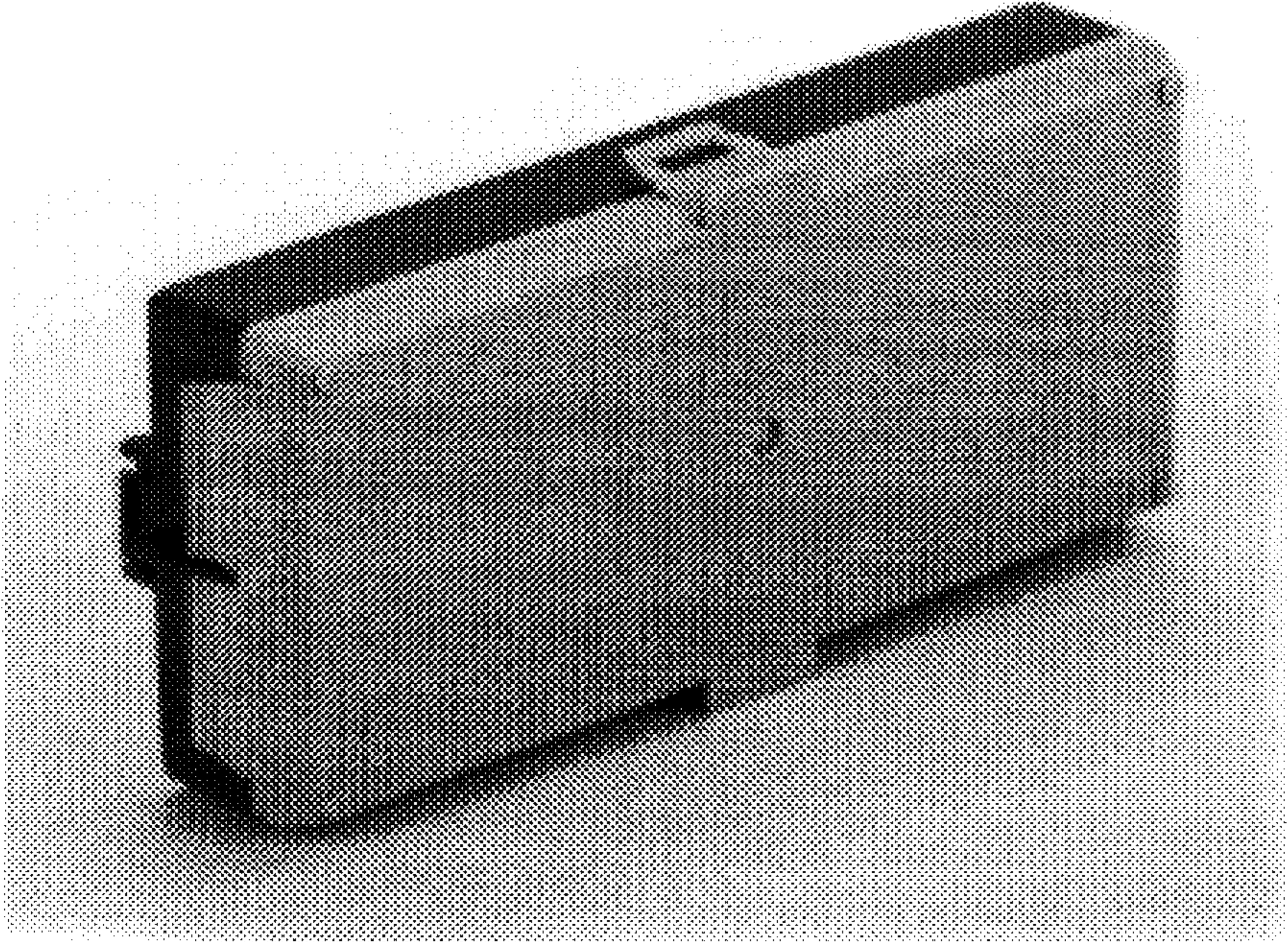

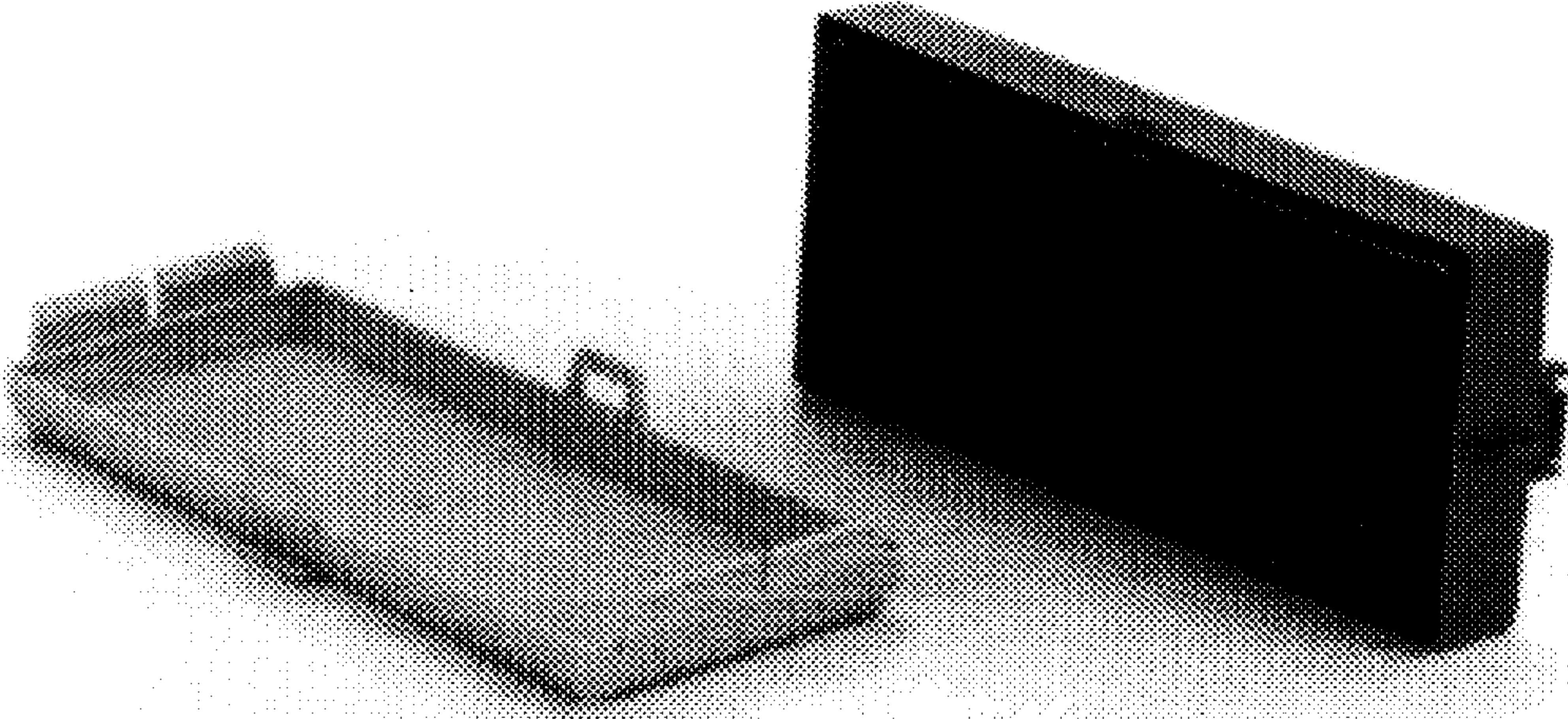

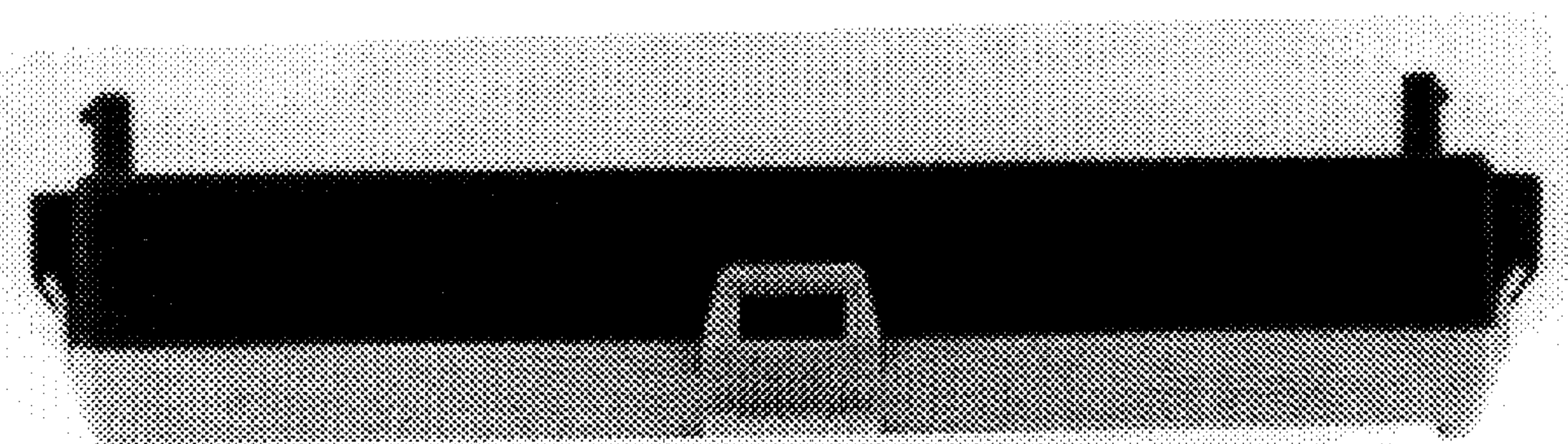

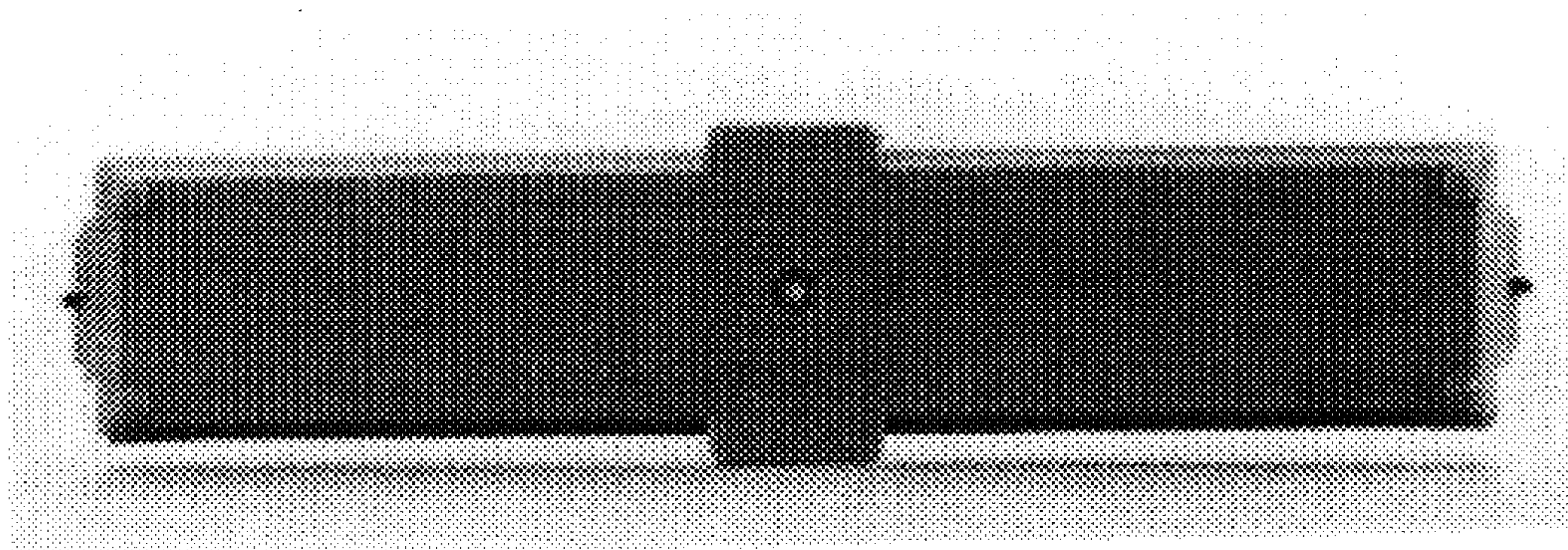

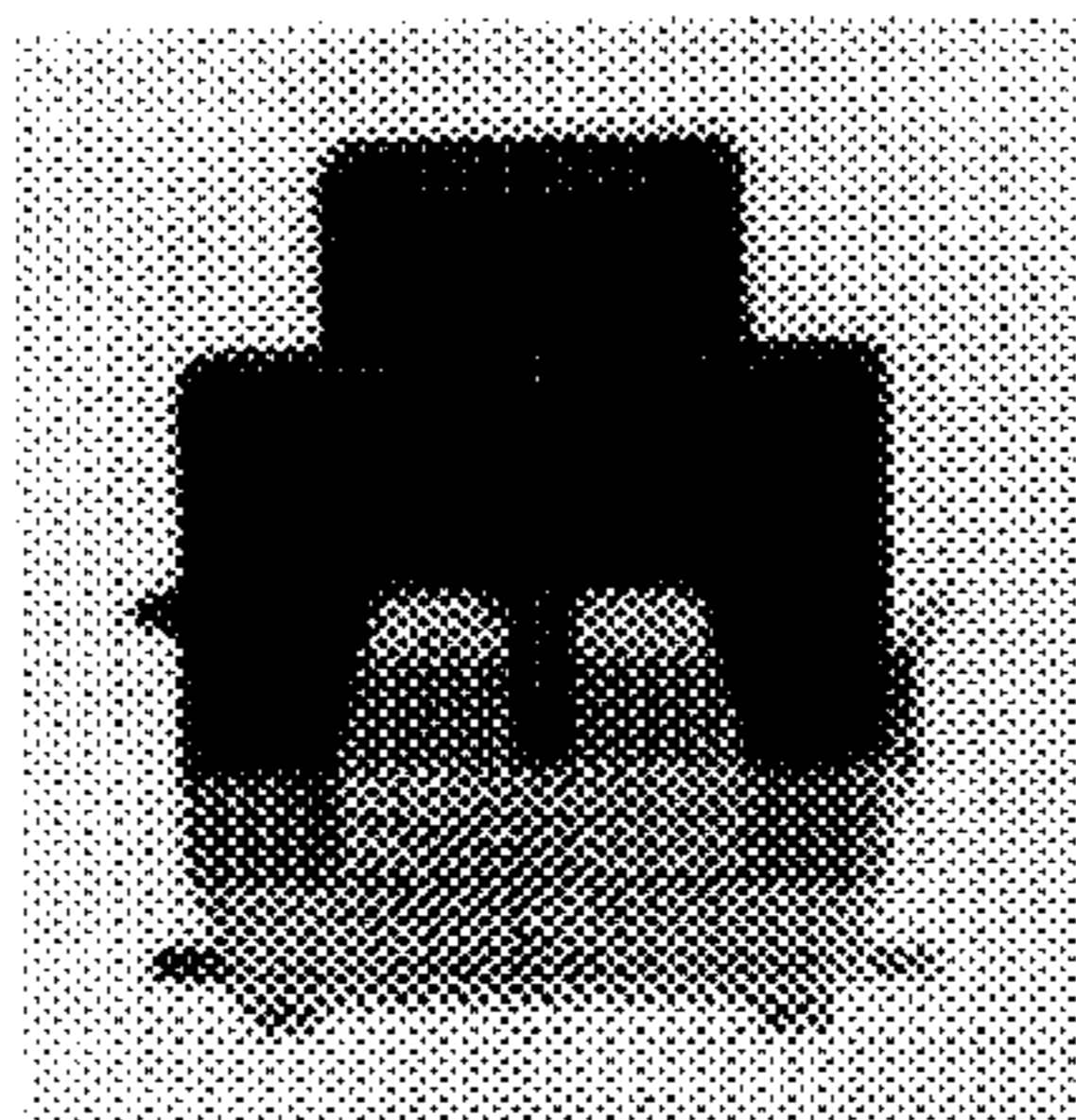

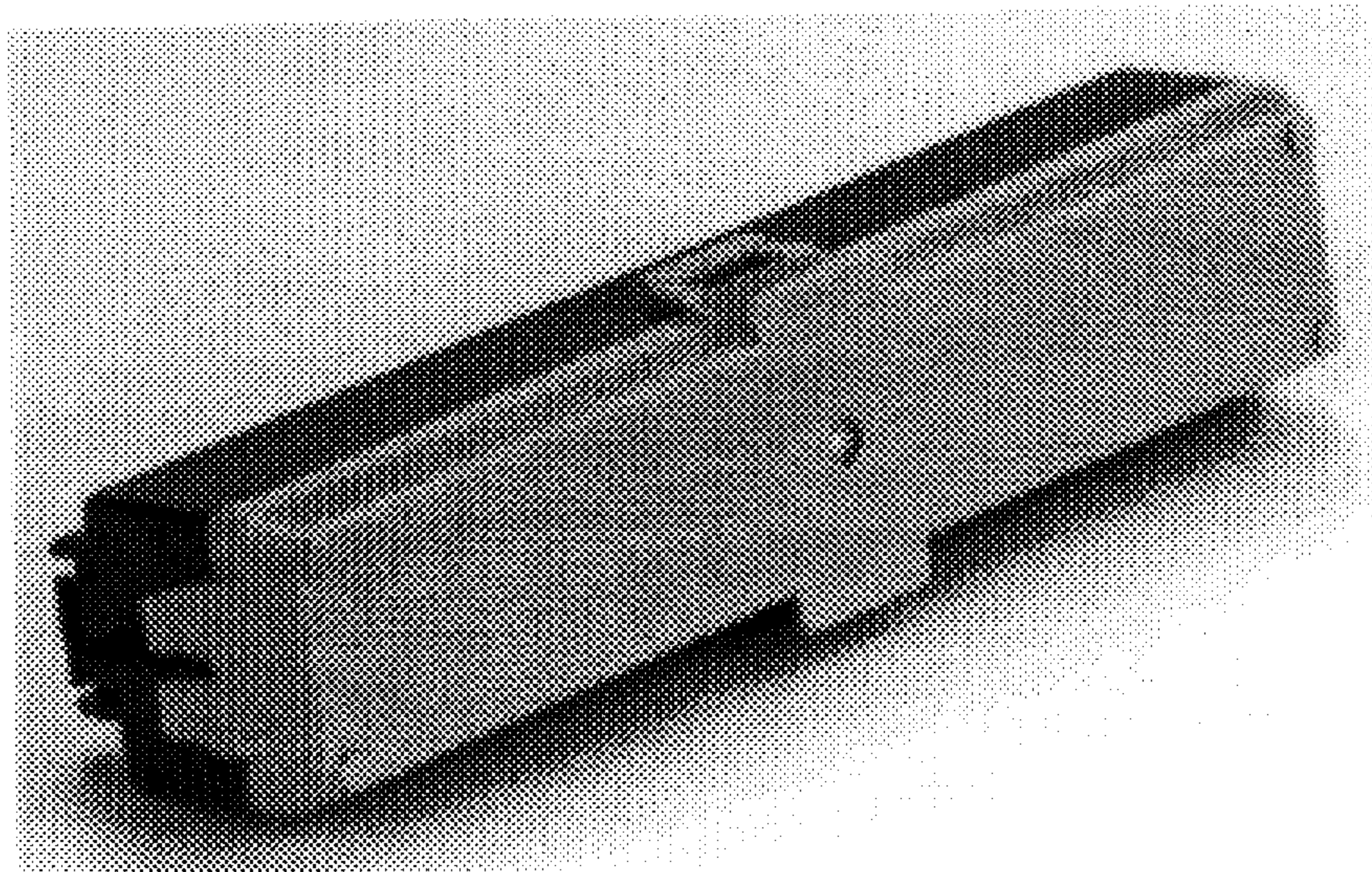
