The ornamental design for a combined toothbrush handle with window and toothpaste dispenser, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a combined toothbrush handle with a window and a toothpaste dispenser showing my new design;

FIG. 4 is a right side view thereof;

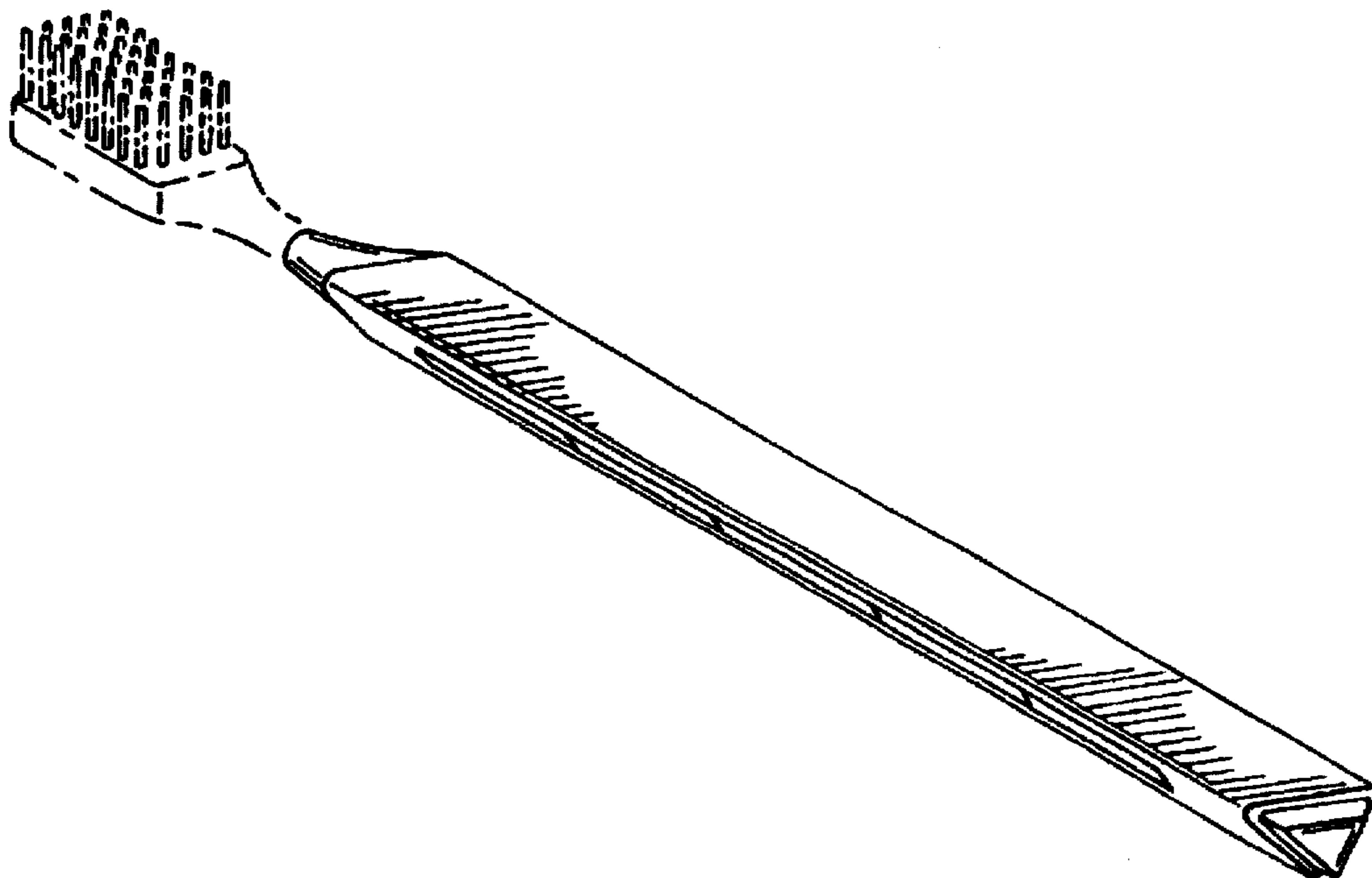
FIG. 5 is a bottom view thereof;

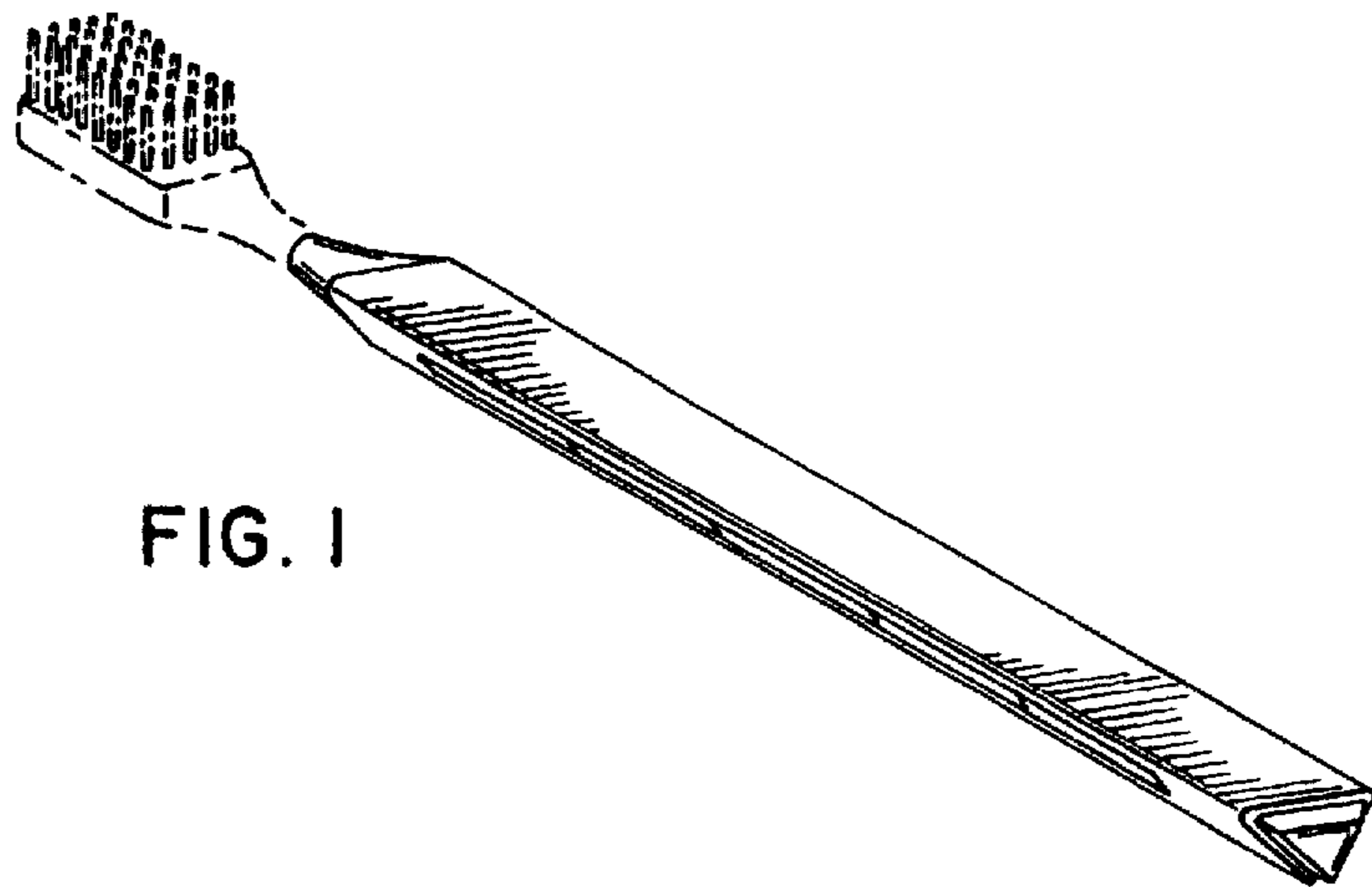

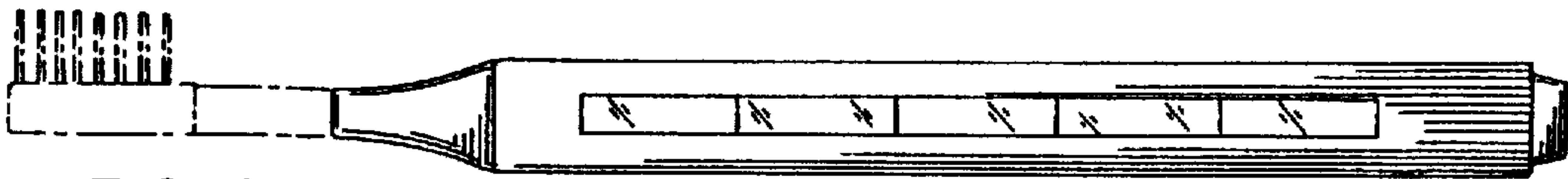

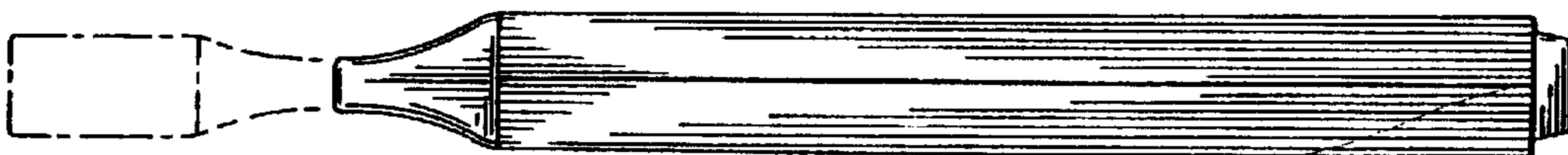
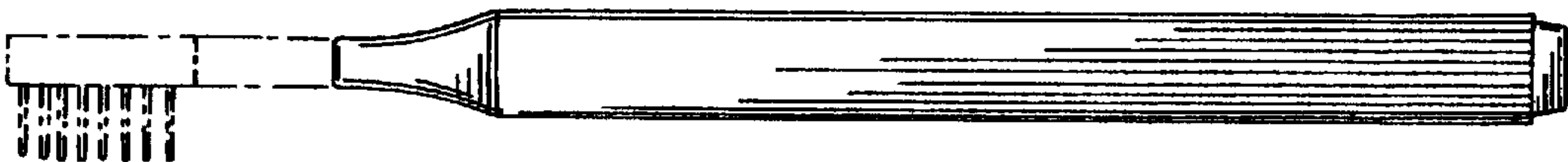

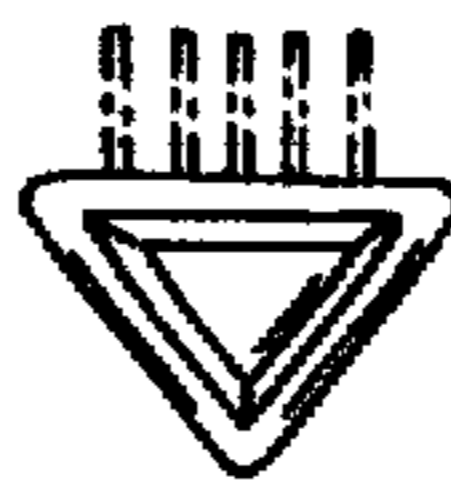
