The ornamental design for a seat, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a seat in the form of a three-cushioned sofa;
FIG. 2 is a side elevational view thereof, the opposite side elevational view being a mirror image;
FIG. 3 is a top view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a front elevational view of a seat in the form of a two-cushioned sofa;
FIG. 6 is a side elevational view of the sofa shown in FIG. 5, the opposite side elevational view being a mirror image;
FIG. 7 is a top view of the sofa shown in FIG. 5;
FIG. 8 is a rear elevational view of the sofa shown in FIG. 5;
FIG. 9 is a front elevational view of a seat in the form of a love seat;
FIG. 10 is a side elevational view of the love seat shown in FIG. 9, the opposite side elevational view being a mirror image;
FIG. 11 is a top view of the love seat shown in FIG. 9; and
FIG. 12 is a rear elevational view of the love seat shown in FIG. 9.

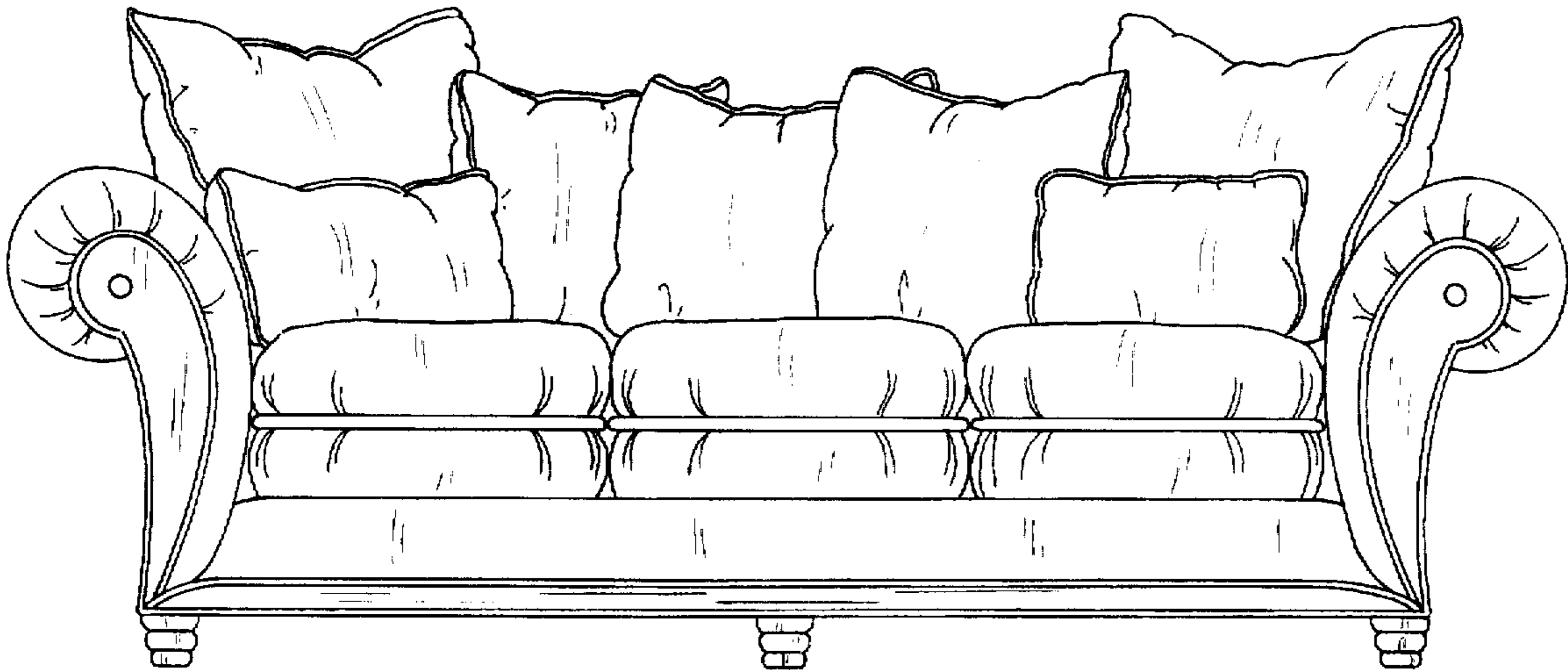

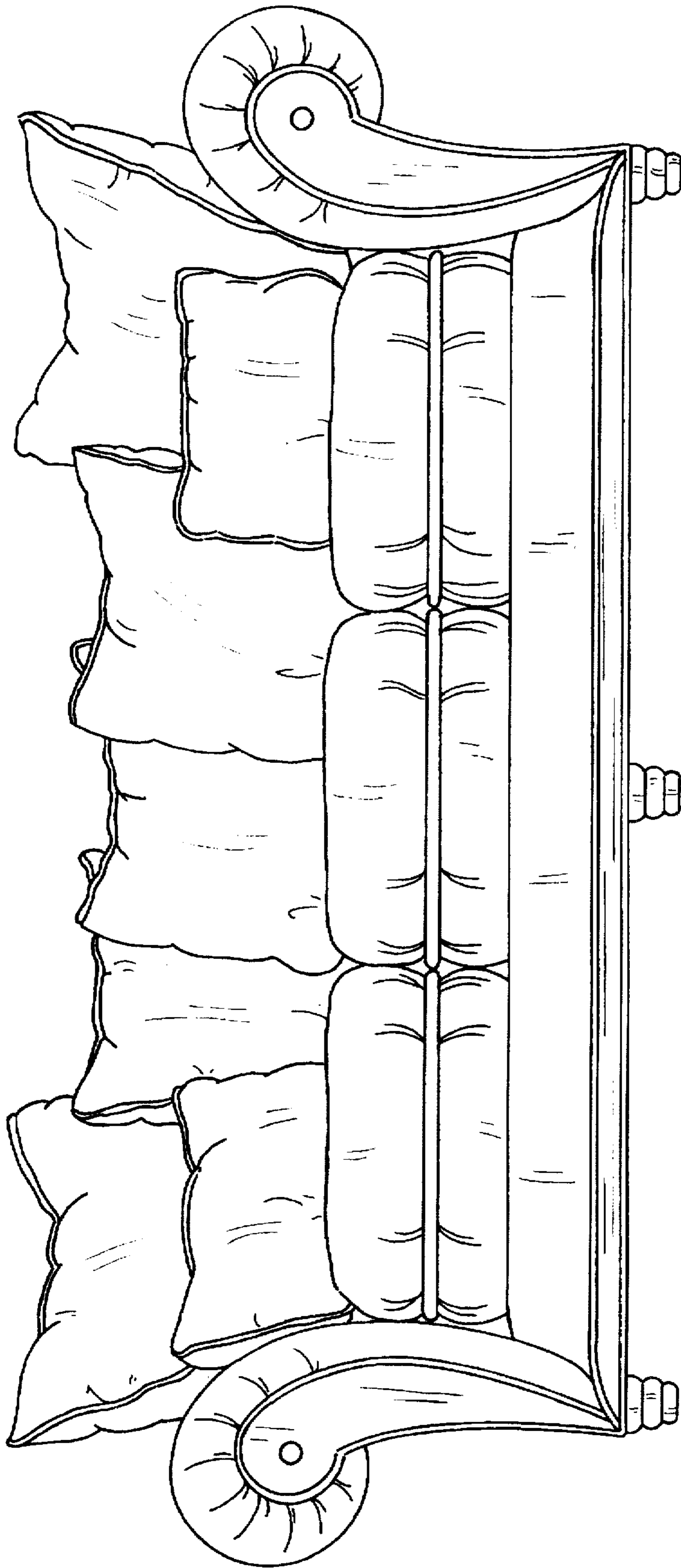

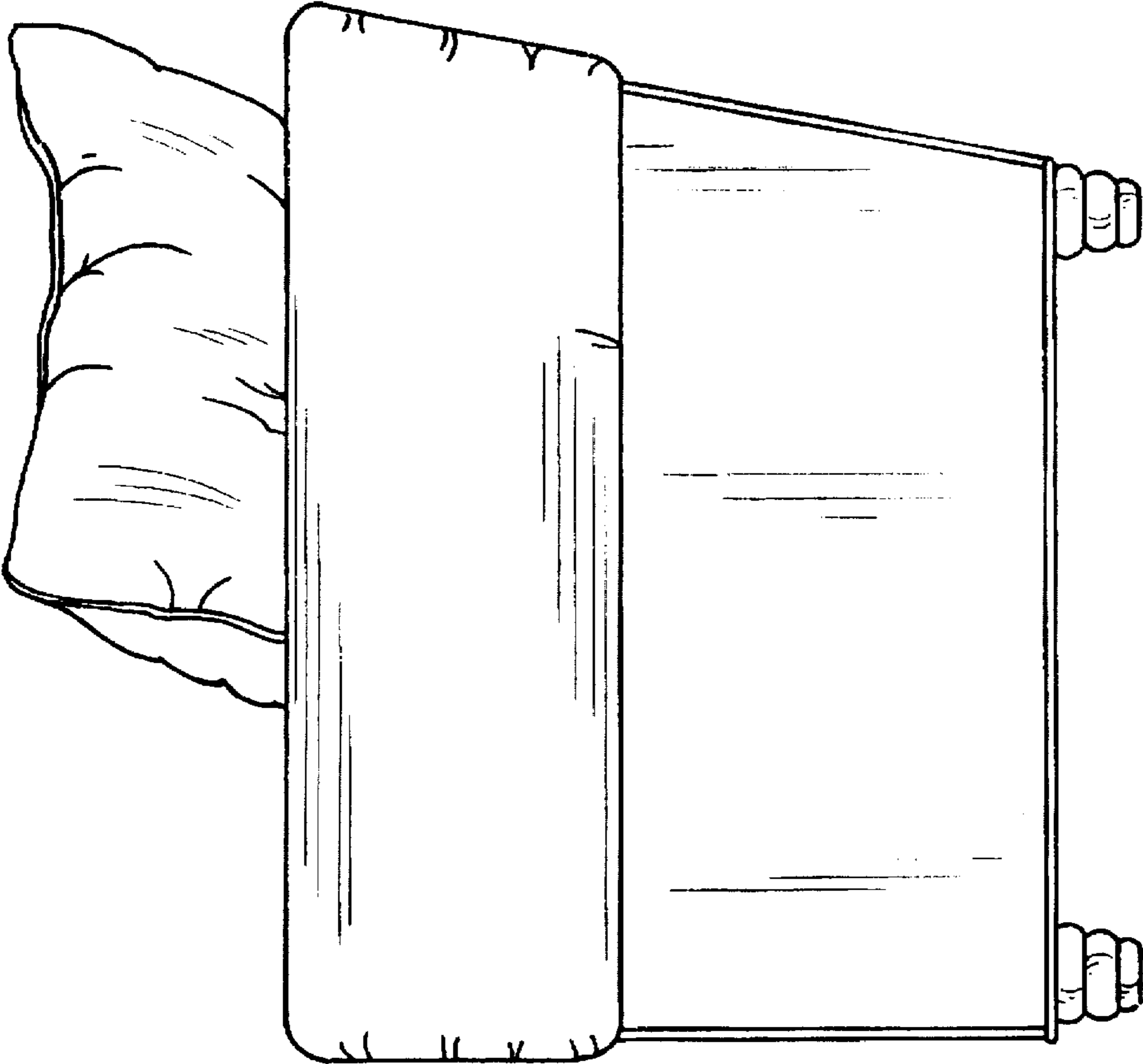

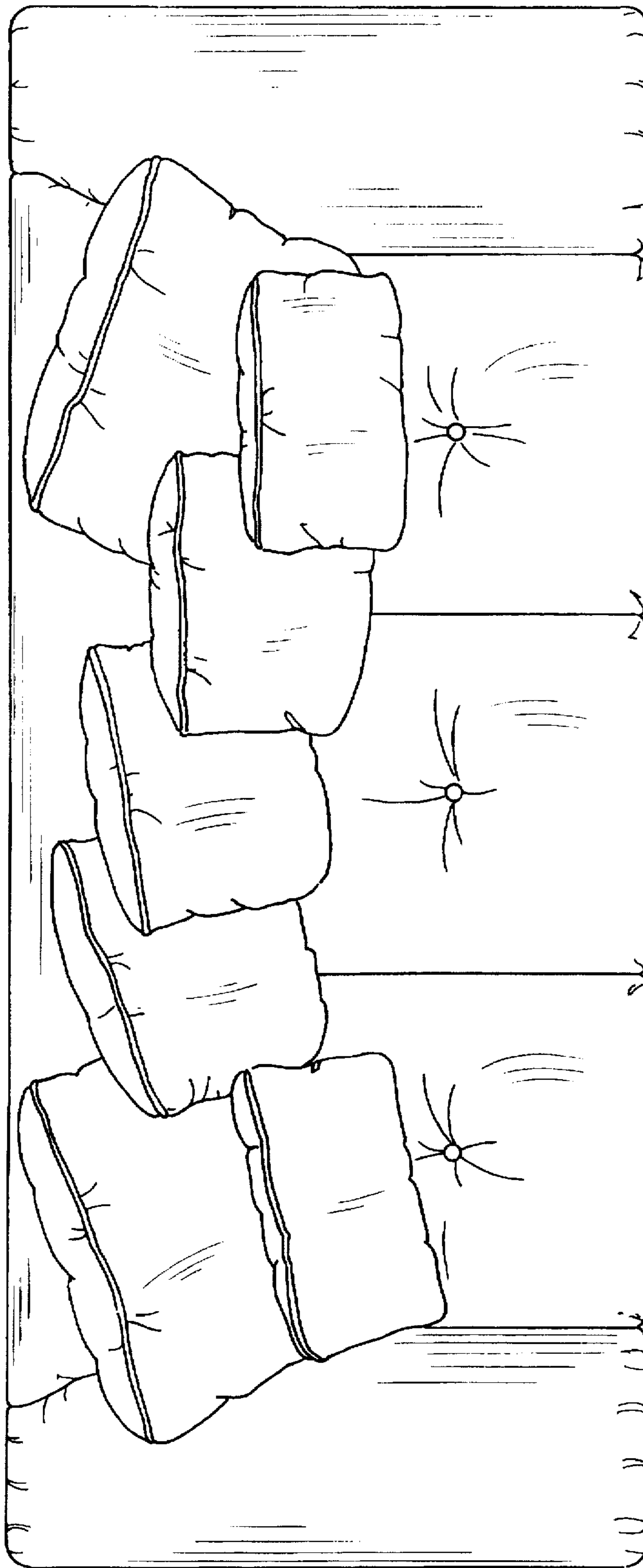

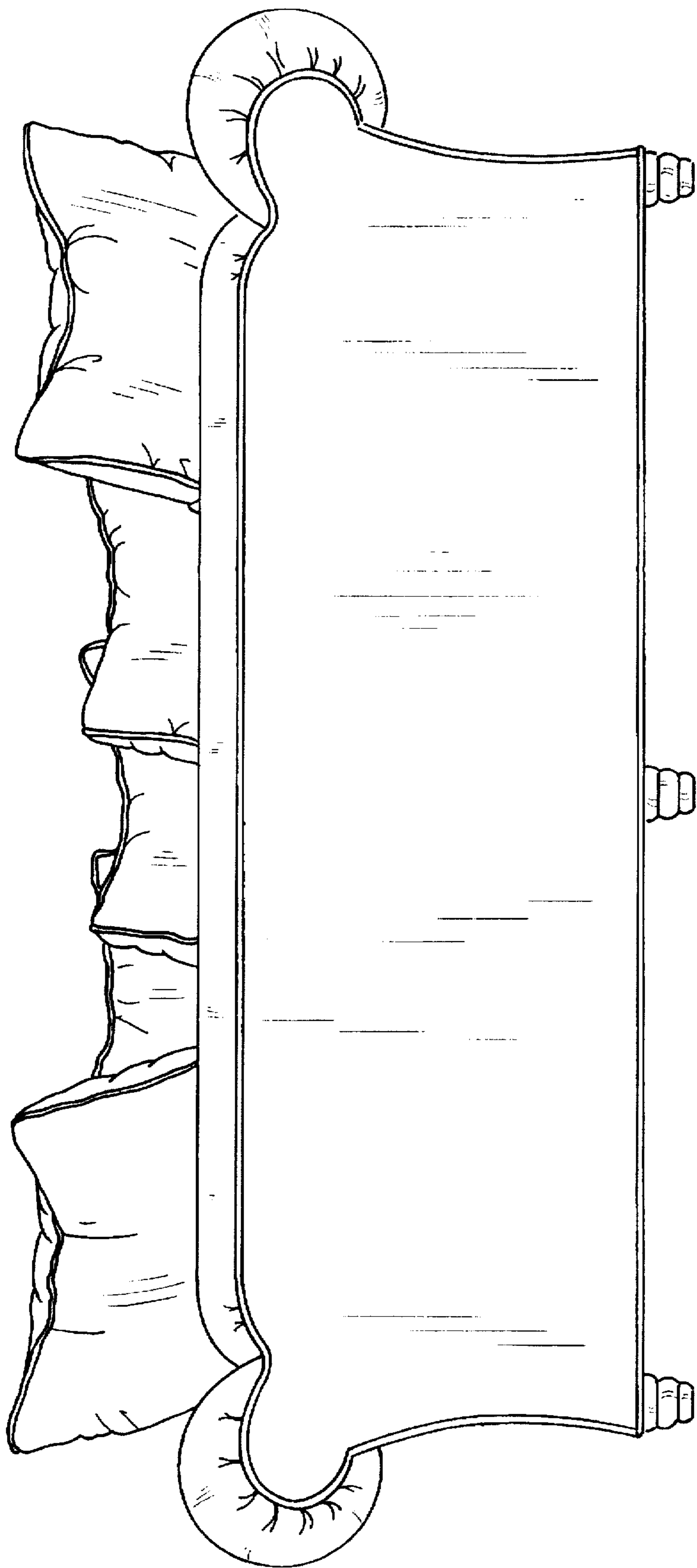

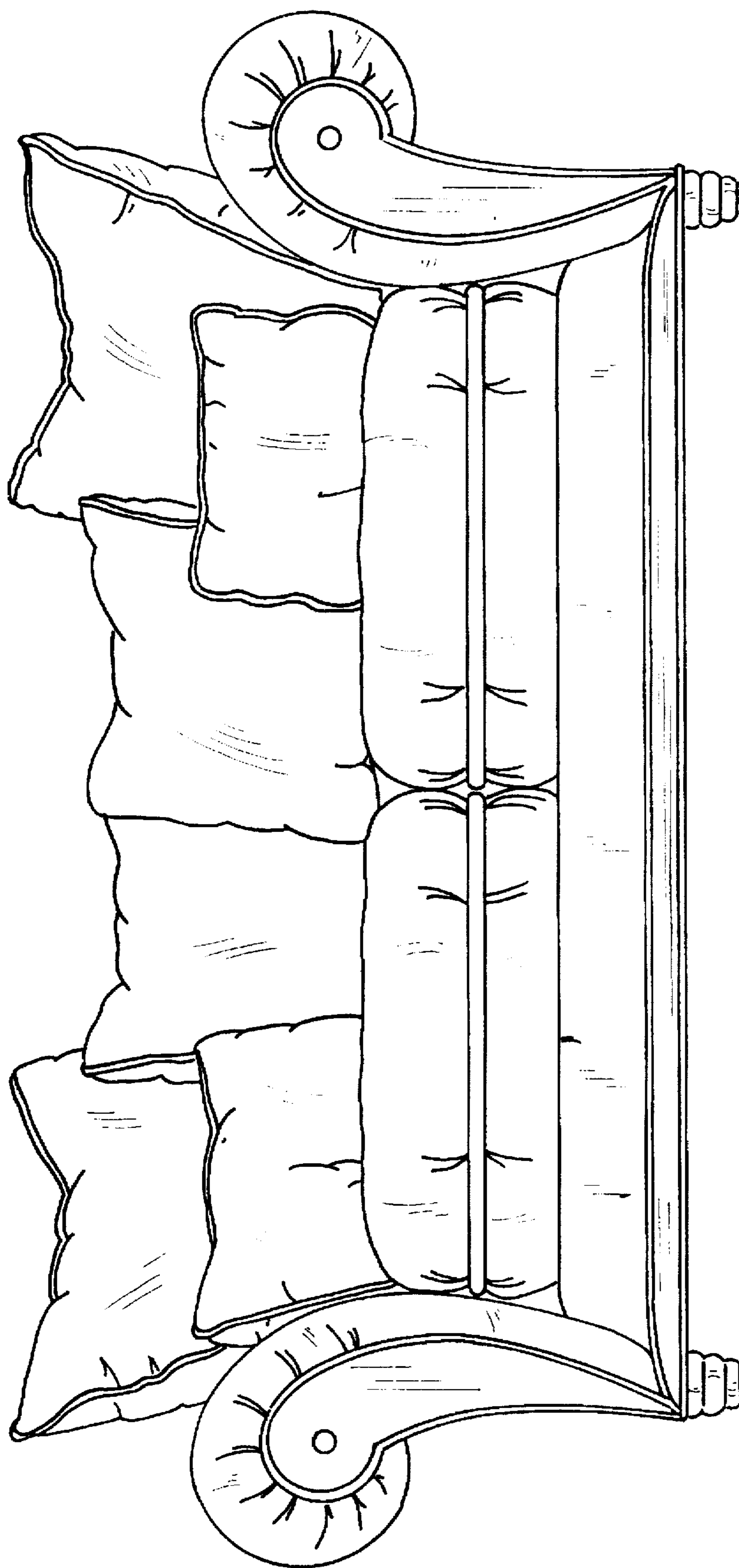

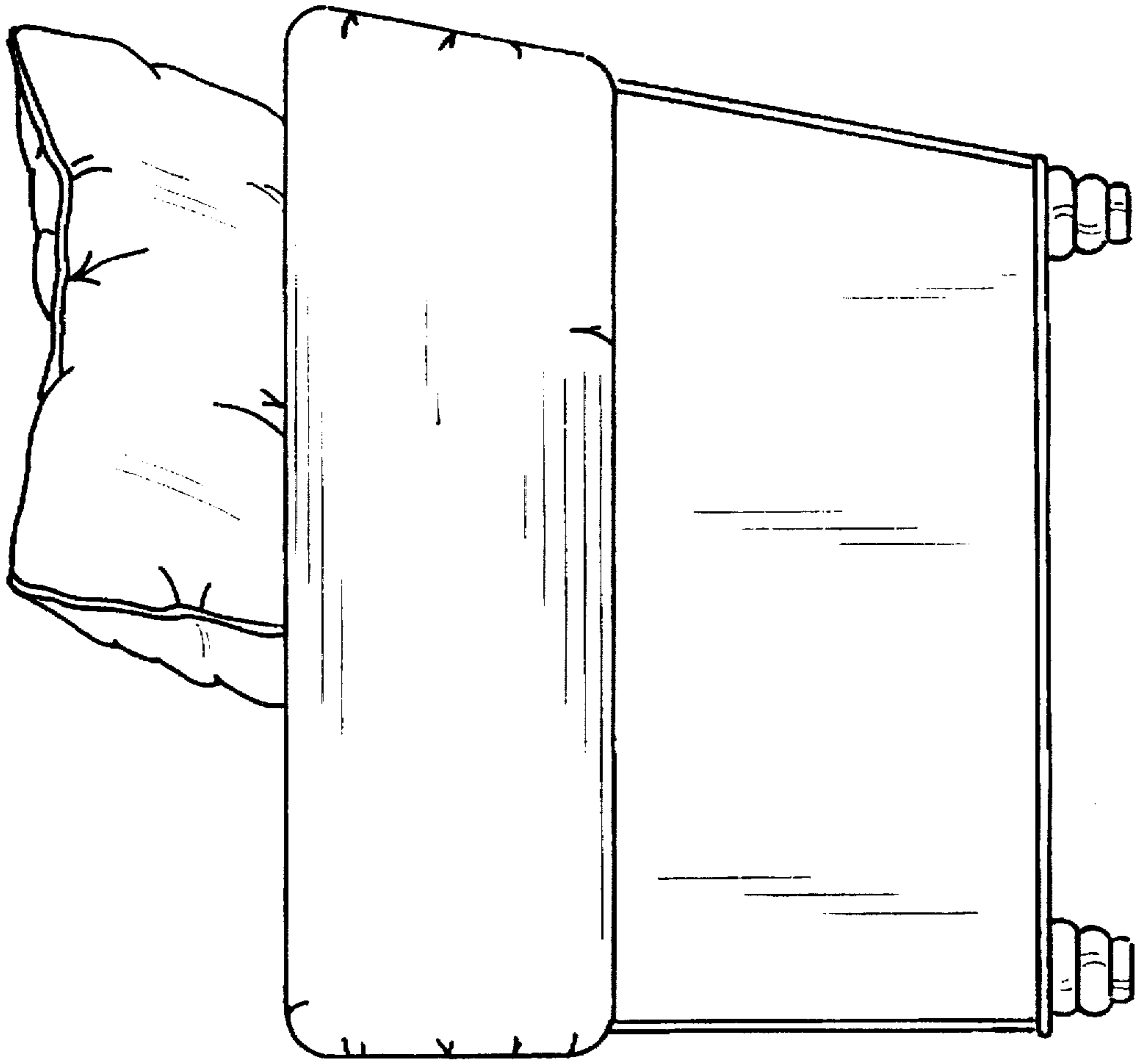

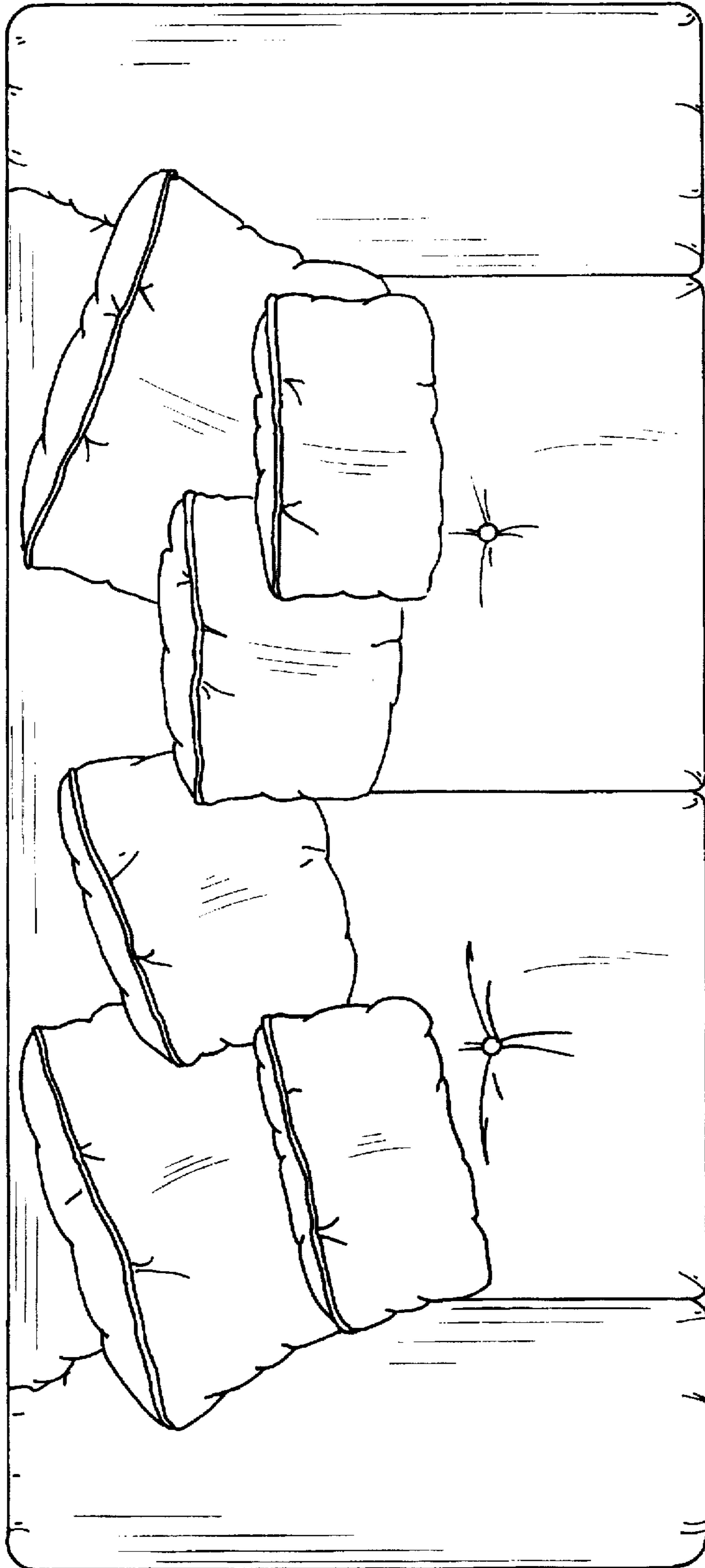

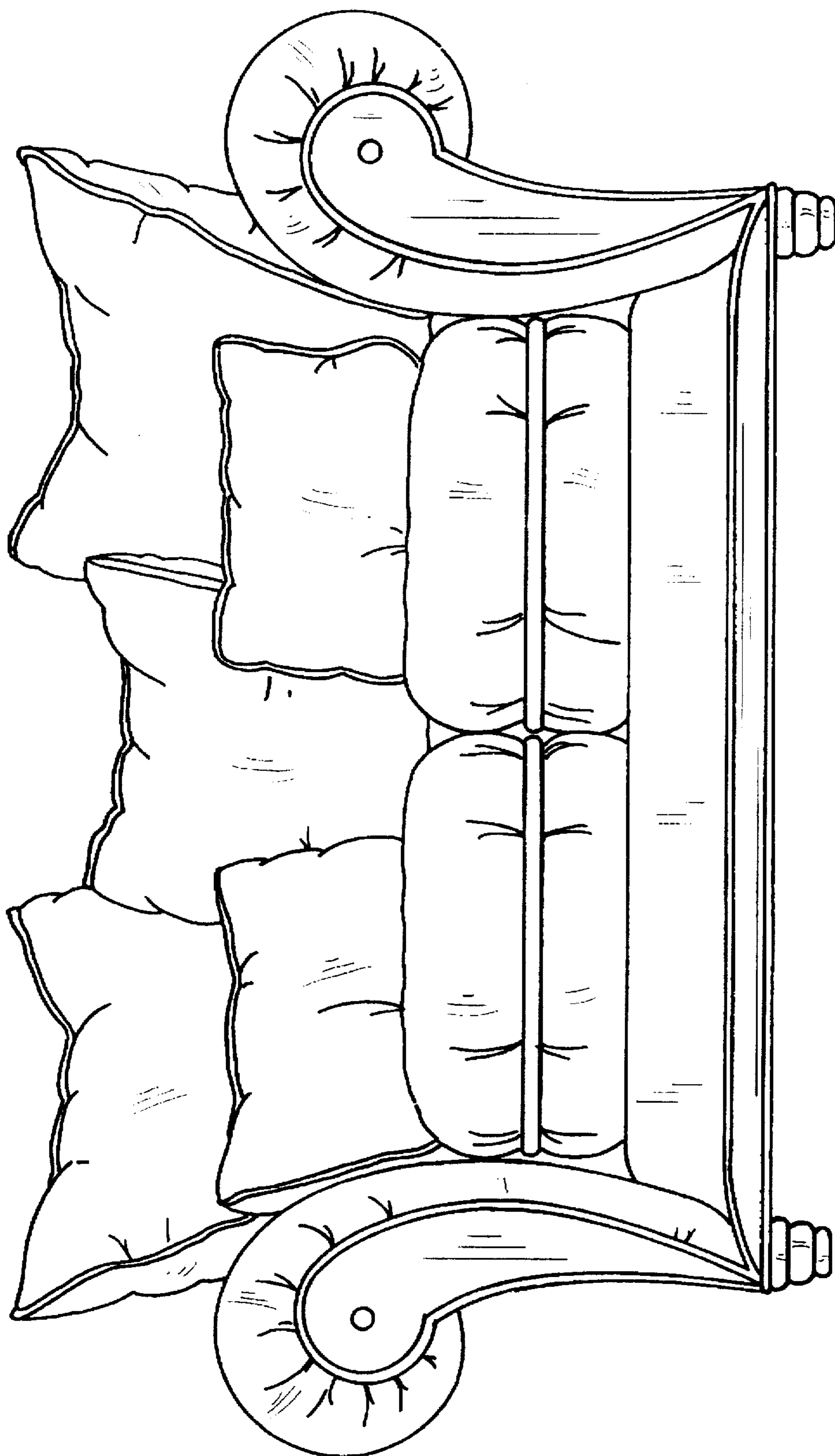

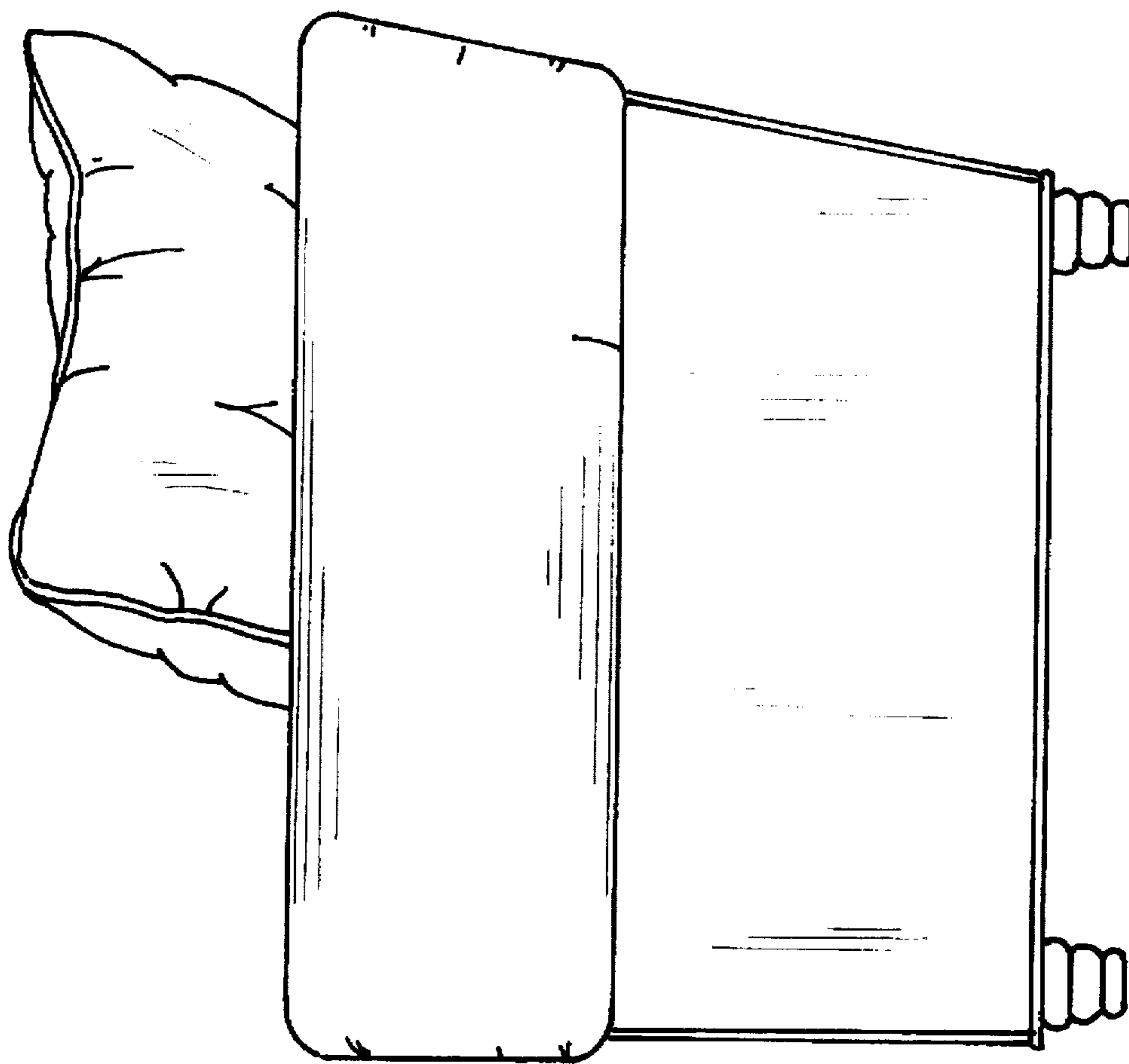

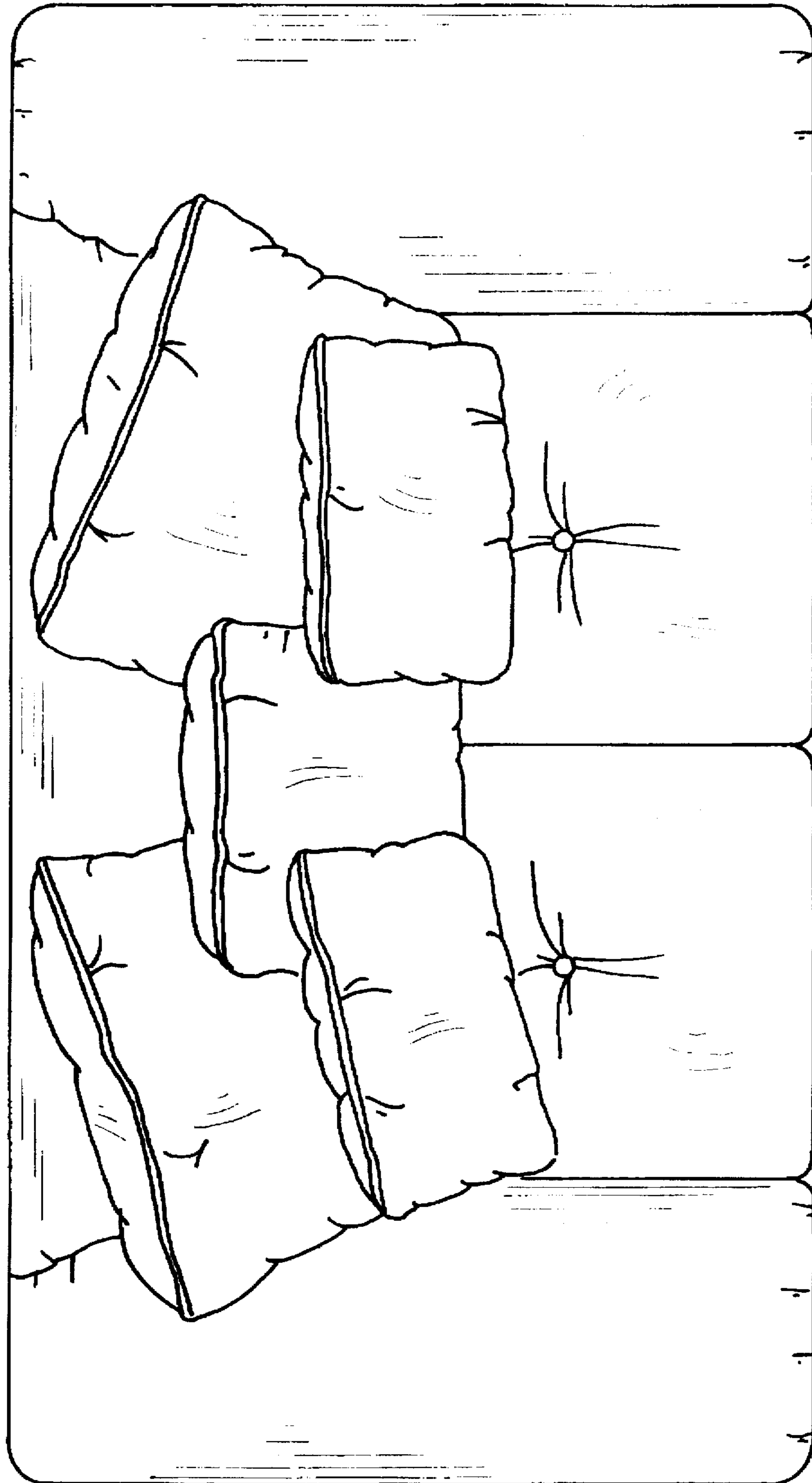

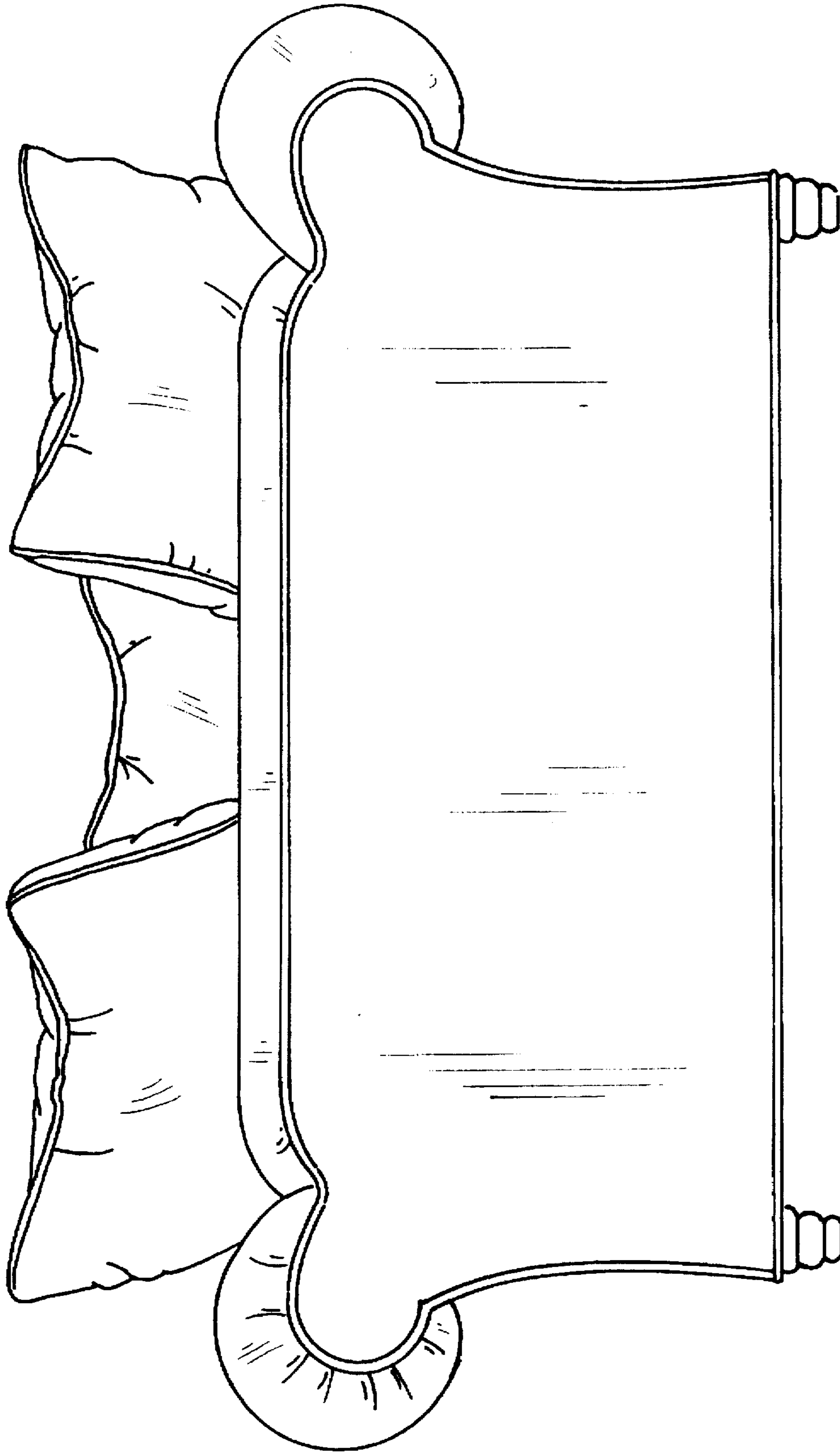
