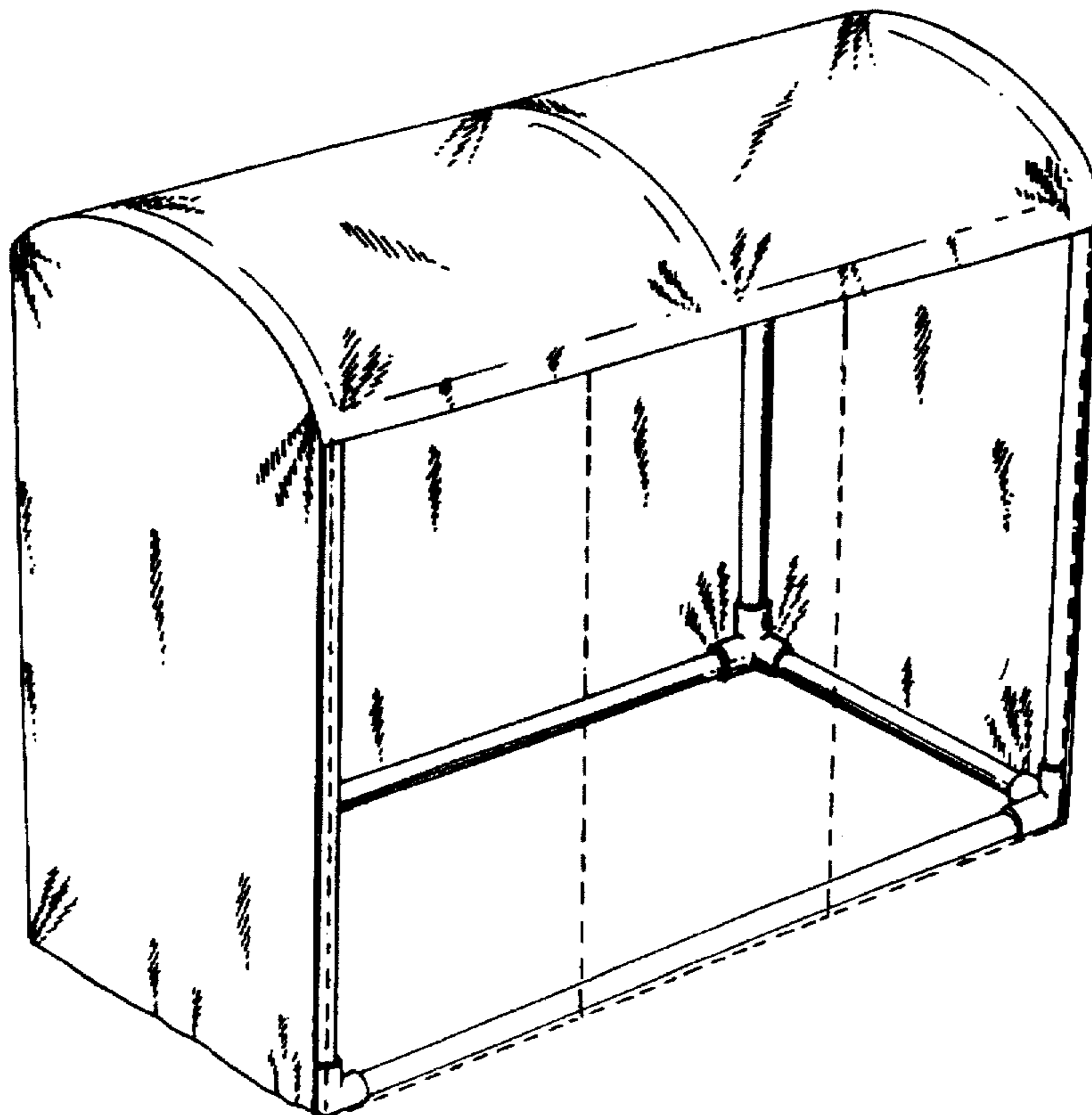
FIG. 1 is a perspective view of a covering device for a merchandising display showing my new design;

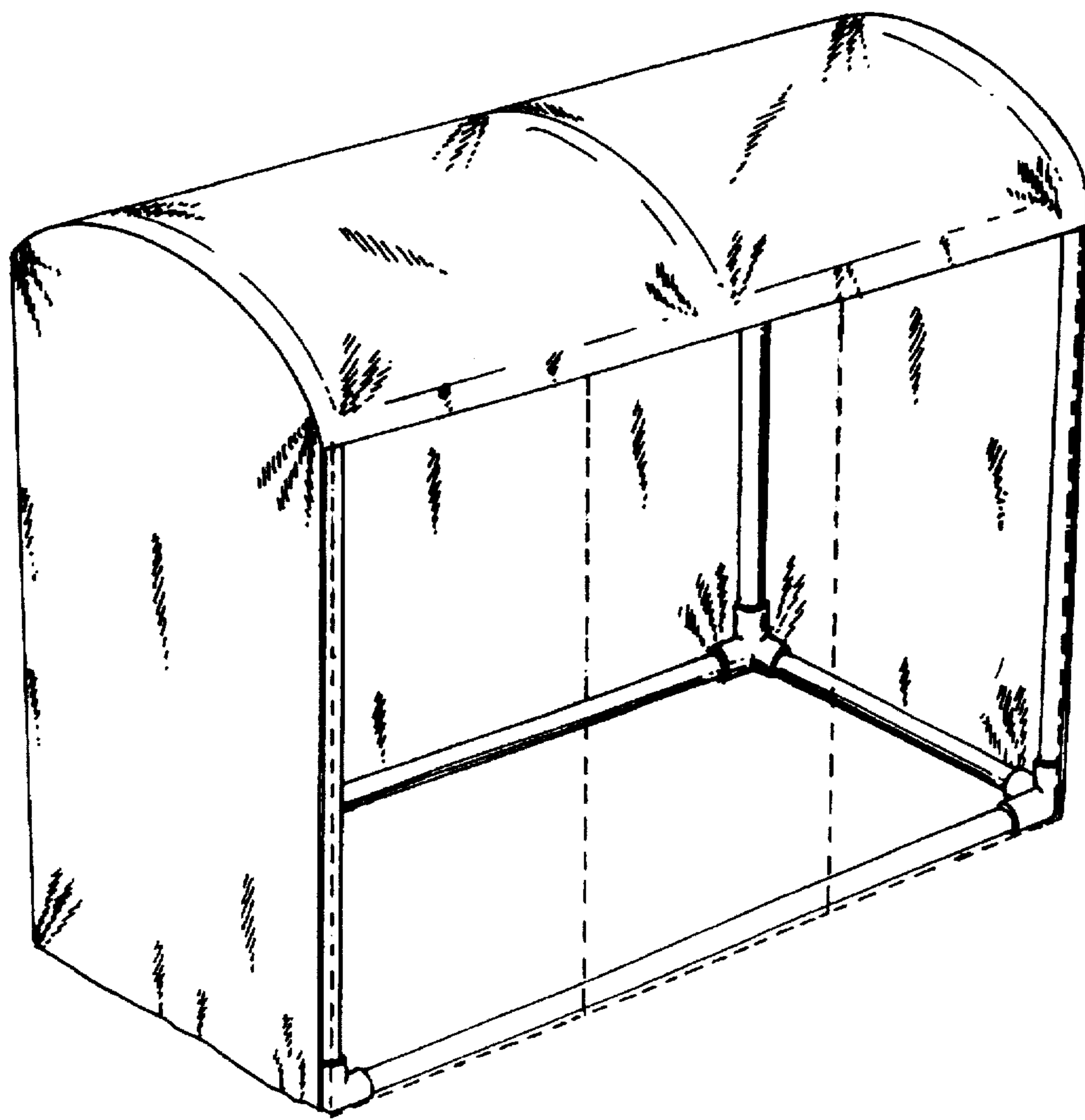

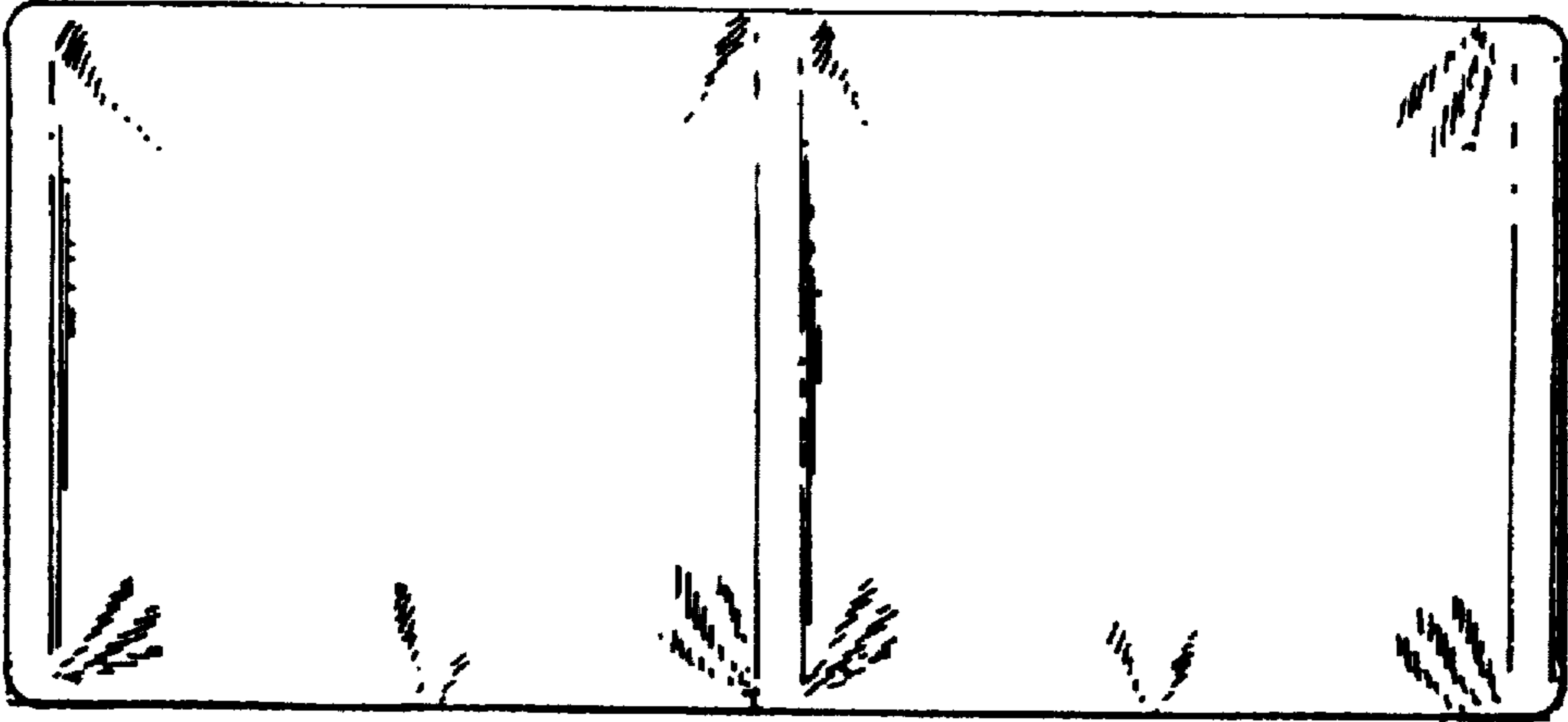

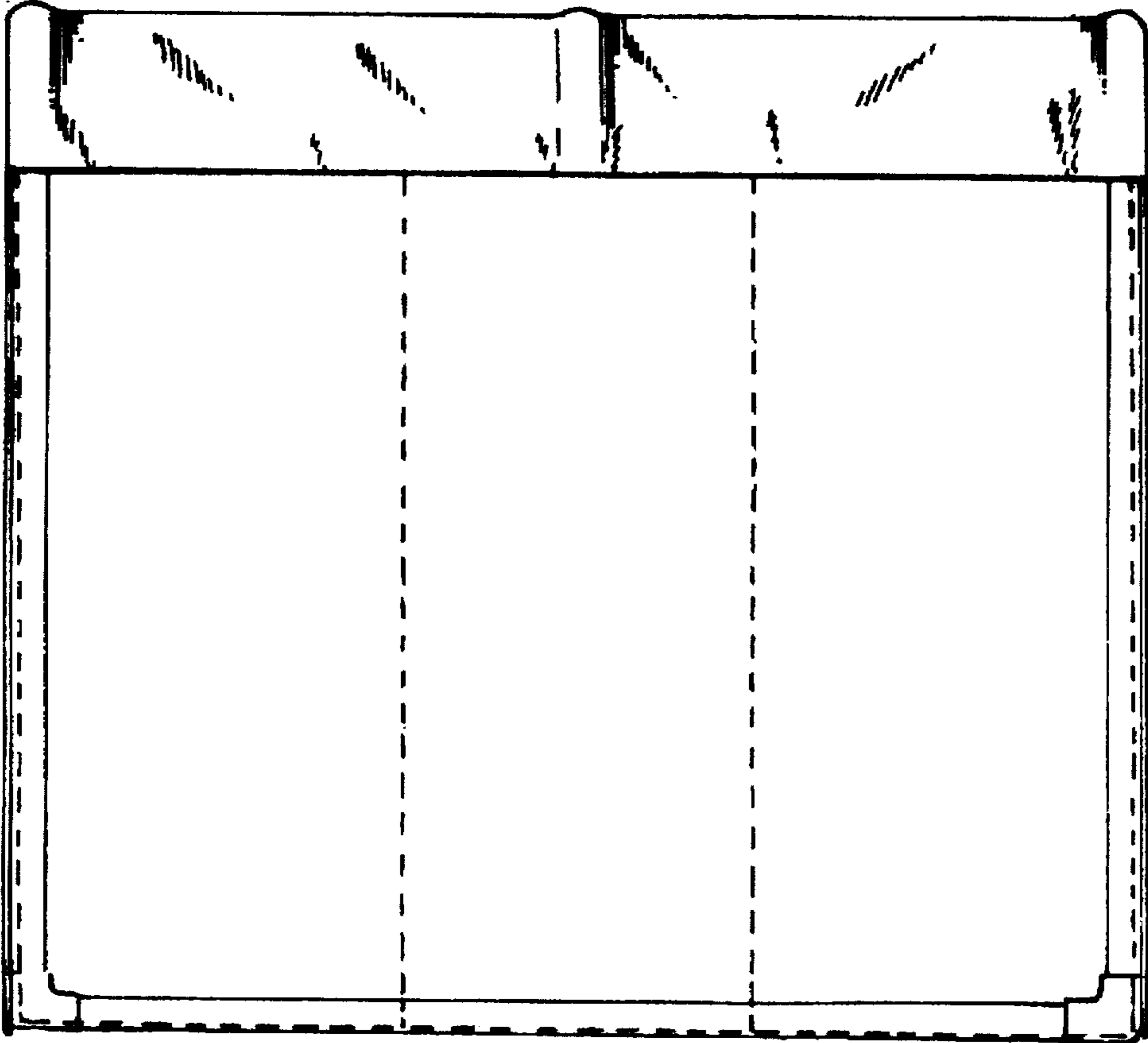

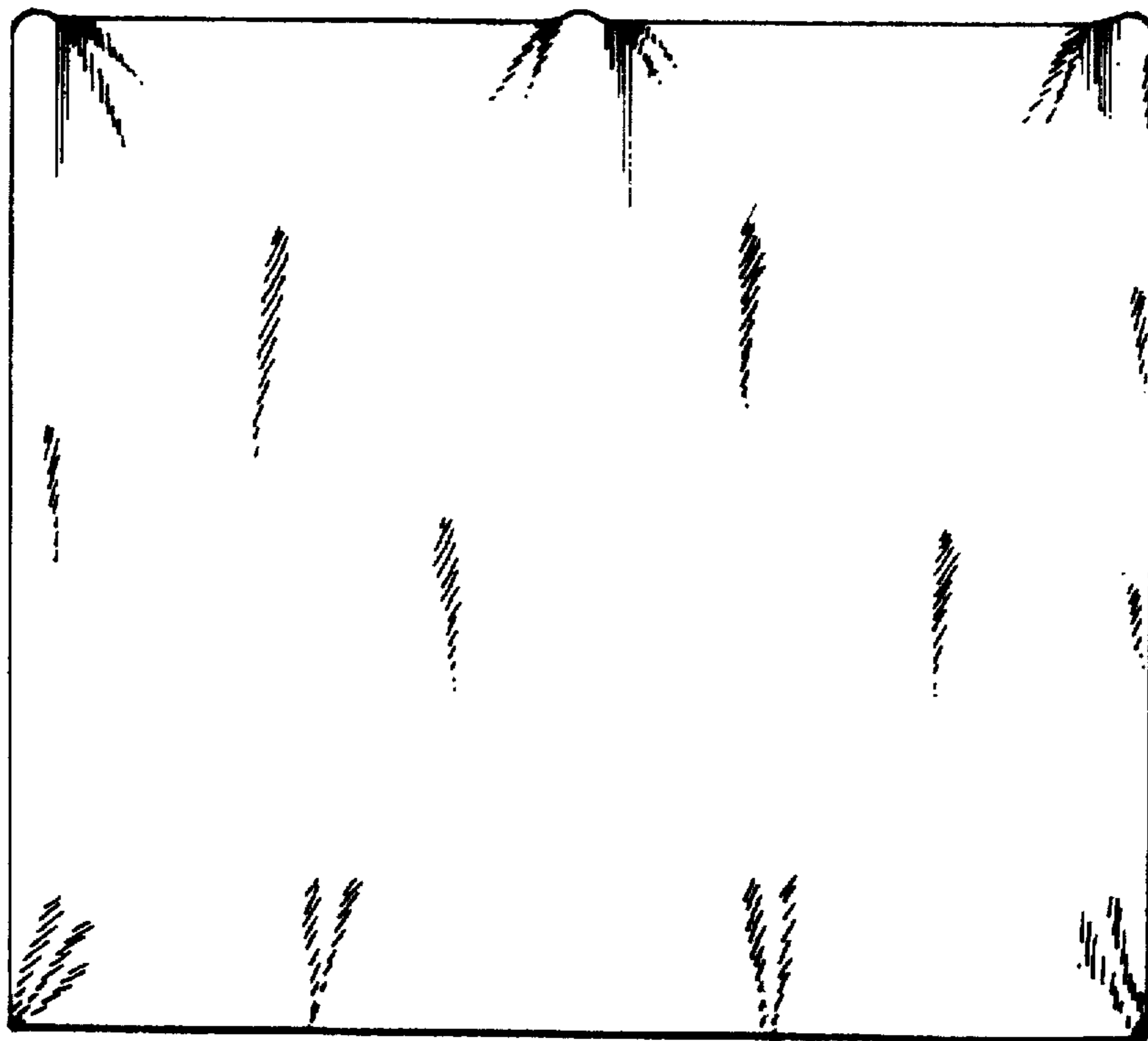
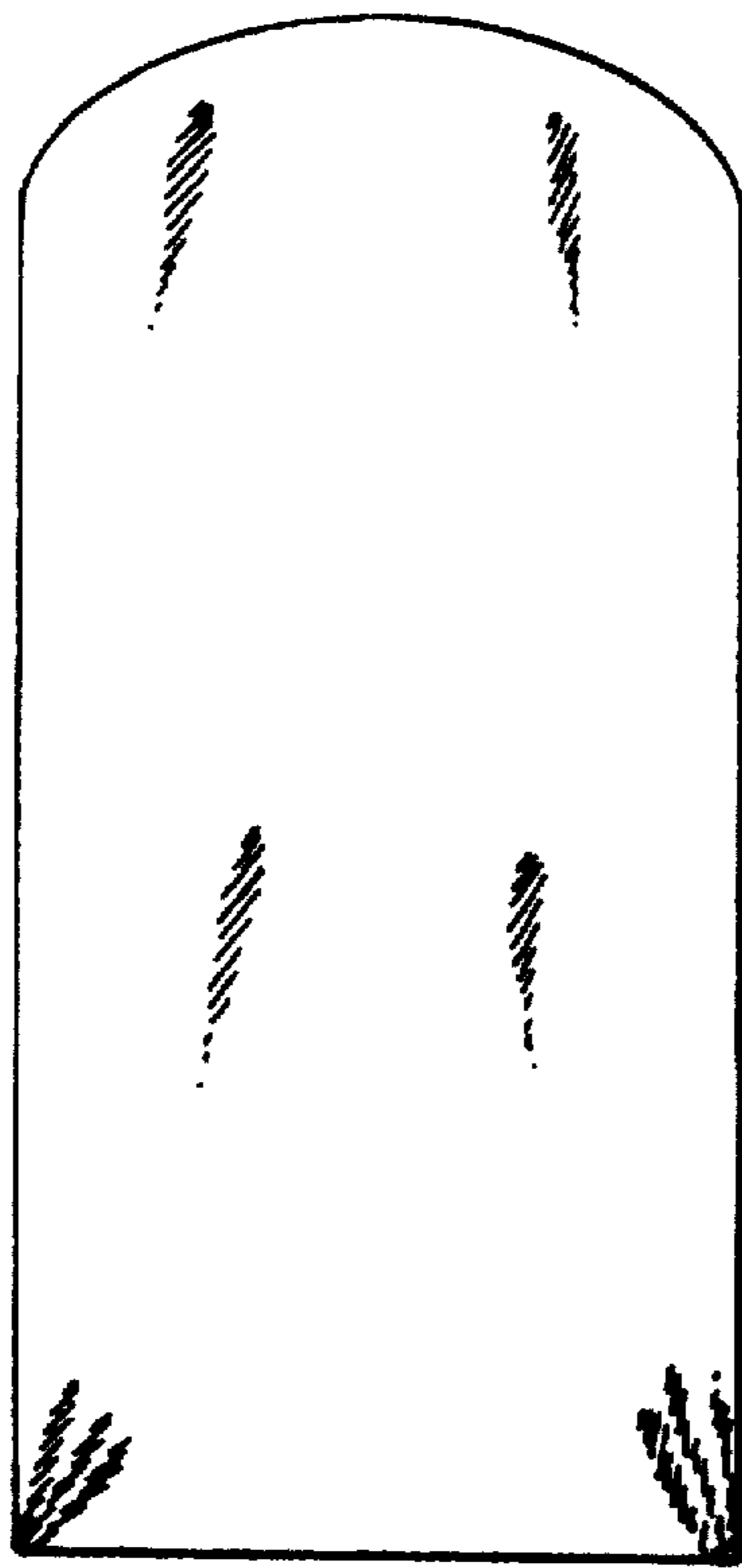
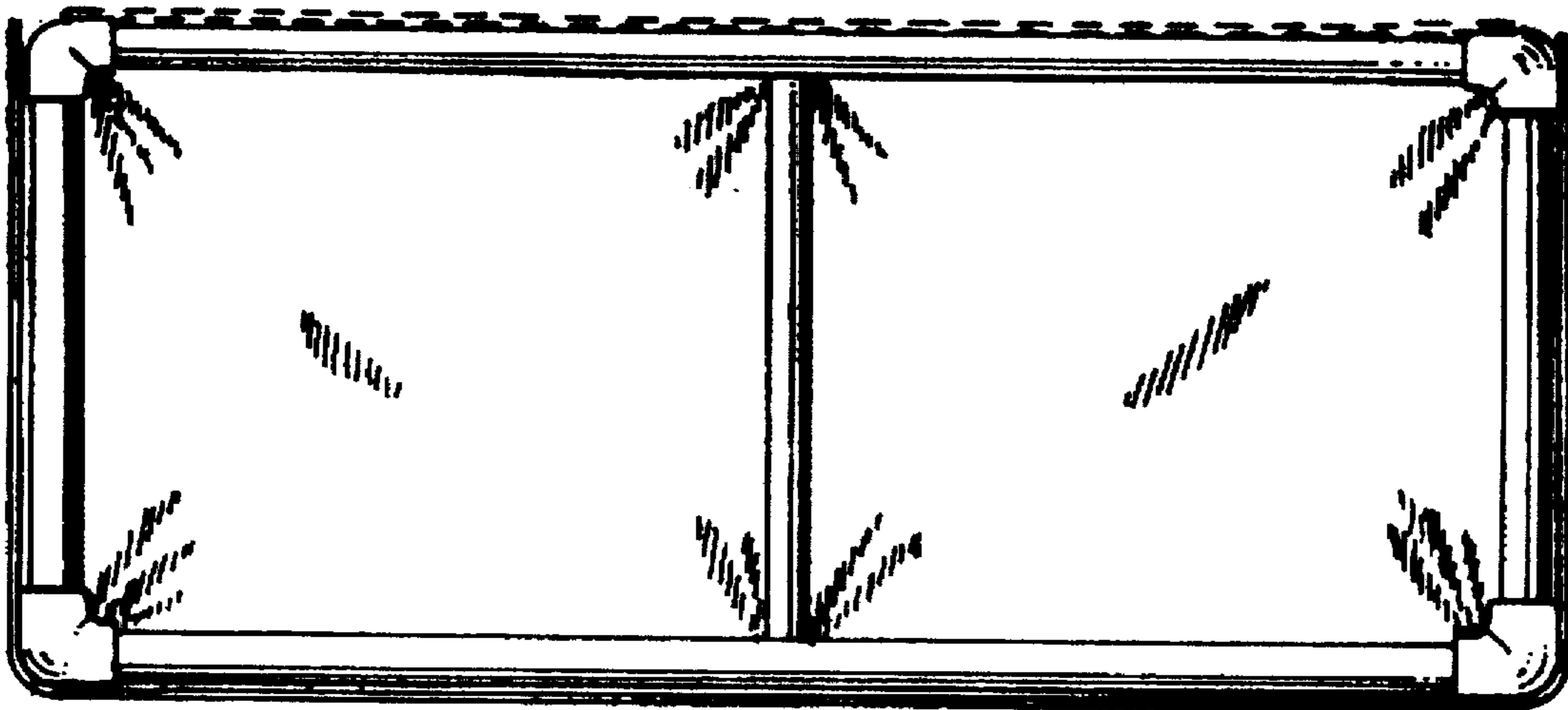

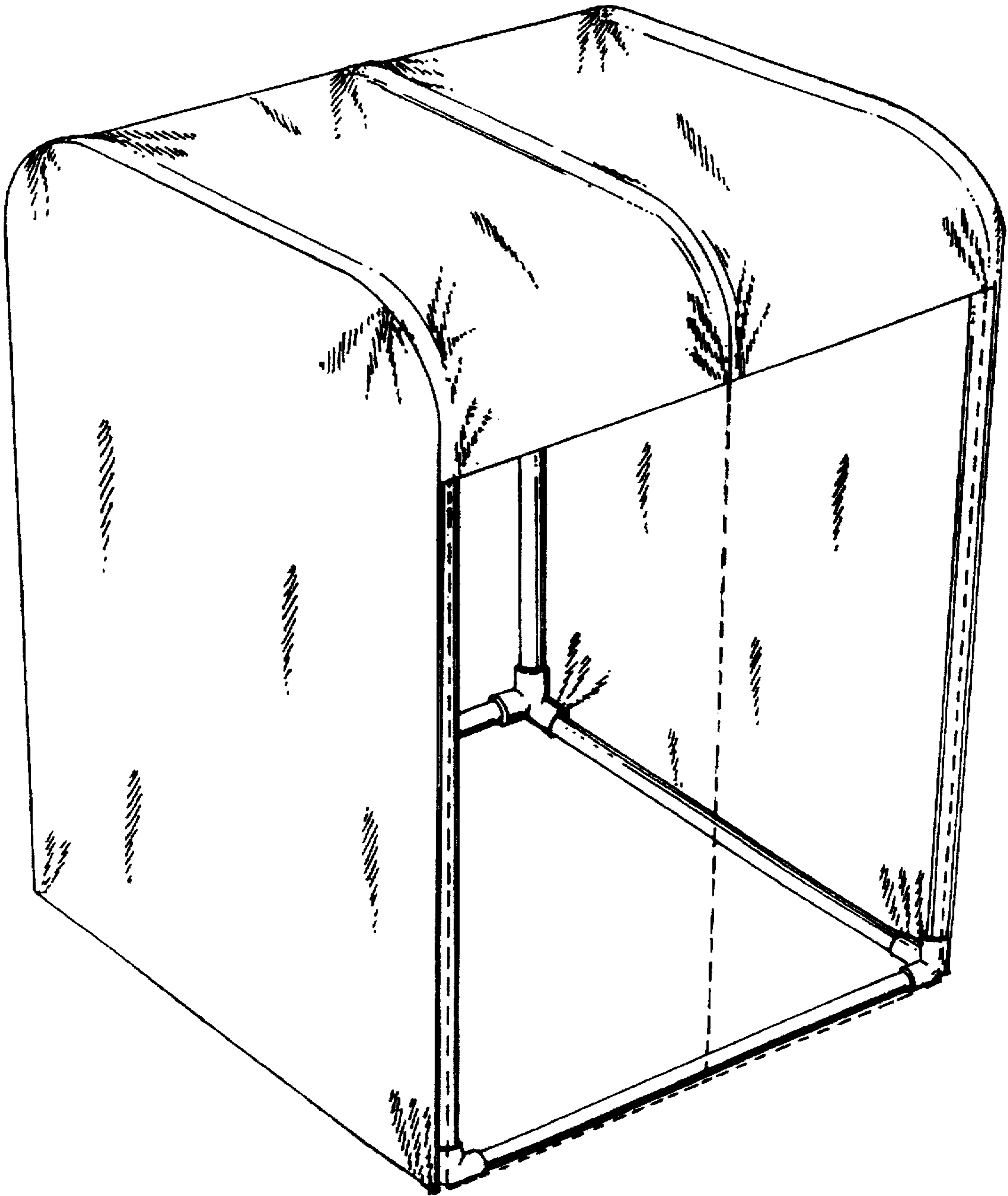

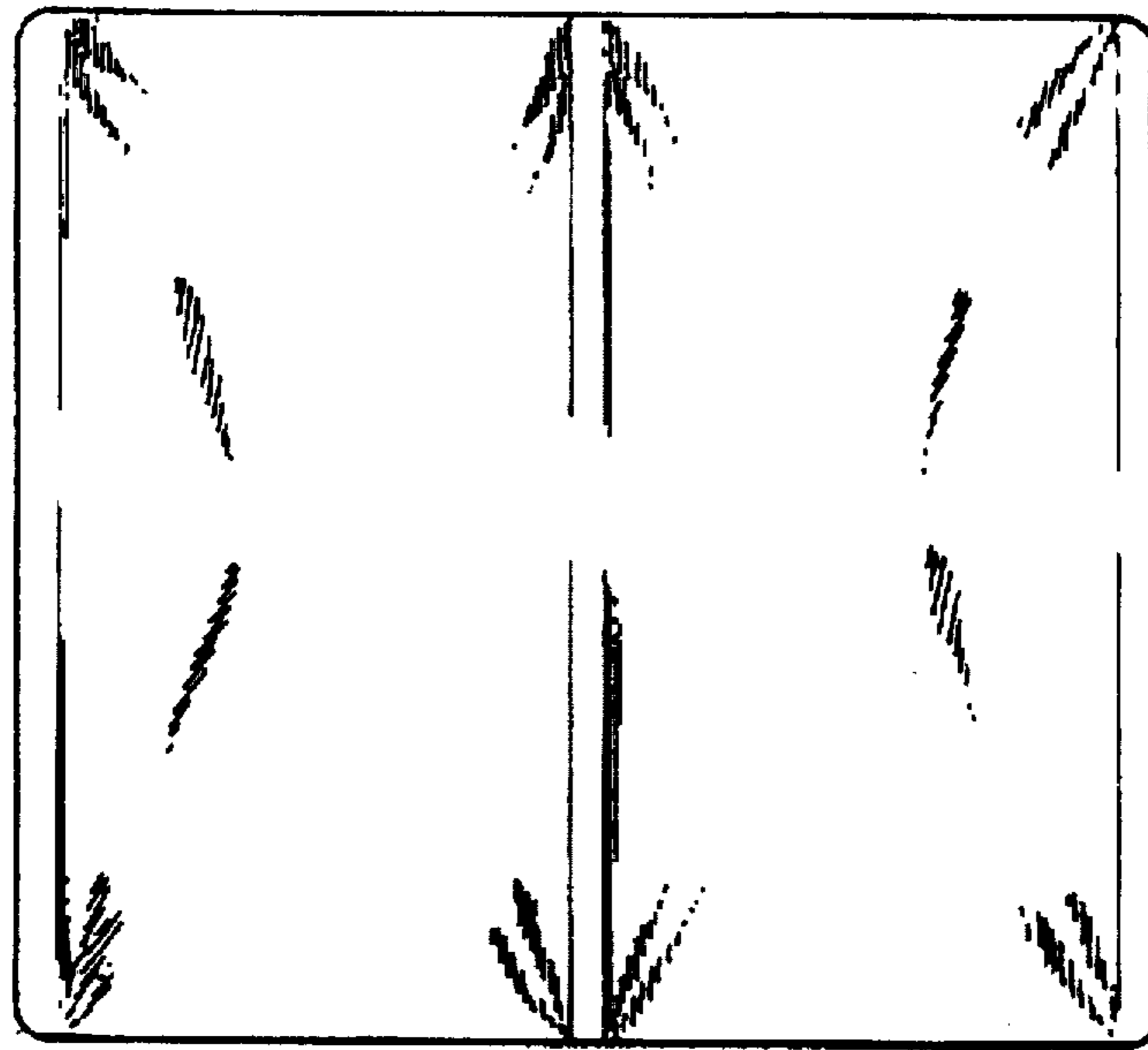

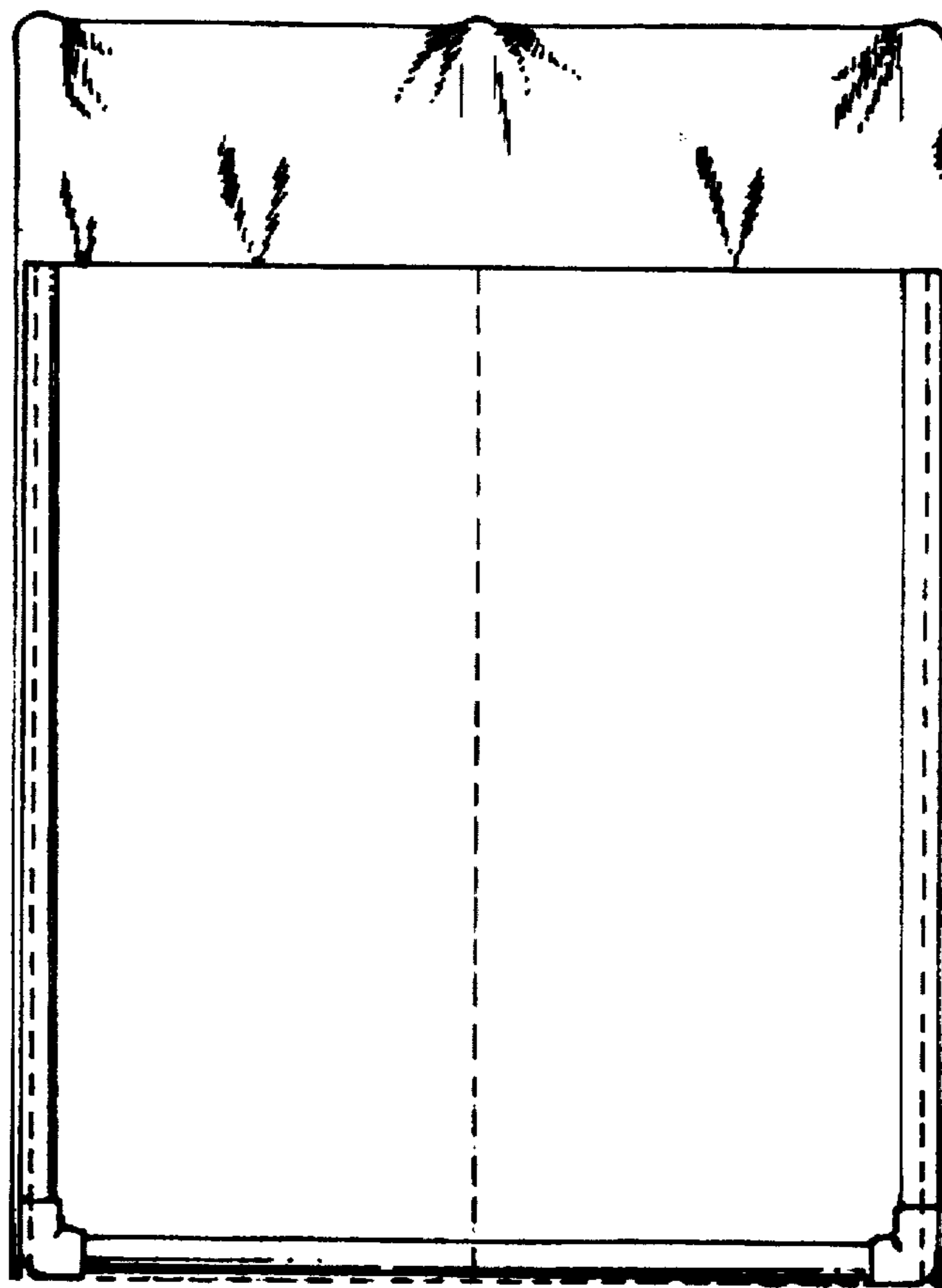

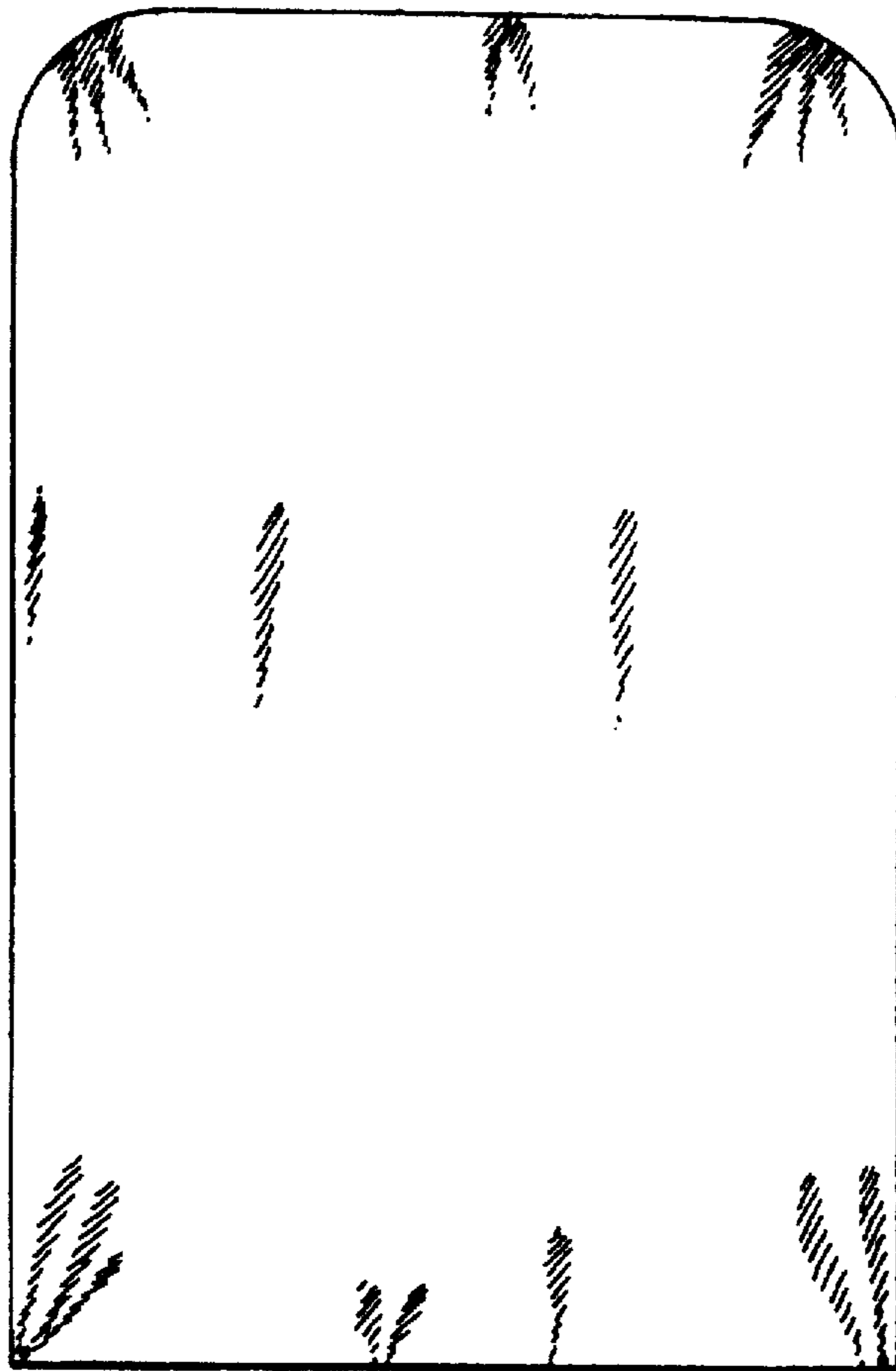

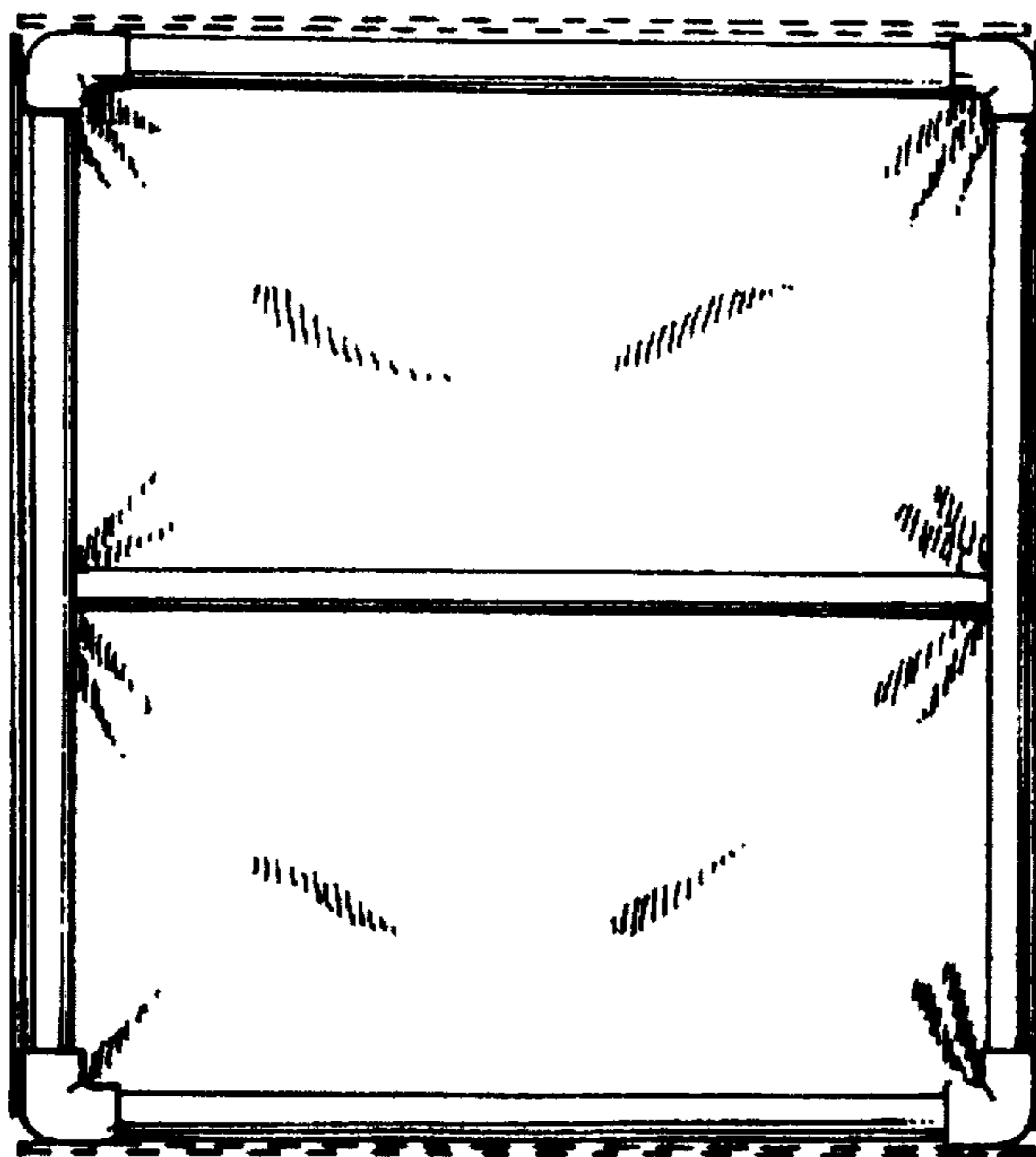
