FIG. 10 is a left side elevational view of the wall hook illustrated in FIG. 7, the right side elevational view being the mirror image thereof;

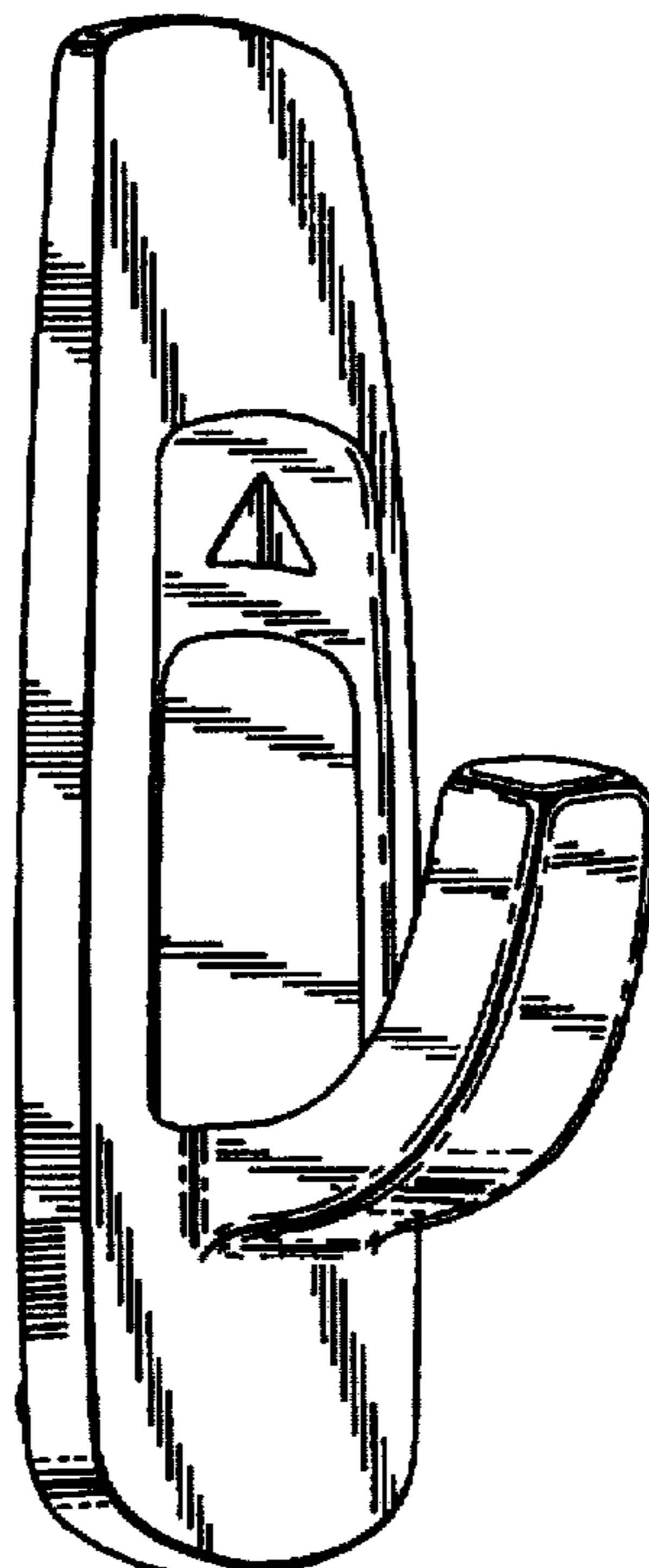
FIG. 11 is a top plan view of the wall hook illustrated in FIG. 7; and,

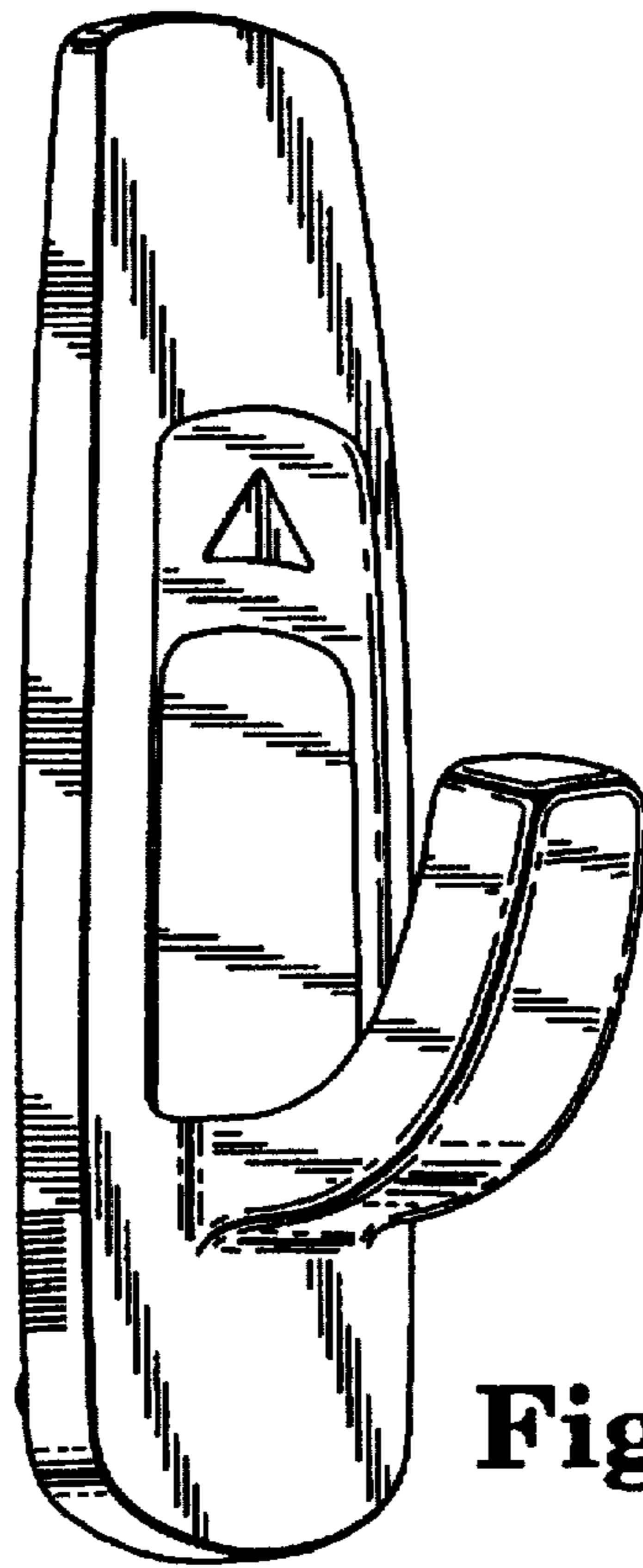
FIG. 12 is a bottom plan view of the wall hook illustrated in FIG. 7.

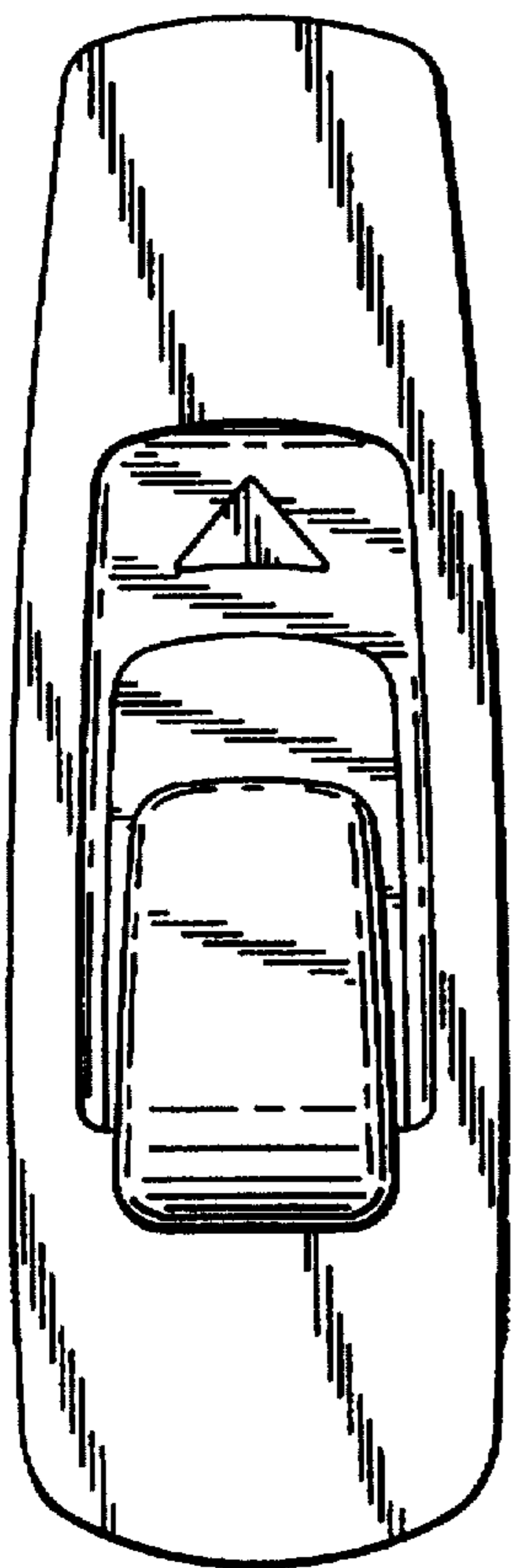

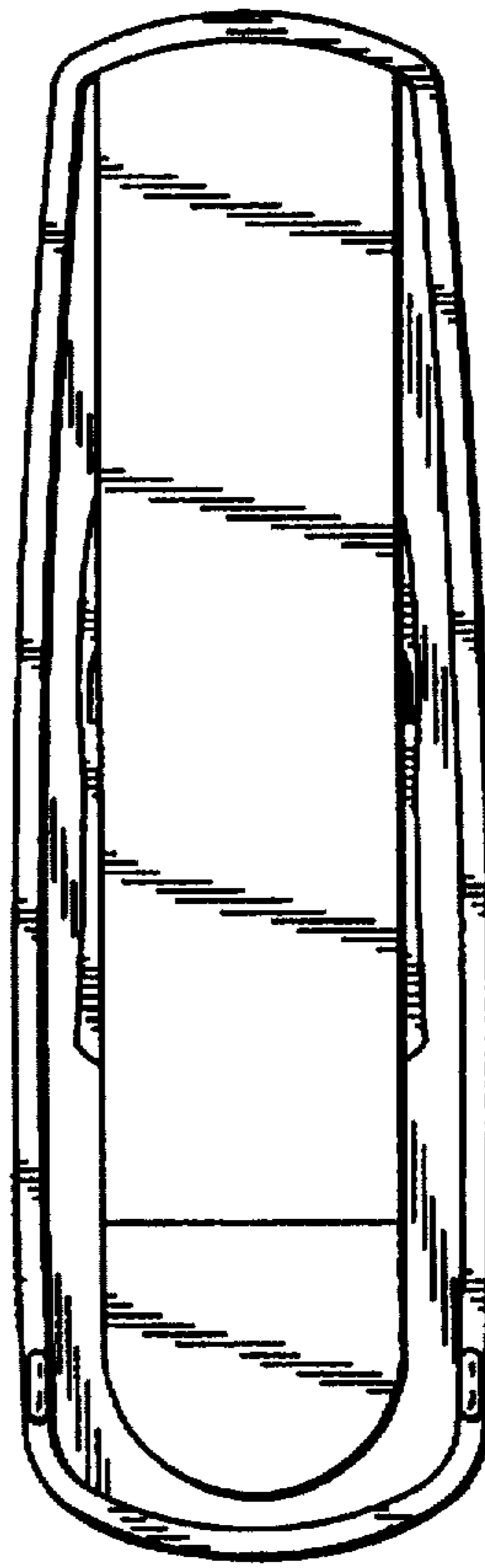




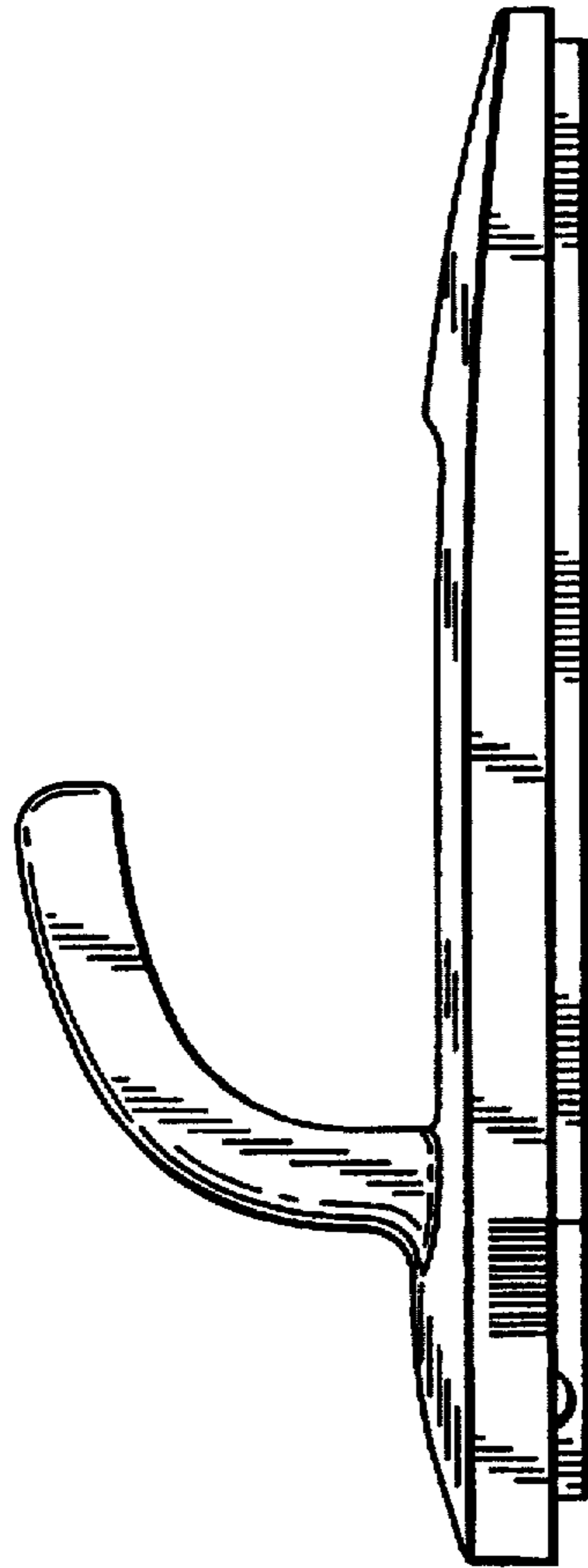

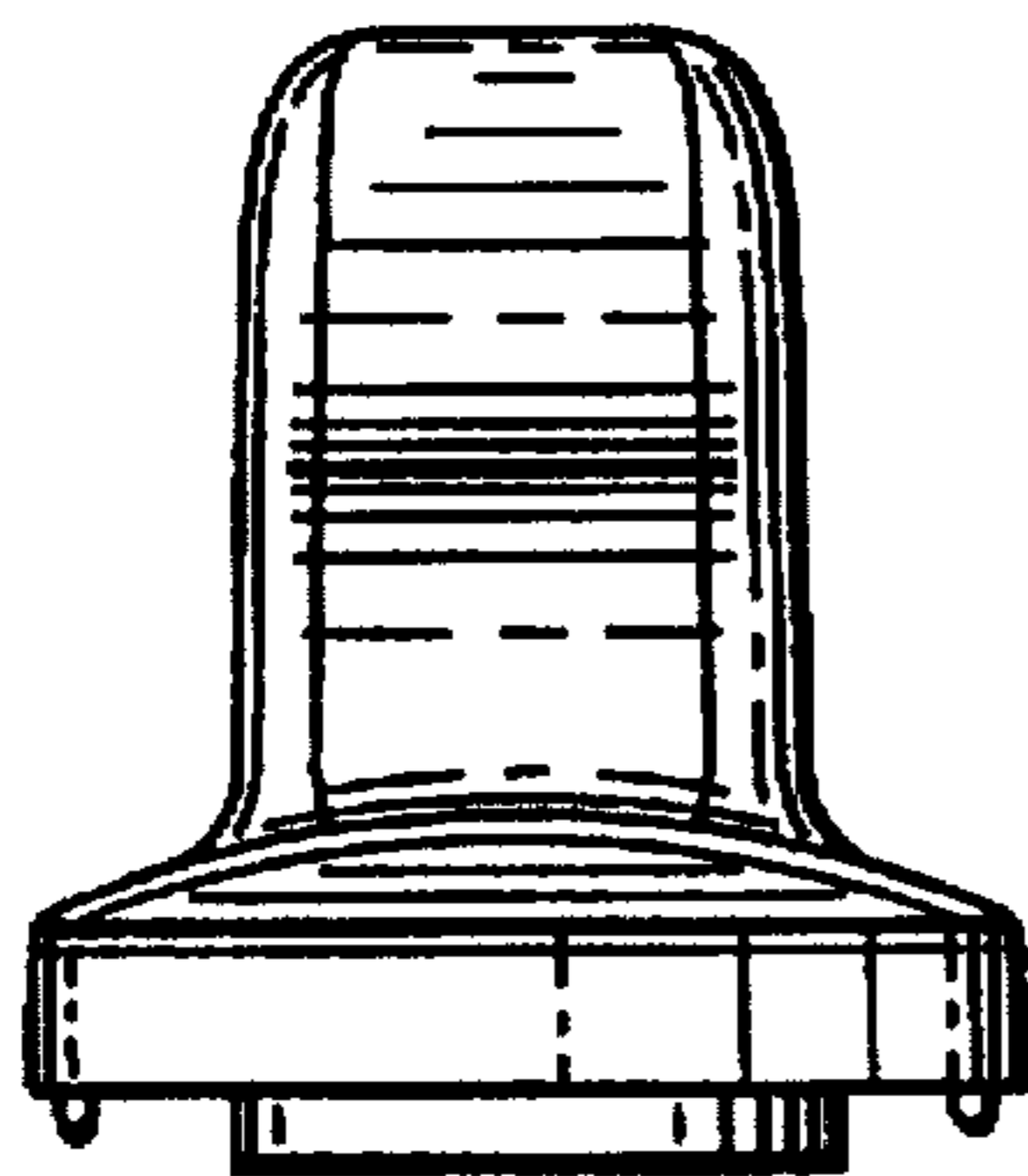

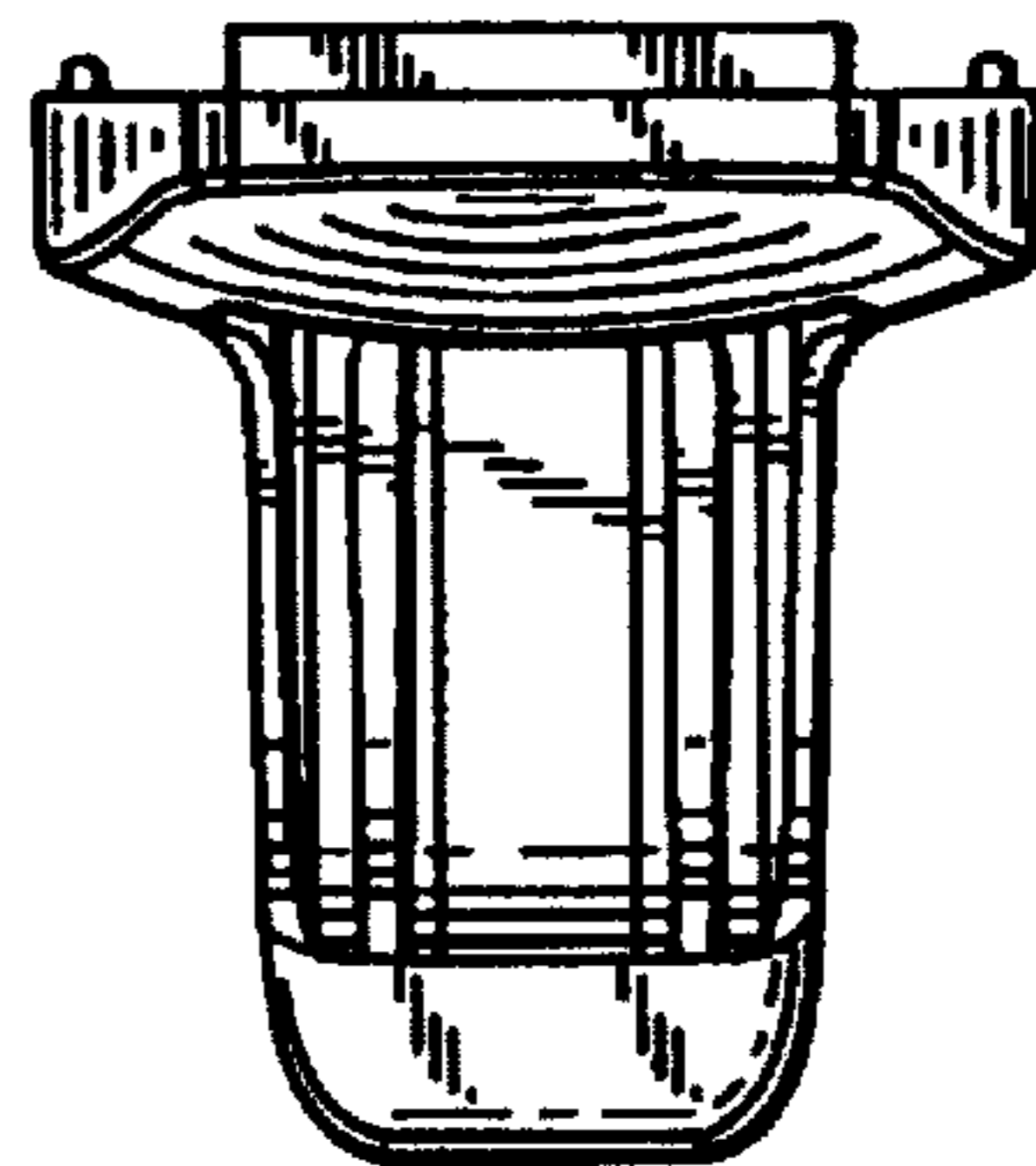

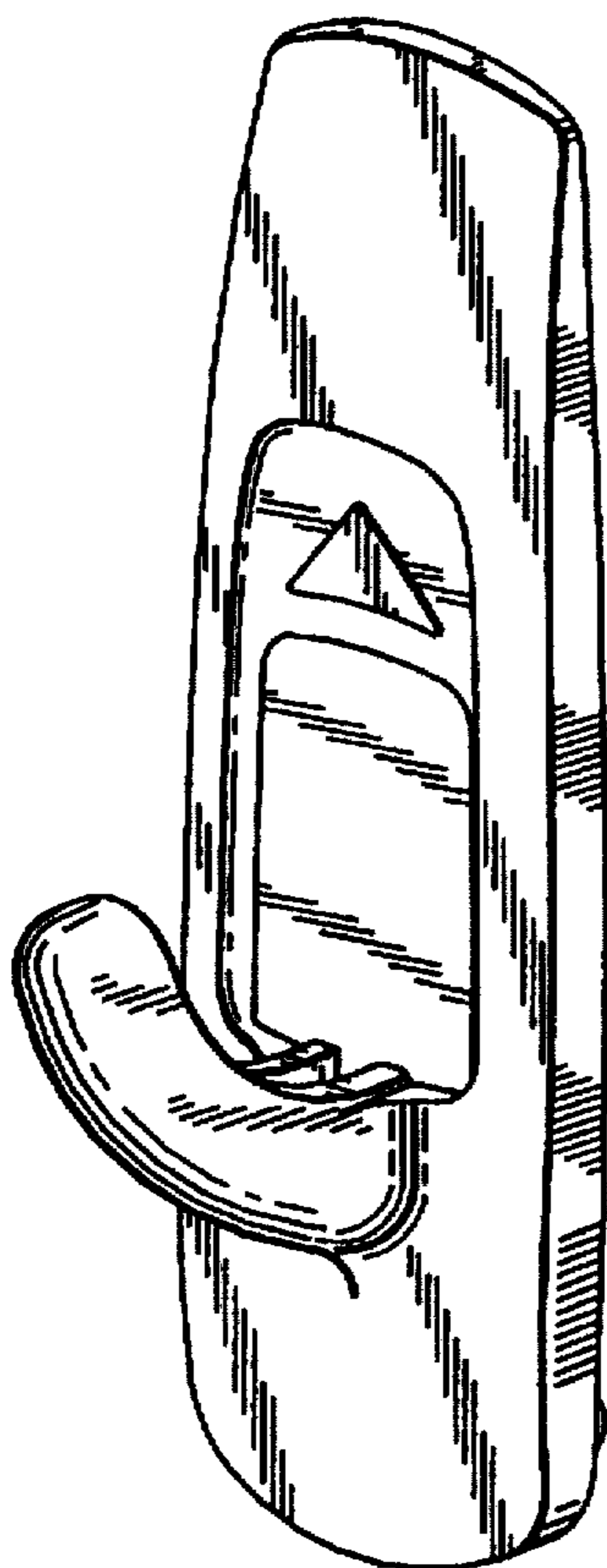

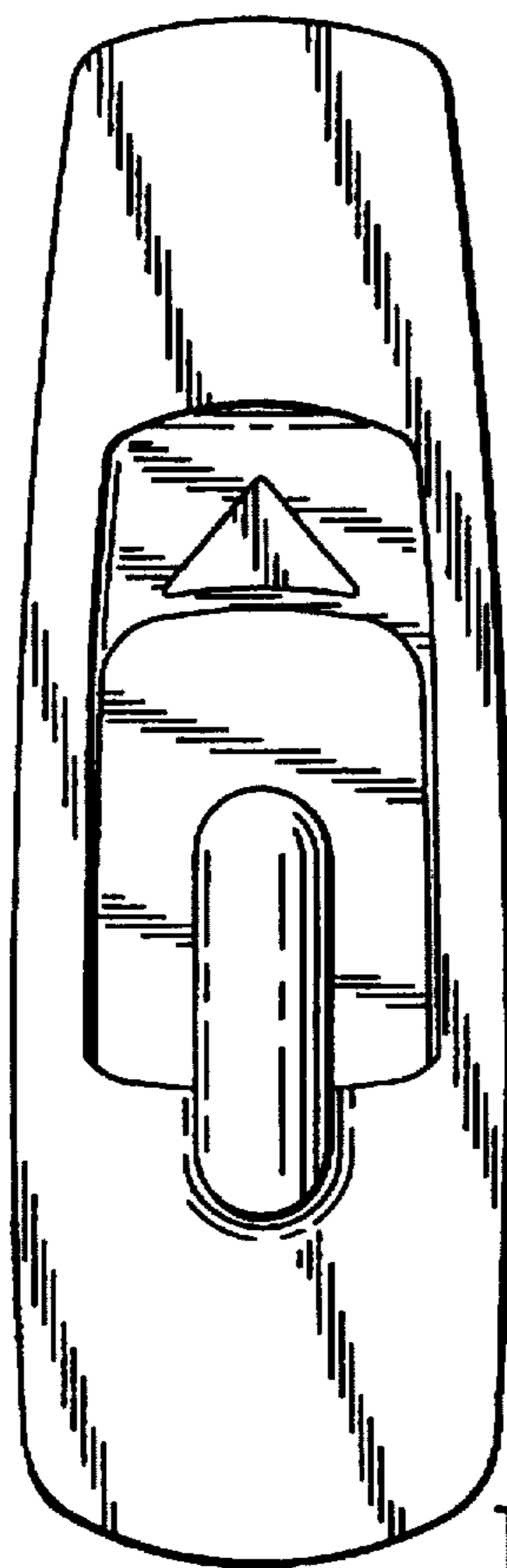

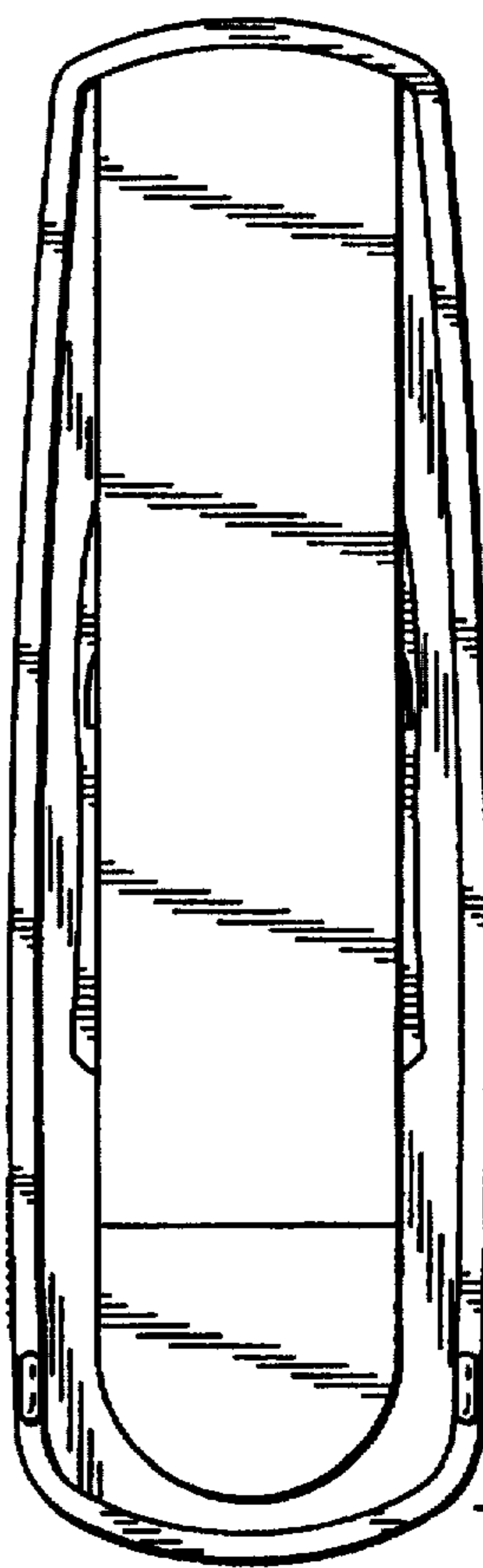

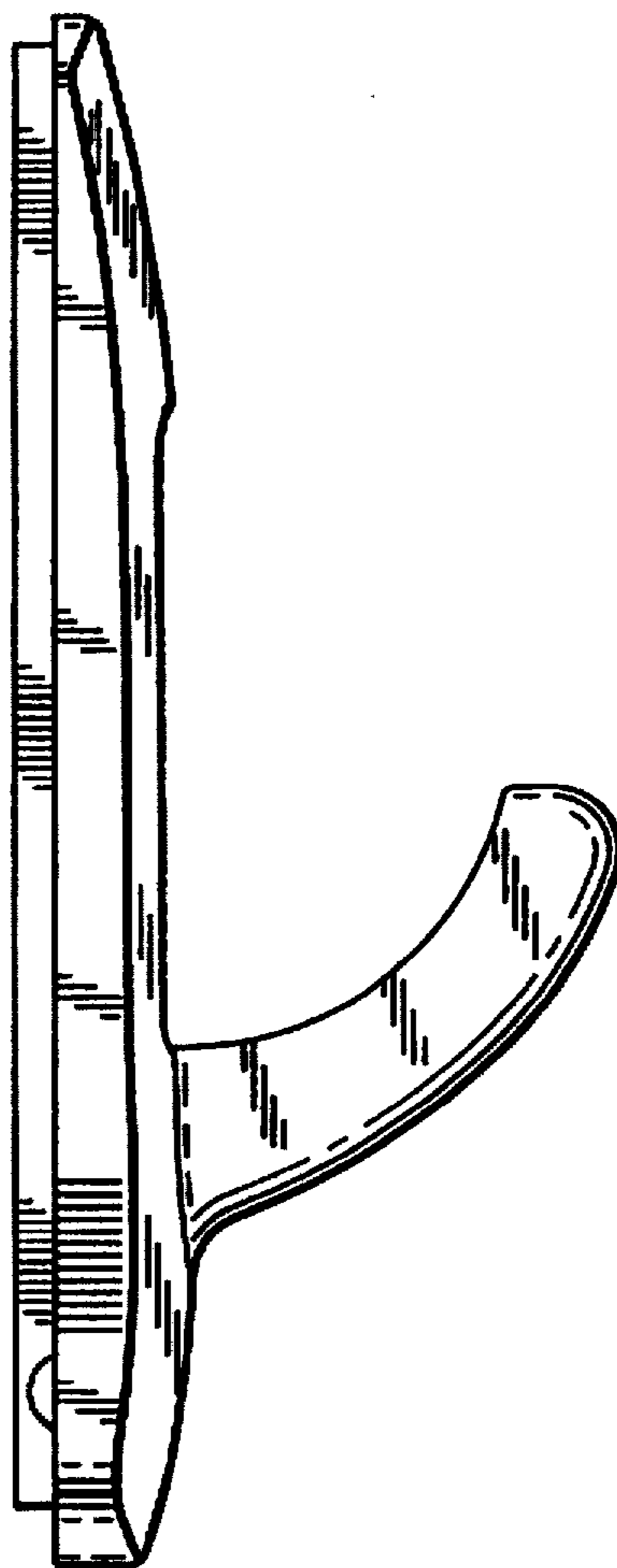

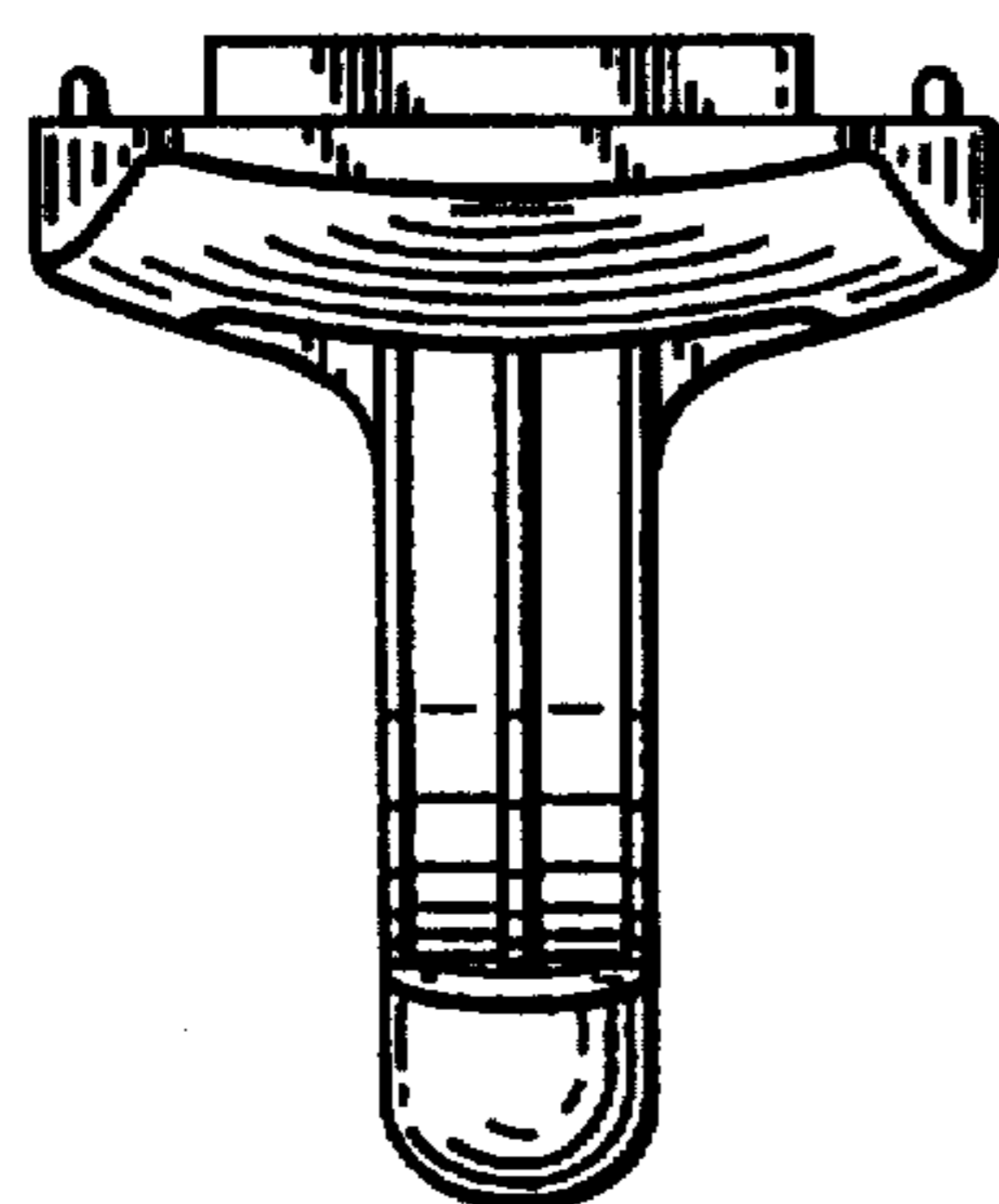

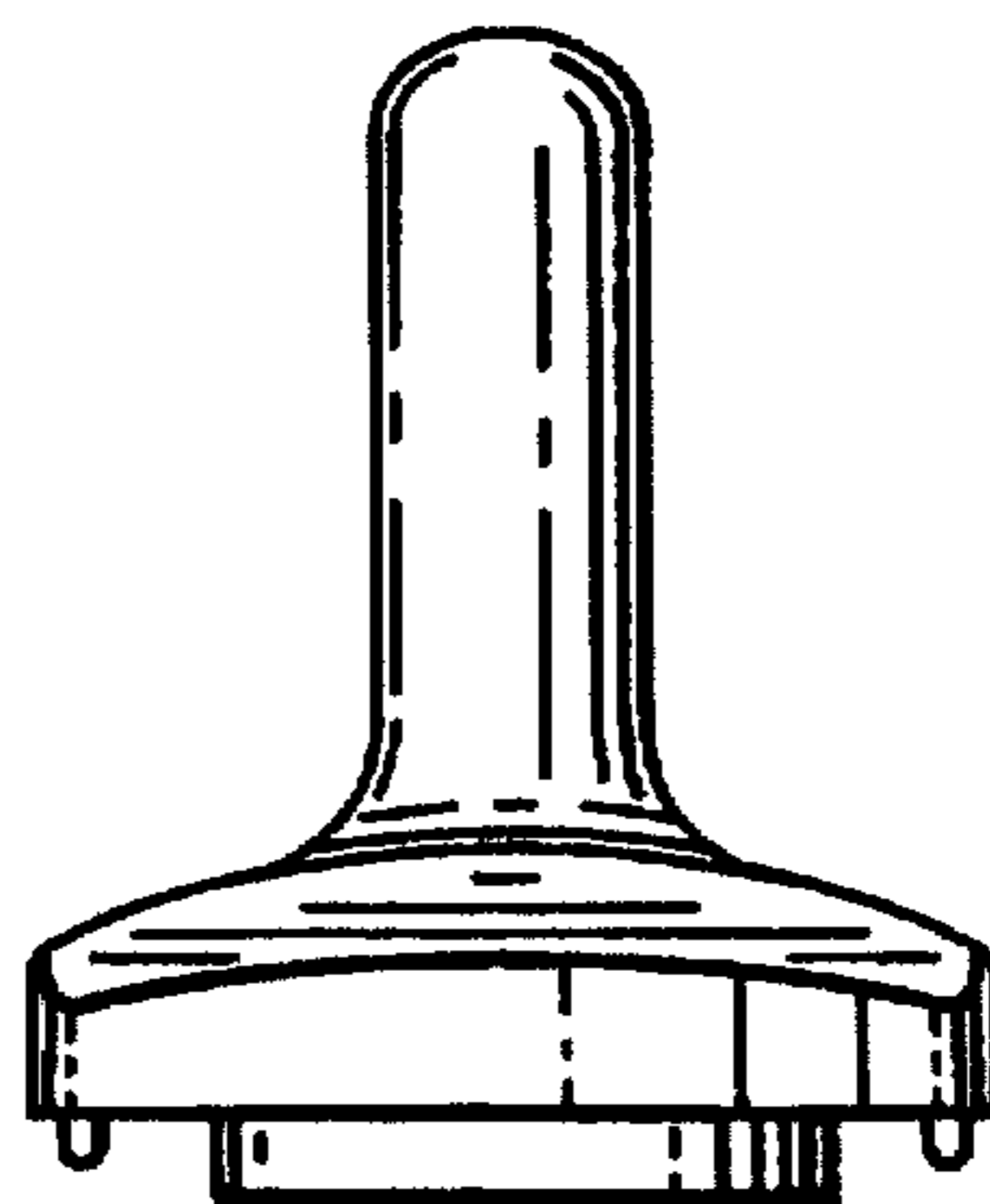
