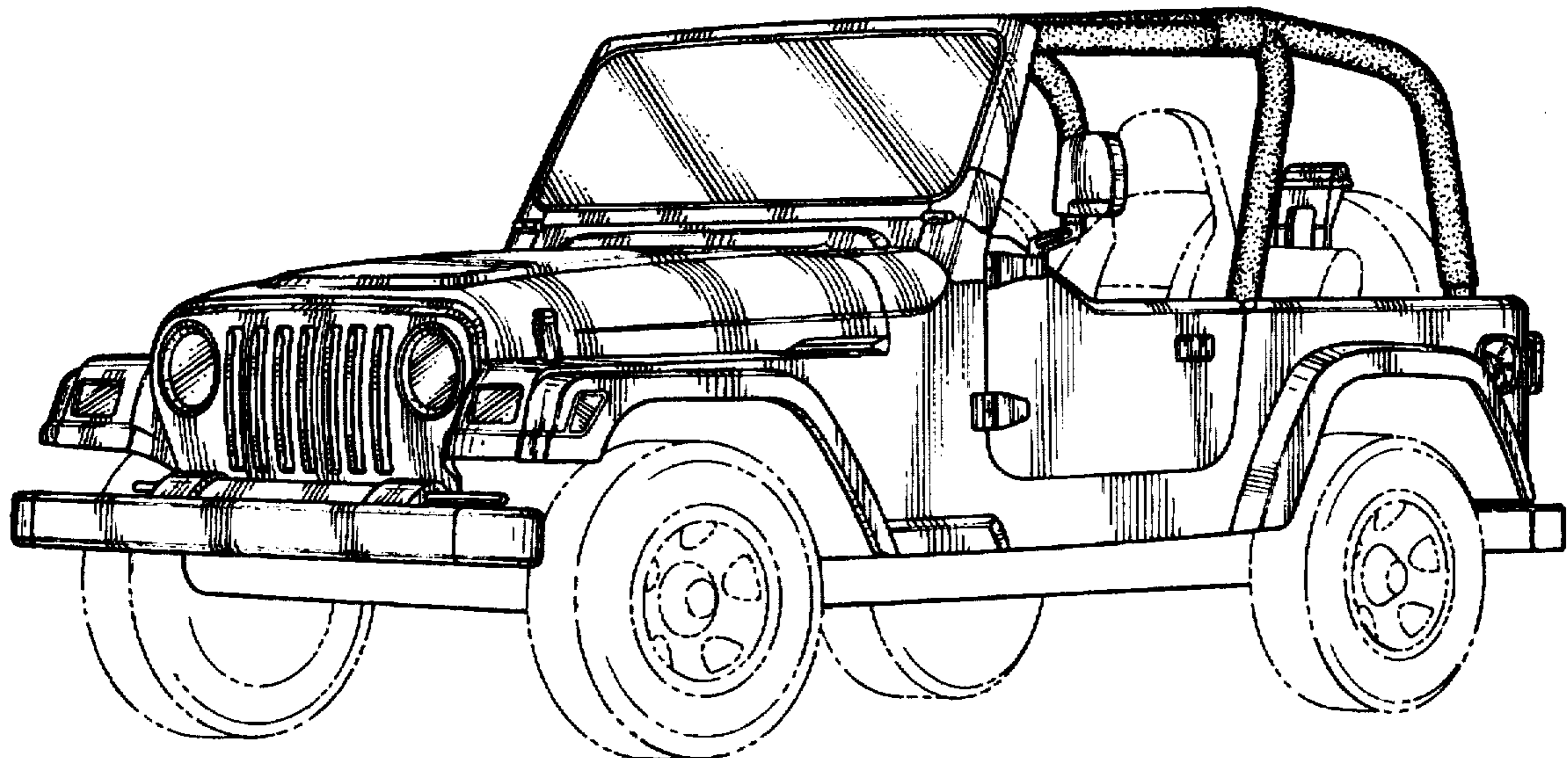
## [57] CLAIM

The ornamental design for a vehicle body, as shown and described.

## DESCRIPTION

FIG. 1 is a front, side perspective view of a vehicle body showing our new design;  
 FIG. 2 is a rear perspective view of the vehicle body shown in FIG. 1;  
 FIG. 3 is a side view of the vehicle body shown in FIG. 1, the opposite side view is a mirror image;  
 FIG. 4 is an elevated front view of the vehicle body shown in FIG. 1;  
 FIG. 5 is a front, top perspective view thereof, on an enlarged scale; and,  
 FIG. 6 is a rear view thereof, the broken line drawing of the spare tire is not shown for clarity of illustration.  
 The broken line drawing of the wheels and the interior details in all views are for illustrative purposes only and form no part of the claimed design.

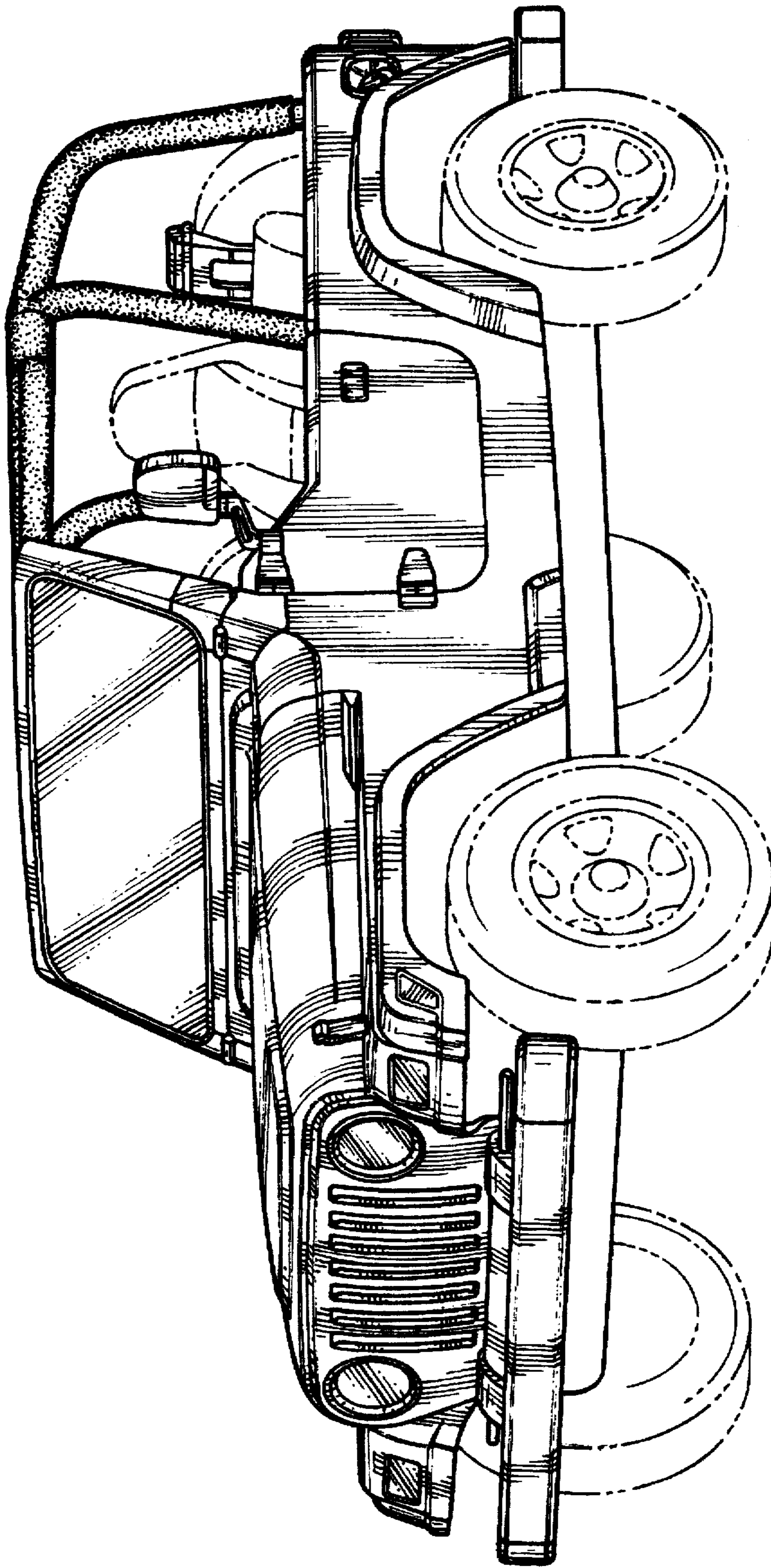

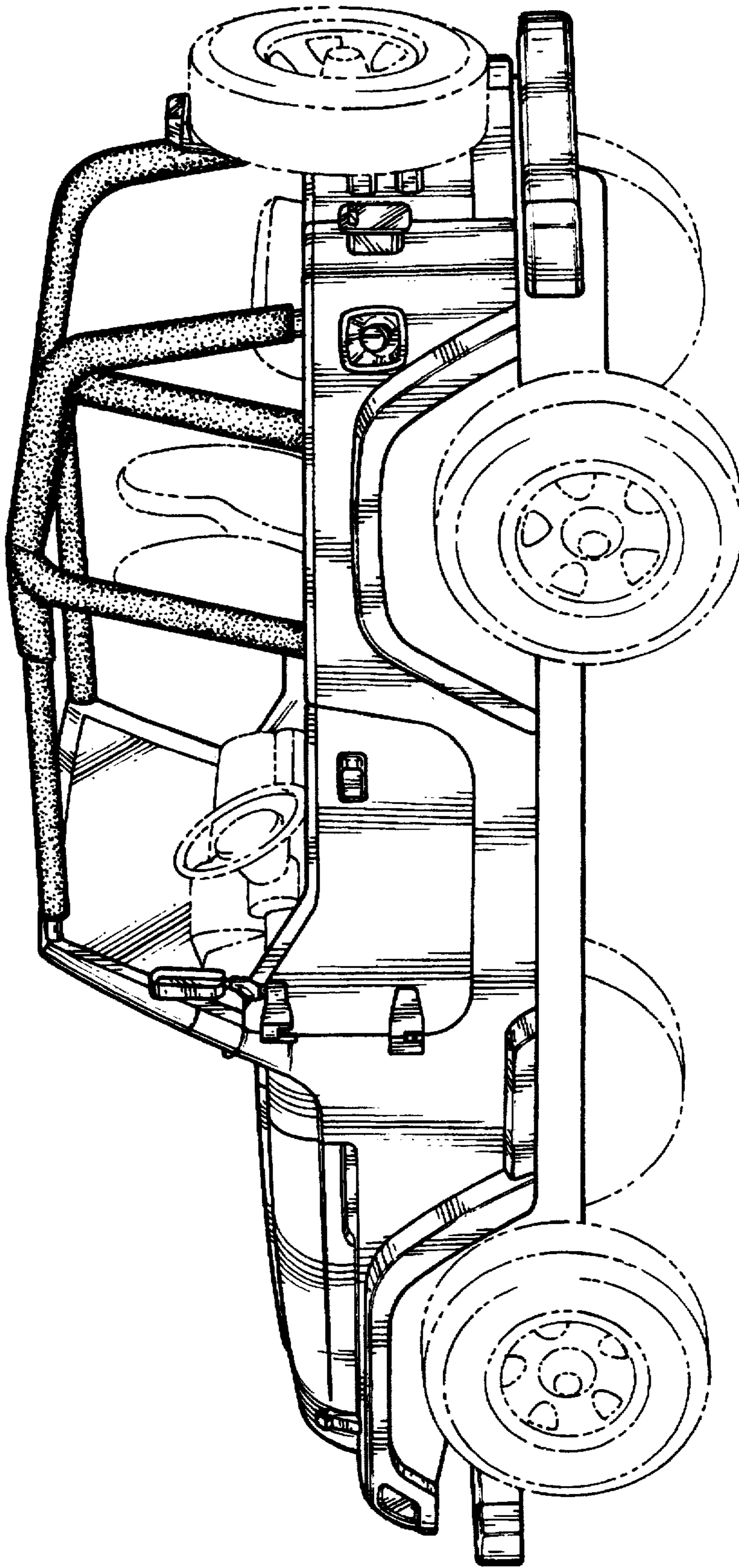

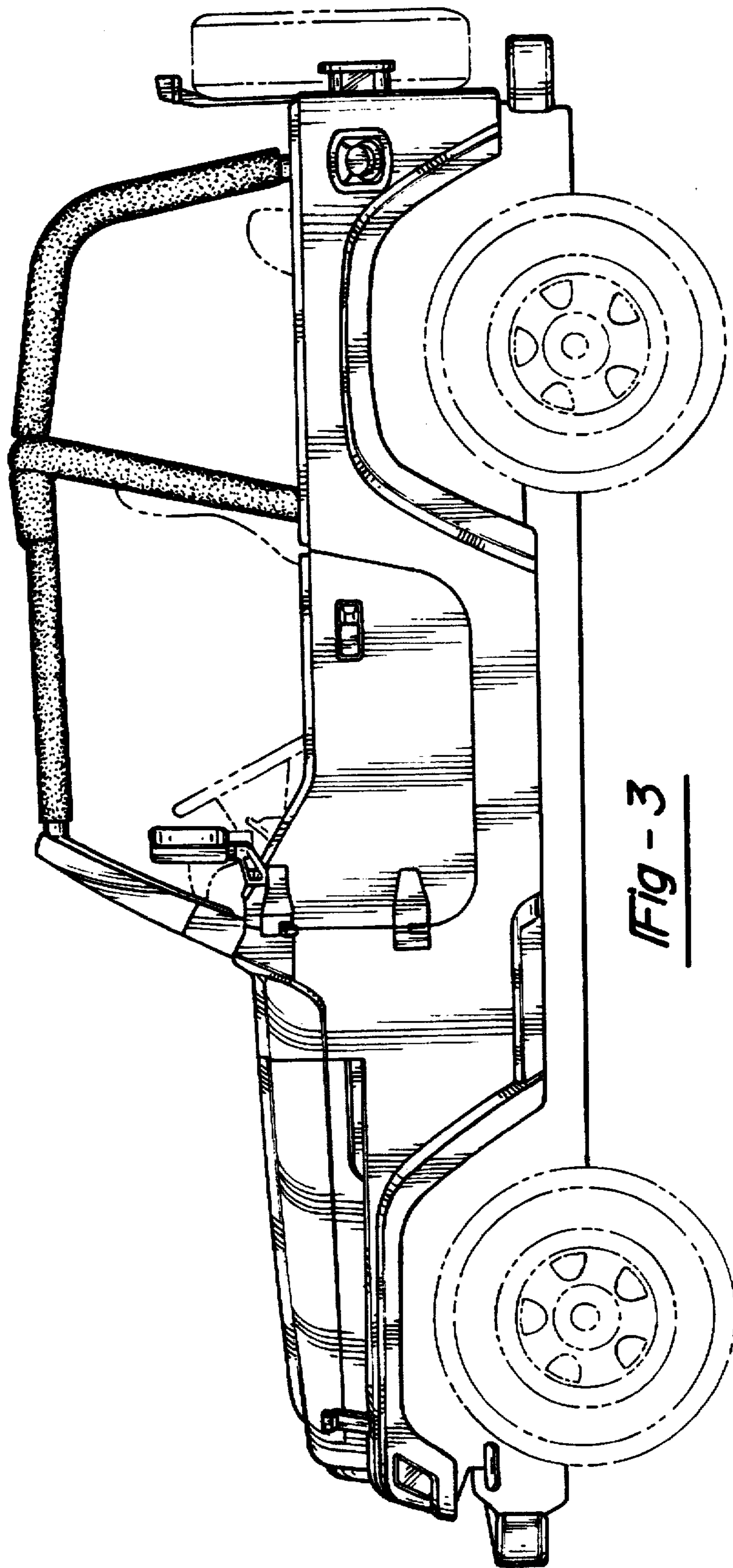

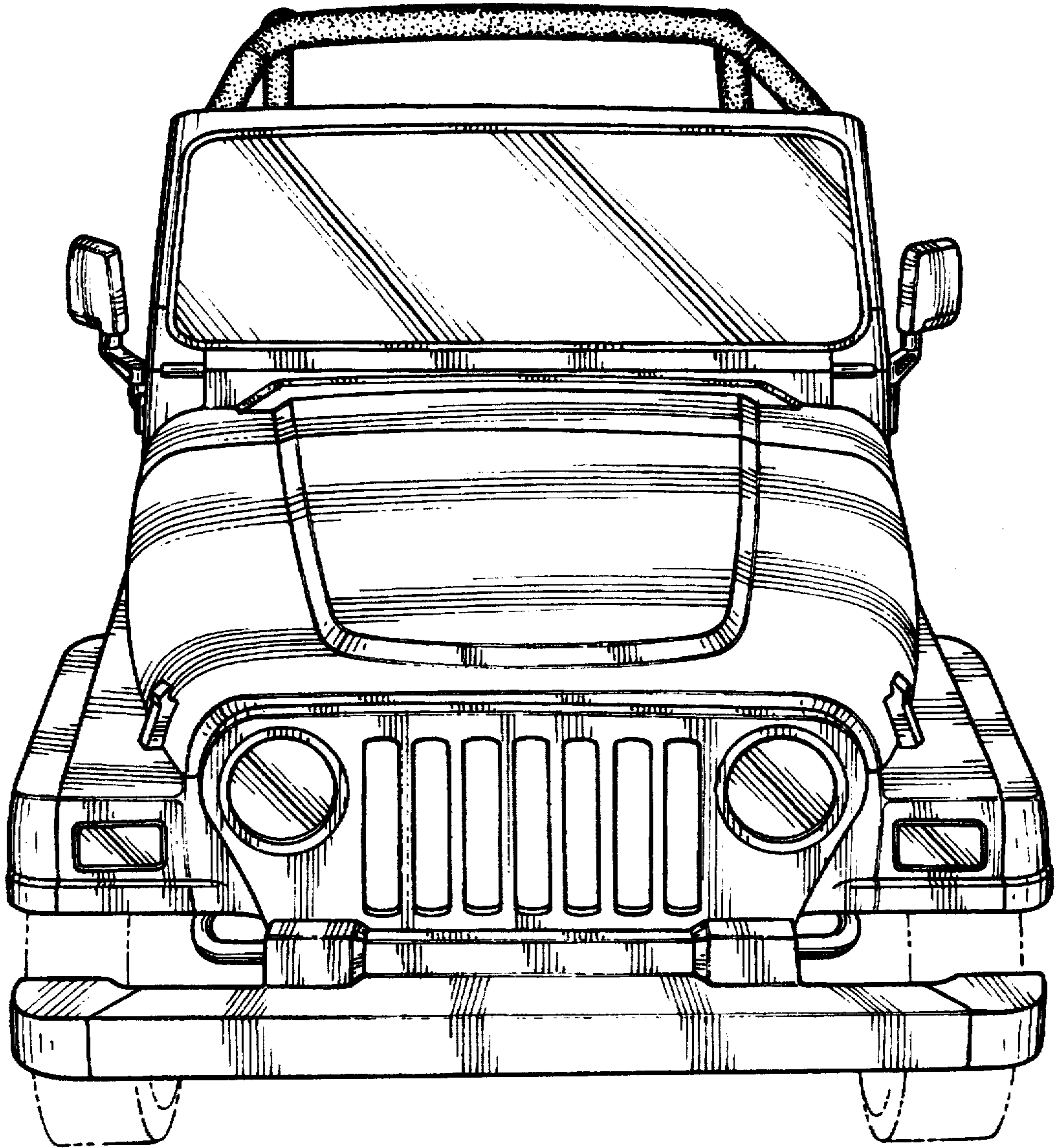
