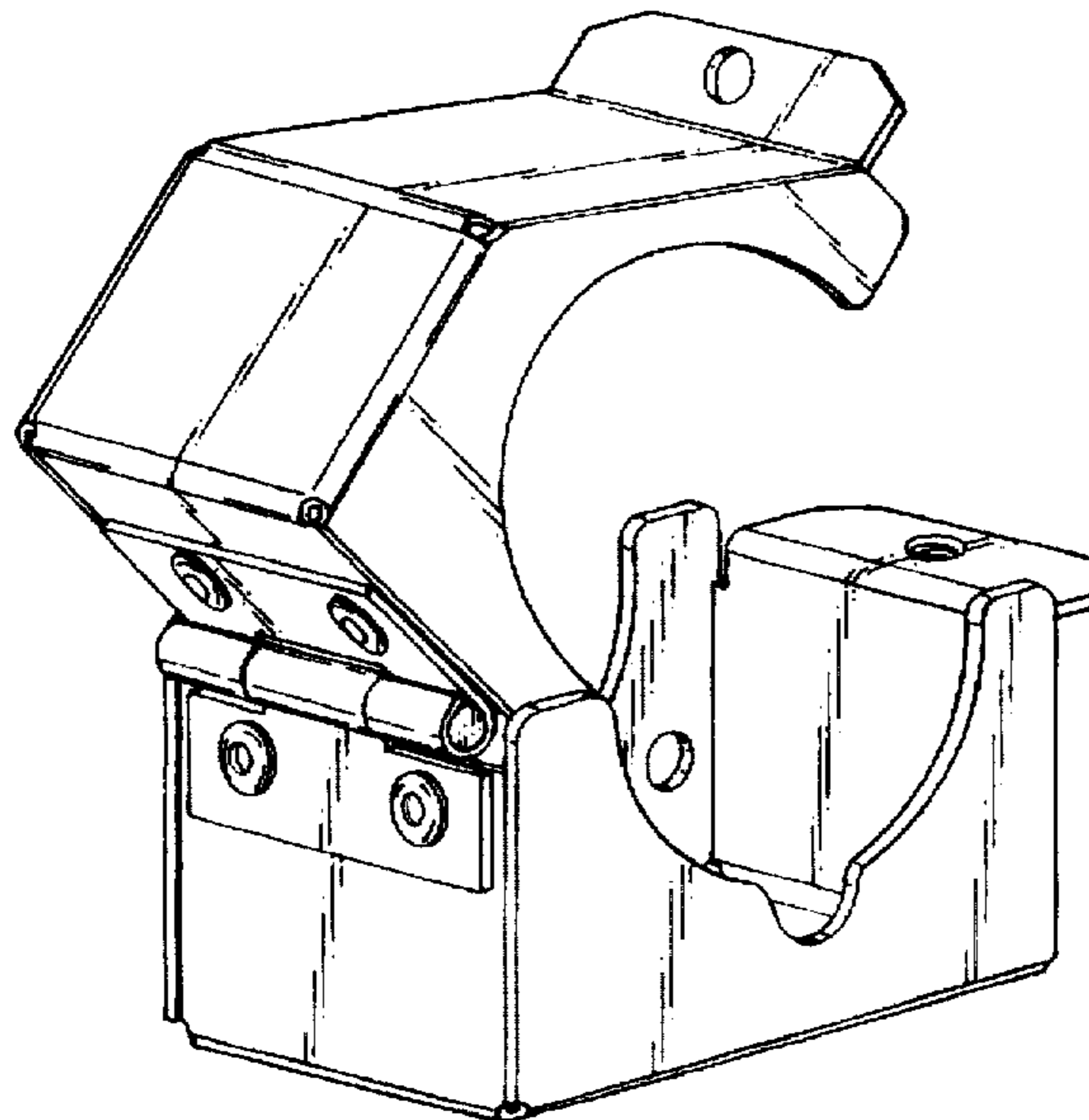
[57] **CLAIM**

The ornamental design for a chassis clamp, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of my new design, in a first, closed position;
FIG. 2 is a front perspective view in a second, open position, shown with the bolt and nut removed for clarity of illustration;
FIG. 3 is a front elevation;
FIG. 4 is a rear elevation;
FIG. 5 is a right side elevation;
FIG. 6 is a left side elevation;
FIG. 7 is a top plan view; and,
FIG. 8 is a bottom plan view.

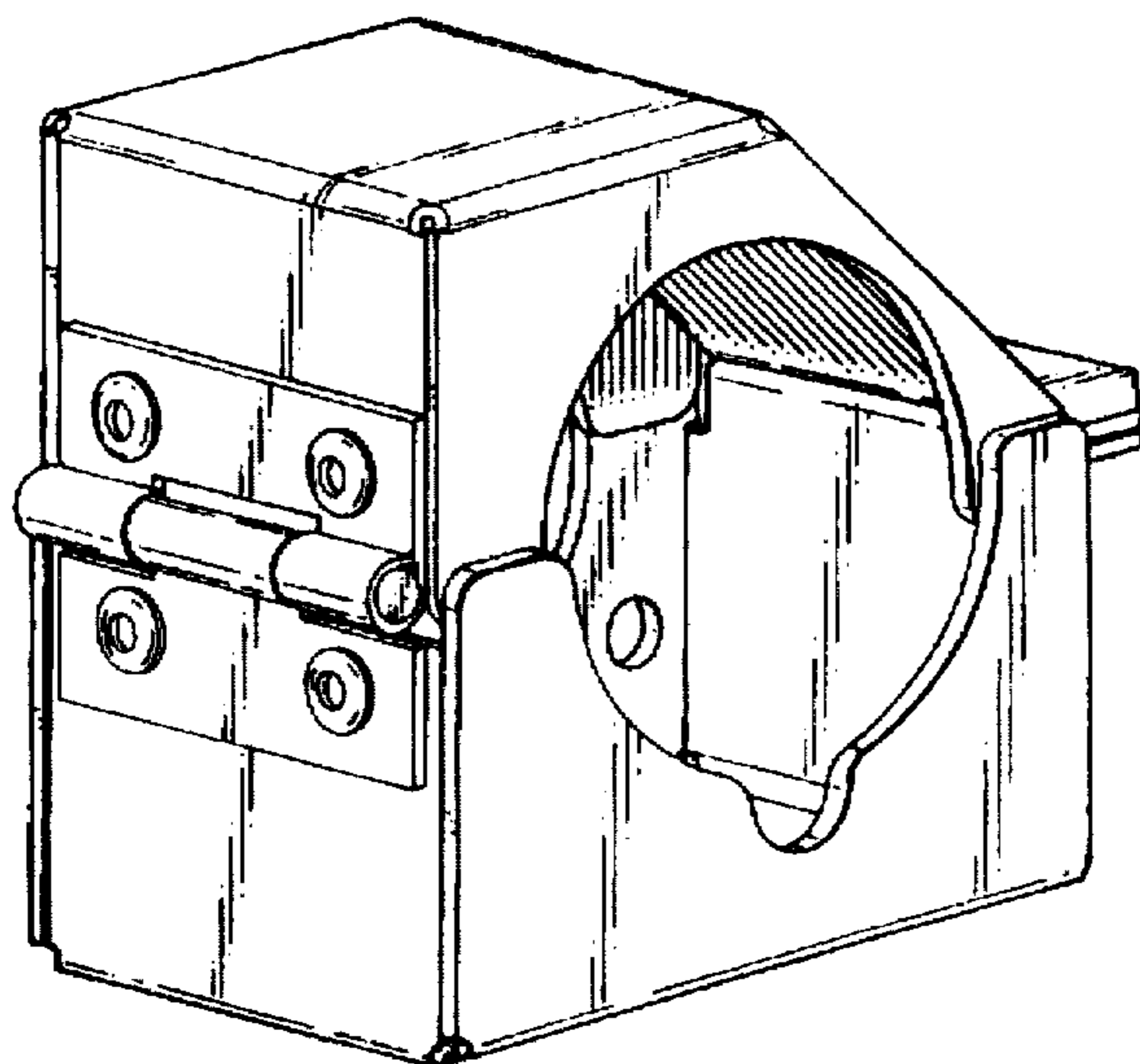

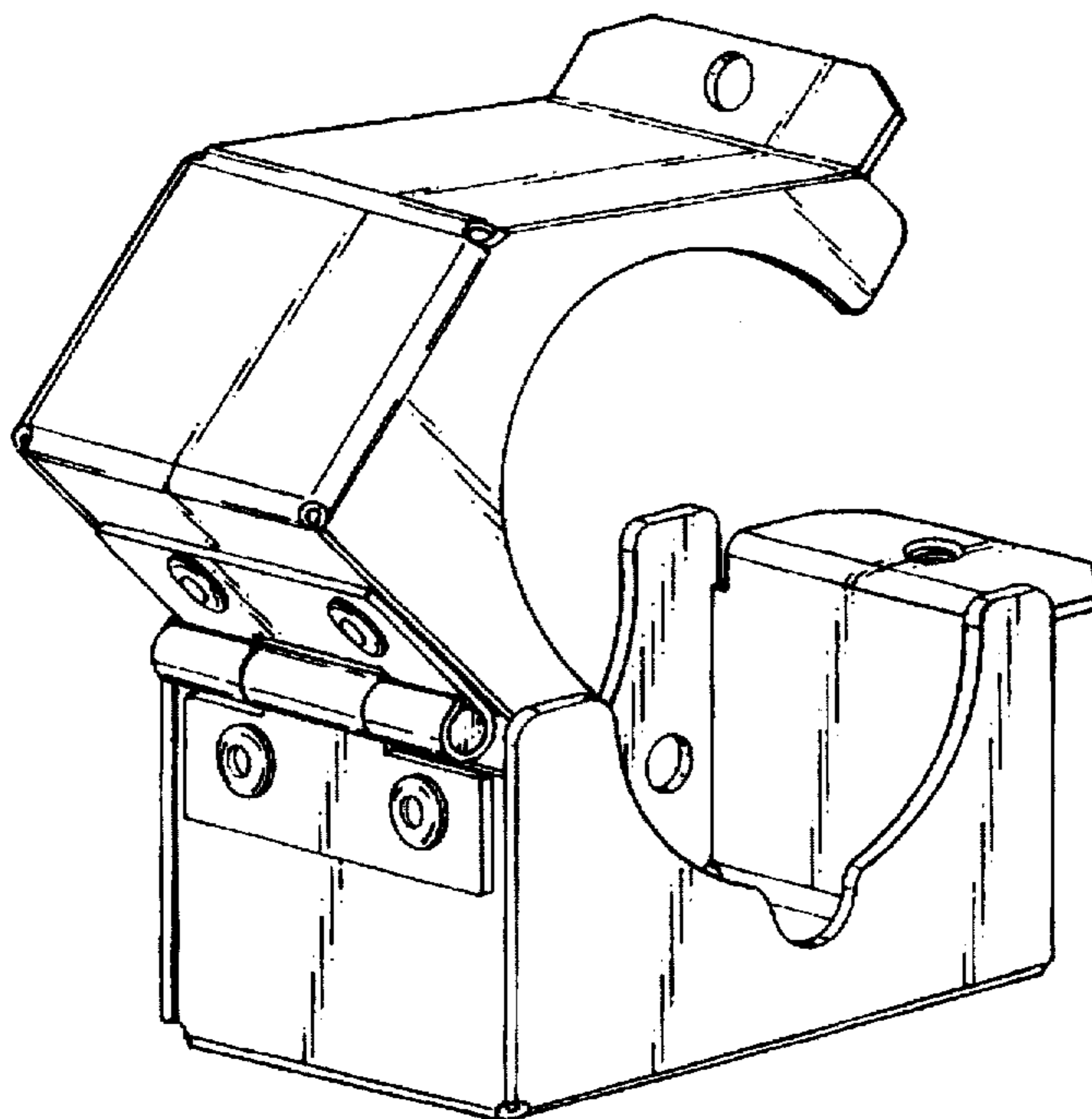

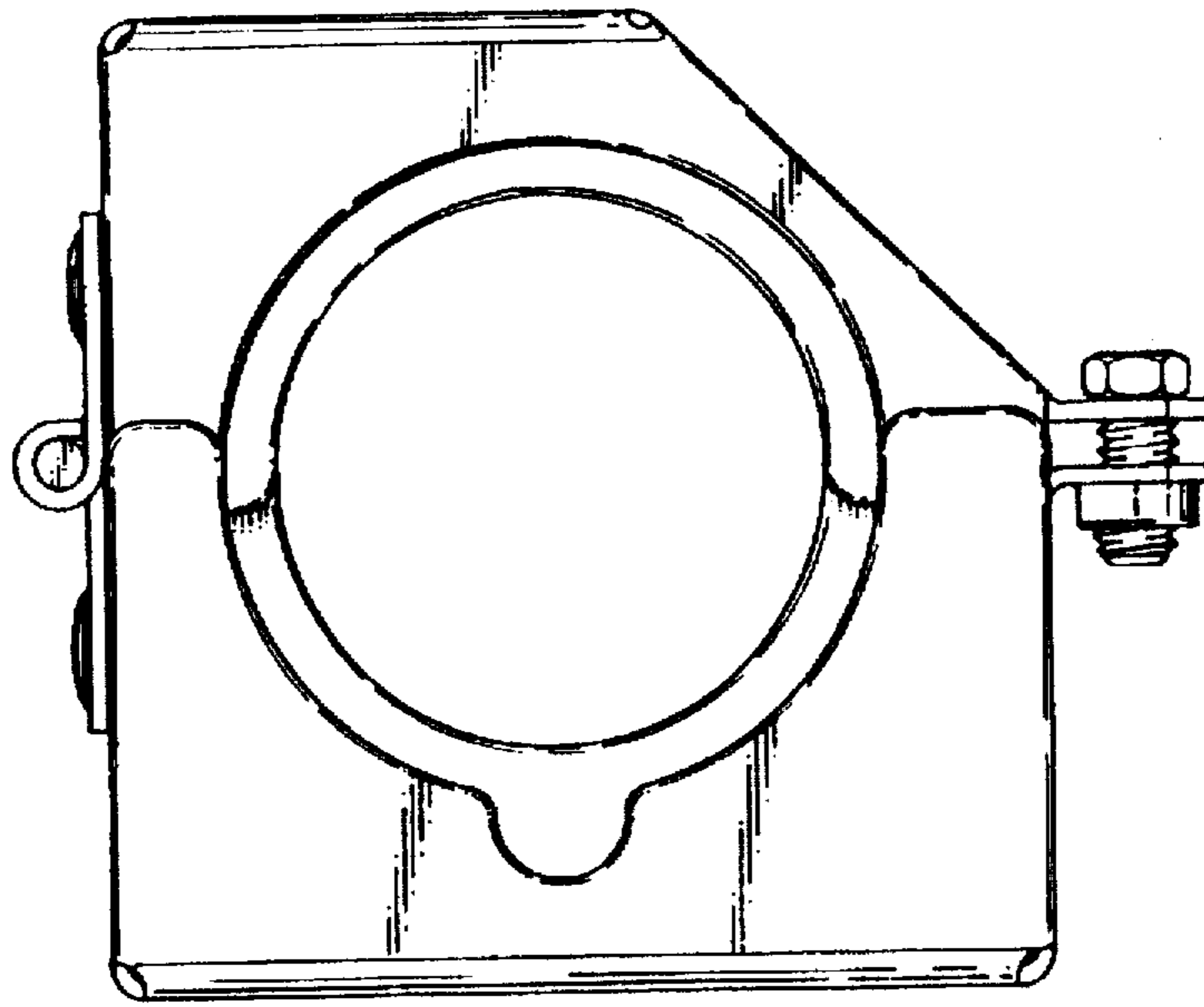

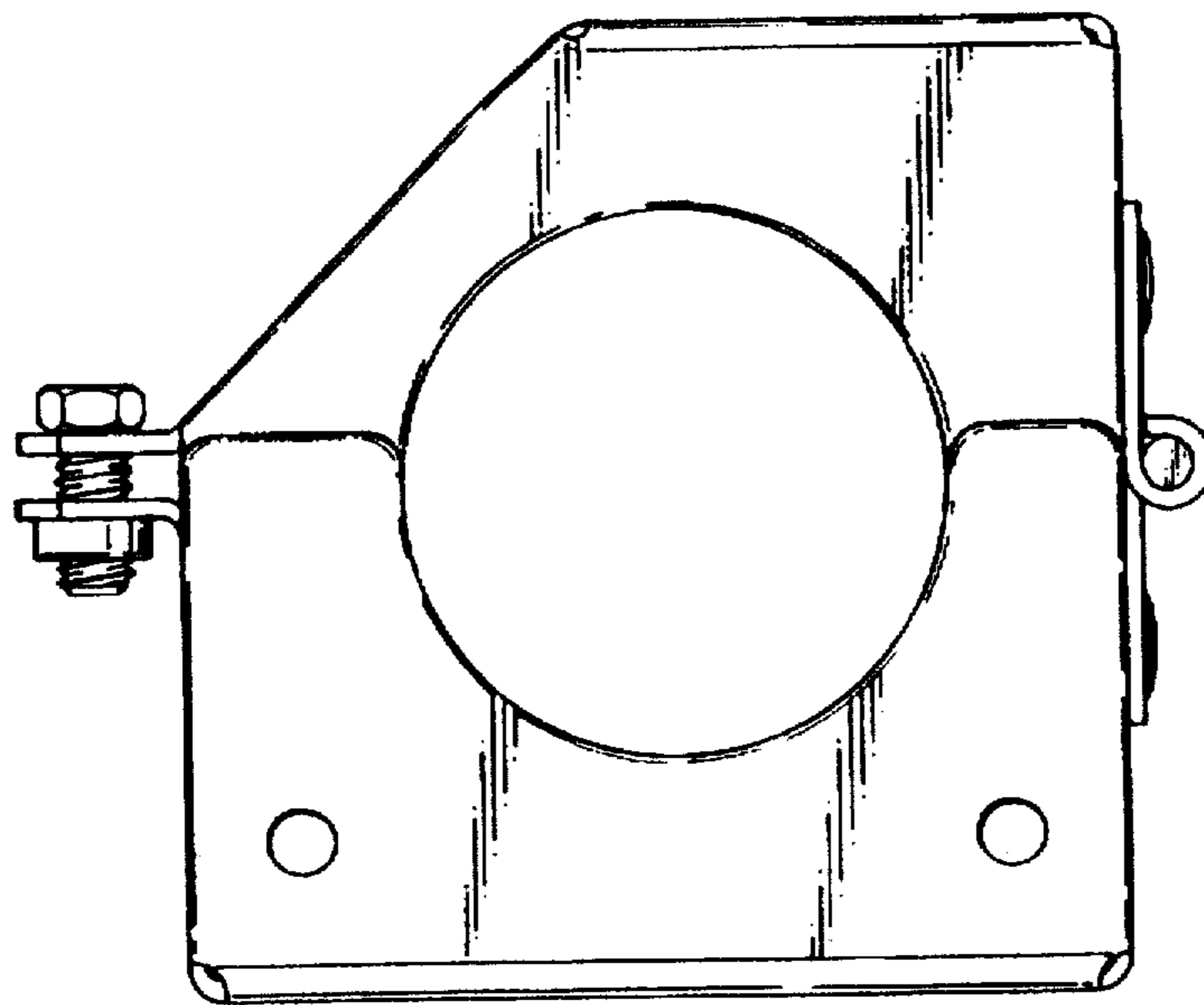

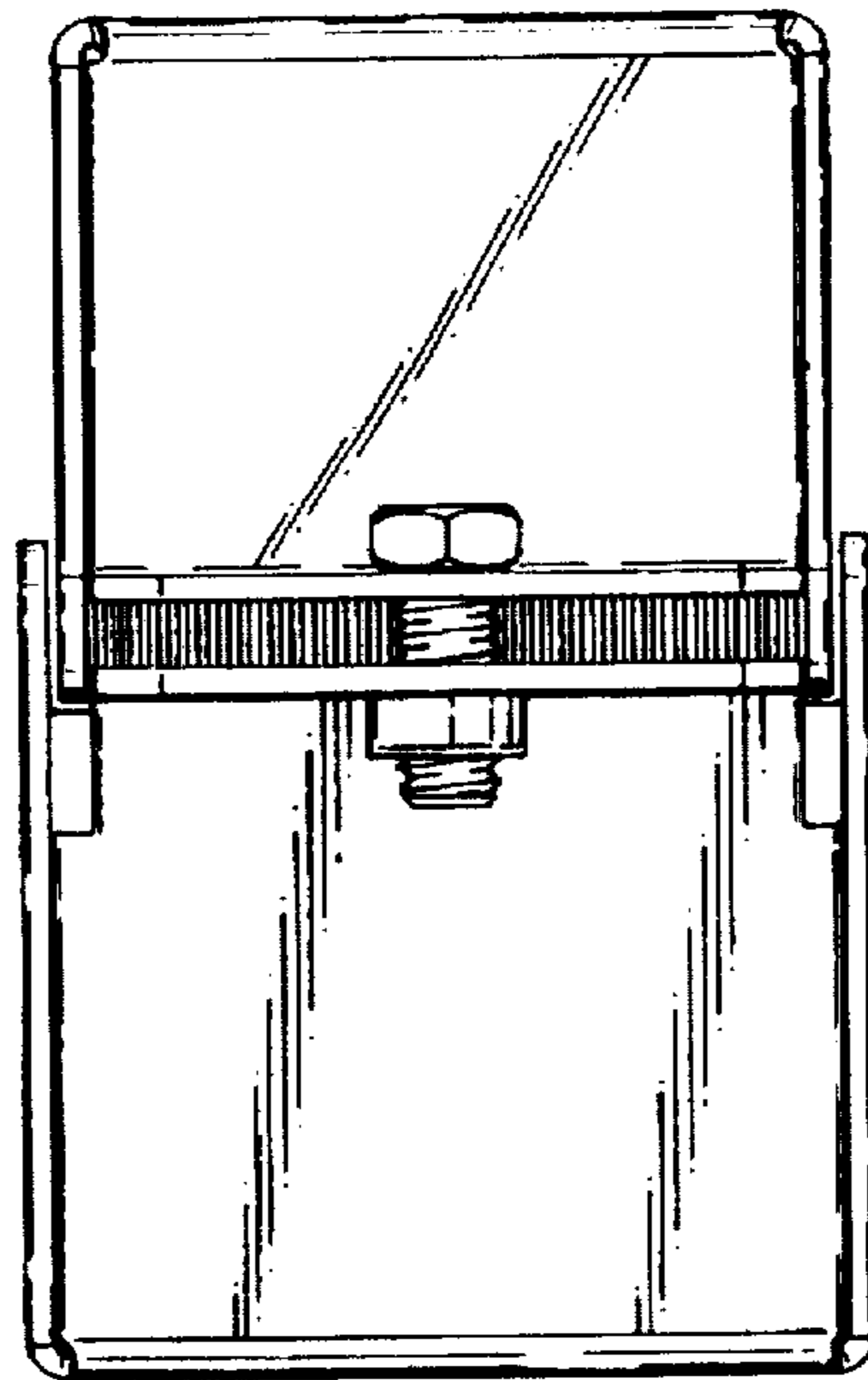

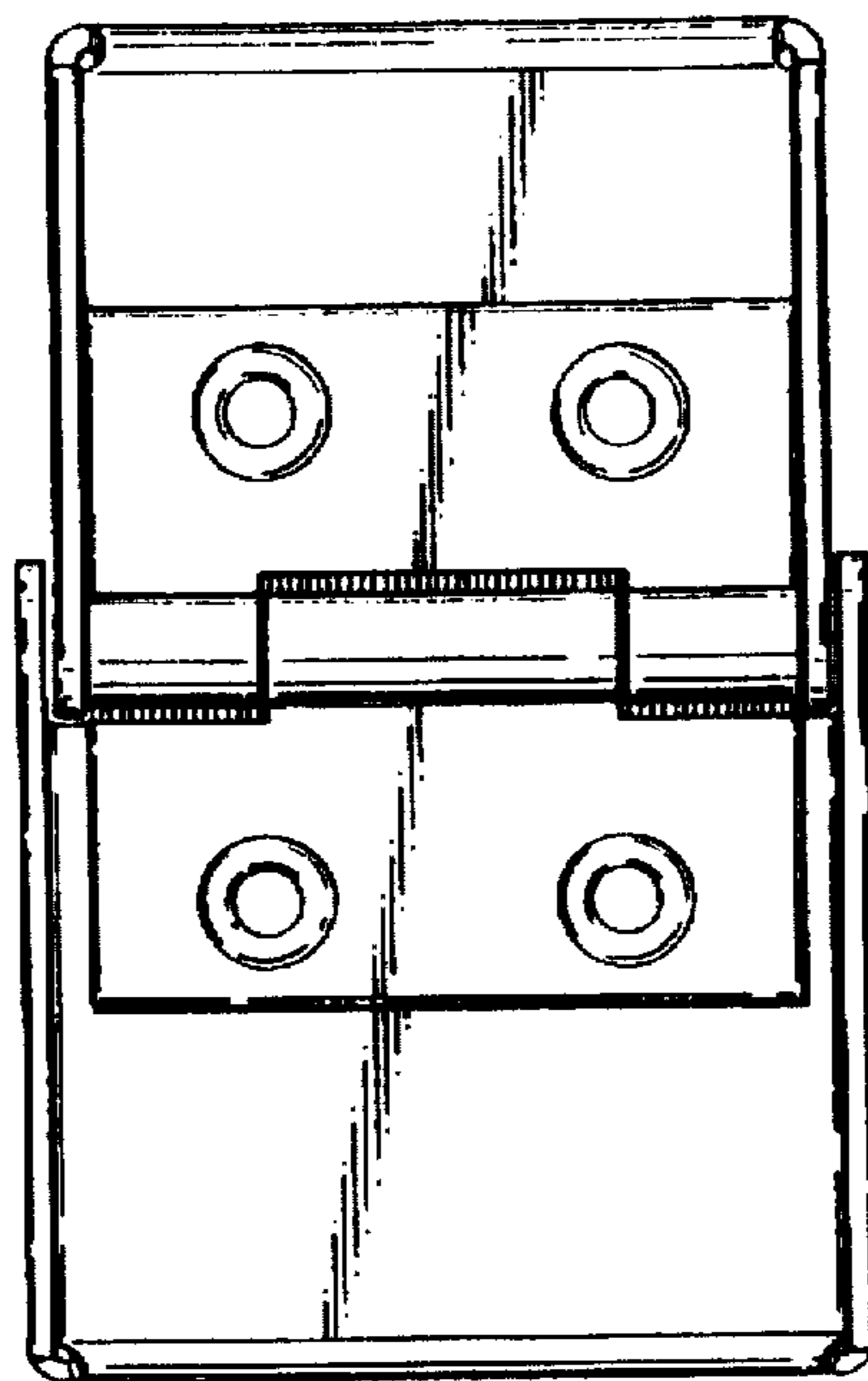

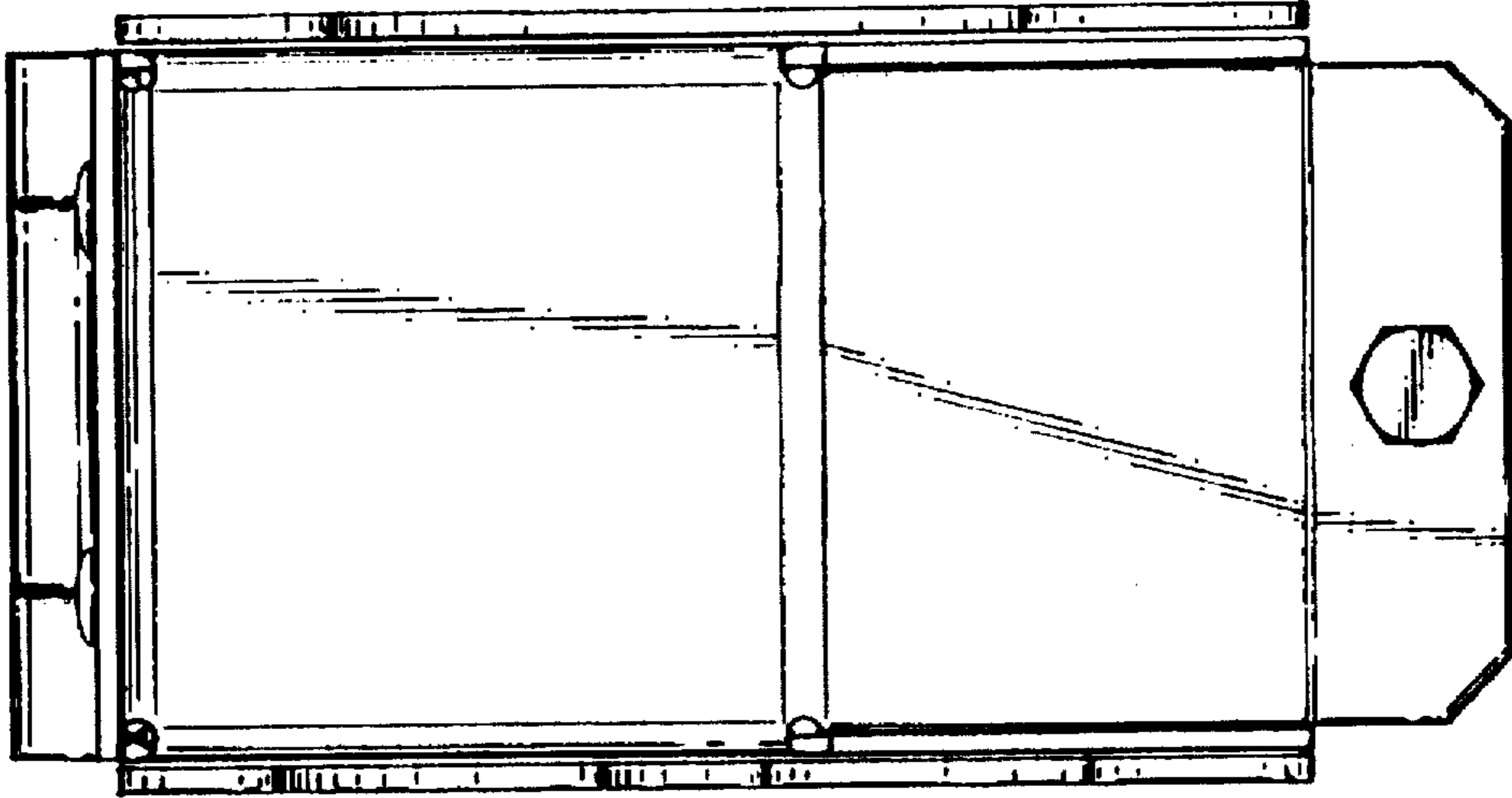

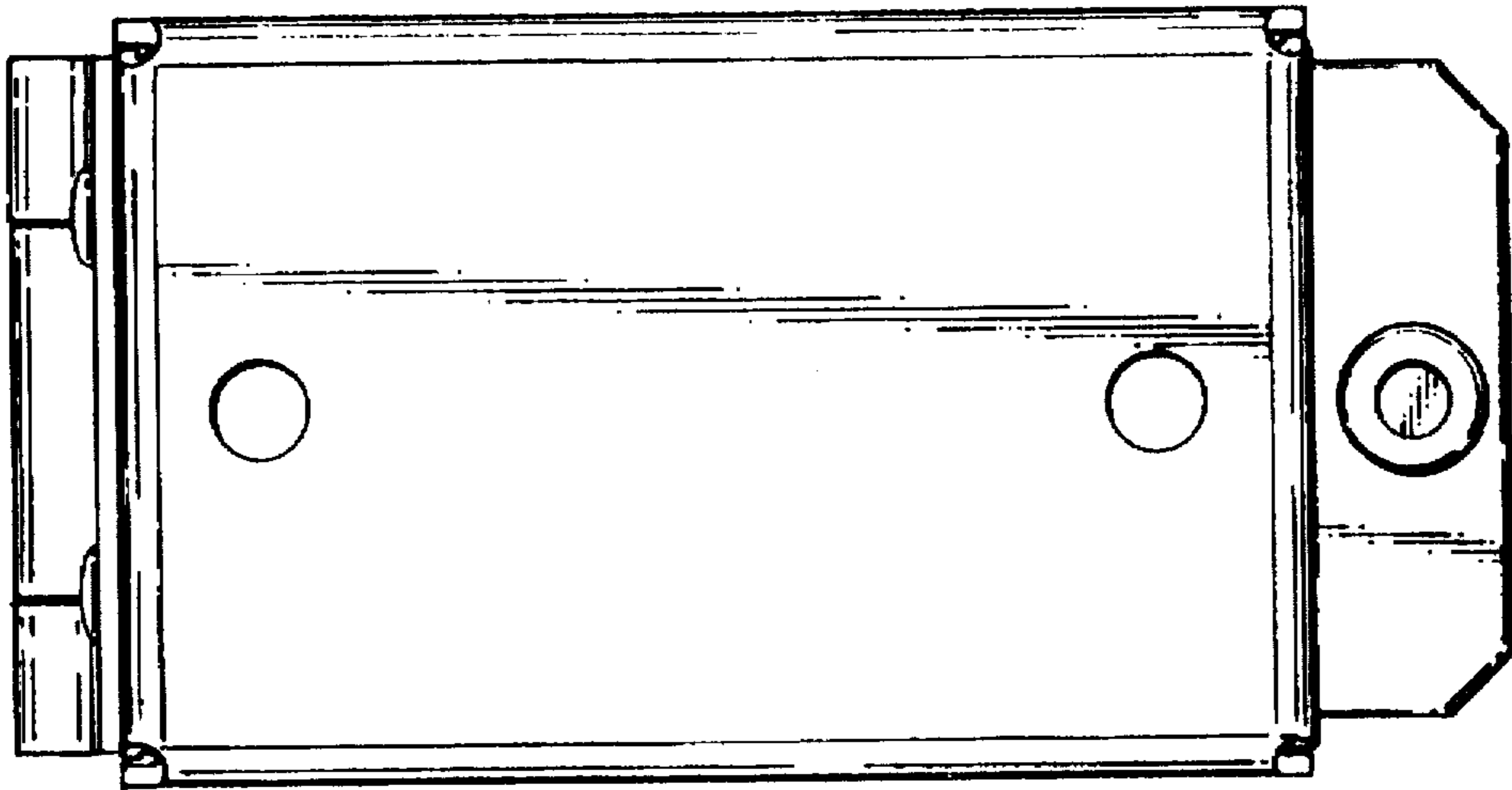
