DESCRIPTION

FIG. 1 is a top and front perspective view of a telephone showing my new design;

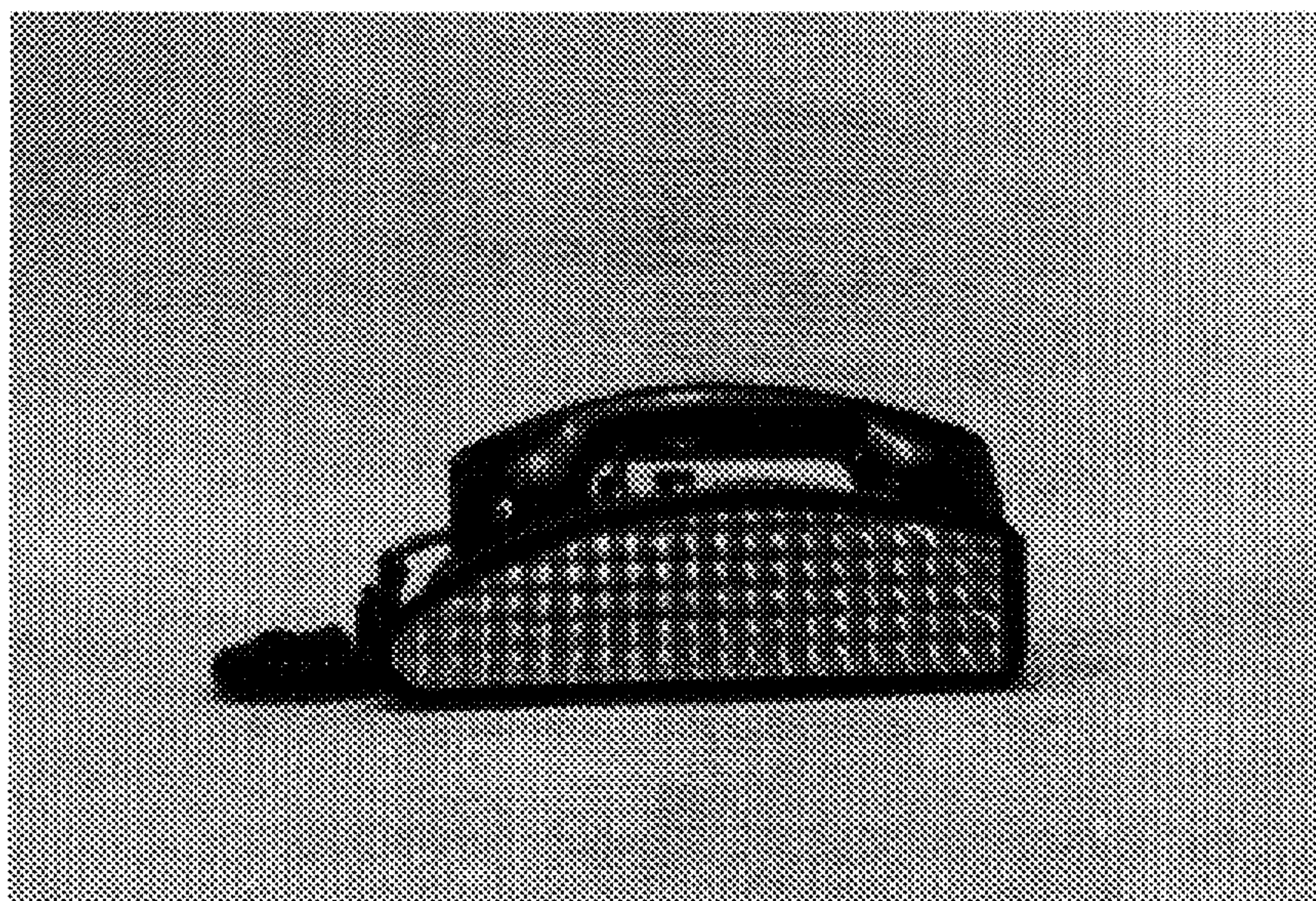

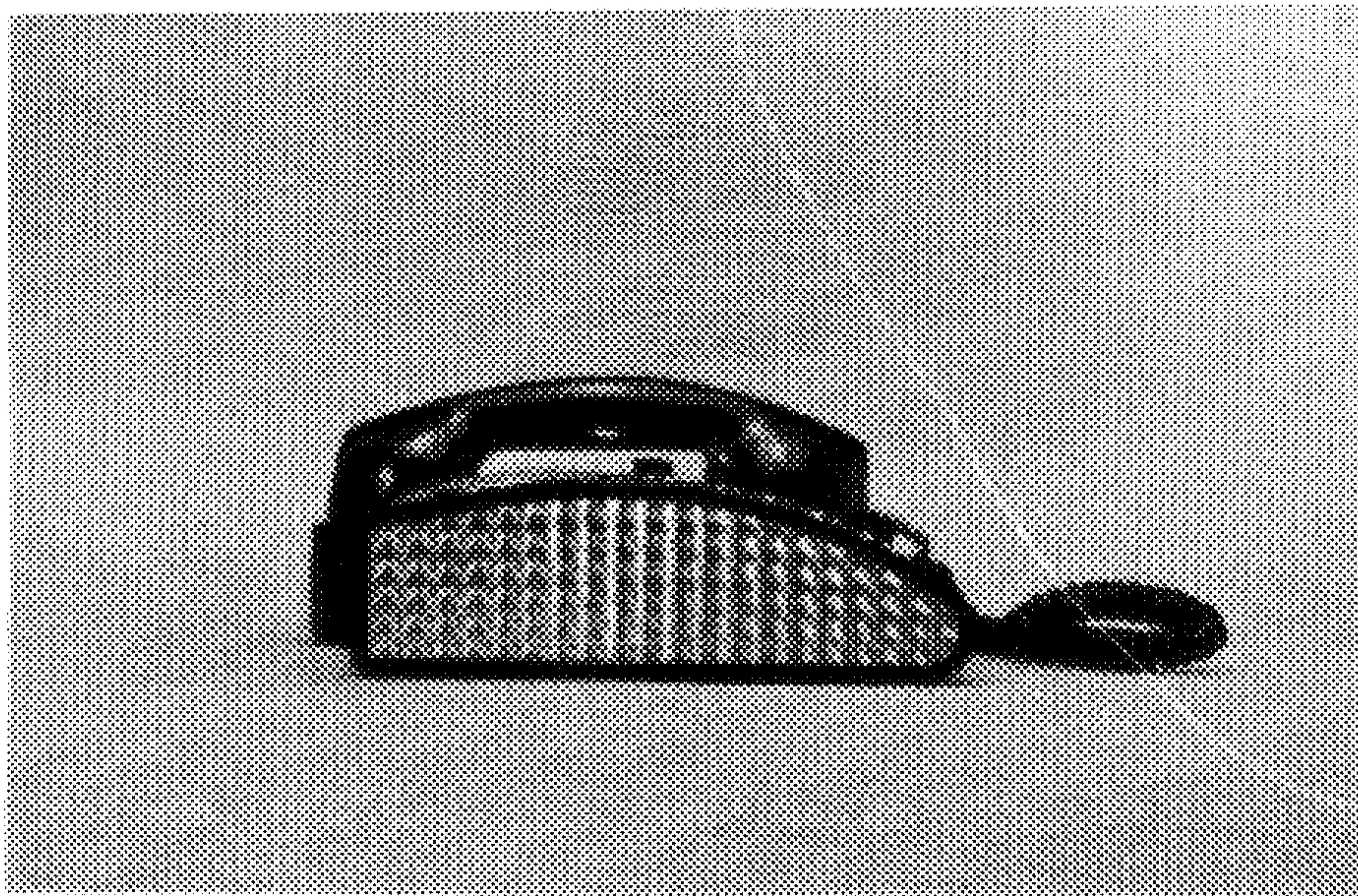

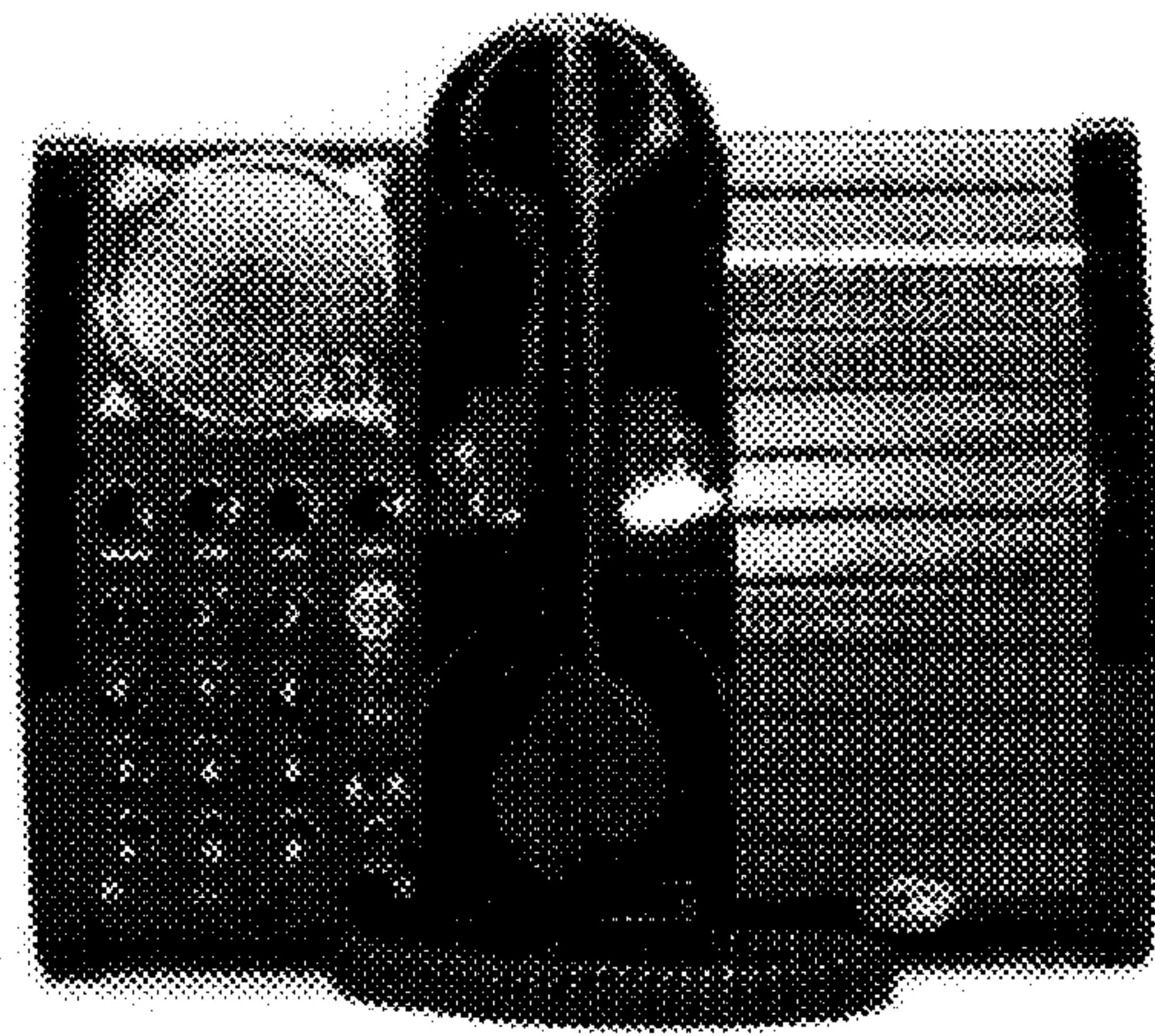

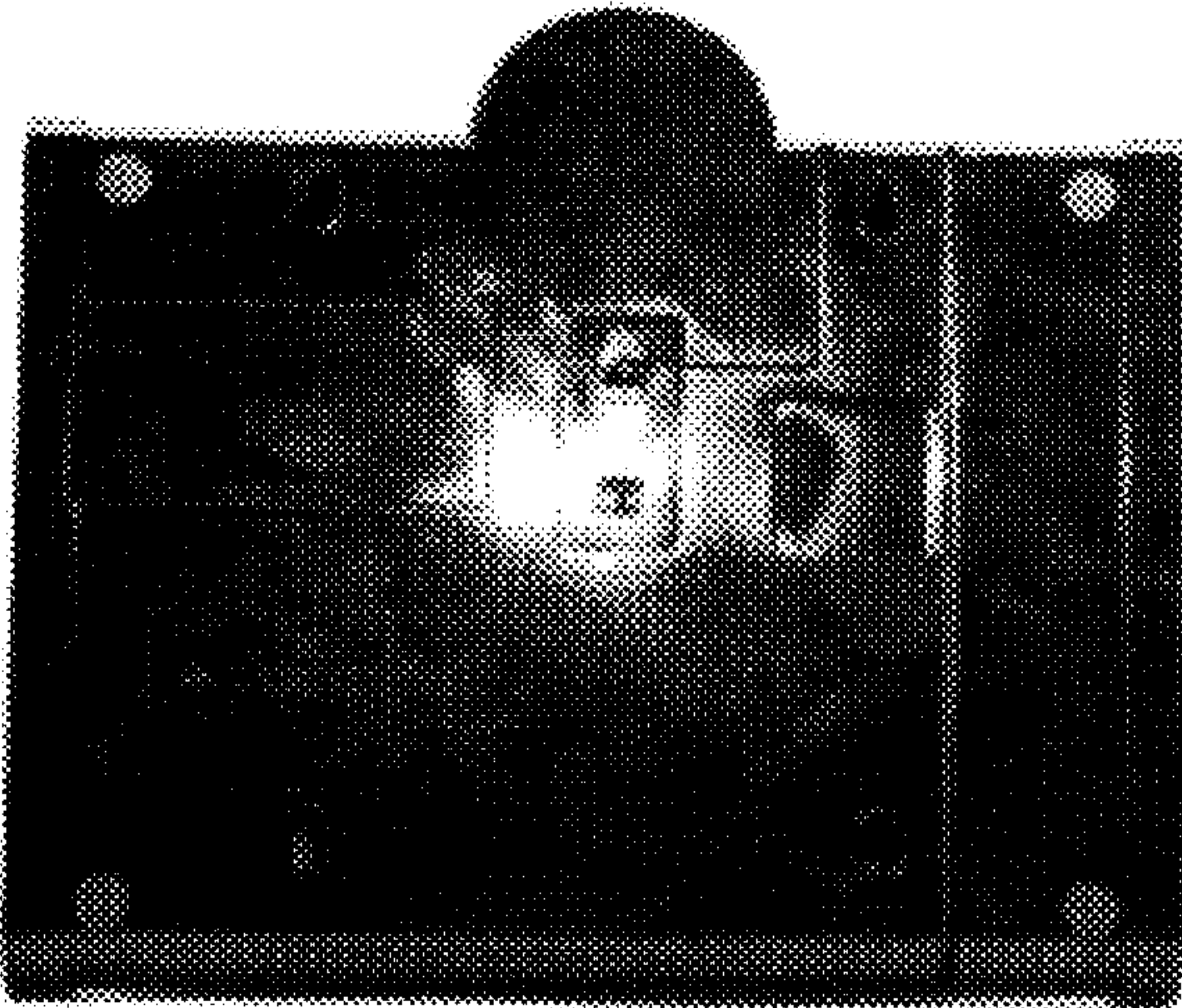

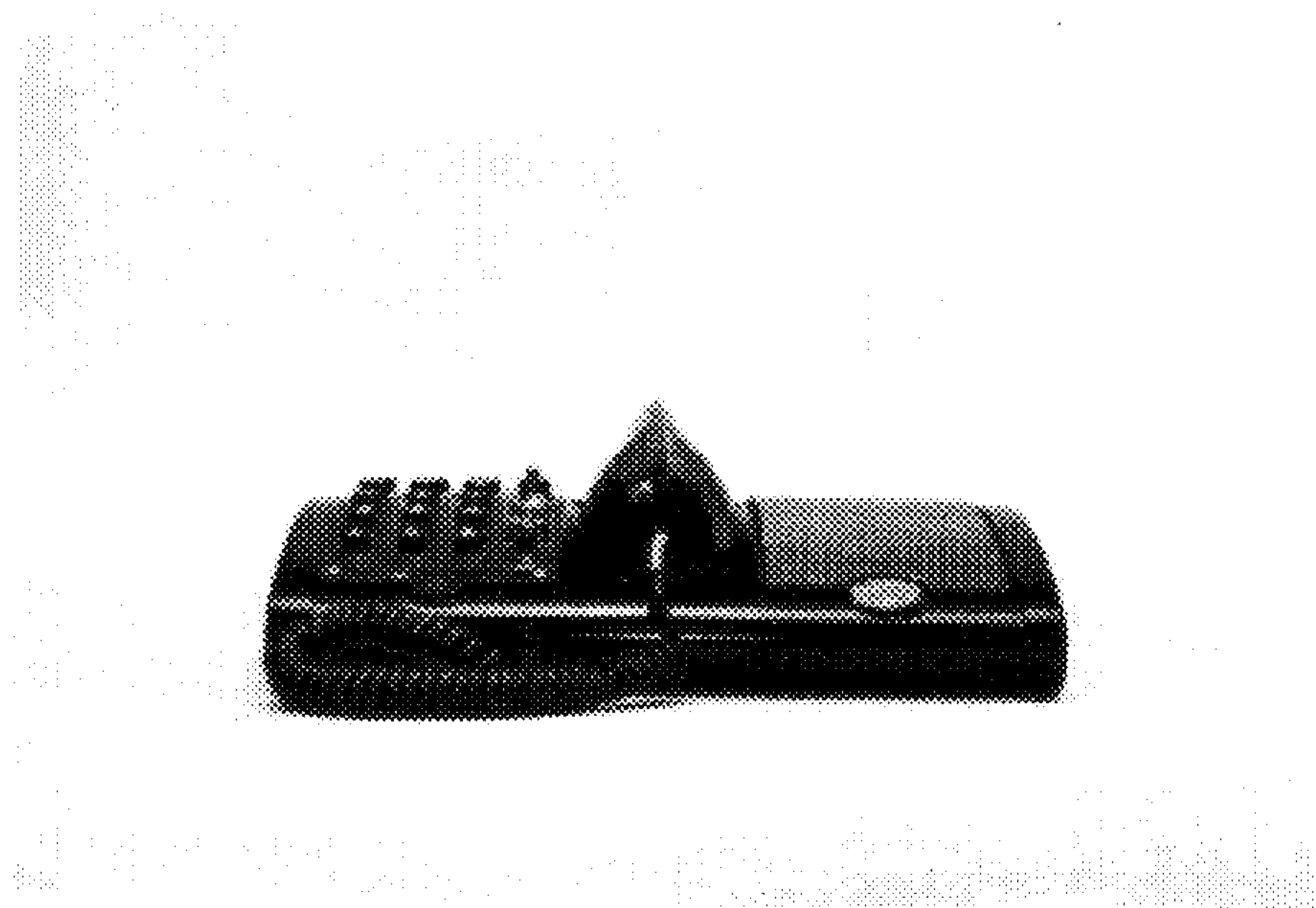
