[57] **CLAIM**

The ornamental design for a disc player combined with a radio tuner and an amplifier, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a disc player combined with a radio tuner and an amplifier showing my new design;

FIG. 2 is a perspective view thereof wherein the lid portion is in the open position;

FIG. 3 is a top plan view of FIG. 1;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a front elevational view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a right side elevational view thereof;

FIG. 8 is a rear elevational view thereof;

FIG. 9 is a perspective view of a second embodiment of a disc player combined with a radio tuner and an amplifier showing my new design;

FIG. 10 is a perspective view of the embodiment of FIG. 9 wherein the lid portion is in the open position;

FIG. 11 is a top plan view of the embodiment of FIG. 9;

FIG. 12 is a left side elevational view of the embodiment of FIG. 9;

FIG. 13 is a front elevational view of the embodiment of FIG. 9;

FIG. 14 is a bottom plan view of the embodiment of FIG. 9;

FIG. 15 is a right side elevational view of the embodiment of FIG. 9; and,

FIG. 16 is a rear elevational view of the embodiment of FIG. 9.

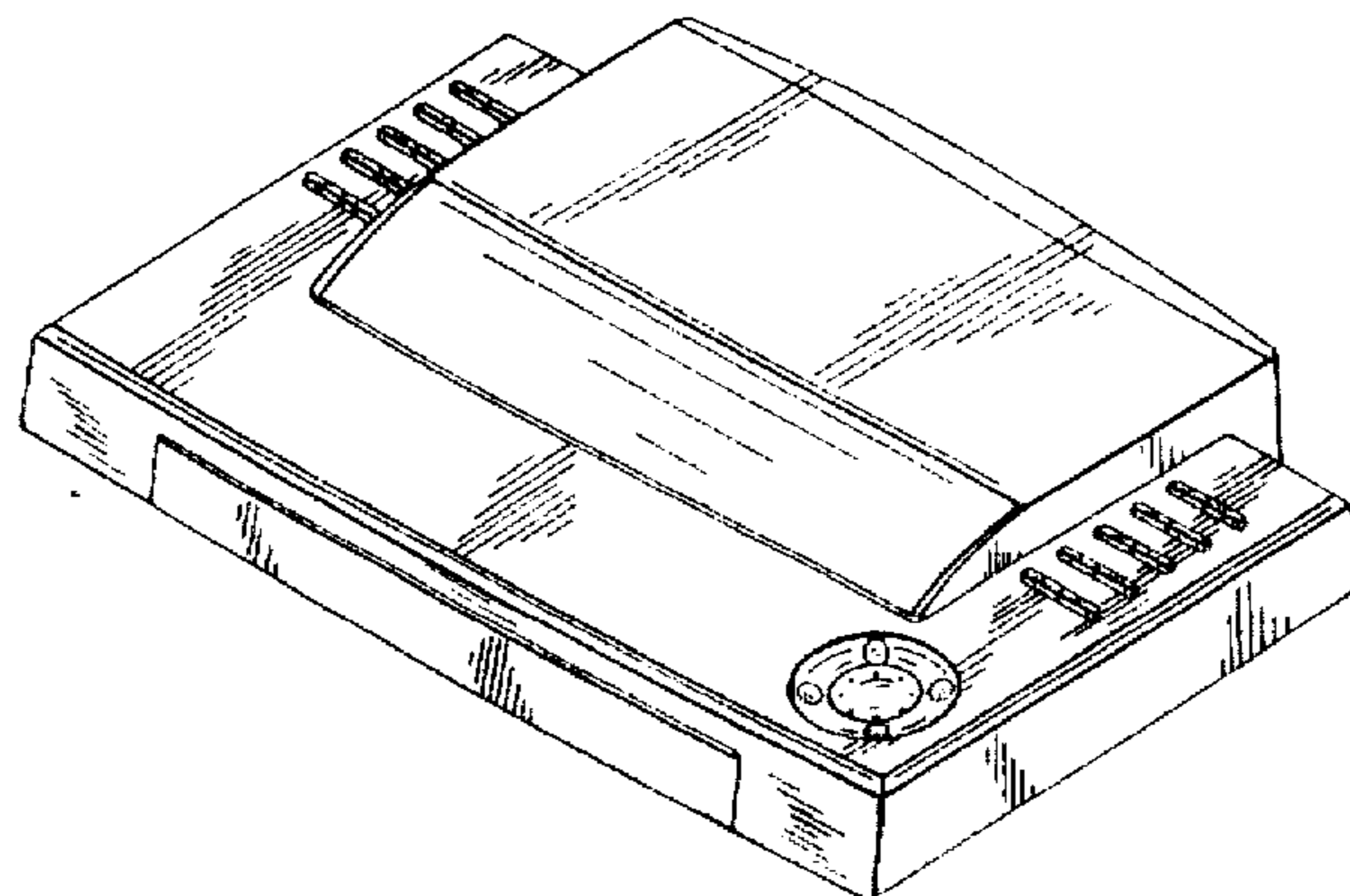
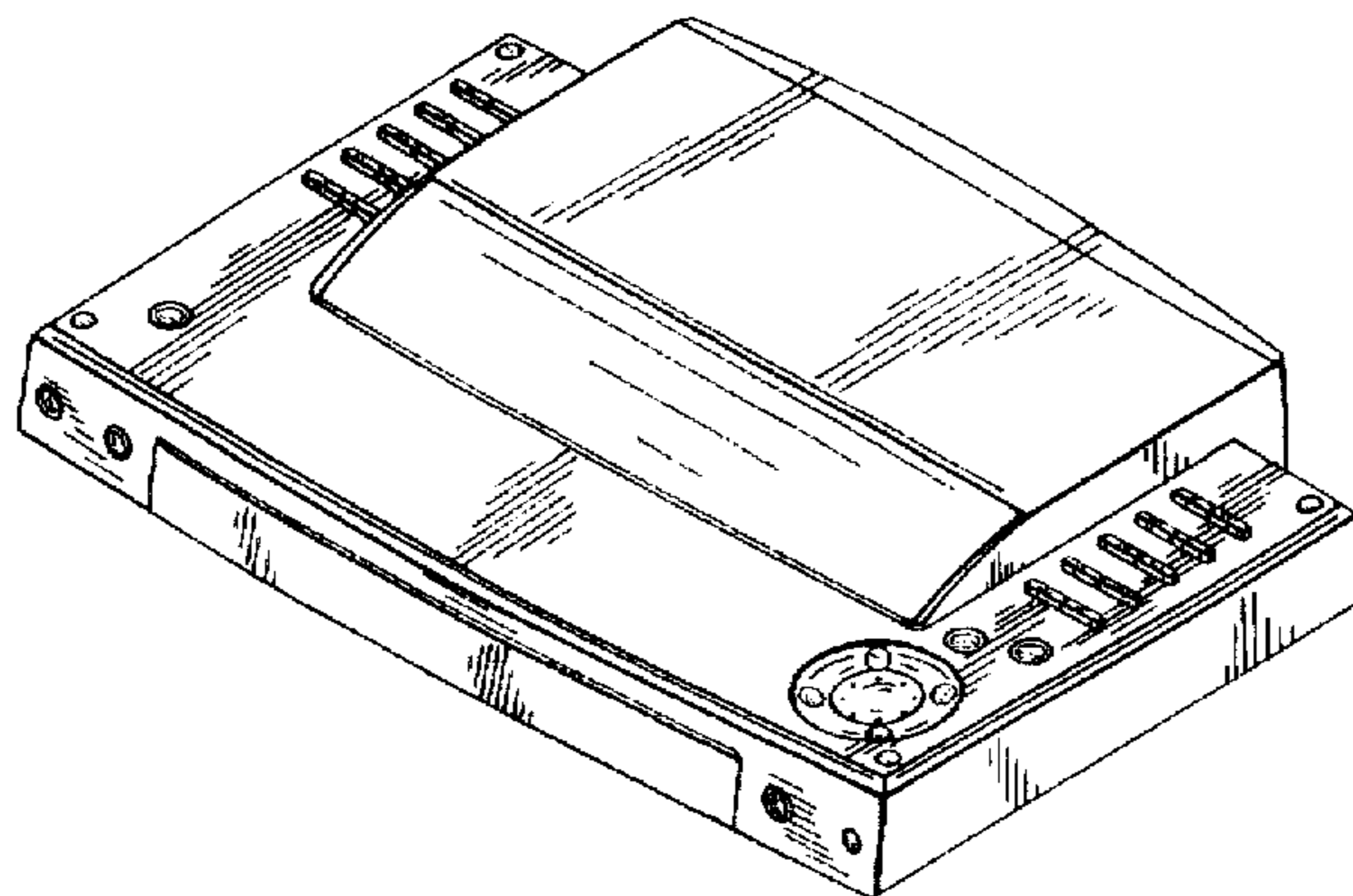

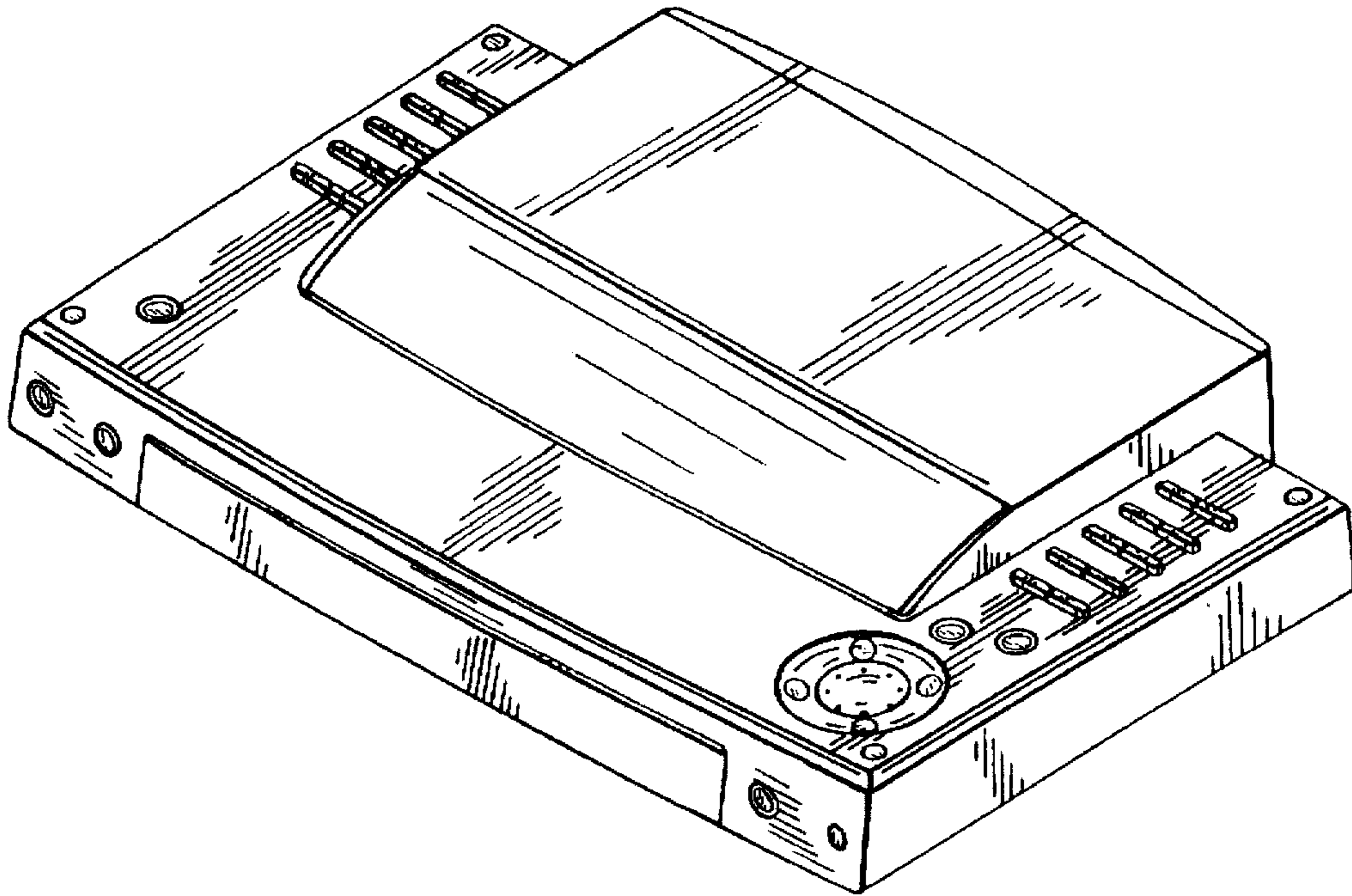

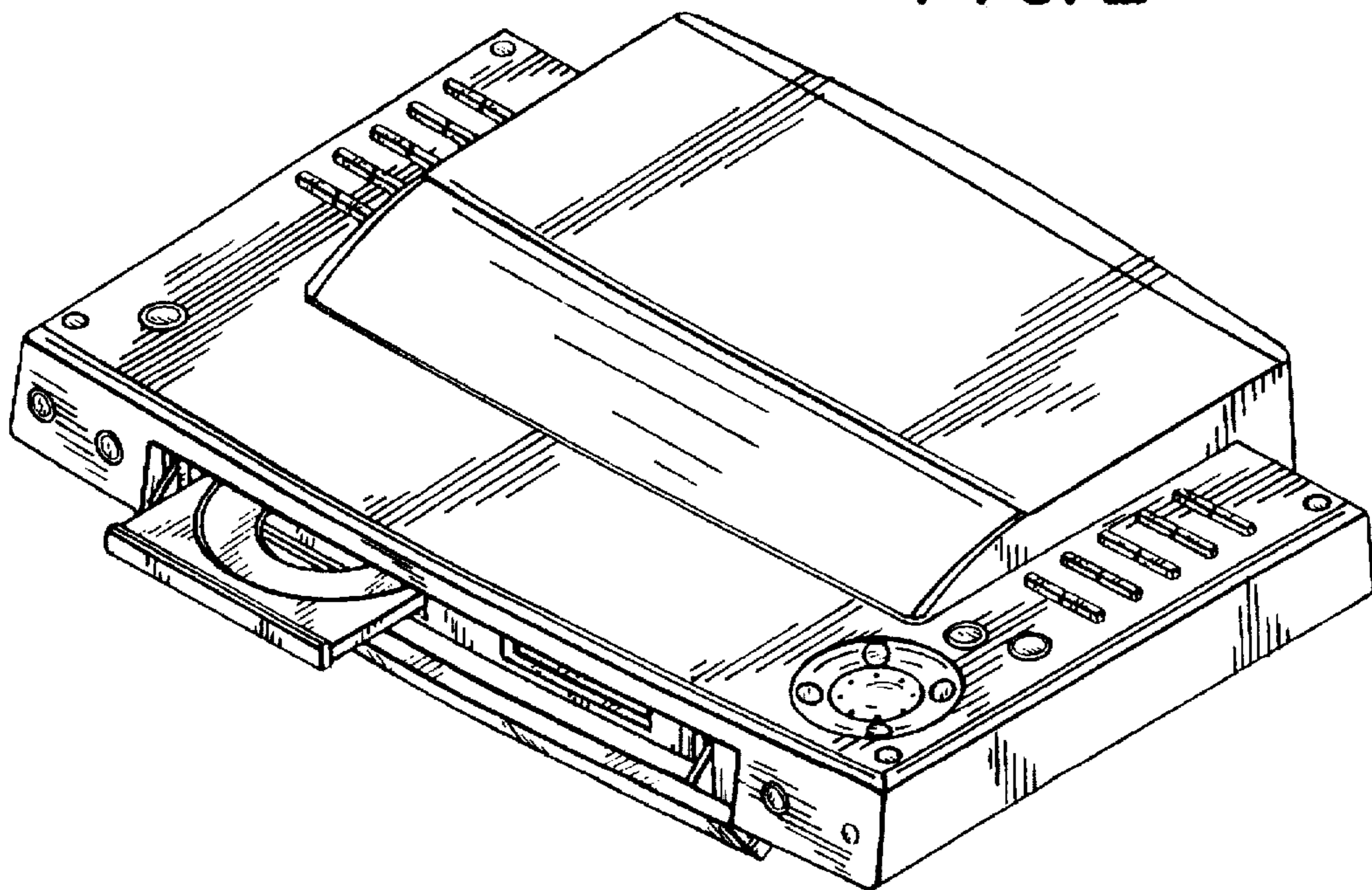

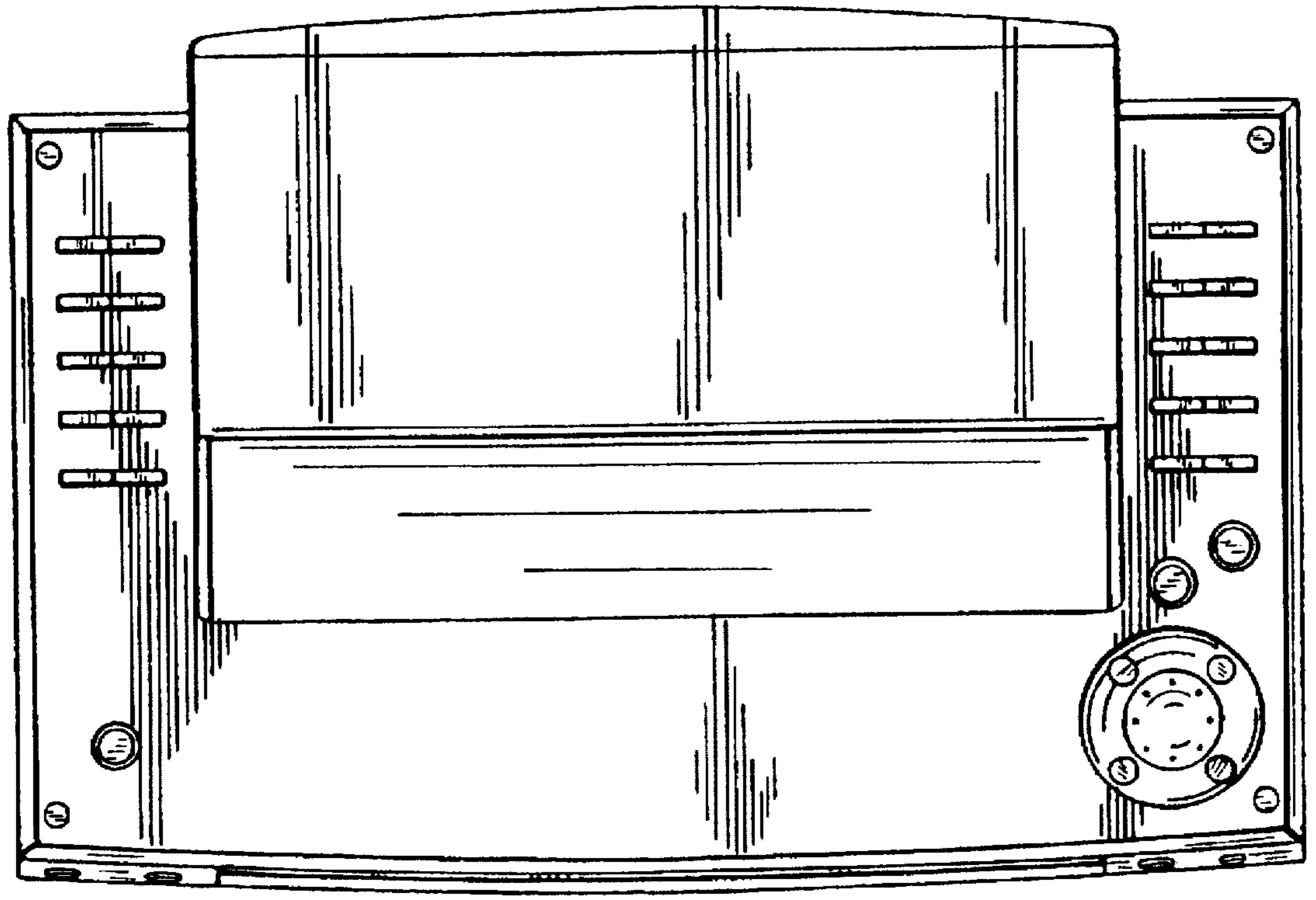

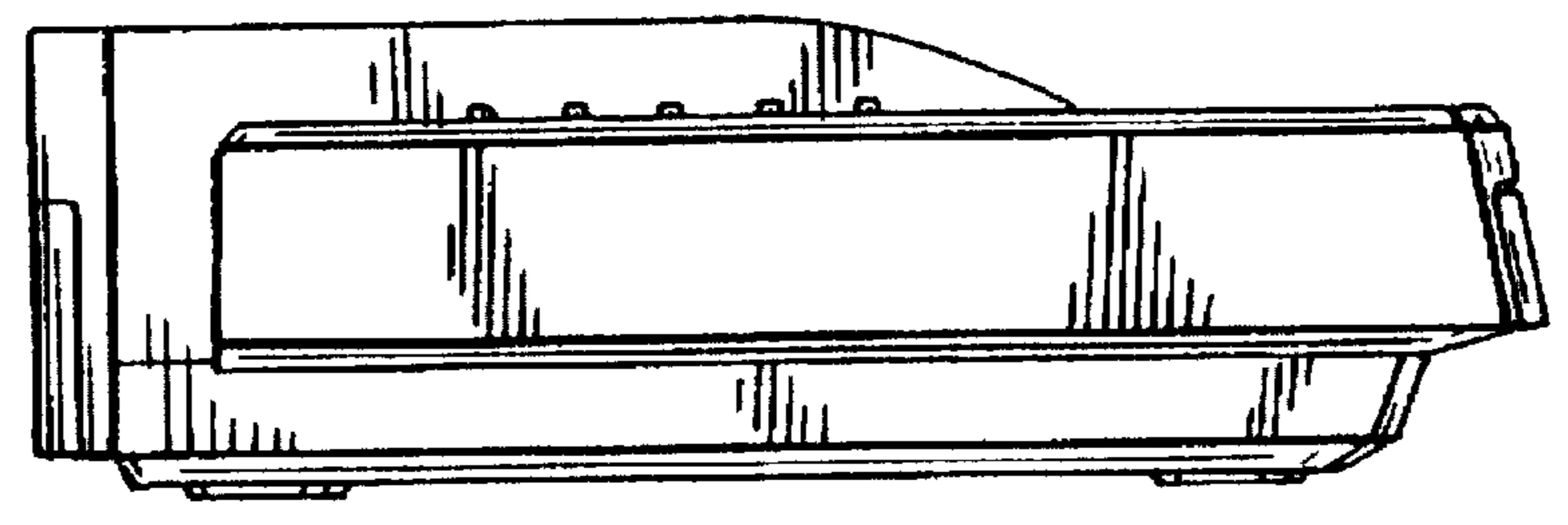

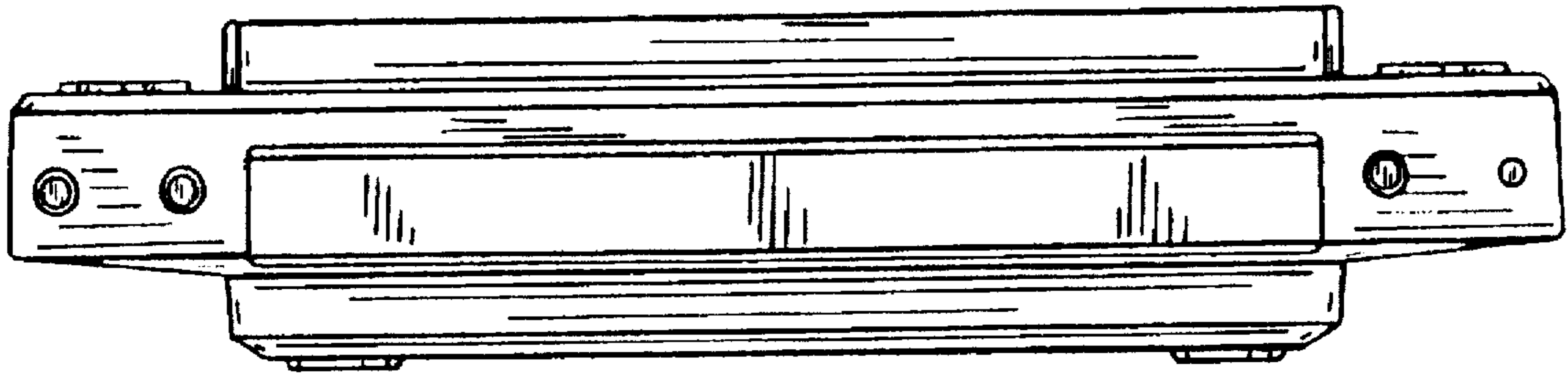

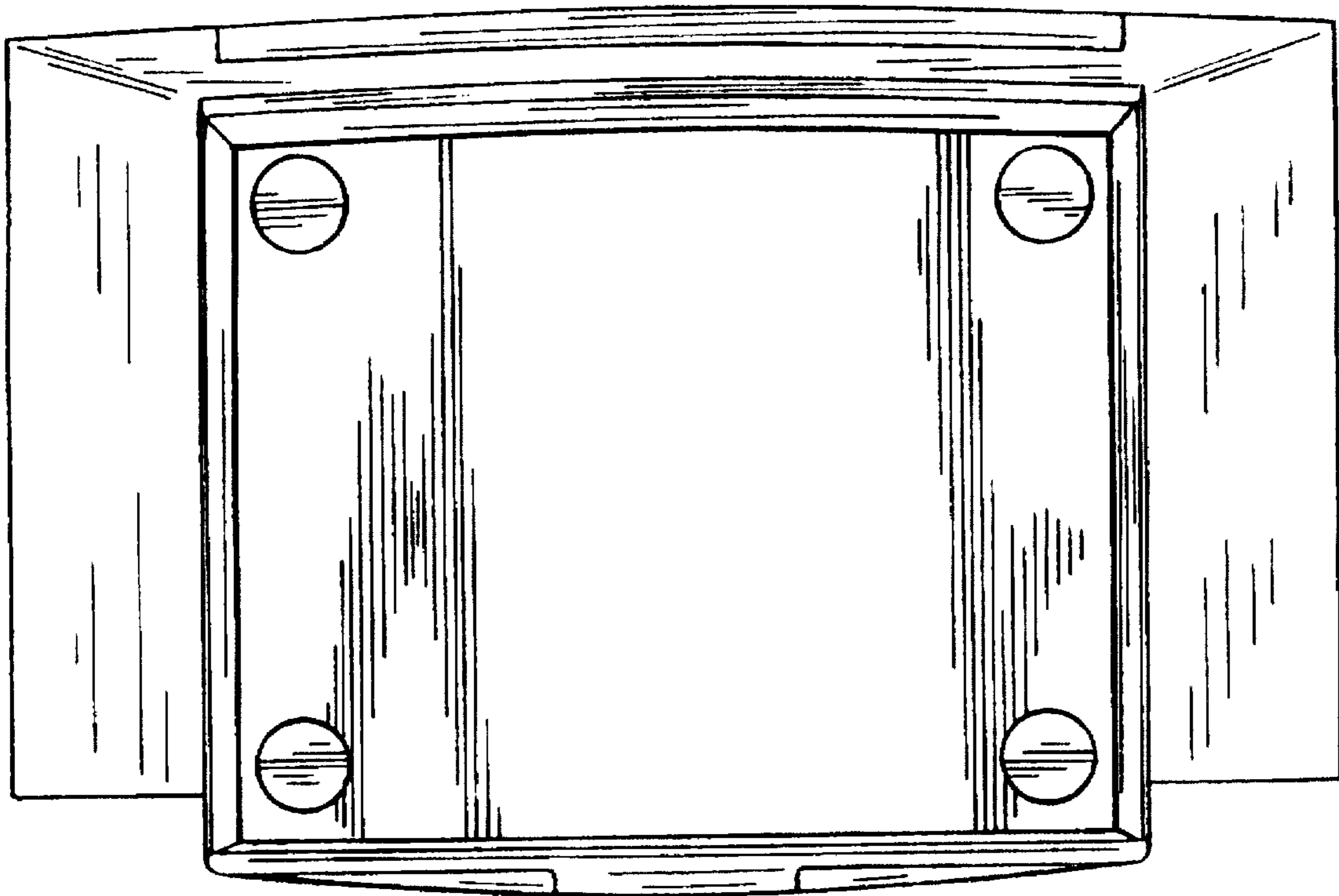

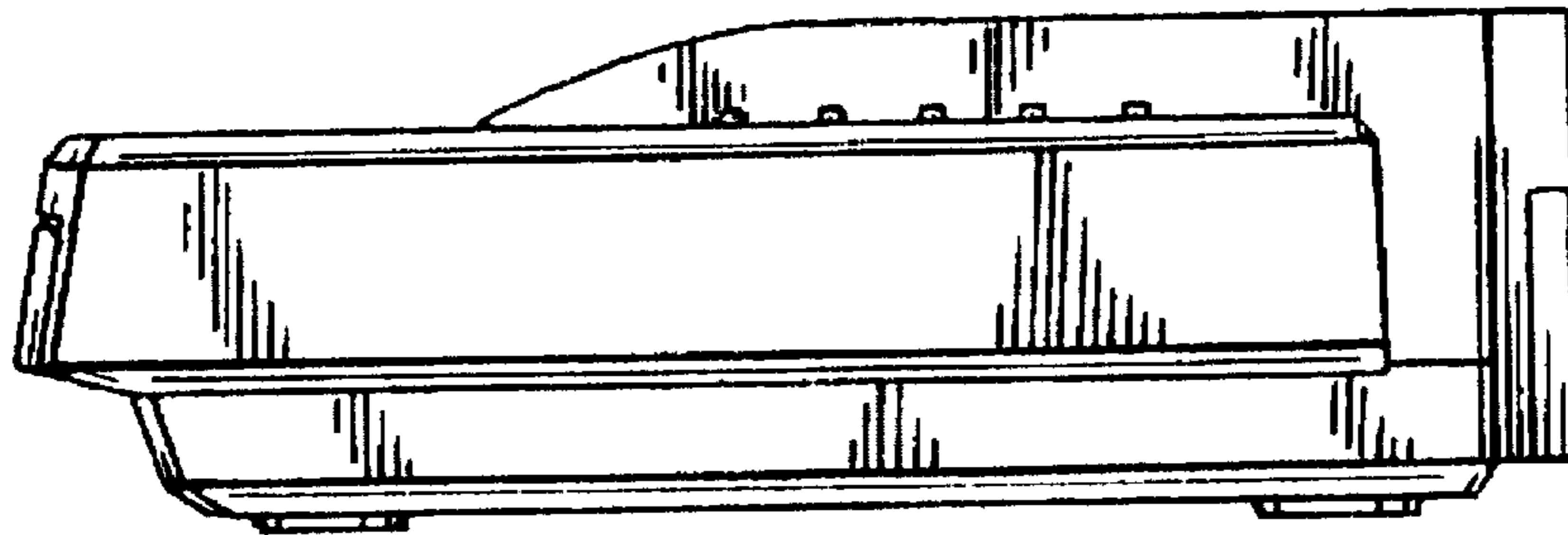

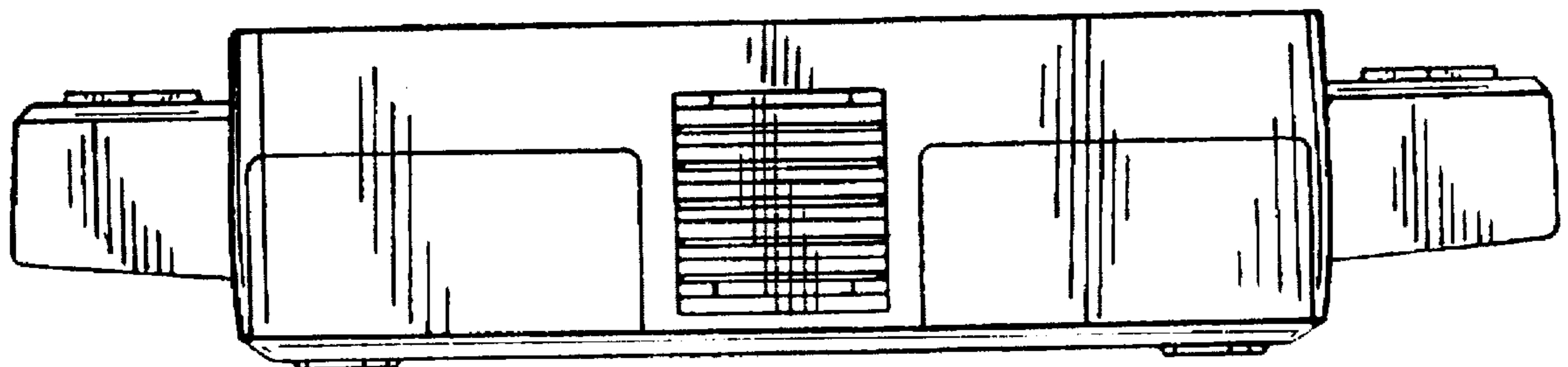

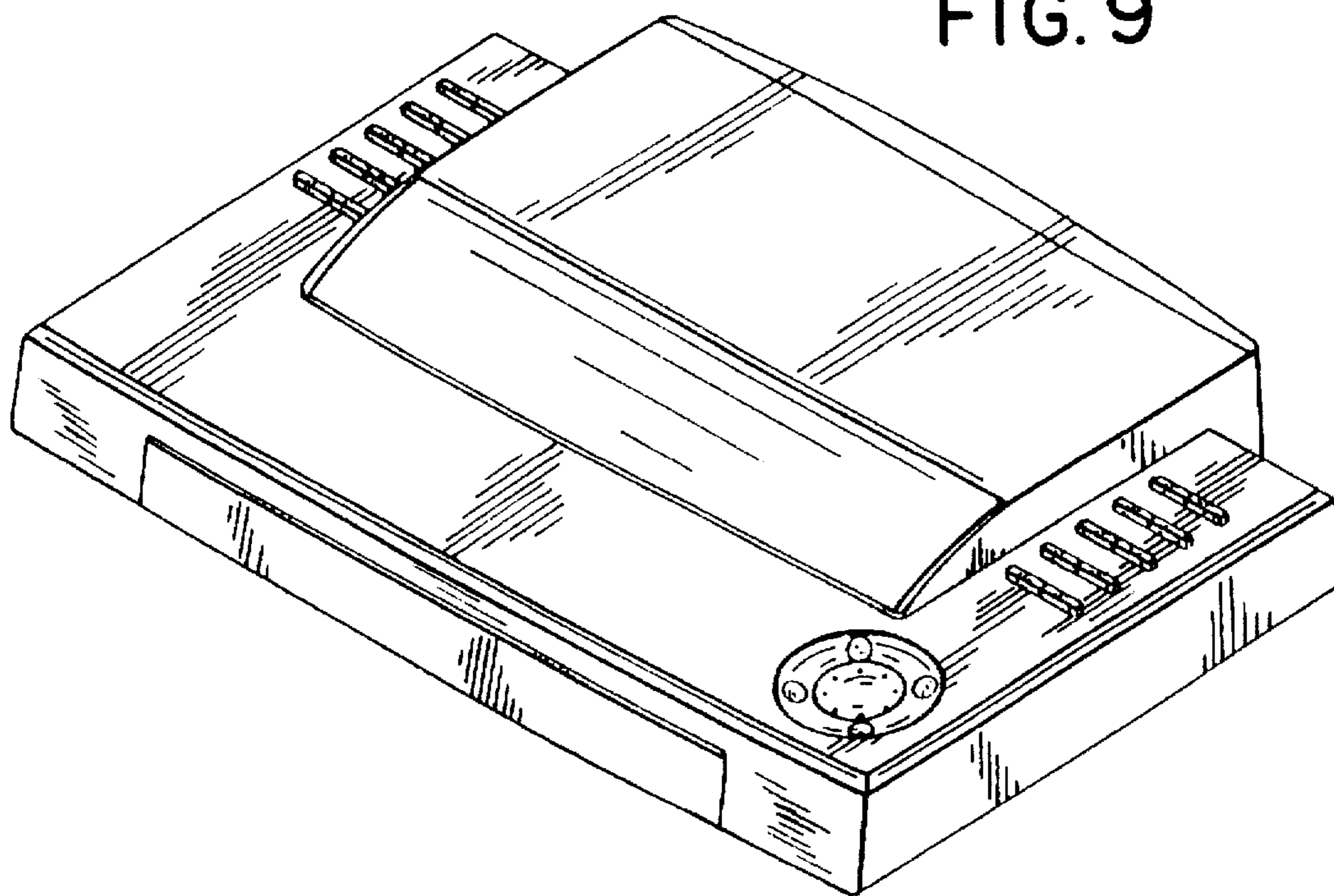

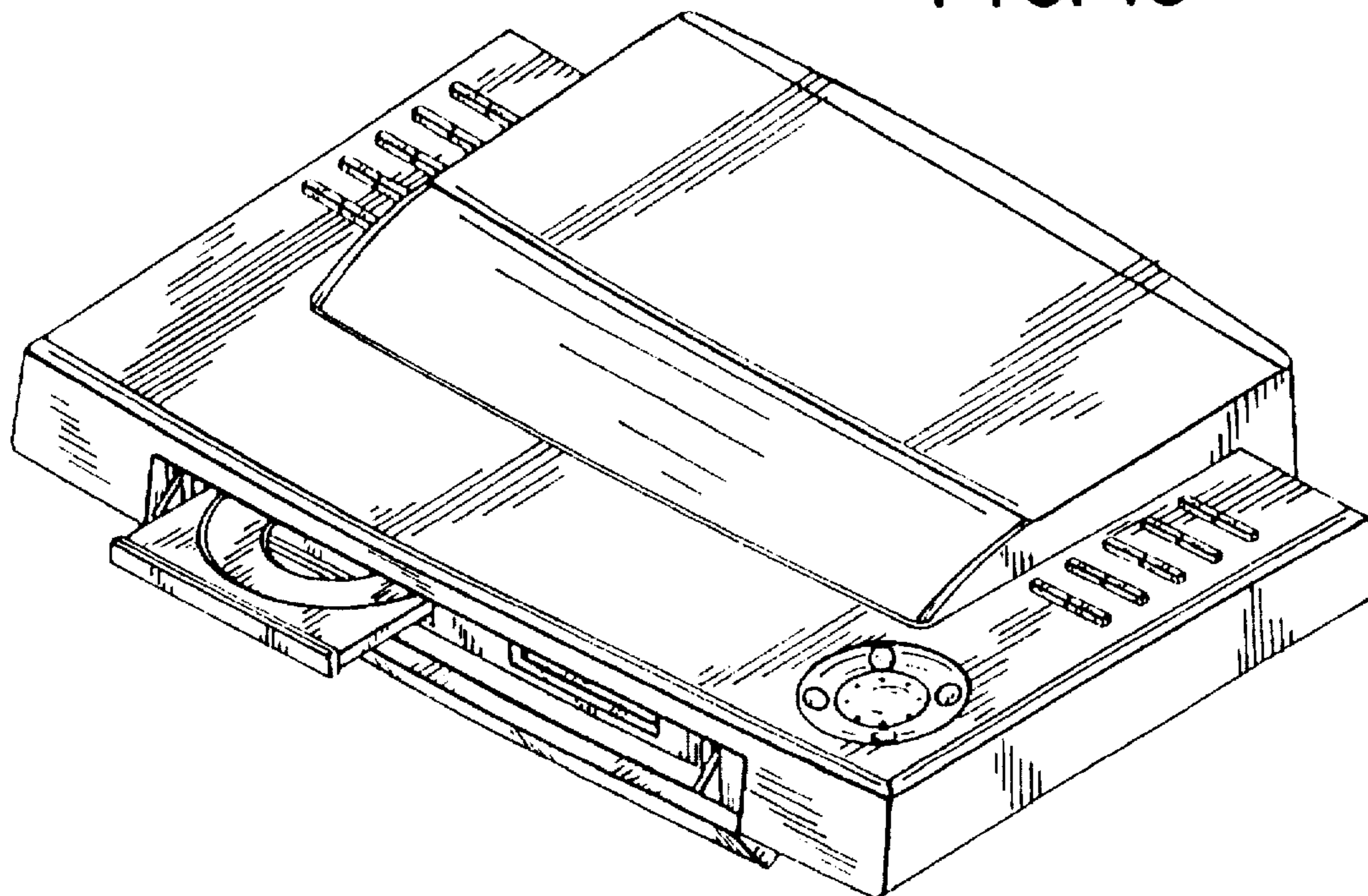

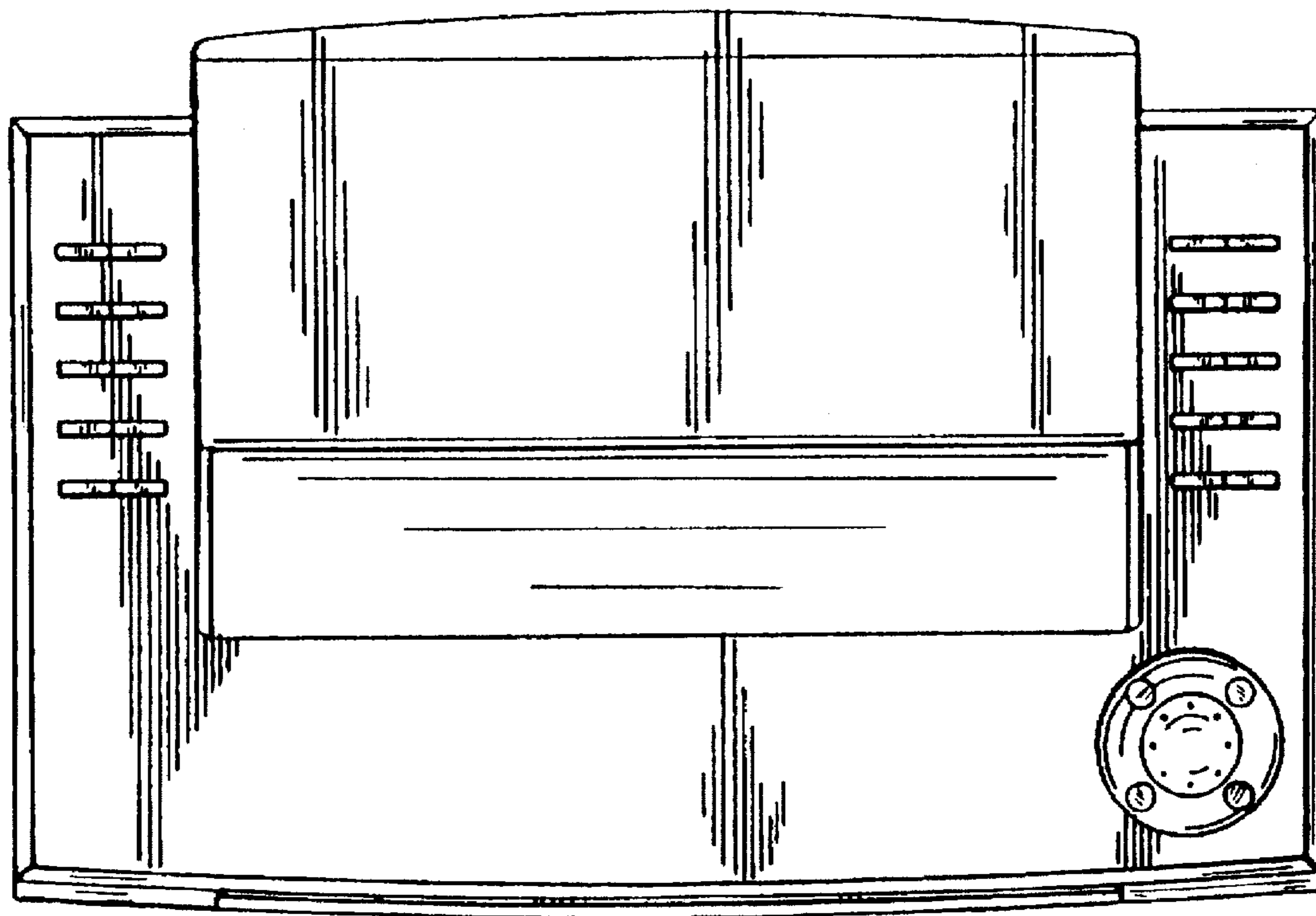

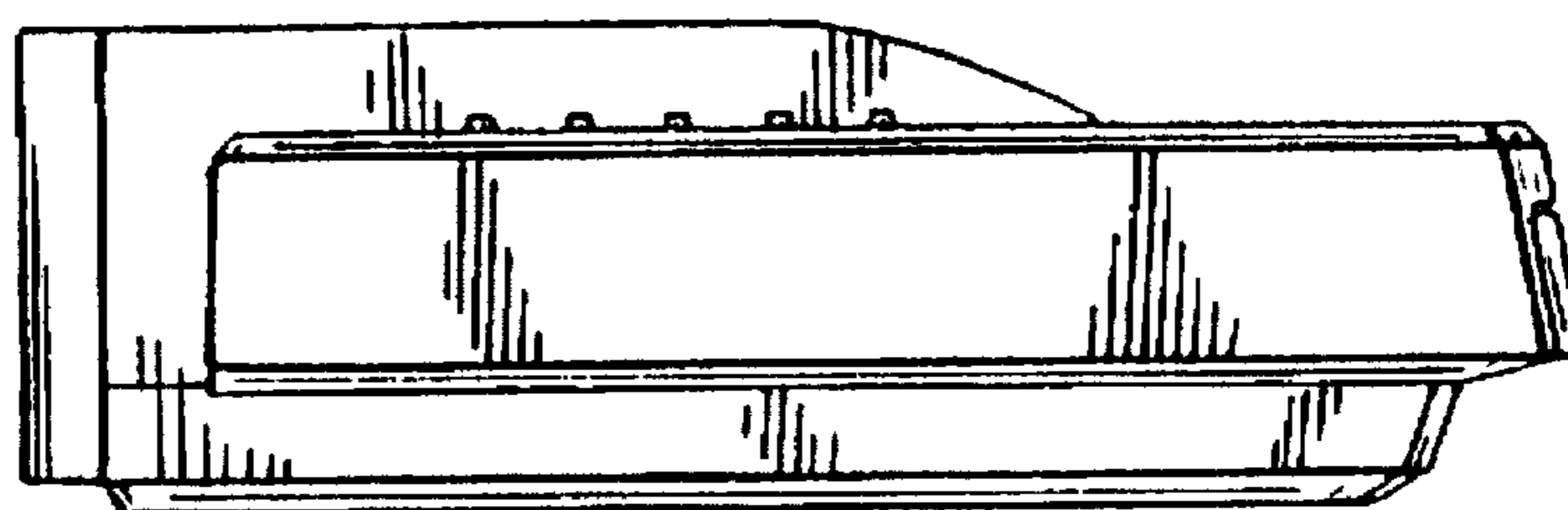

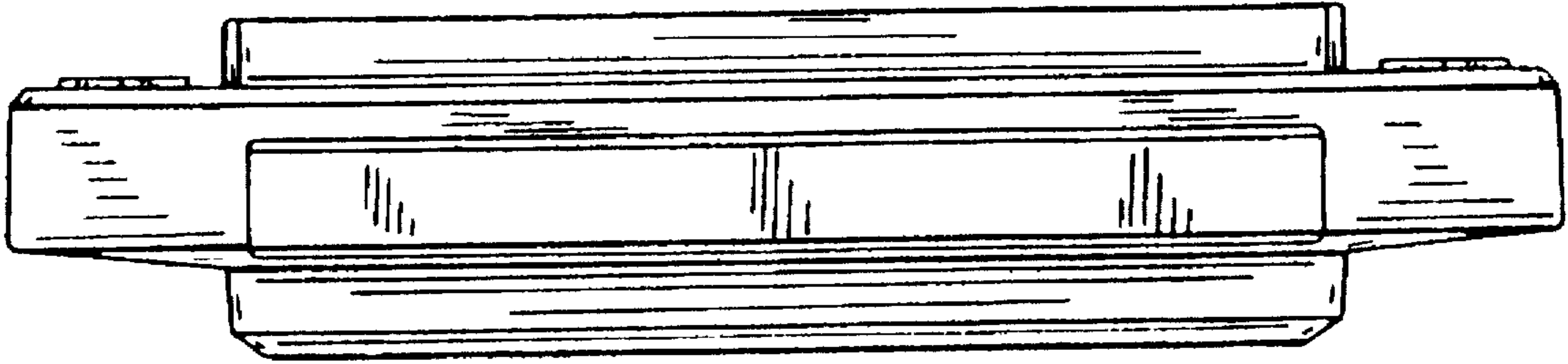

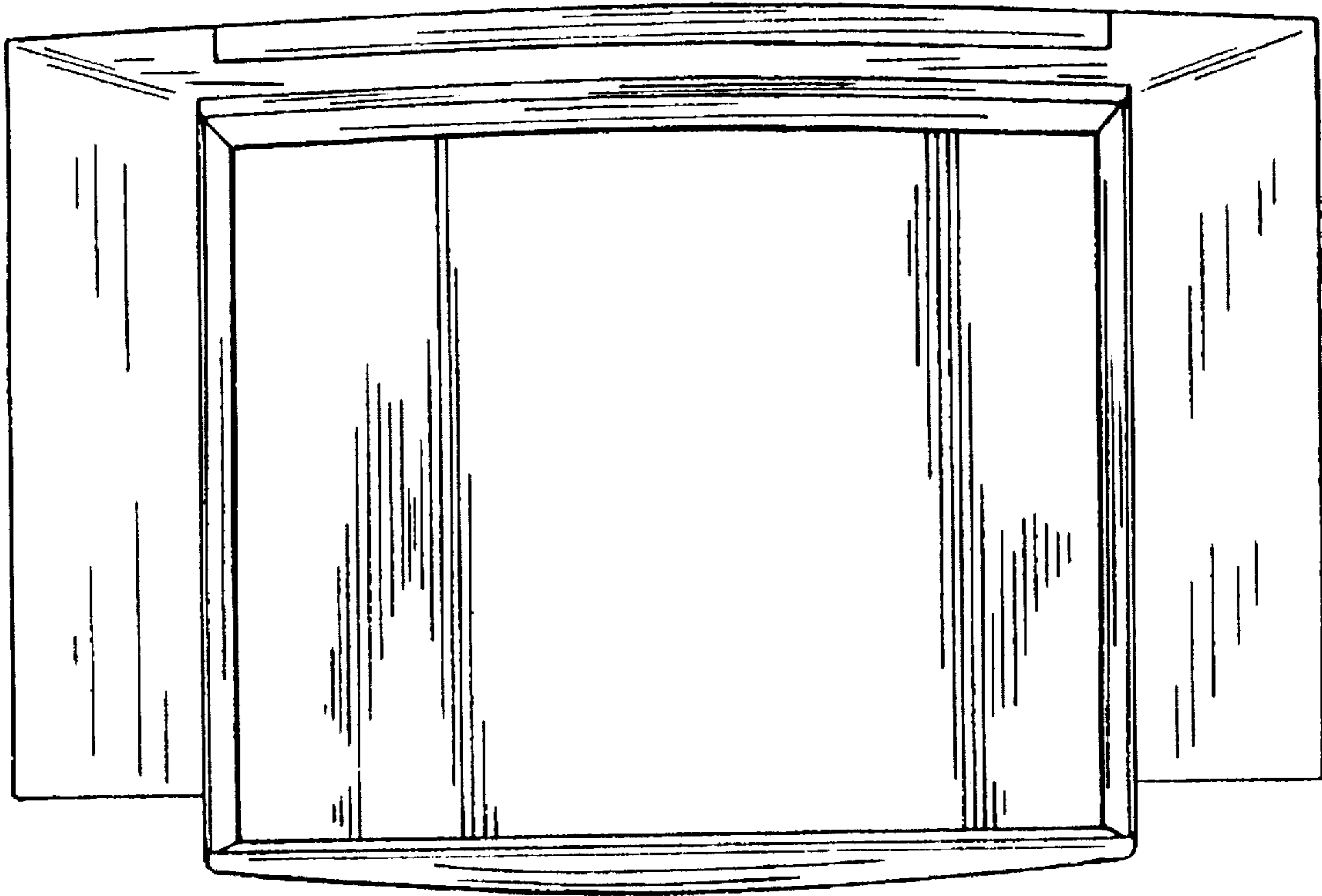

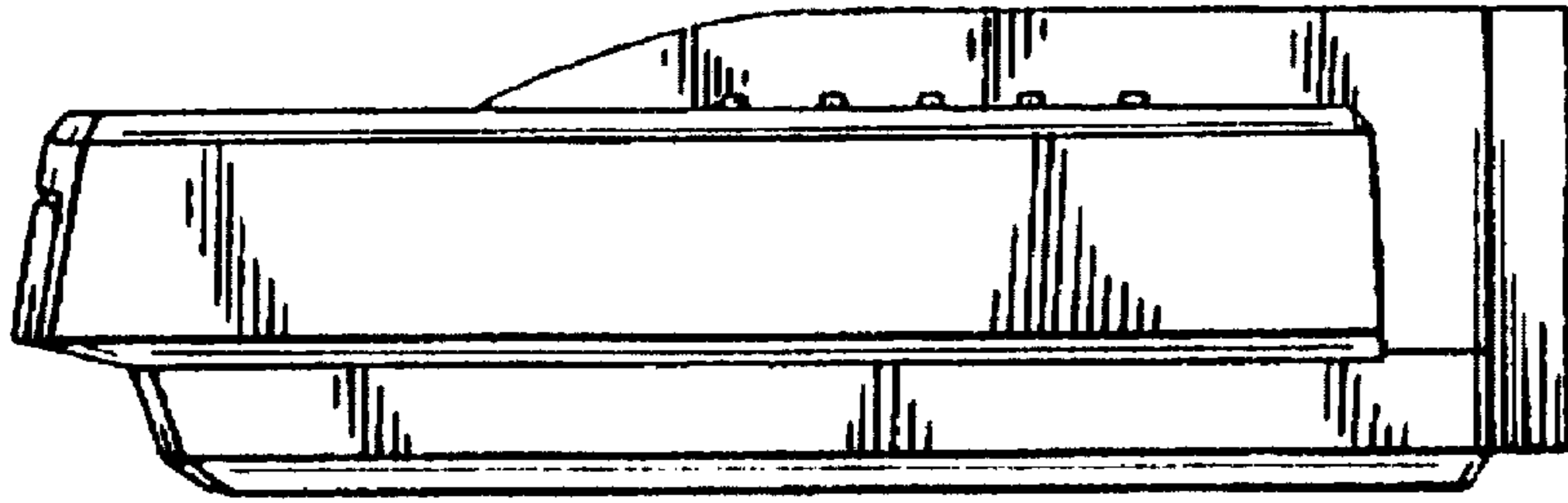
